(57) **CLAIM**

The ornamental design for a support accessory for toilets, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view including front, top and right sides showing my new design for a support accessory for toilets;

FIG. 2 is another perspective view including front, top and right sides thereof with a lid of the toilet in an up position;

FIG. 3 is a left side view thereof of which the right side is a mirror image;

FIG. 4 is a front view thereof;

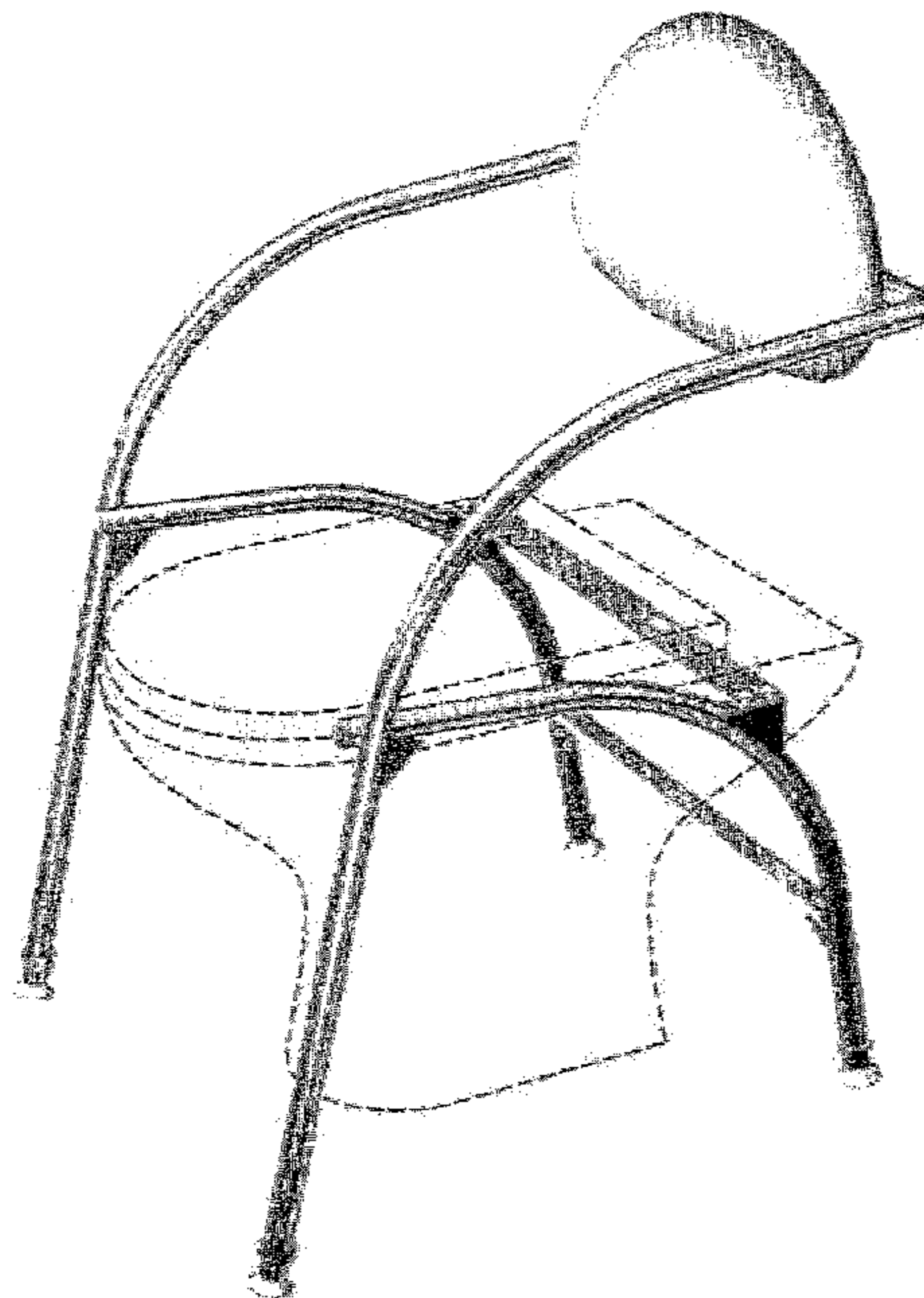
FIG. 5 is a rear view thereof

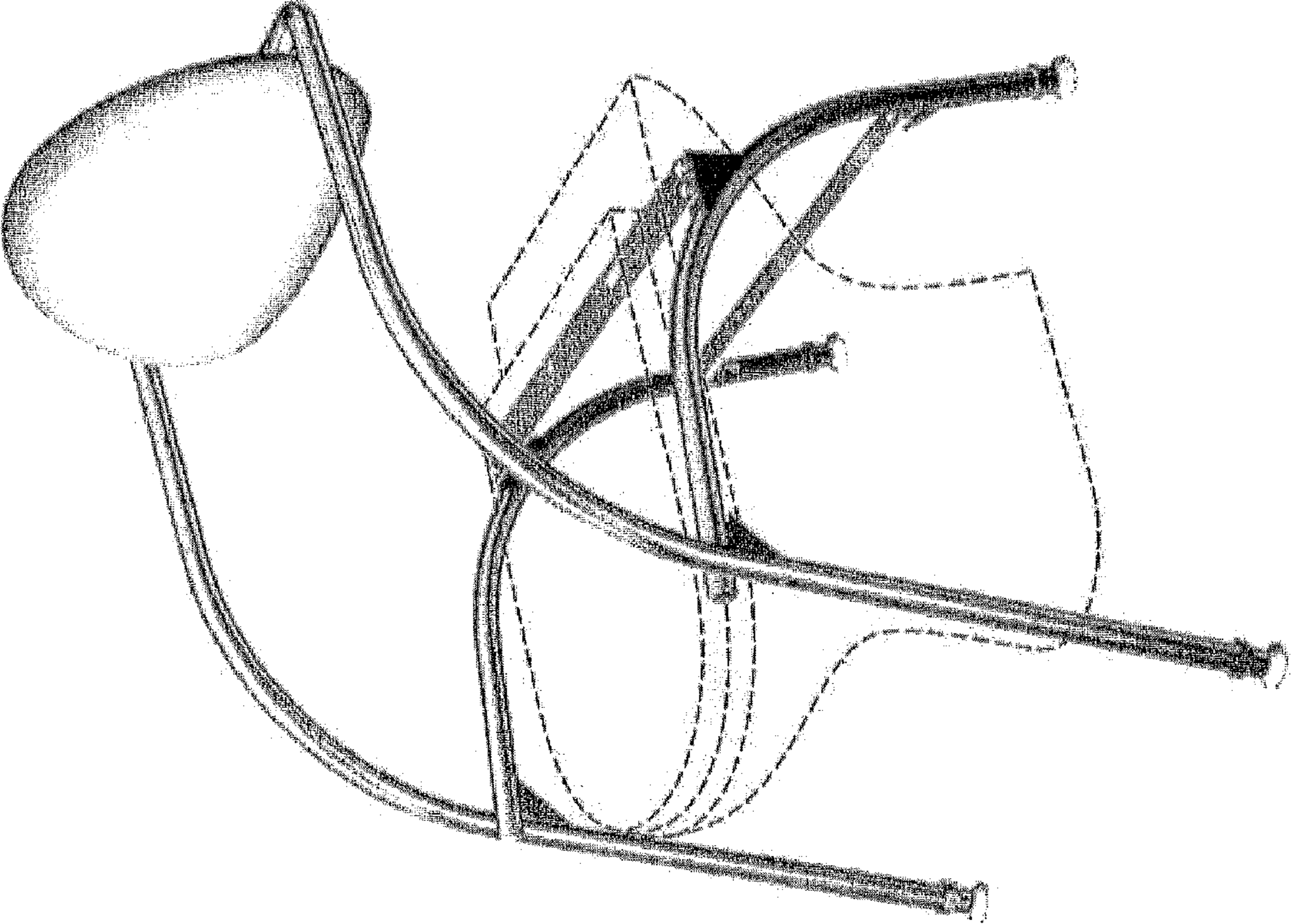

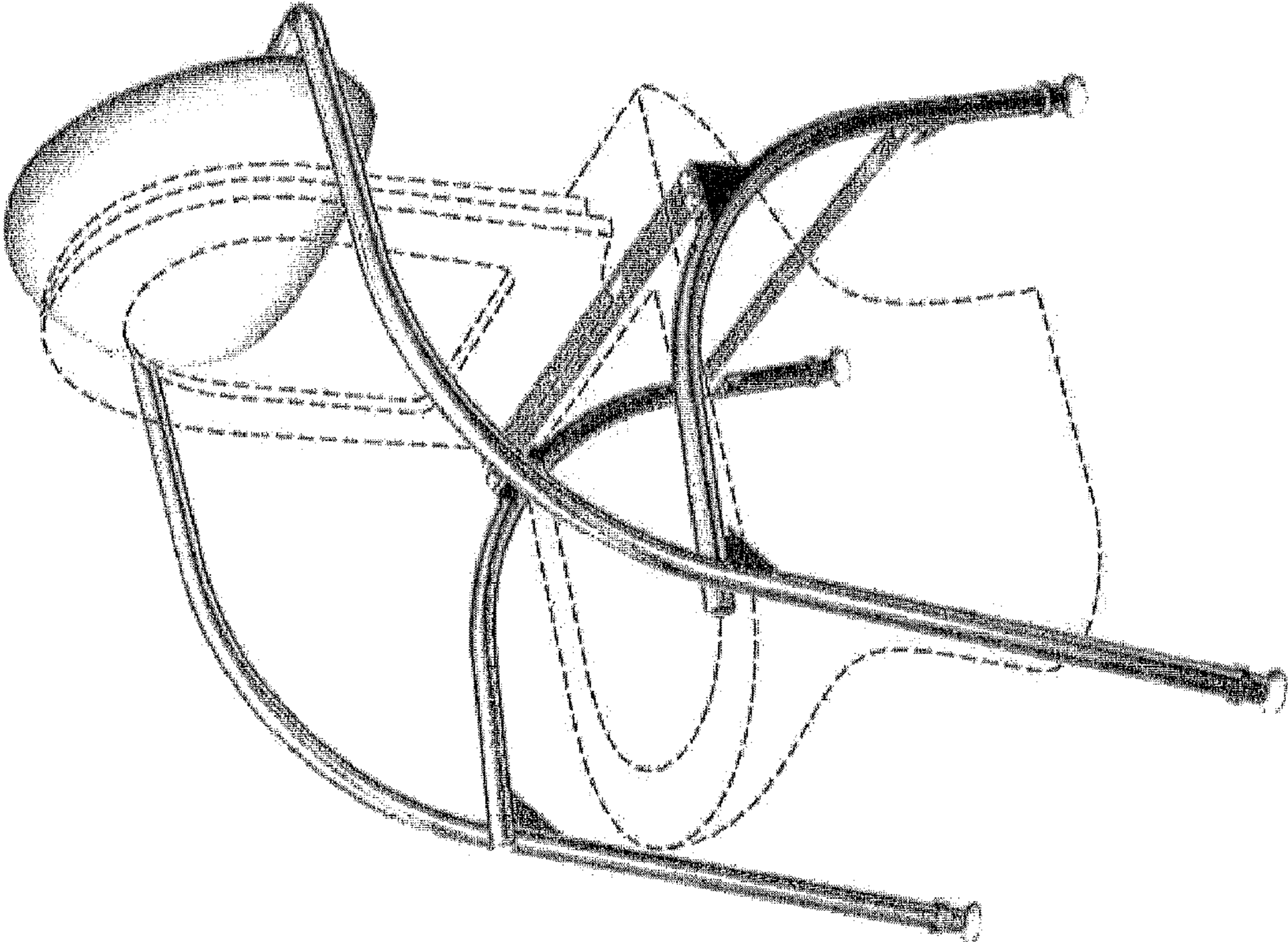

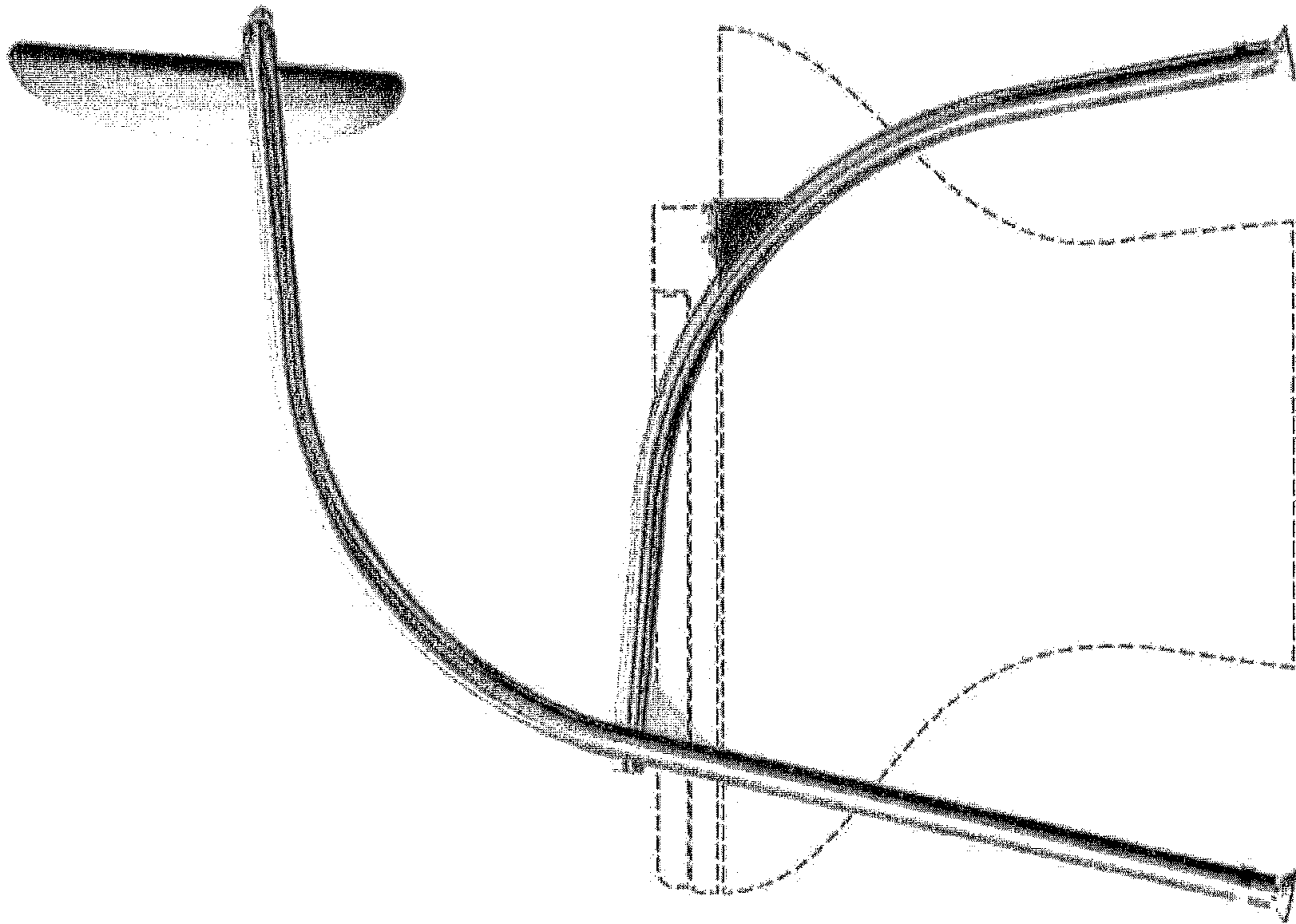

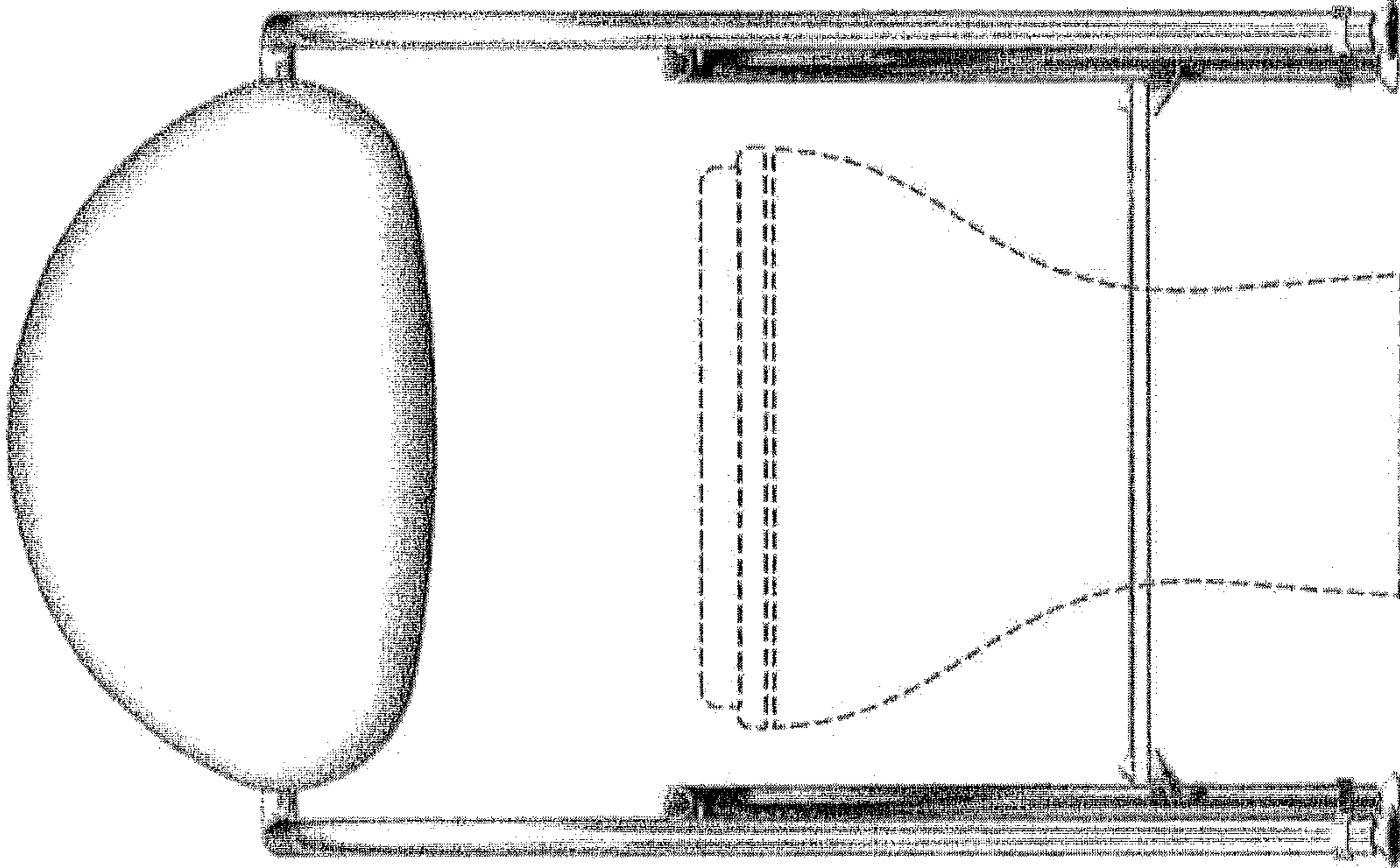

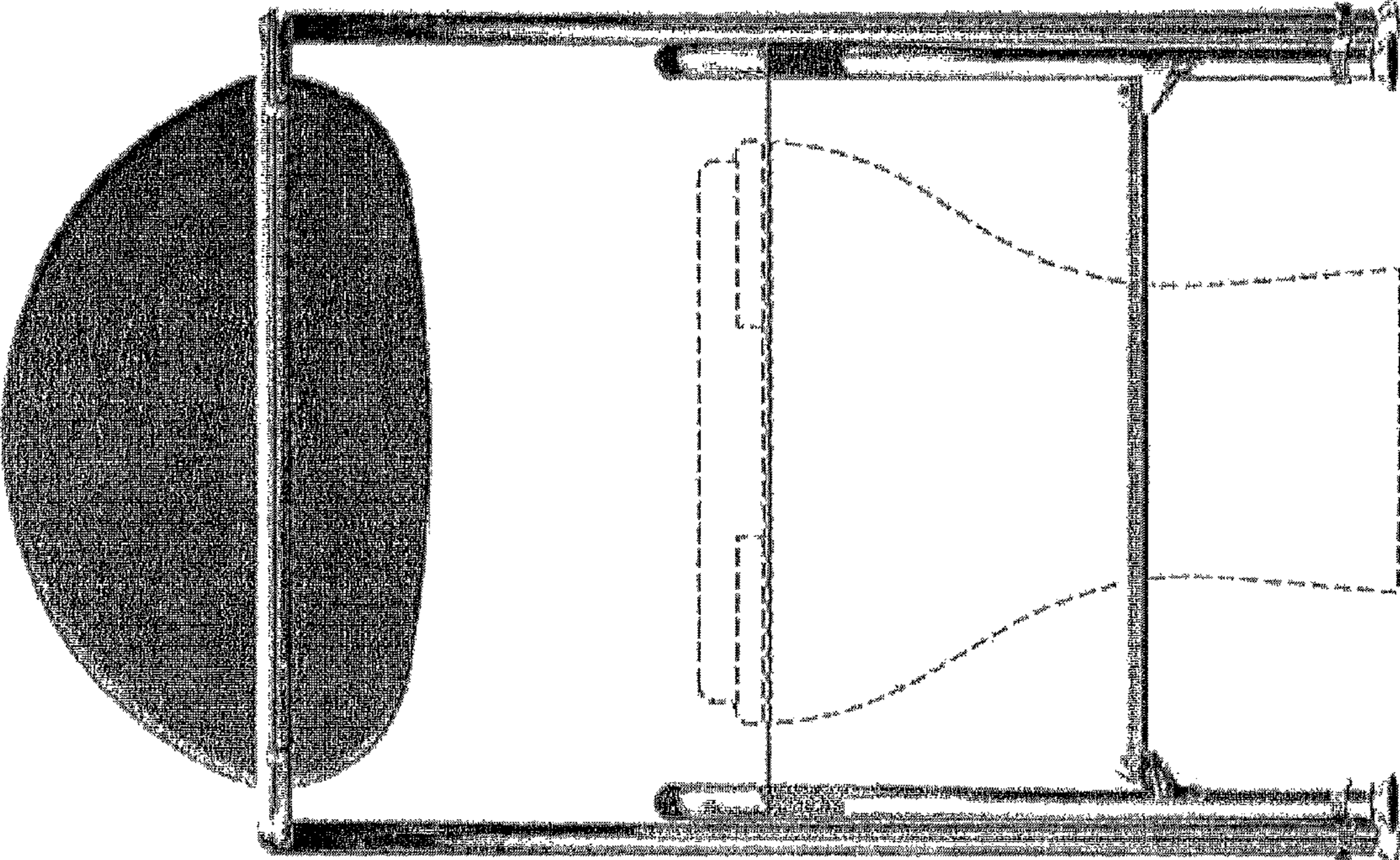

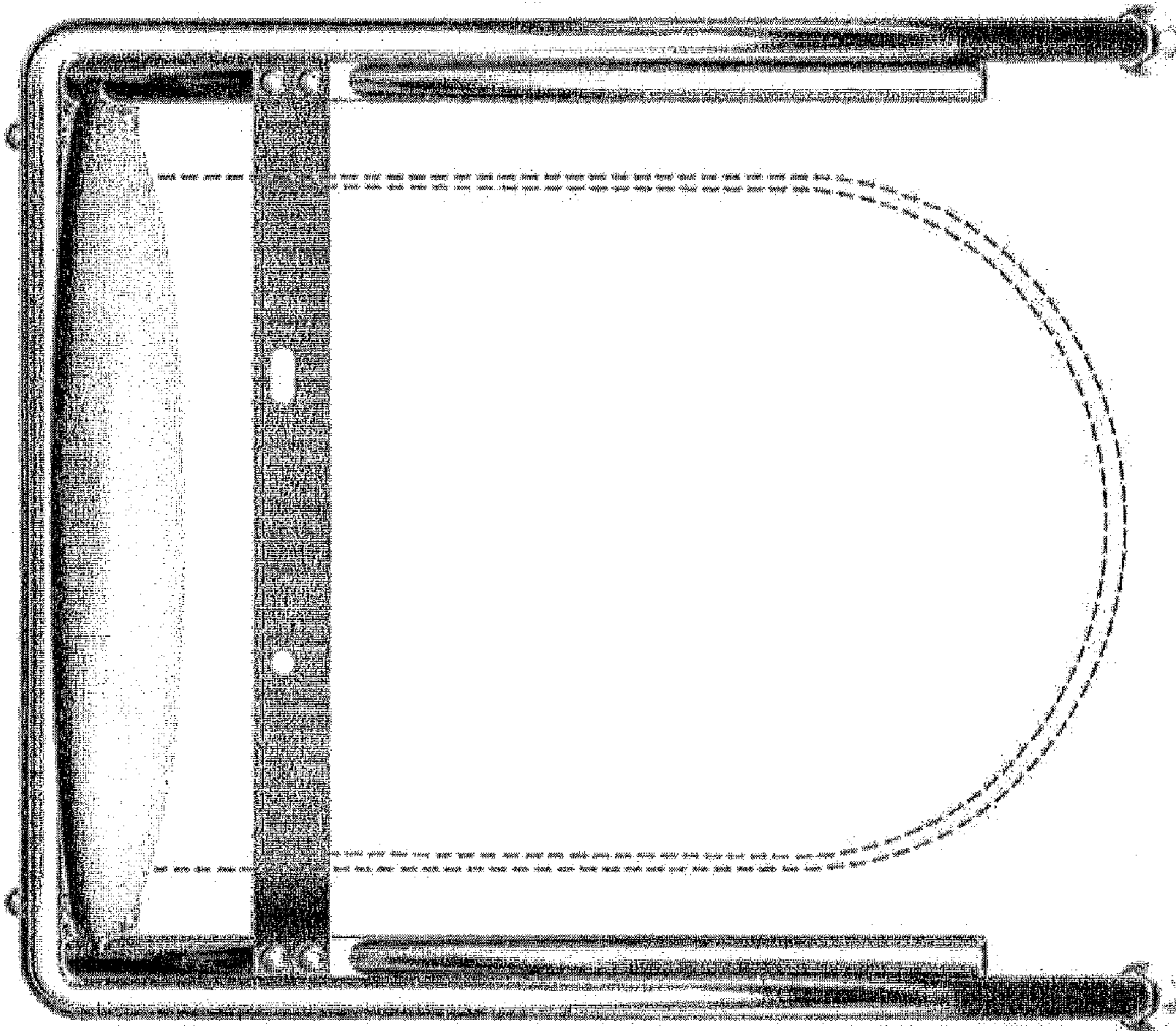

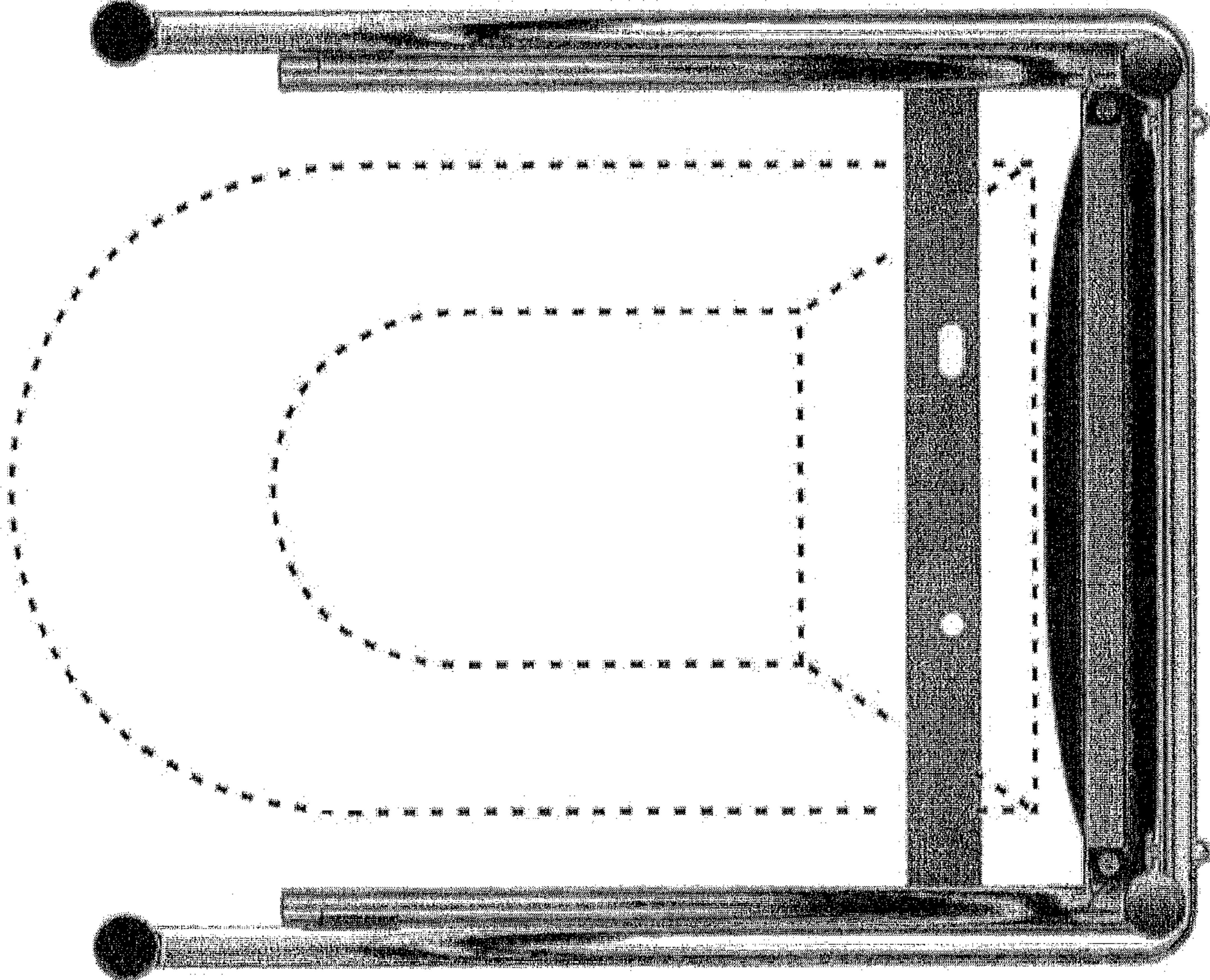
