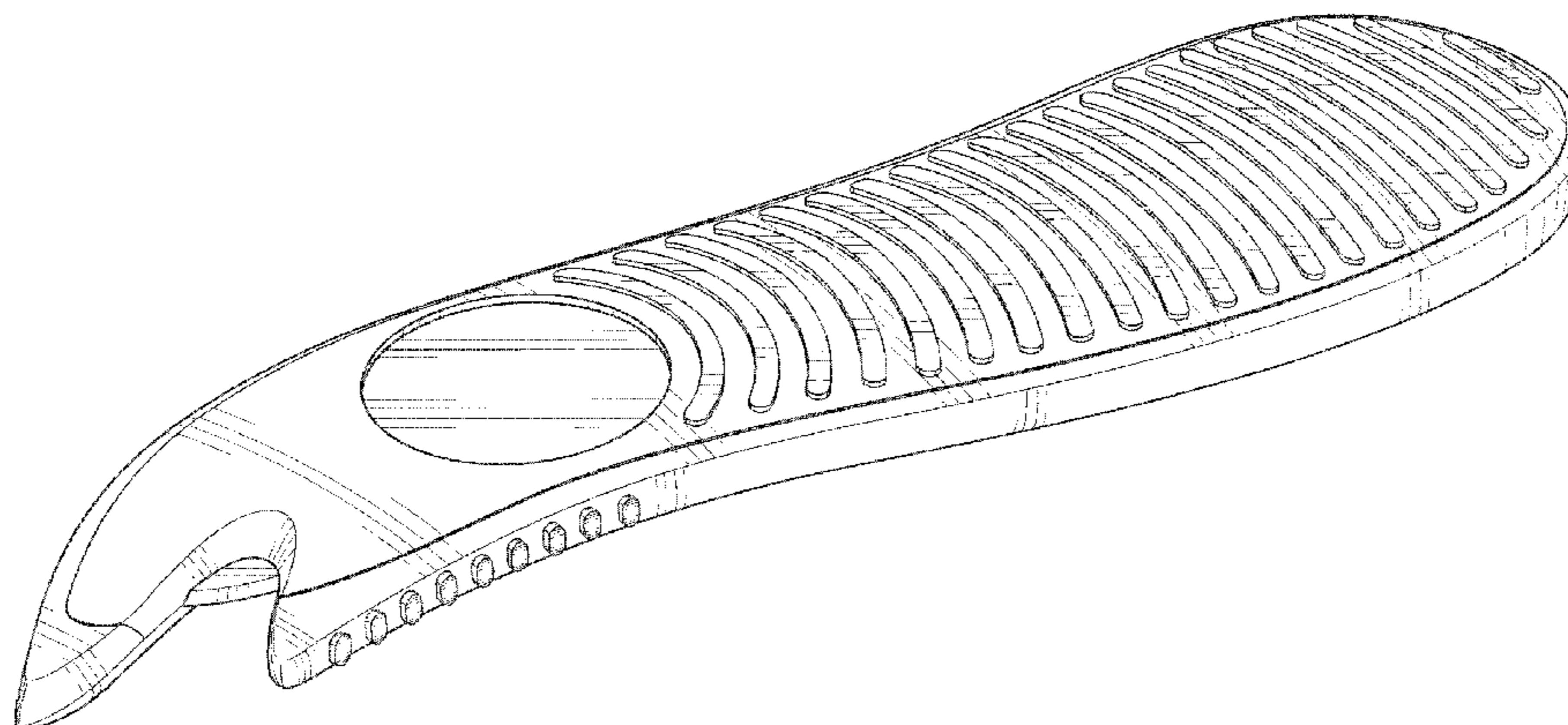
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, right and front perspective view of the scalpel showing our new design;

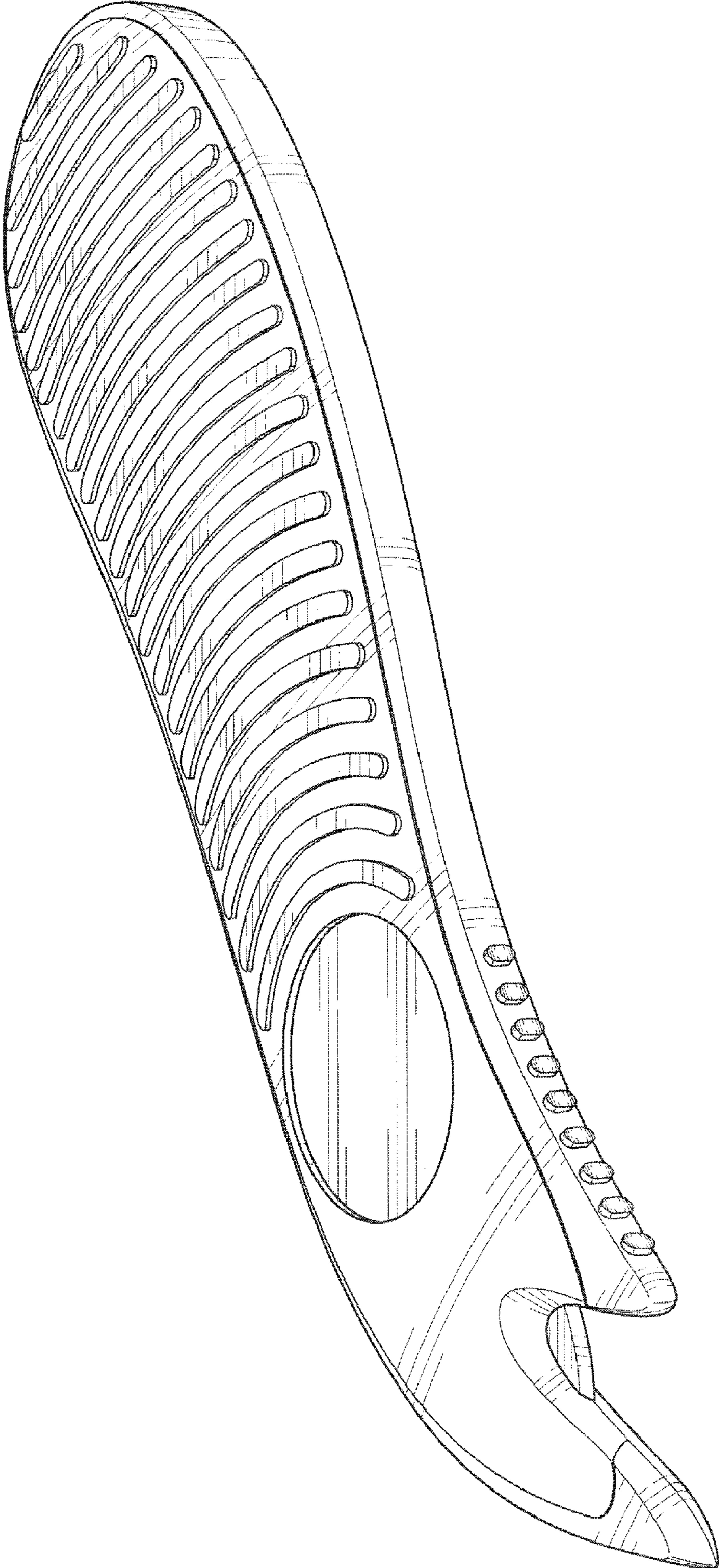

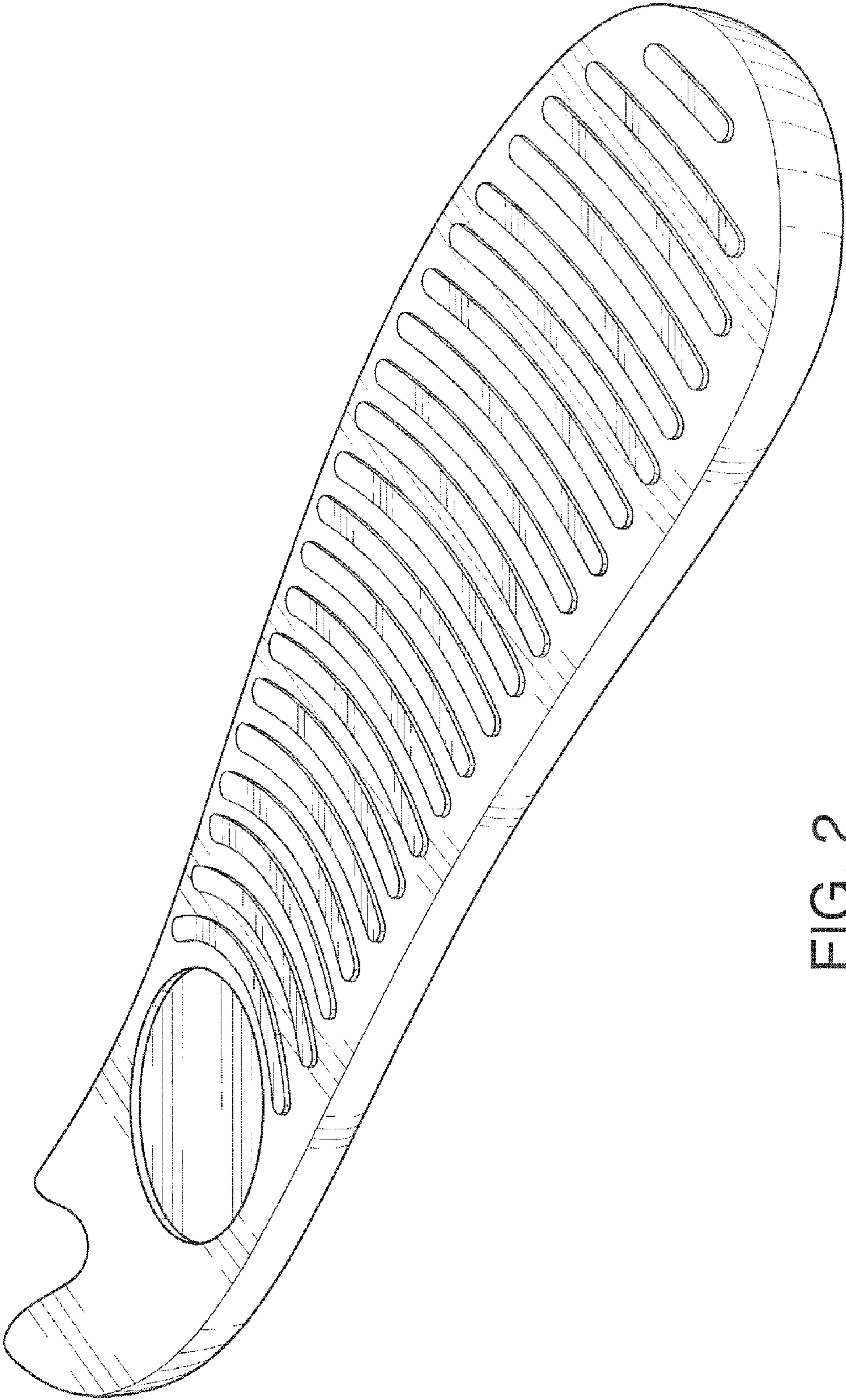

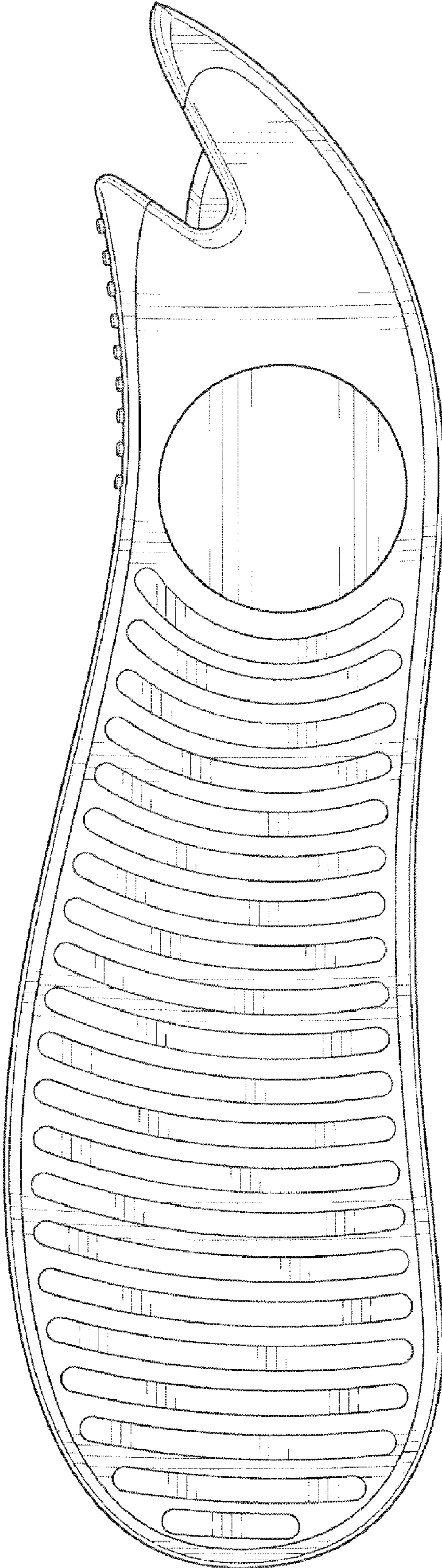

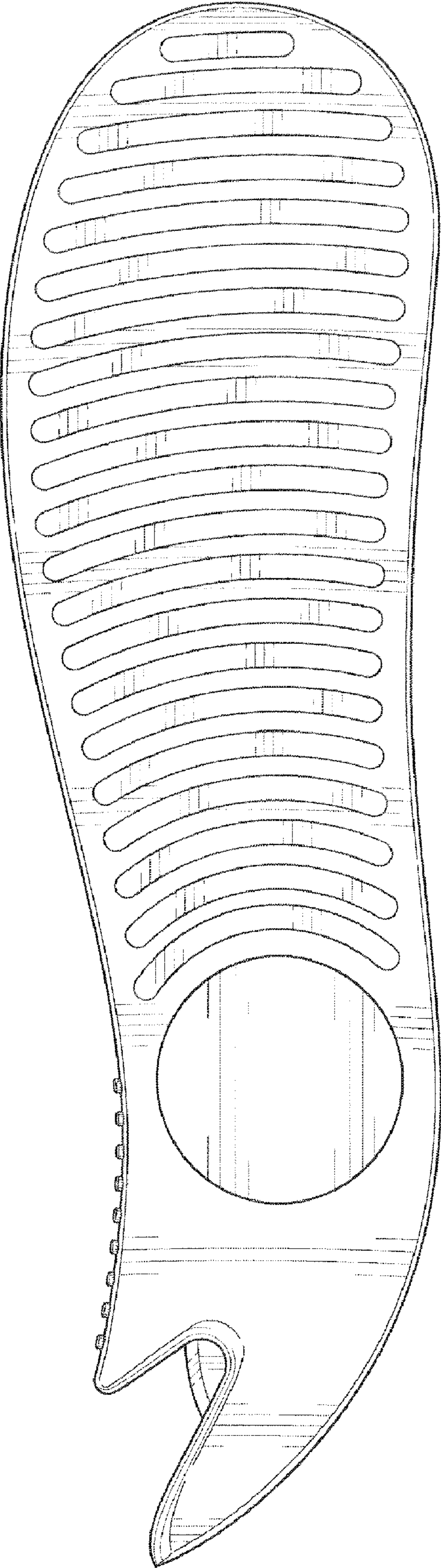

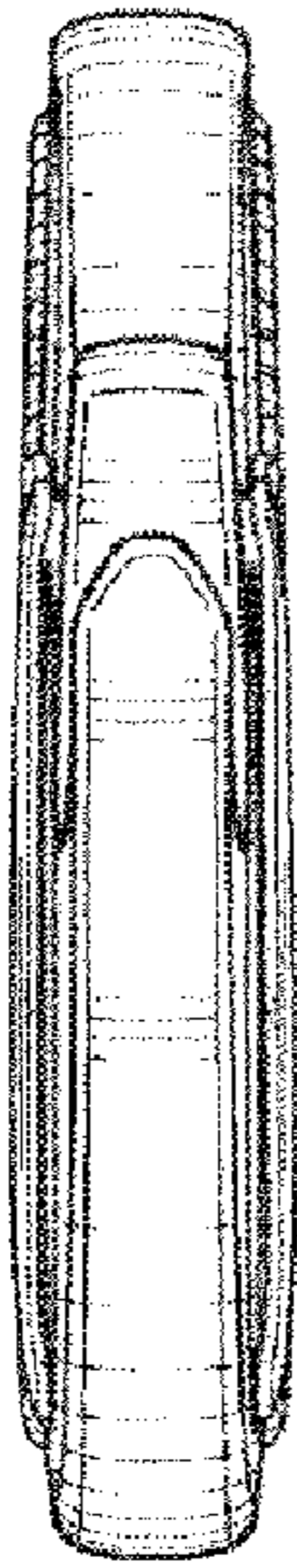

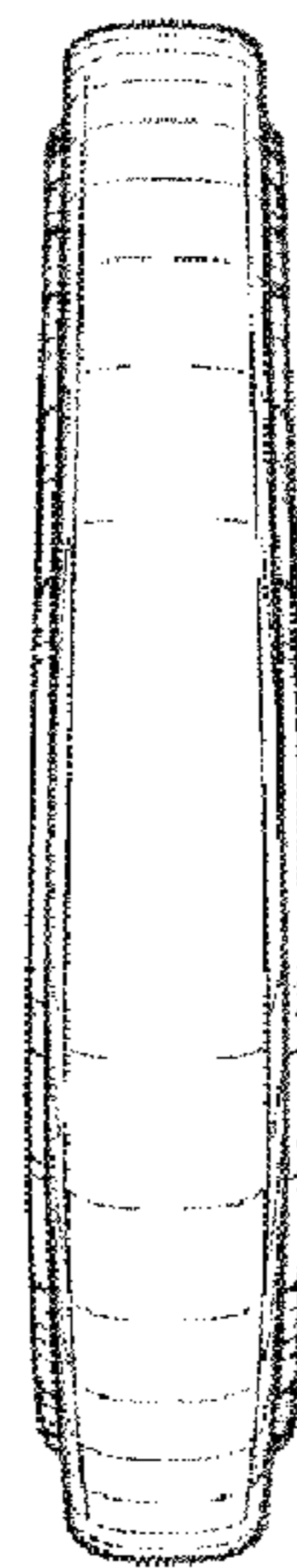

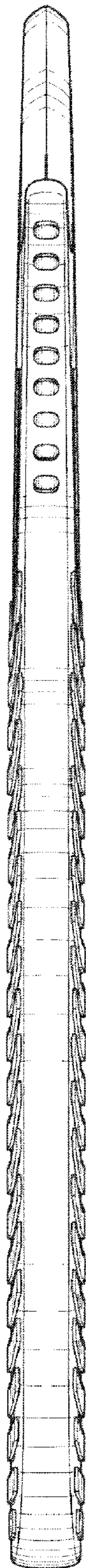

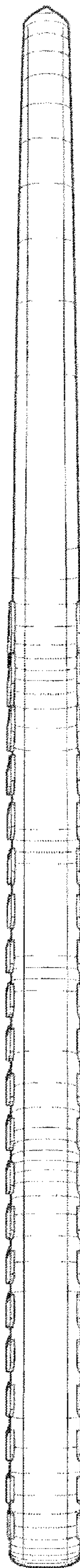
