(57) **CLAIM**

What is claimed is the ornamental design for a stress reliever and massage tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a stress reliever and massage tool, showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

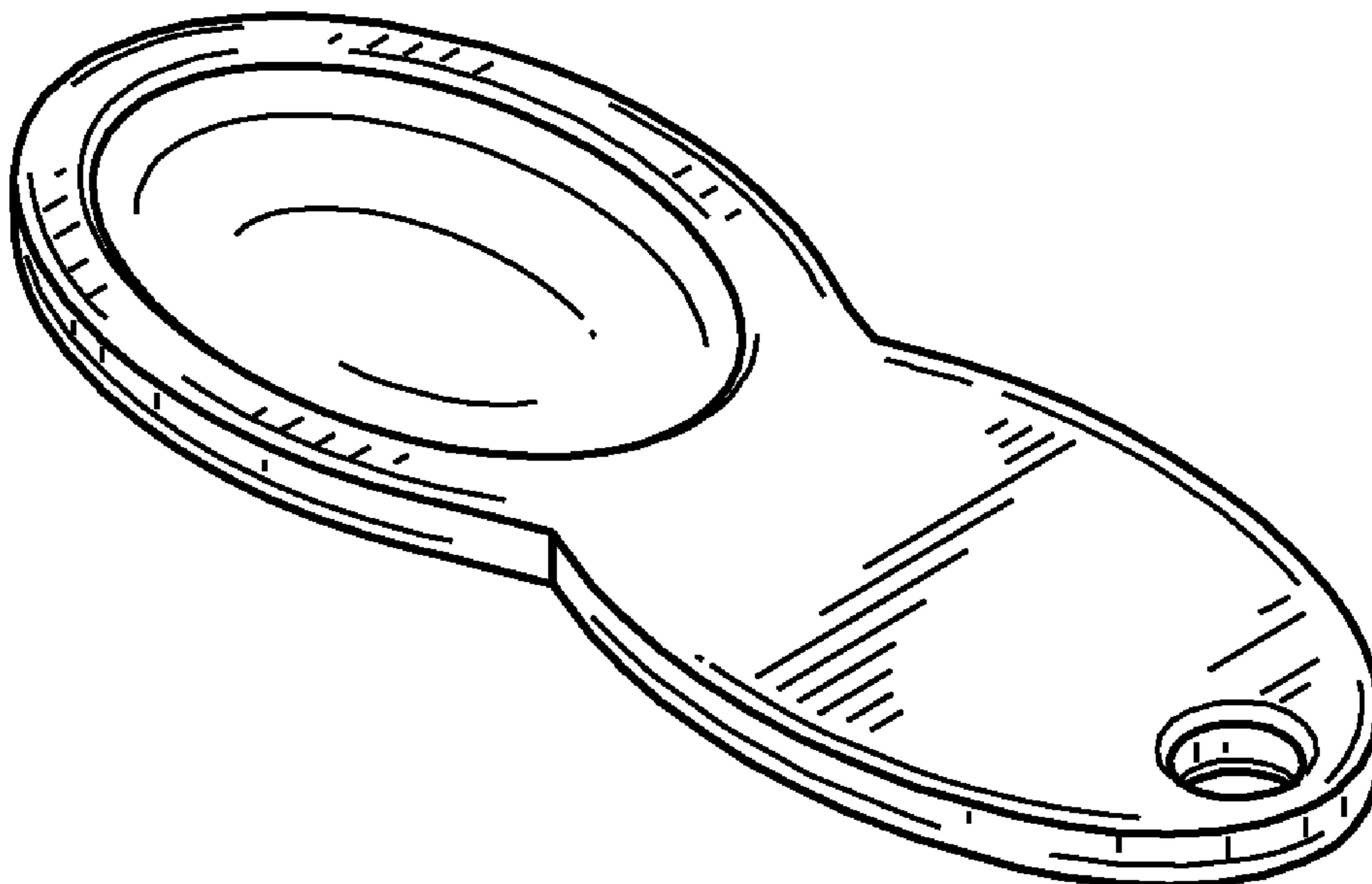
FIG. 4 is a right-side elevational view thereof, the left-side elevational view being a mirror image thereof;

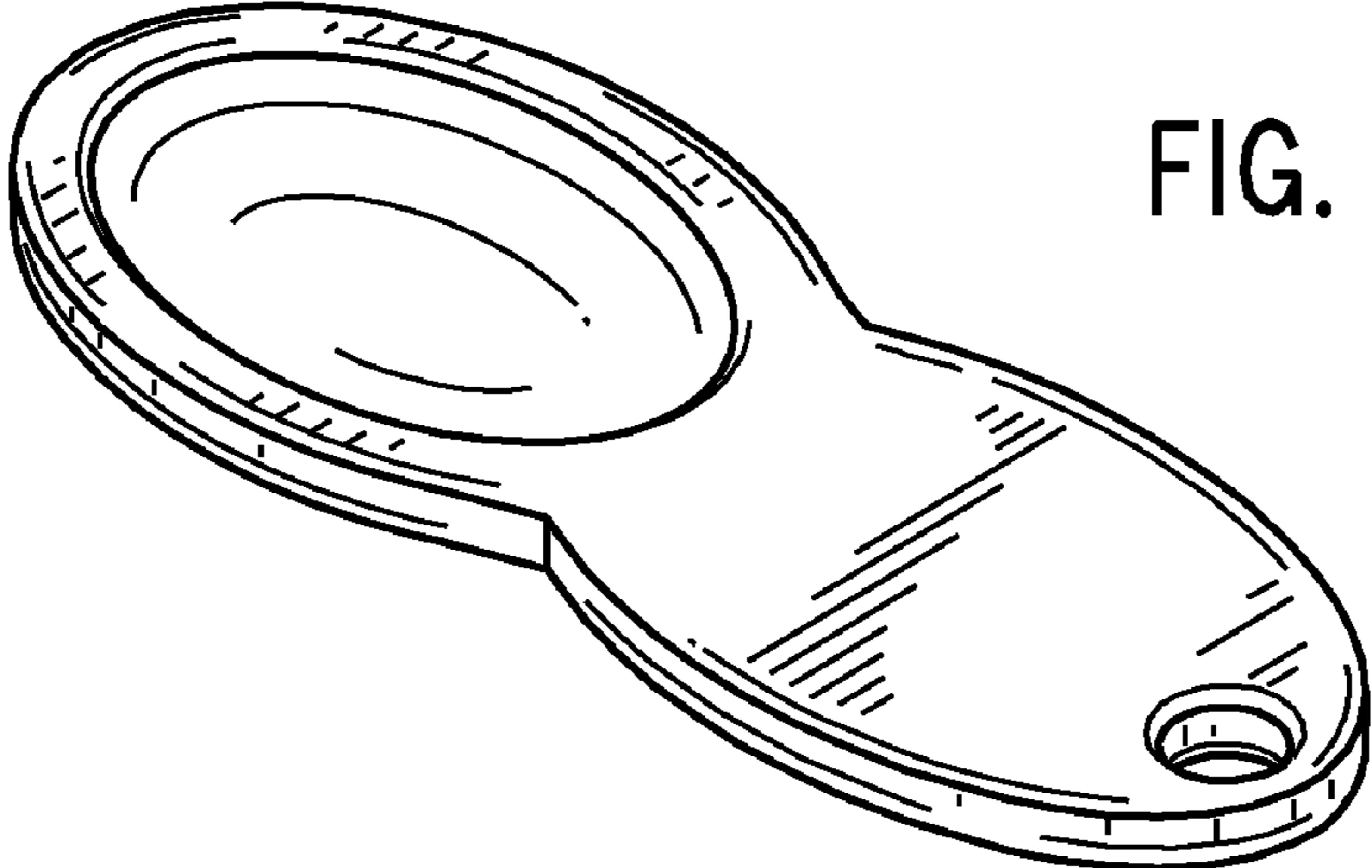

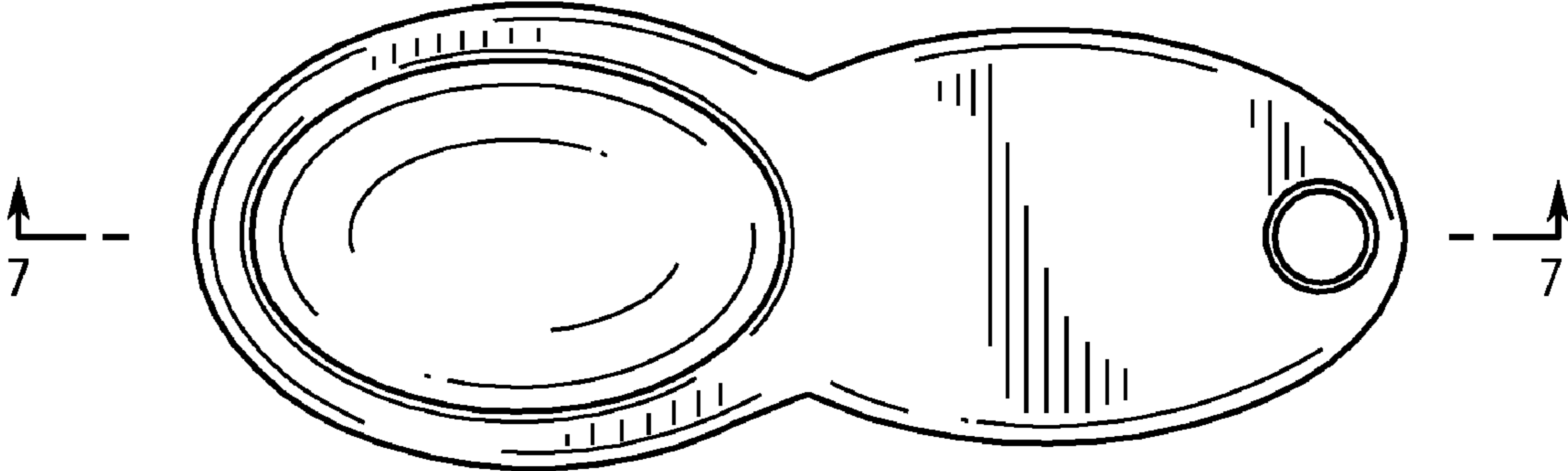

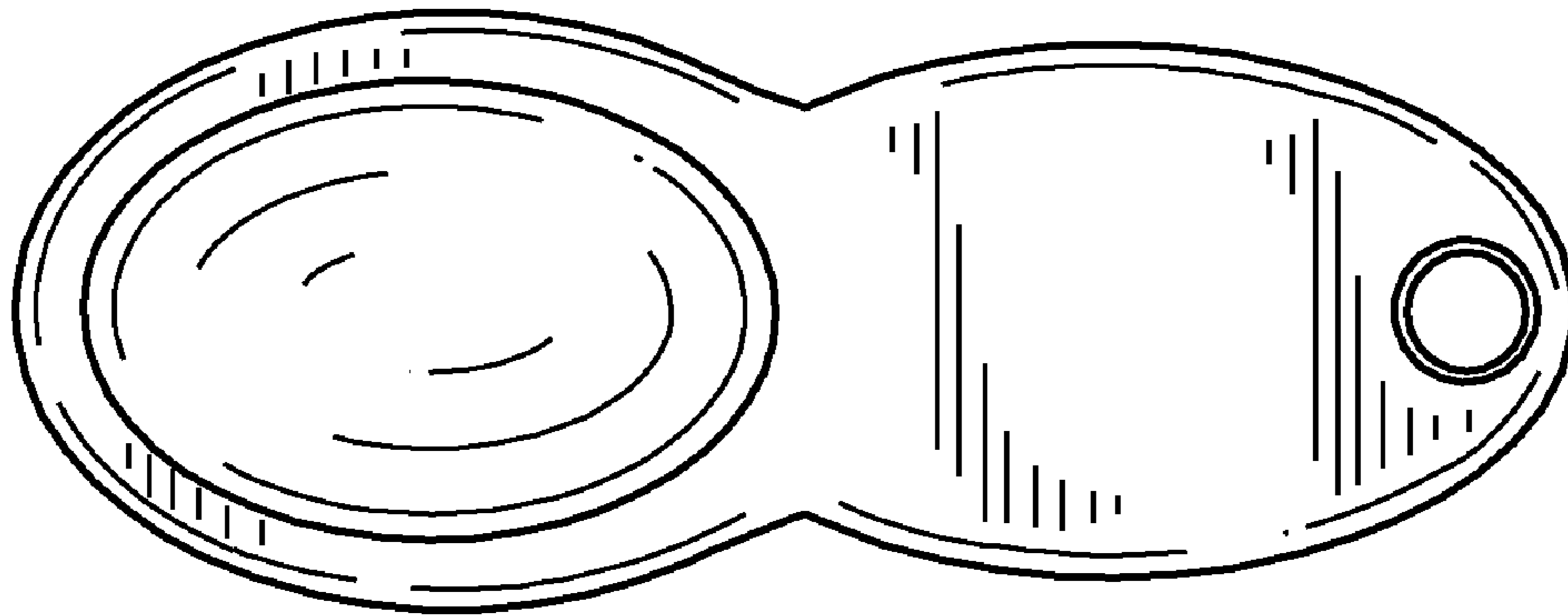

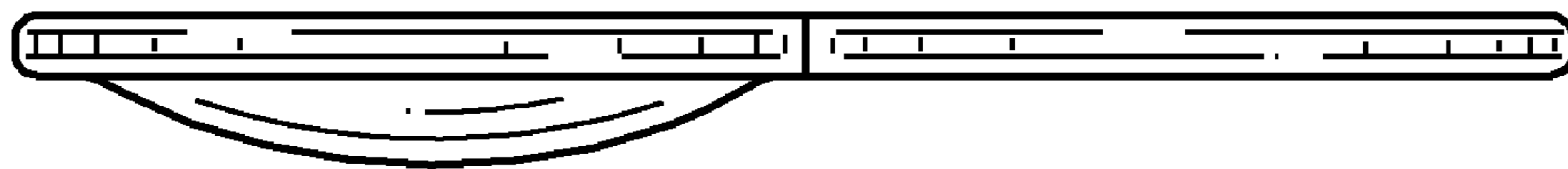

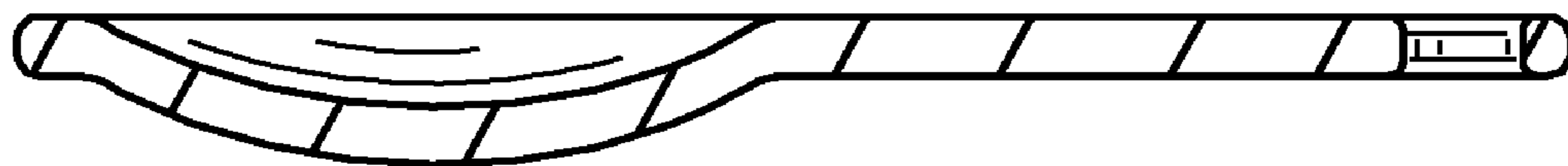
