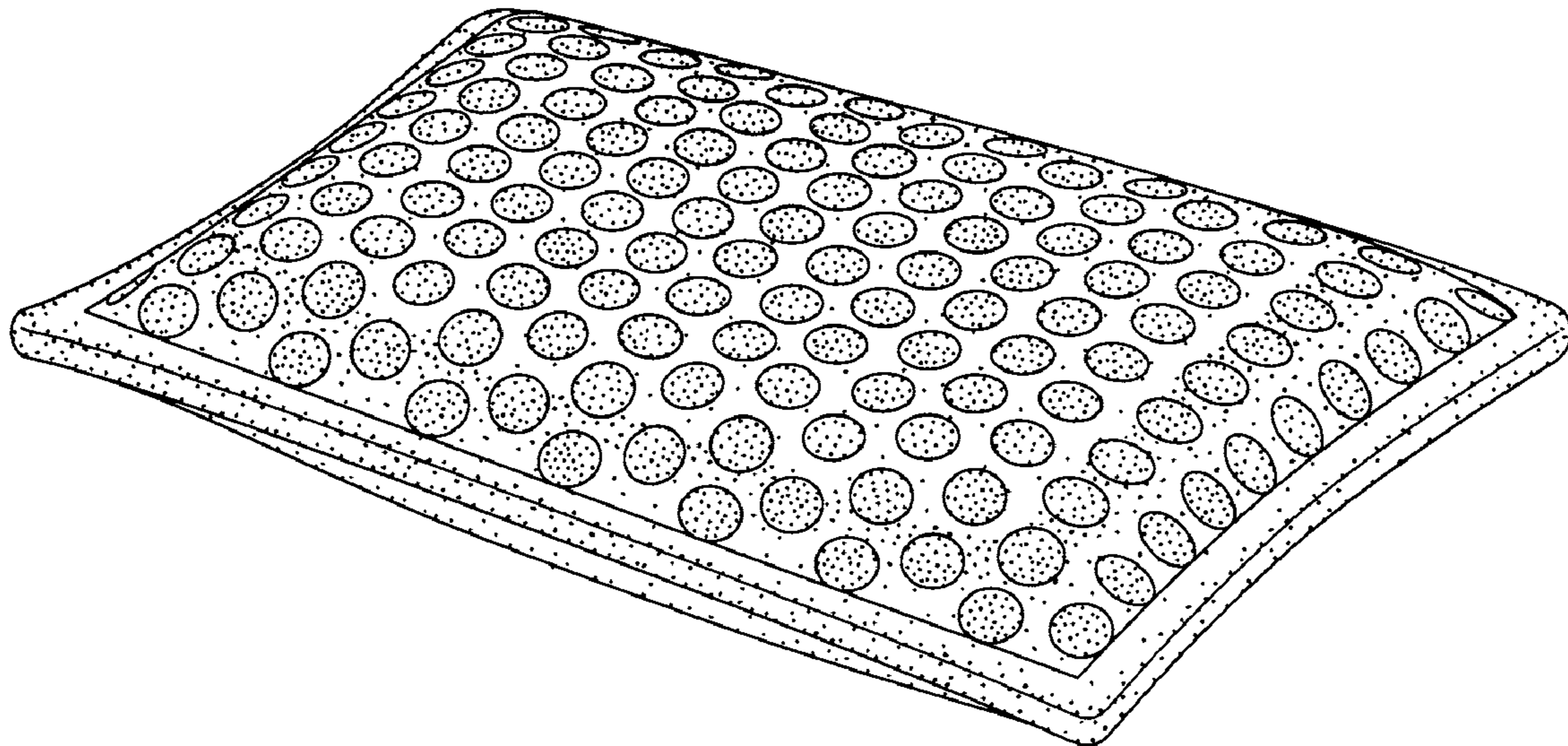
(57) **CLAIM**

FIG. 1 is a bottom, front perspective view of a pad showing my new design;

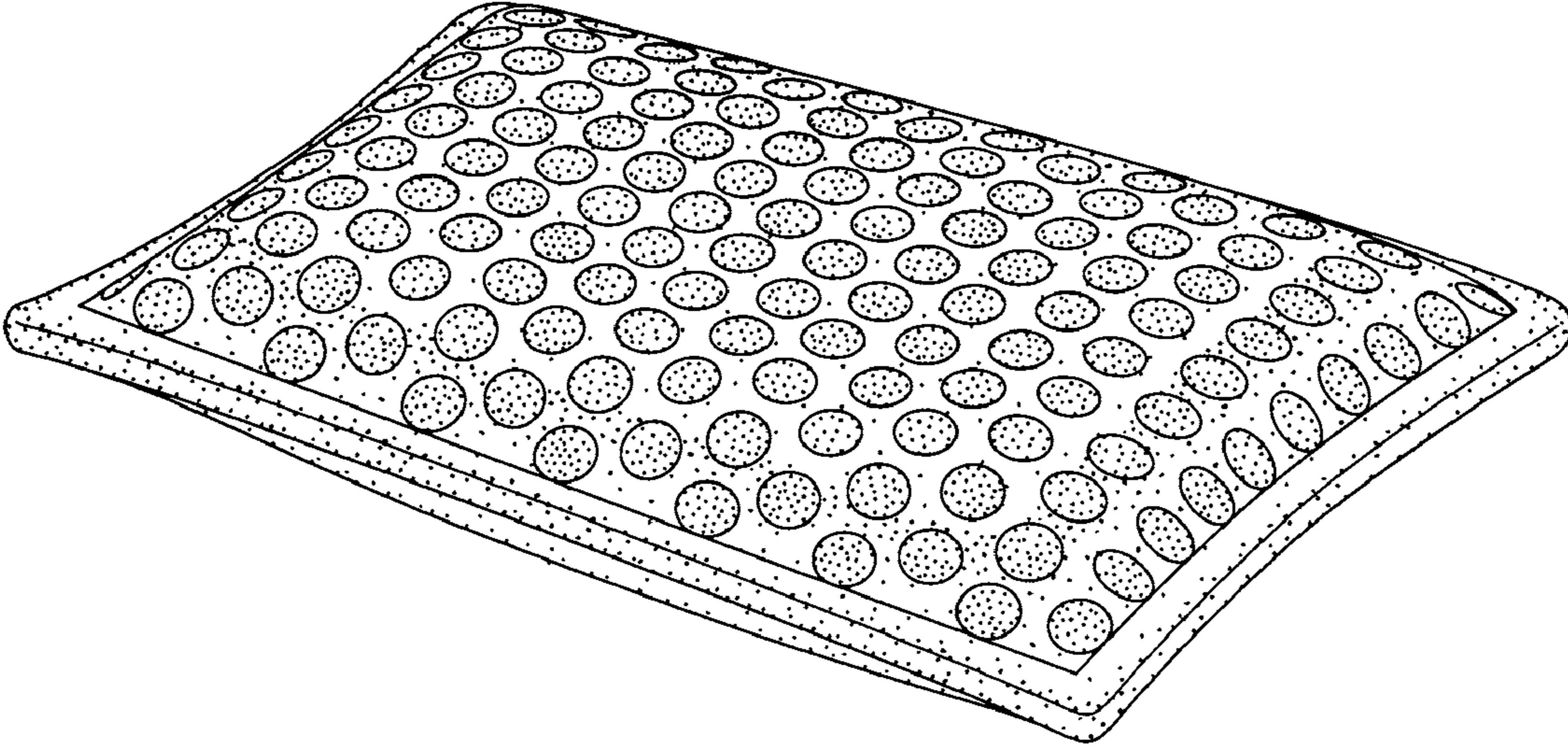

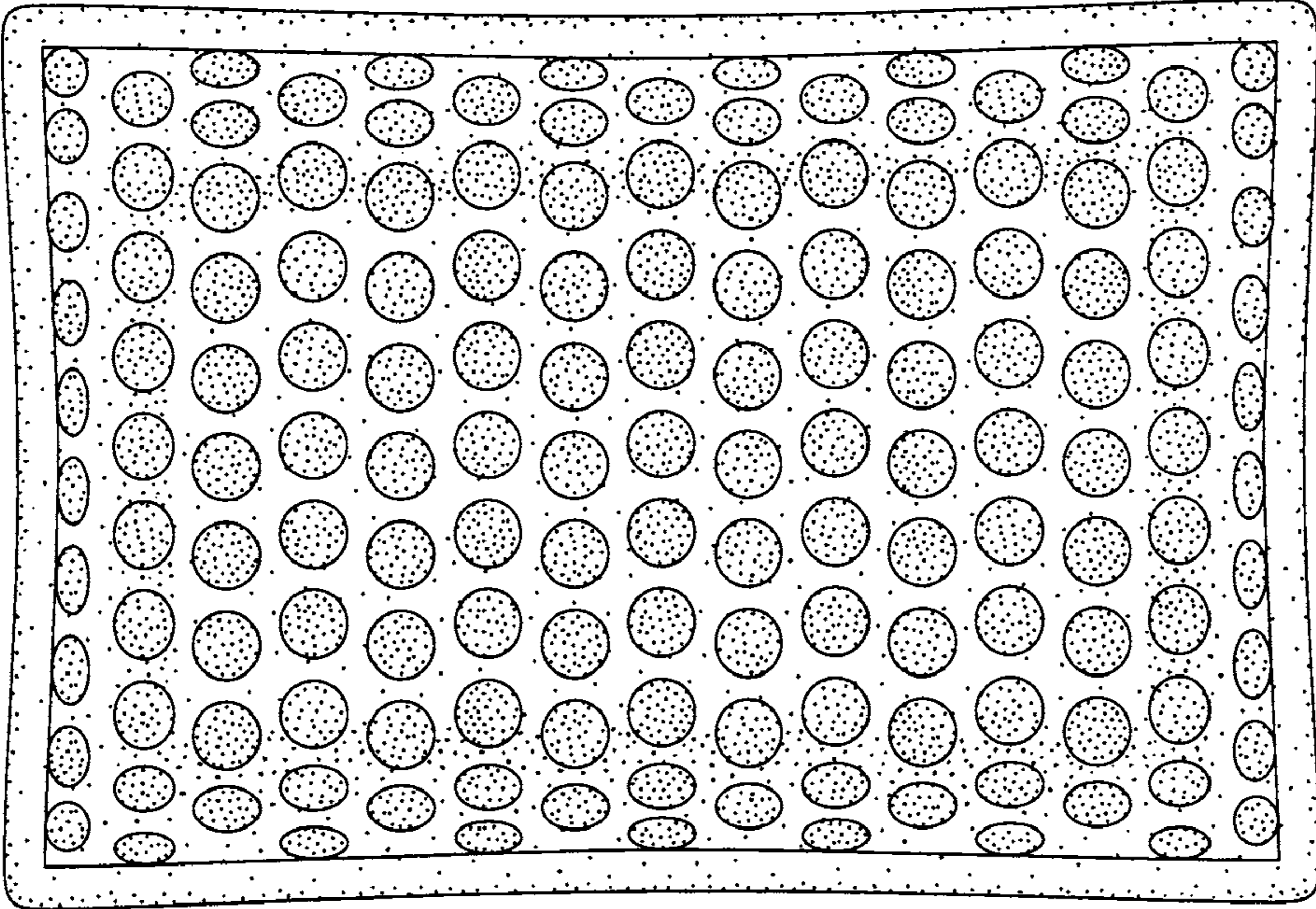

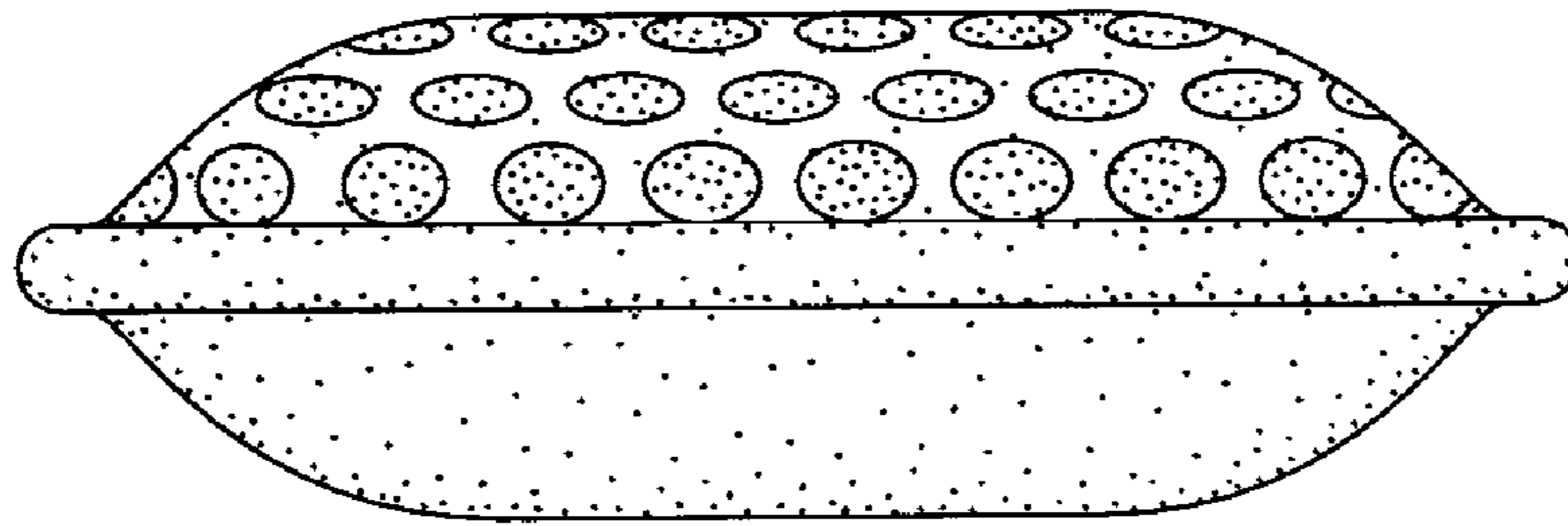

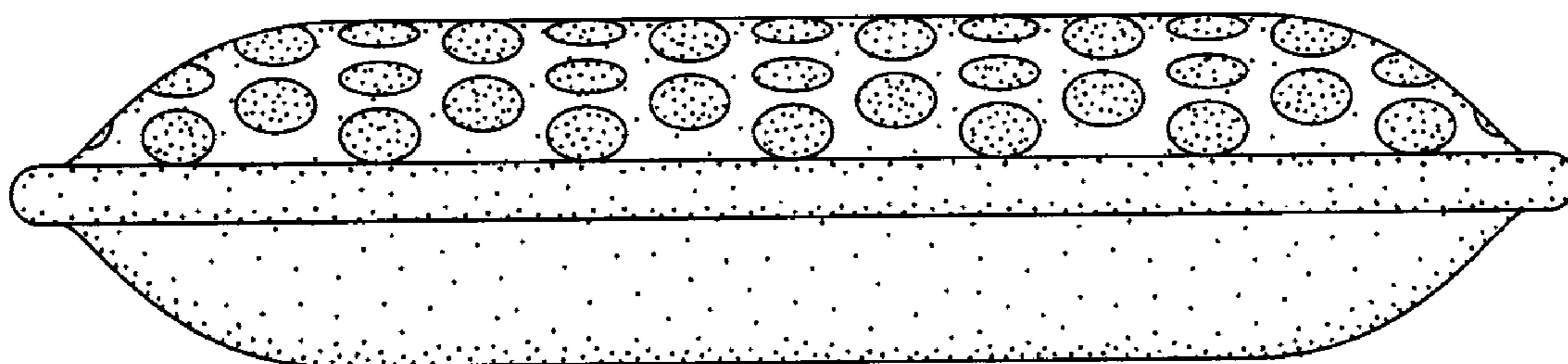

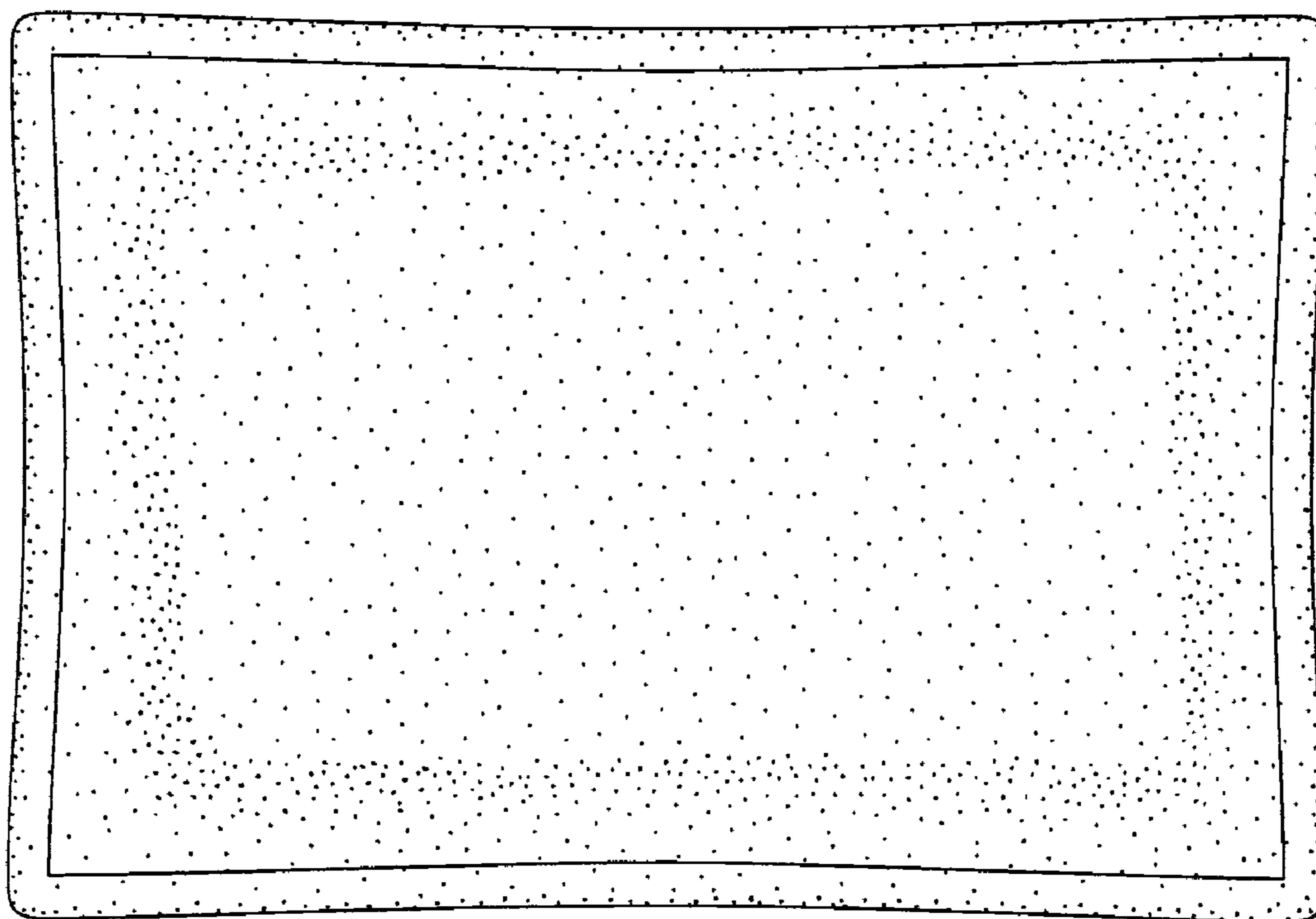
