FIG. 4 is a top view thereof,

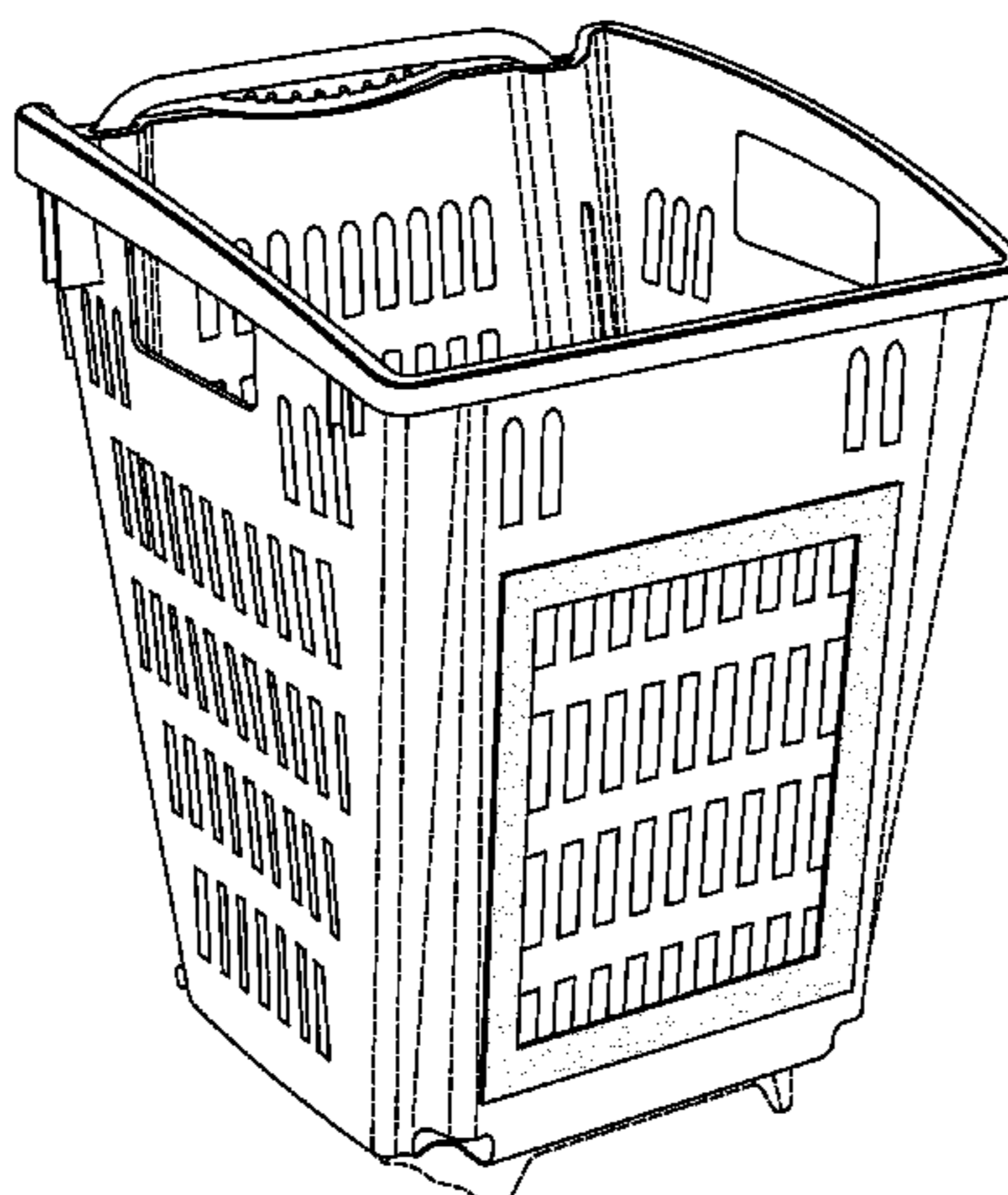
FIG. 5 is a rear view thereof,

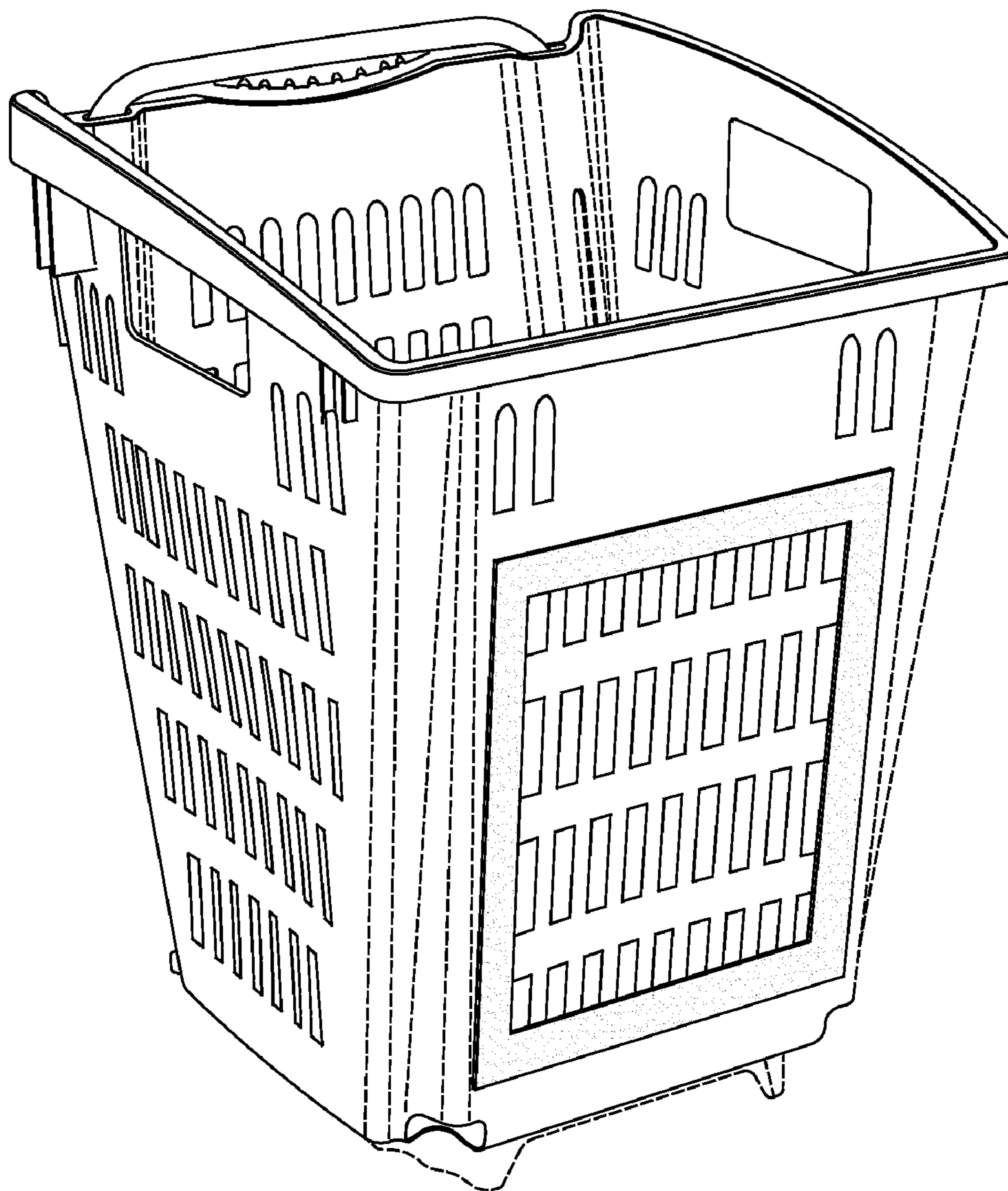

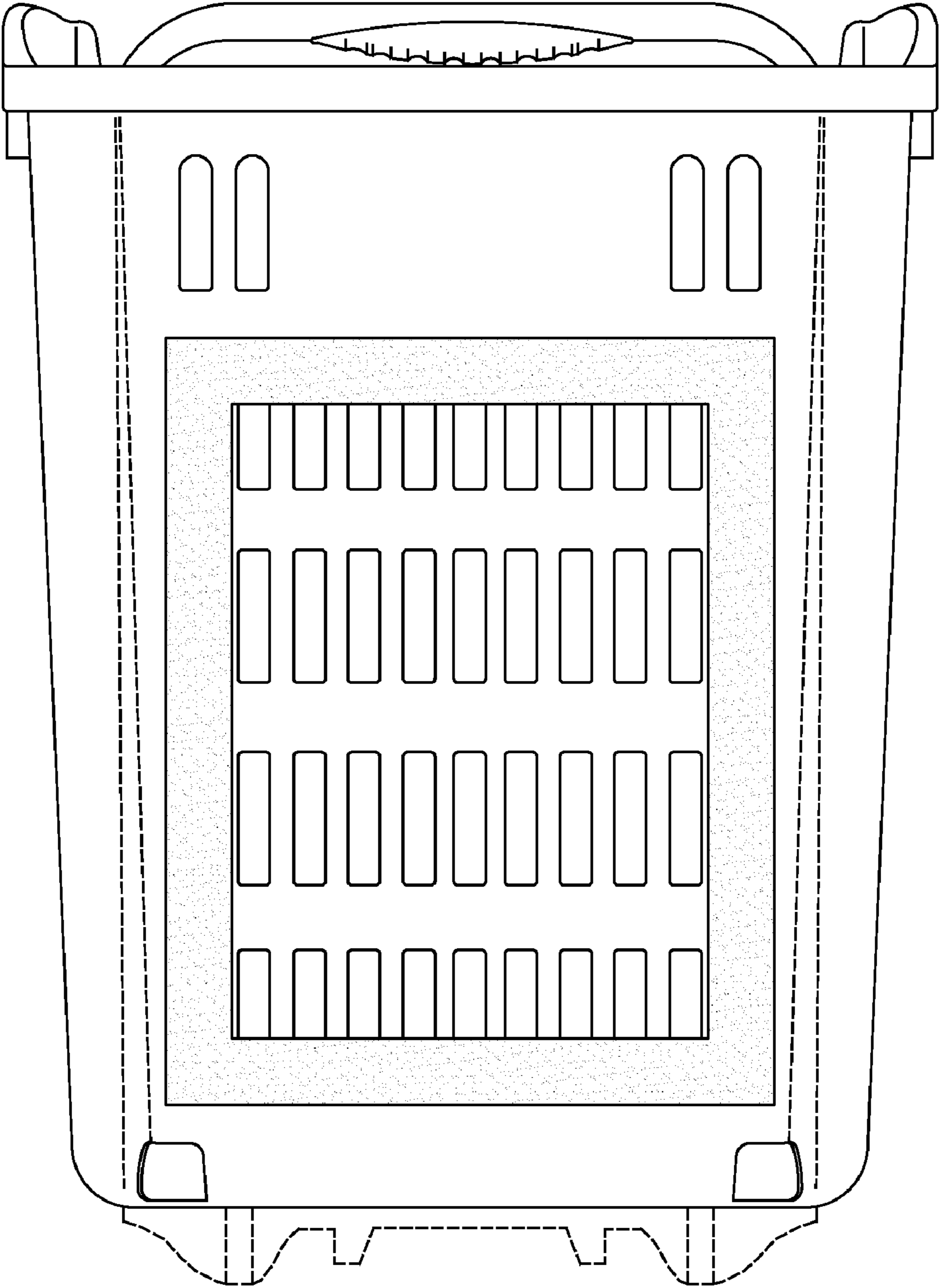

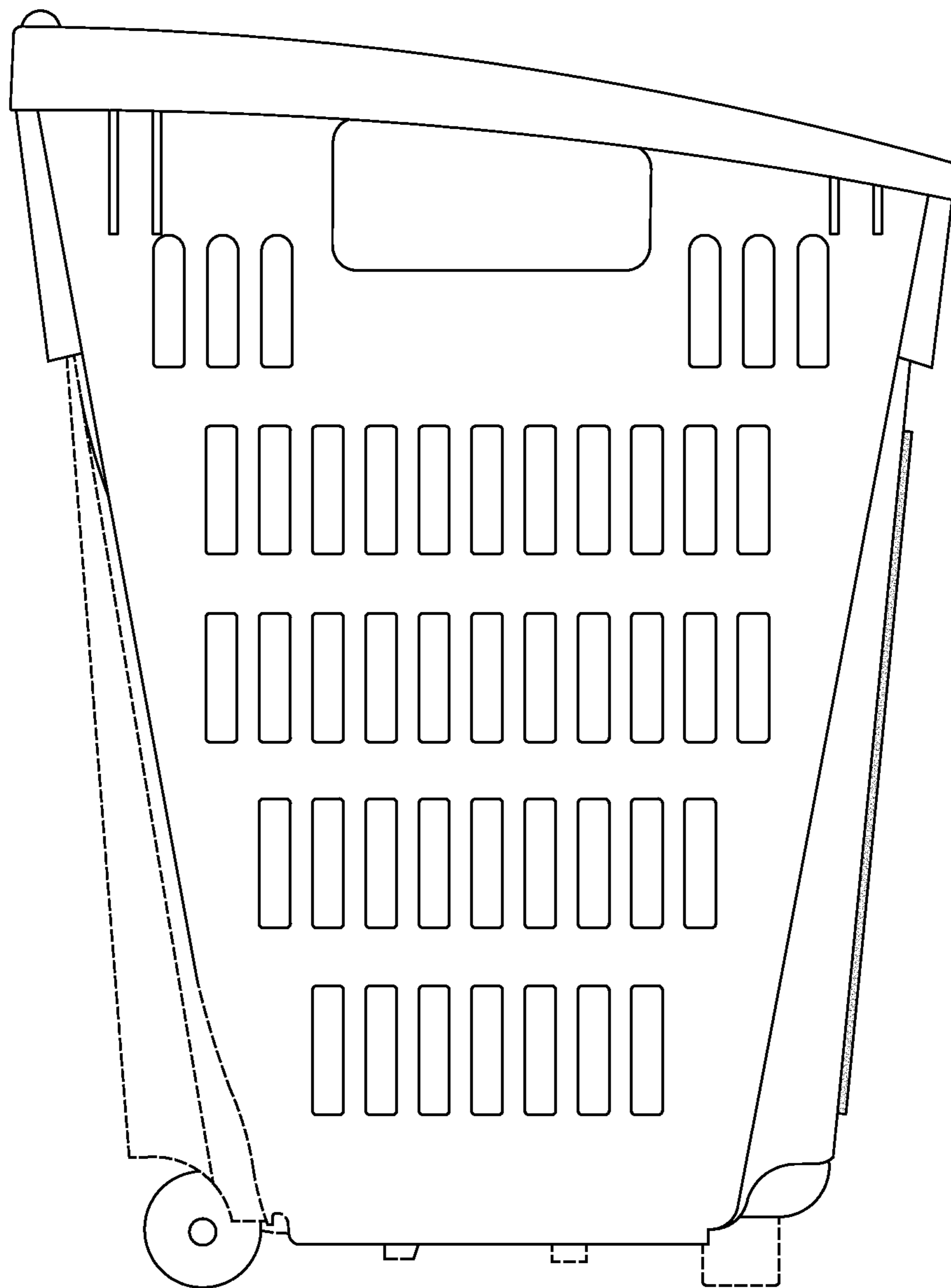

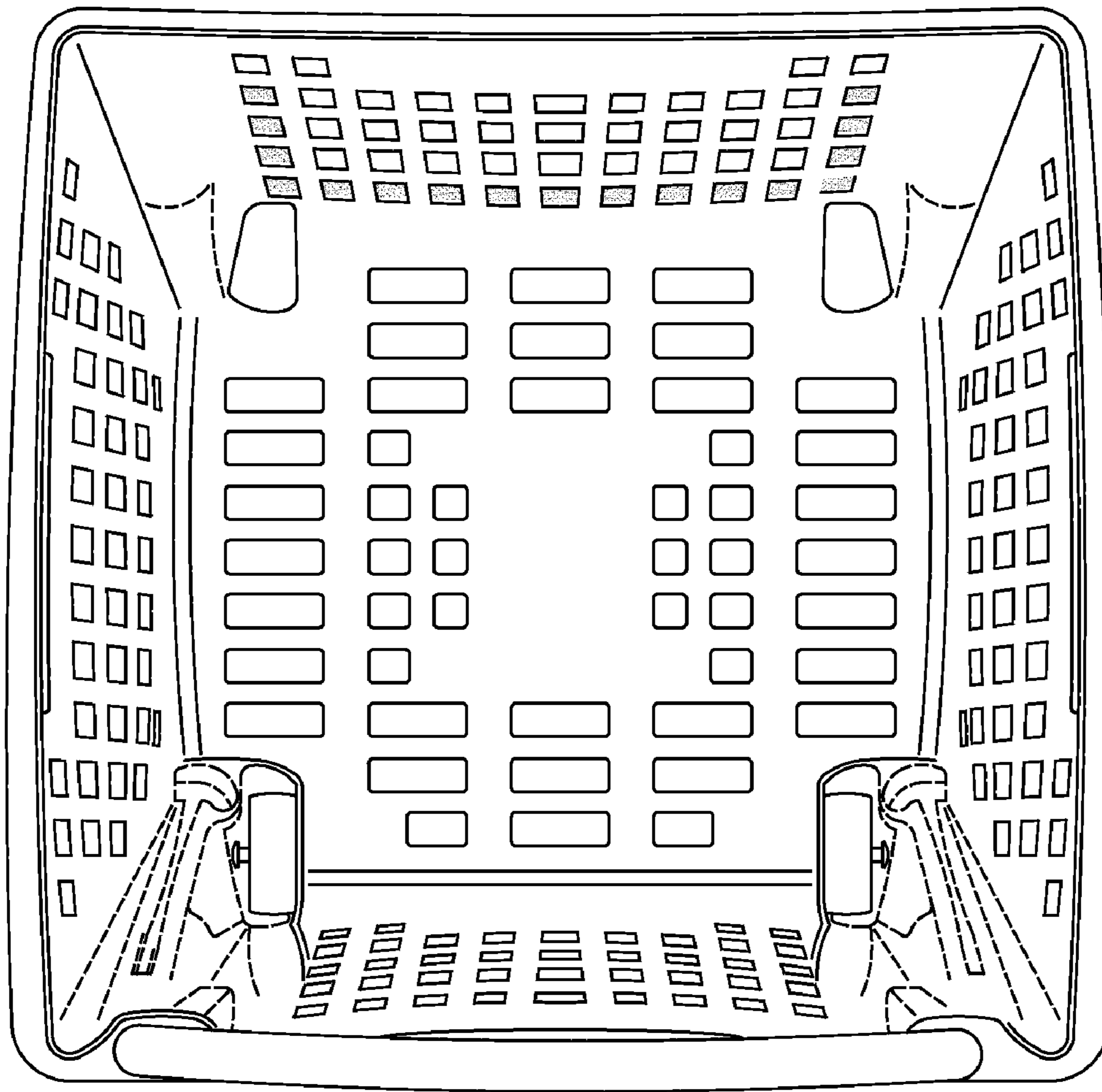

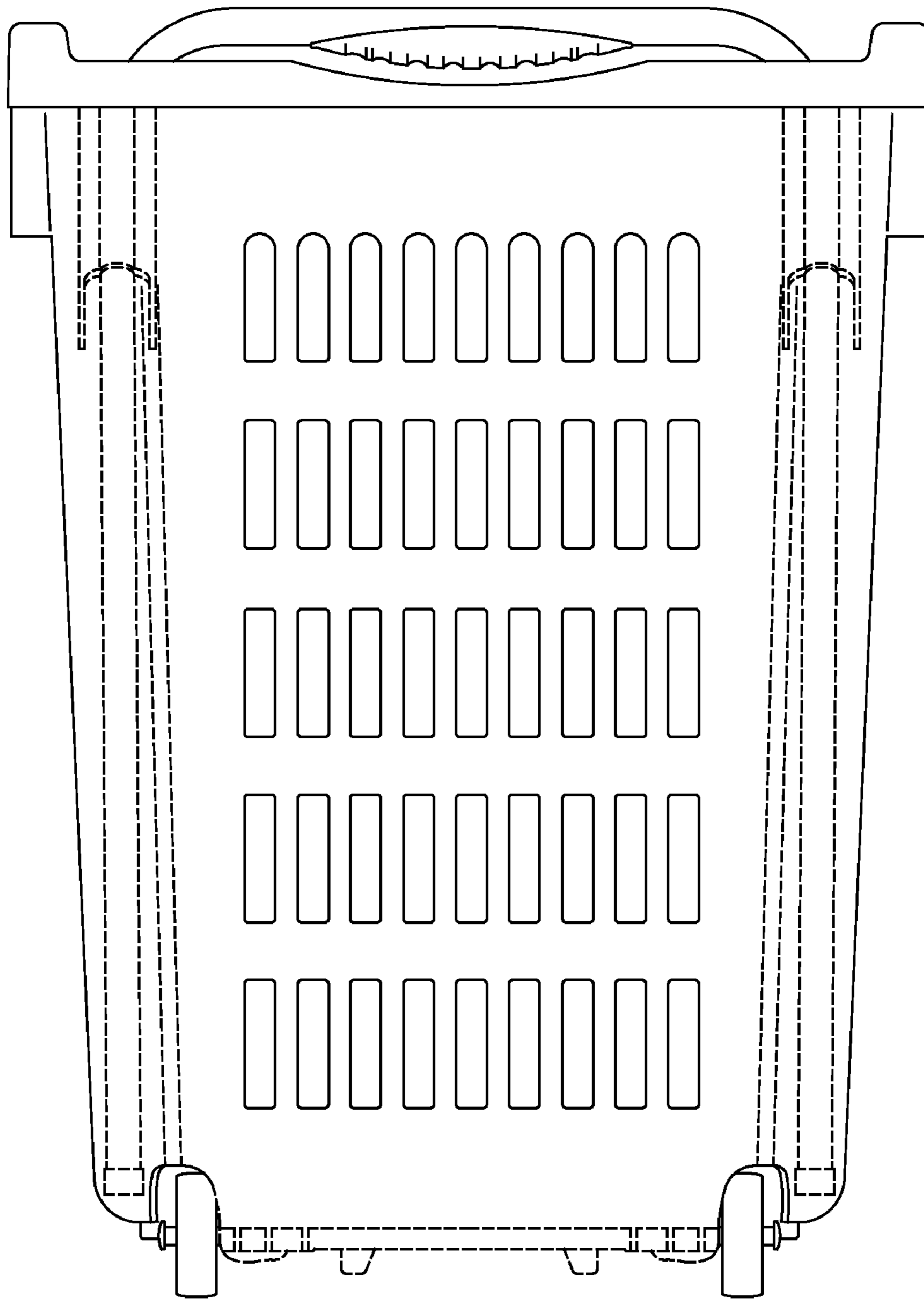

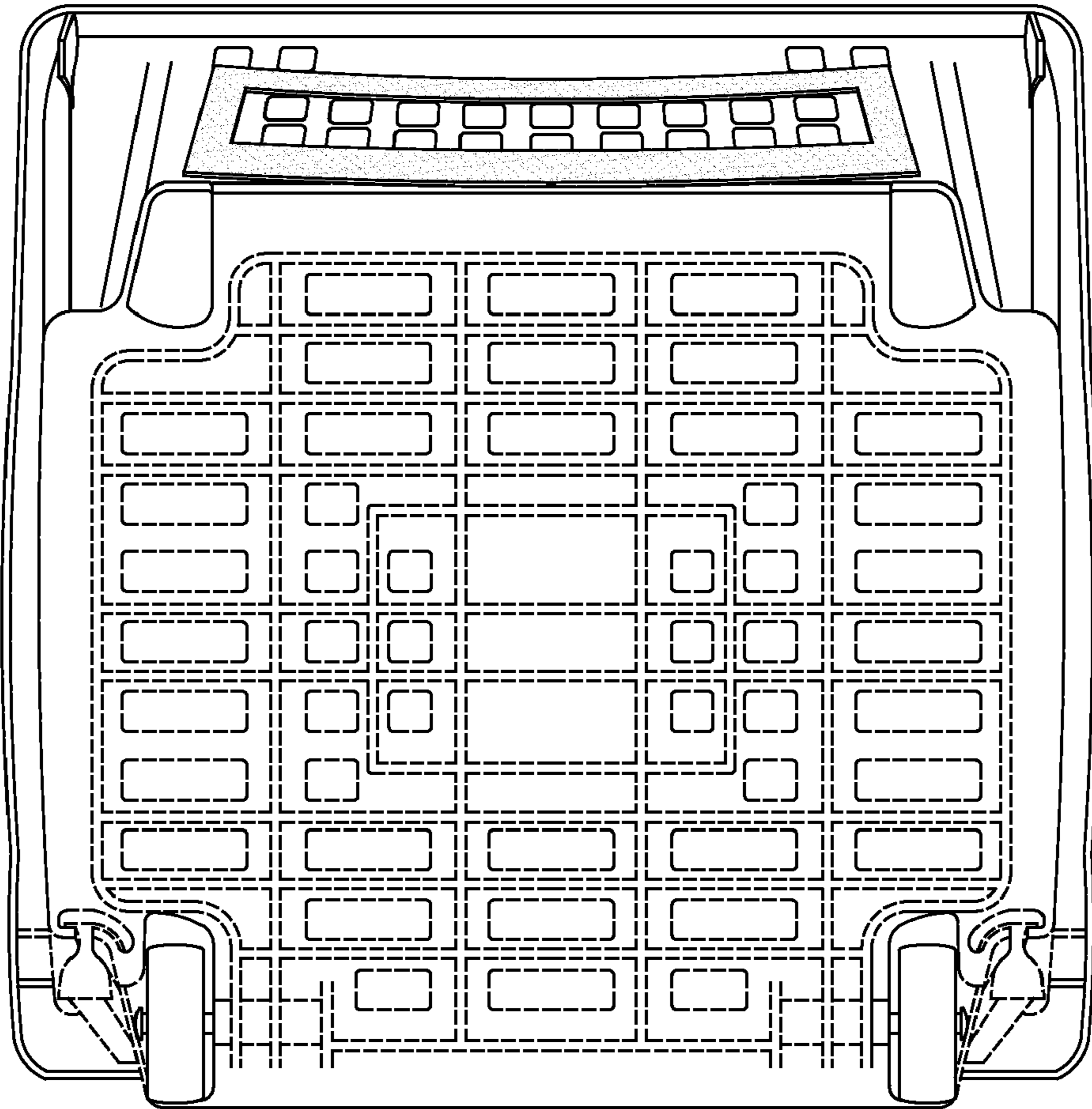

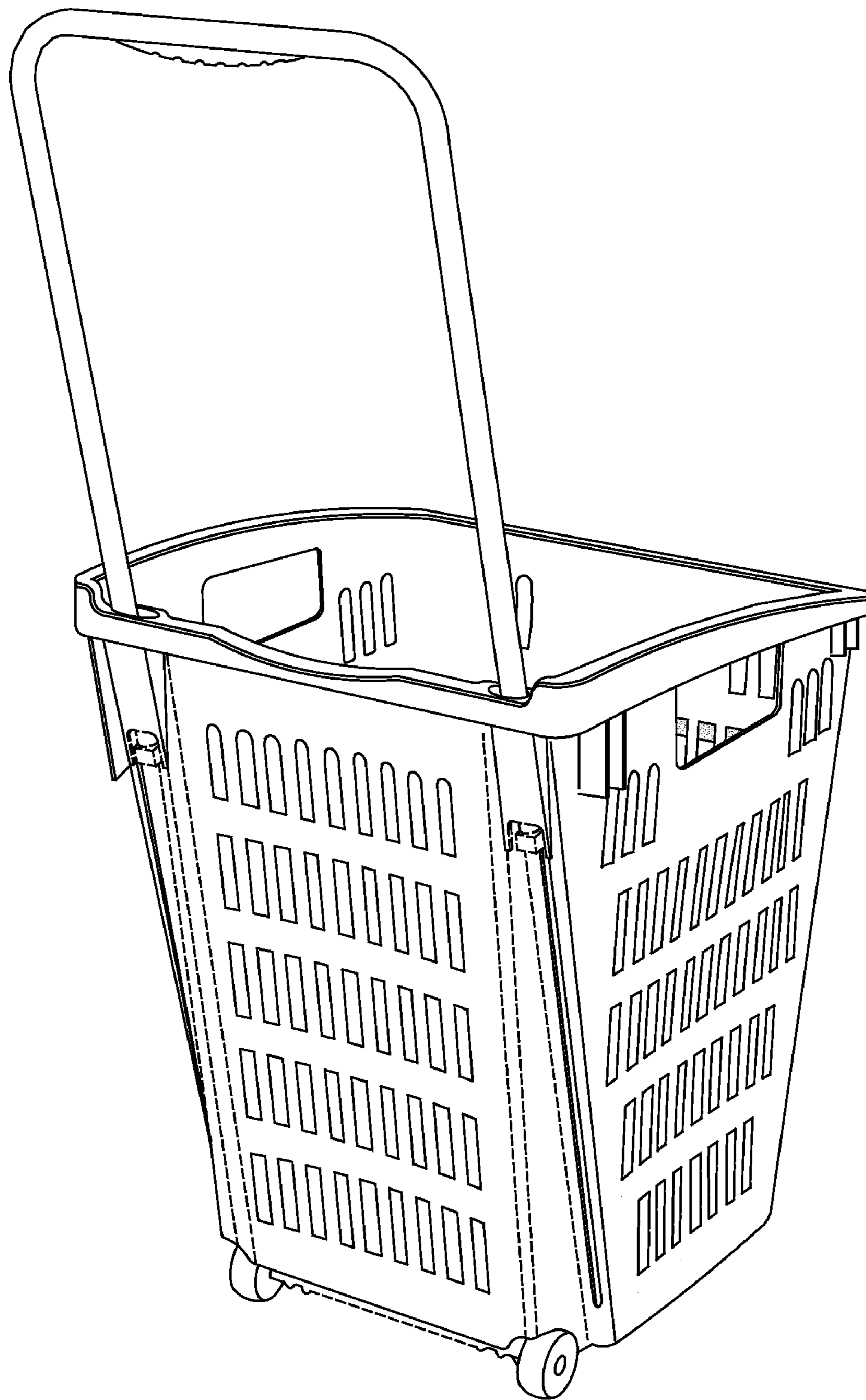
