FIG. 3 is a right side elevational view showing my new design;

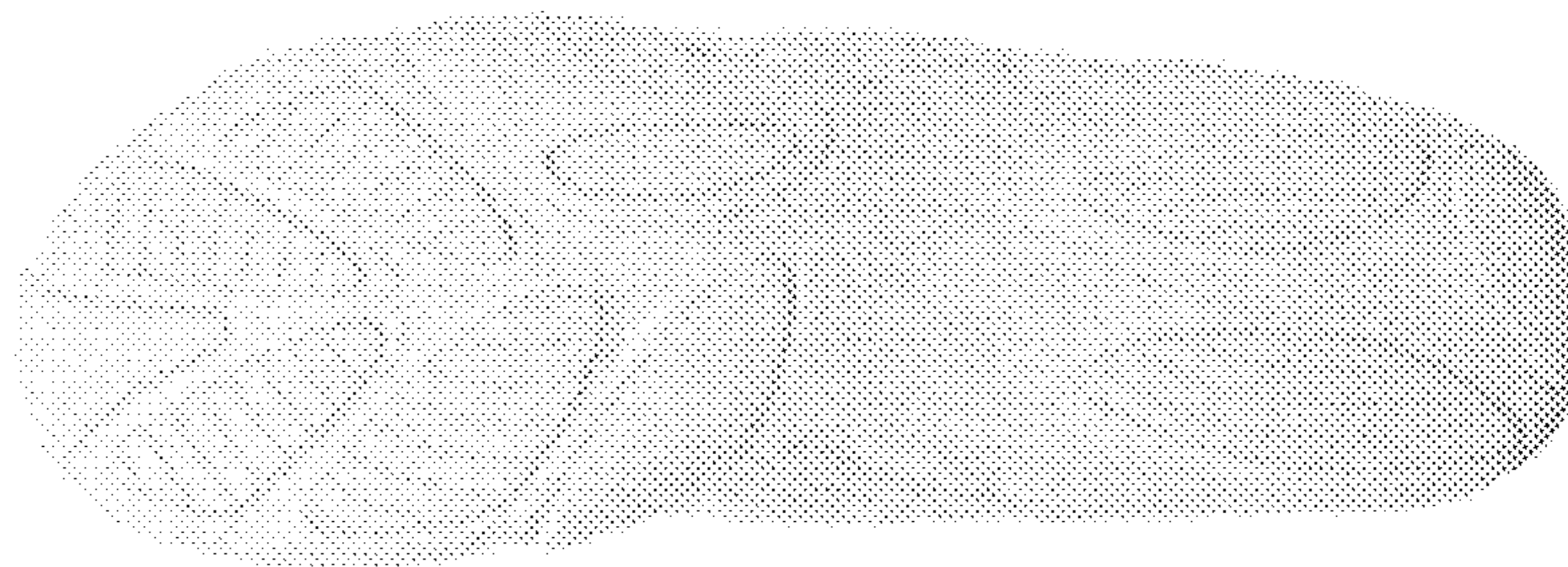
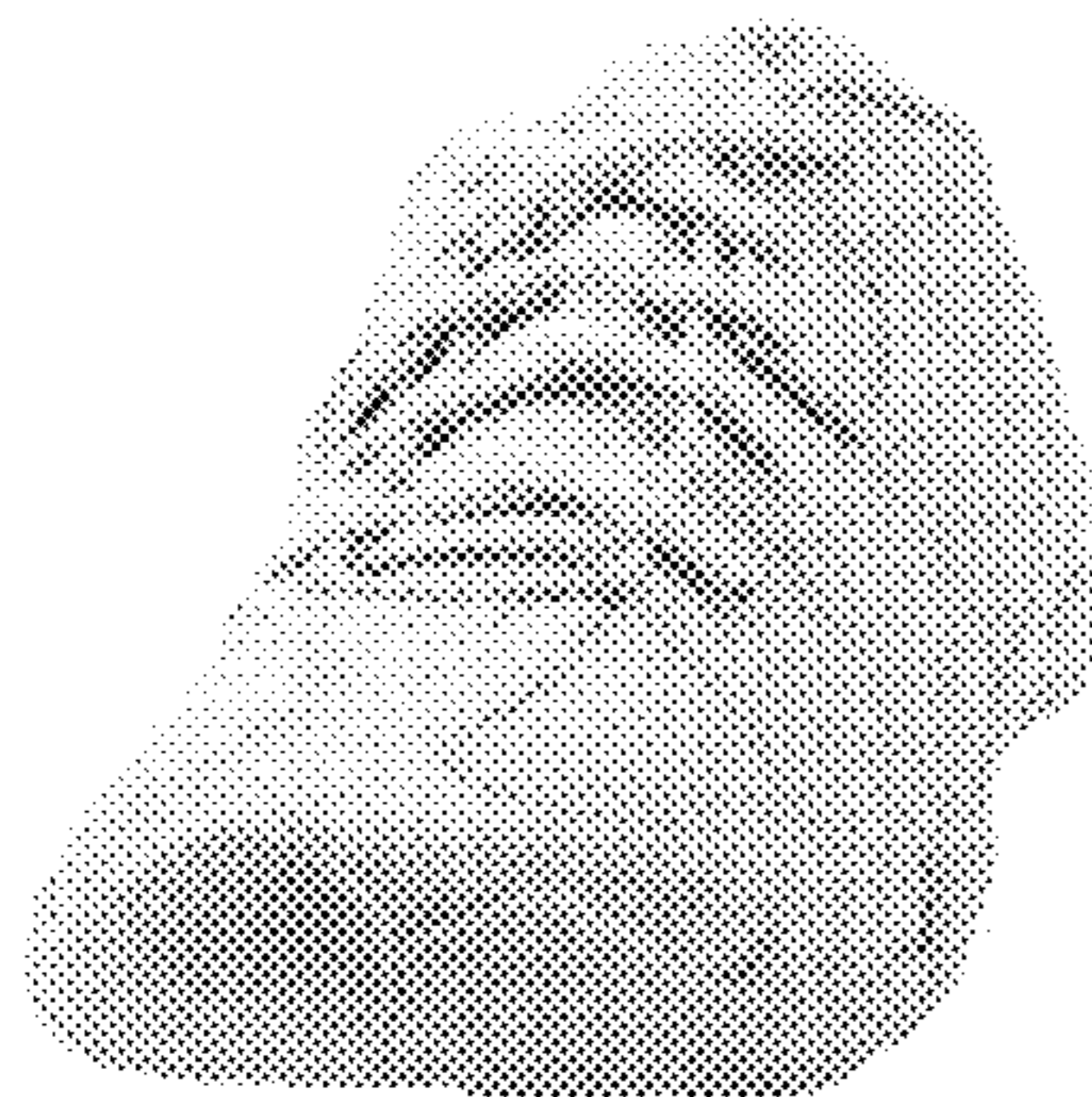
FIG. 4 is a top plan showing my new design.

FIG. 6 is a bottom plan view showing my new design.

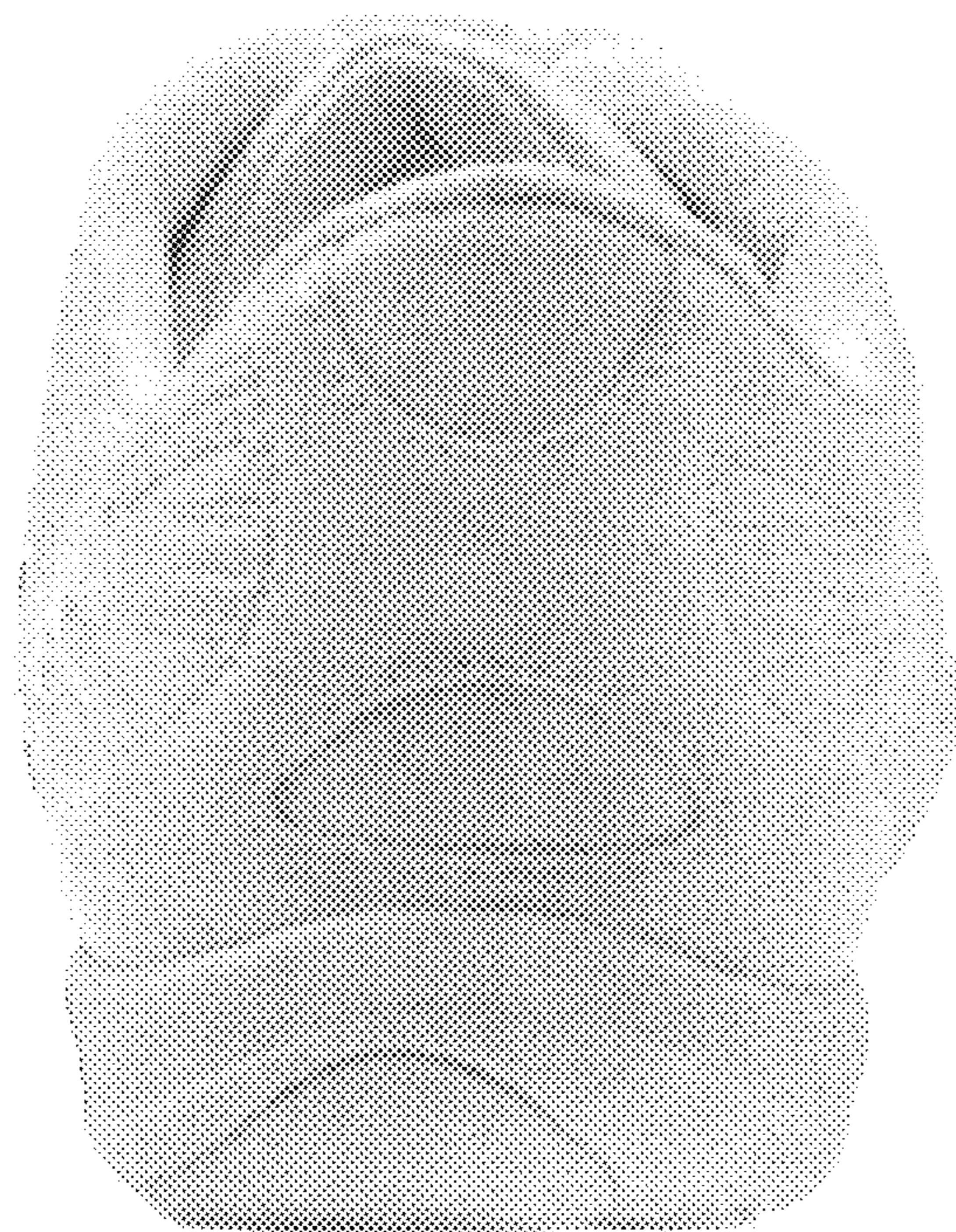
The shoe shown in FIGS. 1-6 is for a left shoe. The right shoe is a mirror image of the left shoe.

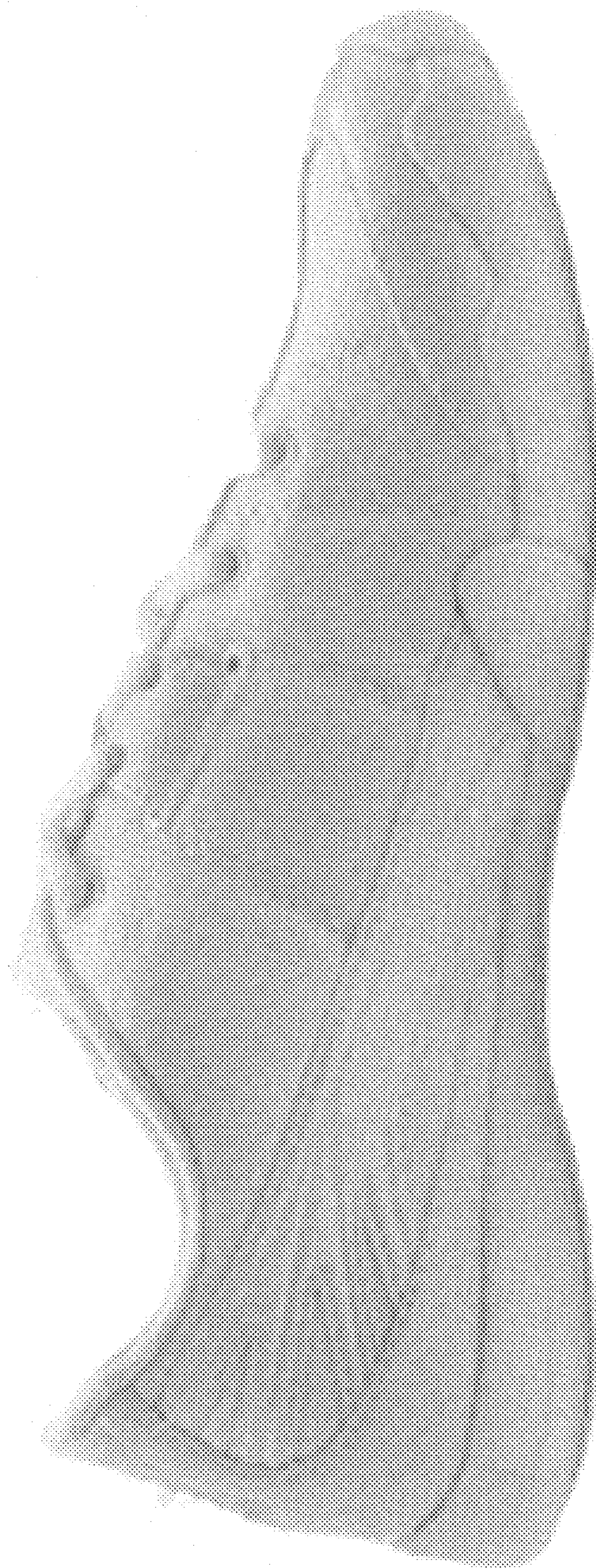

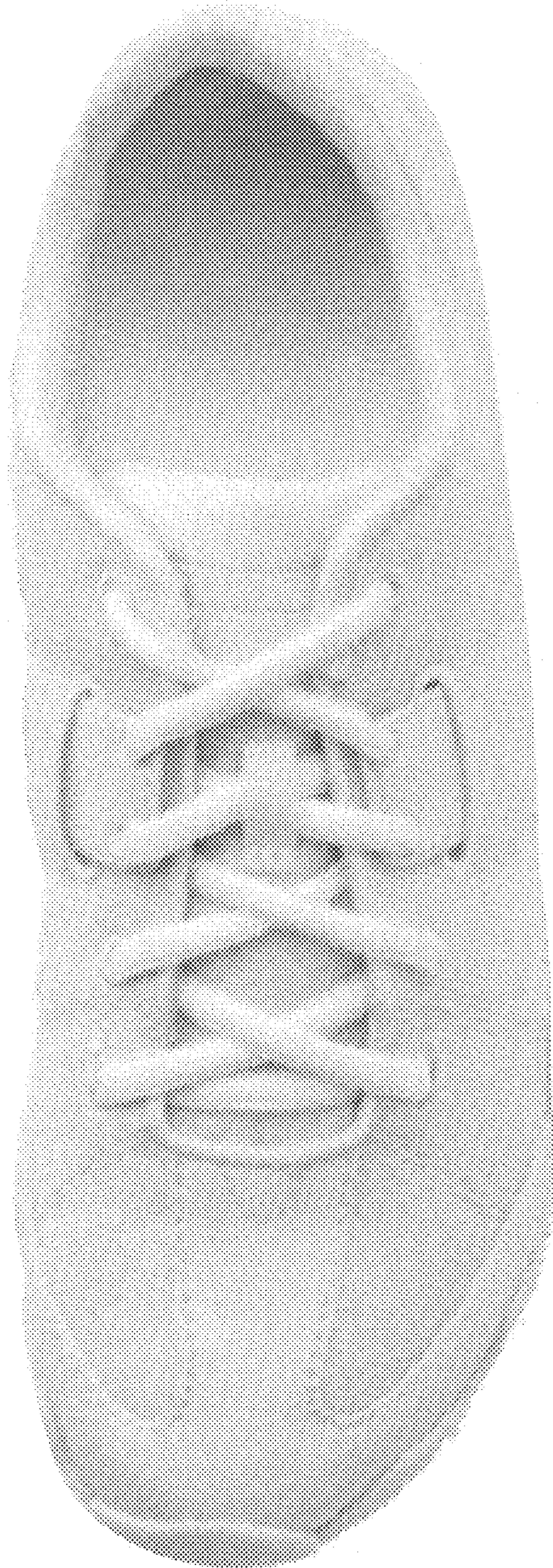
