 FIG. 7 is a bottom view thereof.

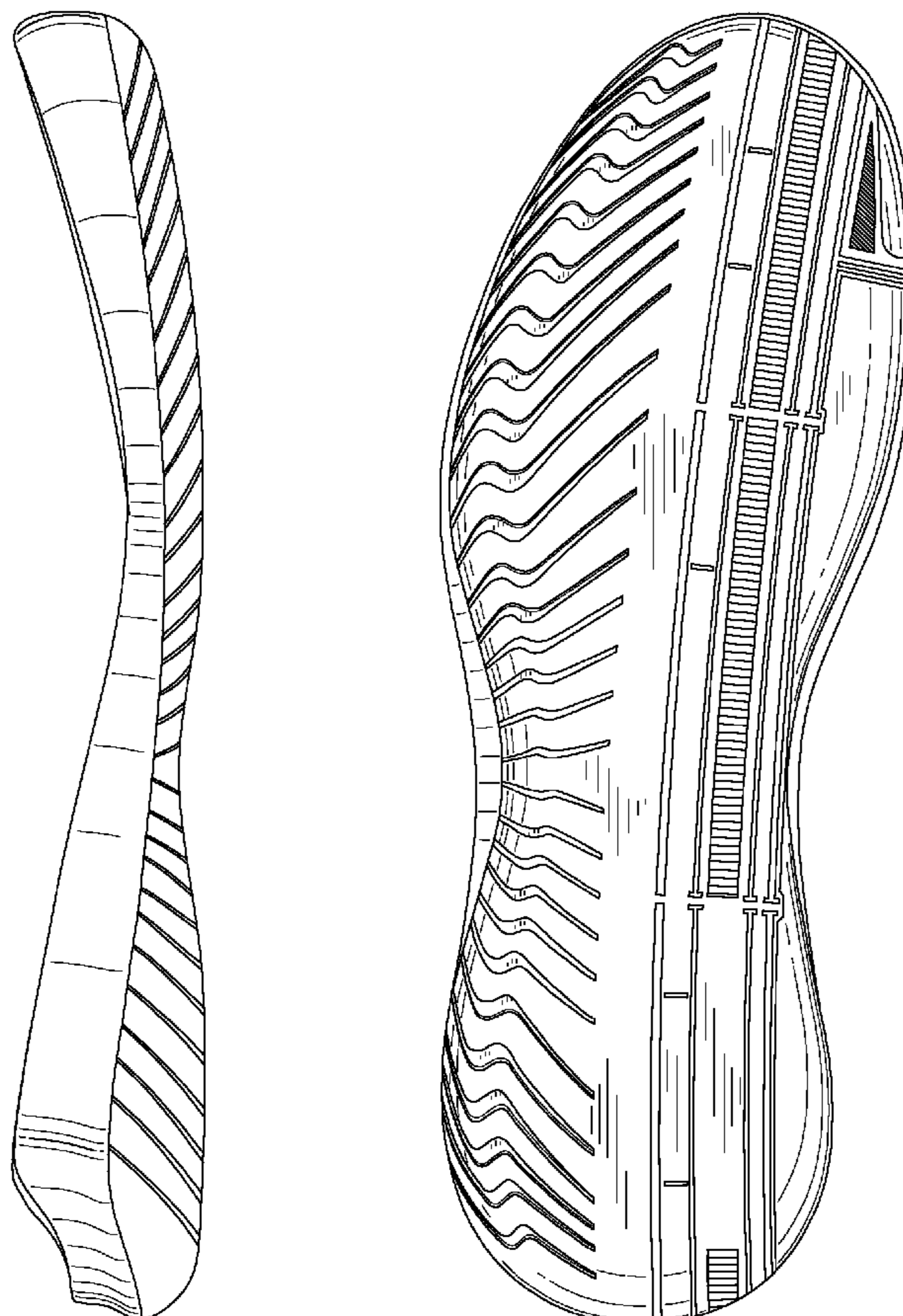
A second embodiment of our design is a mirror image of the embodiment depicted.

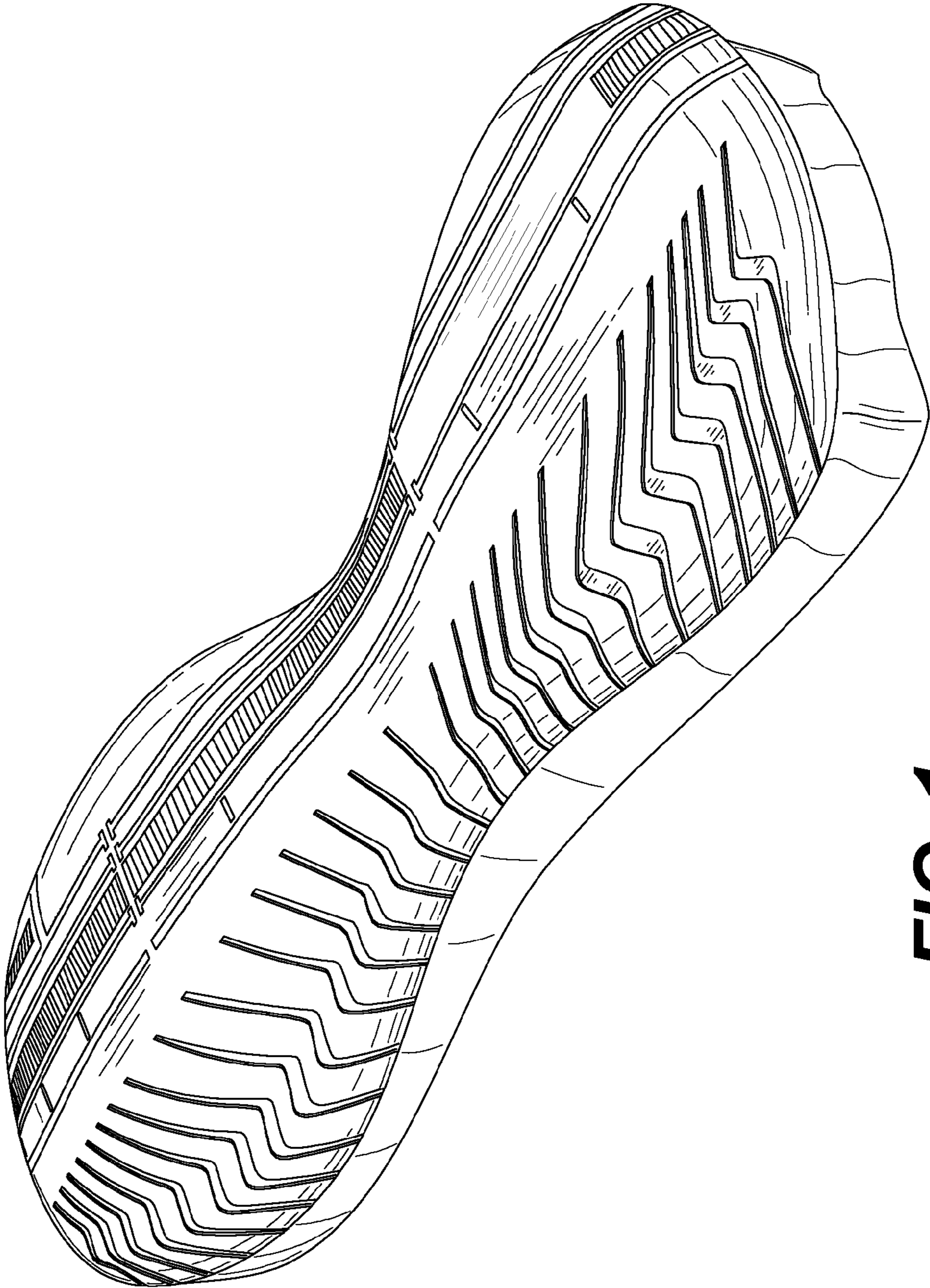

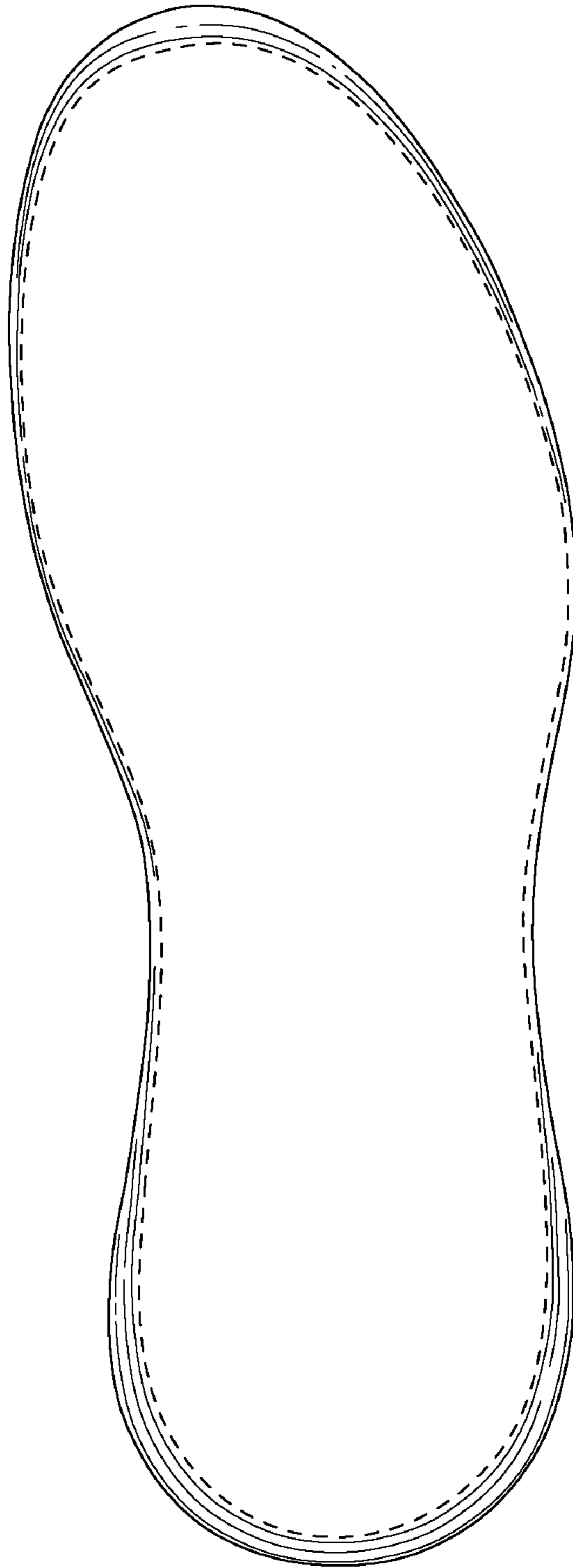

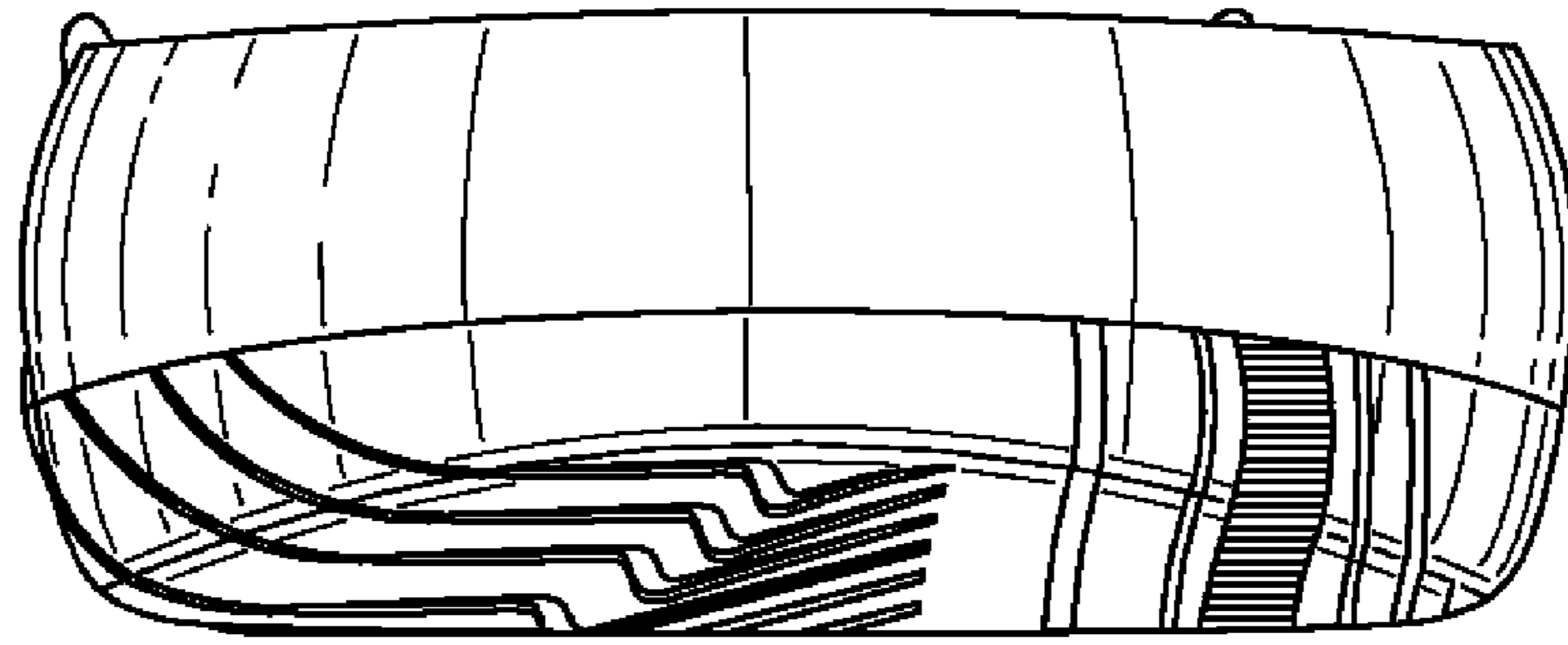




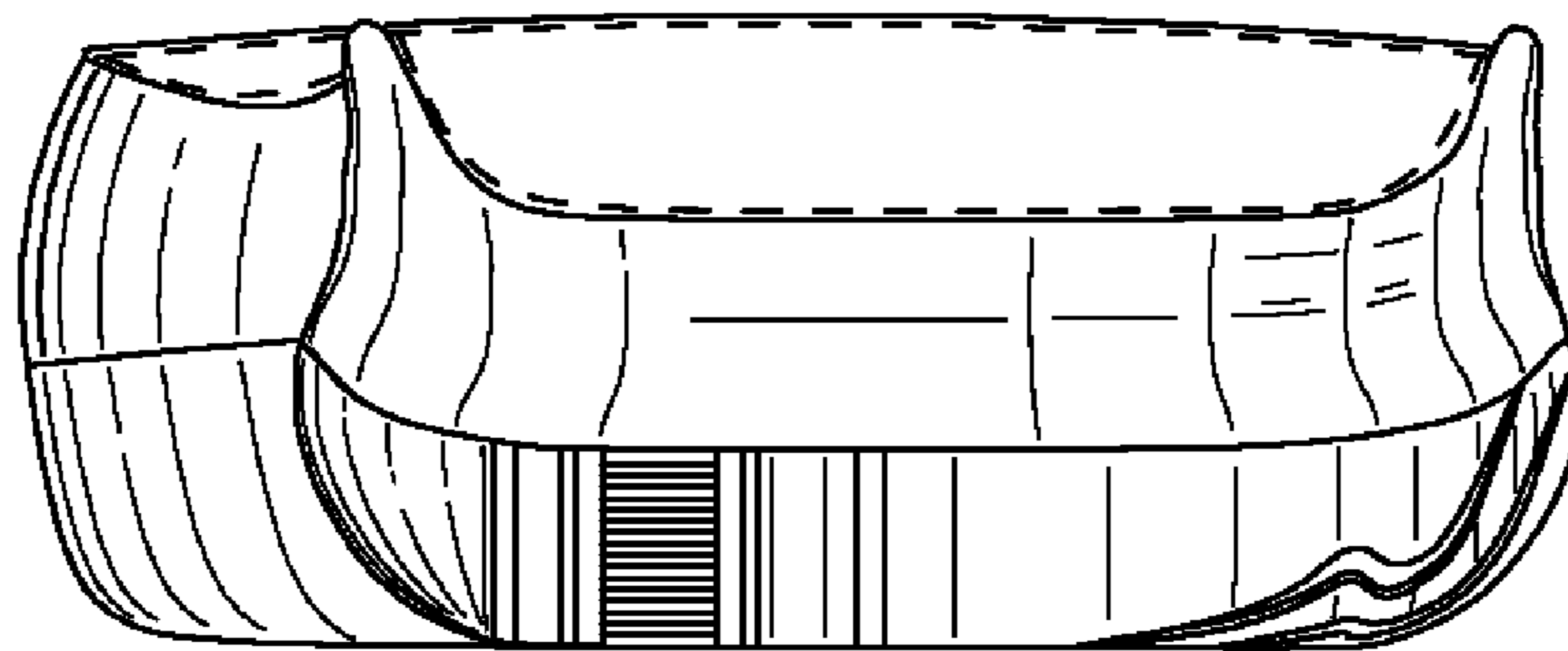

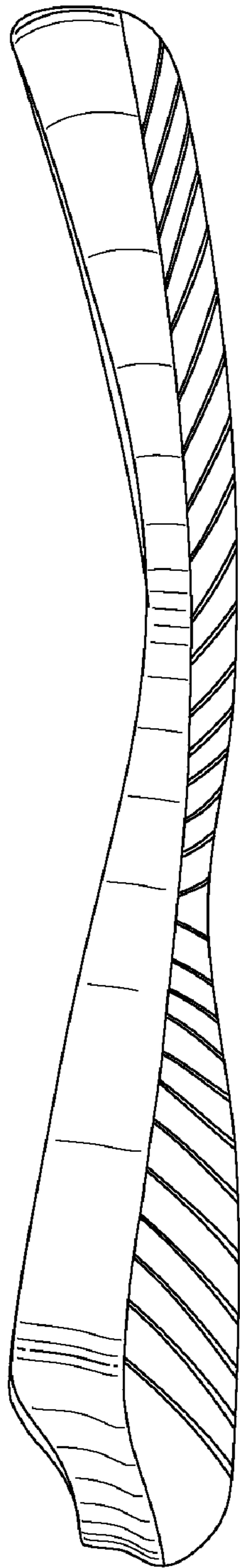

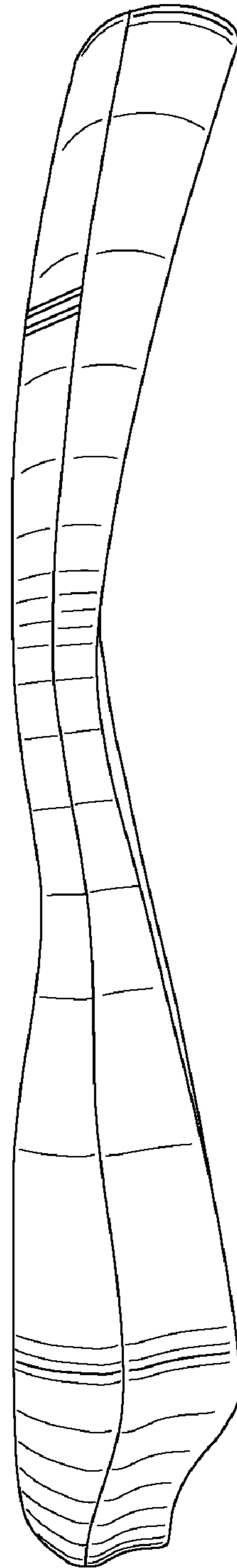

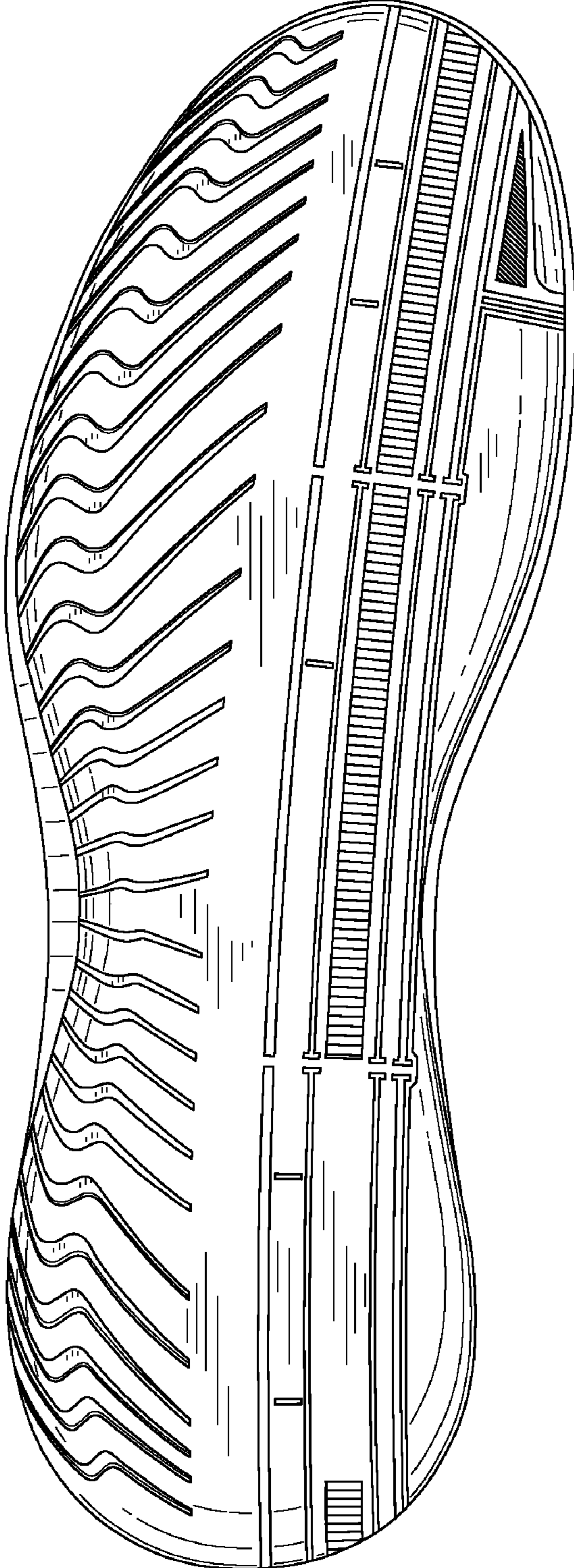
