(57) **CLAIM**

I claim, the ornamental design for a writing desk, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a writing desk, showing my new design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a side view thereof taken from the right of FIG. 3;

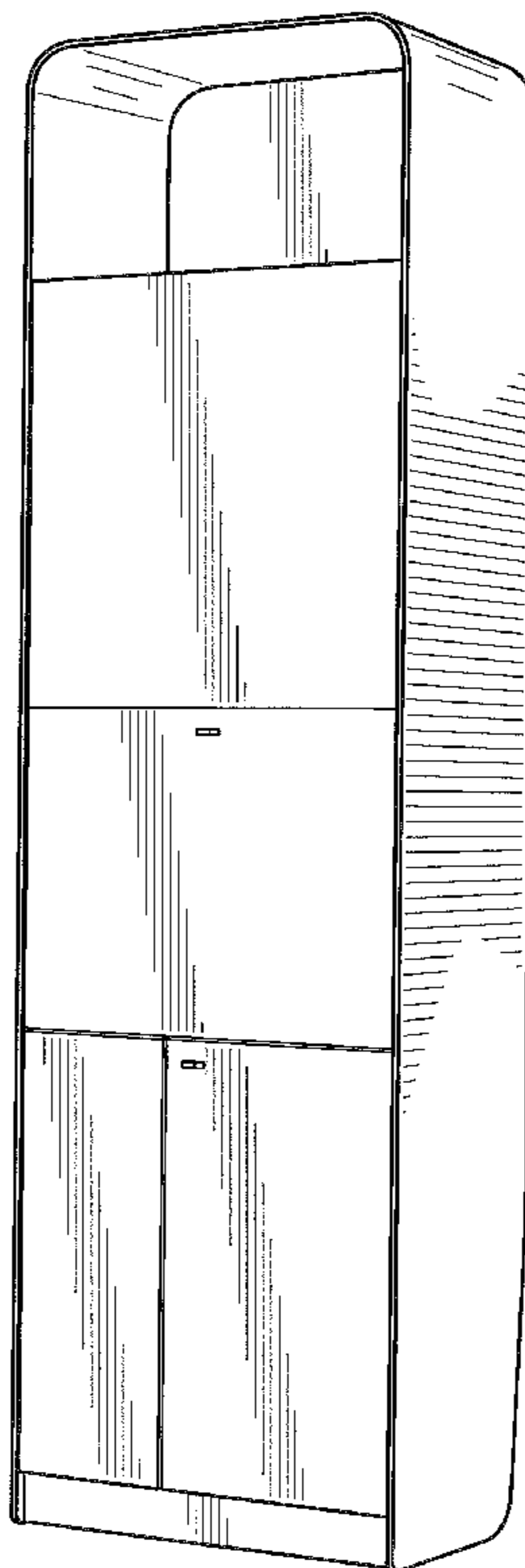
FIG. 5 is an opposite side view thereof taken from the left of FIG. 3;

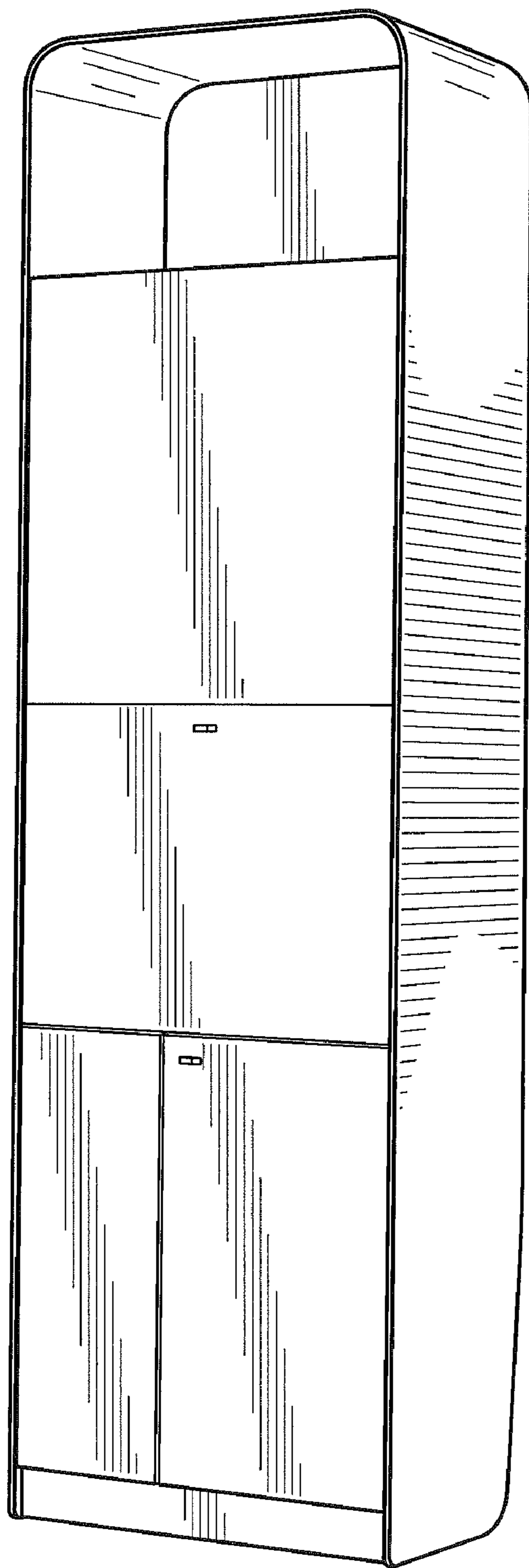

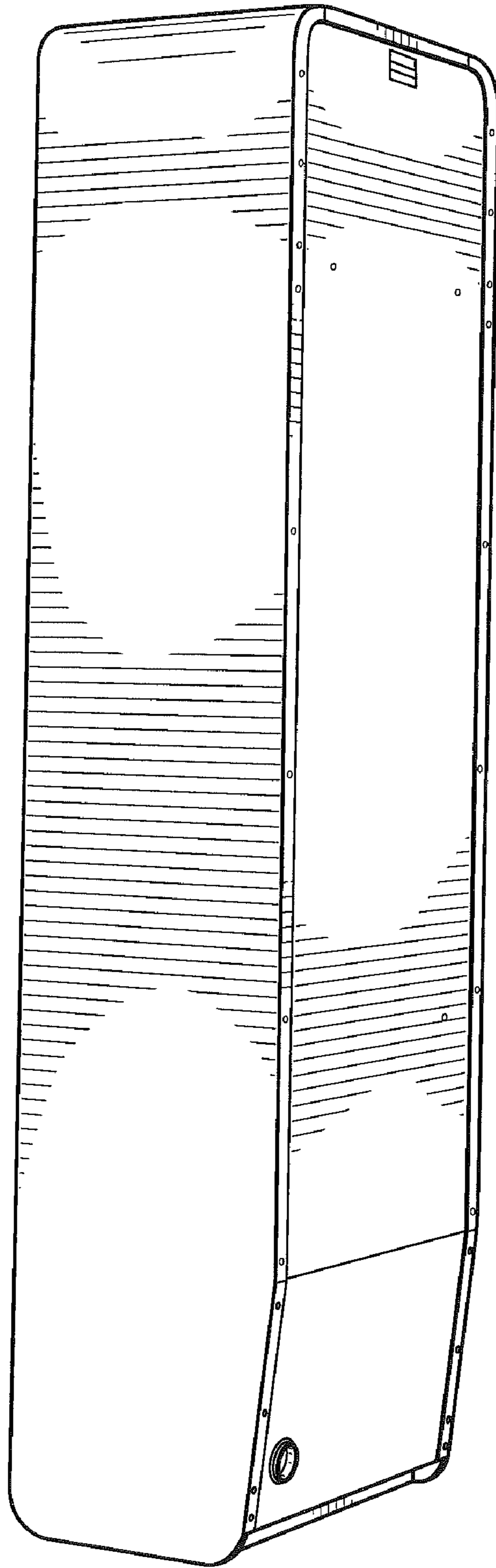

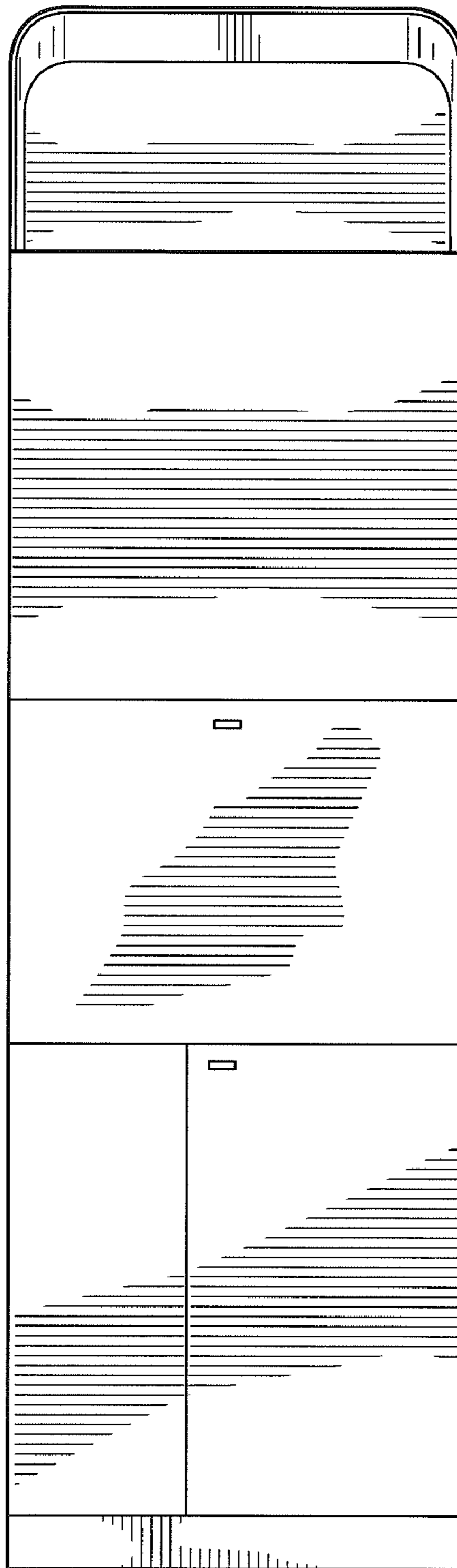

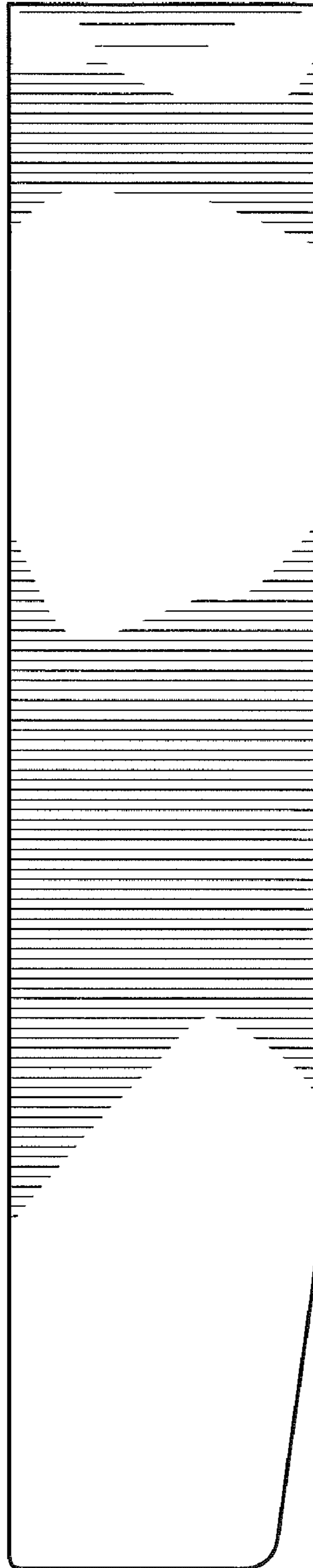

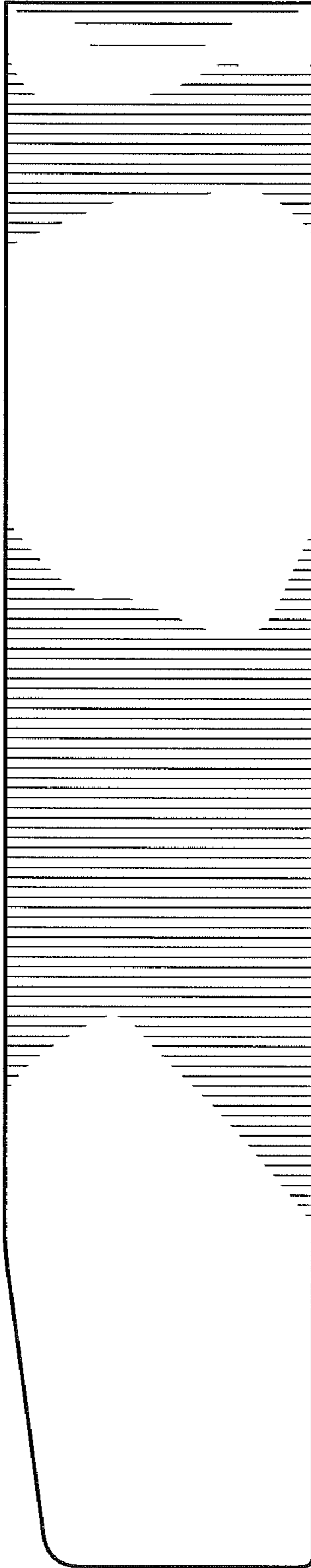

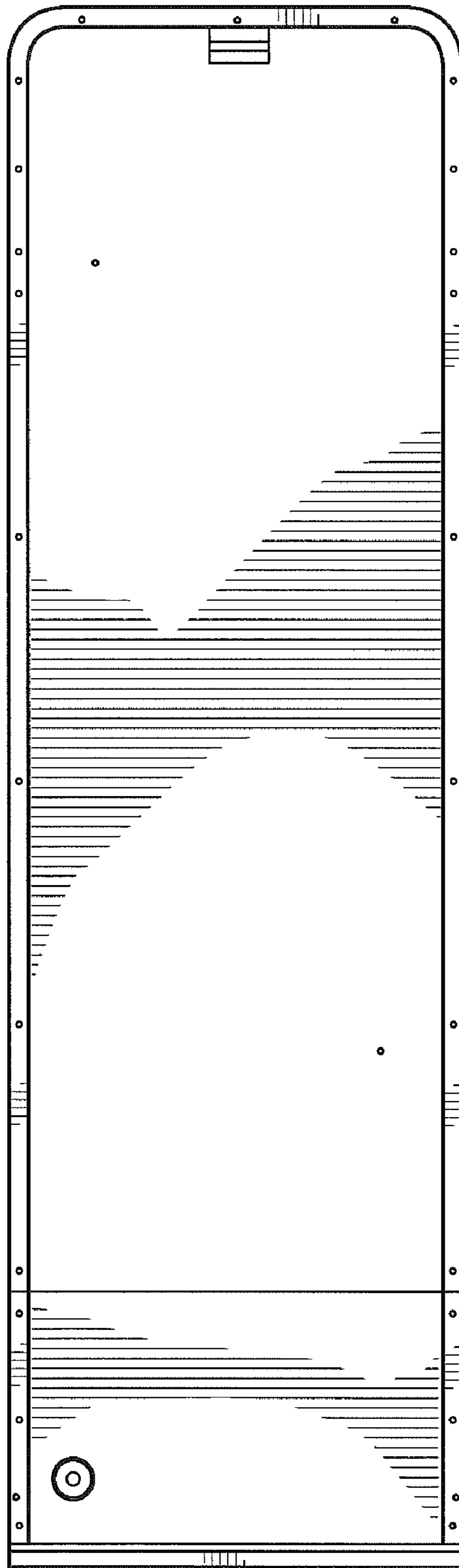

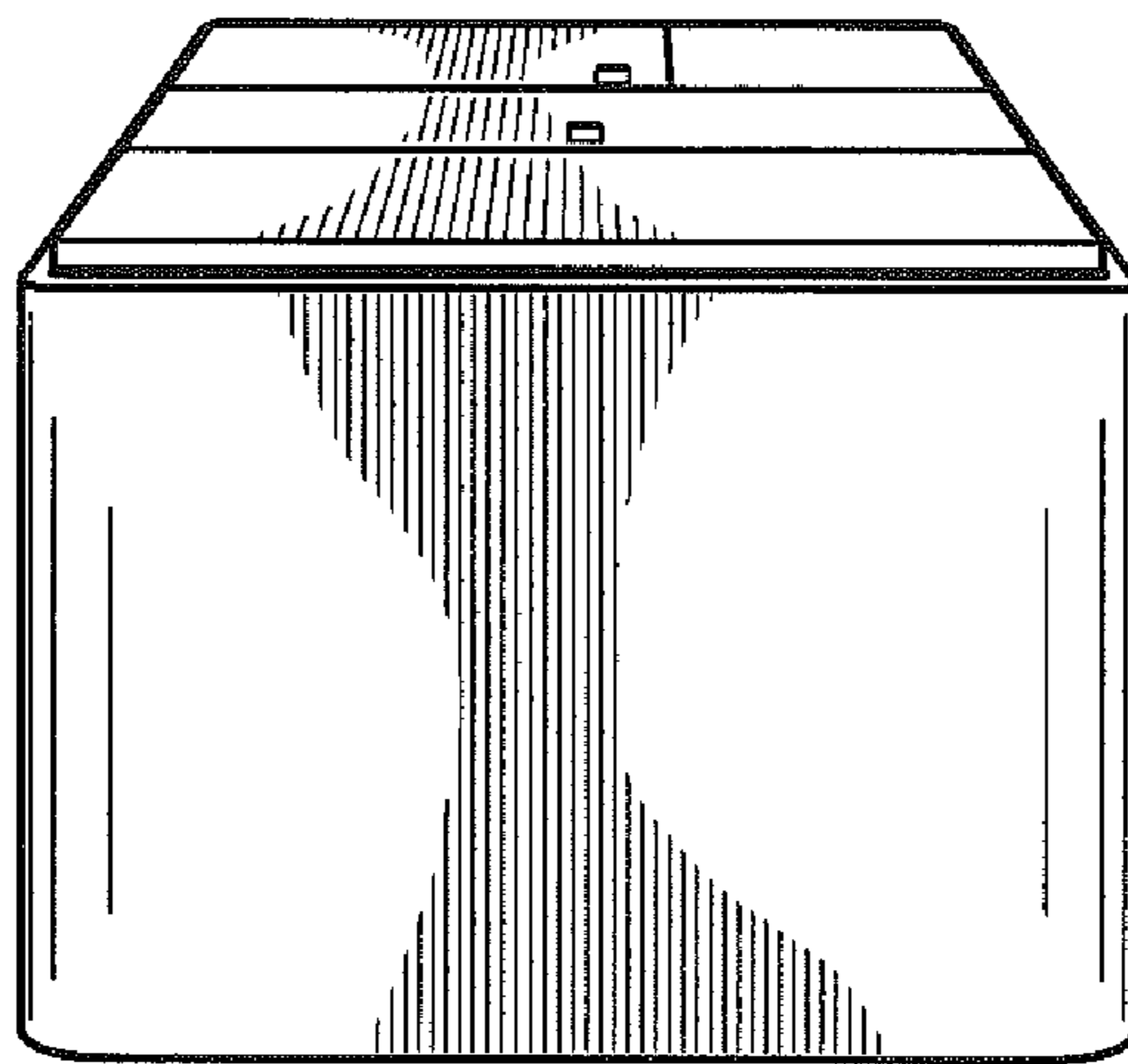
