(57) **CLAIM**

I claim the ornamental design for a hanging disk holder, as
shown and described.

DESCRIPTION

FIG. 1 is a front/right/top perspective view of a first embodi-
ment of the hanging disk holder shown without the tab for
convenience;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof; and

FIG. 6 is a left side elevational view thereof, for which the
right side elevational view thereof would be a mirror image
thereof.

FIG. 7 is a front/left/top perspective view of a second embodi-
ment, further including a tab in the upper left pocket at a first
location;

FIG. 8 is a front elevational view of the hanging disk holder
and tab of FIG. 7 with the tab at the first location;

FIG. 9 is a rear elevational view of the hanging disk holder
and tab of FIG. 7 with the tab at the first location;

FIG. 10 is a front/left/top perspective view thereof, with the
tab in the upper left pocket at a second location;

FIG. 11 is a front elevational view of the hanging disk holder
and tab of FIG. 10 with the tab at the second location;

FIG. 12 is a front/left/top perspective view thereof, with the
tab in the upper right pocket at a third location;

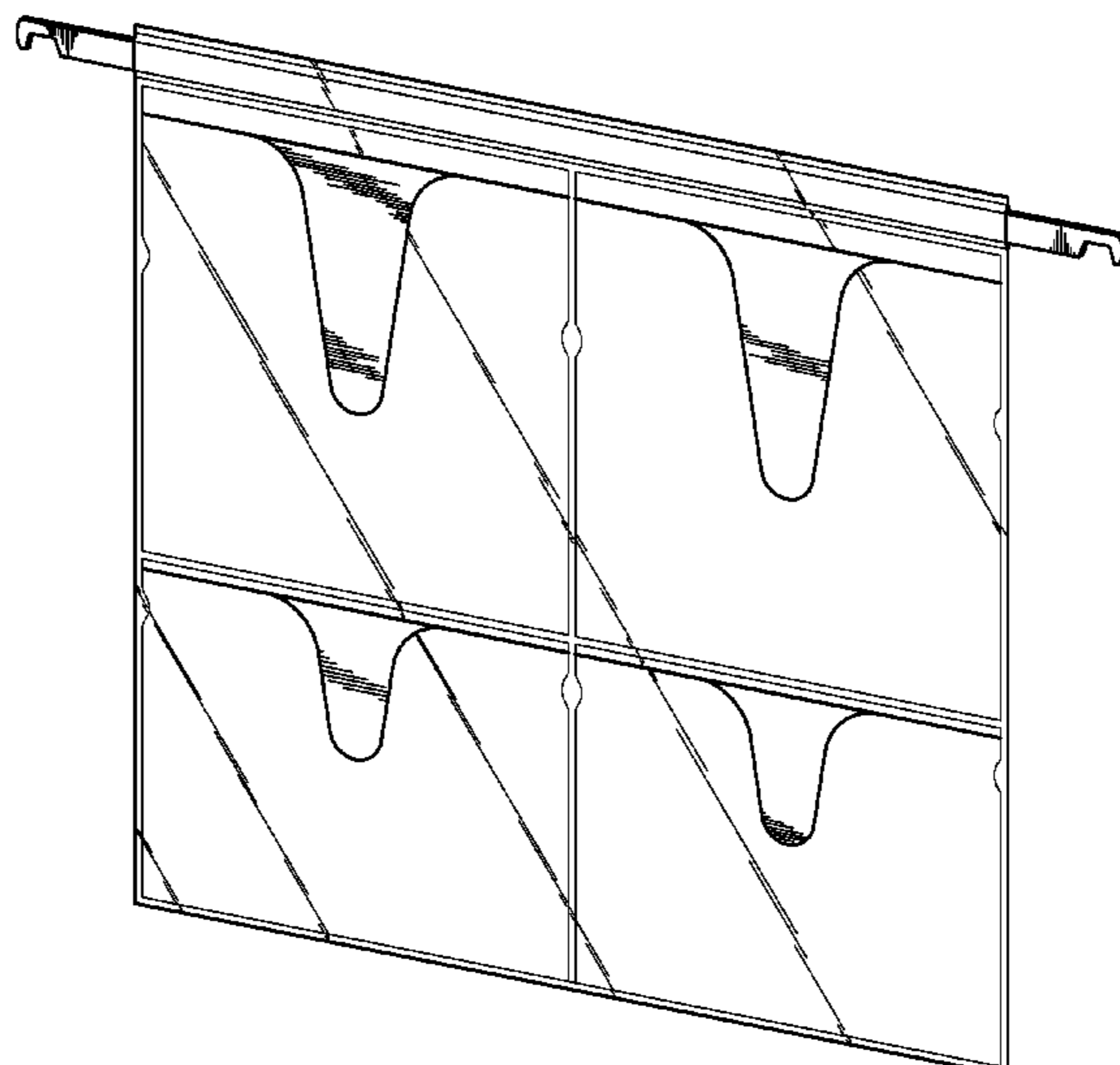
FIG. 13 is a front elevational view of the hanging disk holder
and tab of FIG. 12 with the tab at the third location;

FIG. 14 is a front/left/top perspective view thereof, with the
tab in the upper right pocket at a fourth location; and,

FIG. 15 is a front elevational view of the hanging disk holder
and tab of FIG. 14 with the tab at the fourth location.

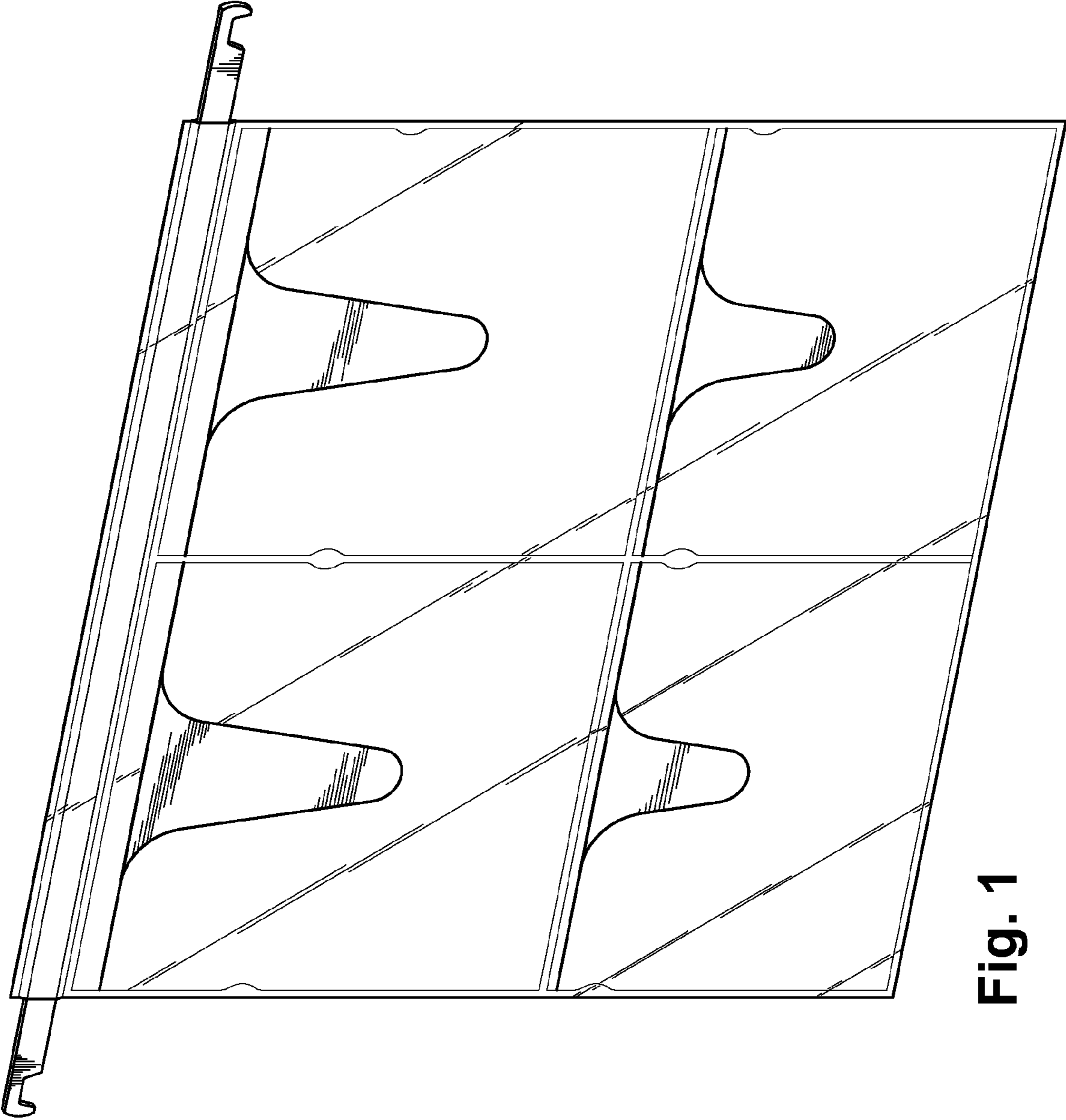

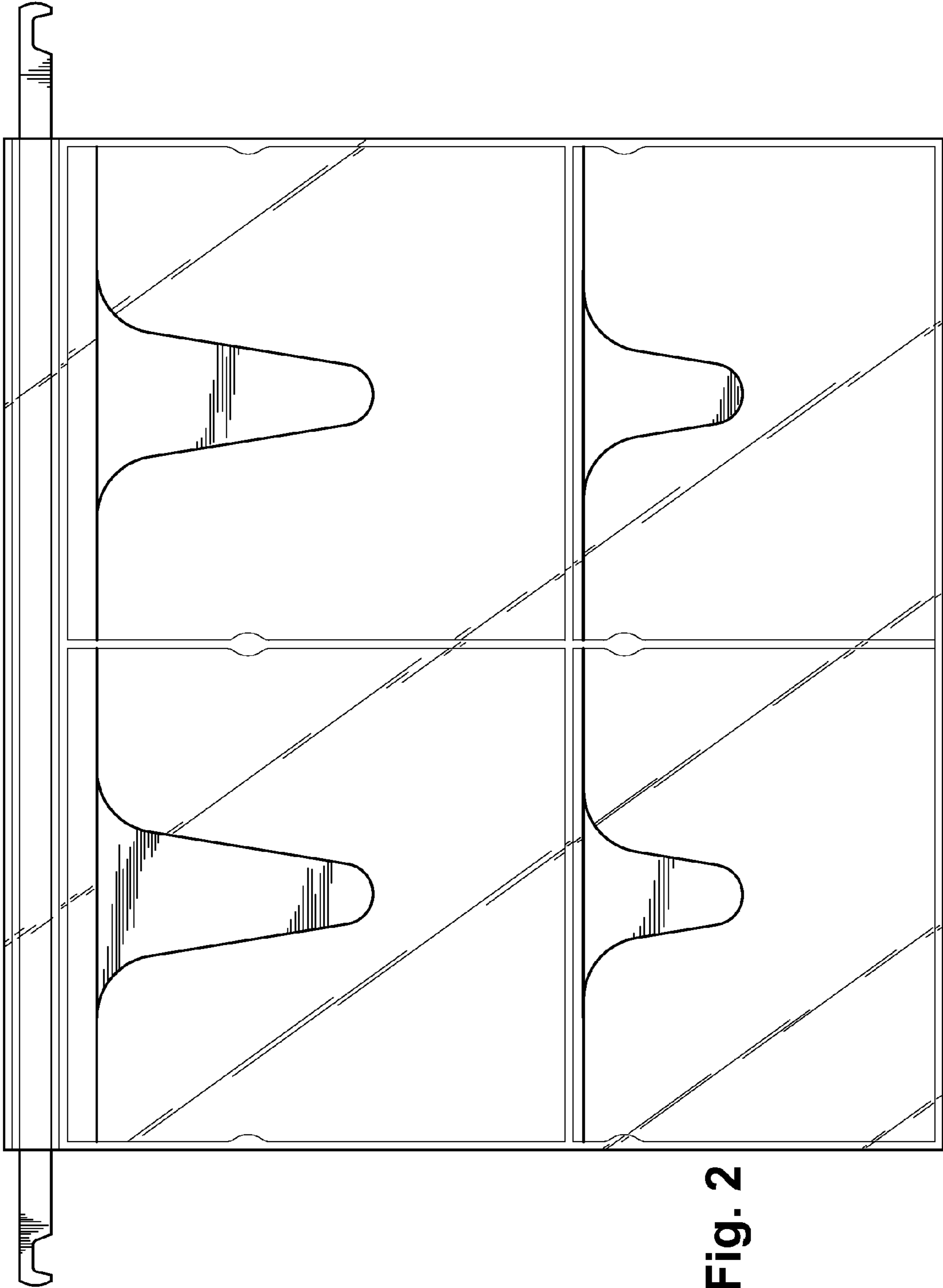

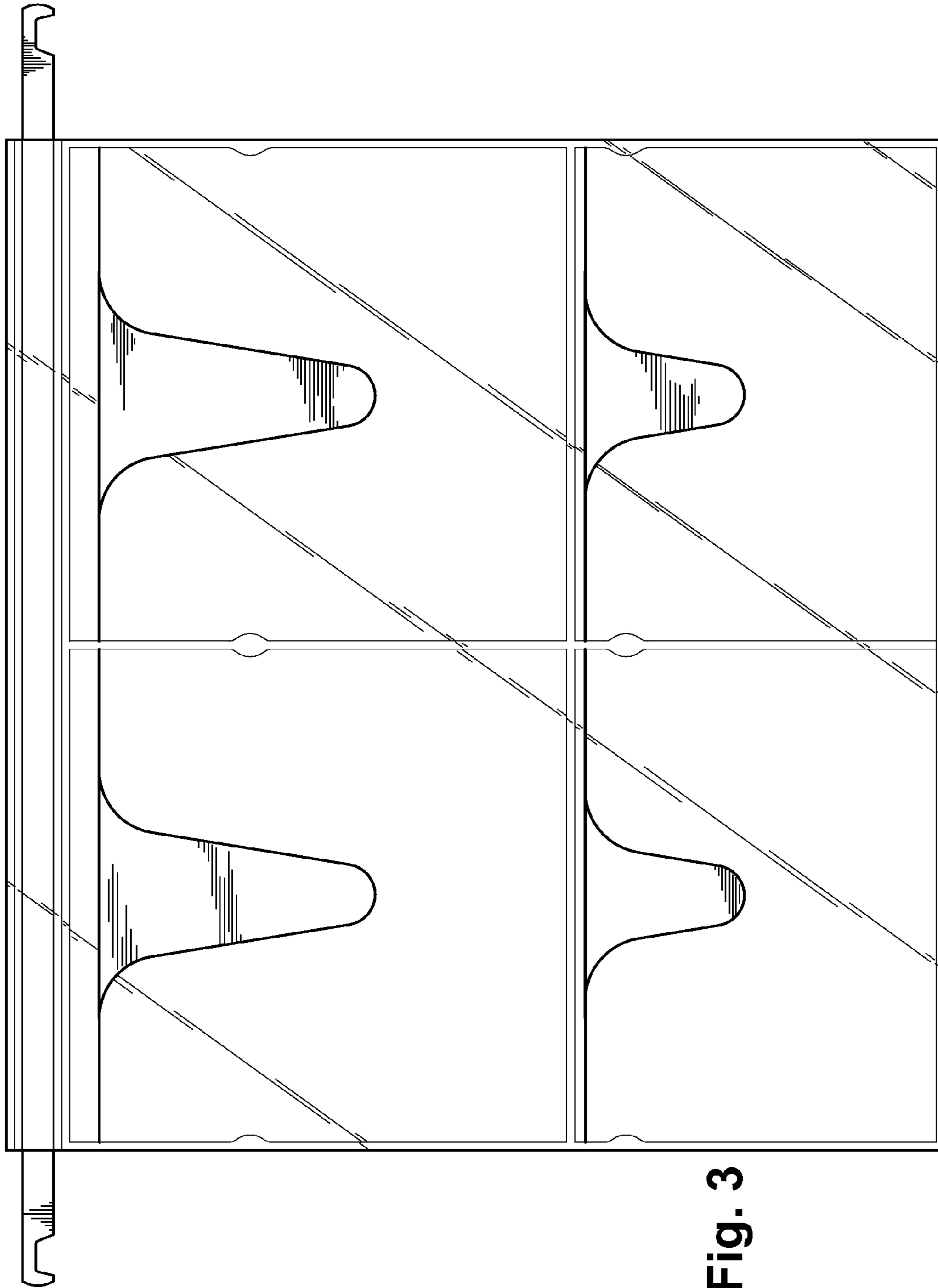

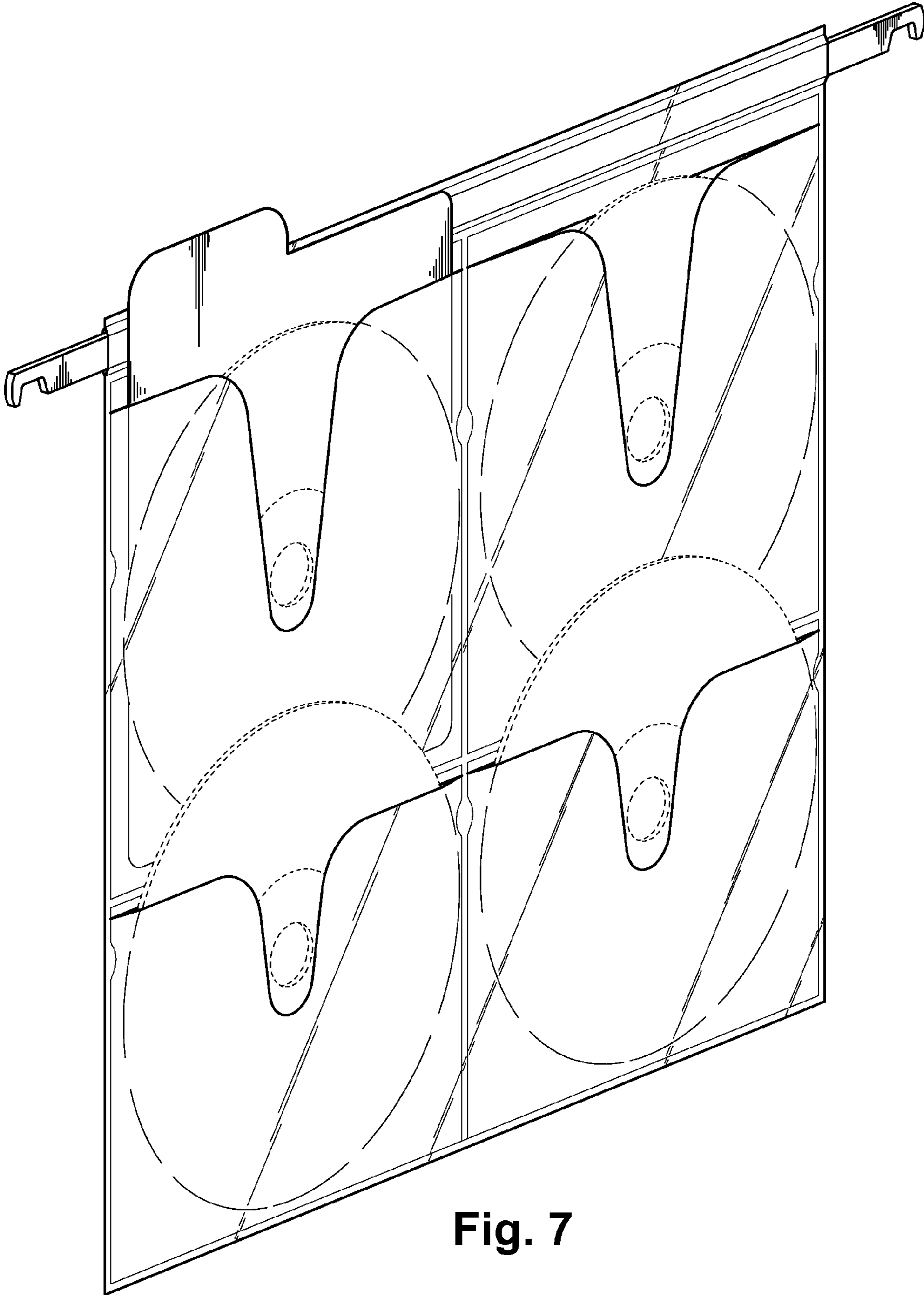

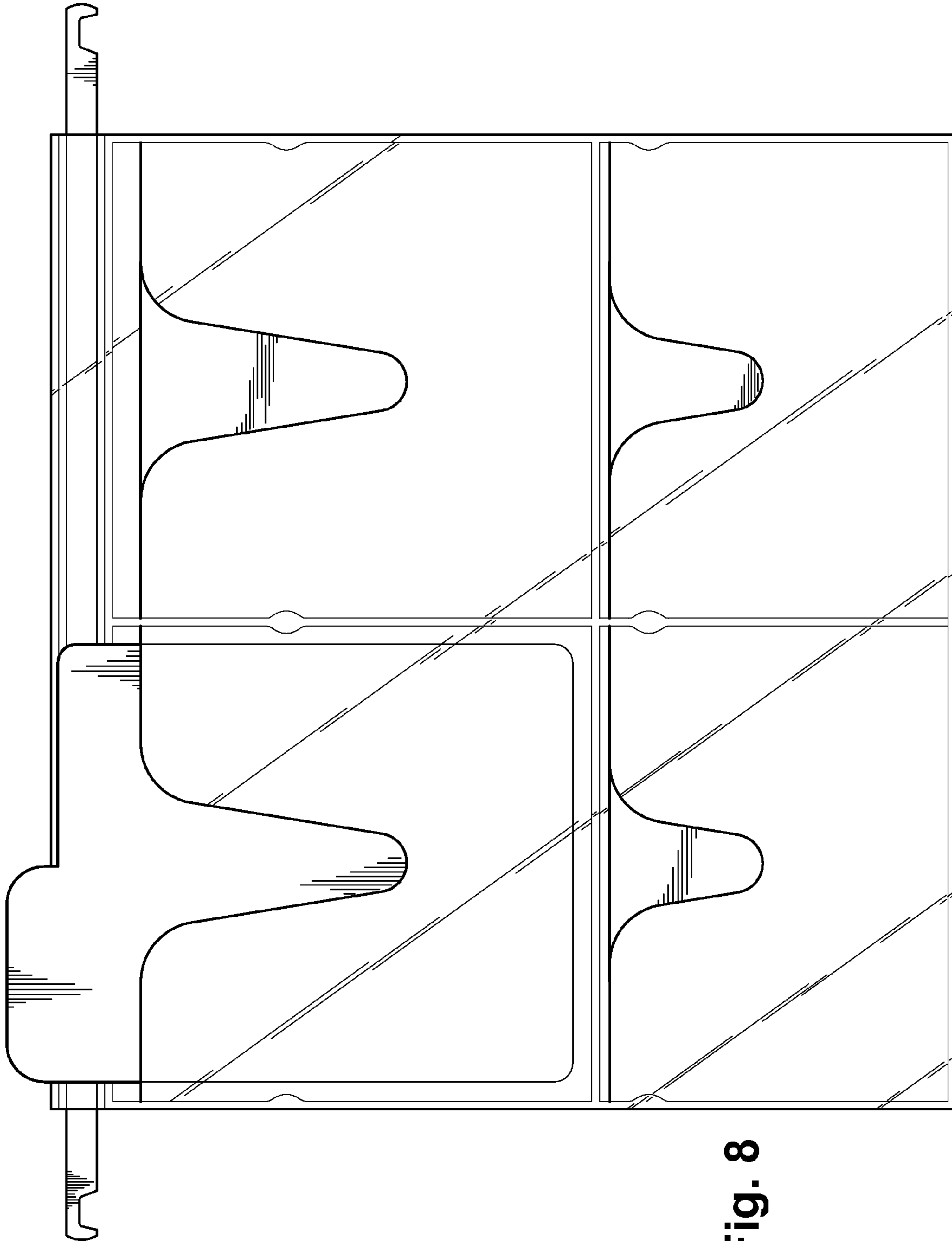

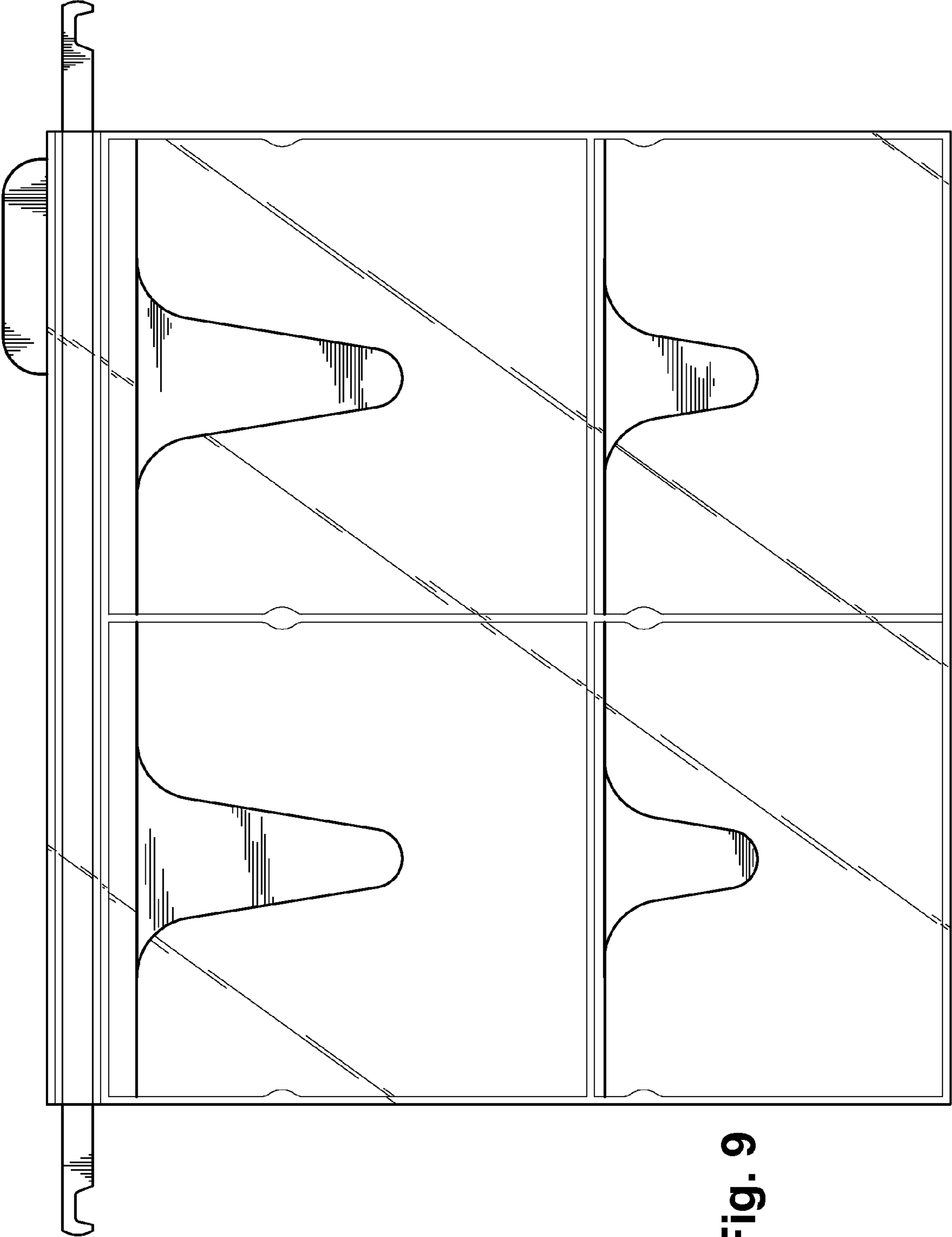

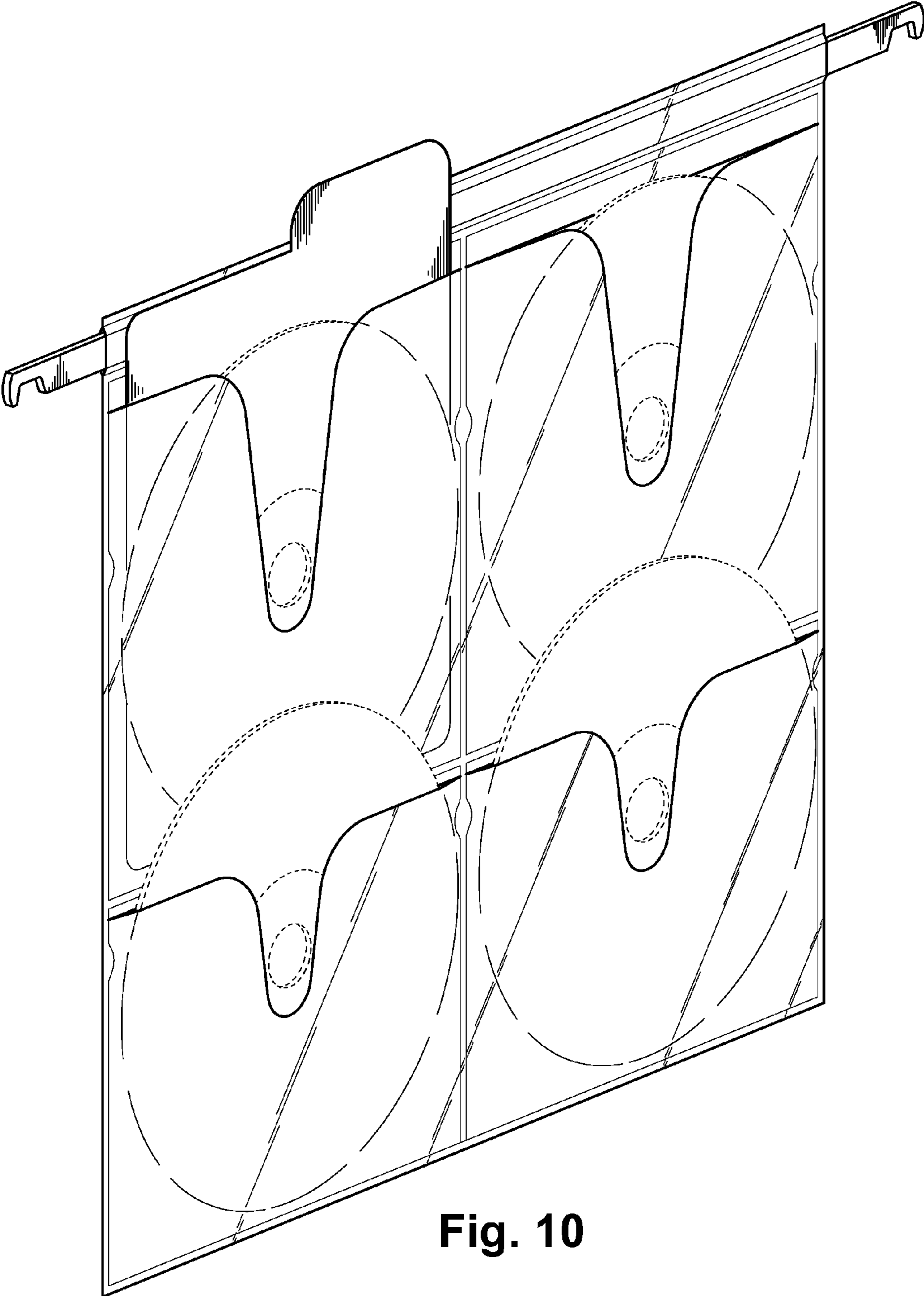

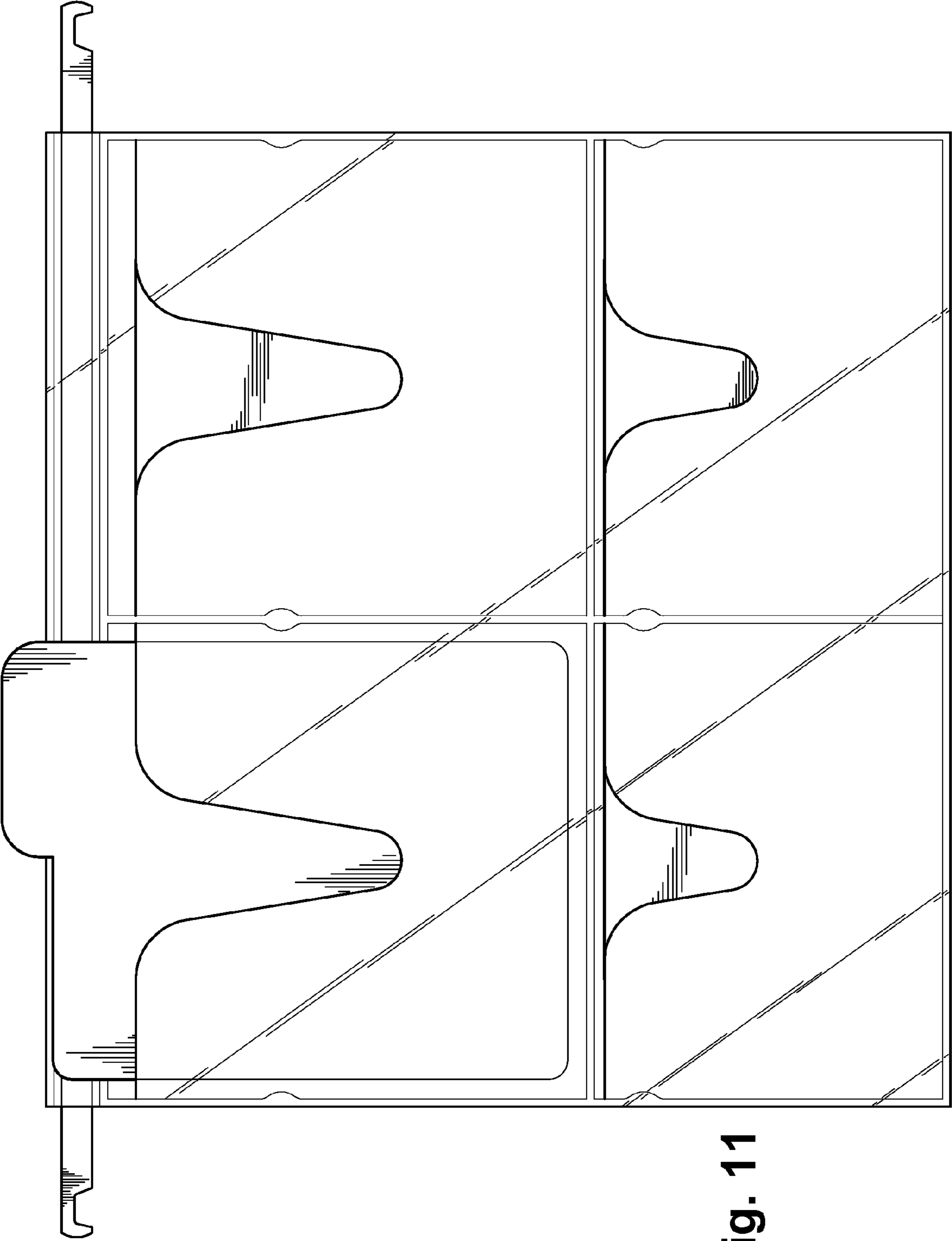

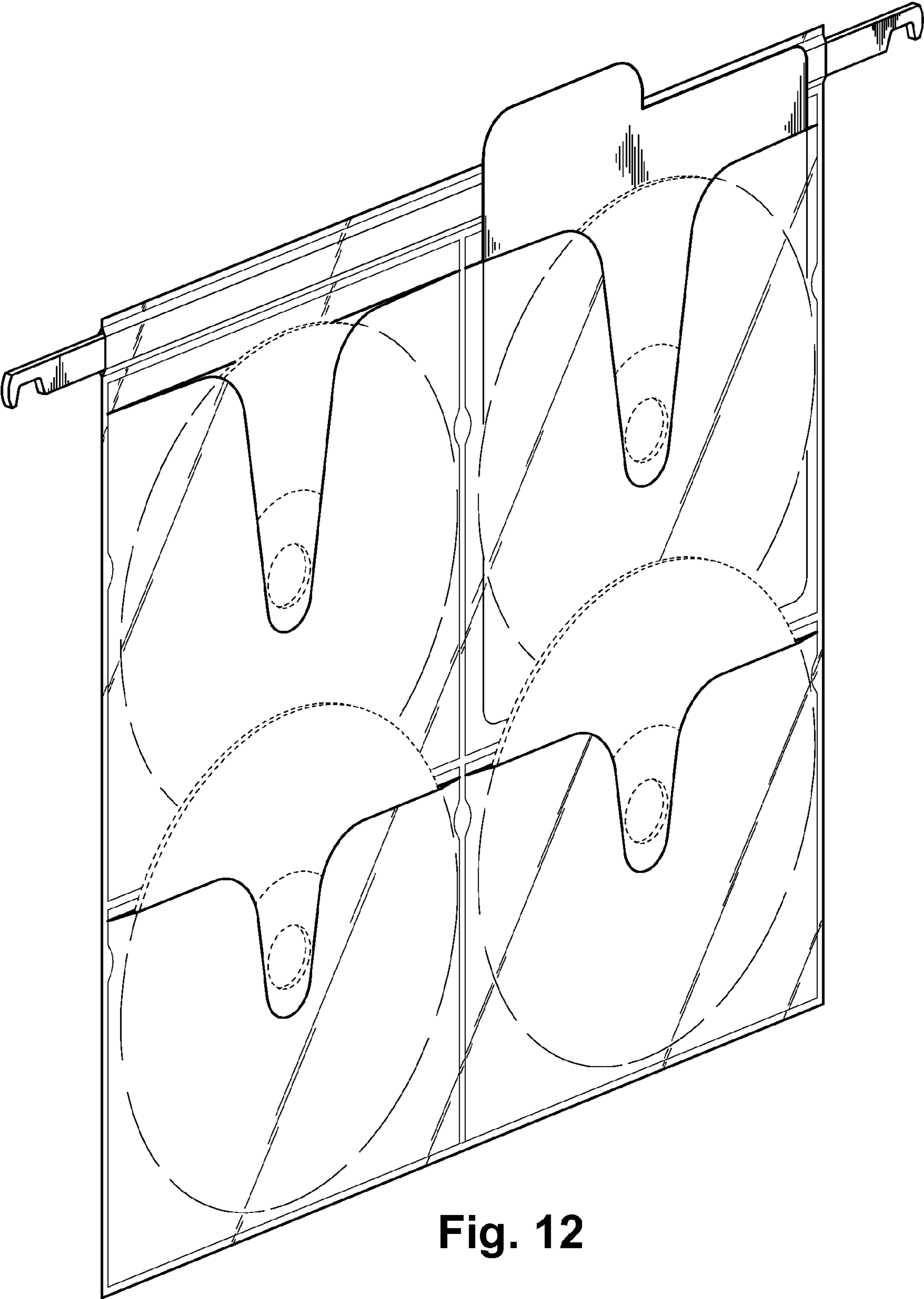

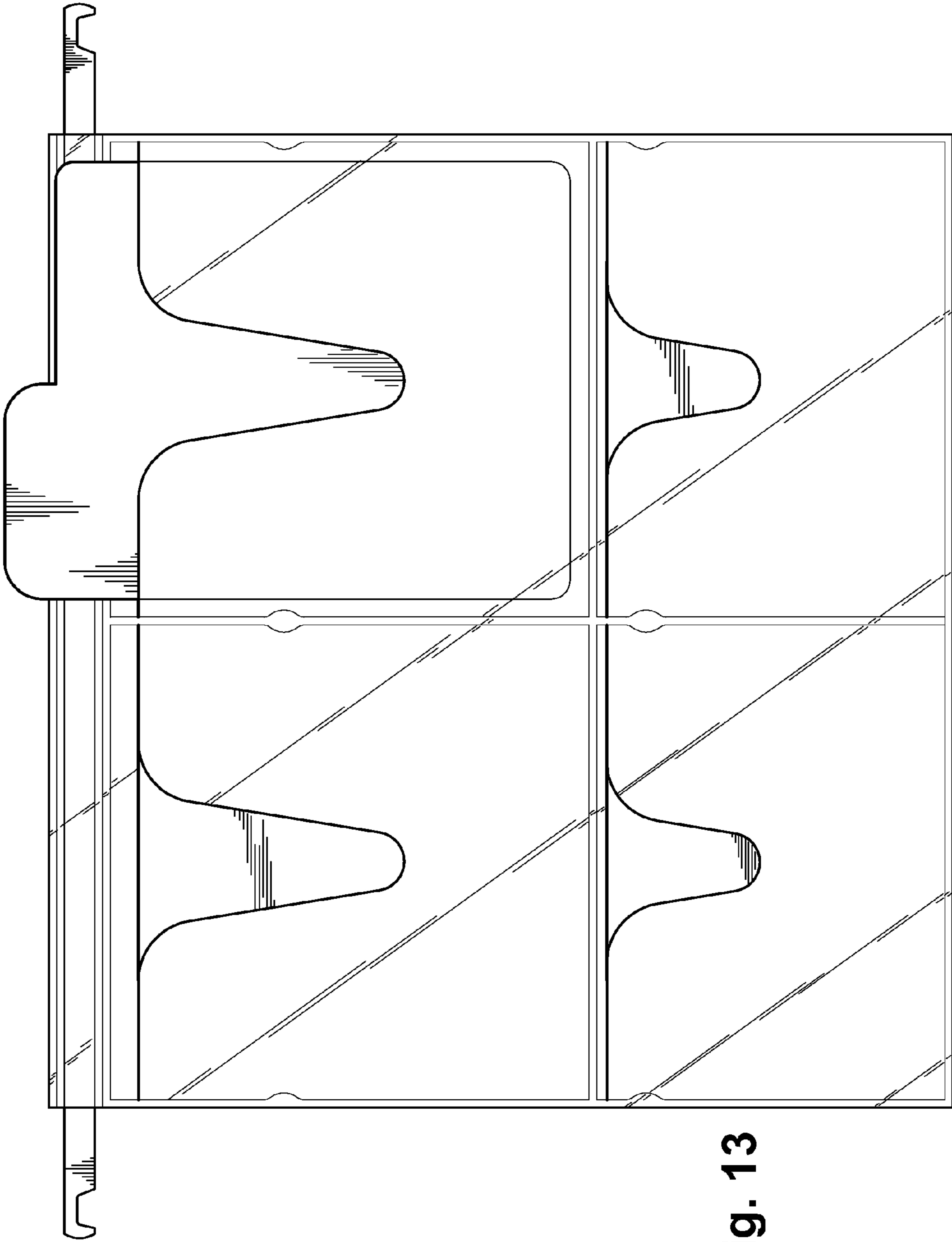

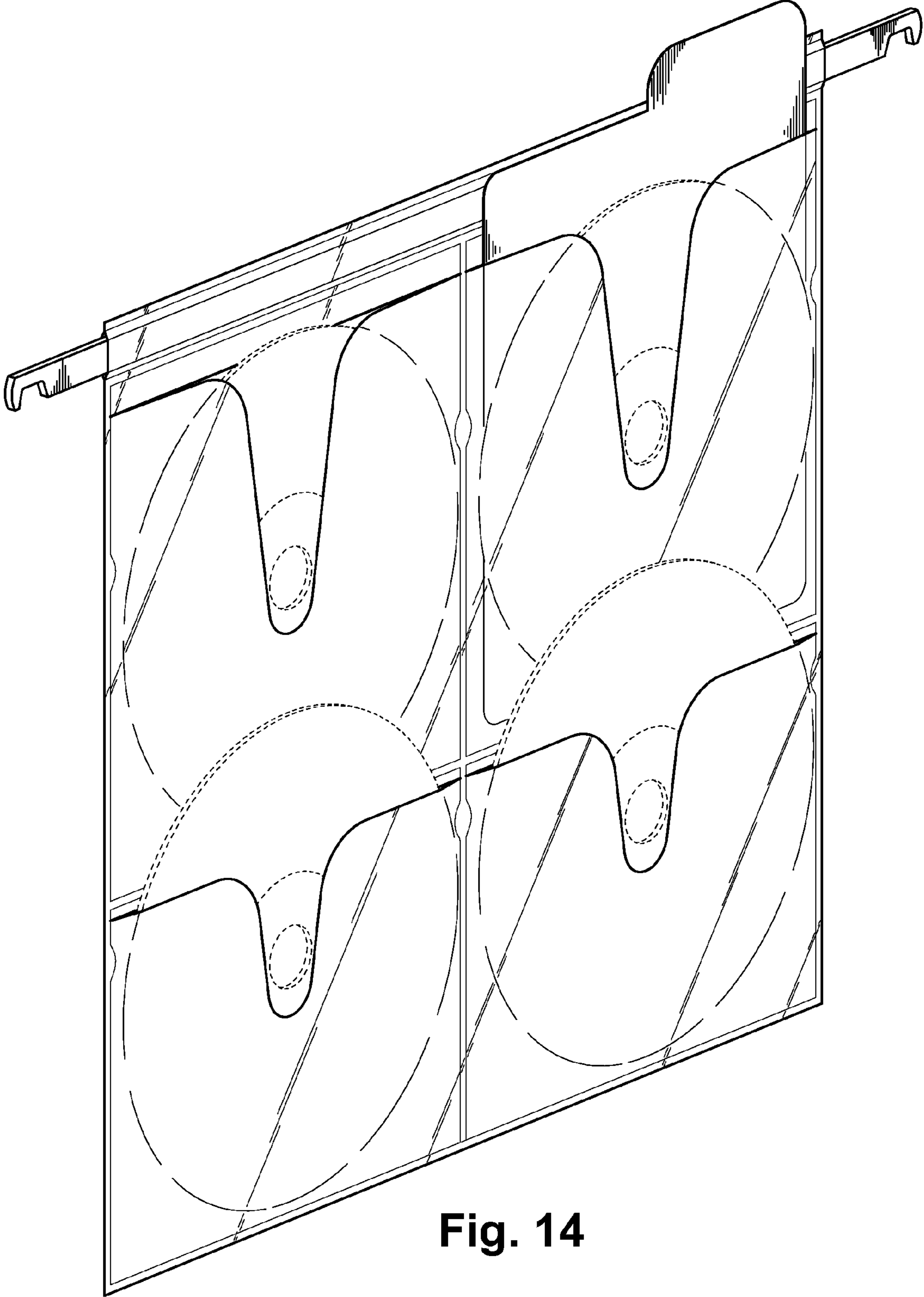

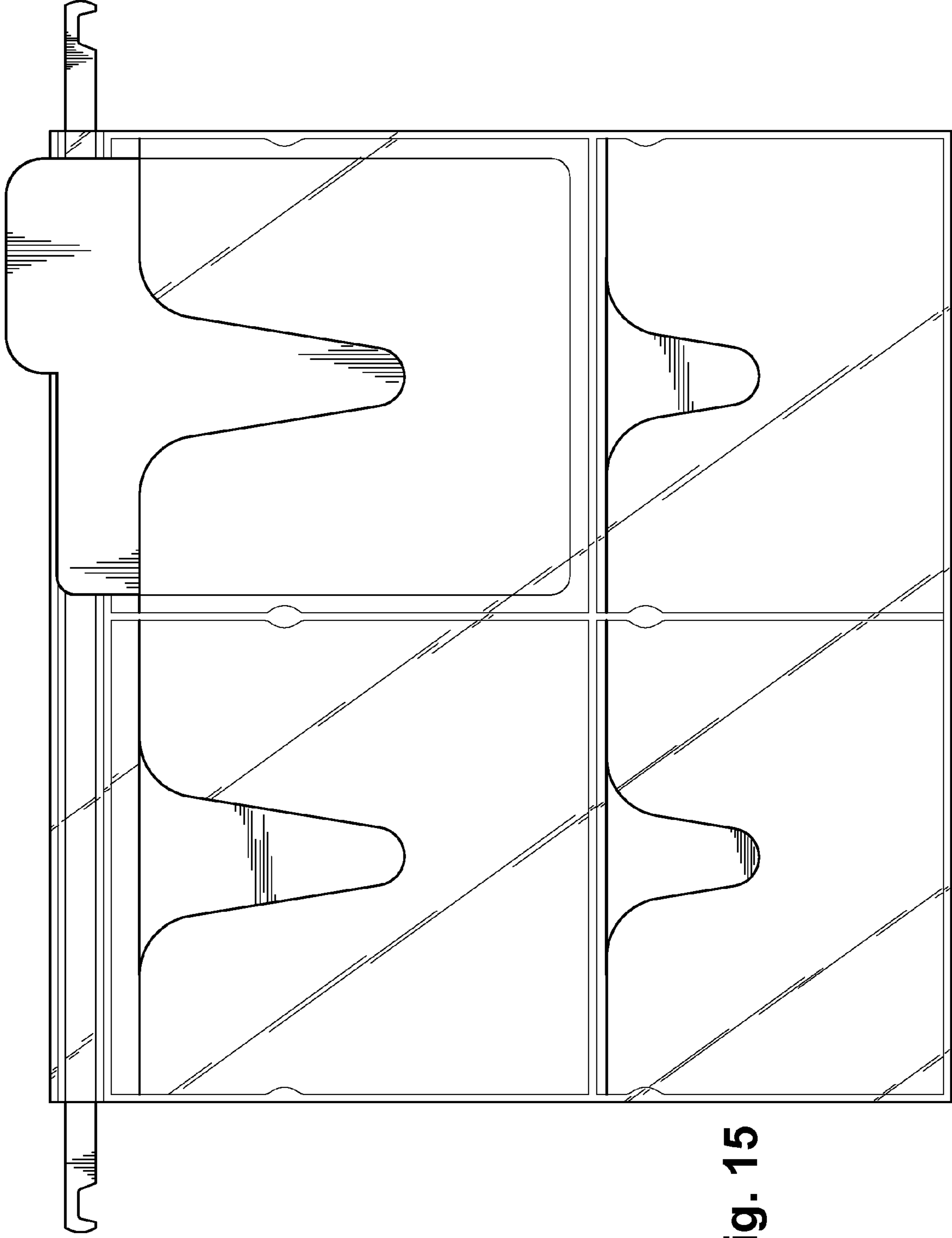
