The ornamental designs for a baseball bat-shaped cooking spatula, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an embodiment of a baseball bat-shaped cooking spatula;

FIG. 2 is a side view of the baseball bat-shaped cooking spatula embodiment shown in FIG. 1.

FIG. 3 is a top perspective view of the baseball bat-shaped cooking spatula embodiment shown in FIG. 1.

FIG. 4 is a top view of the baseball bat-shaped cooking spatula embodiment shown in FIG. 1.

FIG. 5 is a bottom view of the baseball bat-shaped cooking spatula embodiment shown in FIG. 1.

FIG. 6 is a front view of a second embodiment of a baseball bat-shaped cooking spatula;

FIG. 7 is a side view of the baseball bat-shaped cooking spatula embodiment shown in FIG. 6.

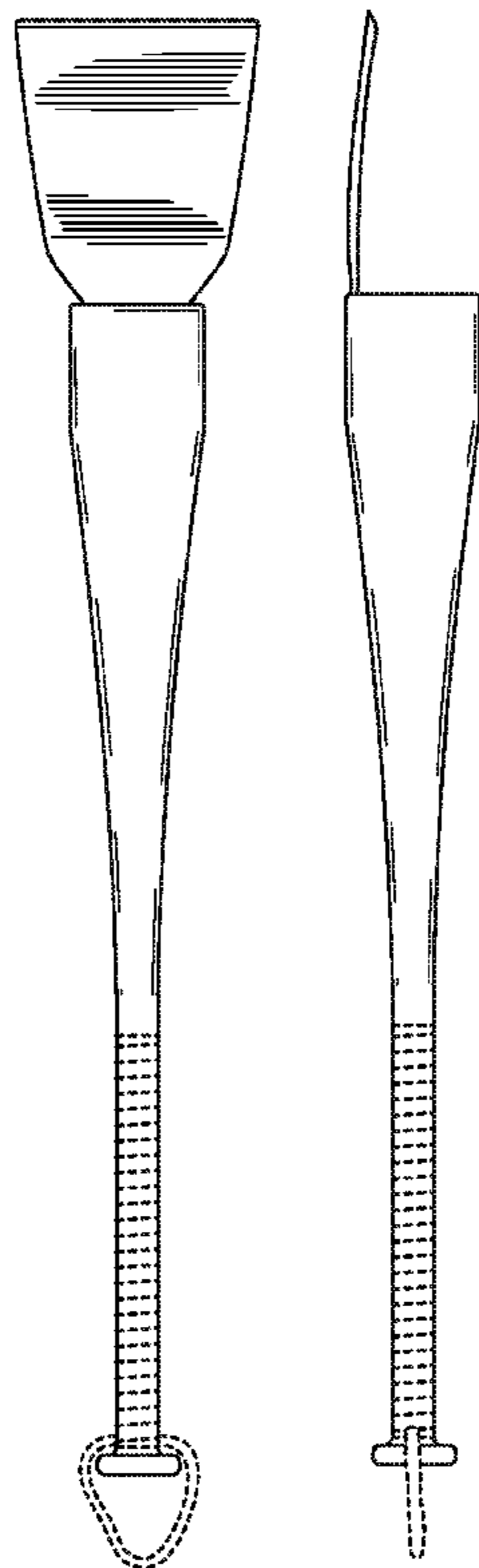
FIG. 8 is a top perspective view of the baseball bat-shaped cooking spatula embodiment shown in FIG. 6.

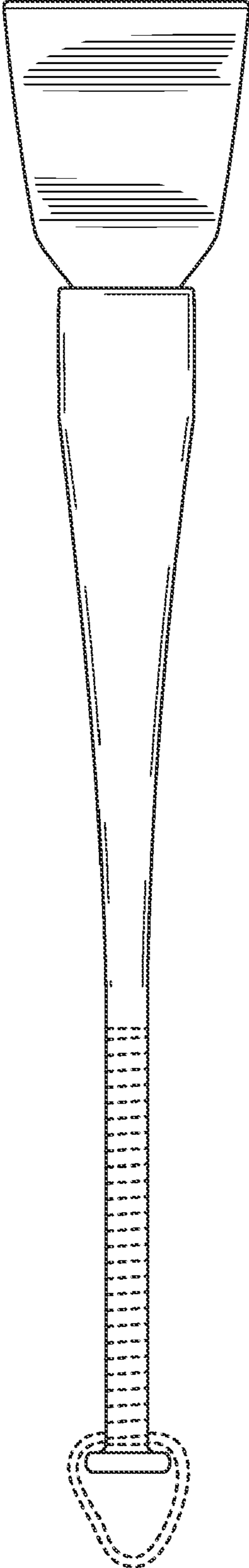

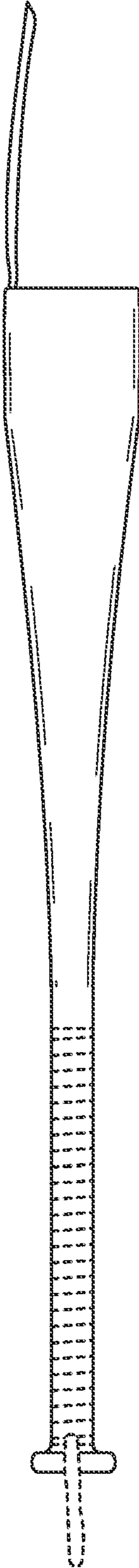

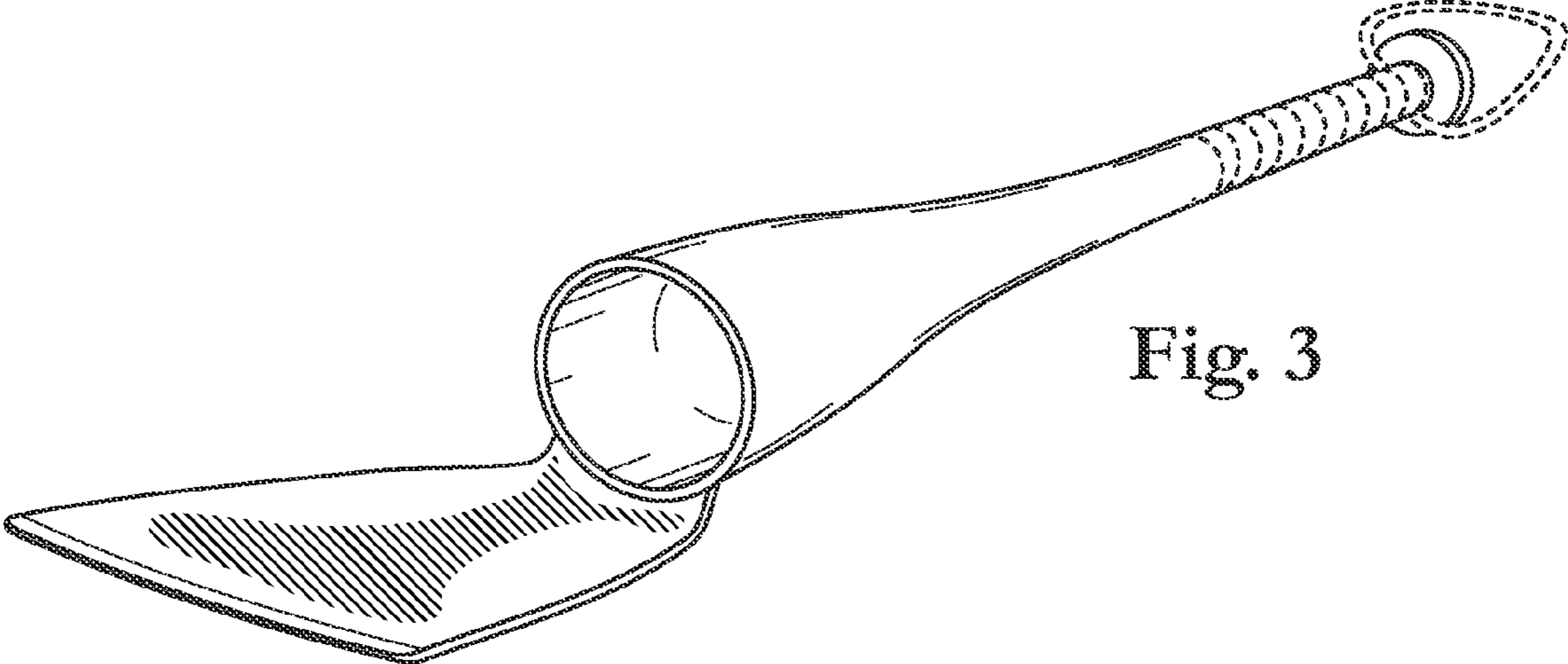

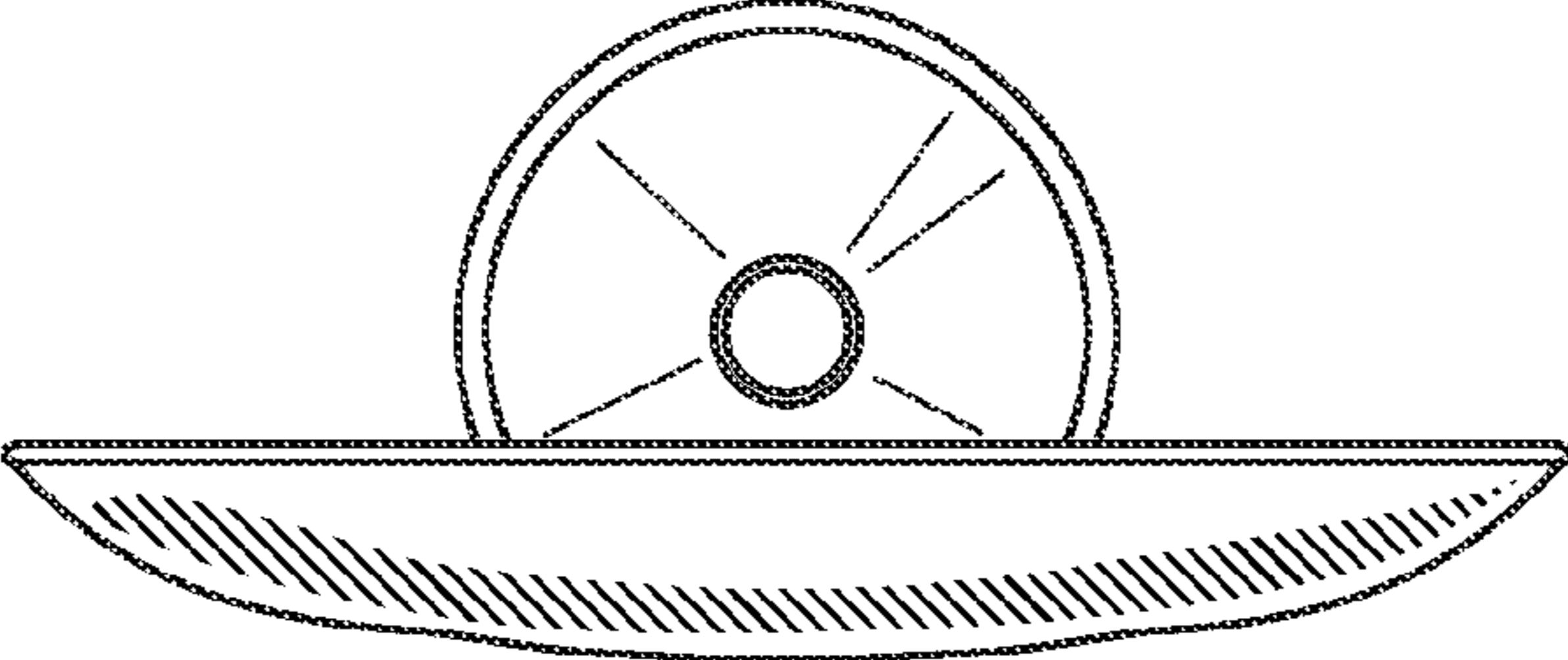

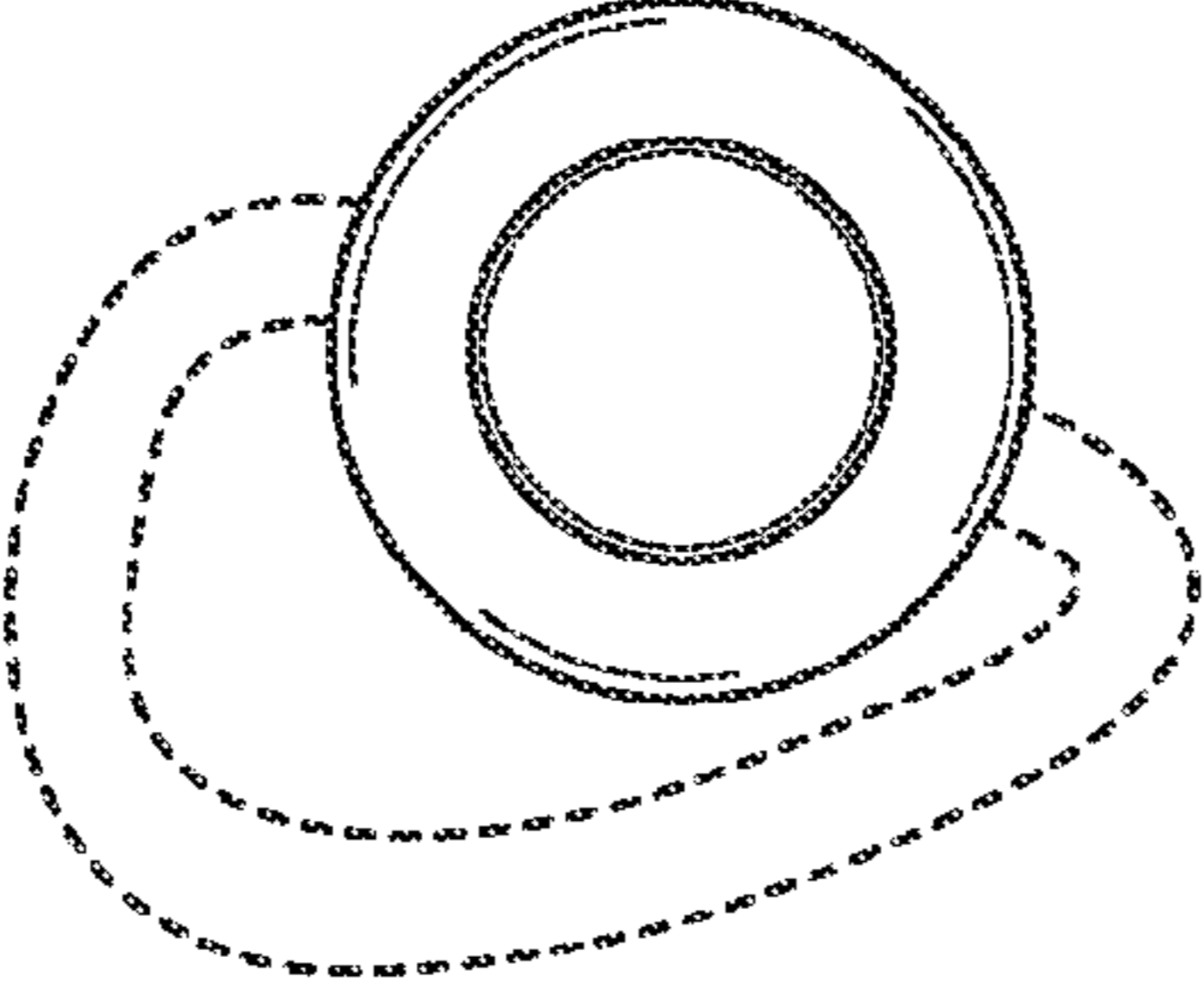

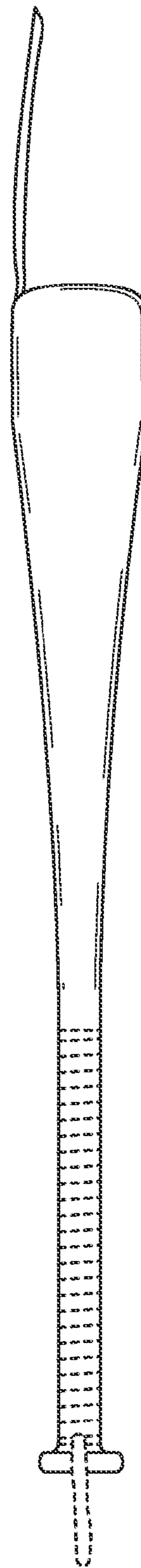

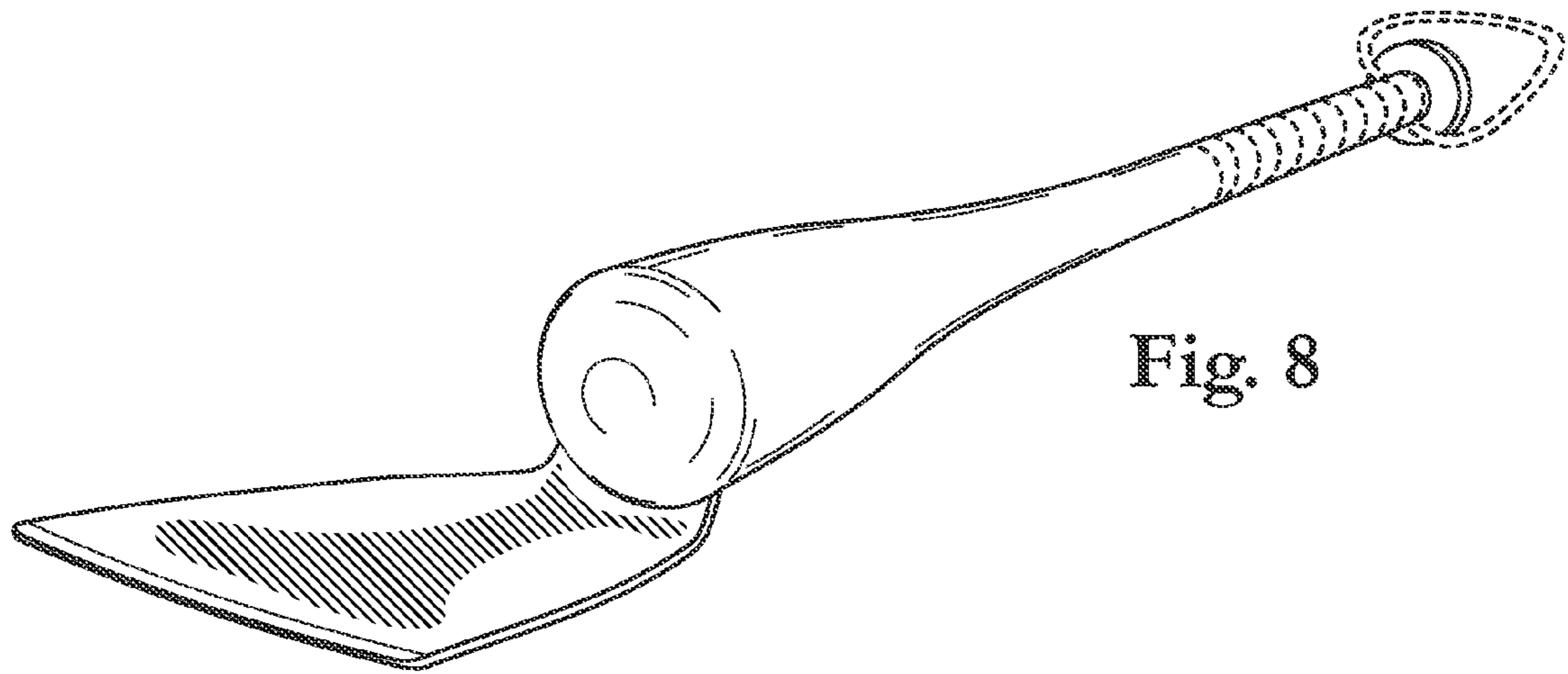

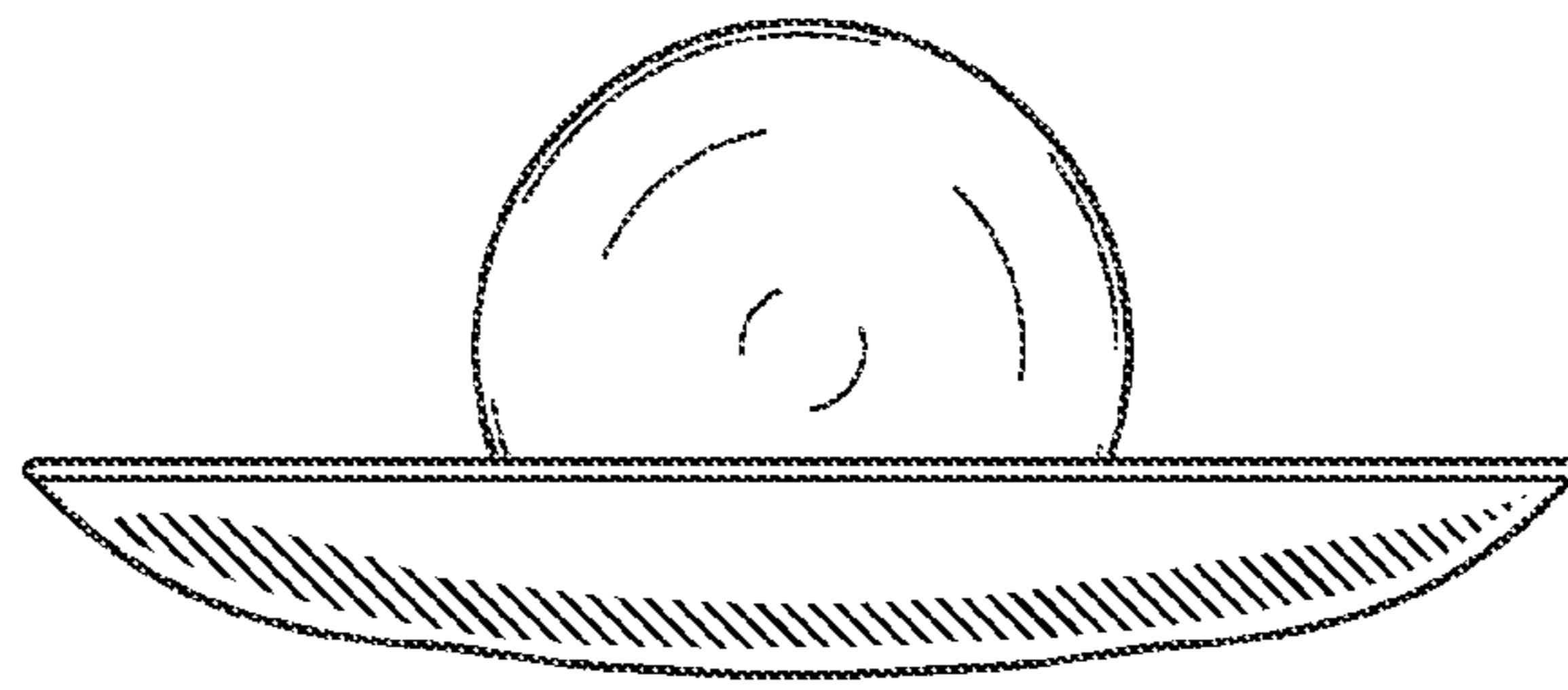

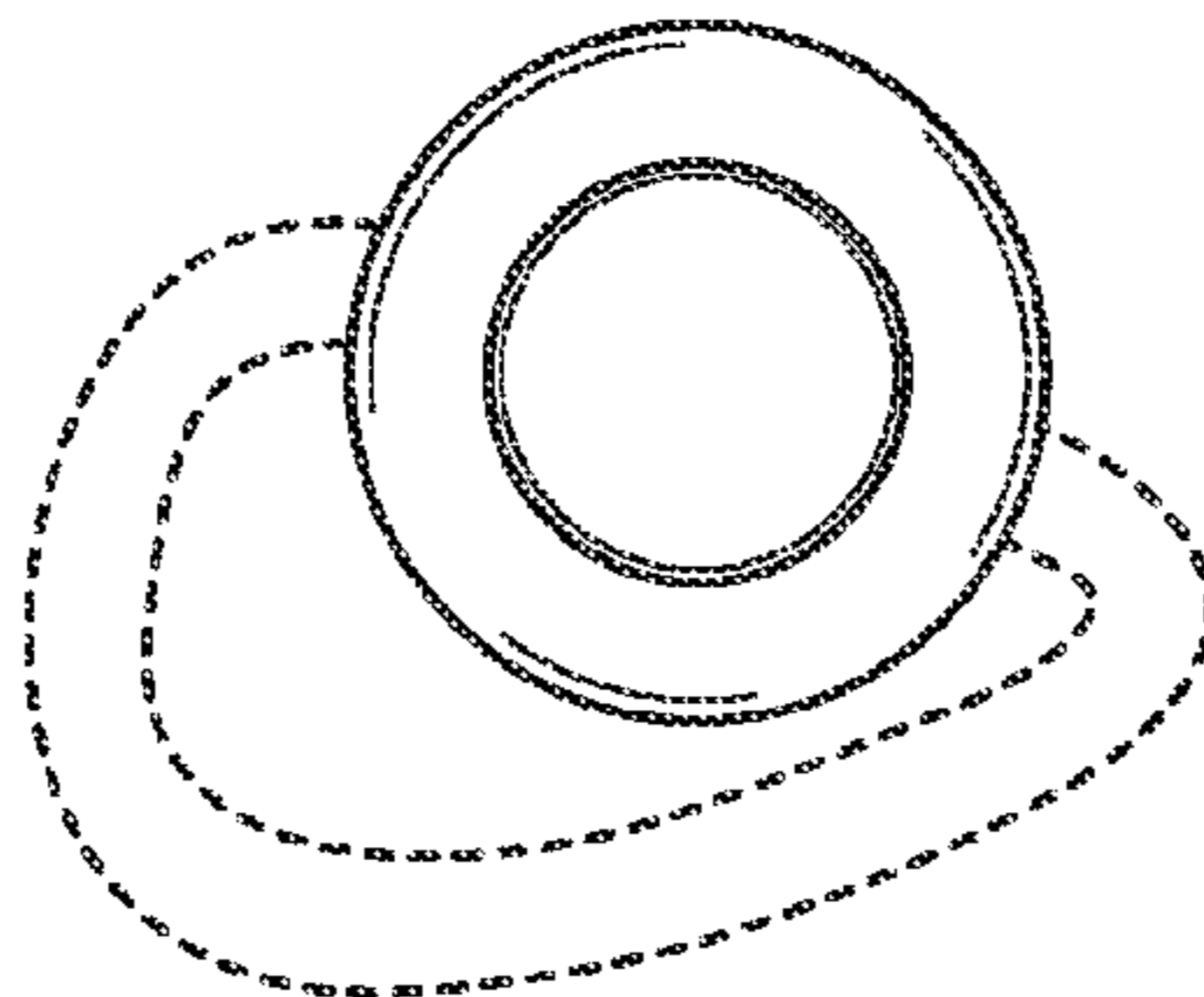
