I claim the ornamental design for a hub with fins for an abrasive wheel, as shown and described.

DESCRIPTION

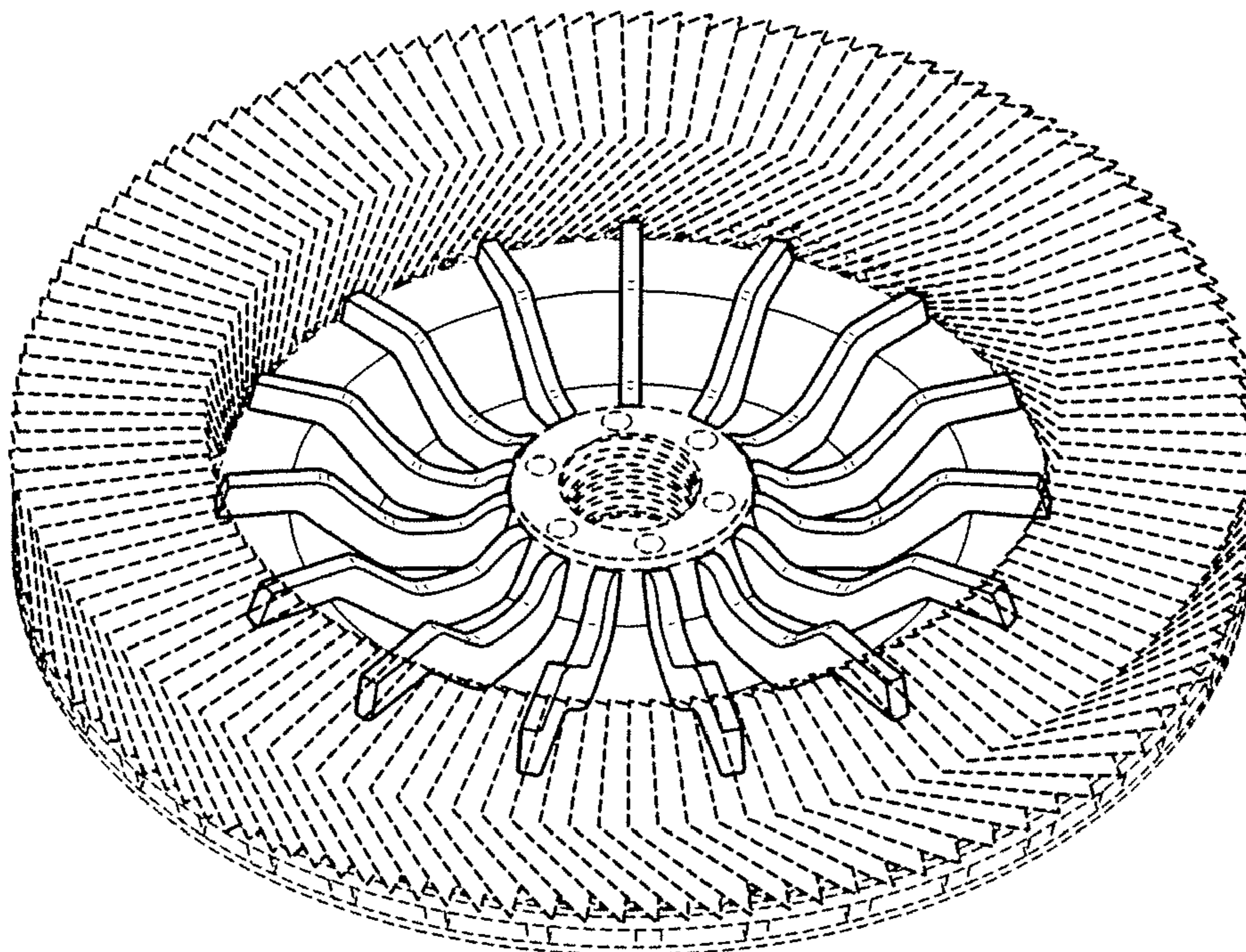
FIG. 1 is a front perspective view of a hub with fins for an abrasive wheel according to a first variant of the present design;

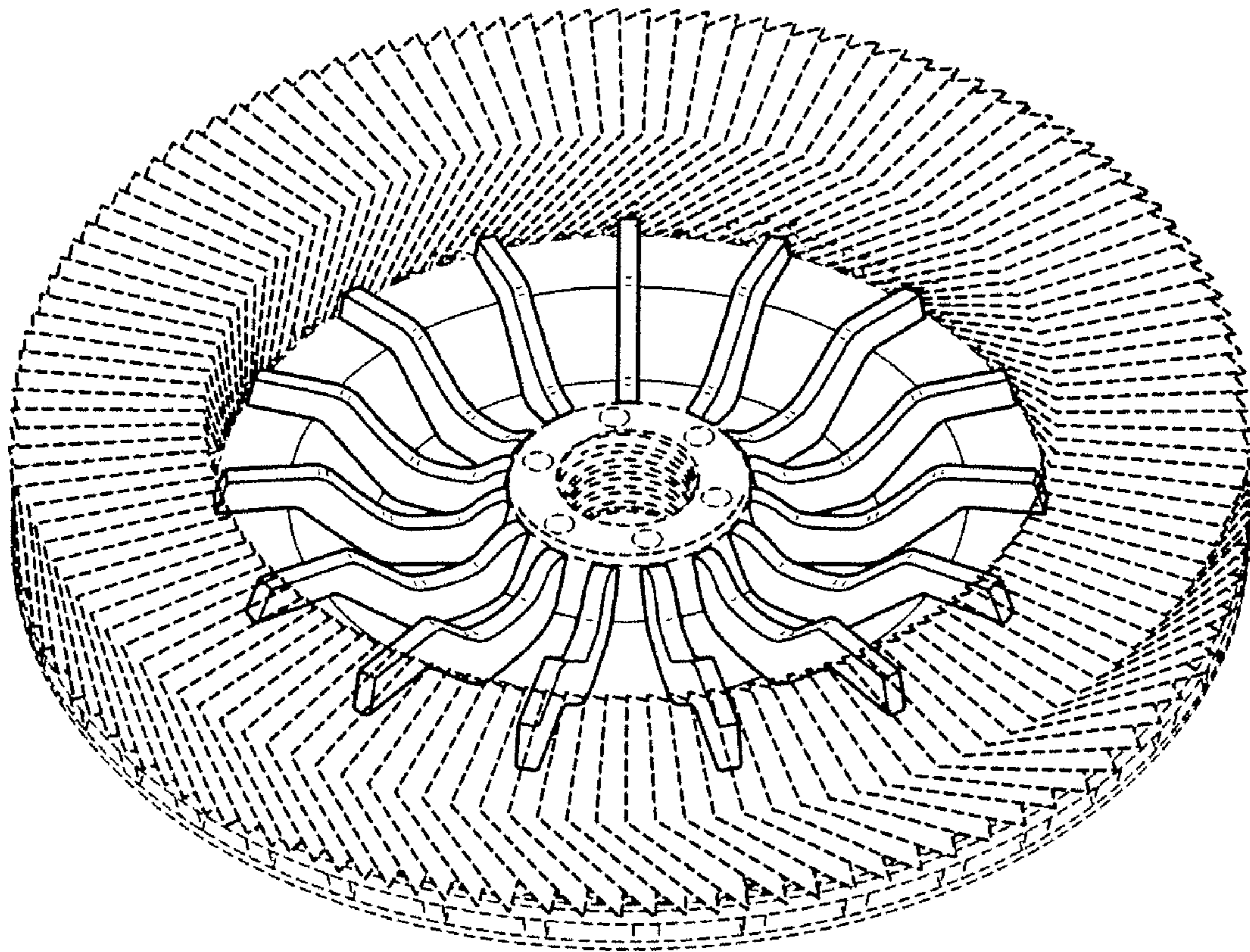

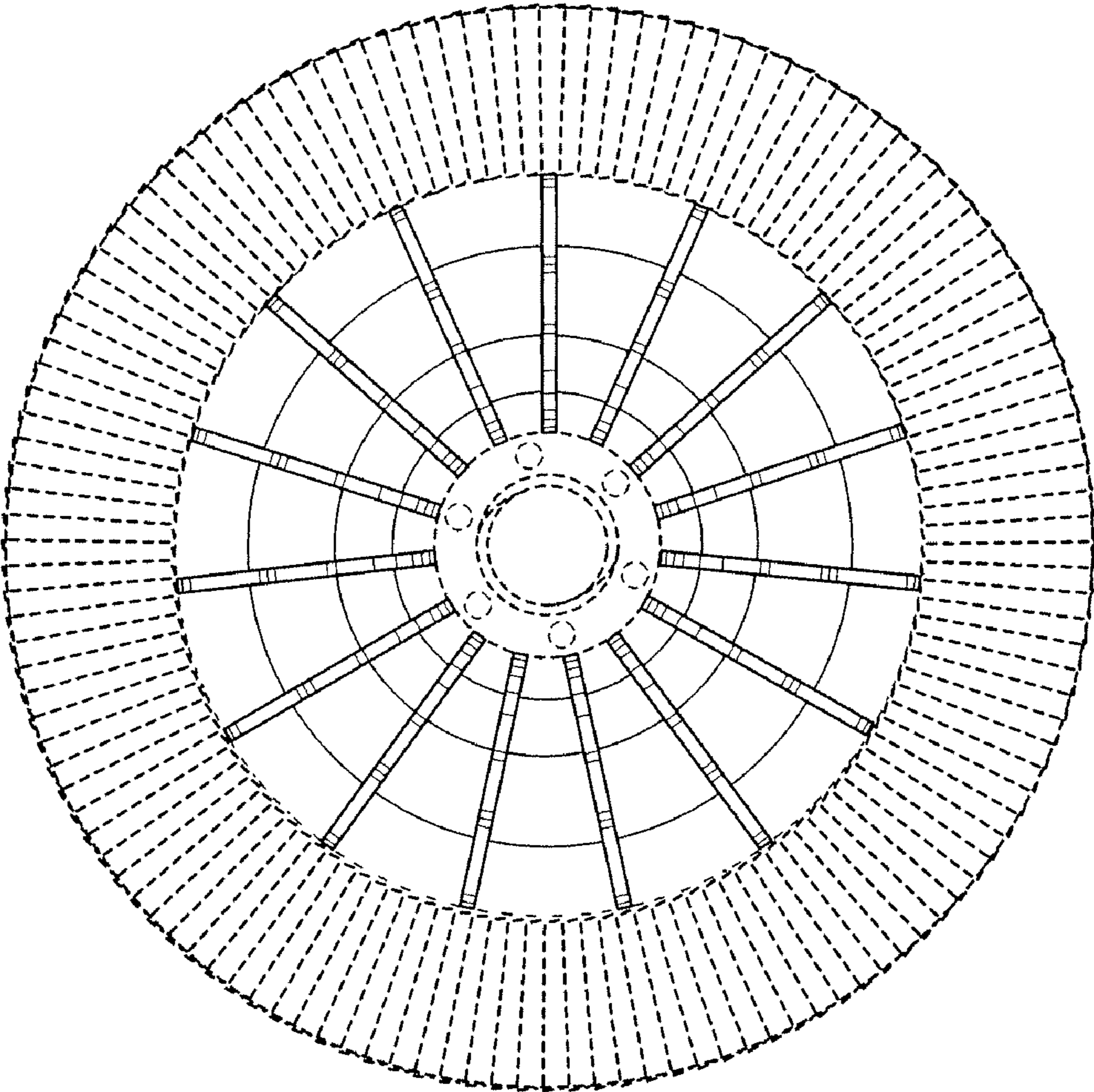

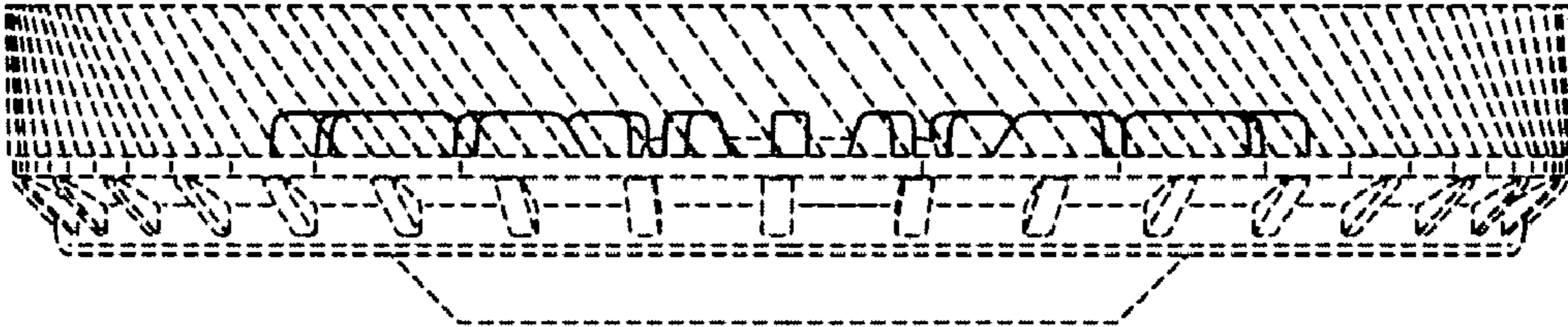
