FIG. 1 is a front perspective view of a panorama window bag according to my new design;

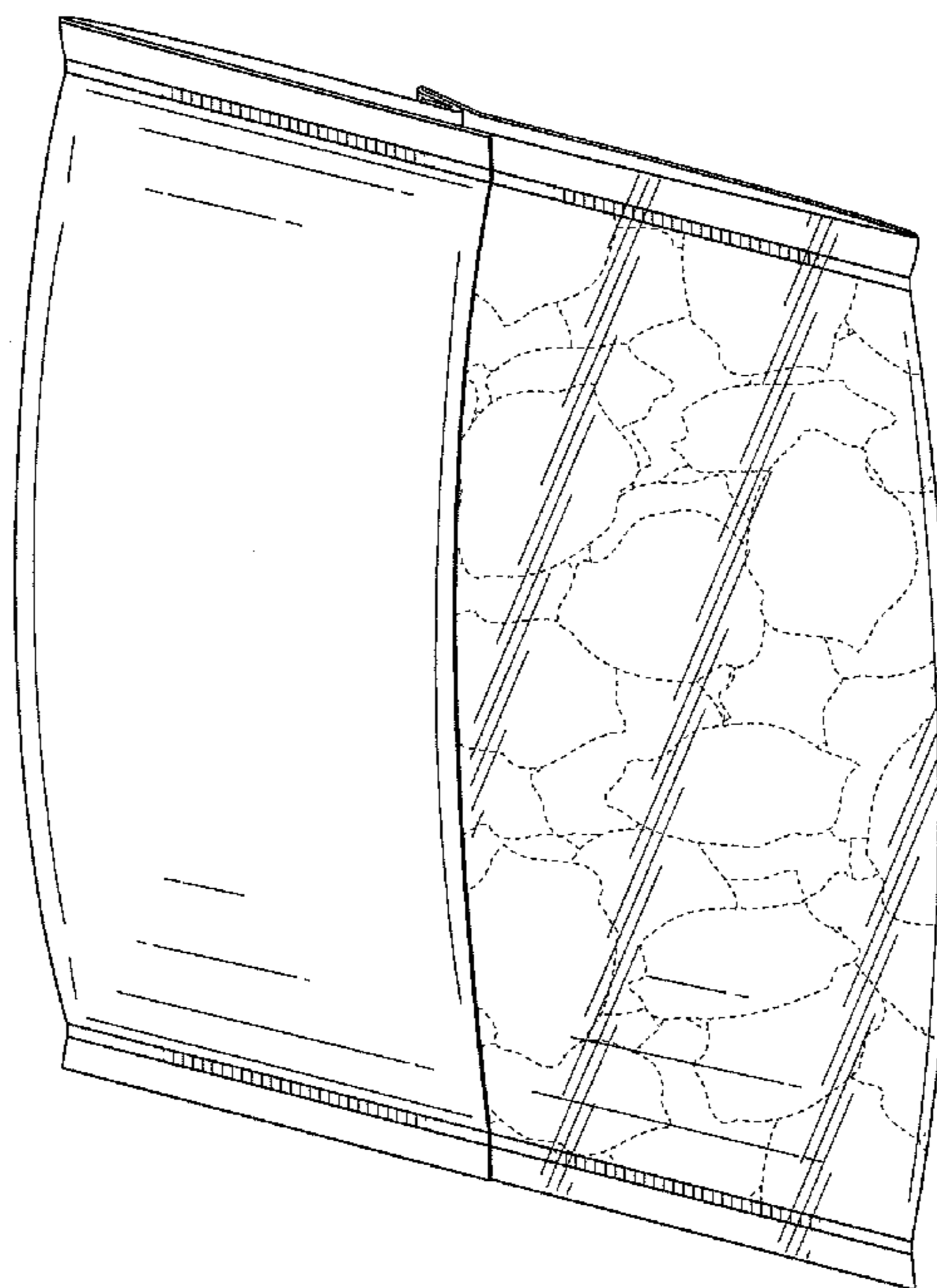
FIG. 2 is a plan front view thereof;

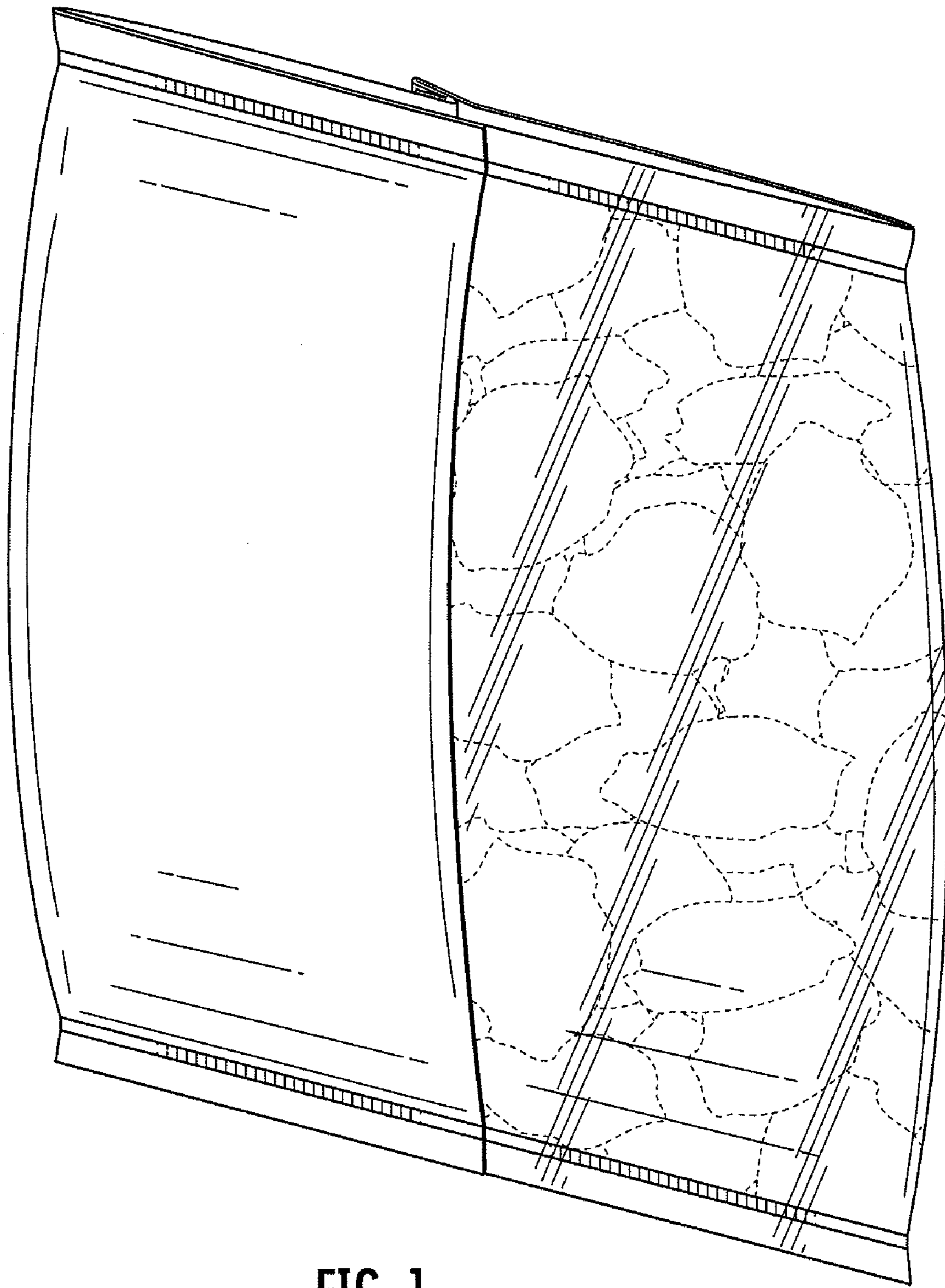

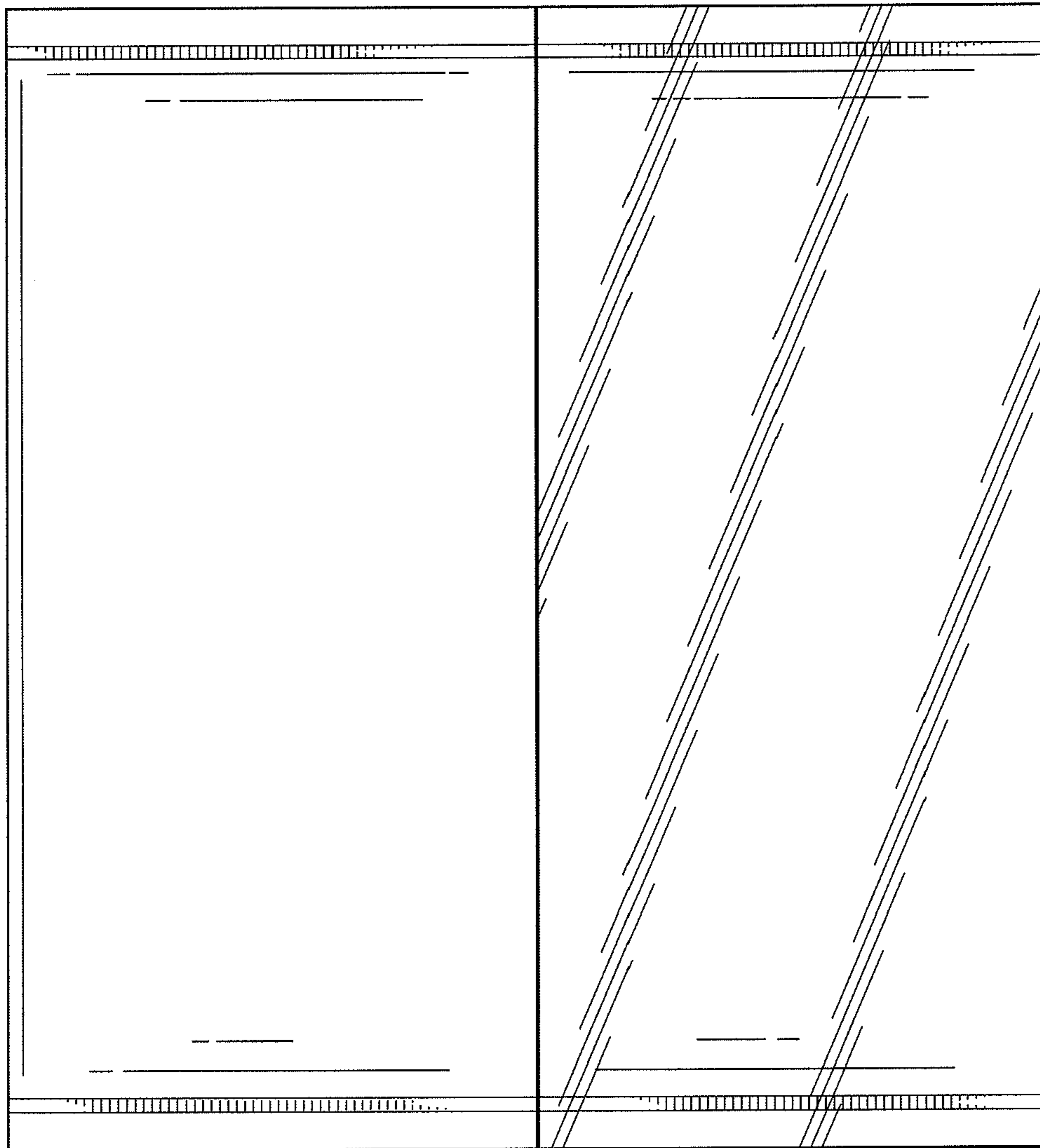

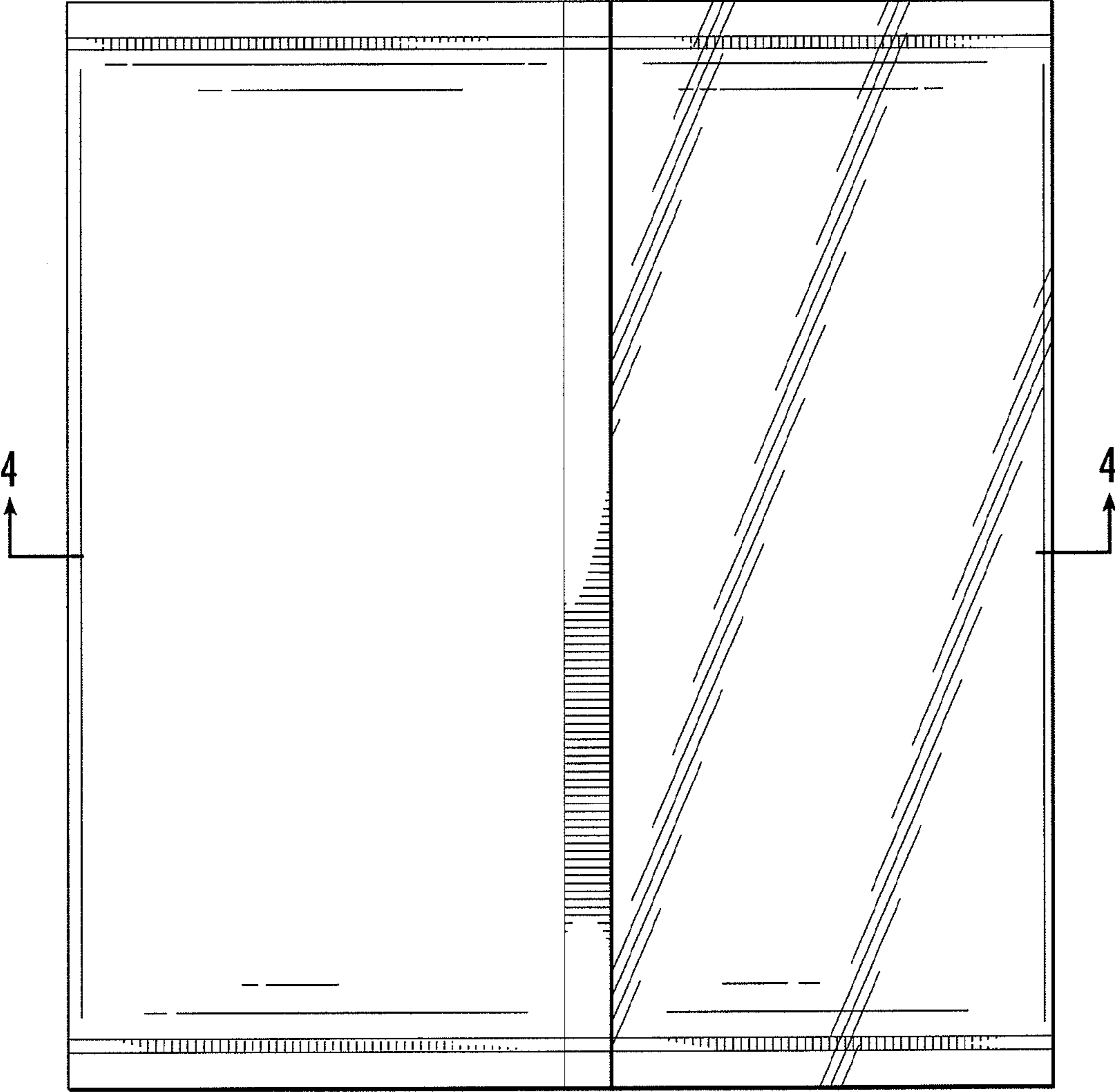

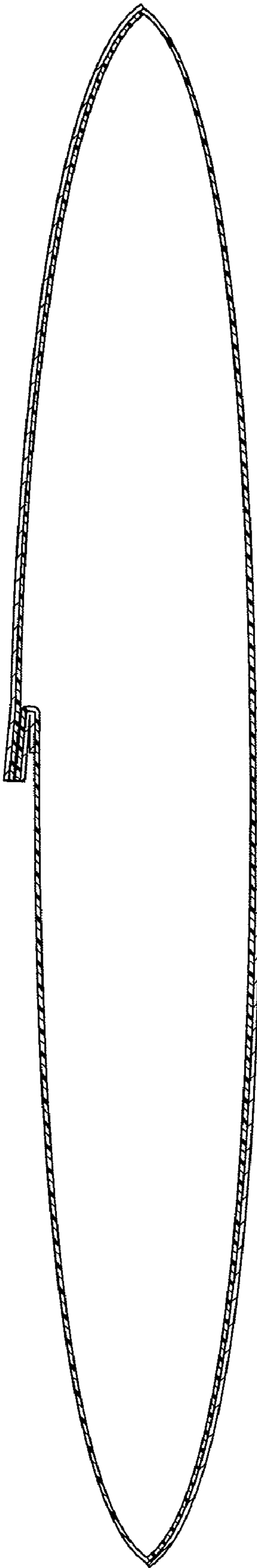
