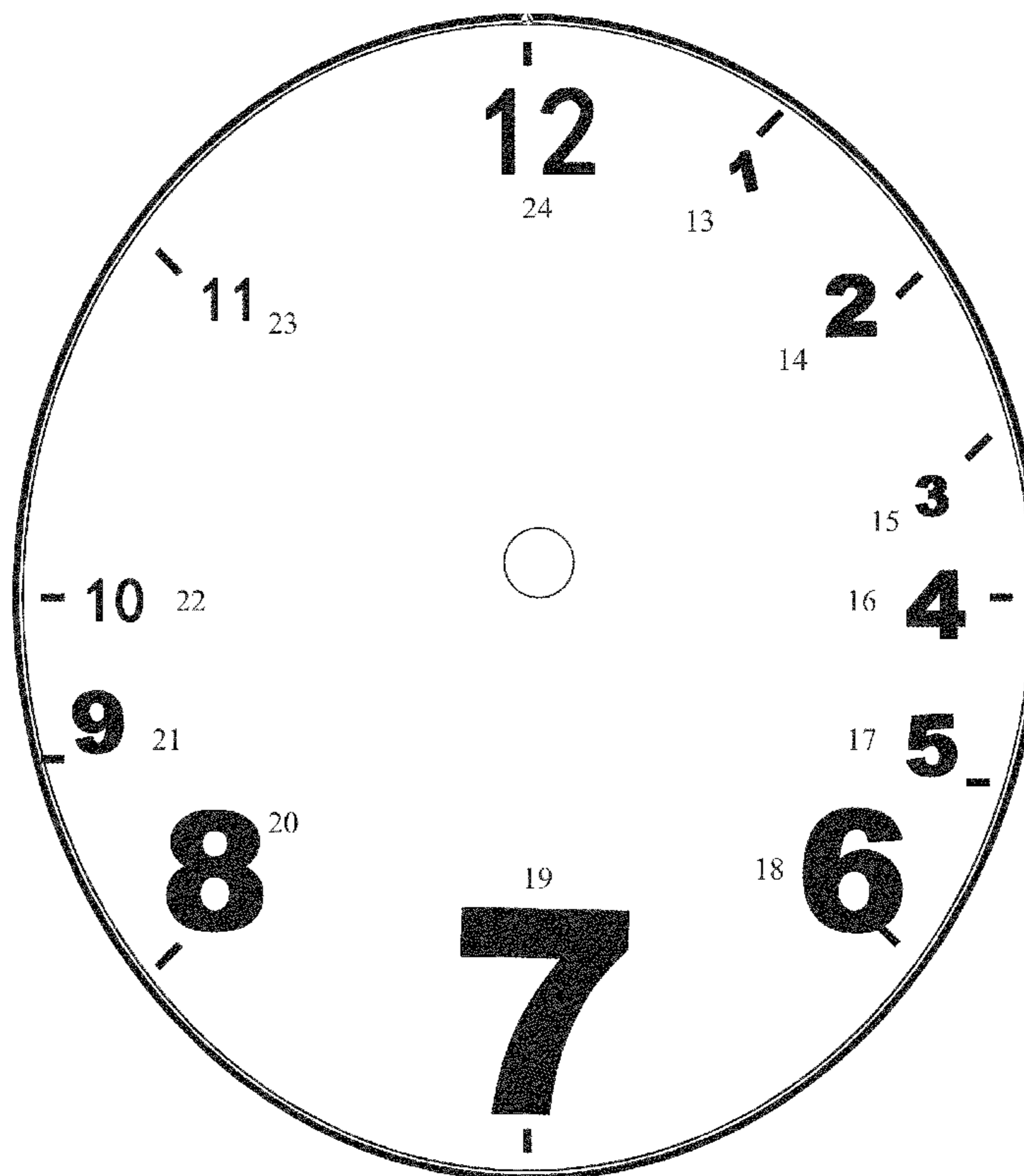
The ornamental design for a clock face, as shown and described.

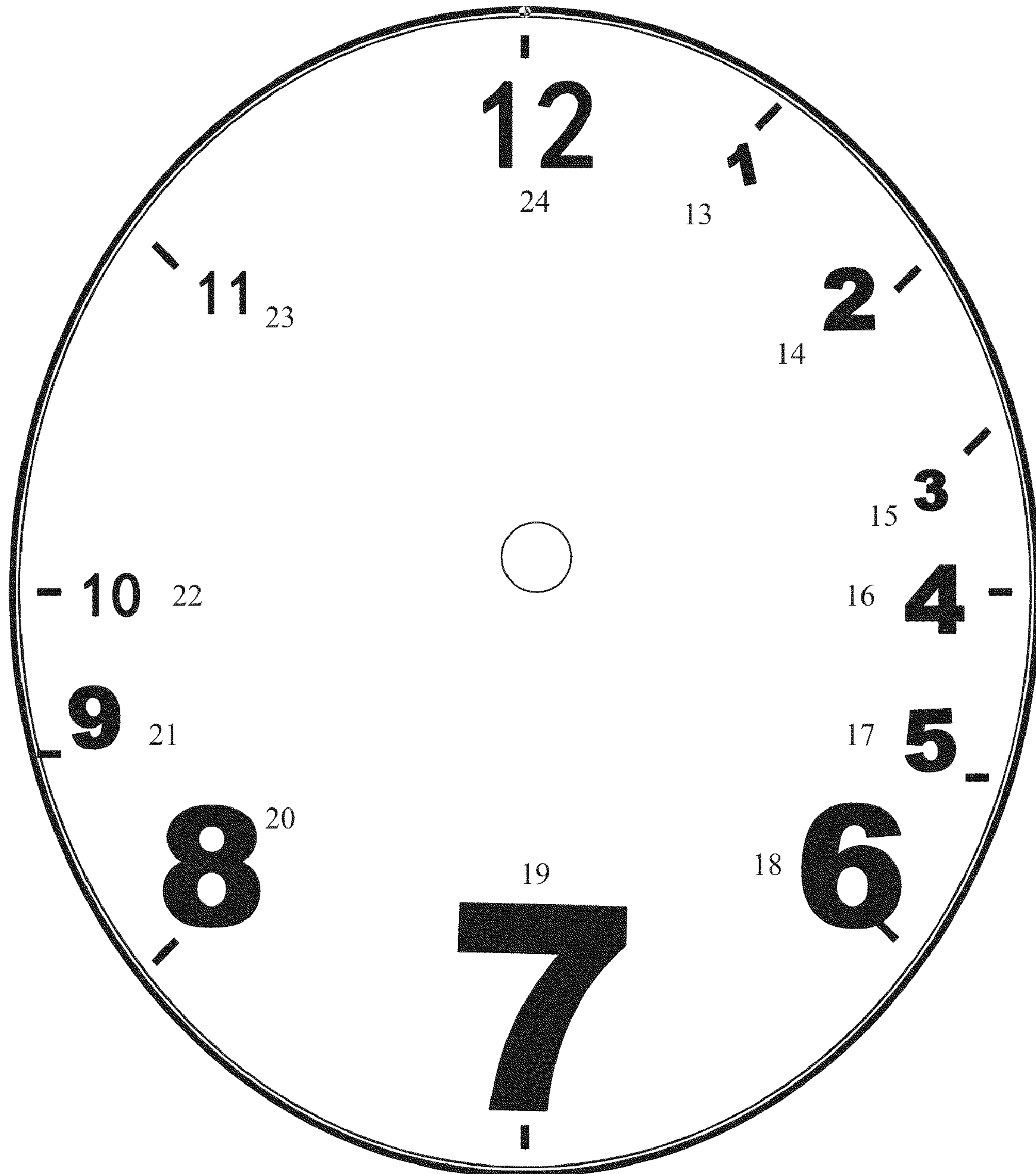

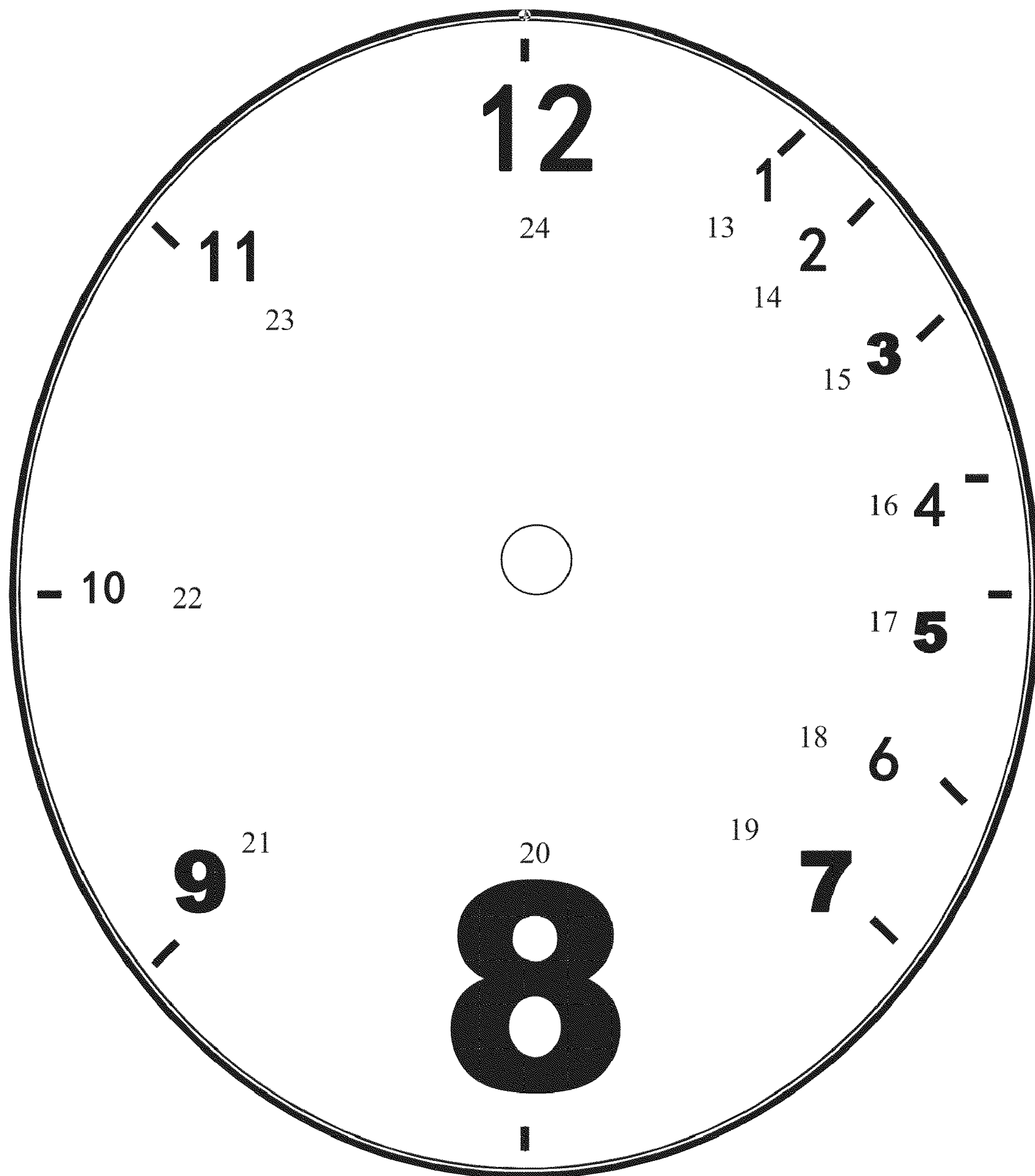
