The ornamental design for an aerodynamic vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the top front and right side of an aerodynamic vehicle;

FIG. 2 is a perspective view of the top rear and right side thereof;

FIG. 3 is a left side elevation view thereof, the right side elevation view being a mirror image of that shown;

FIG. 4 is a front elevation view thereof;

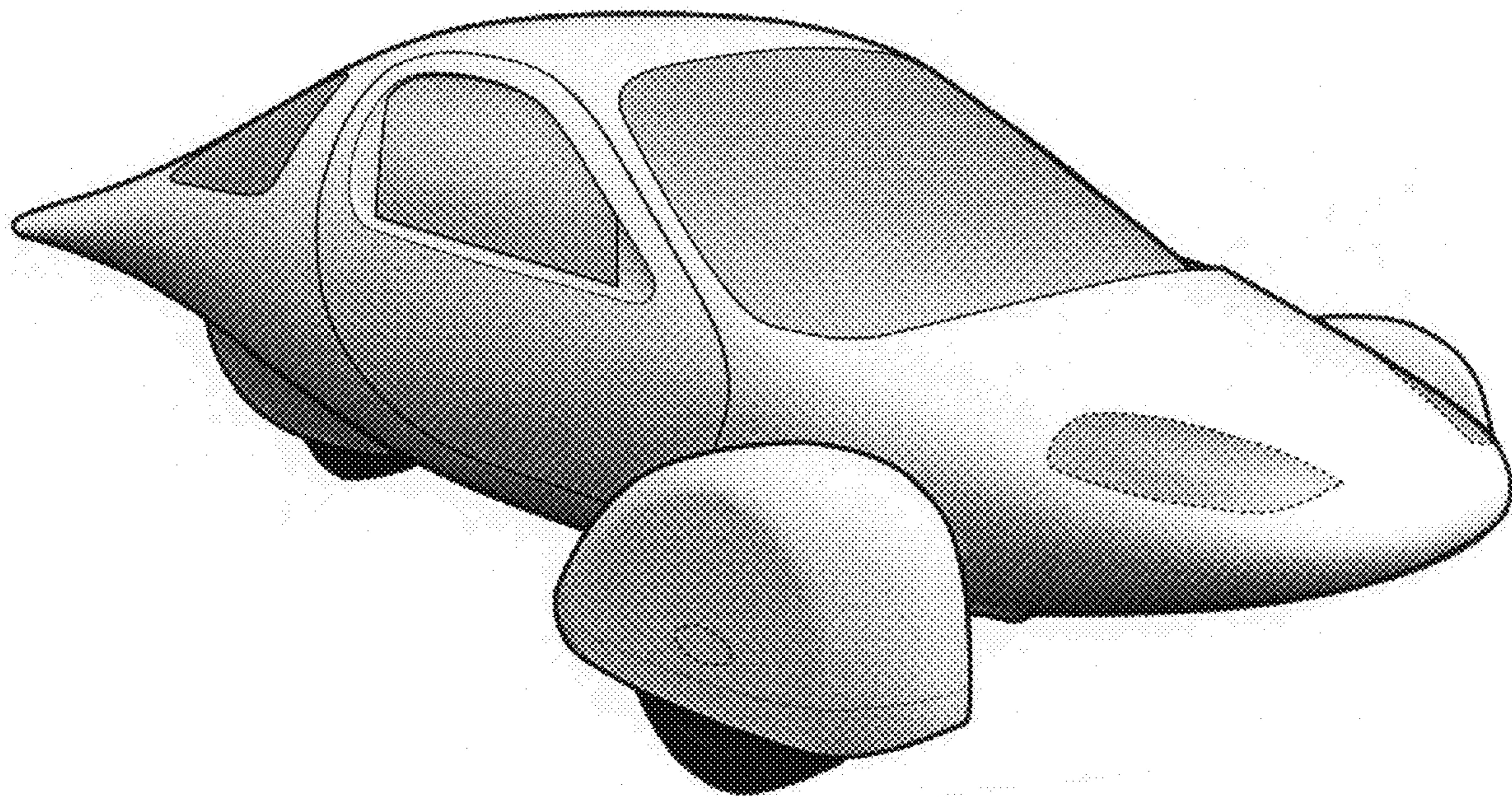
FIG. 5 is a rear elevation view thereof;

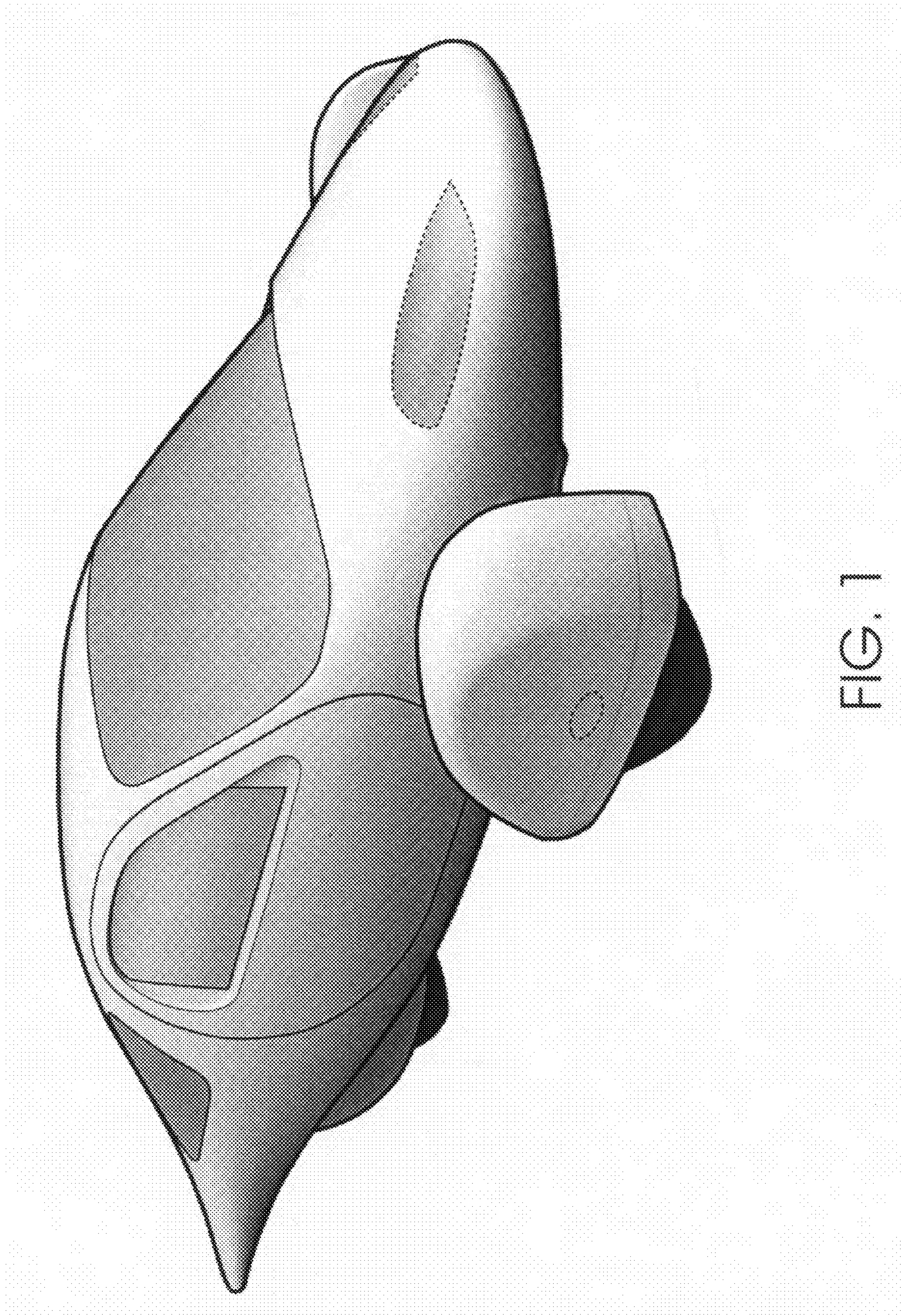

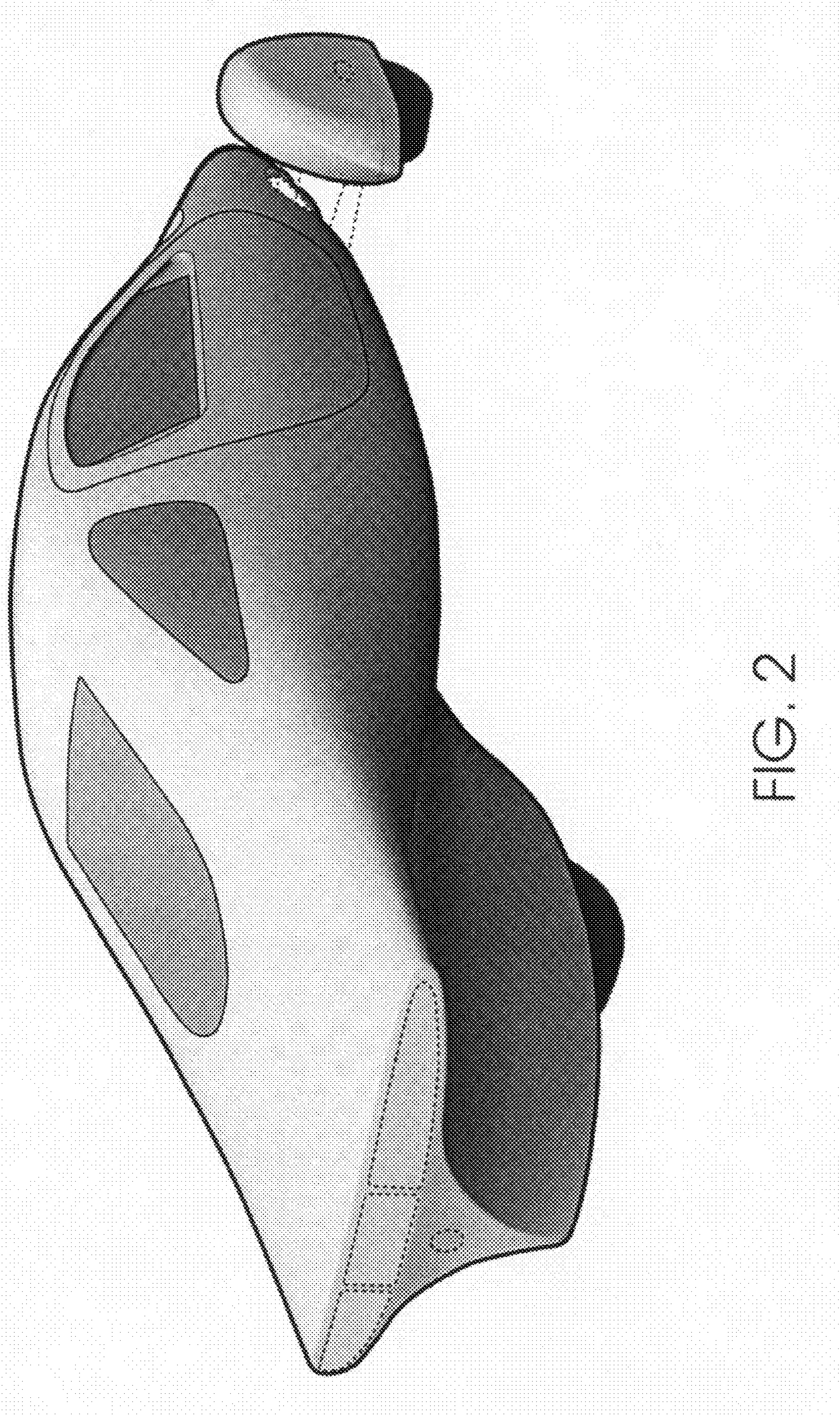

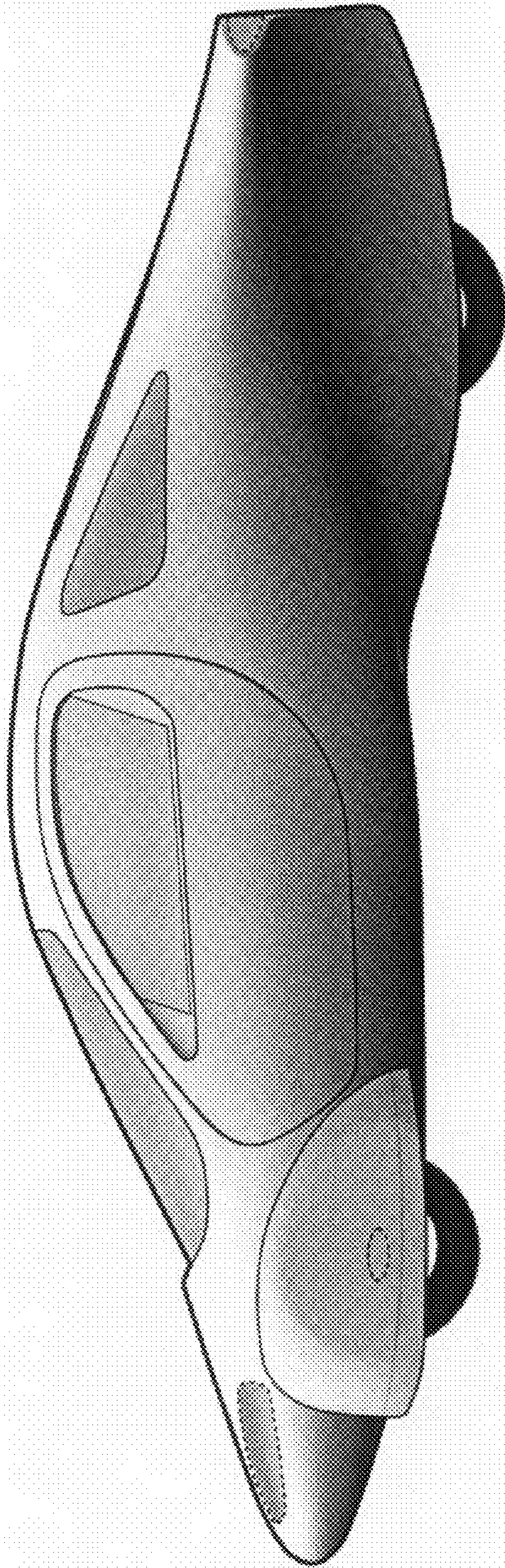

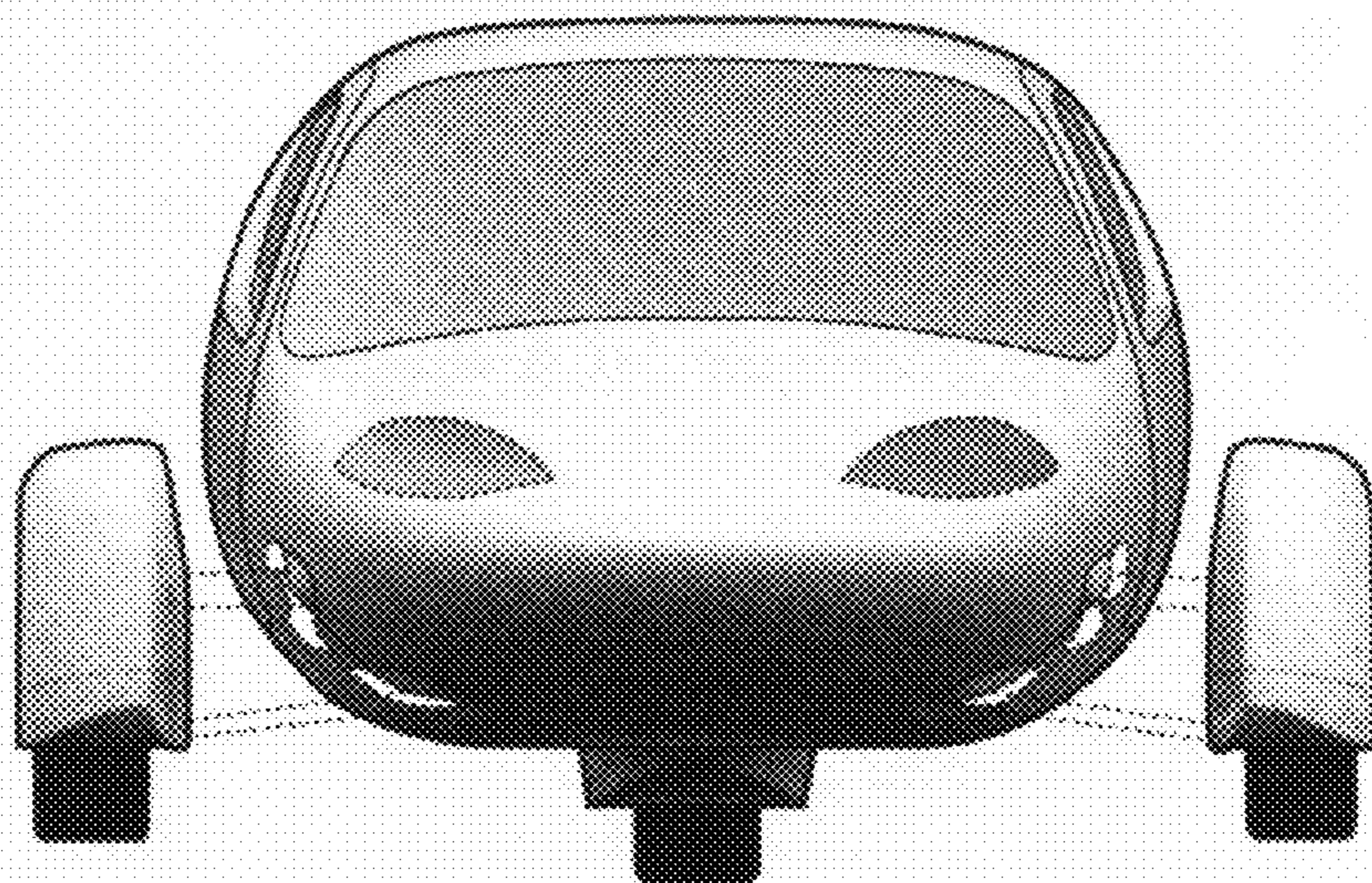

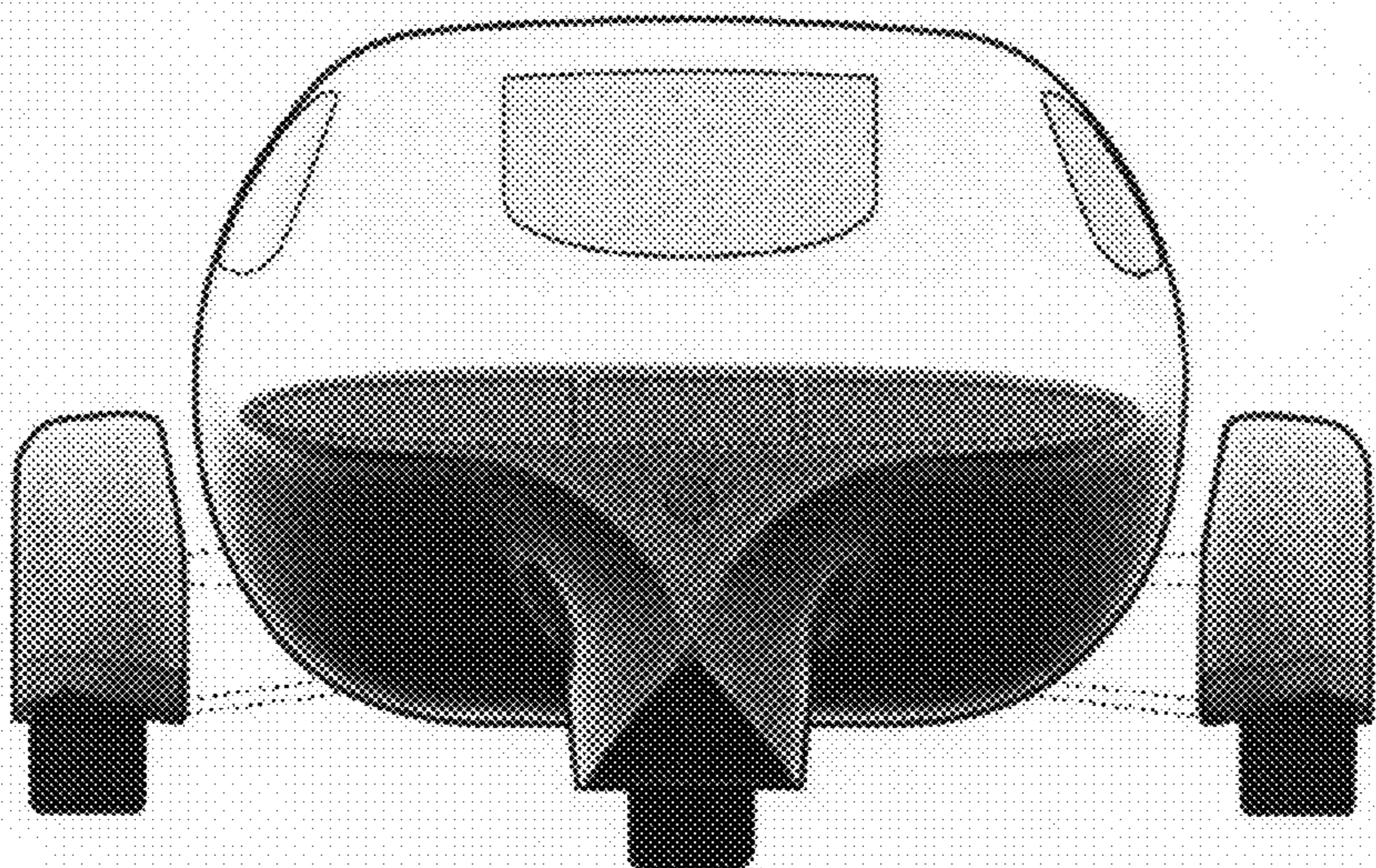

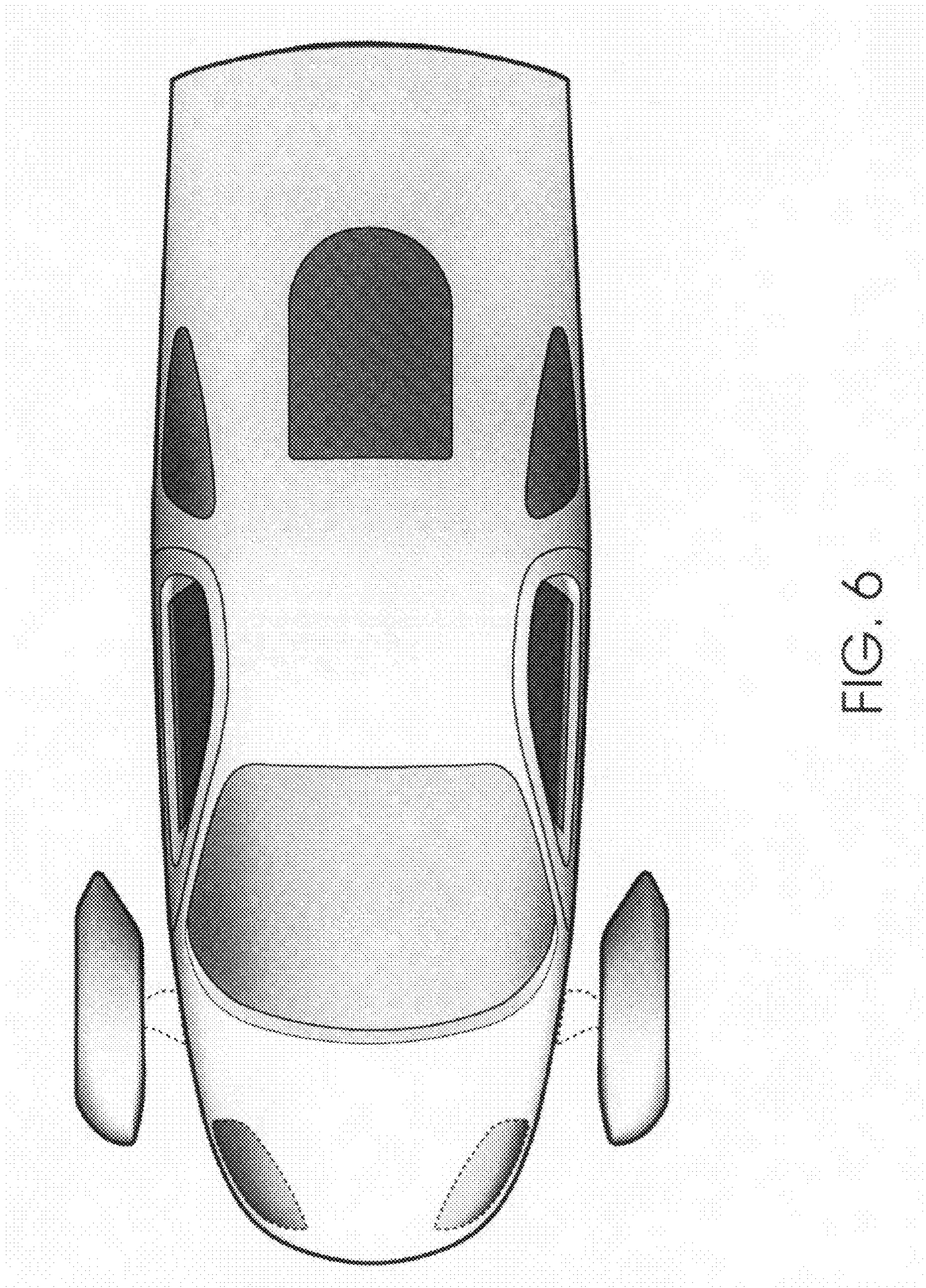

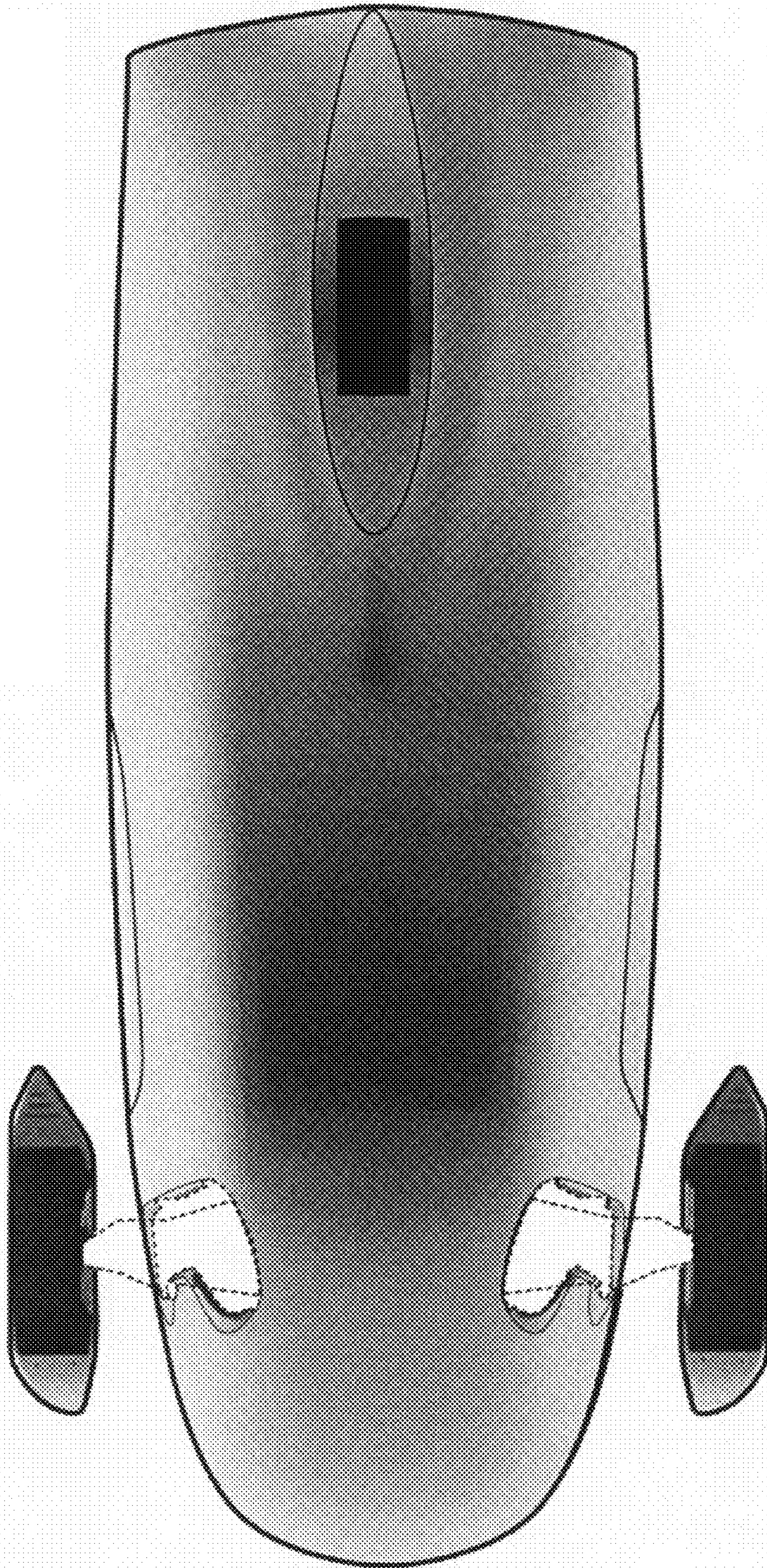
