DESCRIPTION

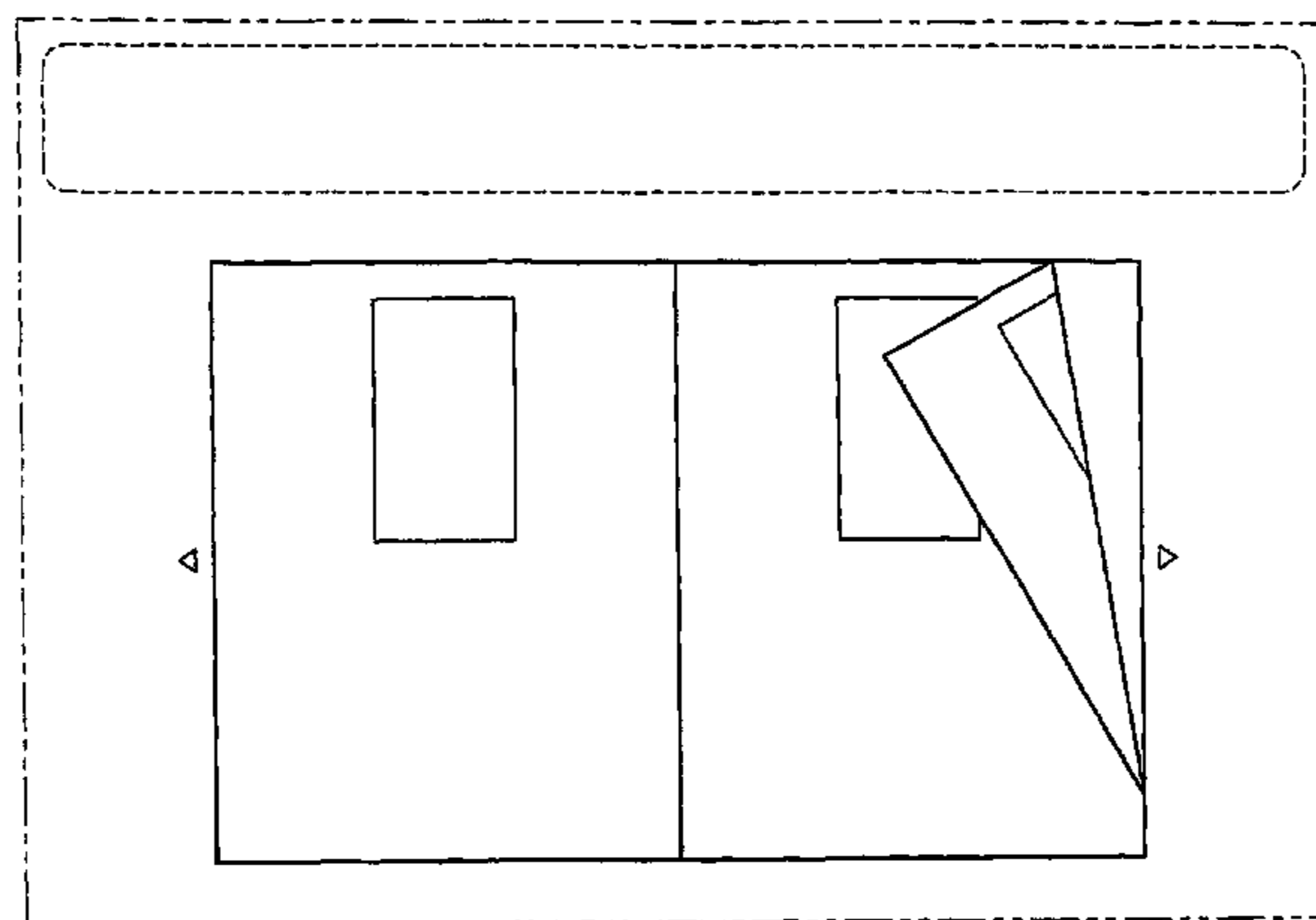

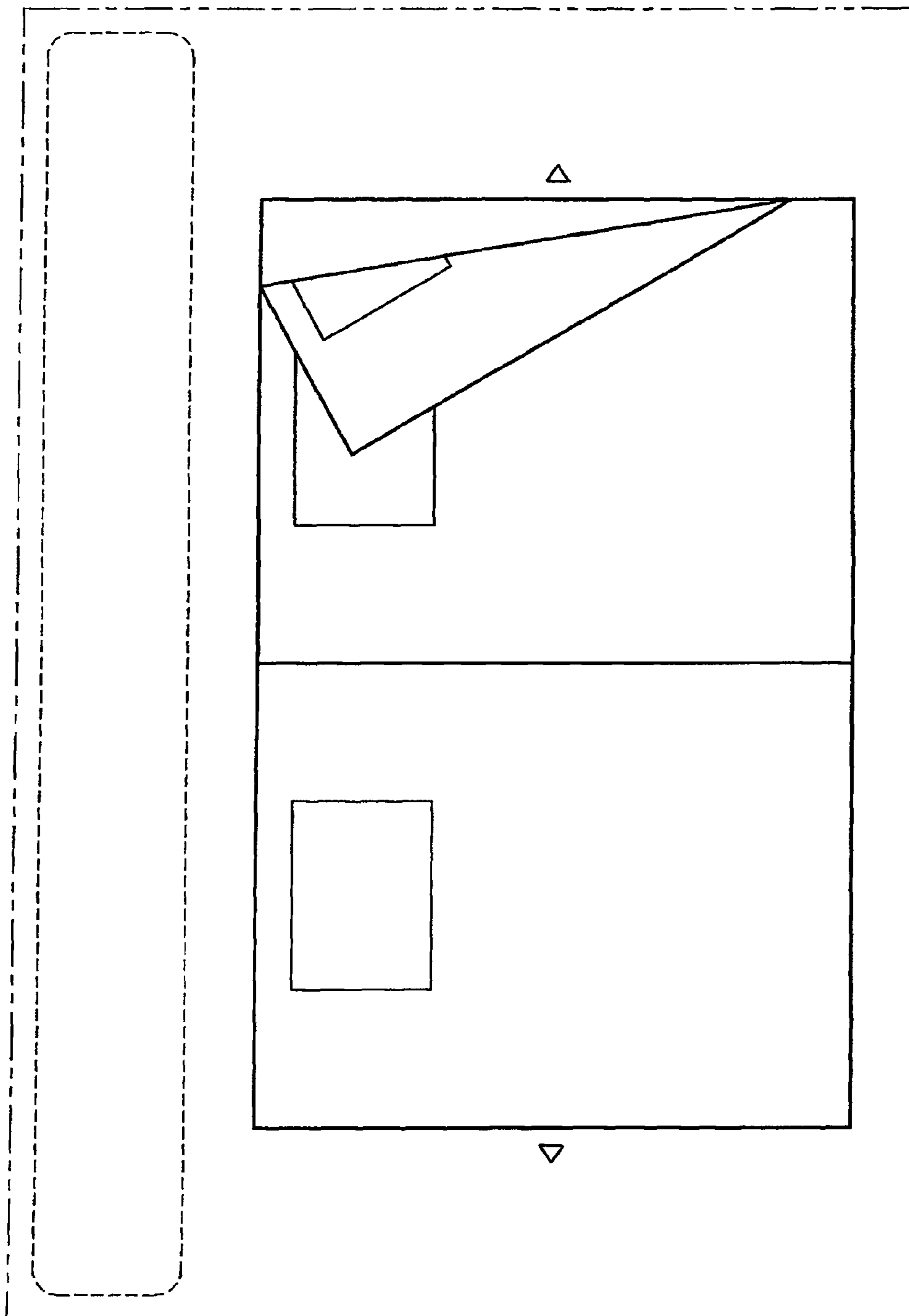
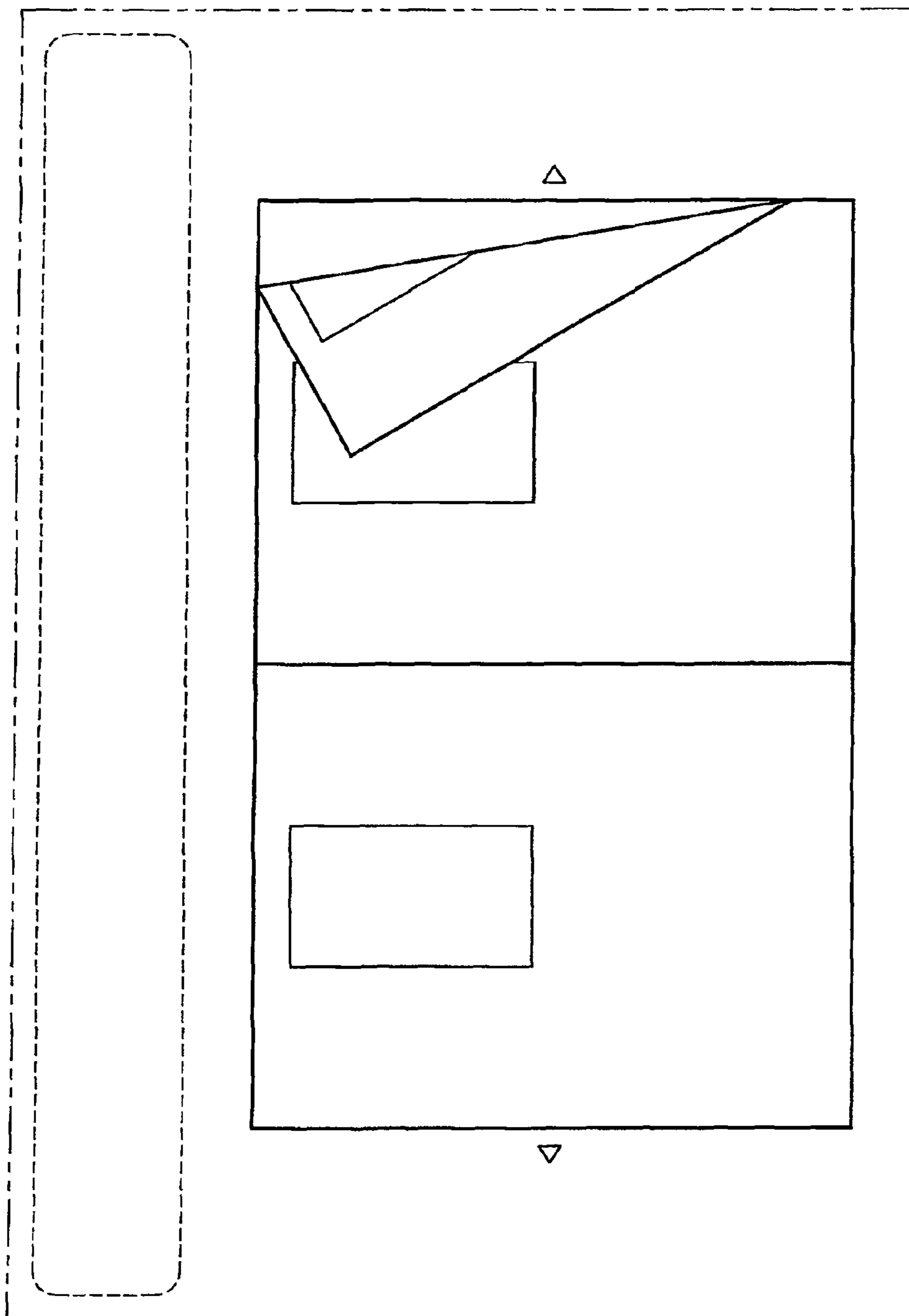
