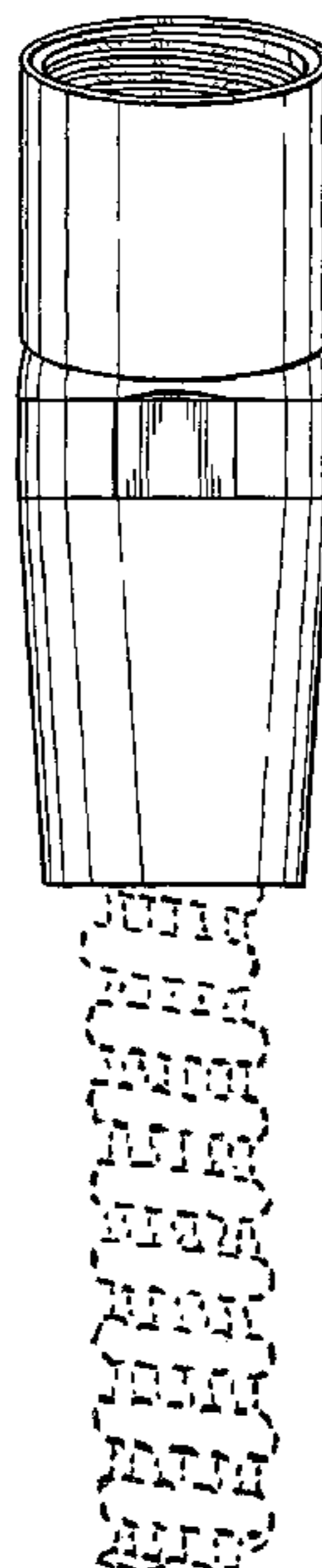
**CLAIM**

(57) The ornamental design for a swivel adapter for faucets, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a swivel adapter for faucets in a forward swiveled position of my new design; FIG. 2 is a left elevational view thereof; FIG. 3 is a right elevational view thereof; FIG. 4 is a top right perspective view thereof; FIG. 5 is a front elevational view thereof, showing the adapter in a rearward swiveled position; FIG. 6 is a top plan view thereof, showing the adapter in an un-swiveled position; and, FIG. 7 is a bottom plan partial cross-sectional view thereof, showing the adapter in an un-swiveled position. The broken lines in the drawing are for illustrative purposes only and form no part of the claimed design.

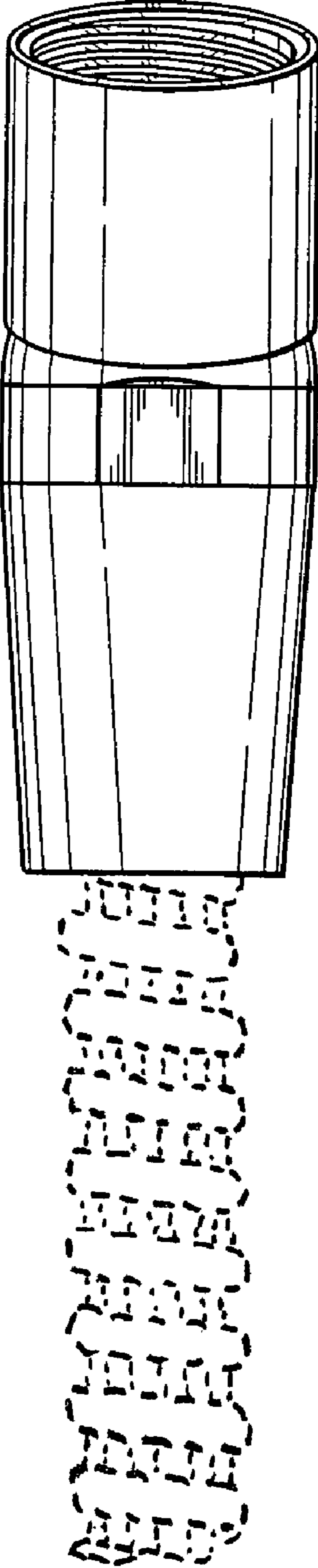

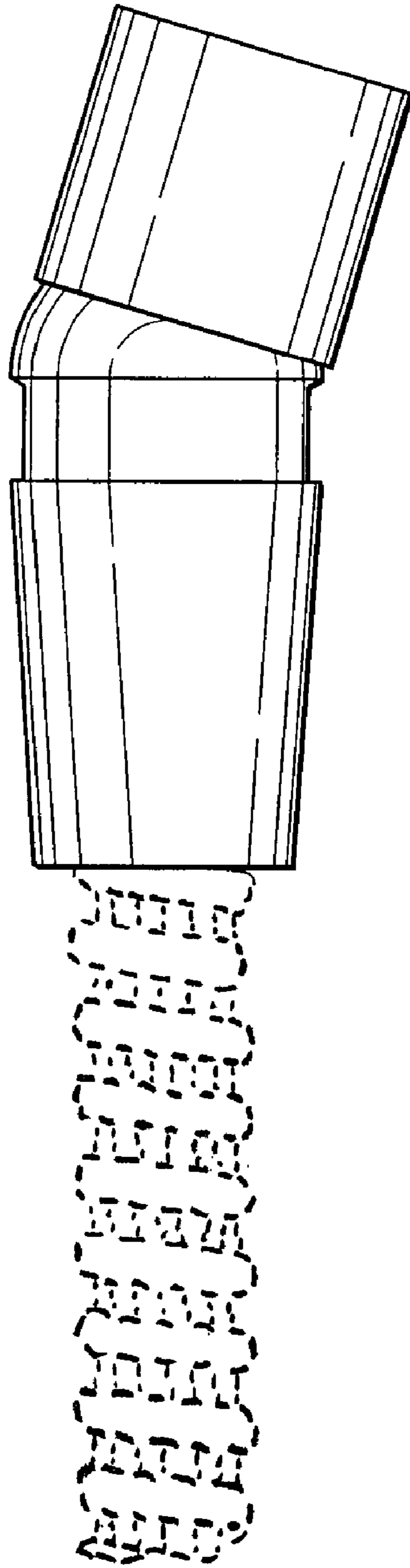

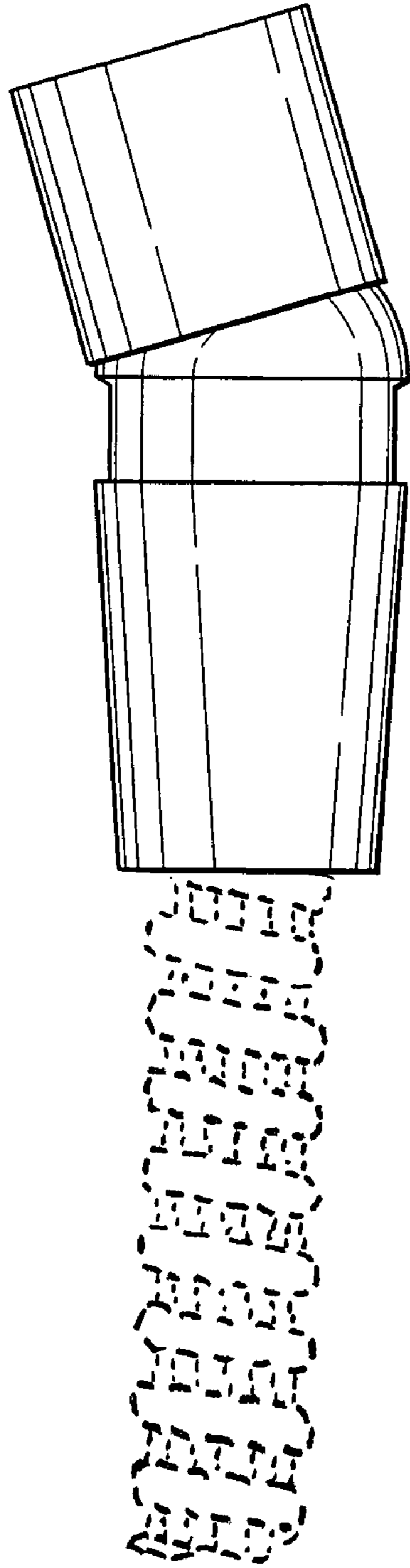

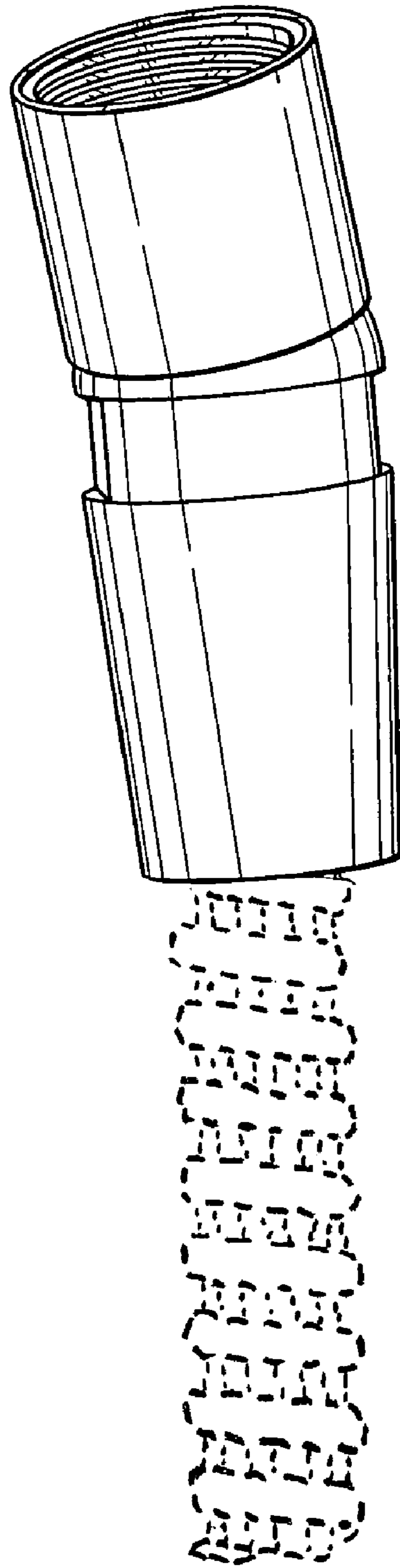

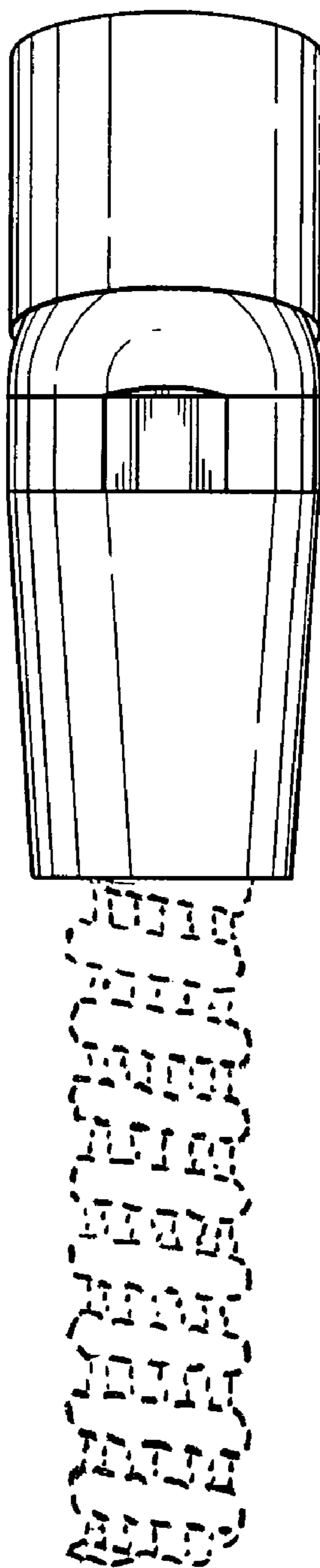

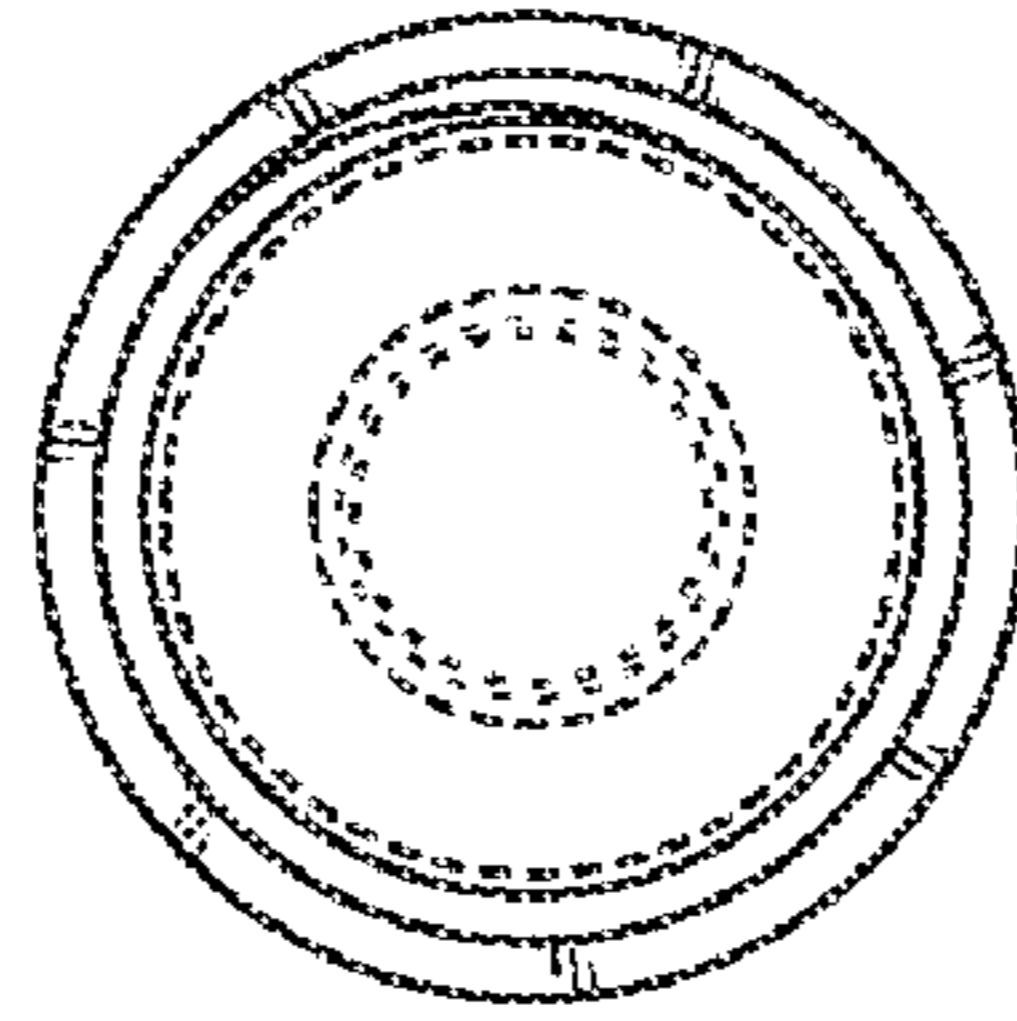

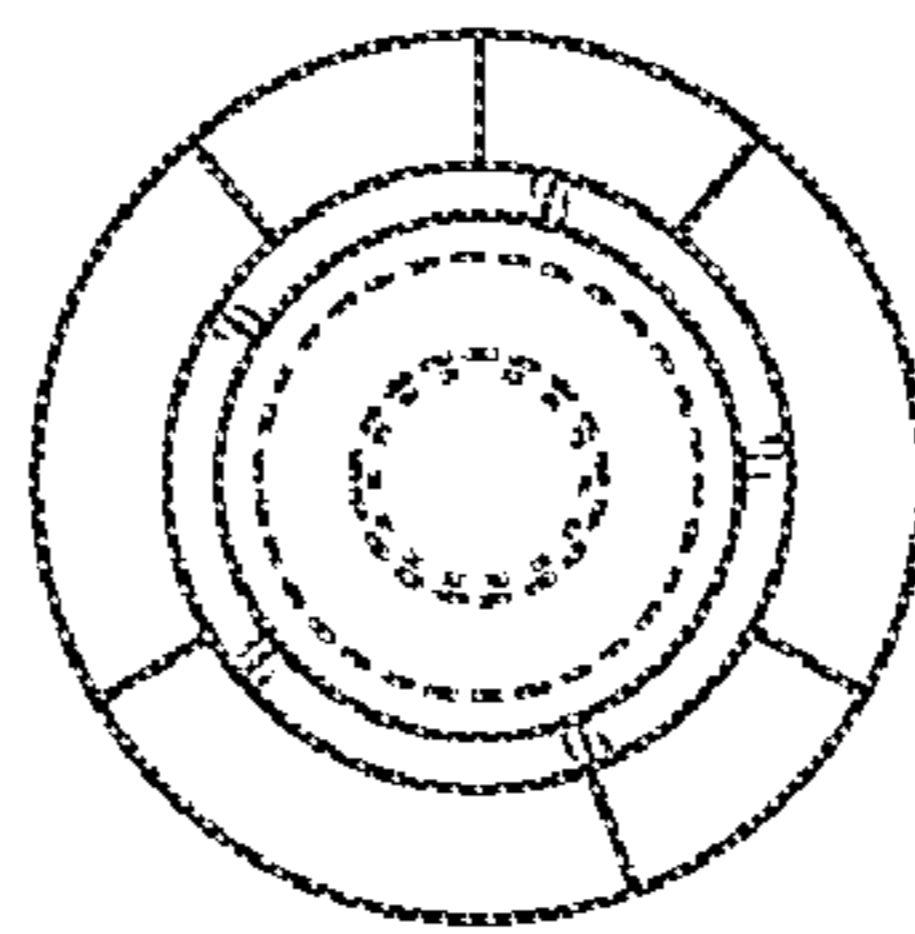
