The ornamental design for a body for a portable heater, as shown and described.

DESCRIPTION

FIG. 1 is a right side front perspective view of a body for a portable heater showing my new design;

FIG. 4 is a right side elevation view thereof;

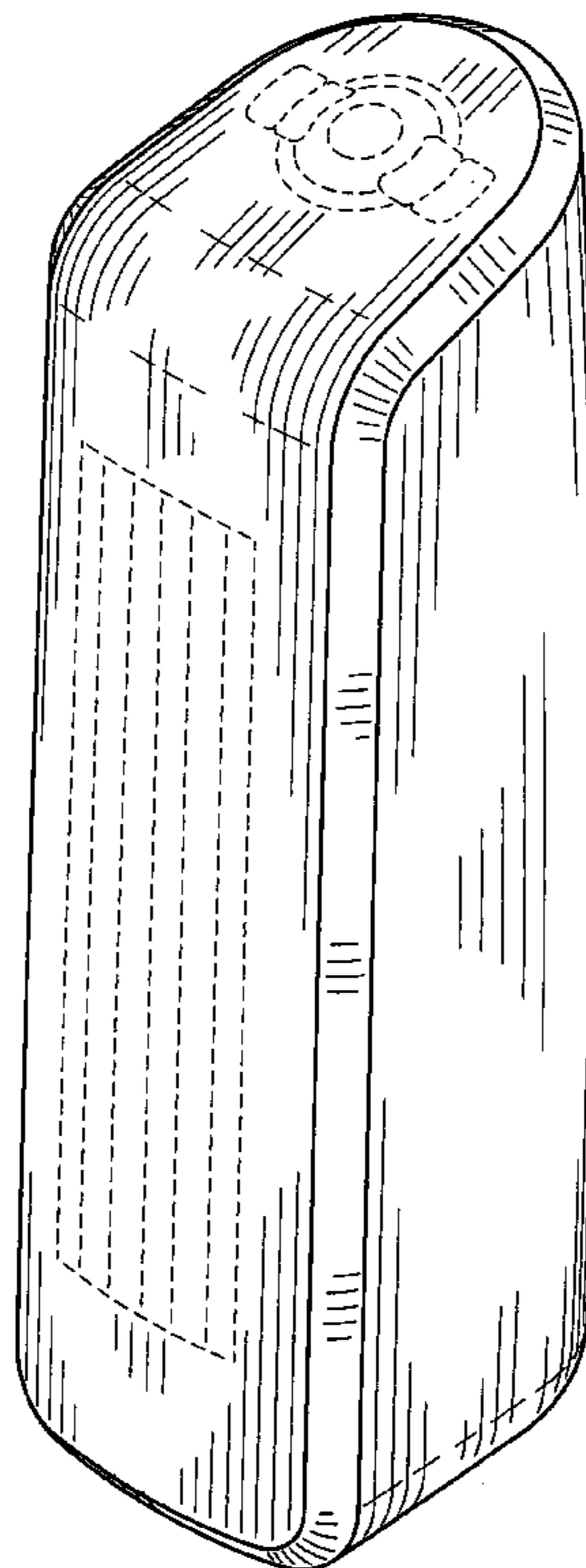
FIG. 5 is a left side elevation view thereof;

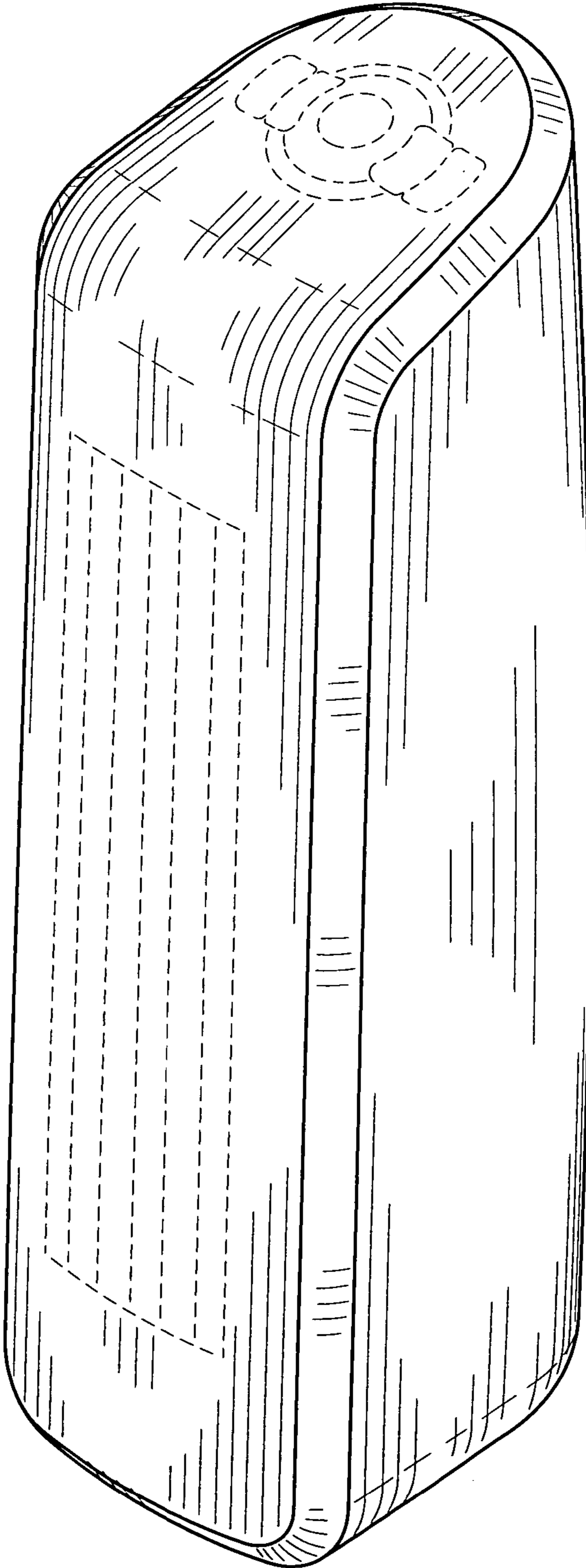

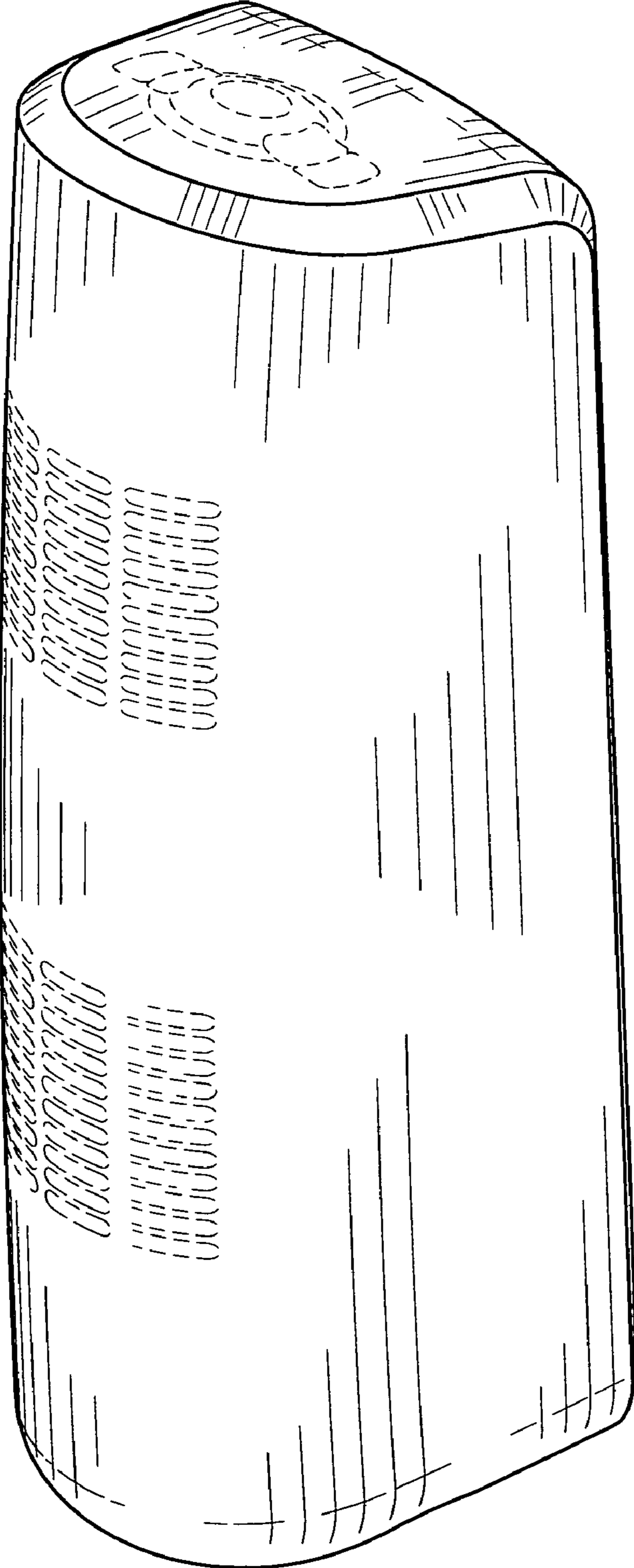

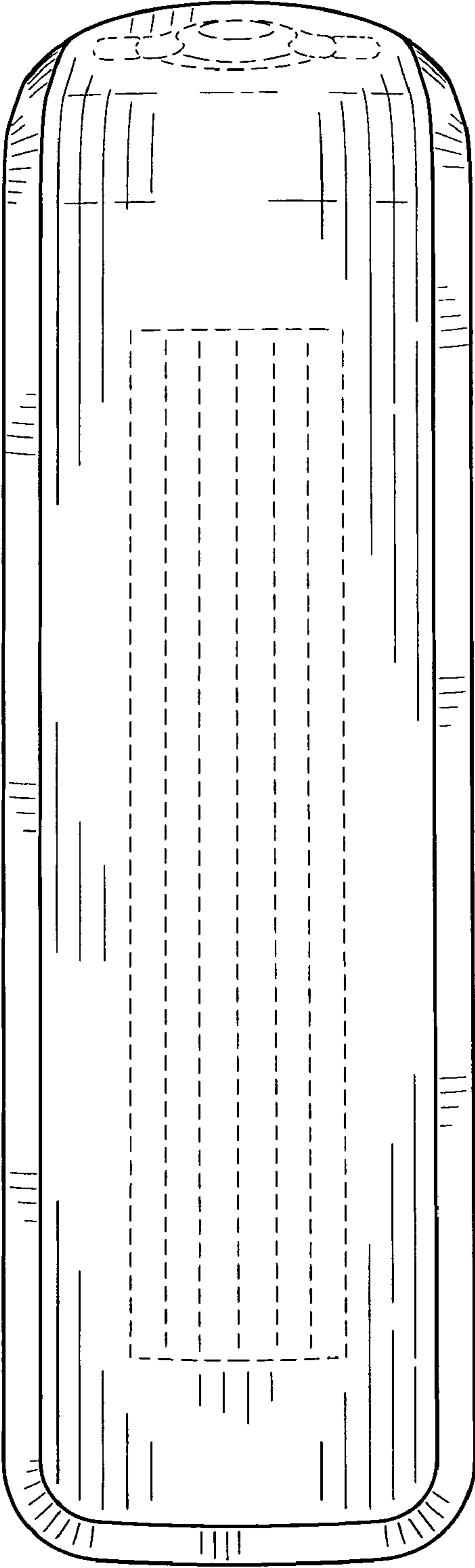

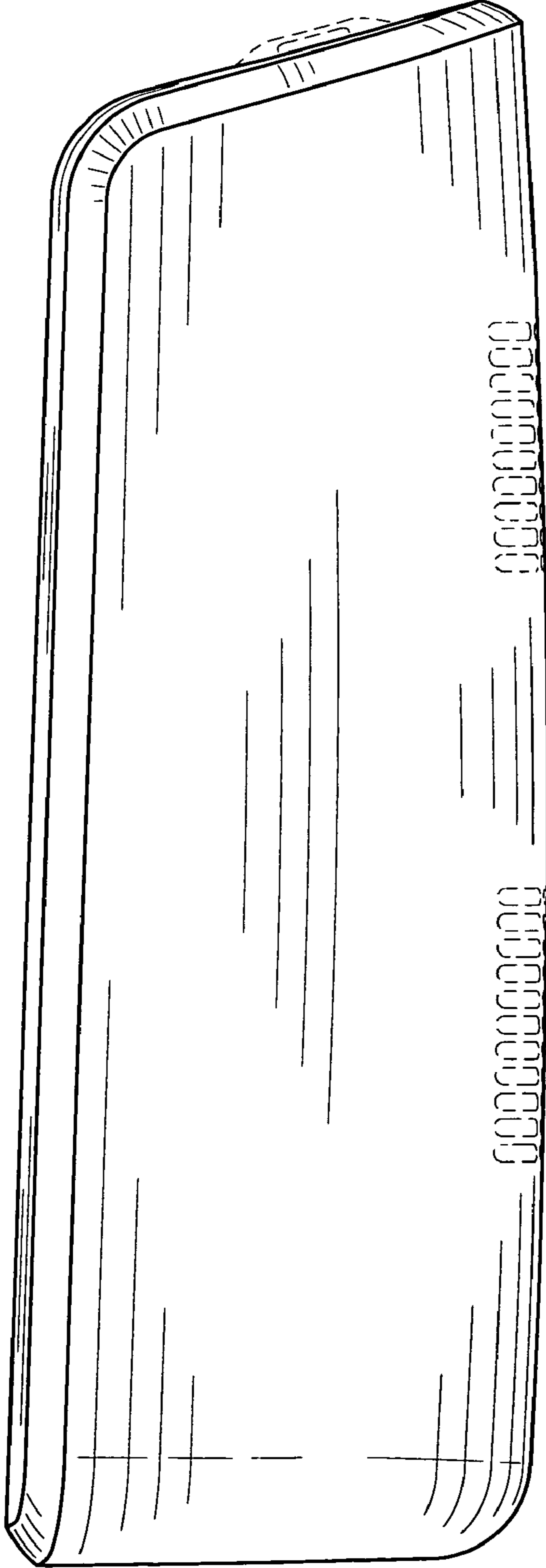

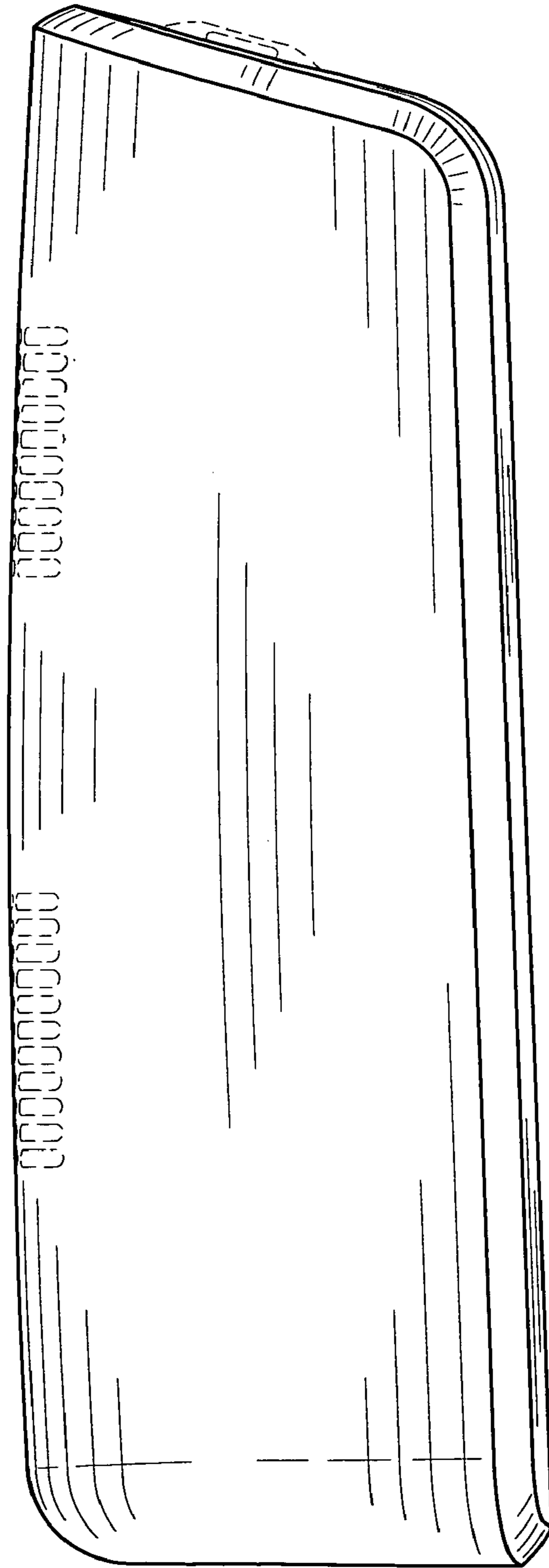

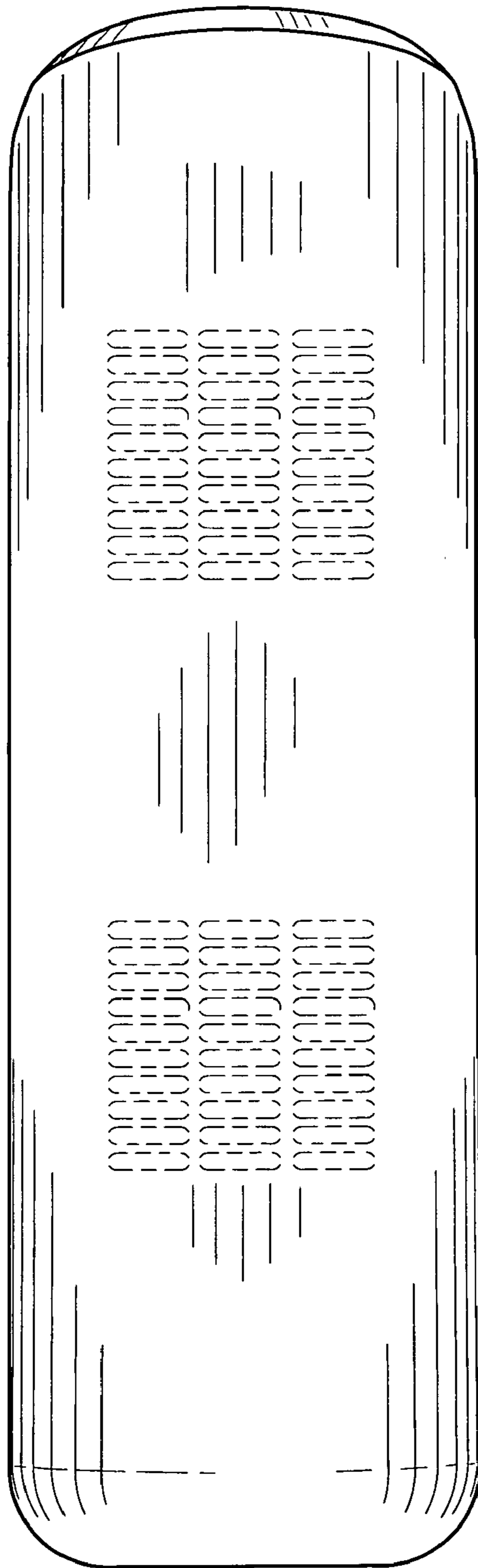

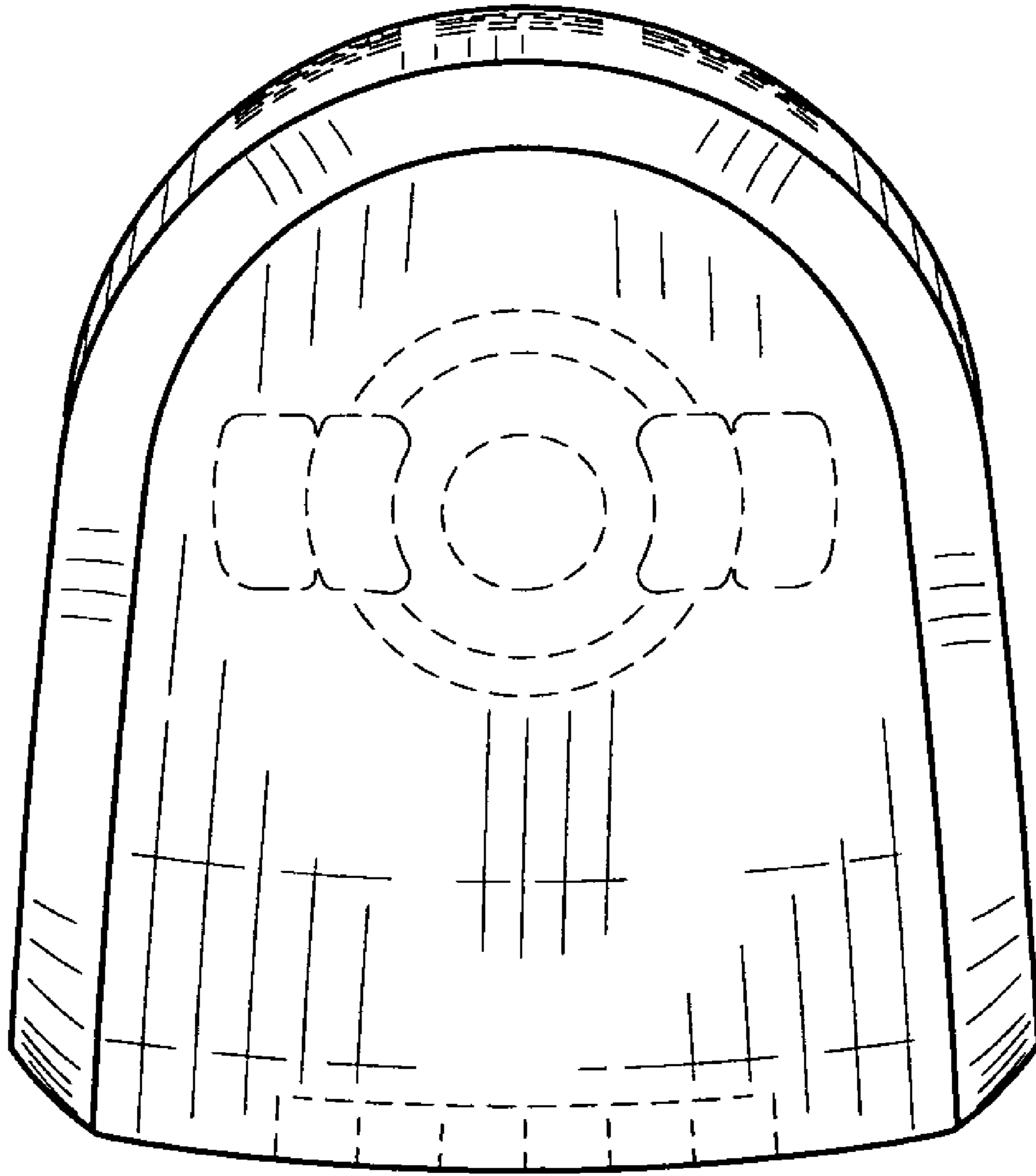
