The ornamental design for a double-cone sphincter introducer assembly and integrated valve assembly, as shown and described.

DESCRIPTION

FIG. 1 is a front and side view of a double-cone sphincter introducer assembly and integrated valve assembly;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

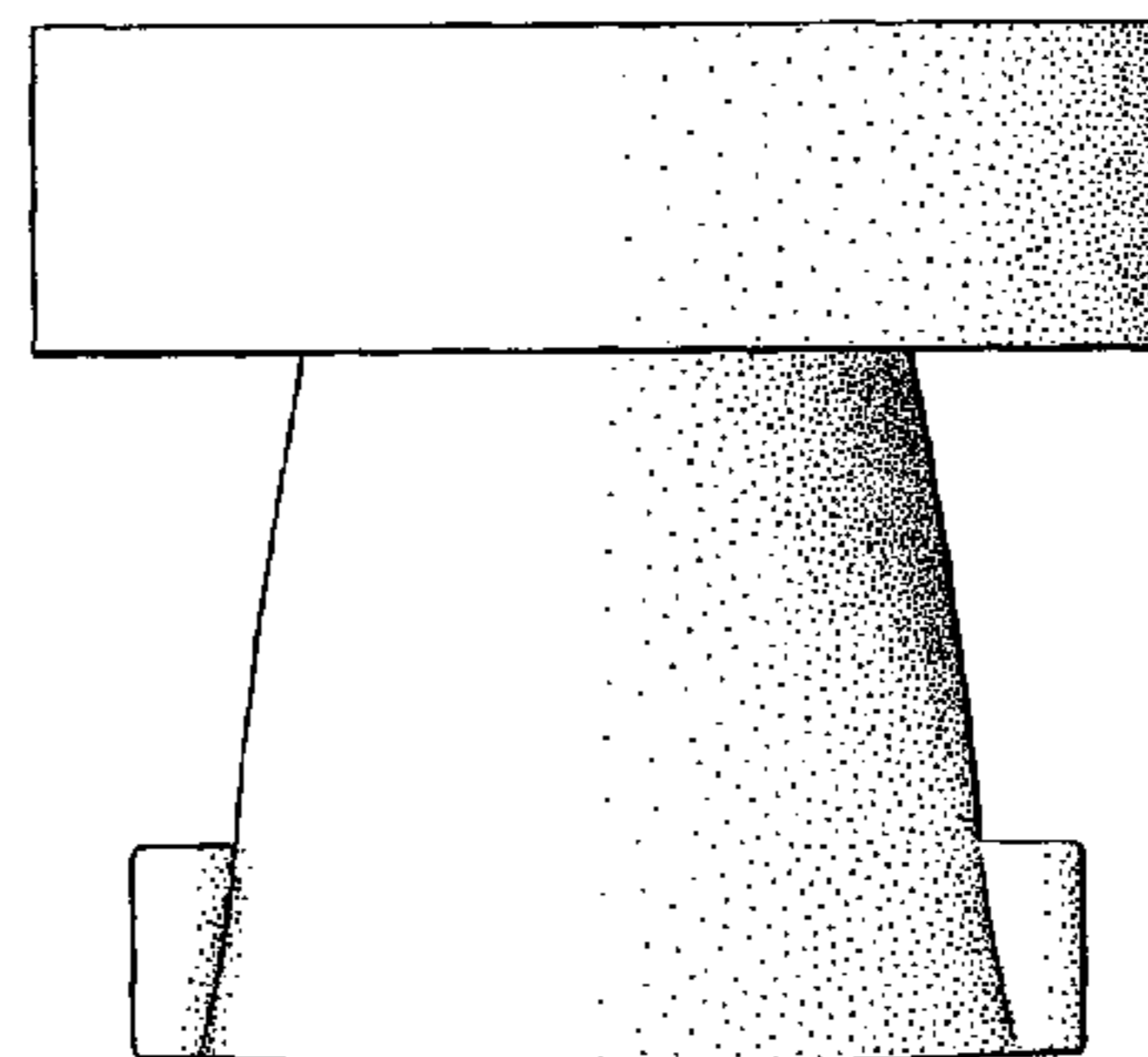
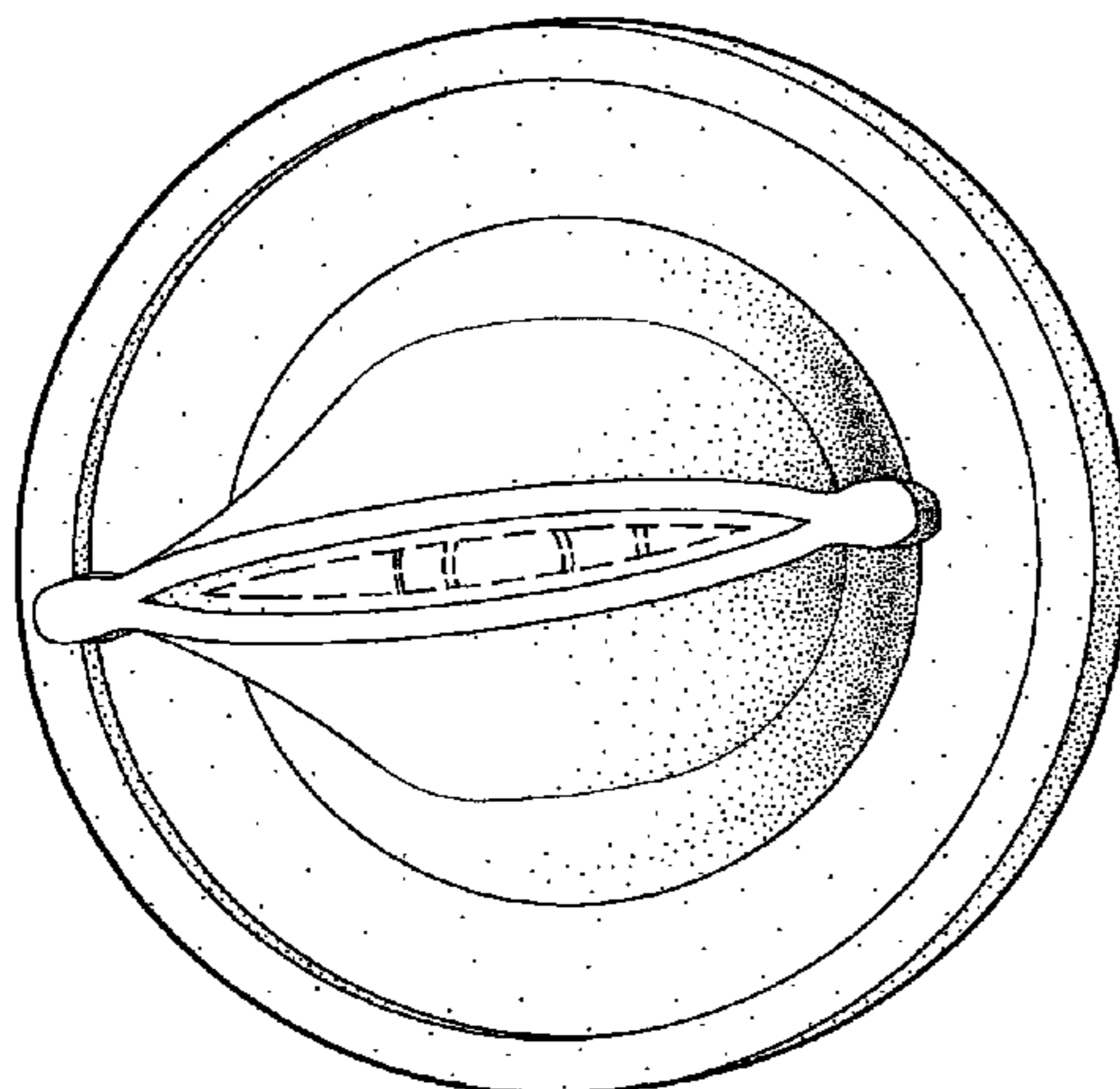
FIG. 5 is a rear elevational view thereof;

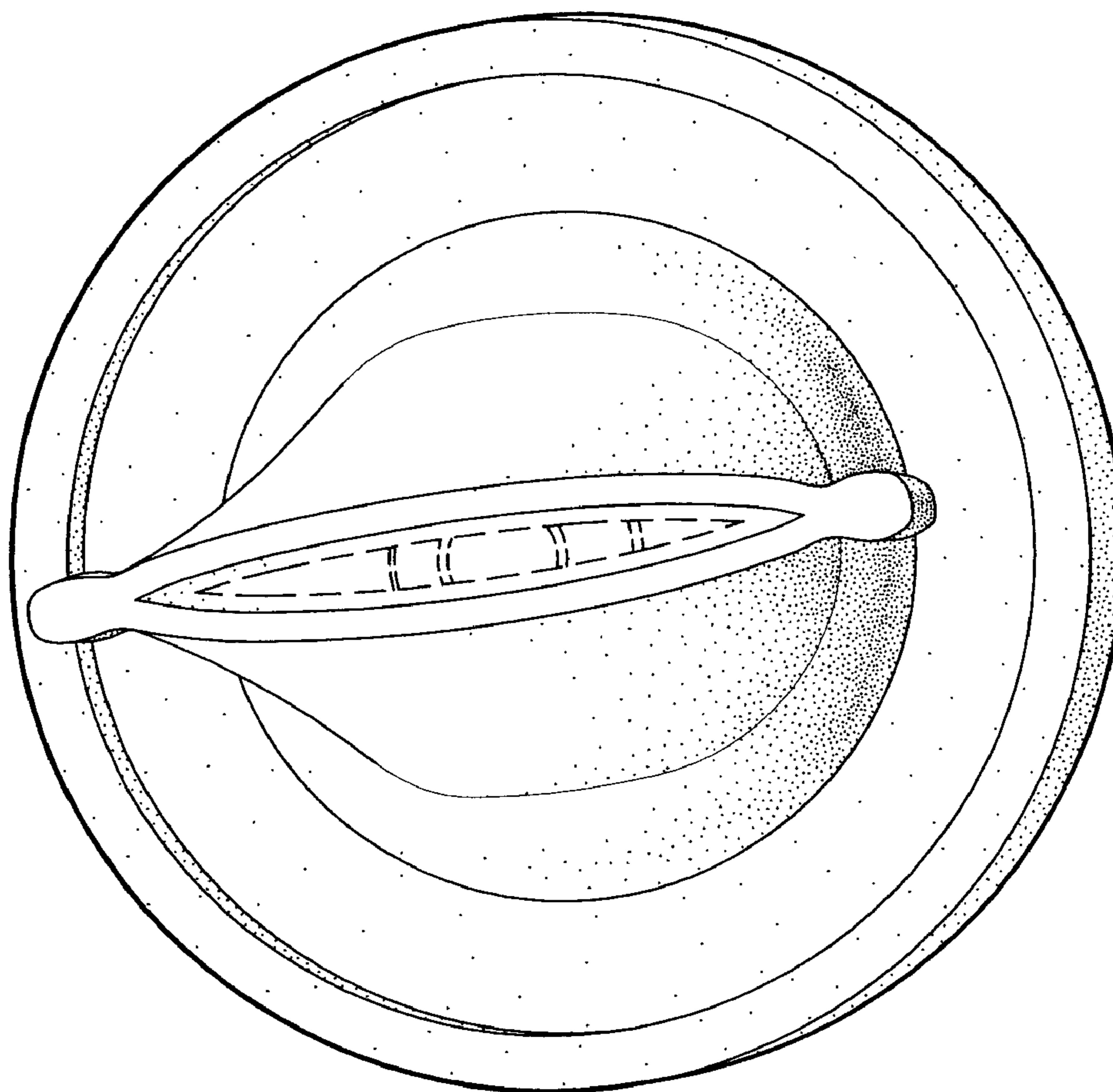

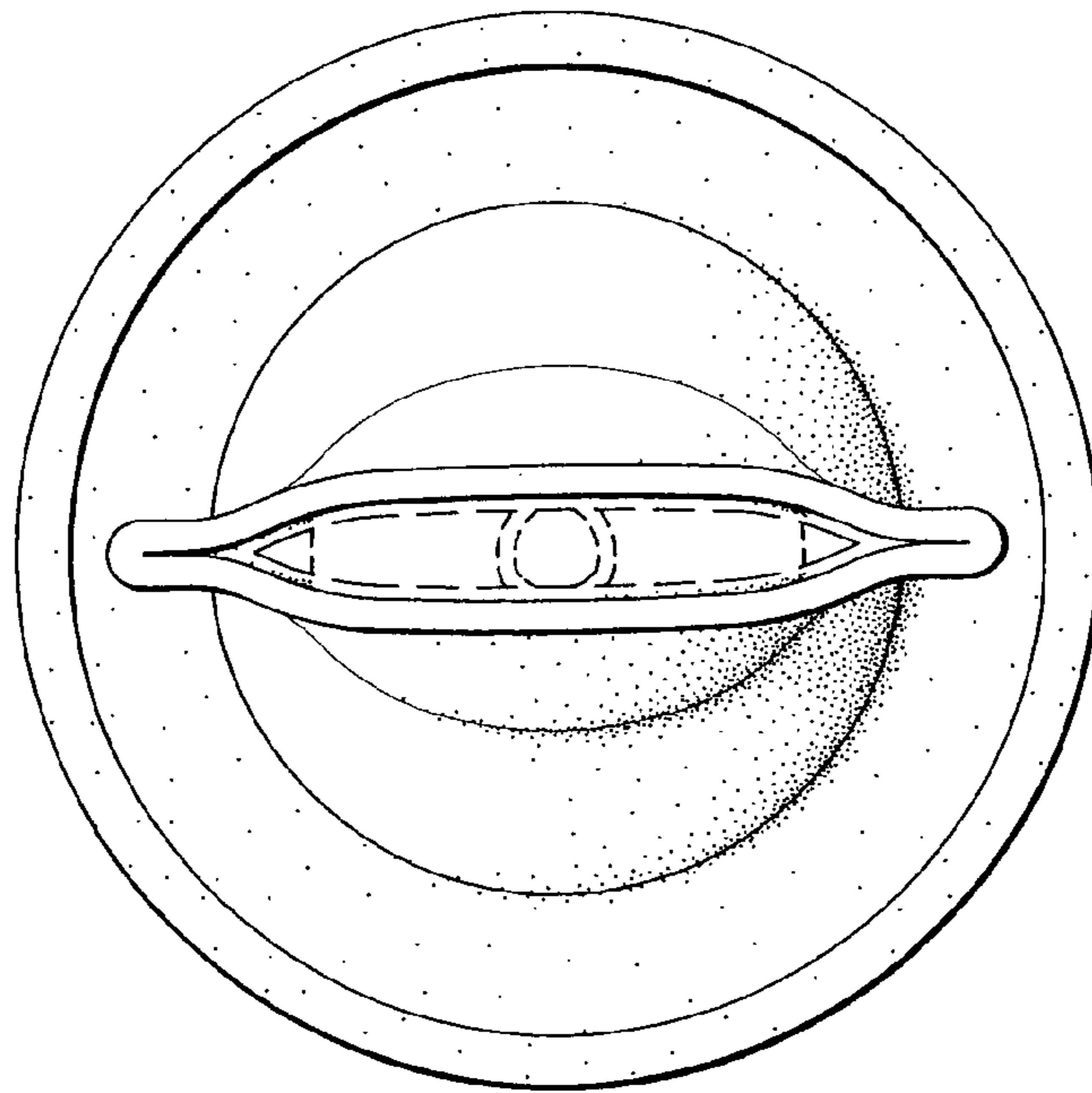

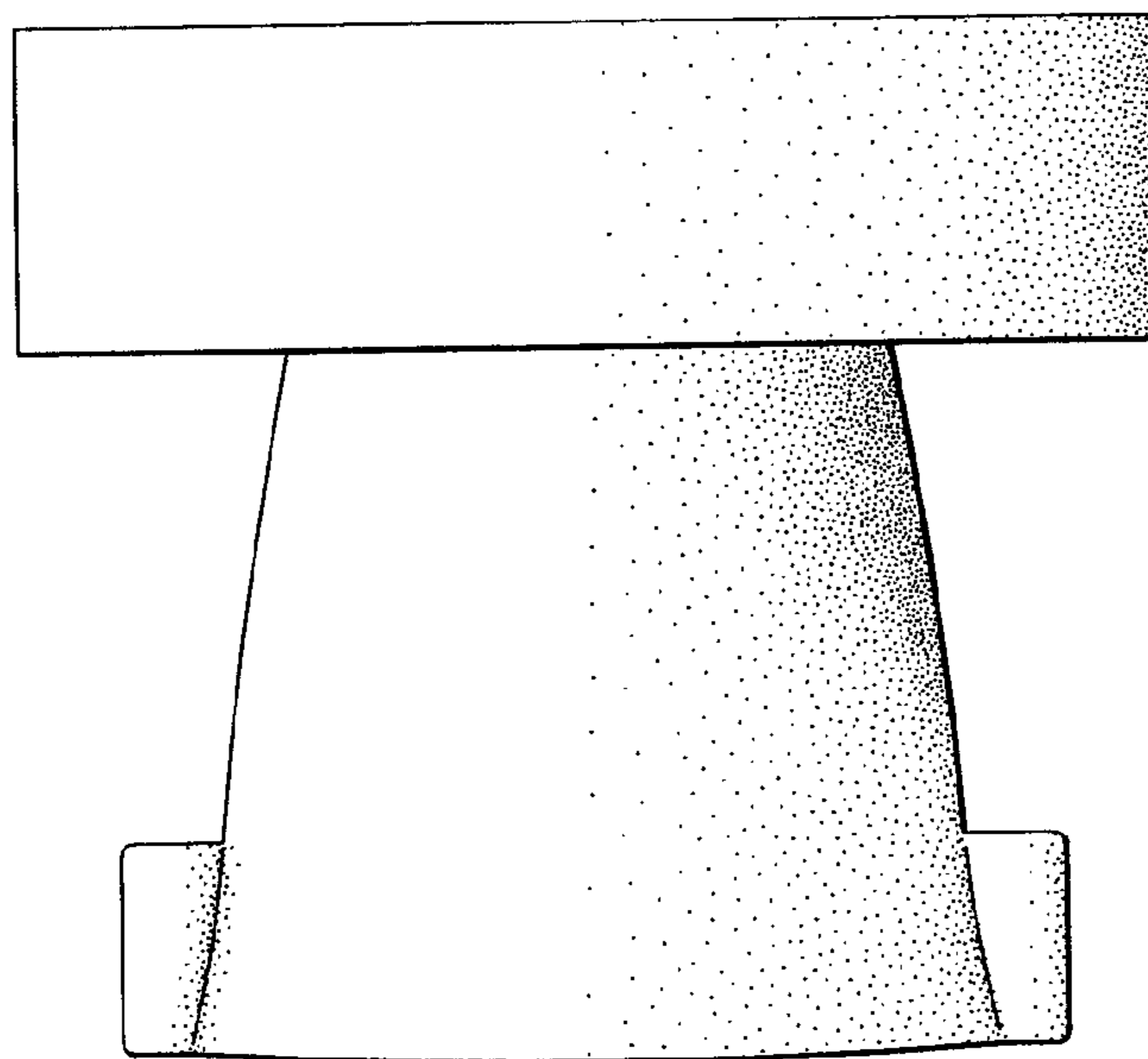

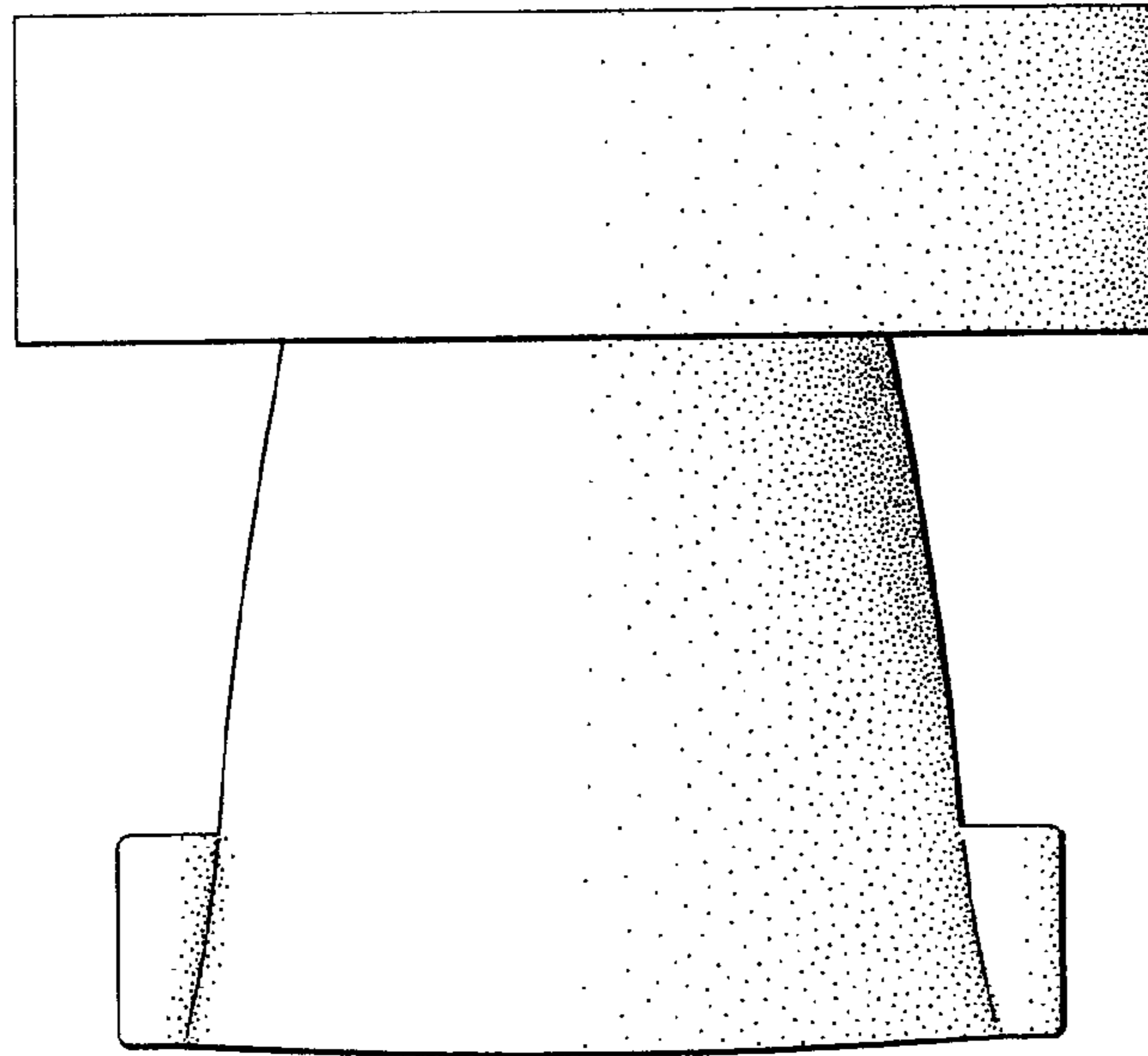

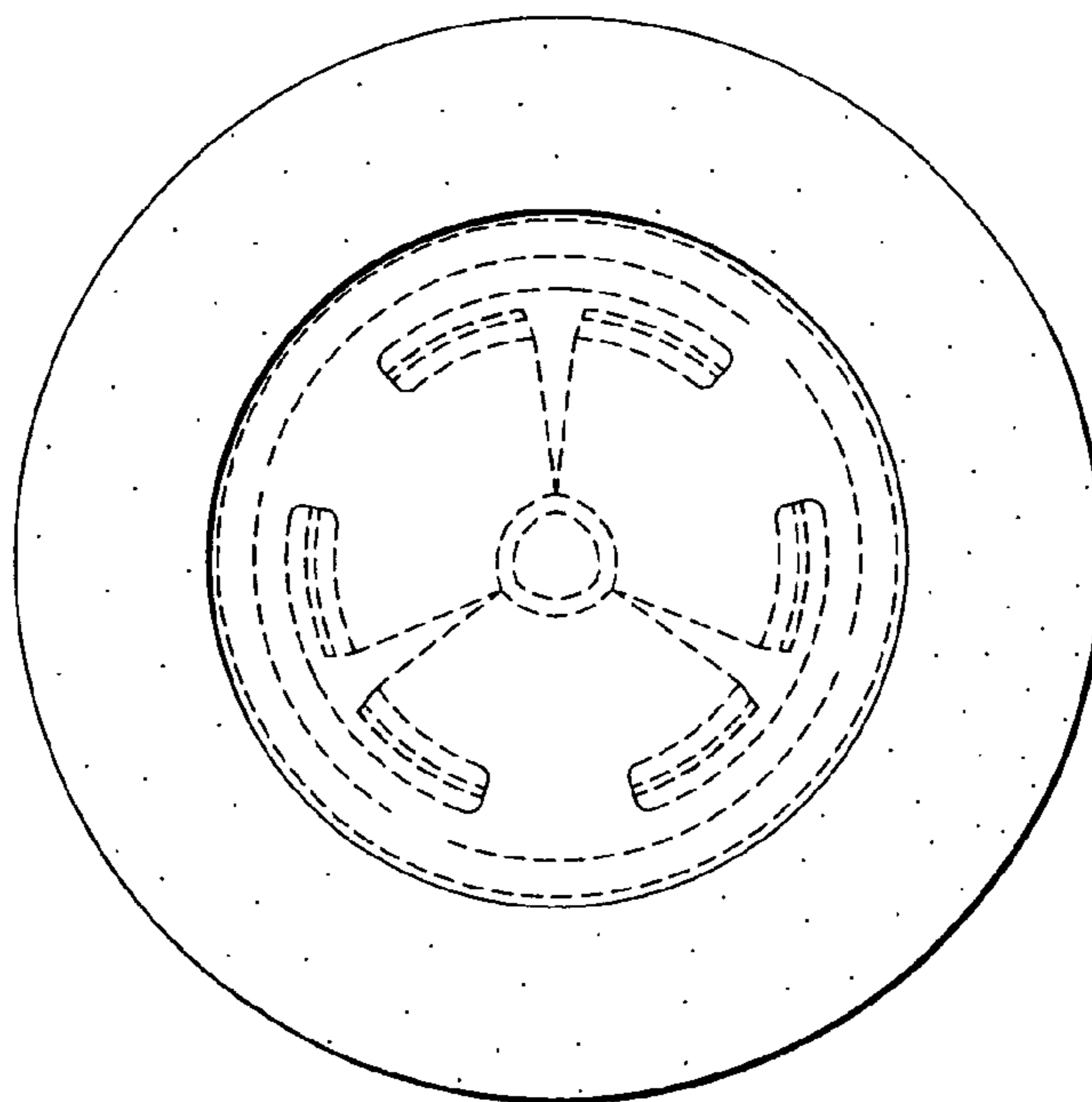

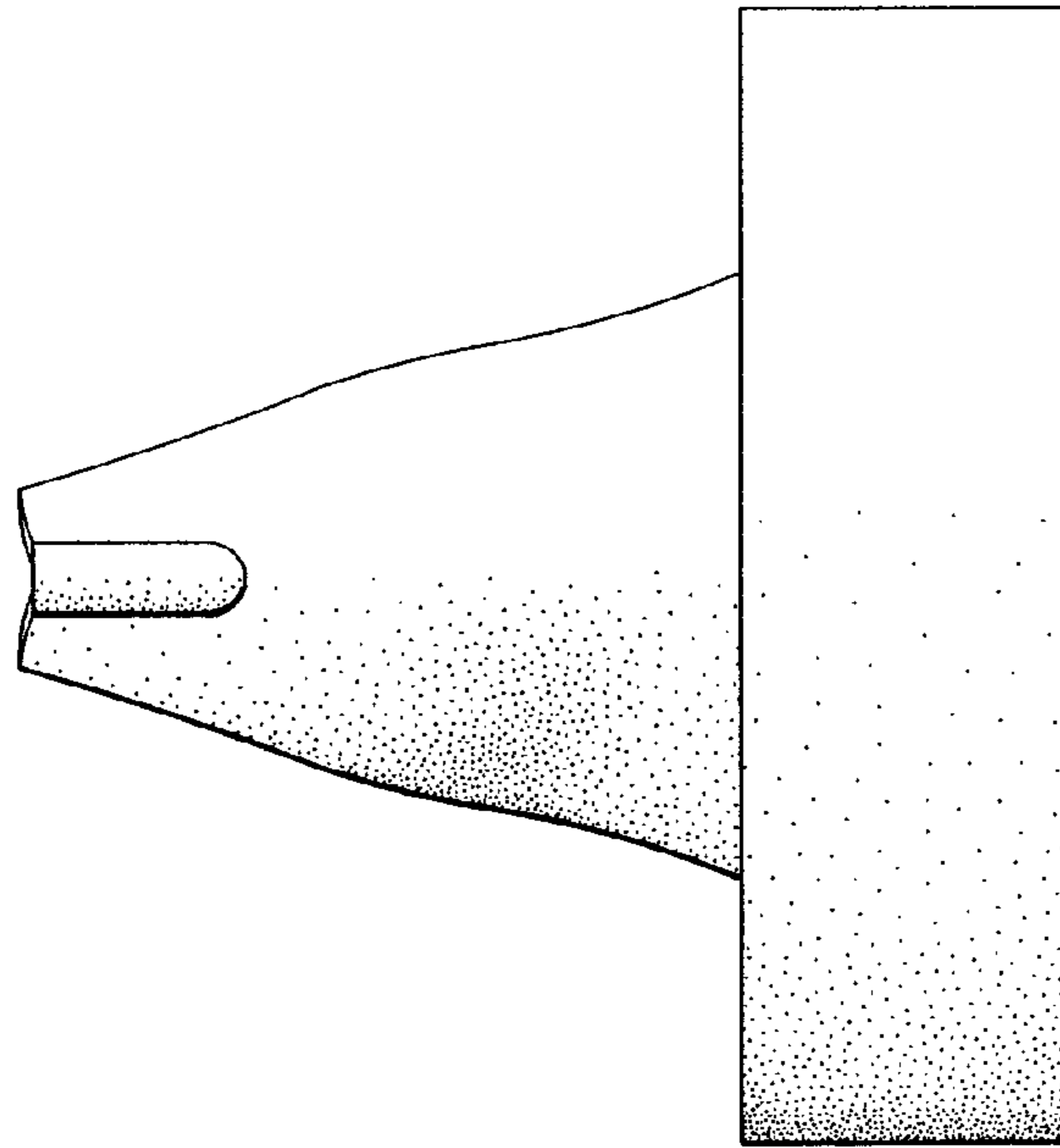

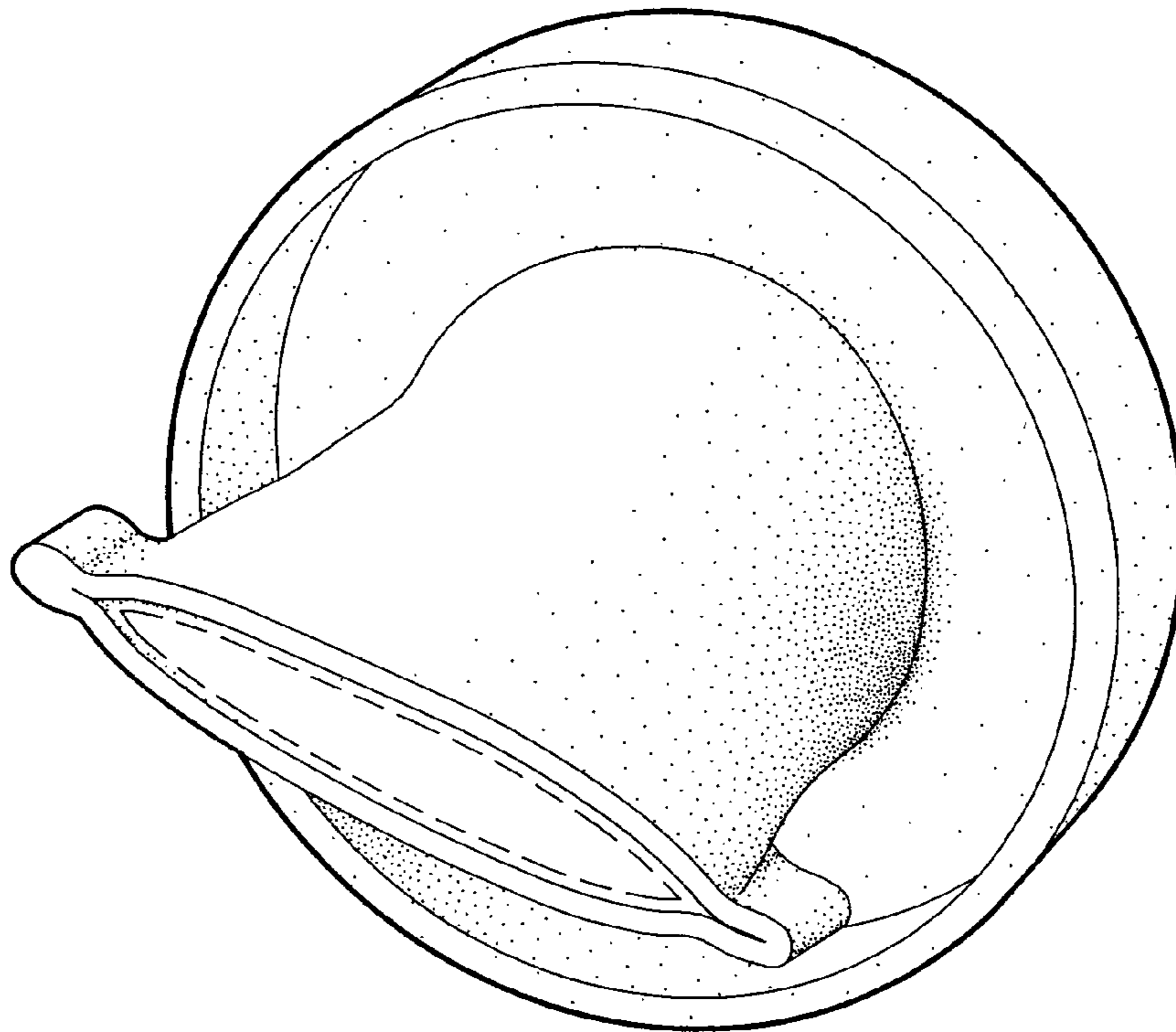
