(57) **CLAIM**

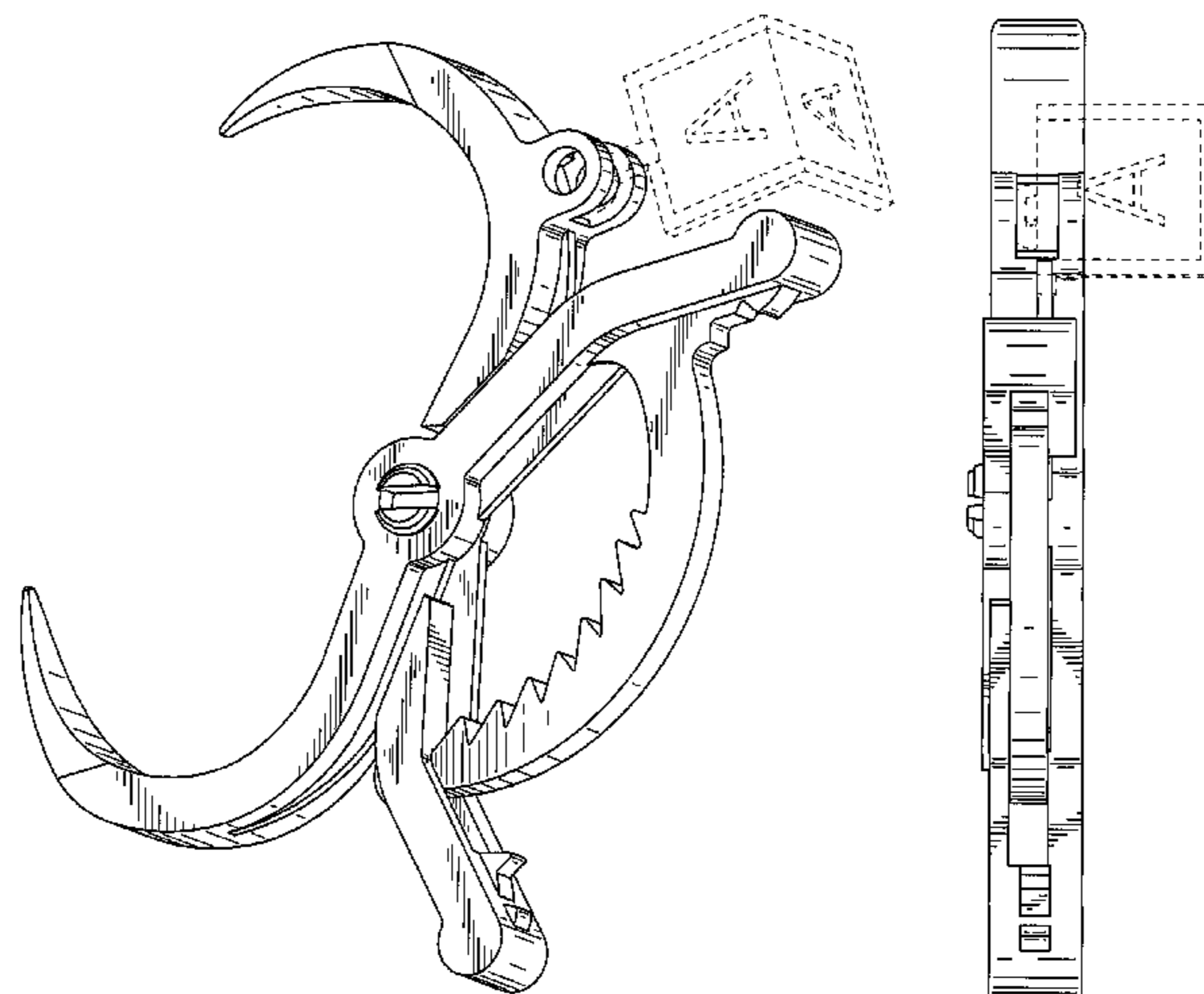
We claim the ornamental design for a surgical clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a surgical clip embodying the invention;  
FIG. 2 is a front view of the surgical clip of FIG. 1;  
FIG. 3 is a rear view of the surgical clip of FIG. 1;  
FIG. 4 is a right side view of the surgical clip of FIG. 1;  
FIG. 5 is a left side view of the surgical clip of FIG. 1;  
FIG. 6 is a top view of the surgical clip of FIG. 1; and,  
FIG. 7 is a bottom view of the surgical clip of FIG. 1.

The broken lines showing portions of a surgical clip are included for illustrating environmental structure and forms no part of the claimed design.

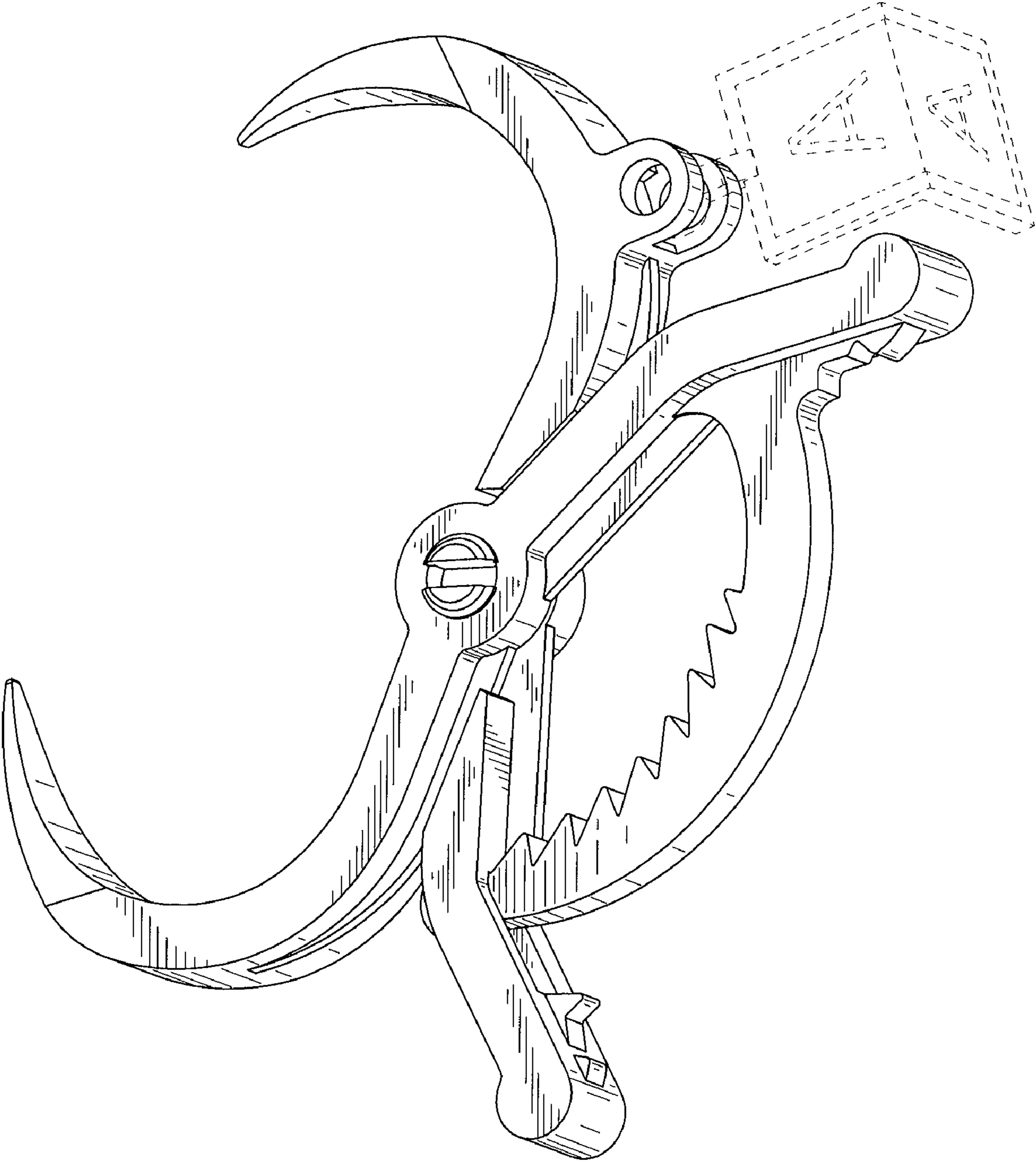

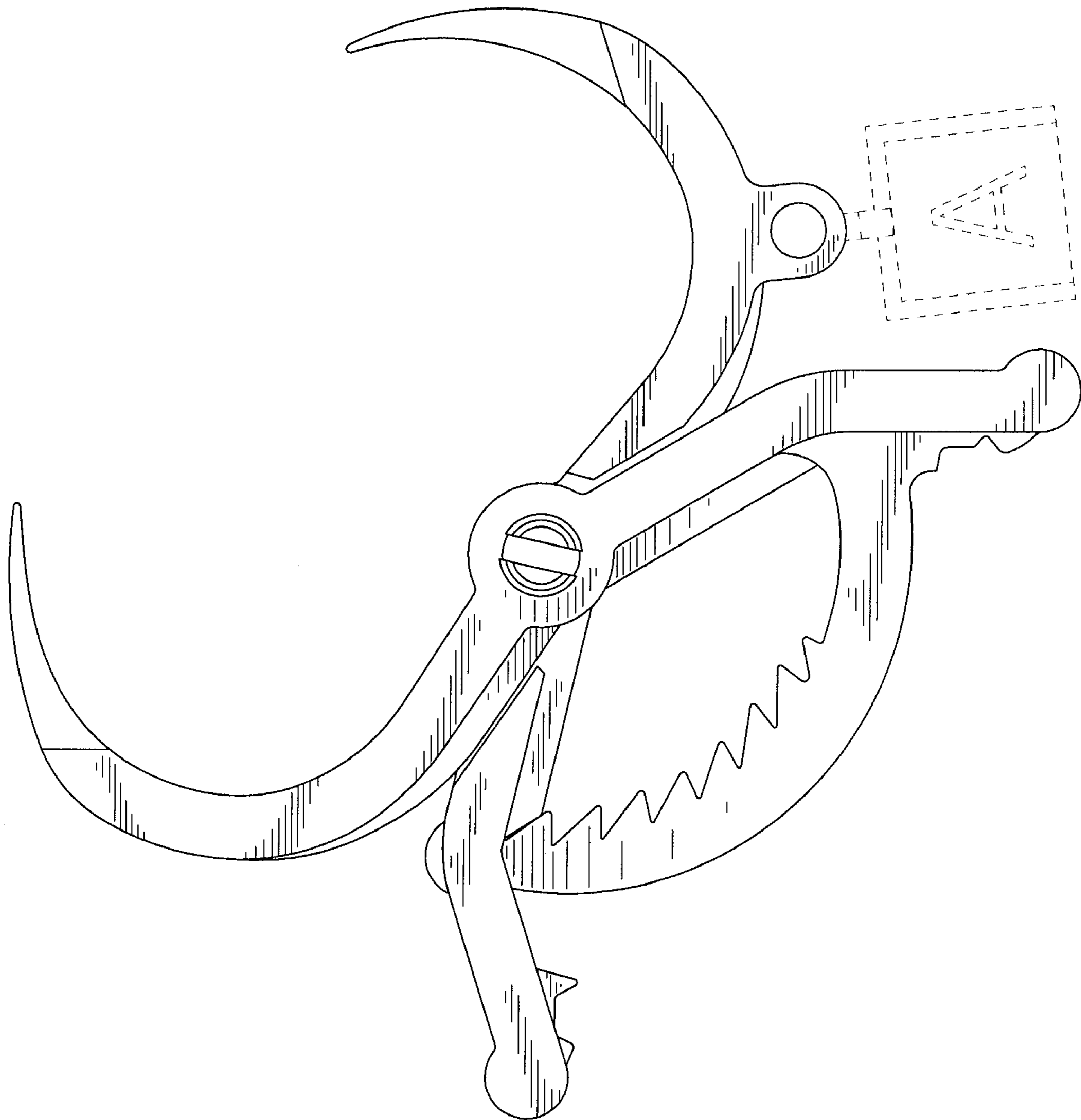

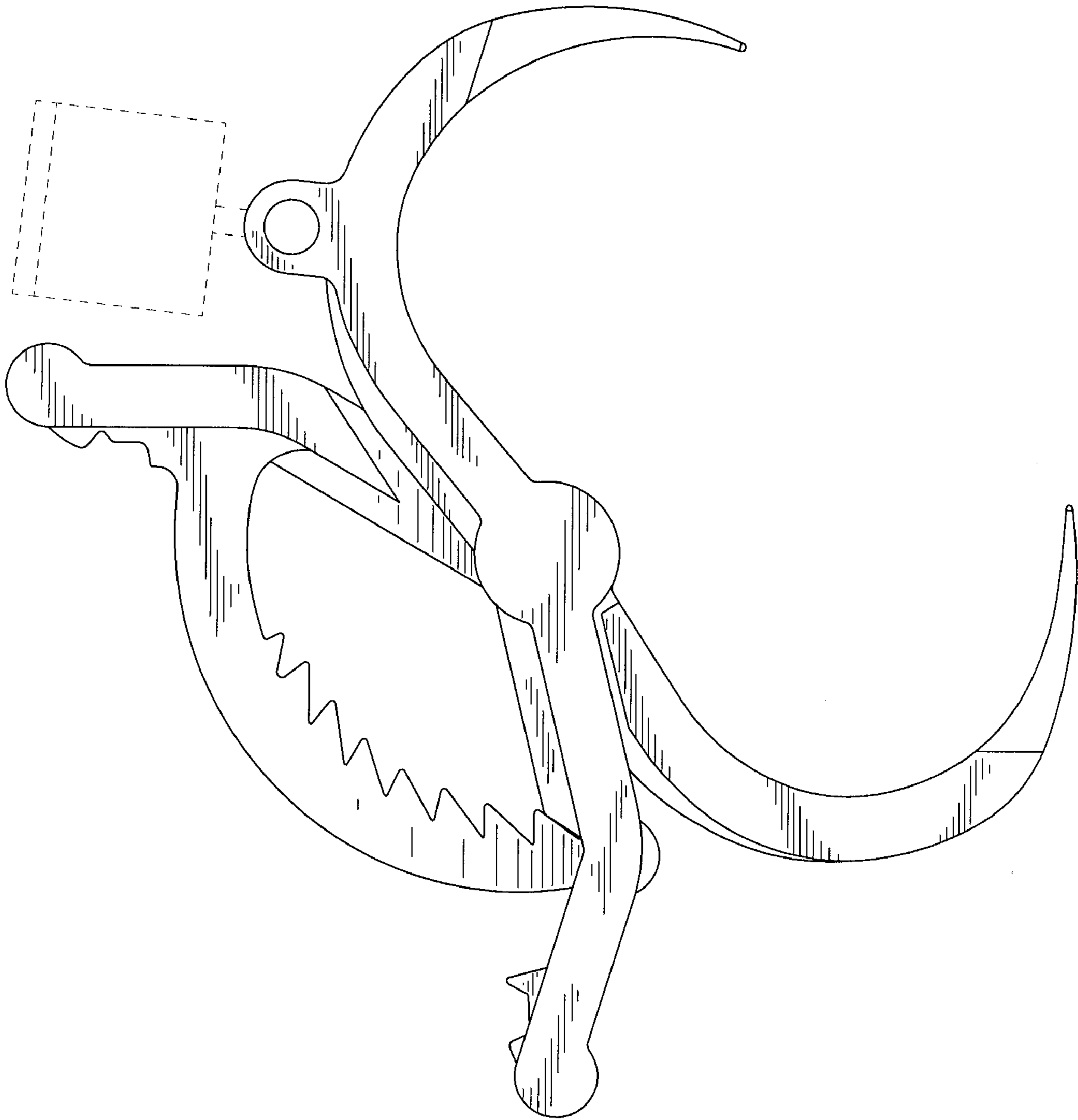

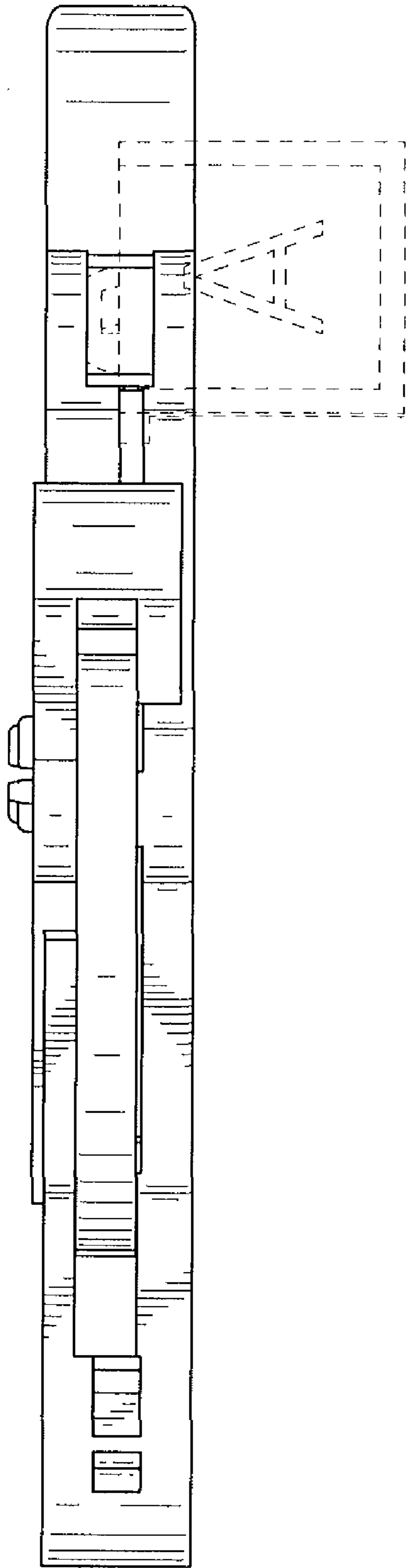

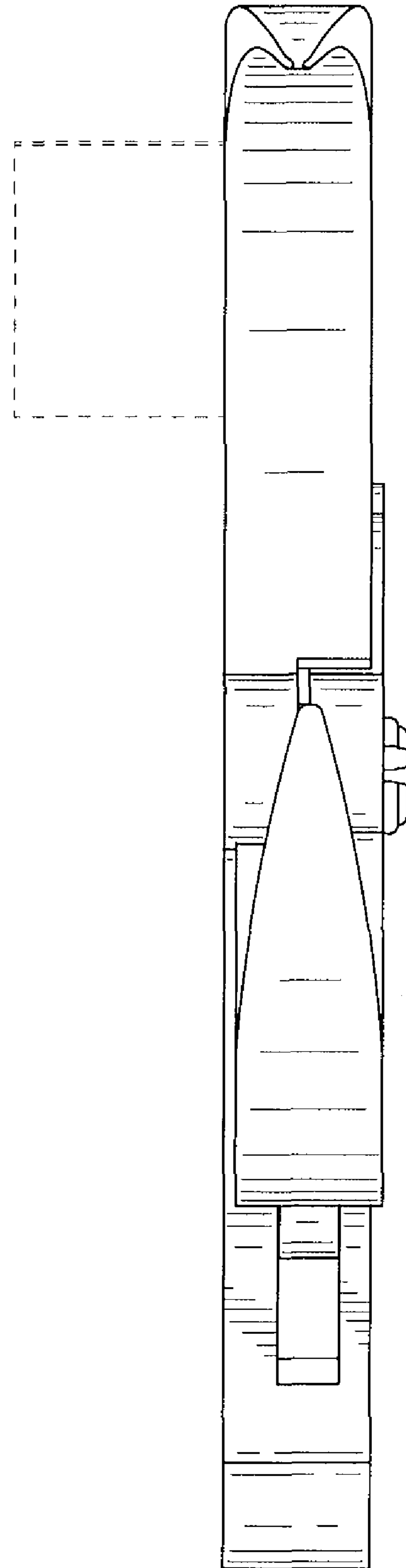

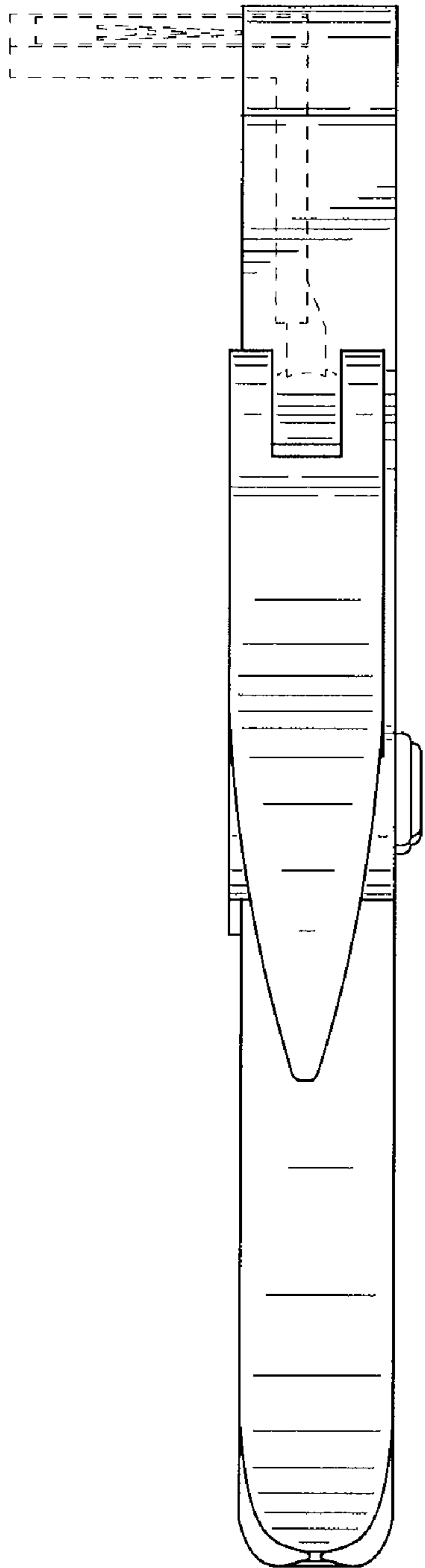

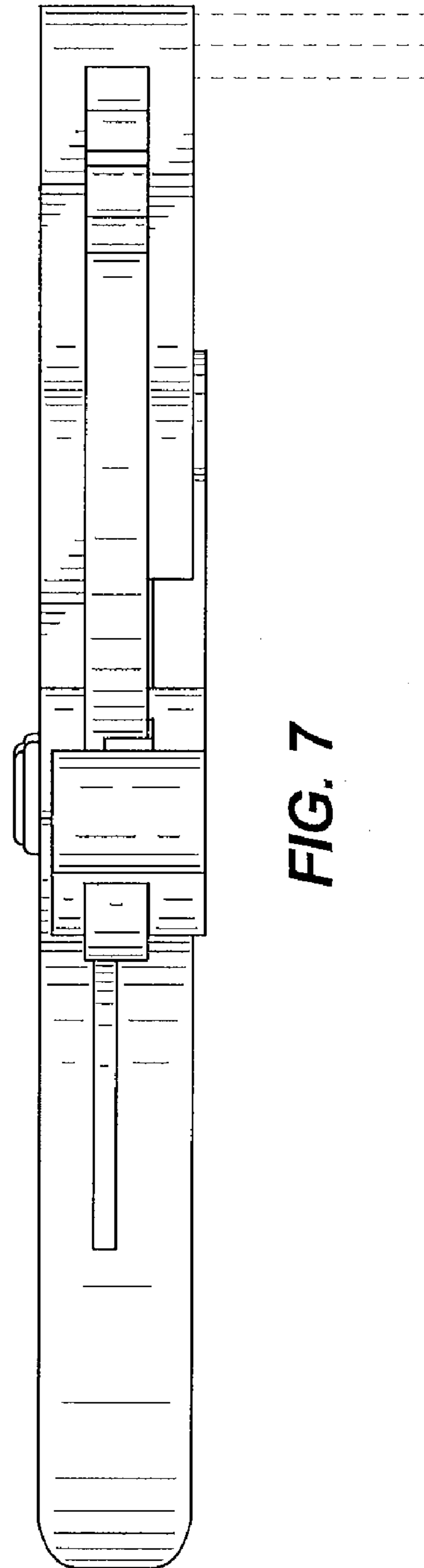
