**DESCRIPTION**

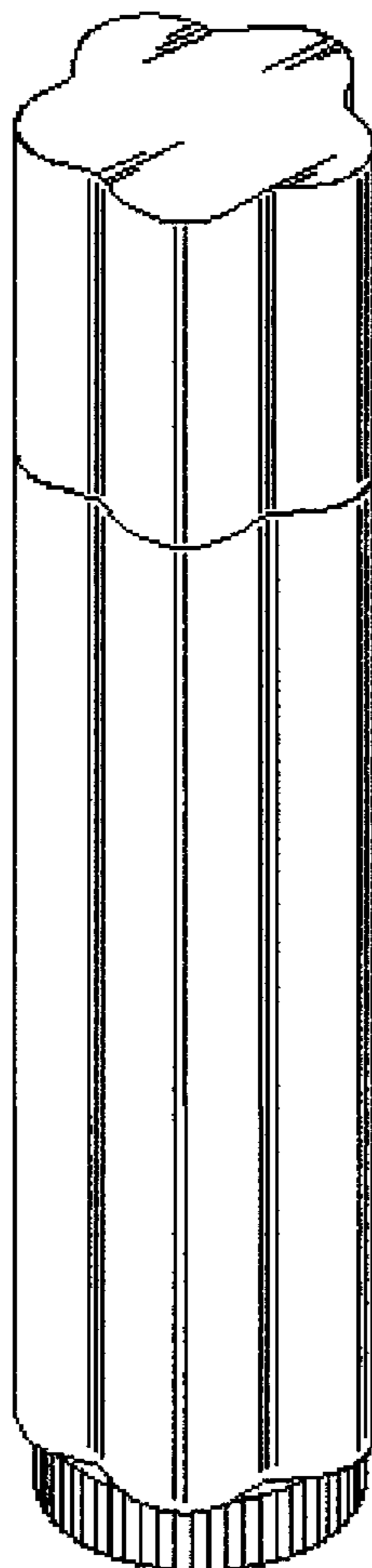
FIG. 1 is a perspective view of a lip balm showing my new design;

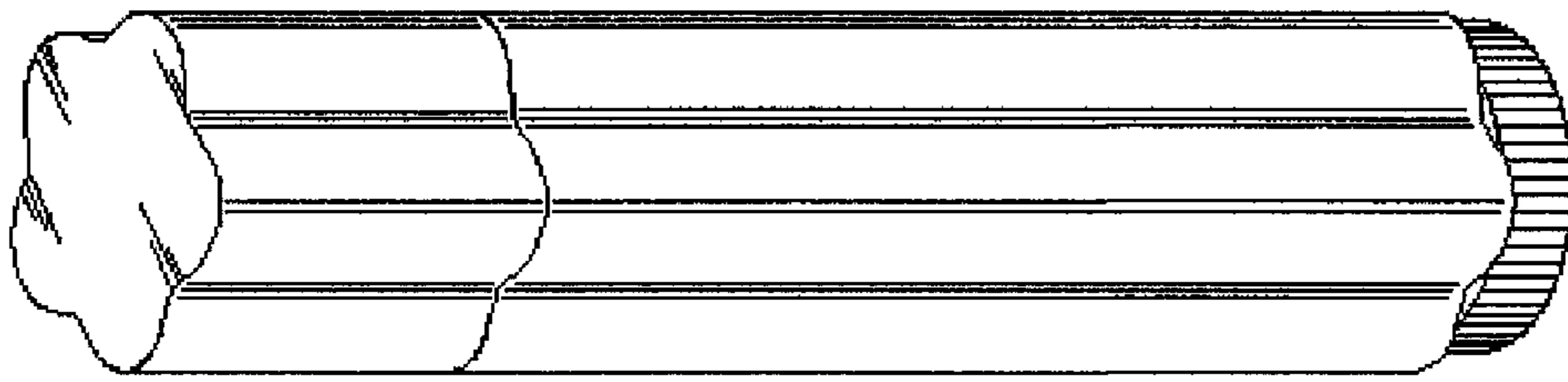

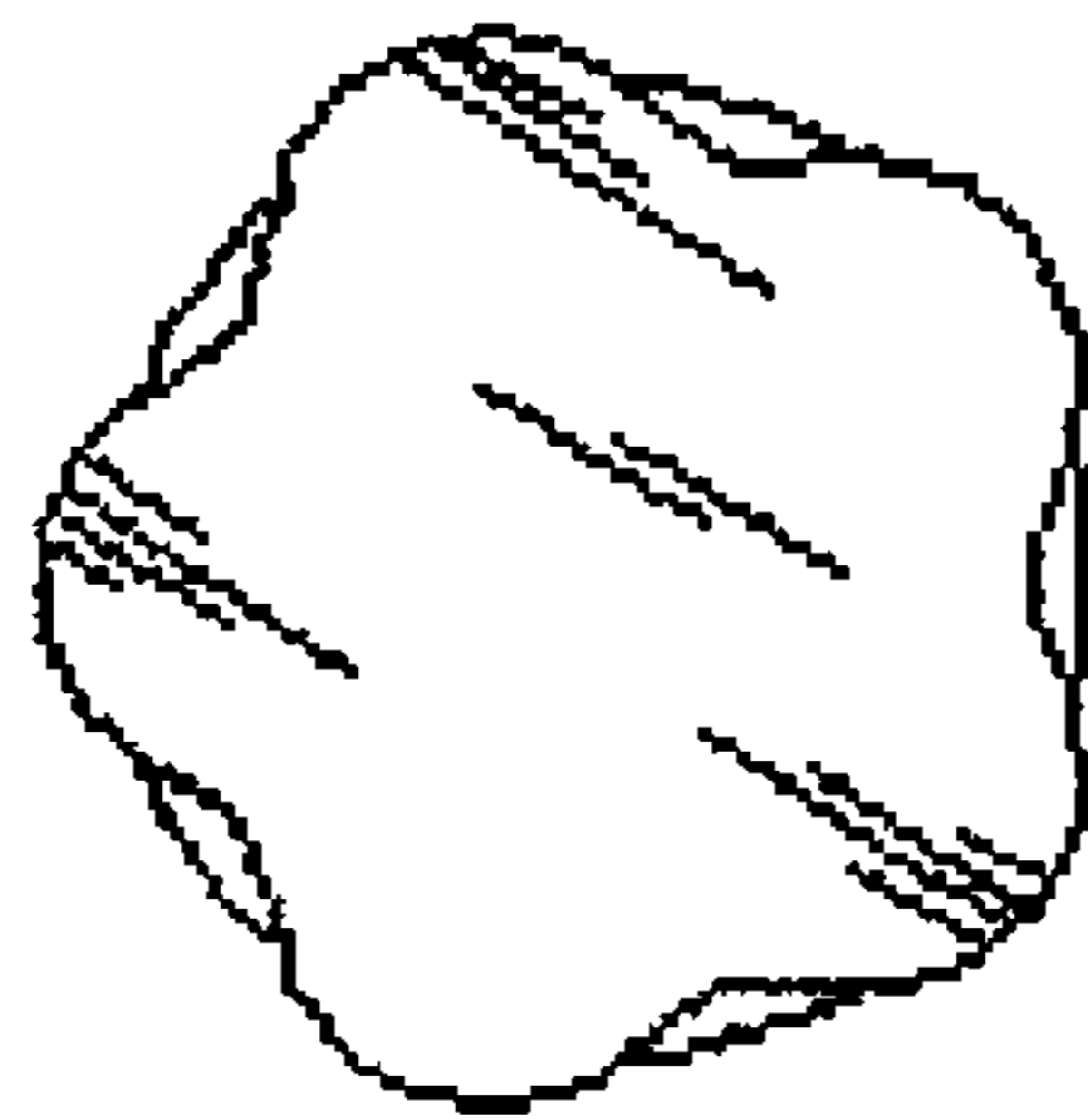

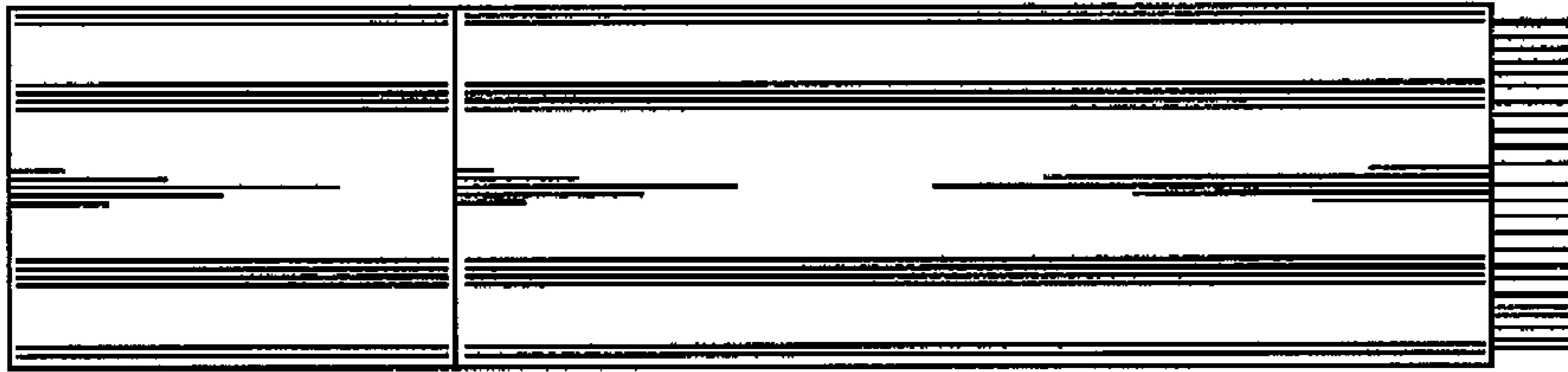

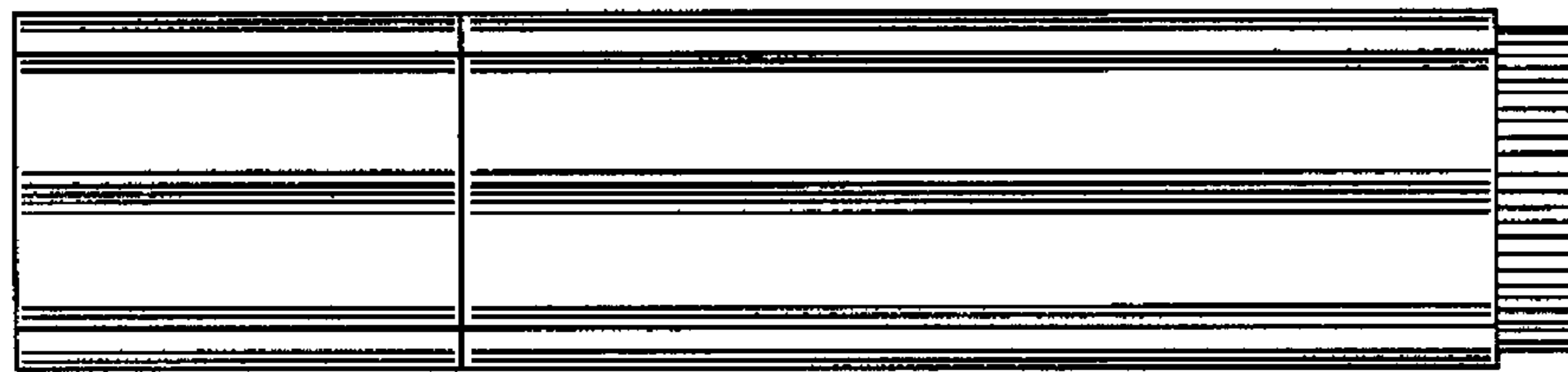

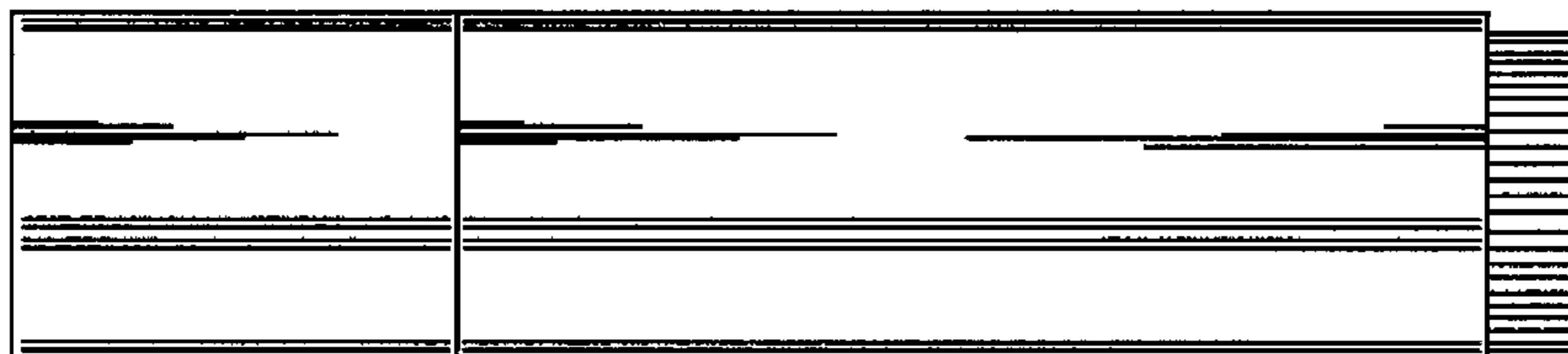

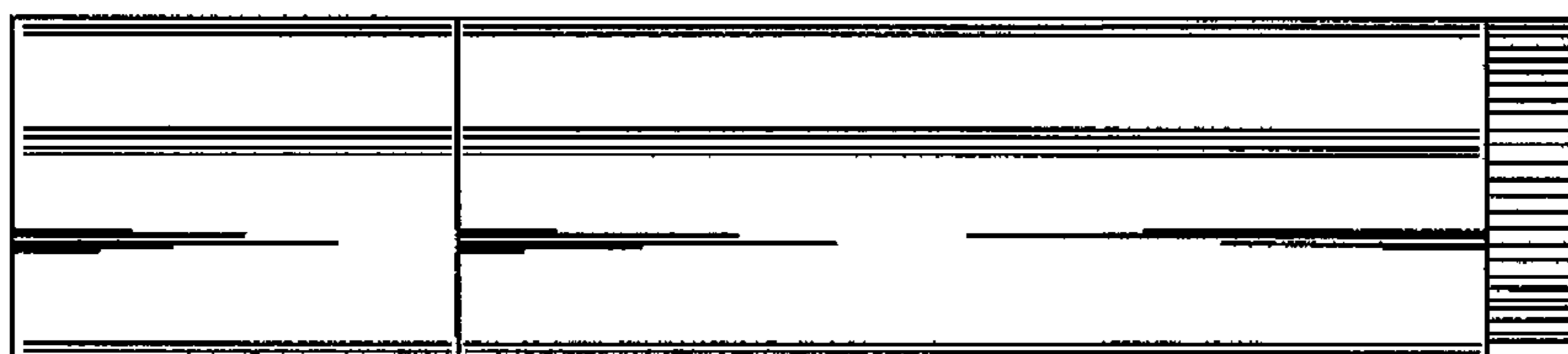
