(57) **CLAIM**

The ornamental design for a pet crate cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pet crate cover showing my design, the pet crate cover shown associated with a pet crate;

FIG. 2 is a perspective view thereof shown without the pet crate;

FIG. 3 is a right side view thereof, the opposite side being a mirage image thereof;

FIG. 4 is a rear view thereof;

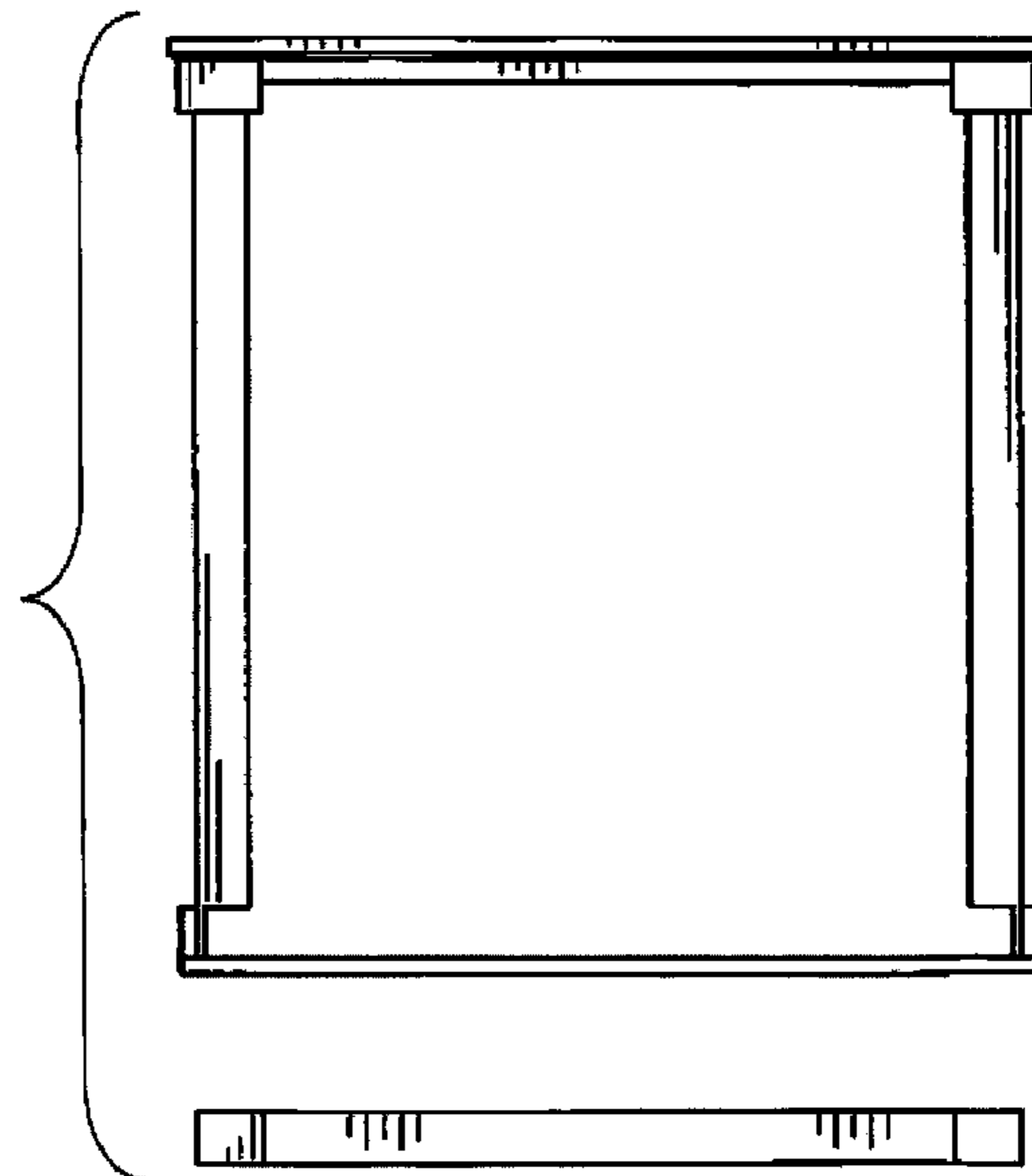
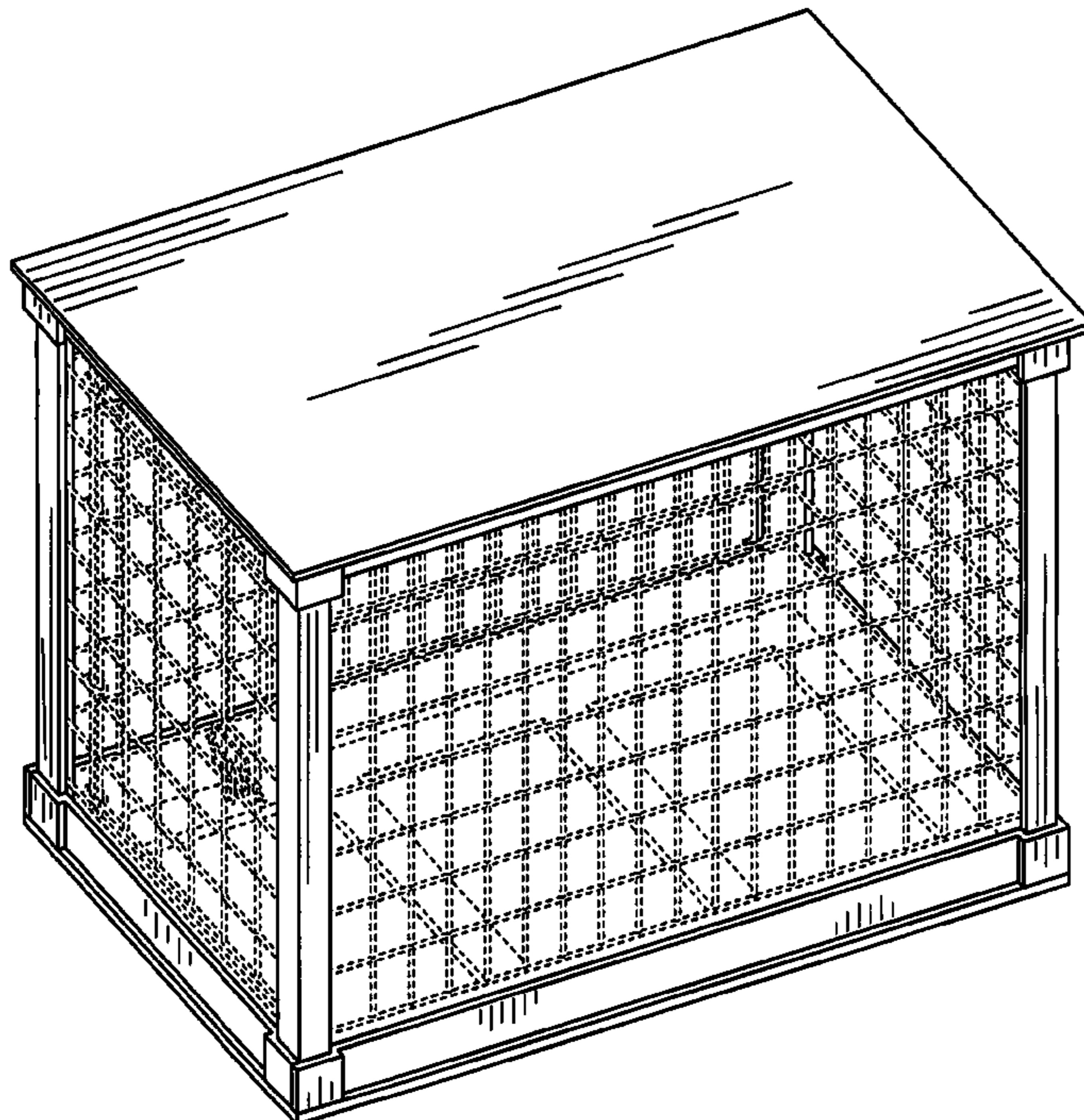
FIG. 5 is a top view thereof;

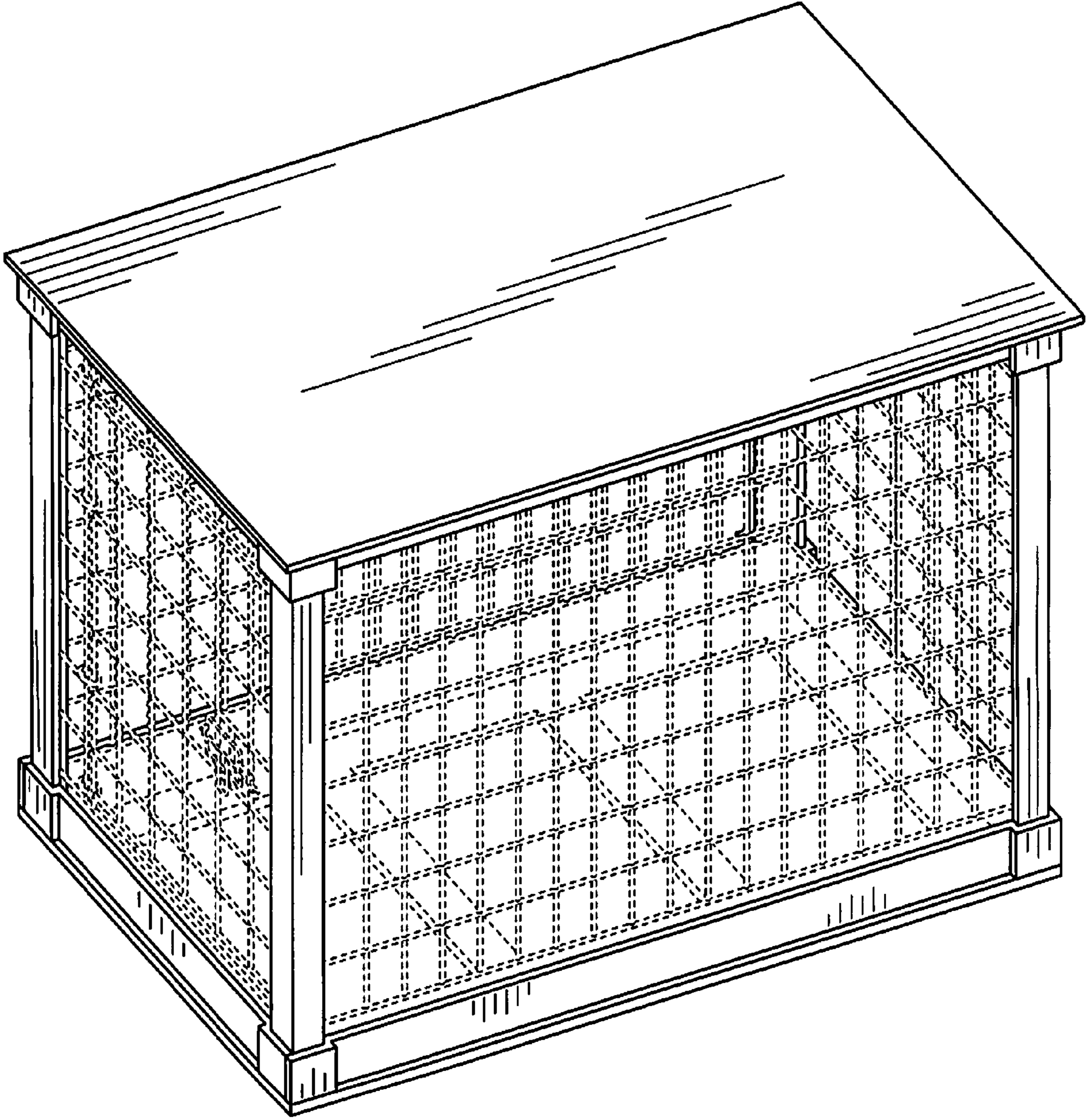

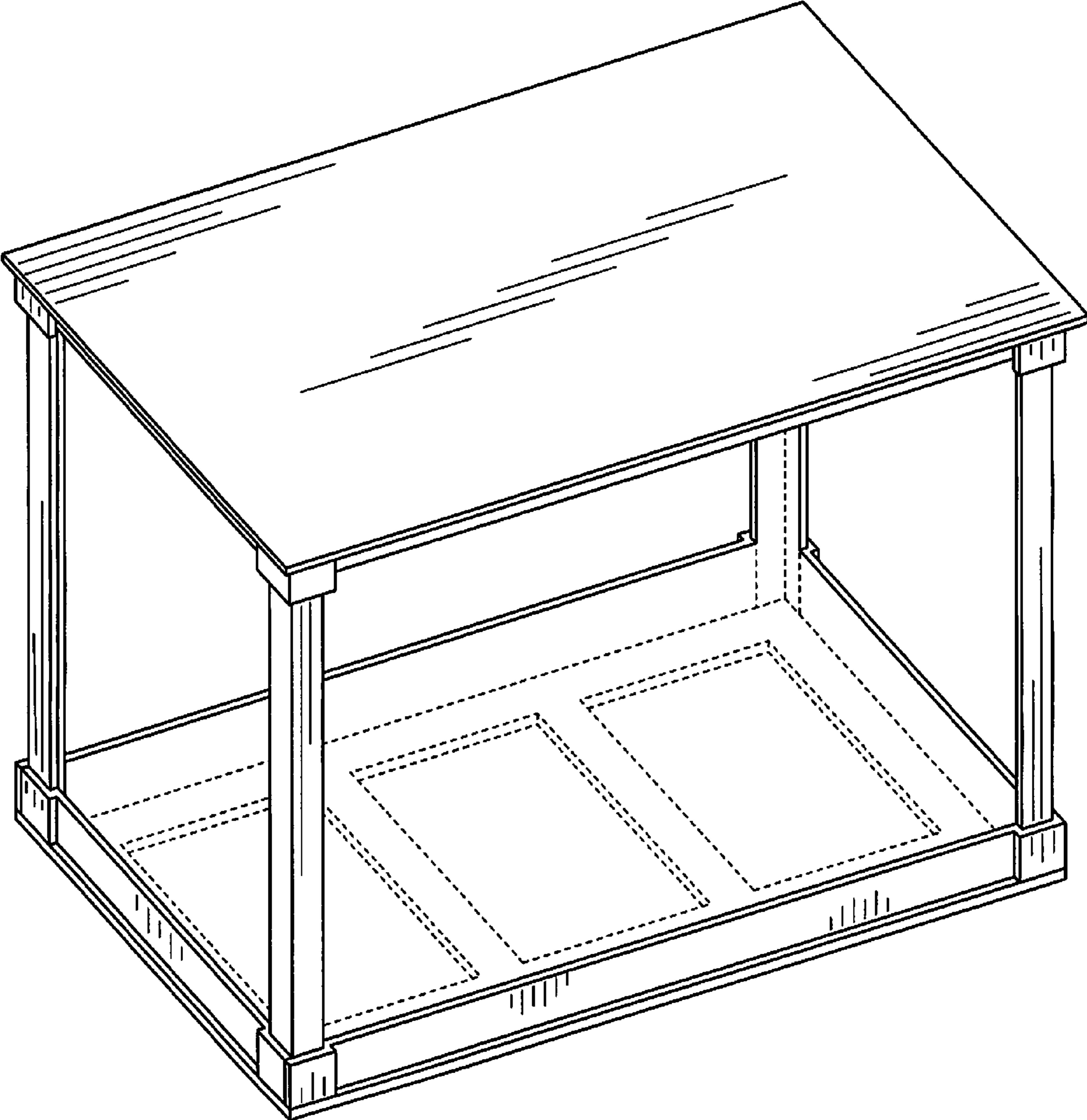

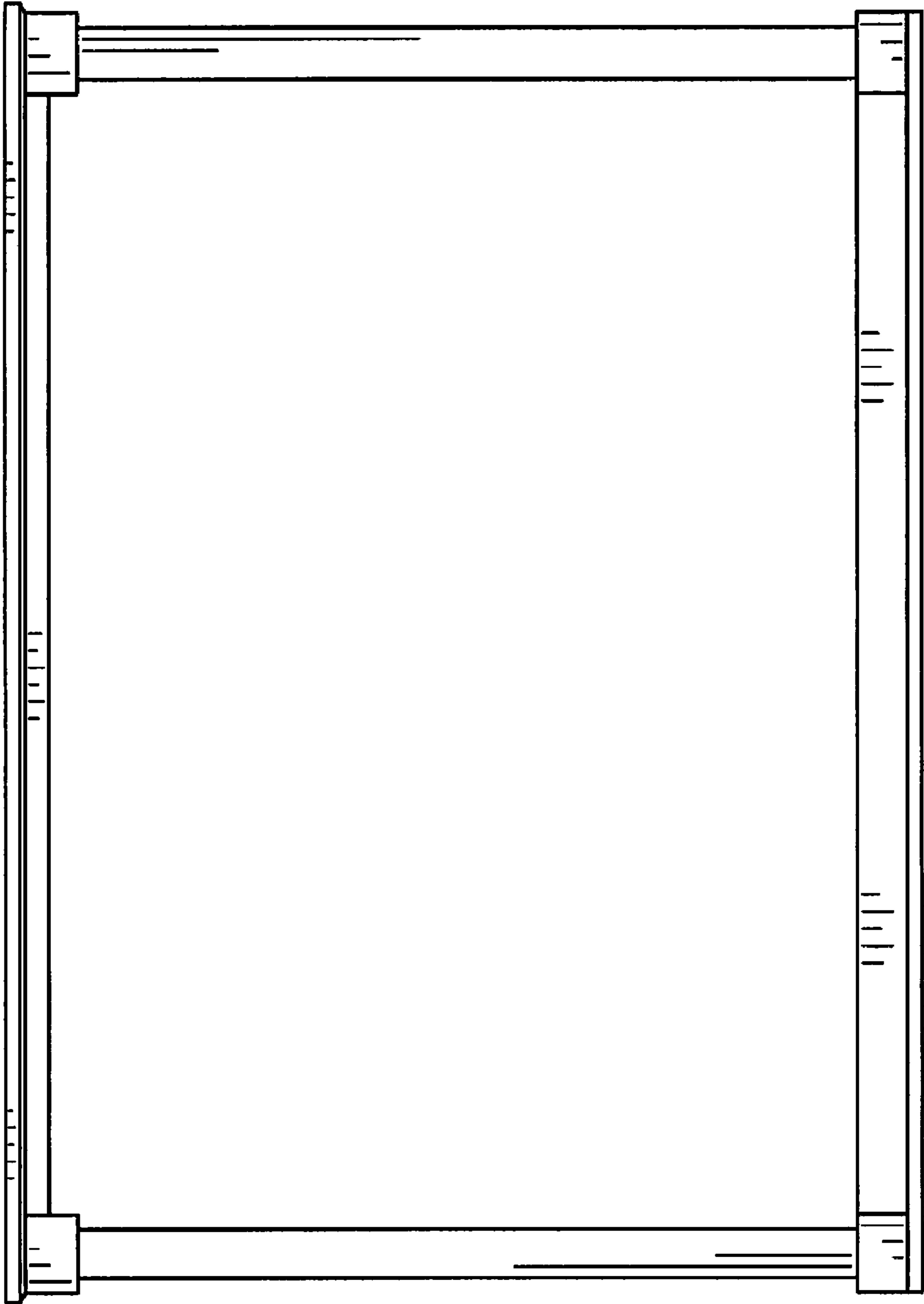

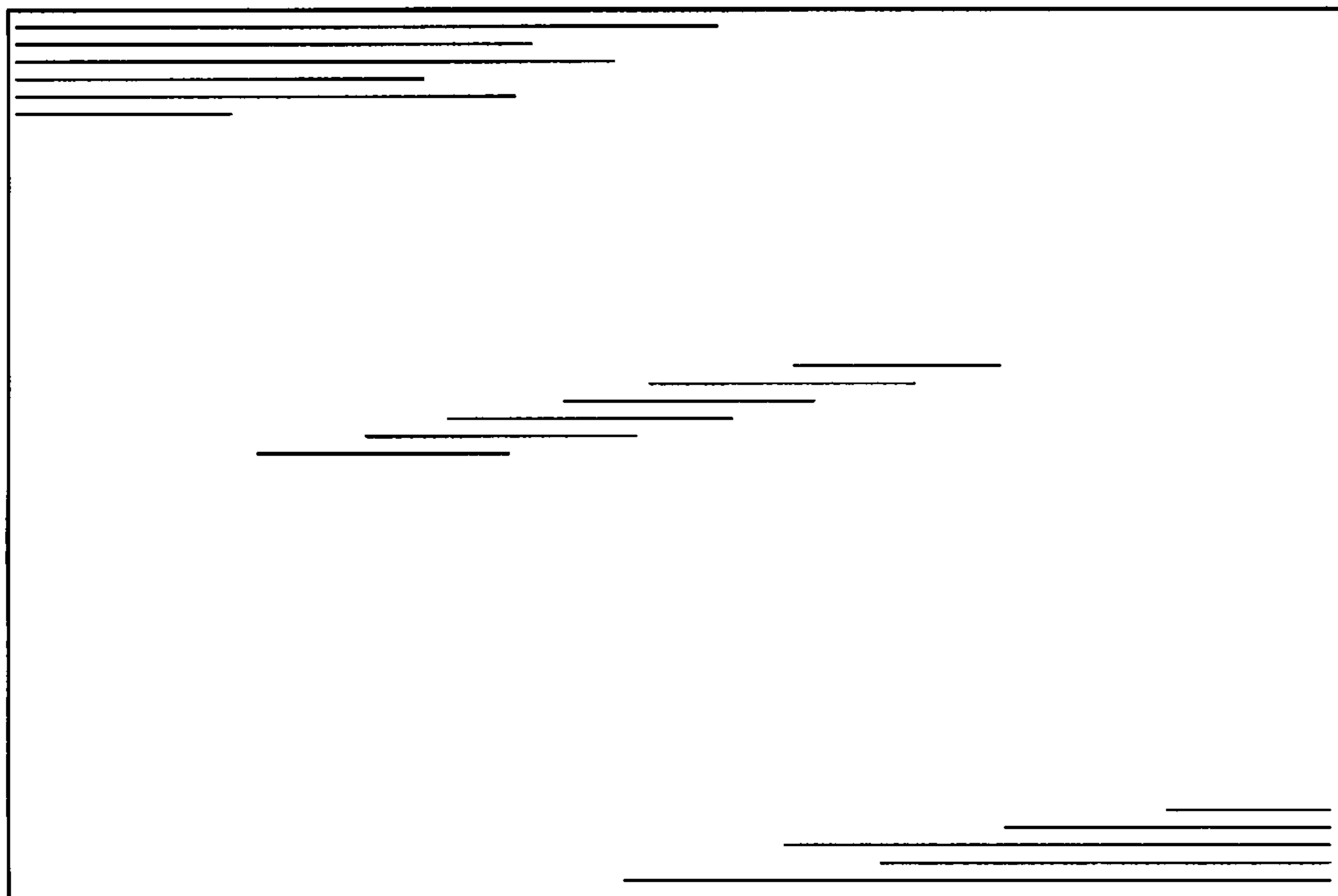

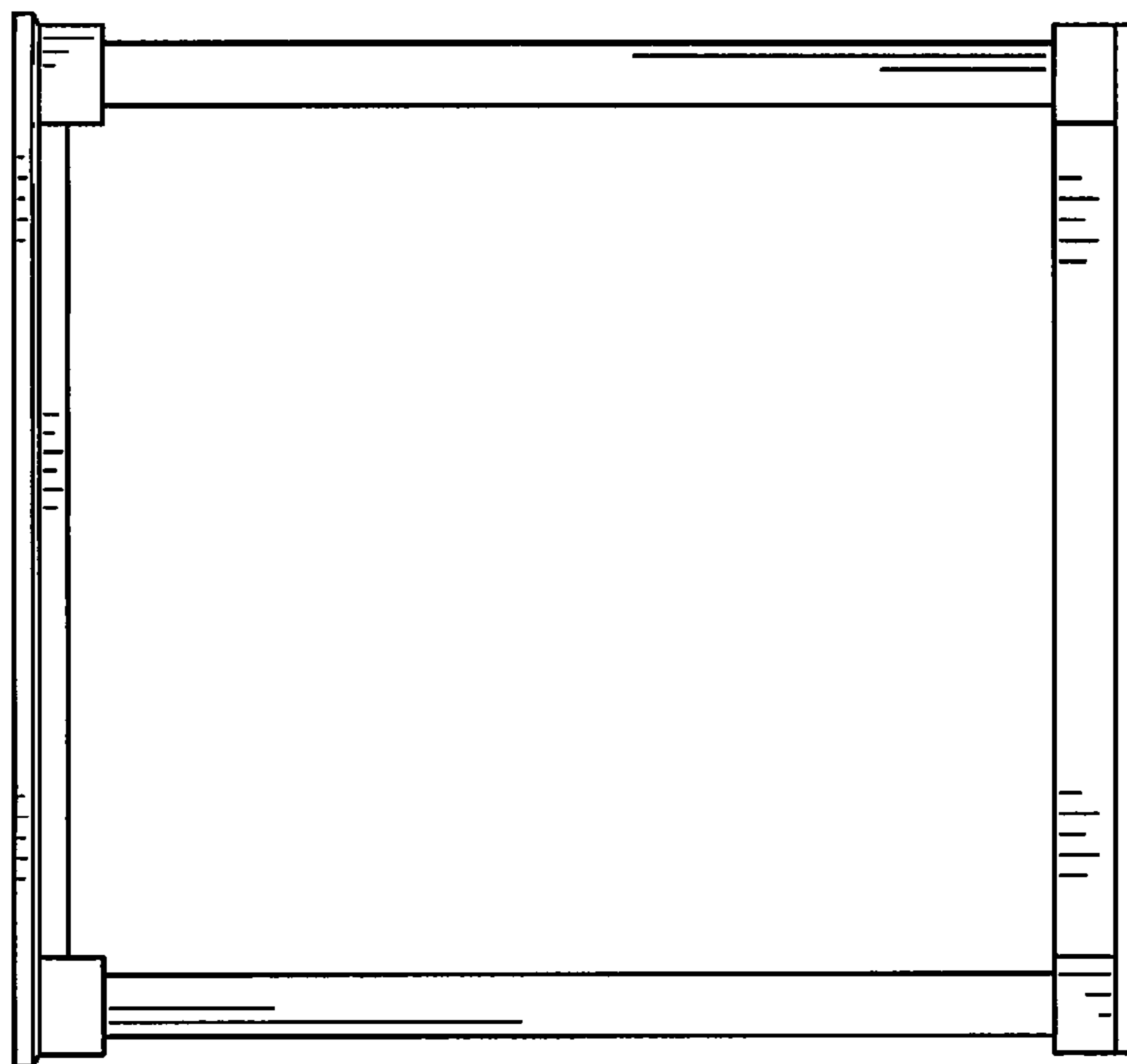

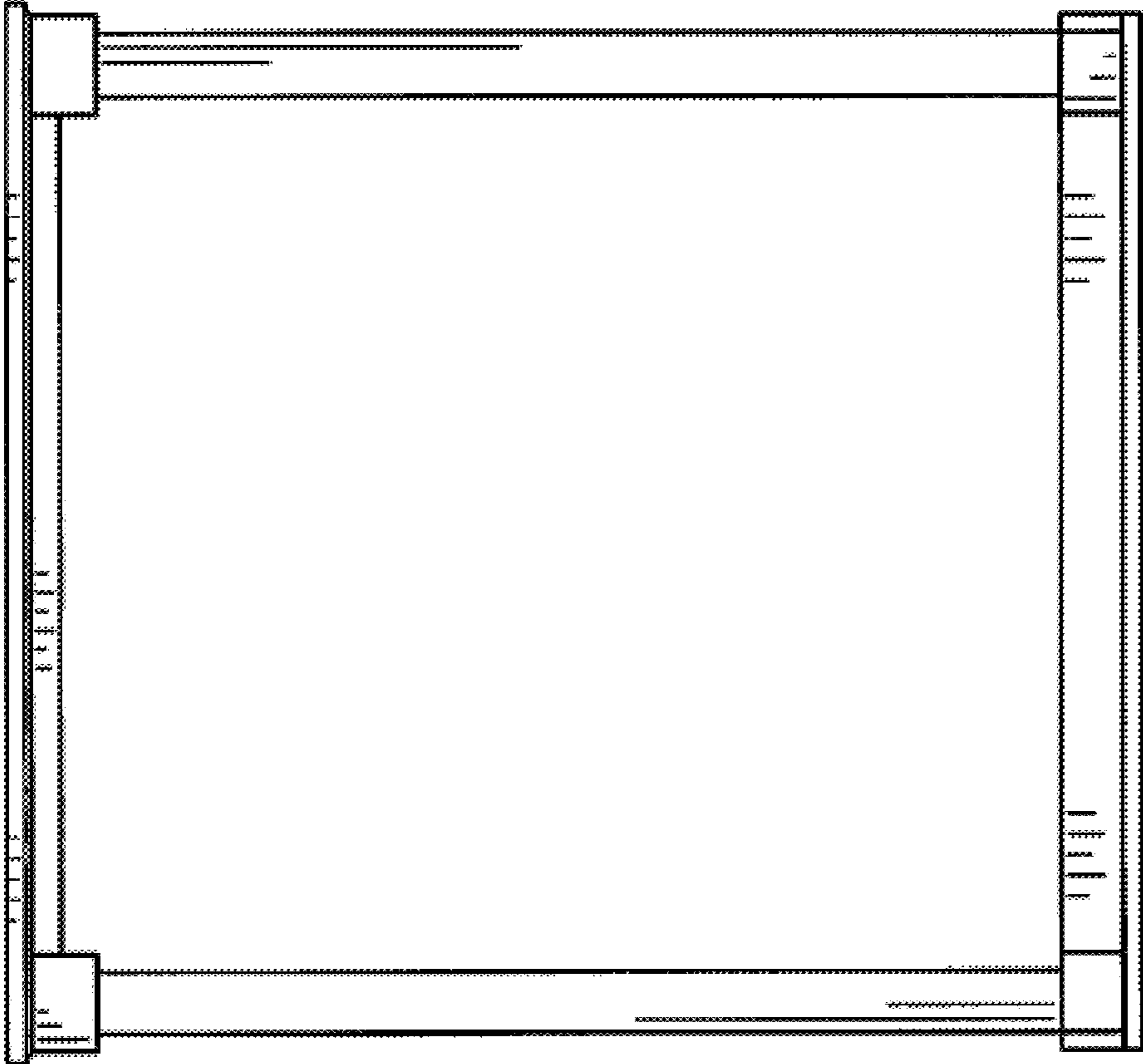

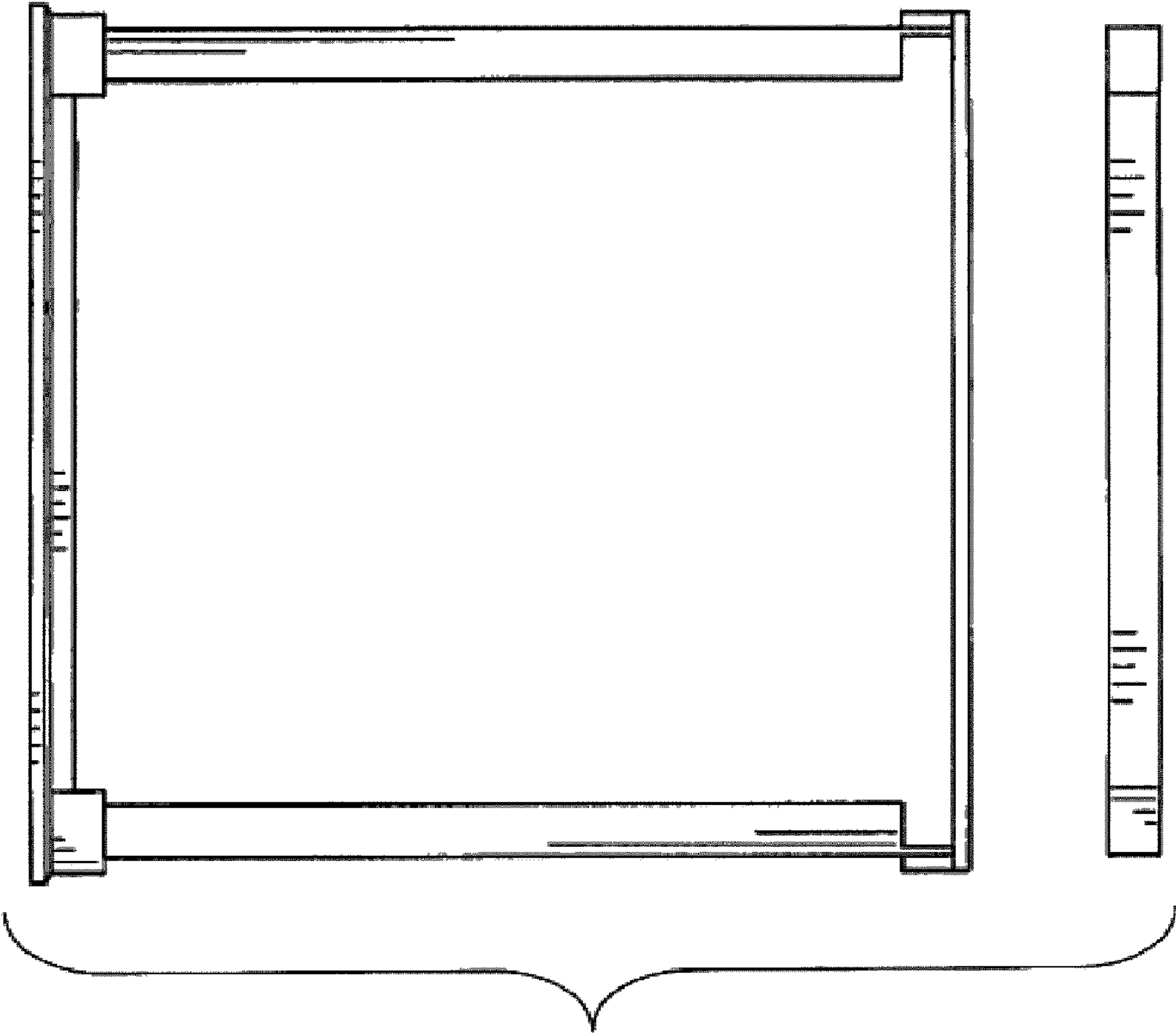
