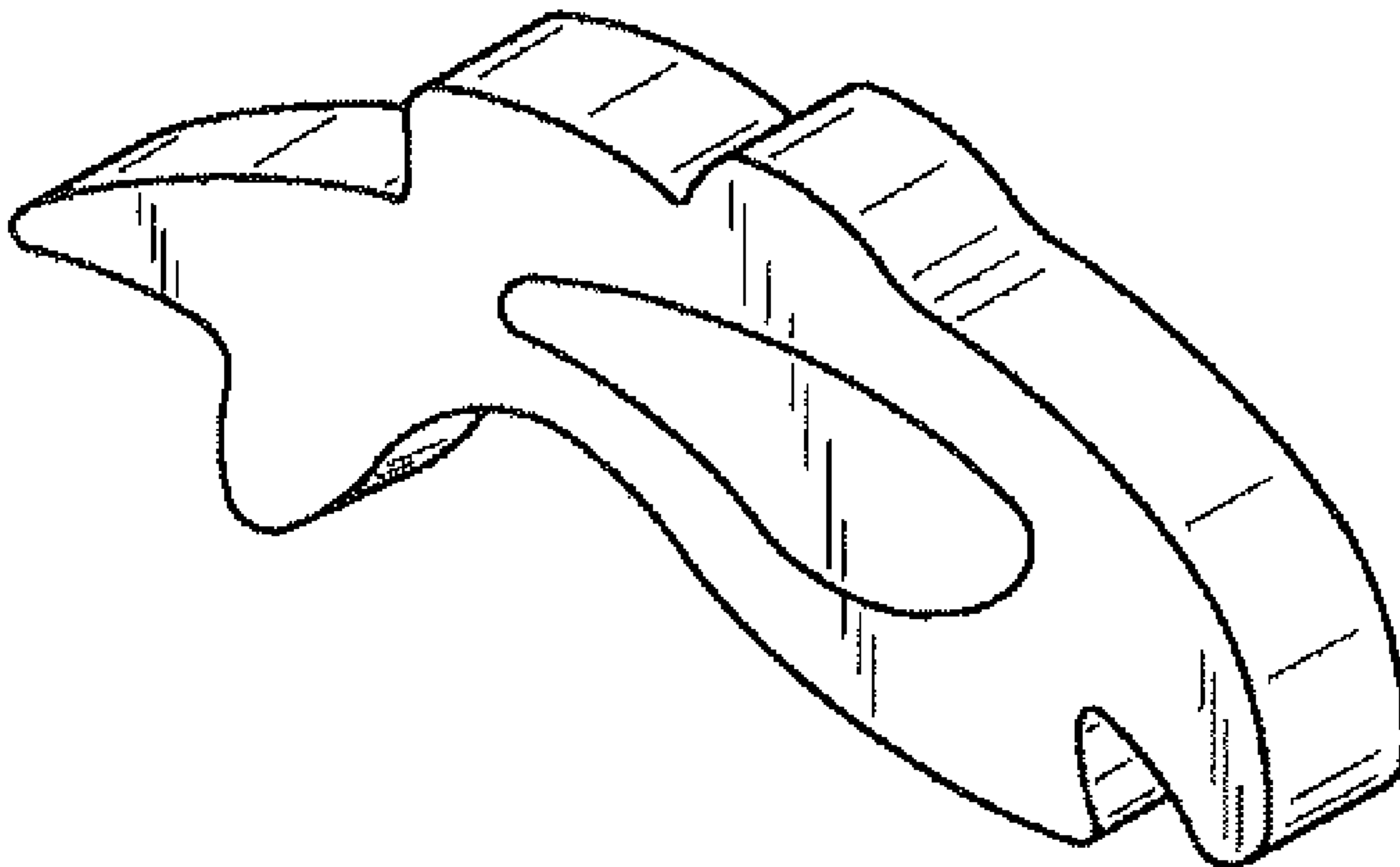

DESCRIPTION

FIG. 1 is a perspective view of a pet treat showing my new design;

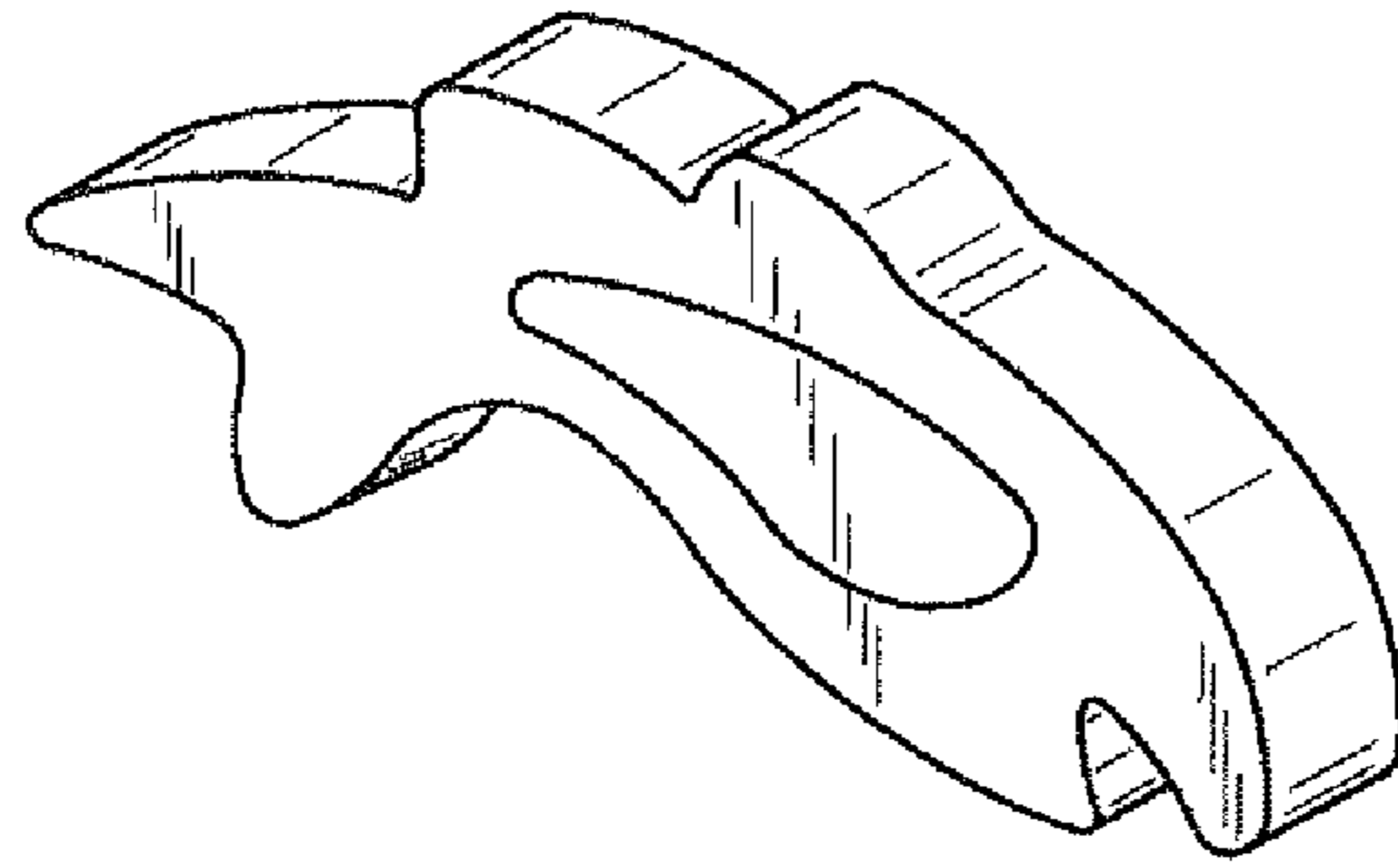

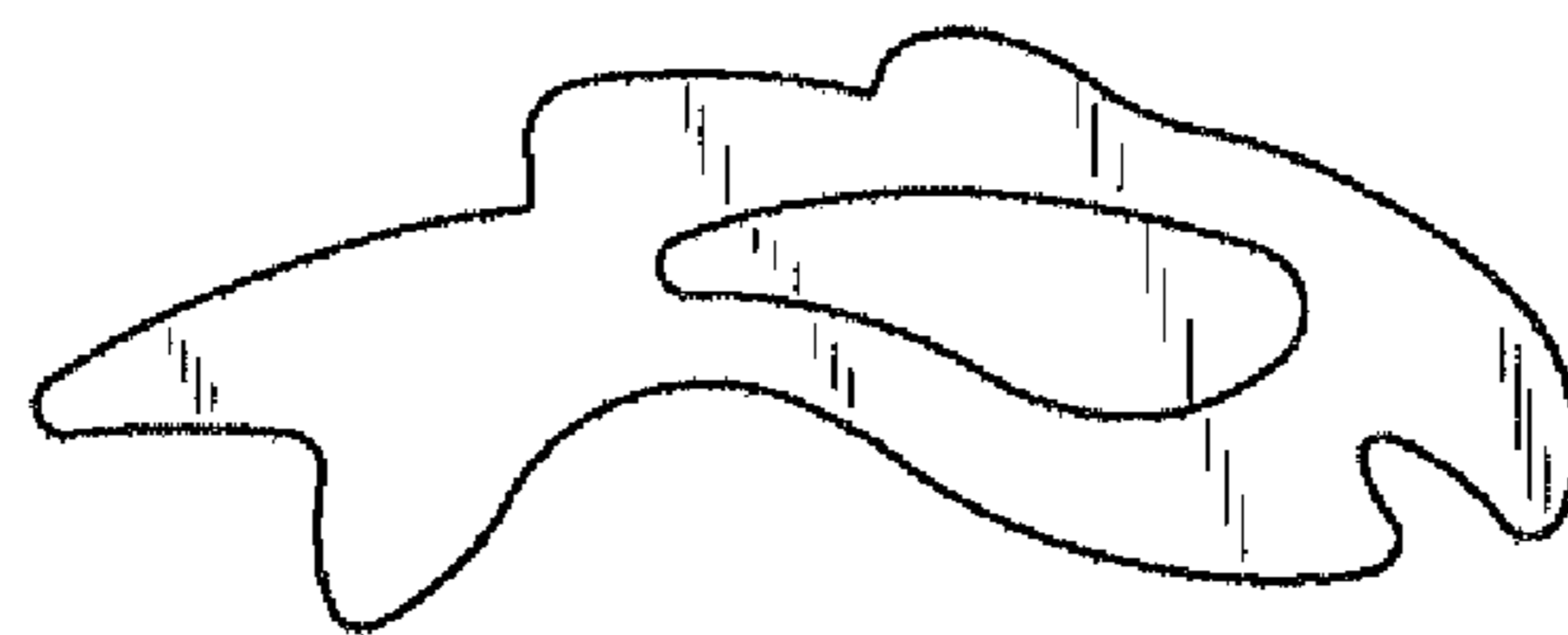

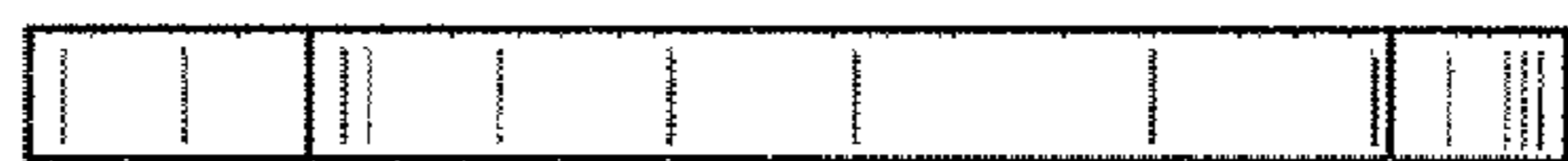

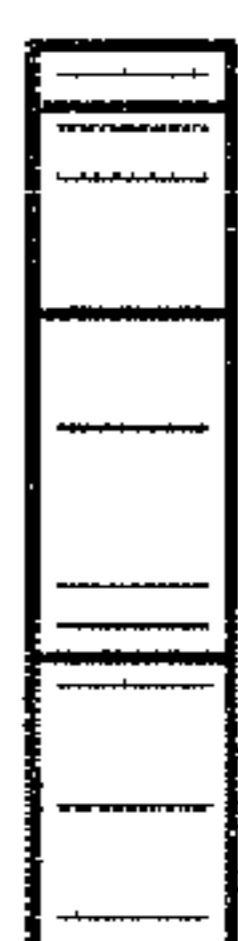

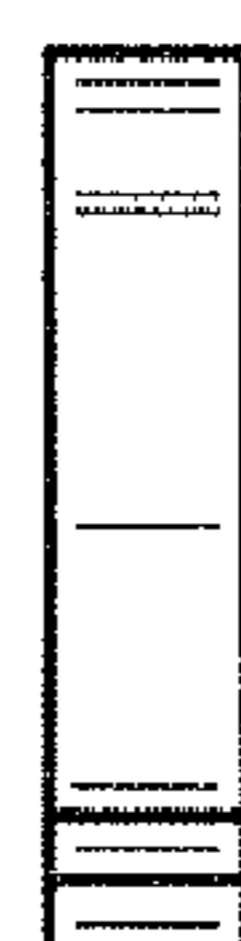
