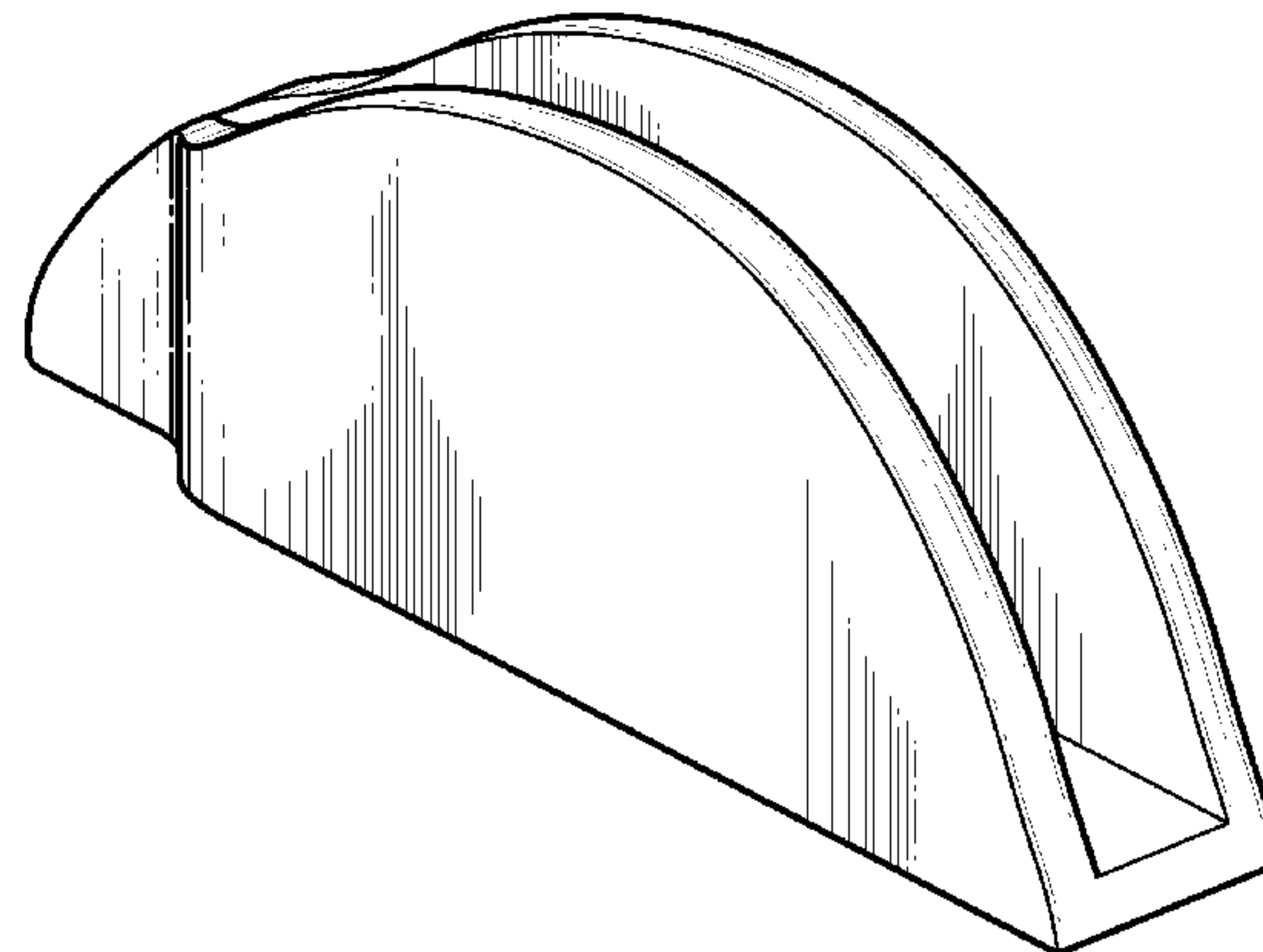
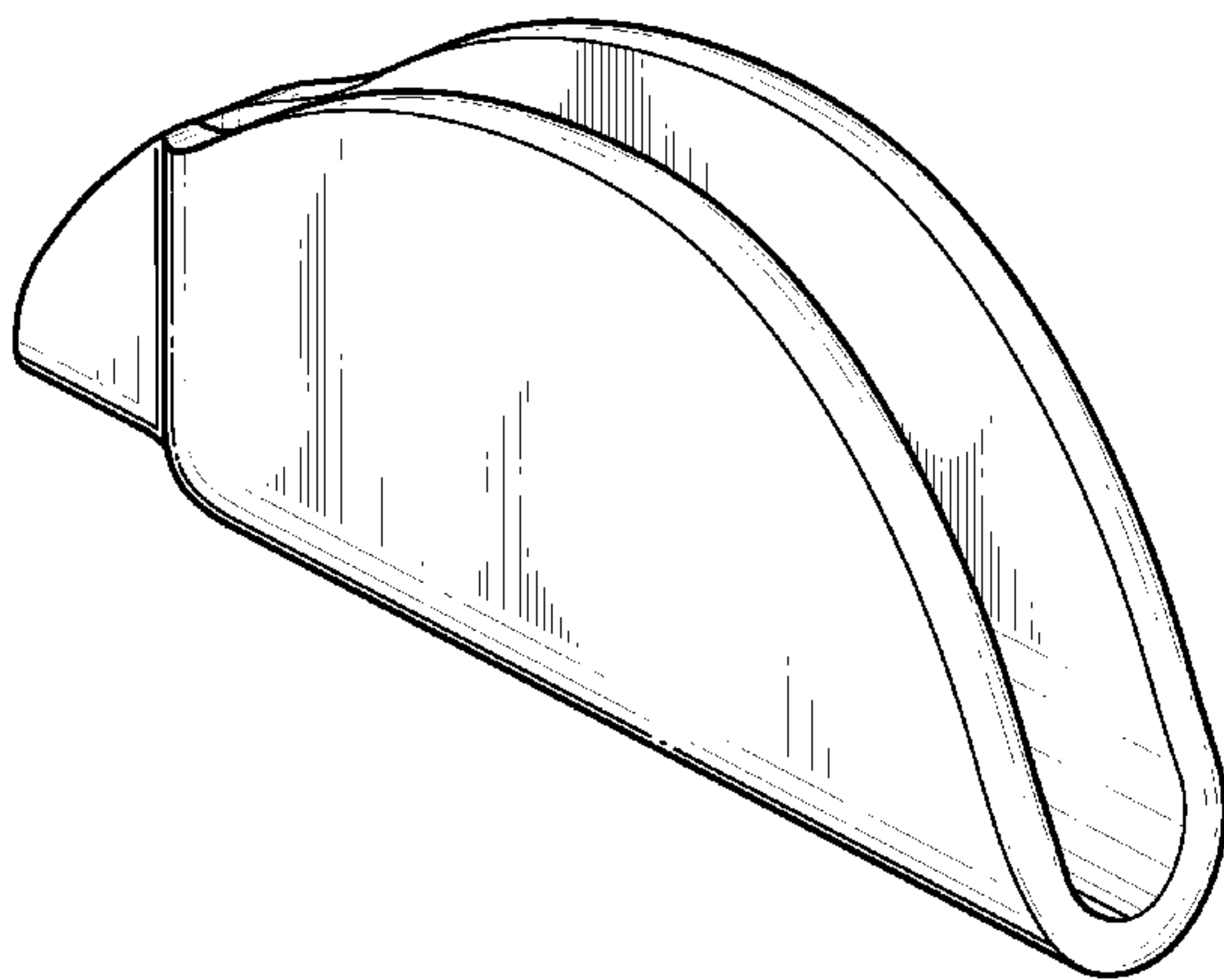
(57) **CLAIM**

The ornamental design for an edible shell for holding of comestible products, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of design for an edible shell for holding of comestible products, showing my new design; FIG. 2 is a side elevational view thereof; FIG. 3 is a top view of the edible shell; FIG. 4 is a bottom view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a perspective view of a second embodiment of my design for an edible shell. FIG. 8 is a side elevational view of the edible shell shown in FIG. 7; FIG. 9 is a top view of the edible shell shown in FIG. 7; FIG. 10 is a bottom view of the edible shell shown in FIG. 7; FIG. 11 is a front elevational view of the edible shell shown in FIG. 7; and, FIG. 12 is a rear elevational view of the edible shell shown in FIG. 7.

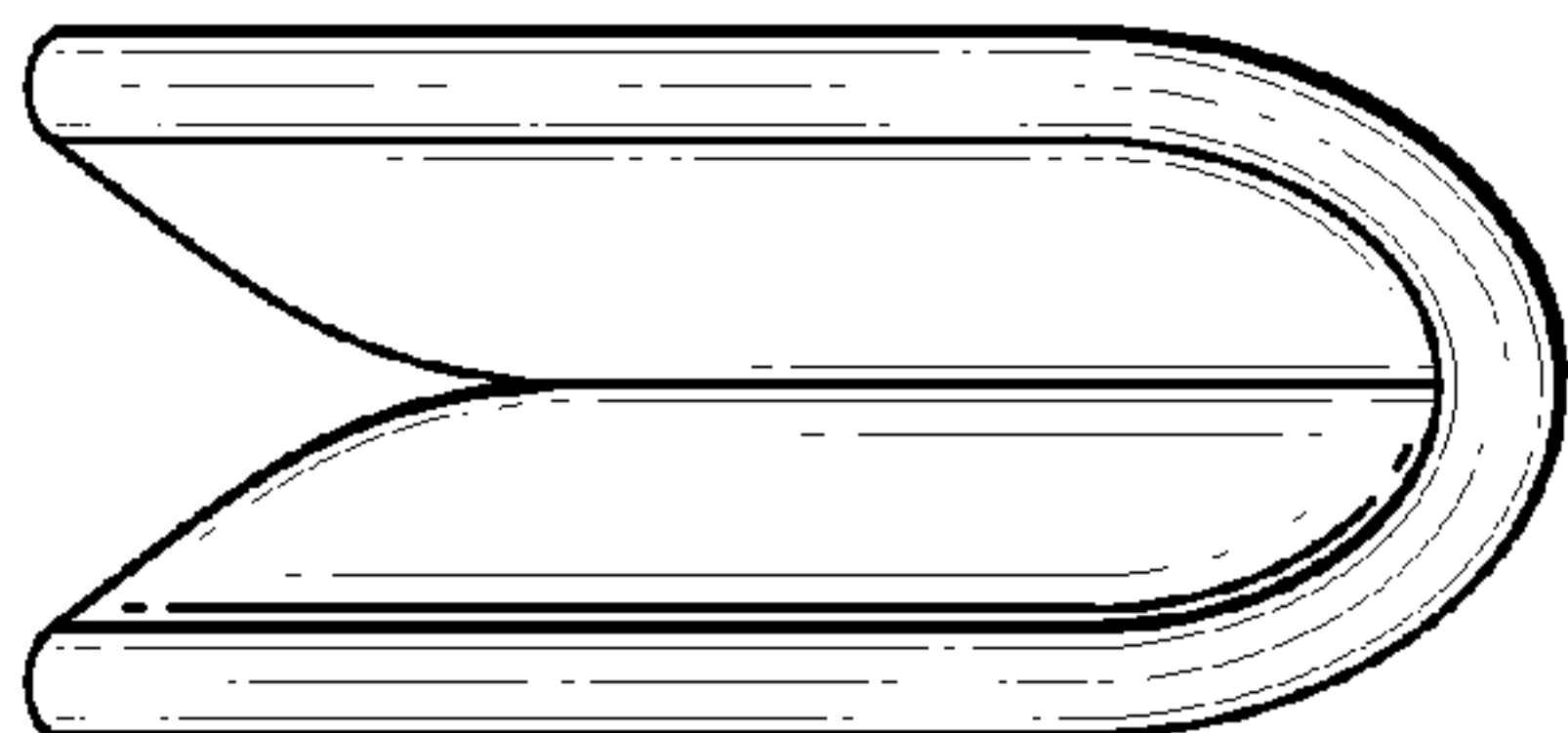

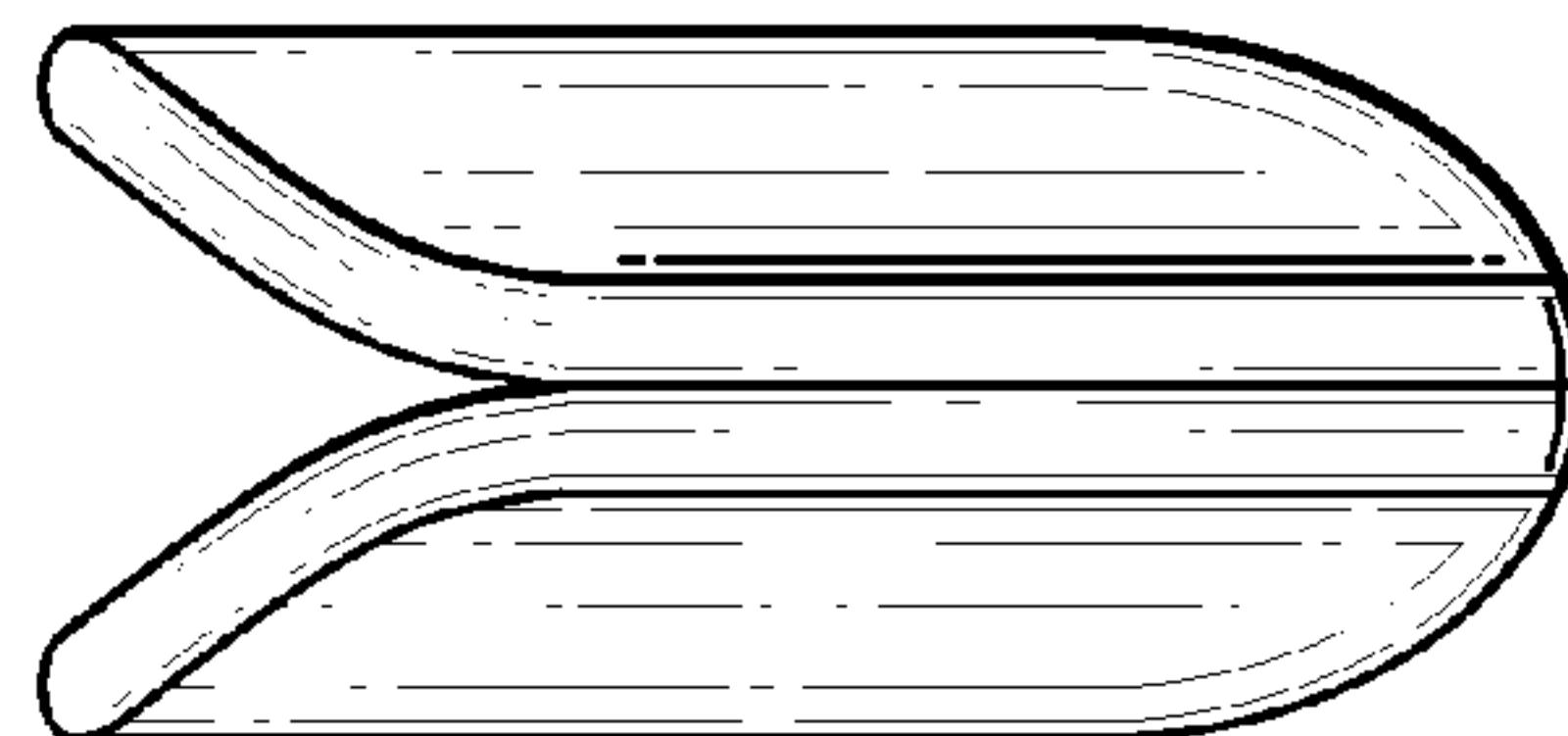

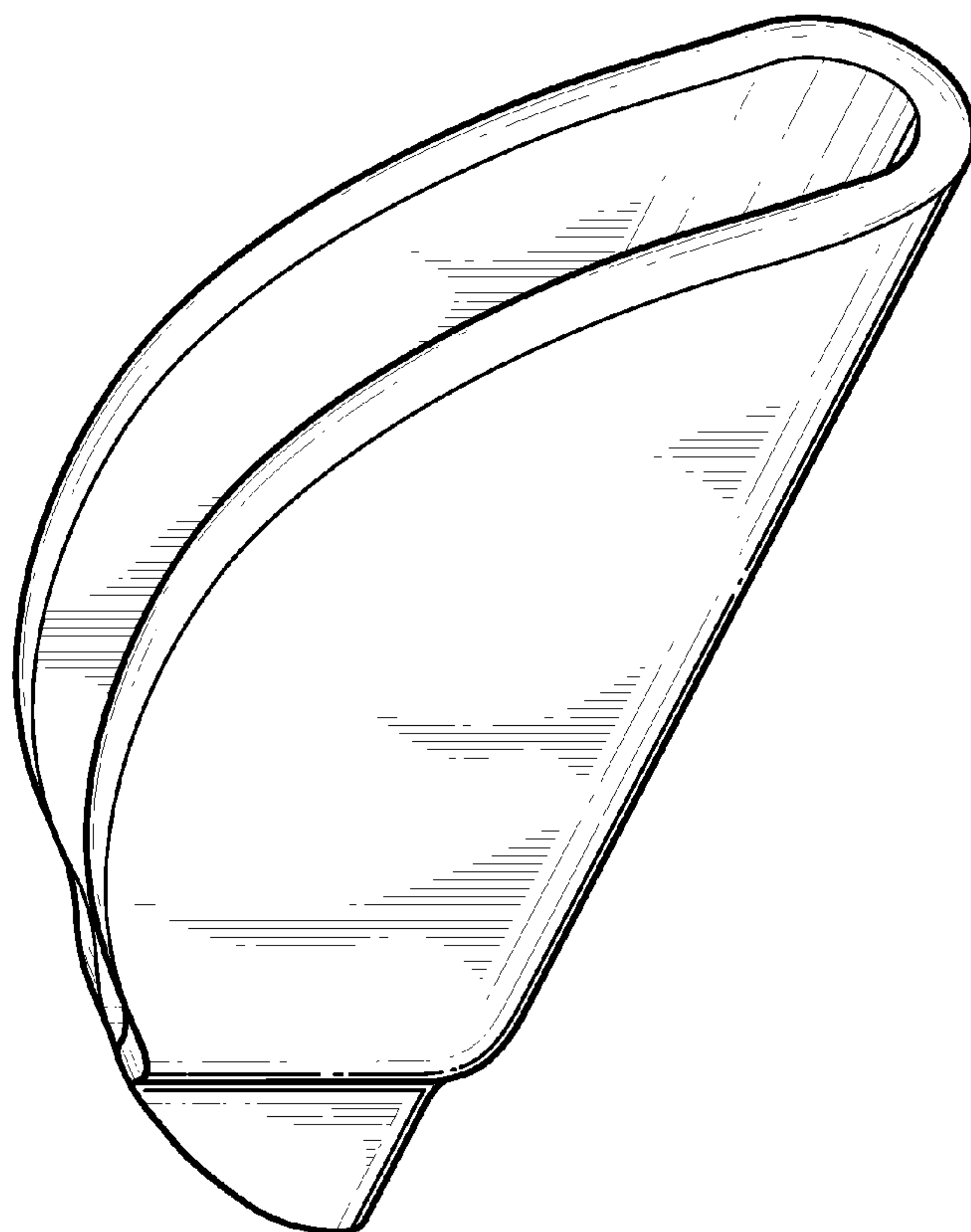

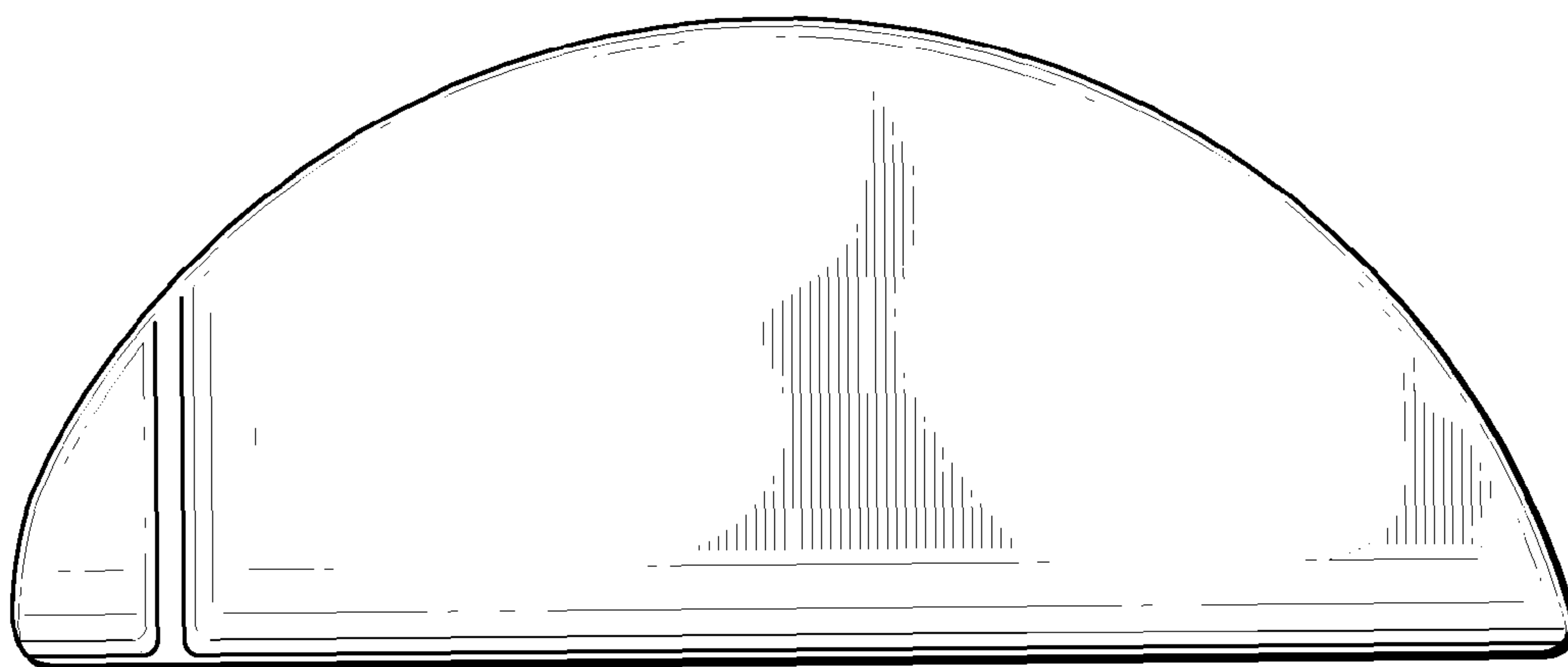

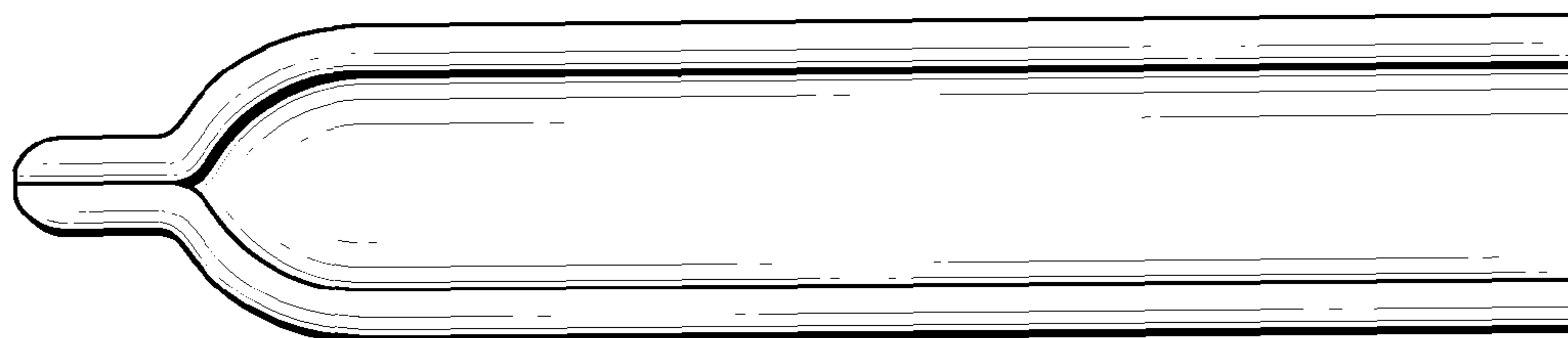

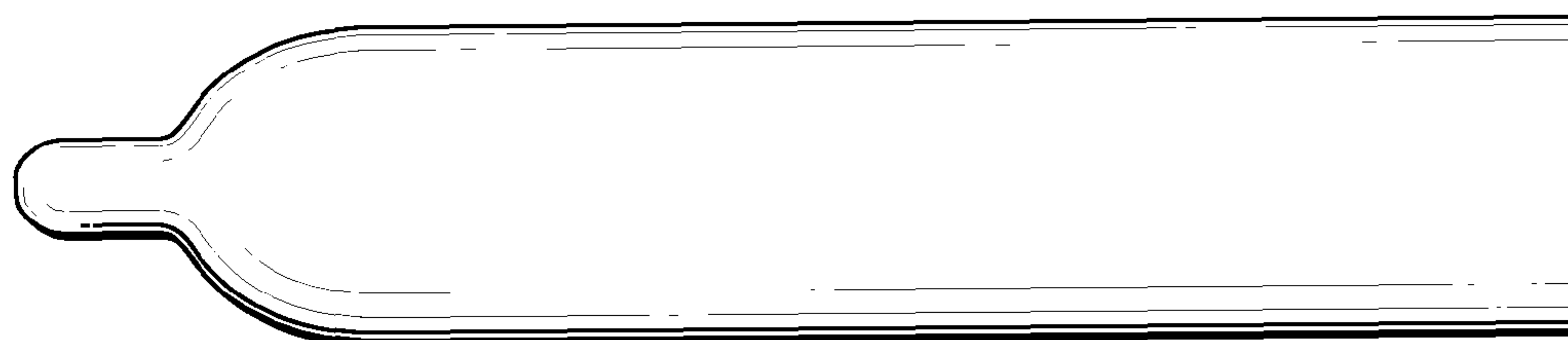

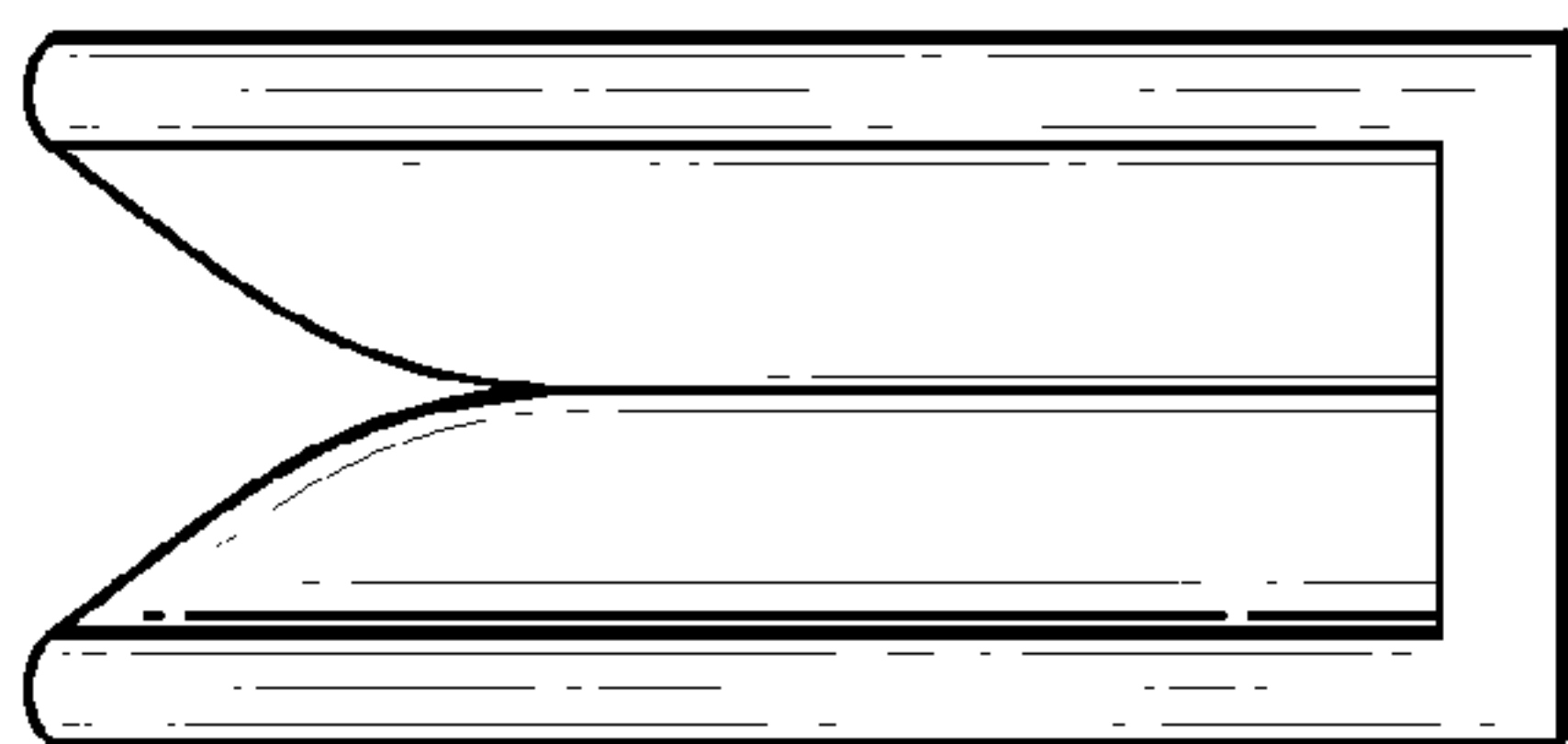

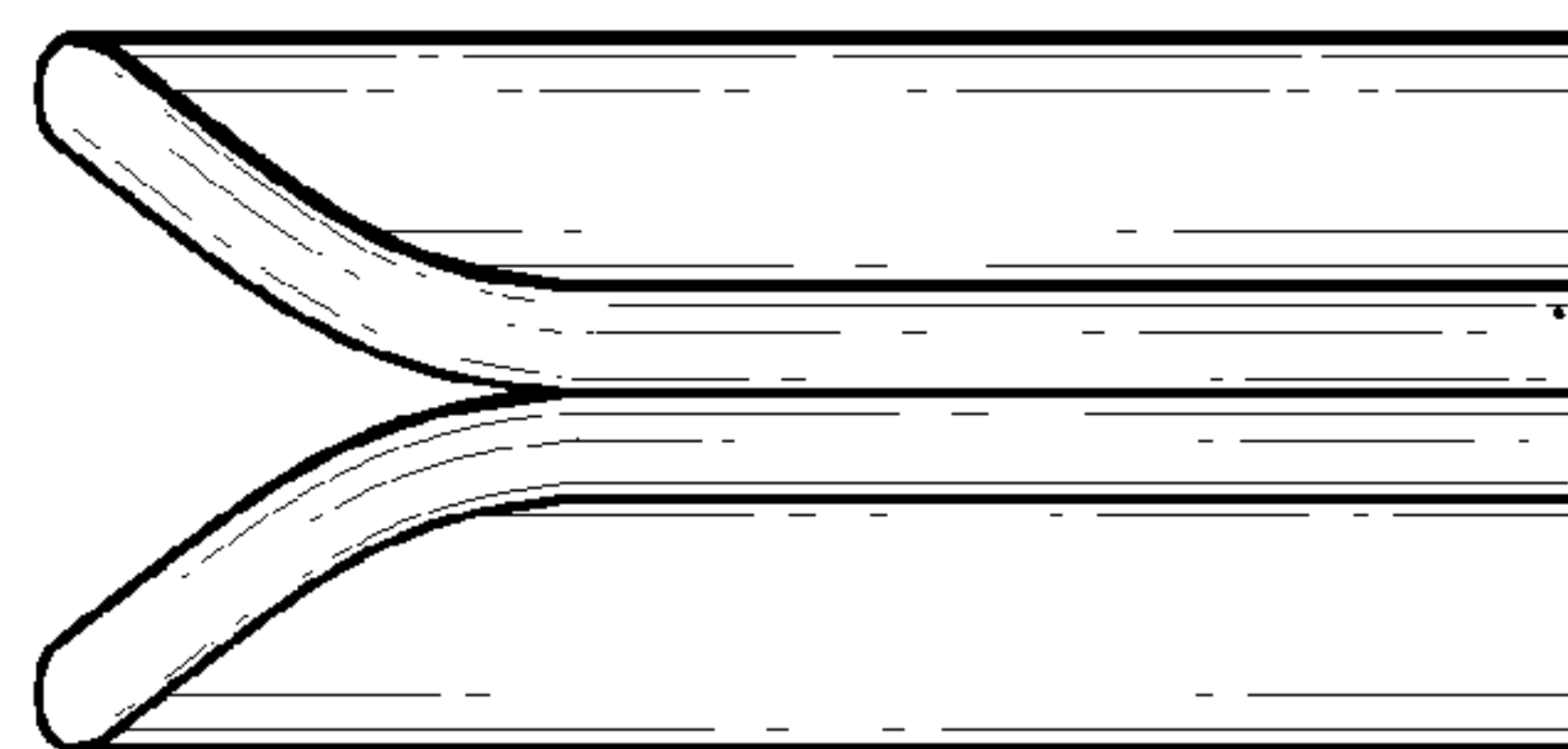

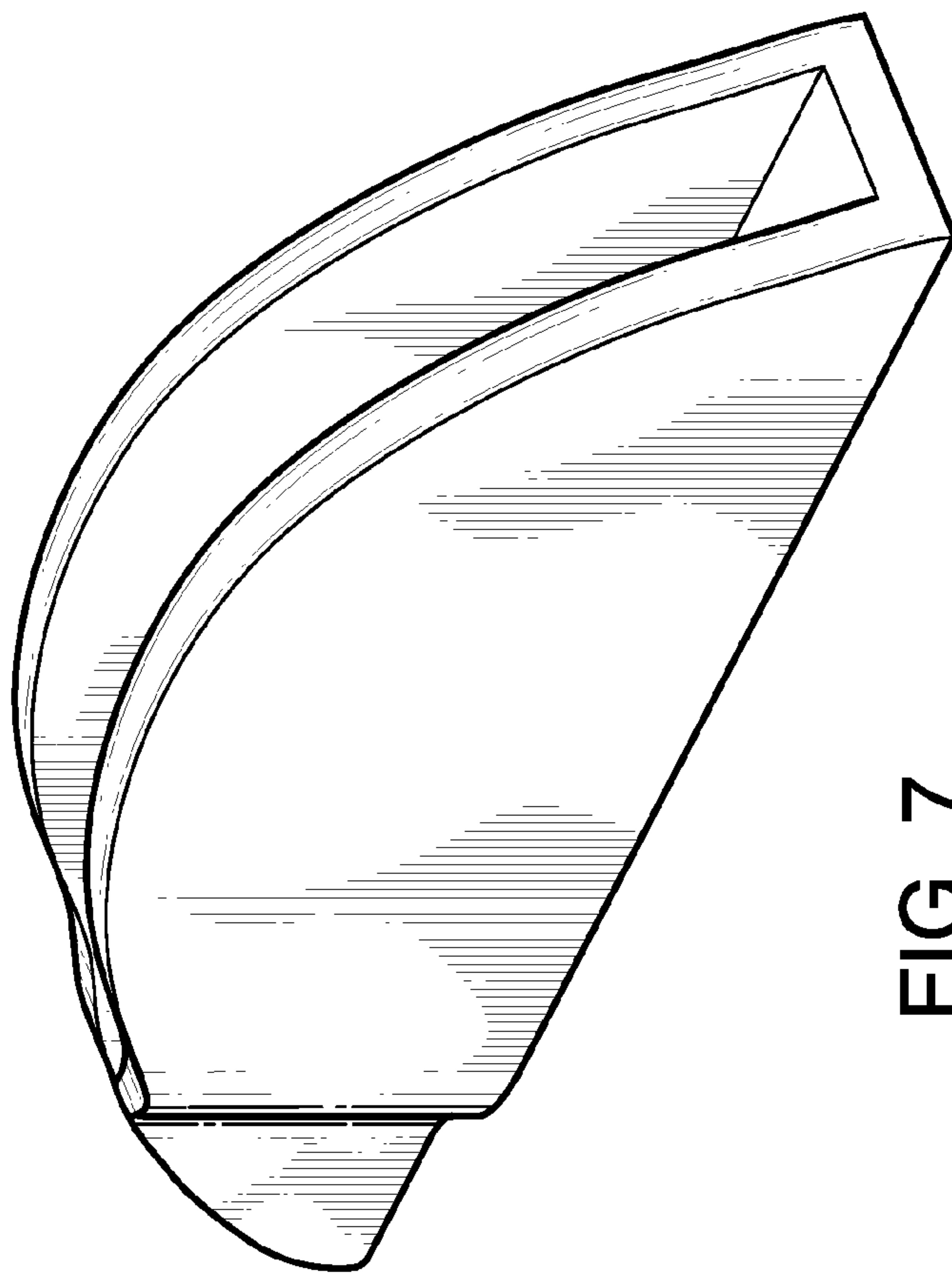

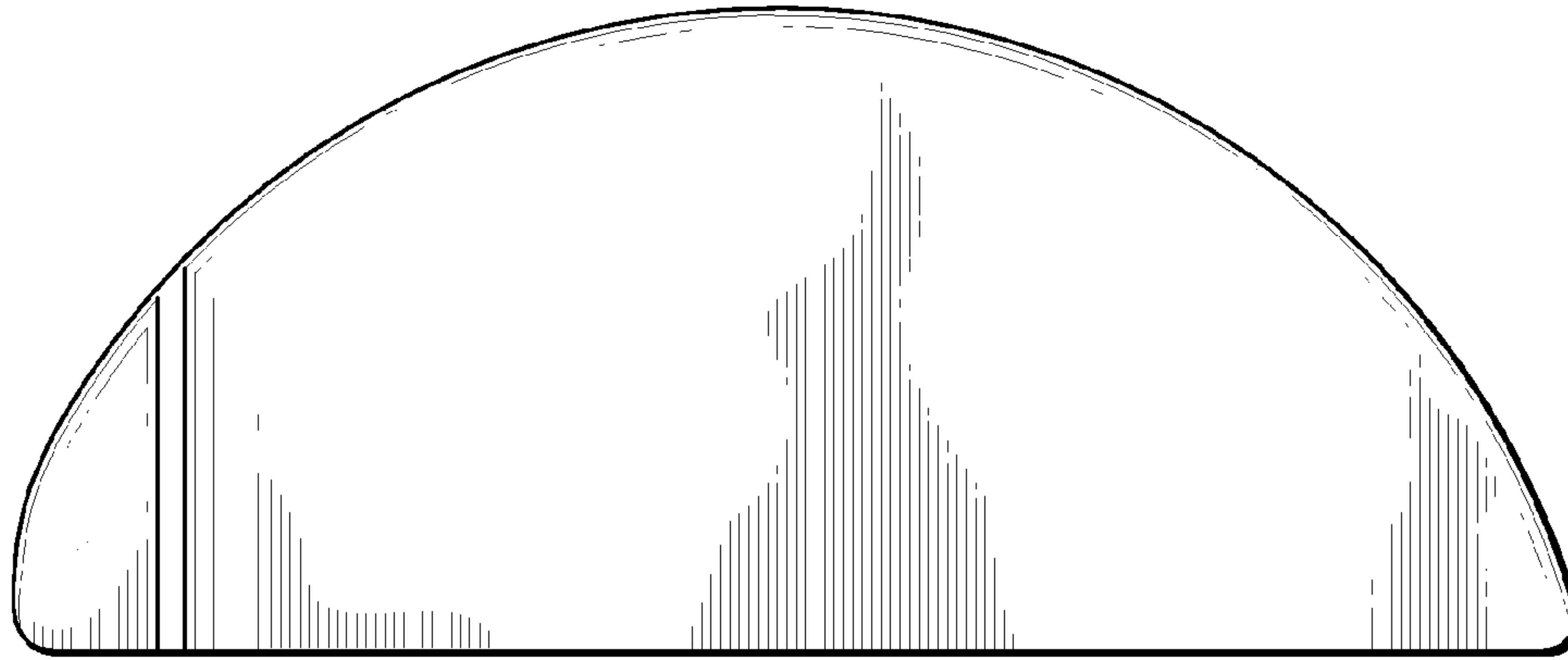

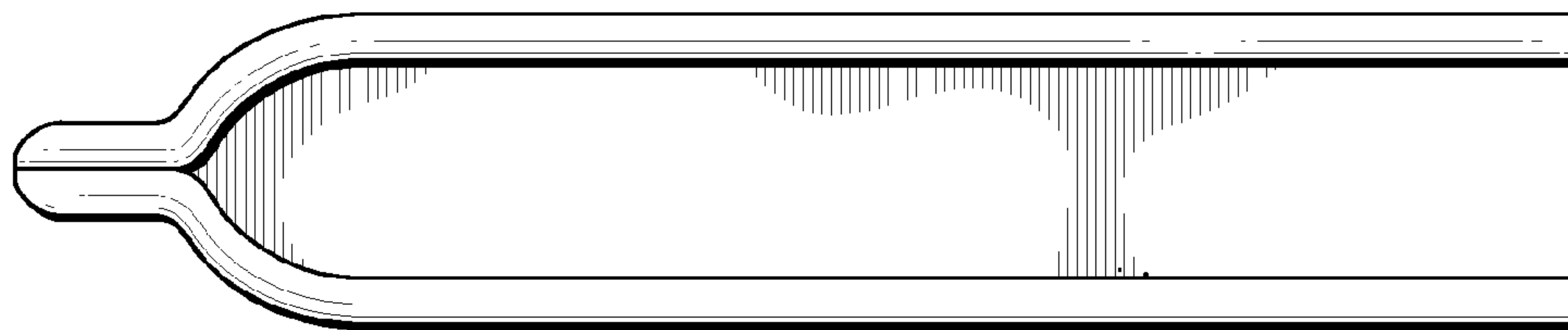

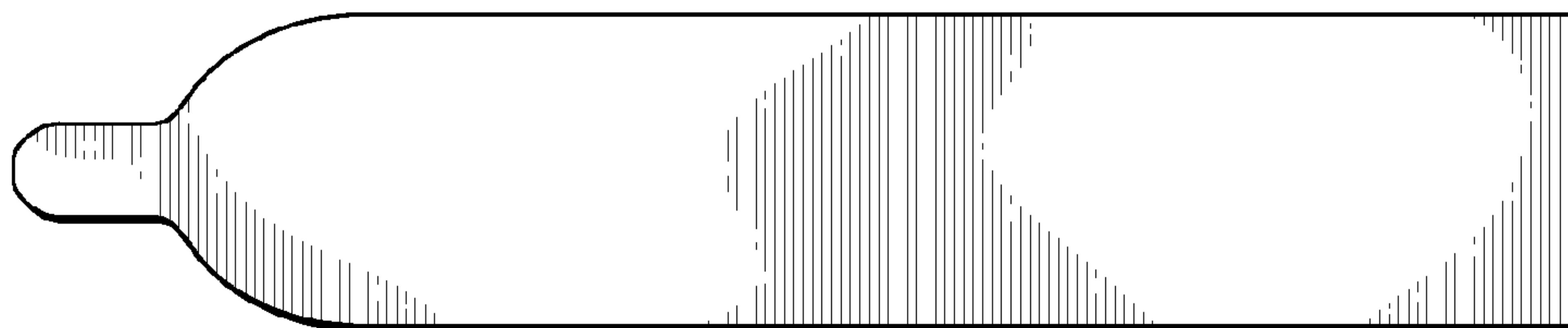
