FIG. 3 is a side view of the claimed design.

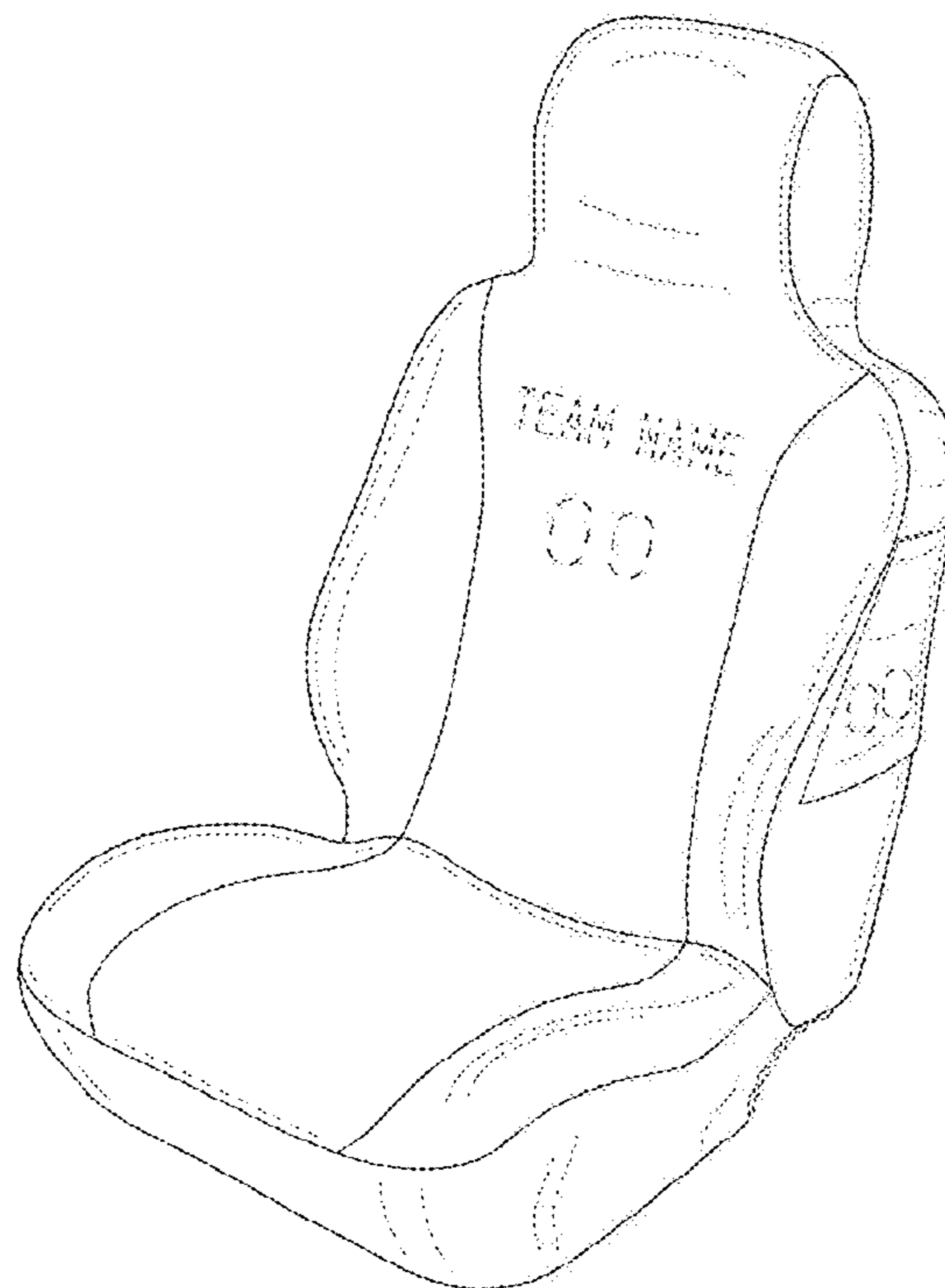
FIG. 4 is a top view of the claimed design.

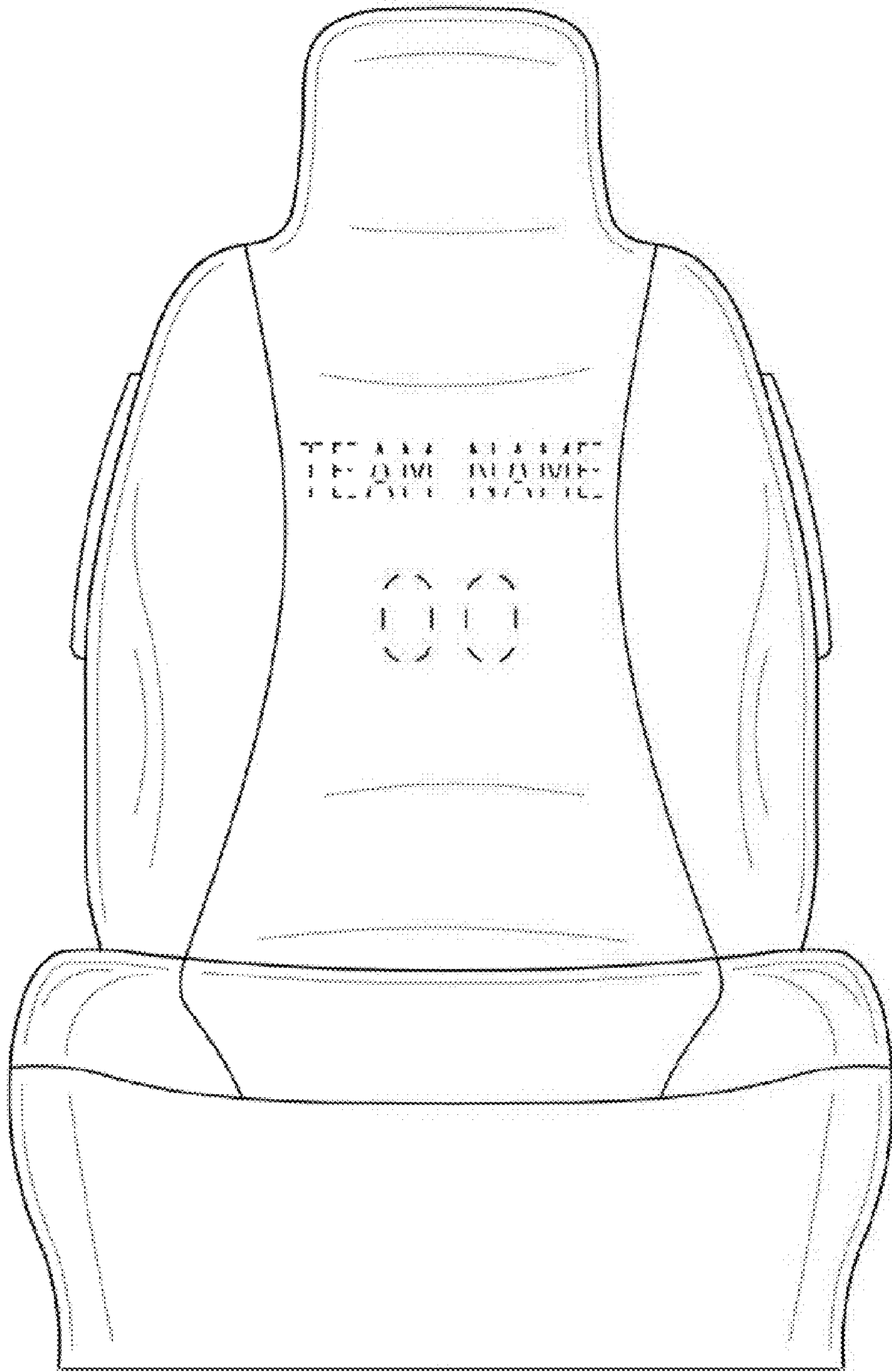

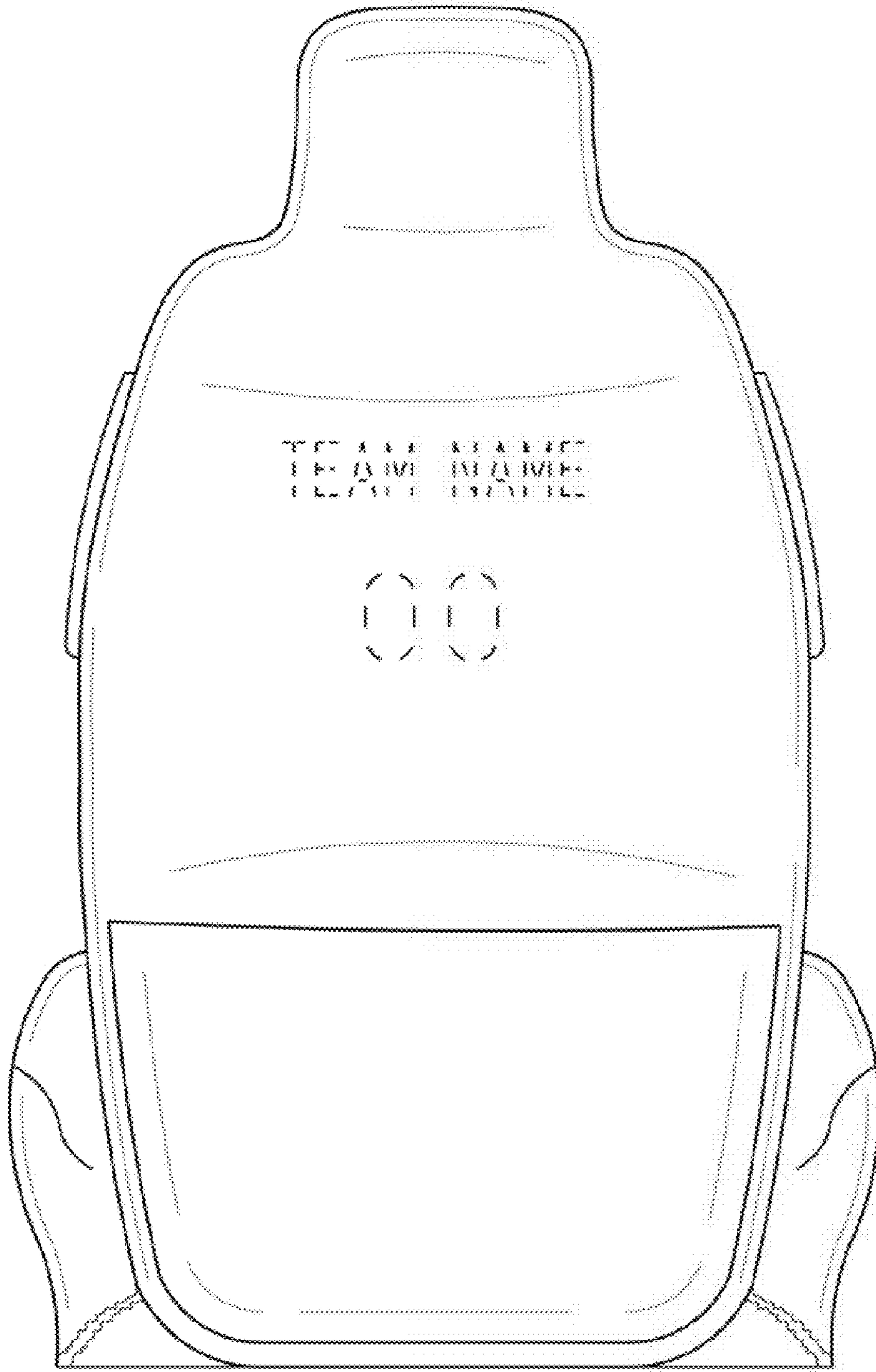

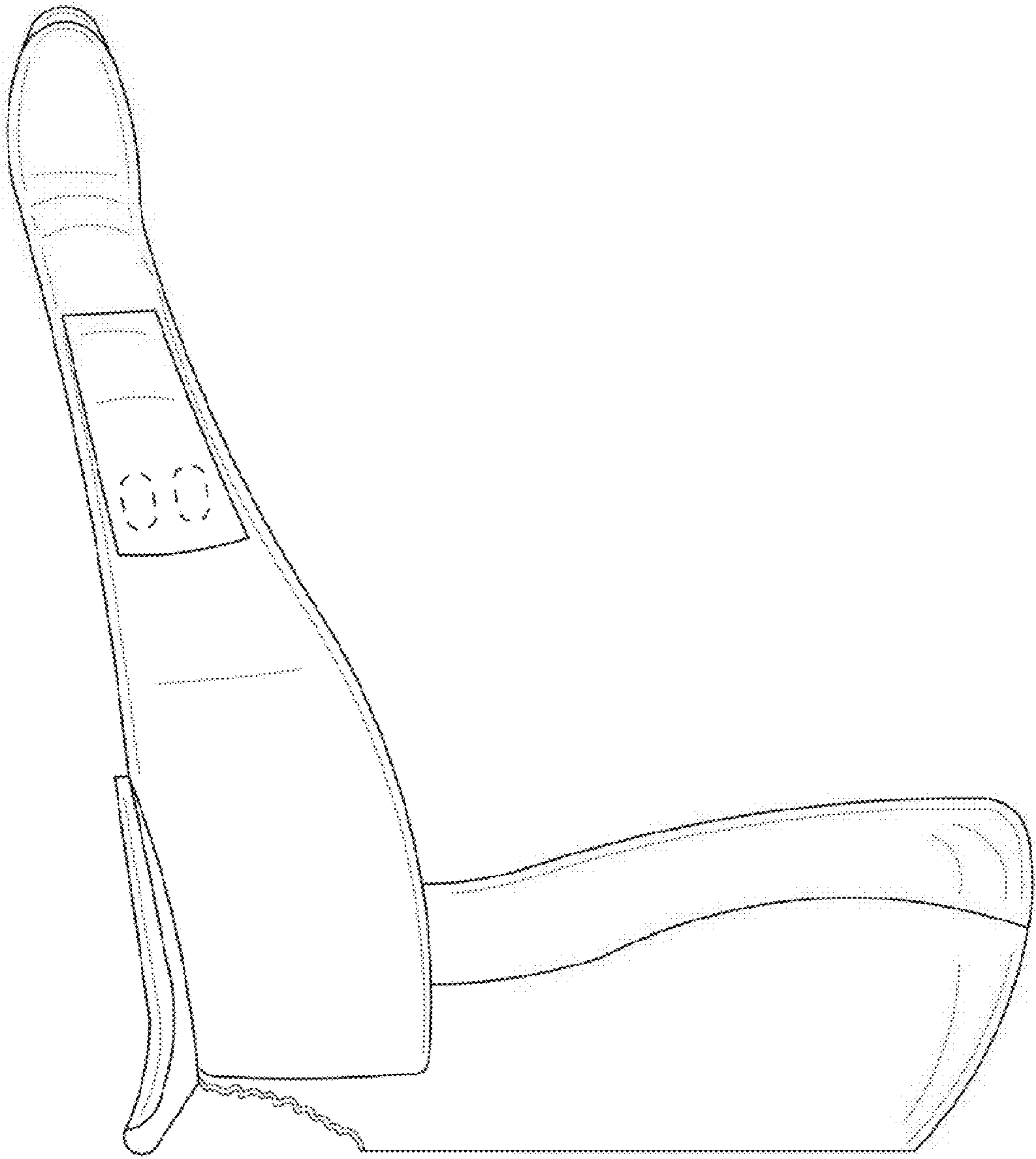

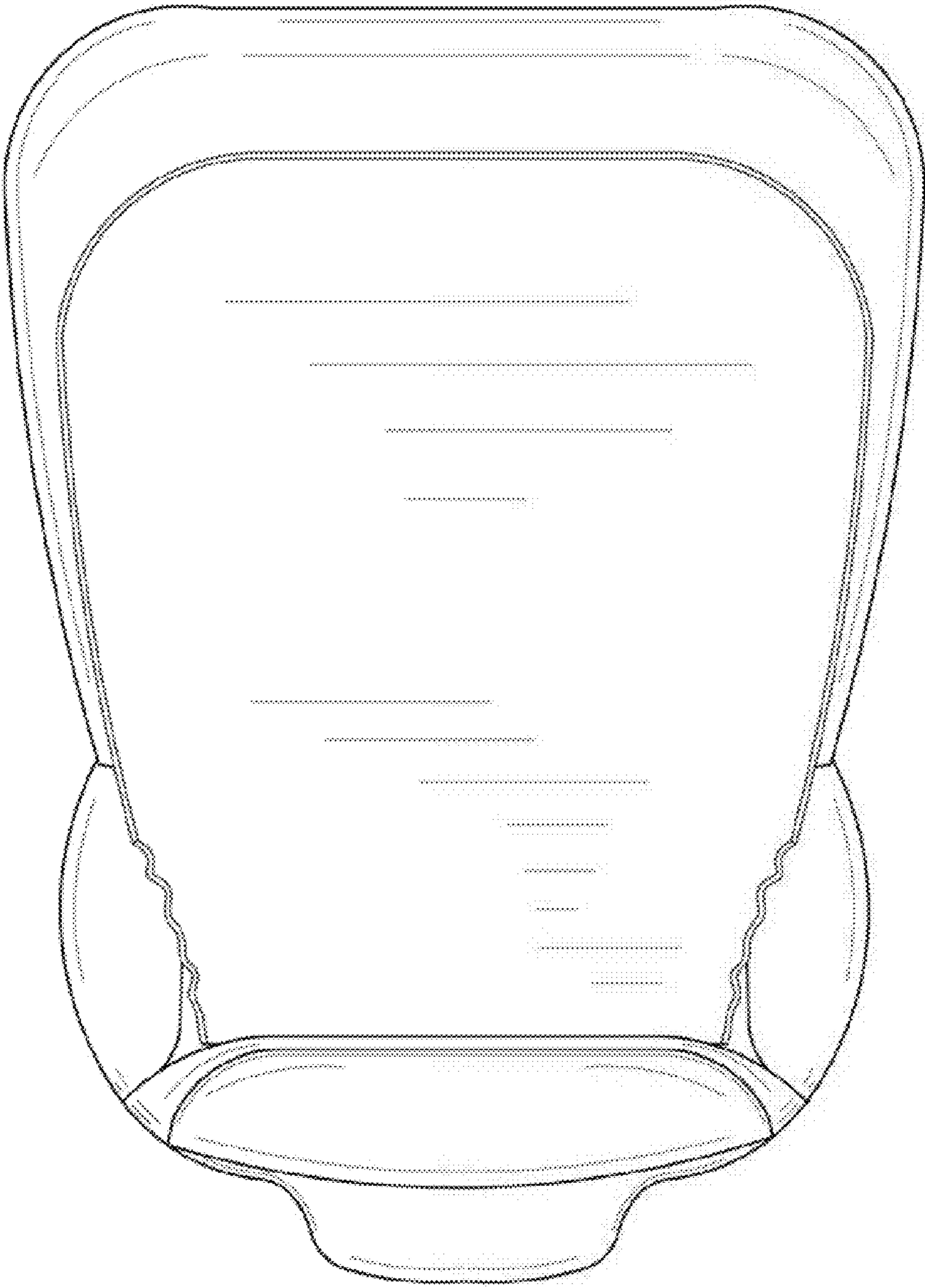

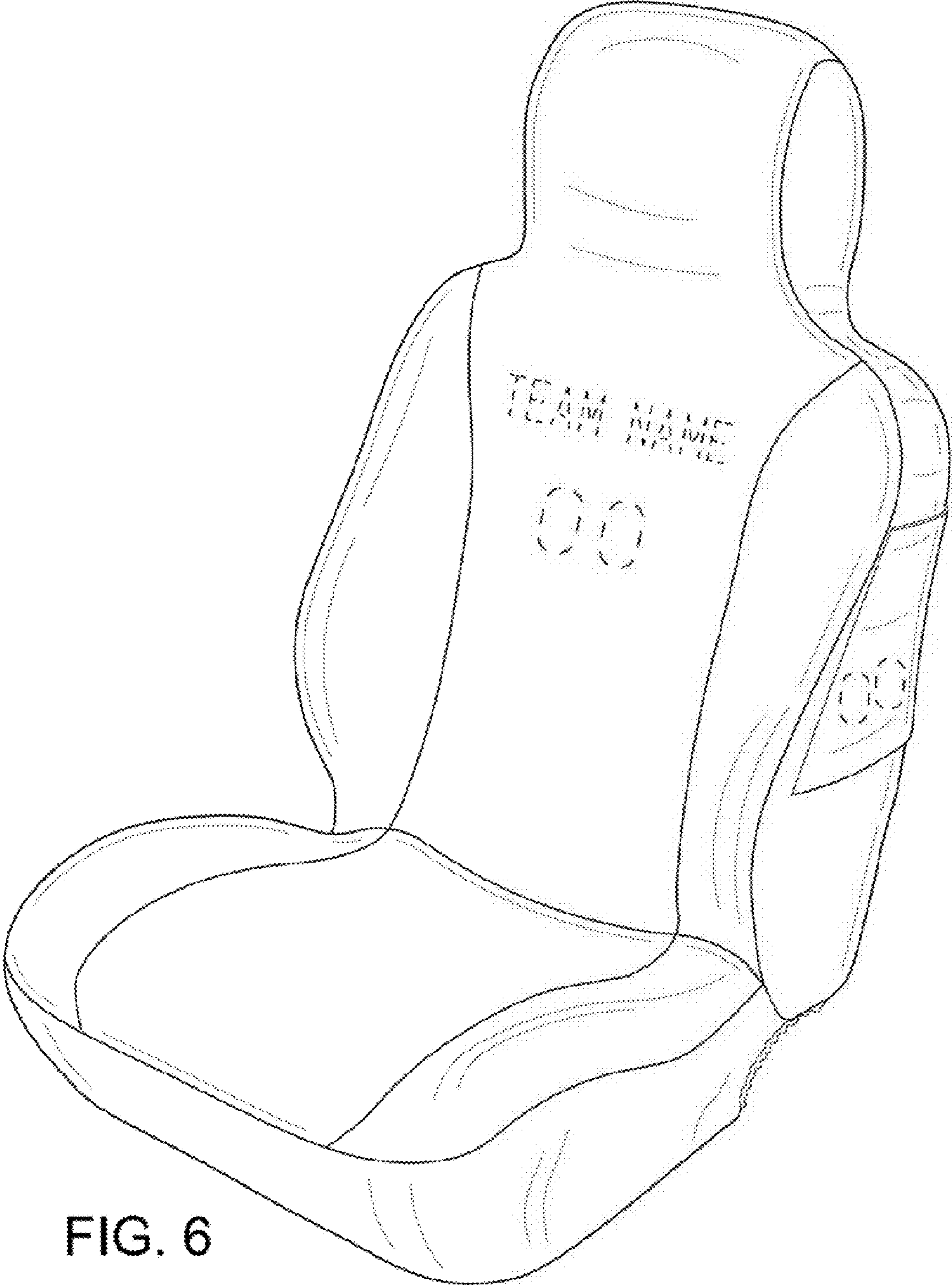
