(57) **CLAIM**

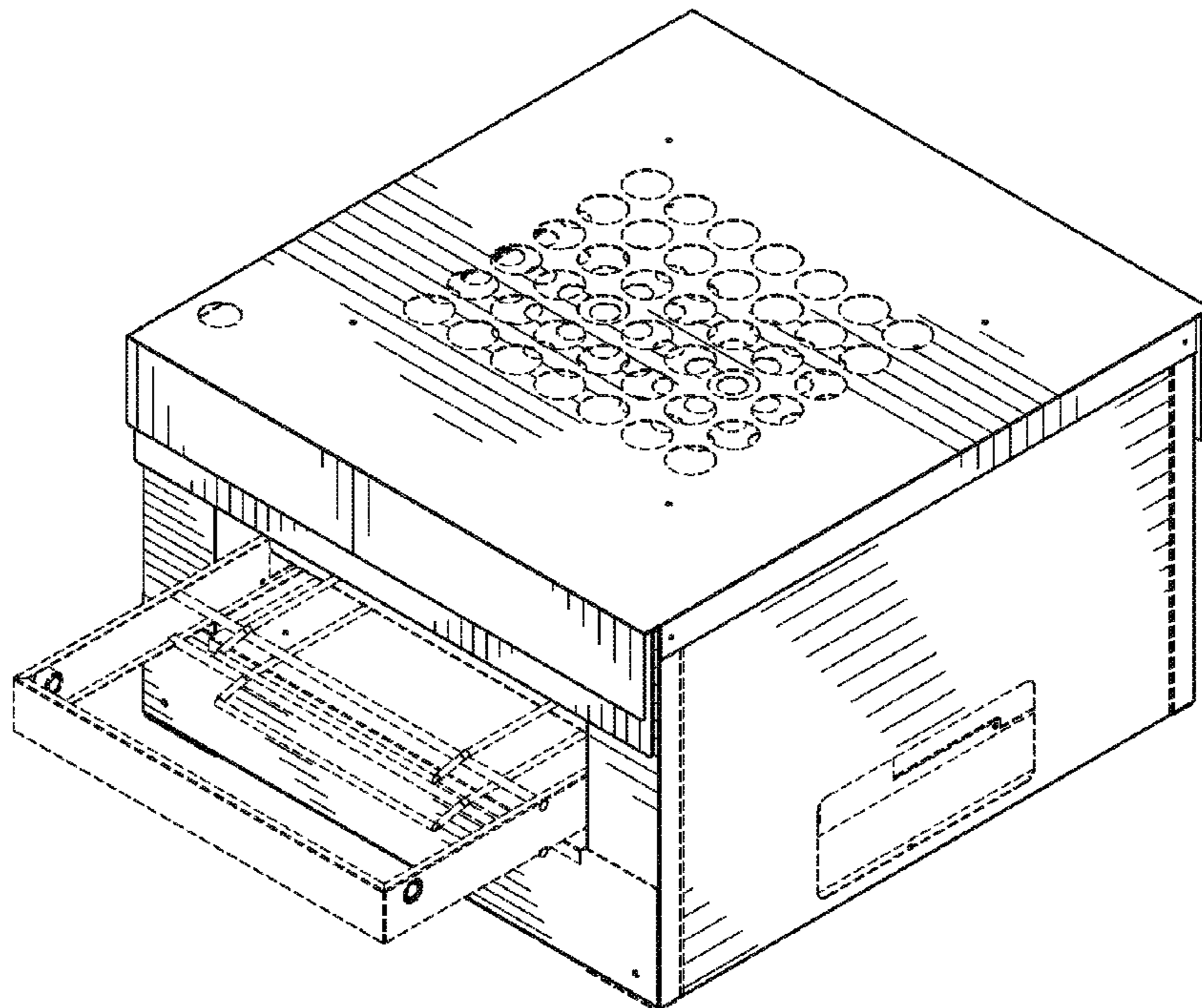
The ornamental design for a conveyor toaster with air-cooled sides, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a conveyor toaster with air-cooled sides, showing our new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a right end view thereof;  
FIG. 4 is a left end view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a rear view thereof; and,

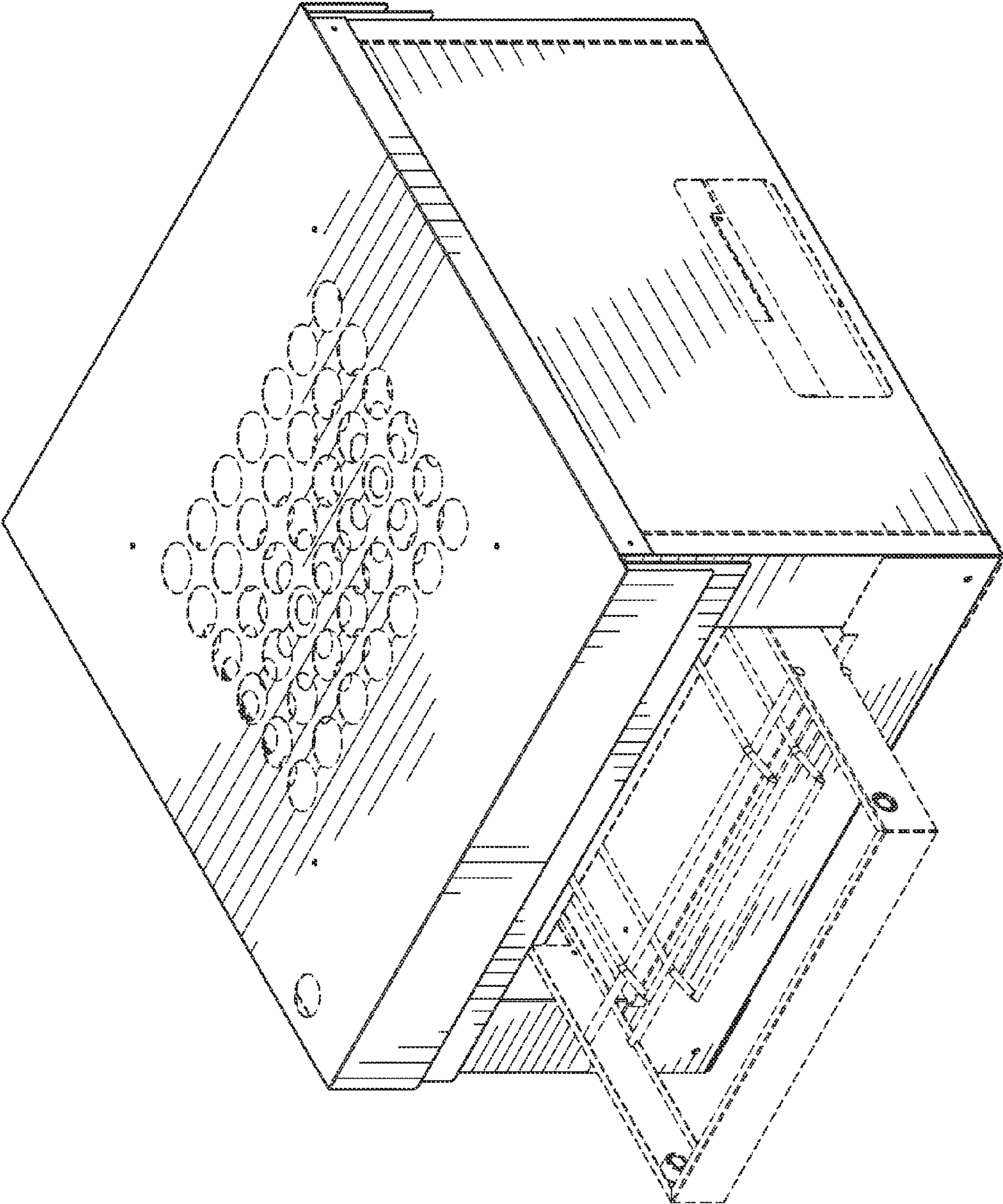

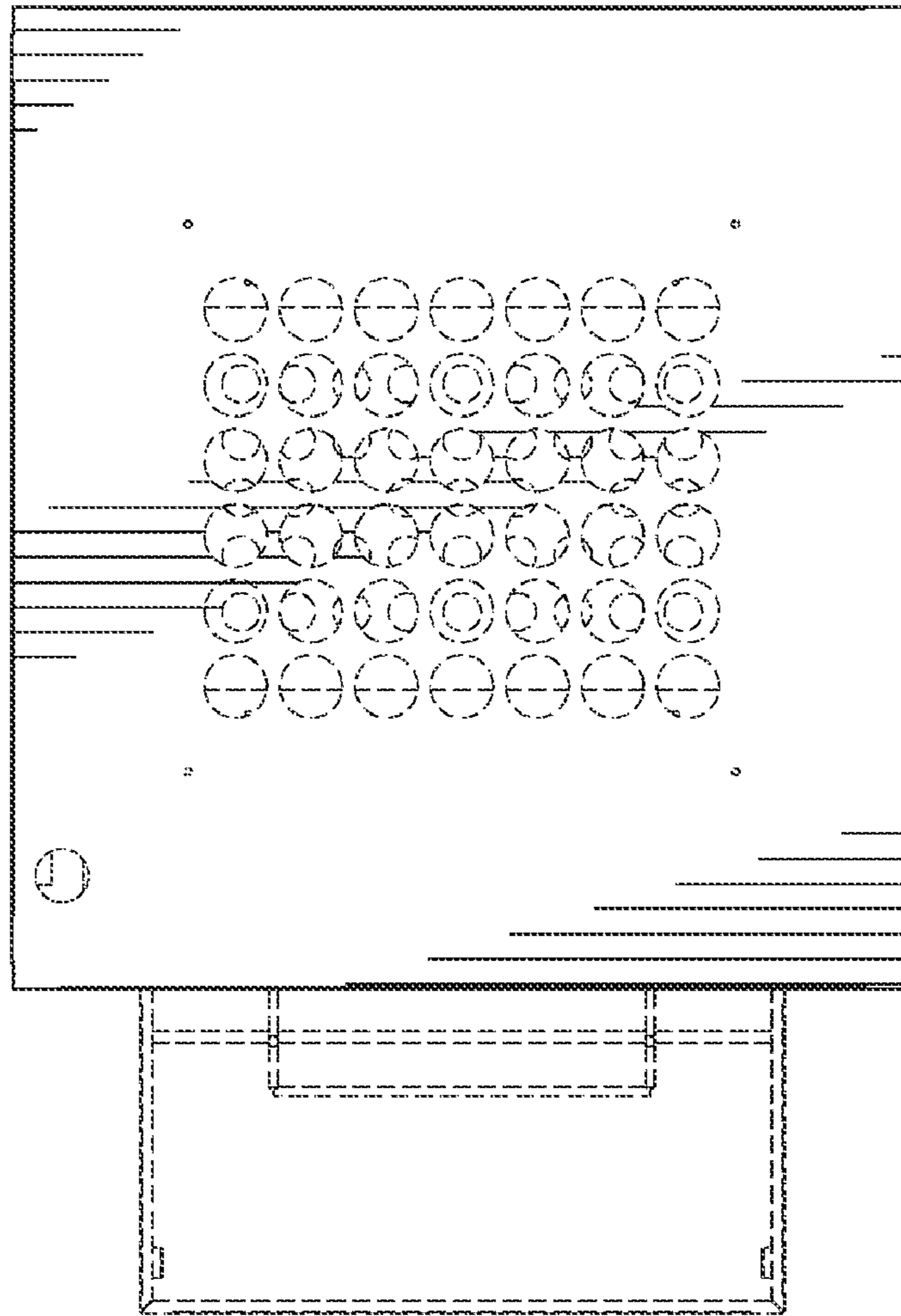

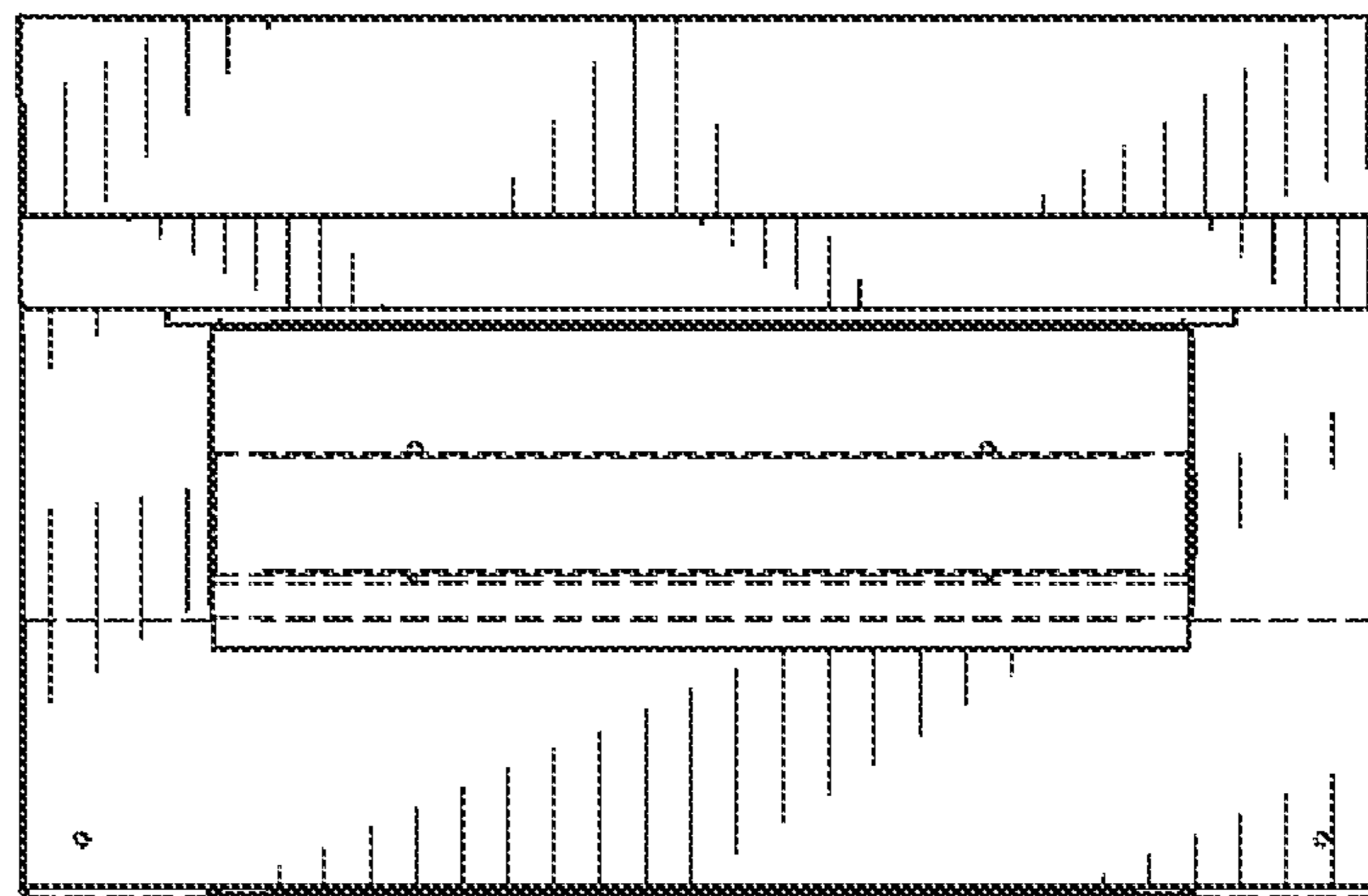

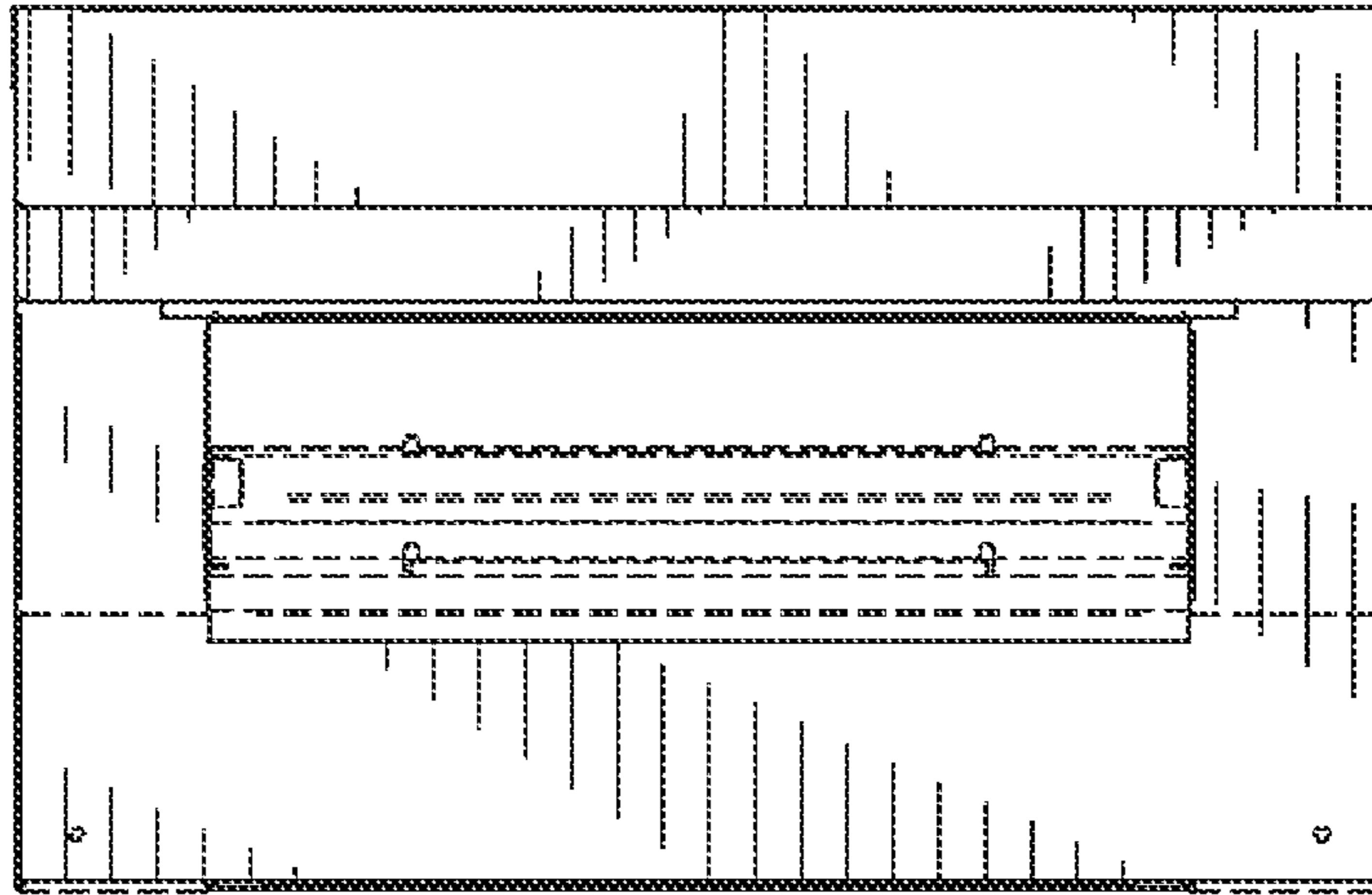

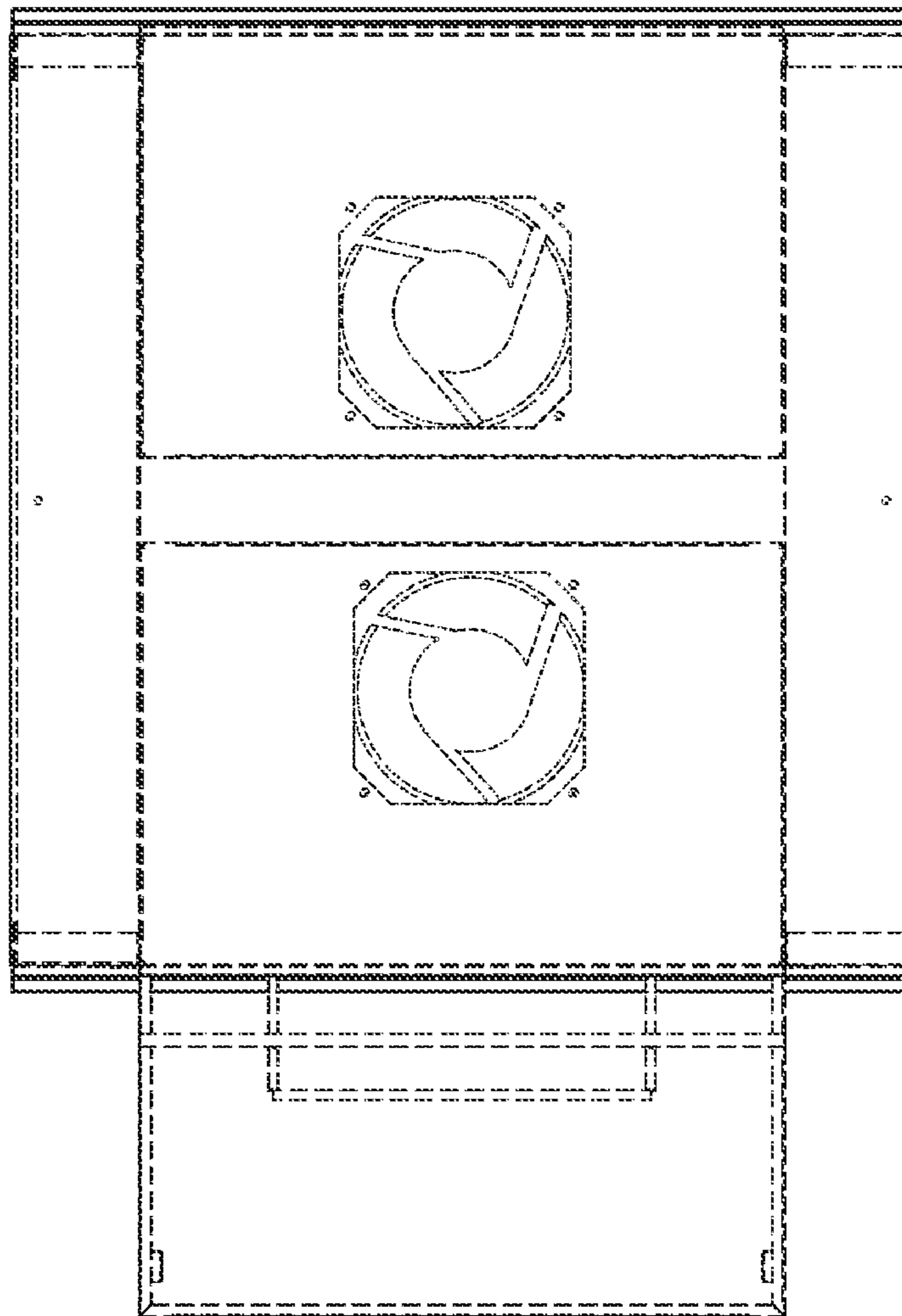

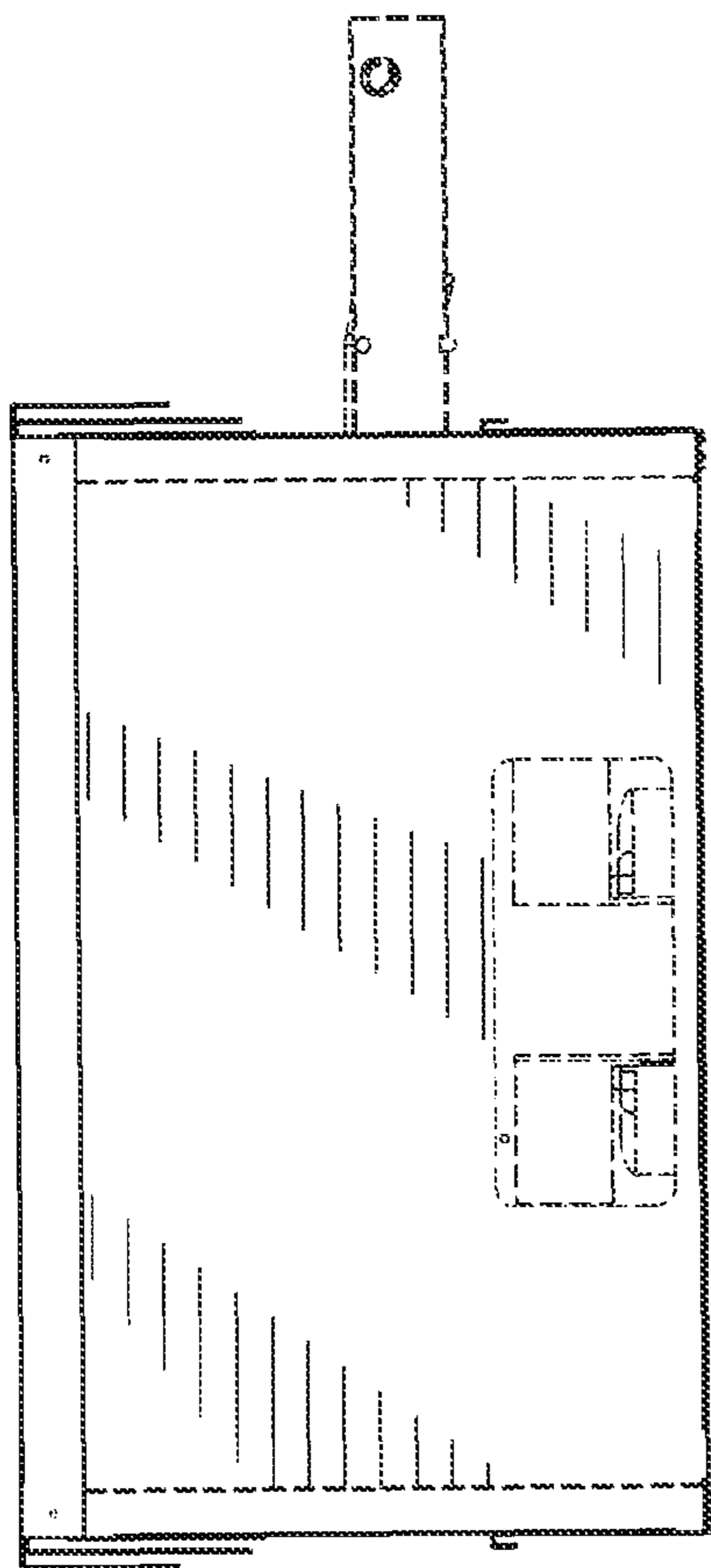

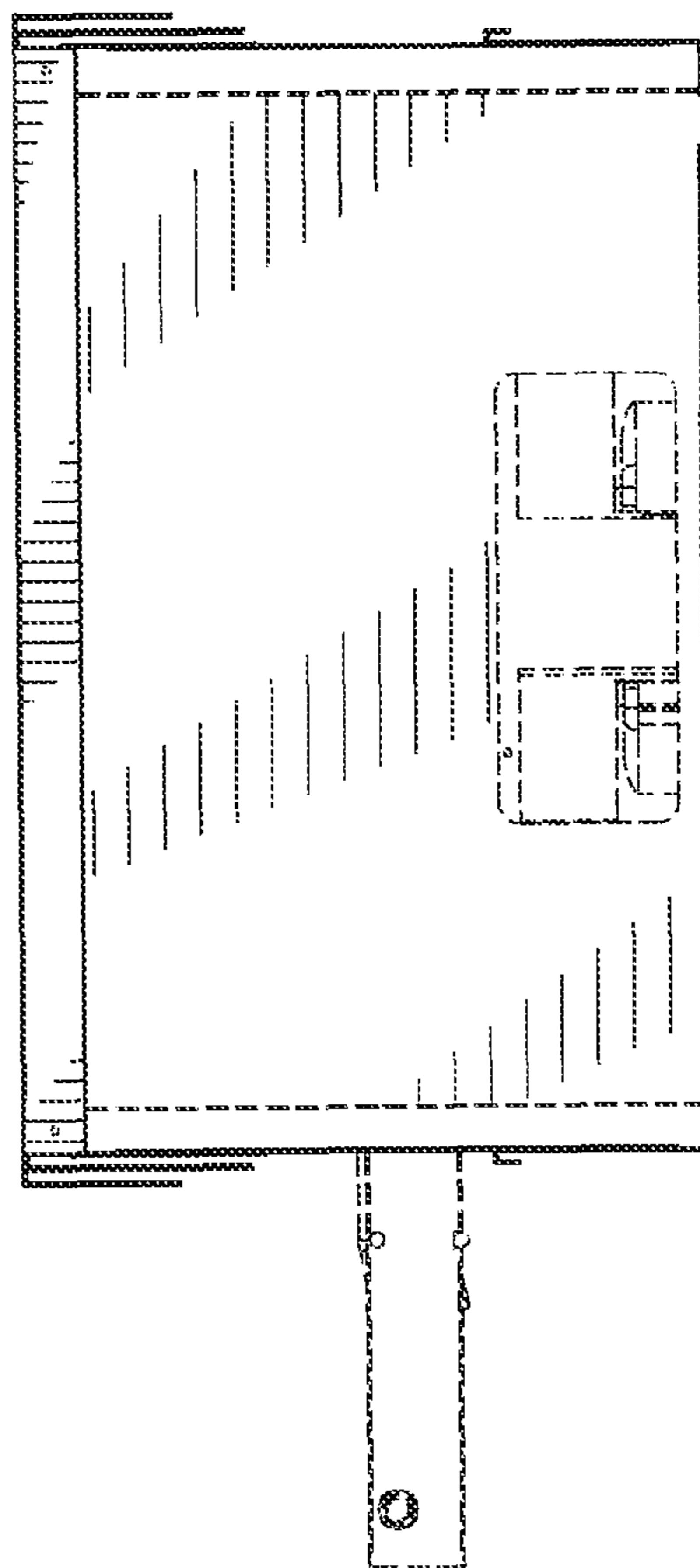
