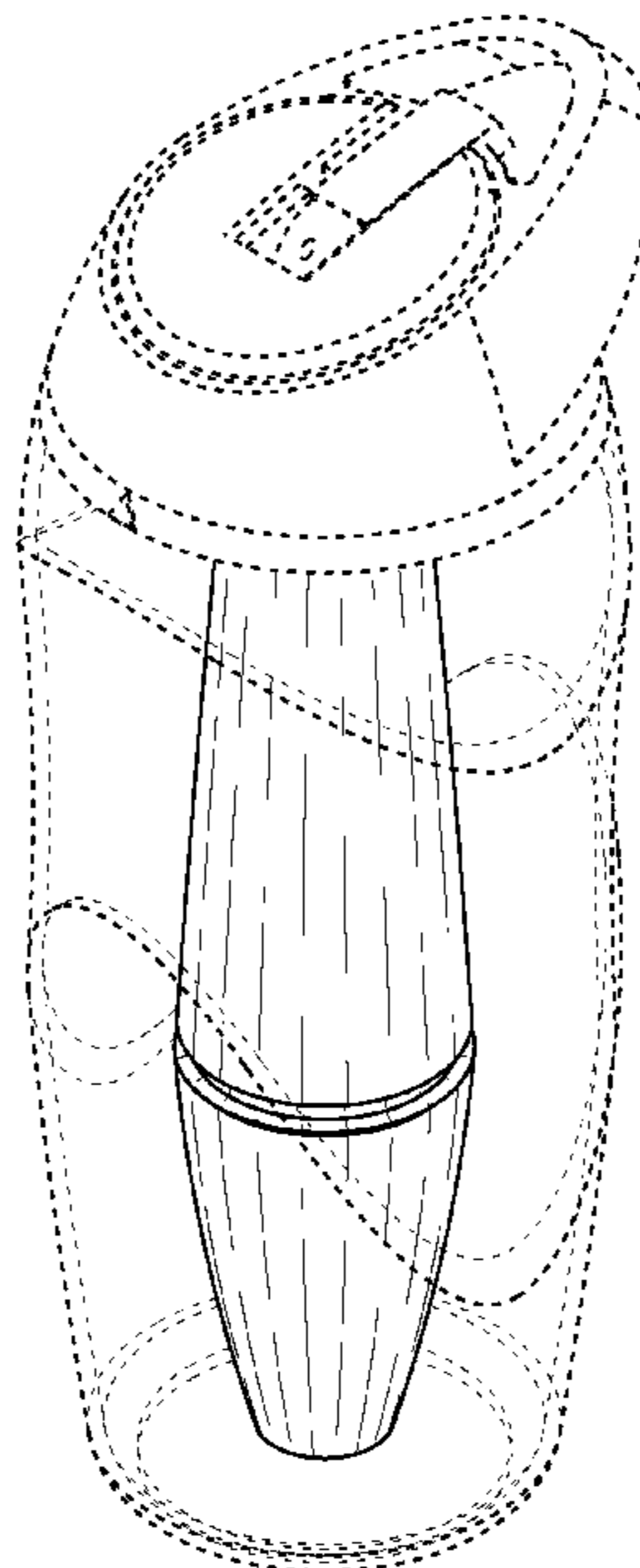
(57) **CLAIM**

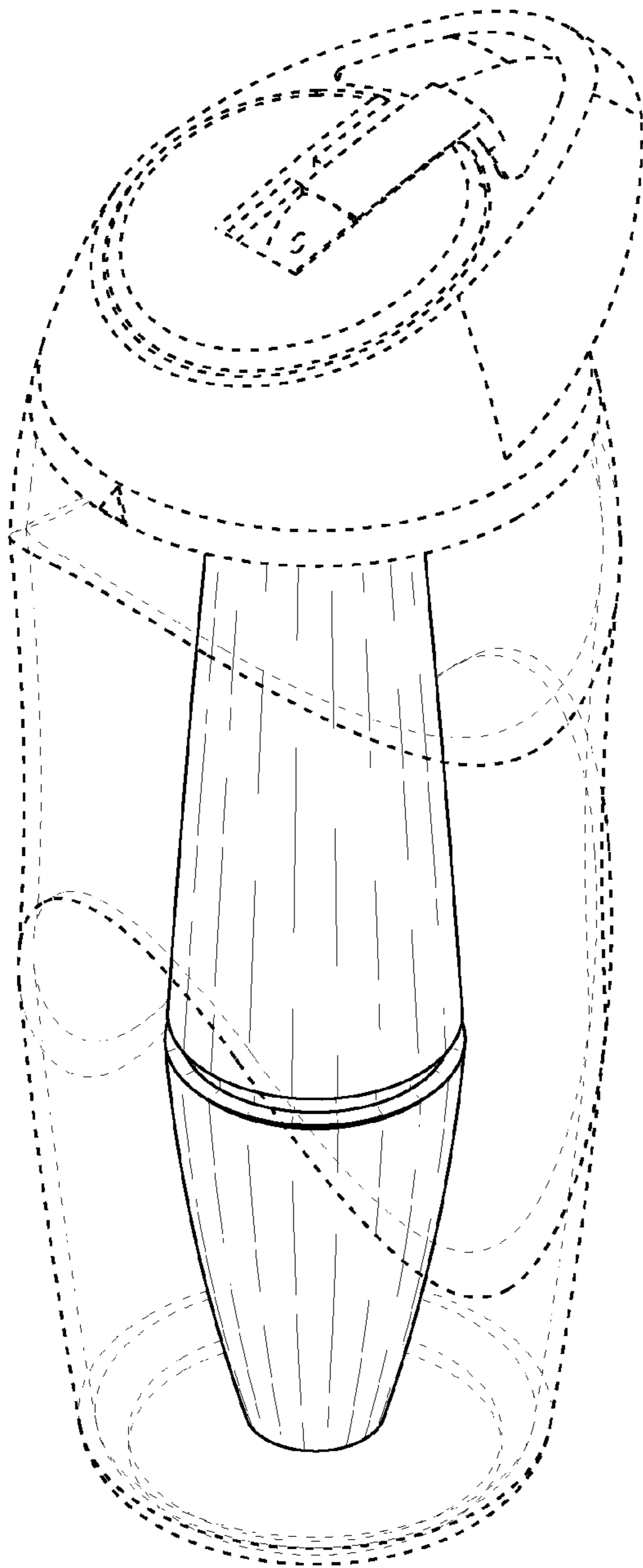
We claim a new ornamental design for a container, as shown and described.

**DESCRIPTION**

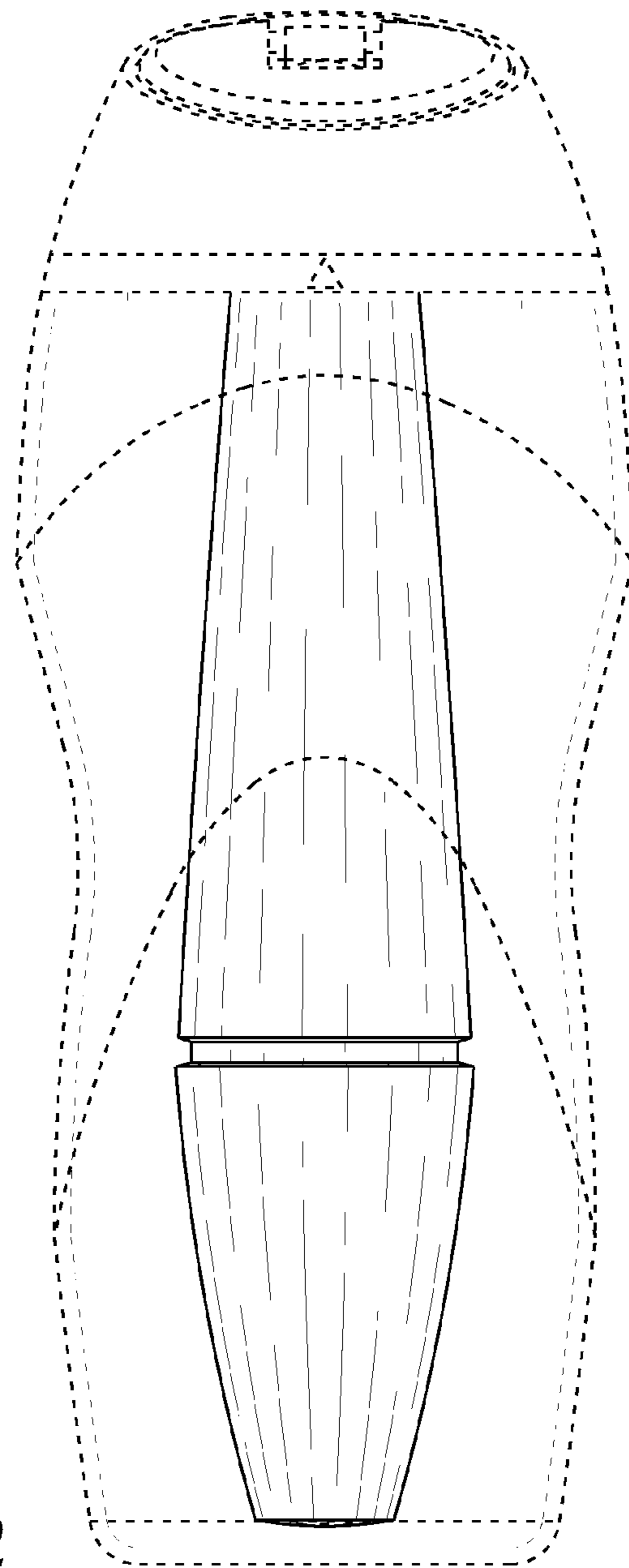
FIG. 1 is a perspective view of a container according to a preferred embodiment of our new design; FIG. 2 is front elevational view of the container of FIG. 1; FIG. 3 is a rear elevational view of the container of FIG. 1; FIG. 4 is a left side elevational view of the container of FIG. 1; the right side elevational view of the container of FIG. 1 being a mirror image of FIG. 4; FIG. 5 is a top plan view of the container of FIG. 1; and, FIG. 6 is a bottom plan view of the container of FIG. 1. The broken lines in FIGS. 1-6 represent environment and are for illustrative purposes only and do not constitute part of the claimed design.

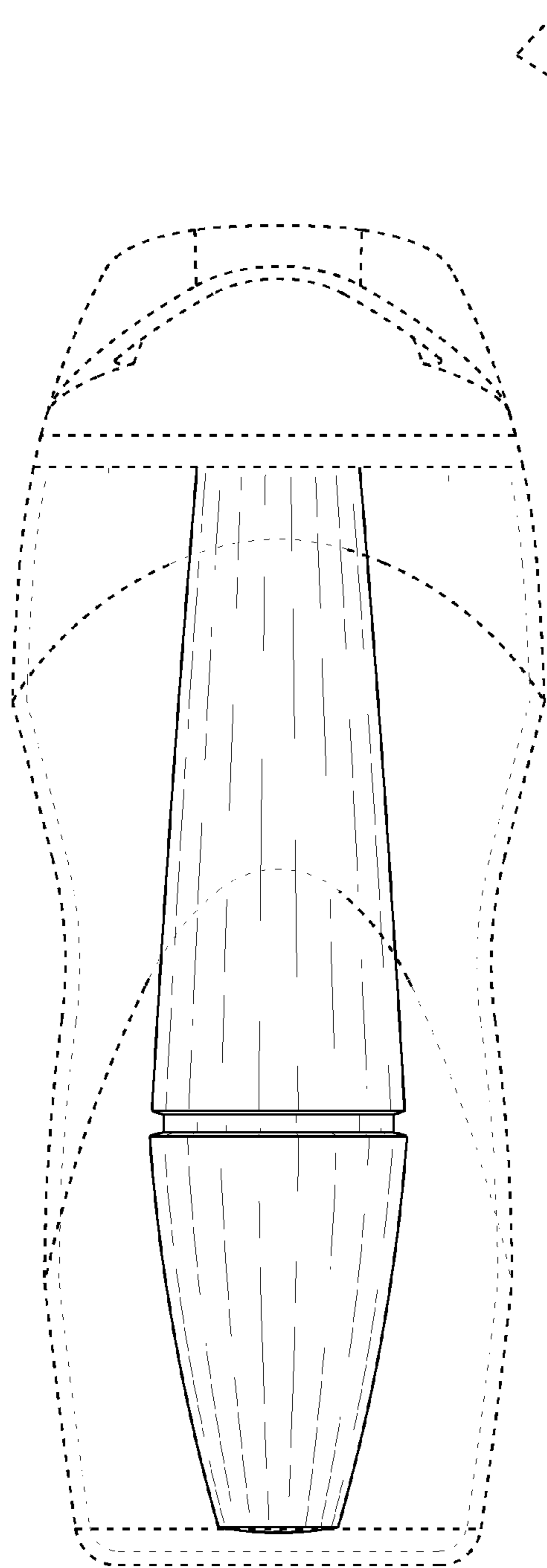




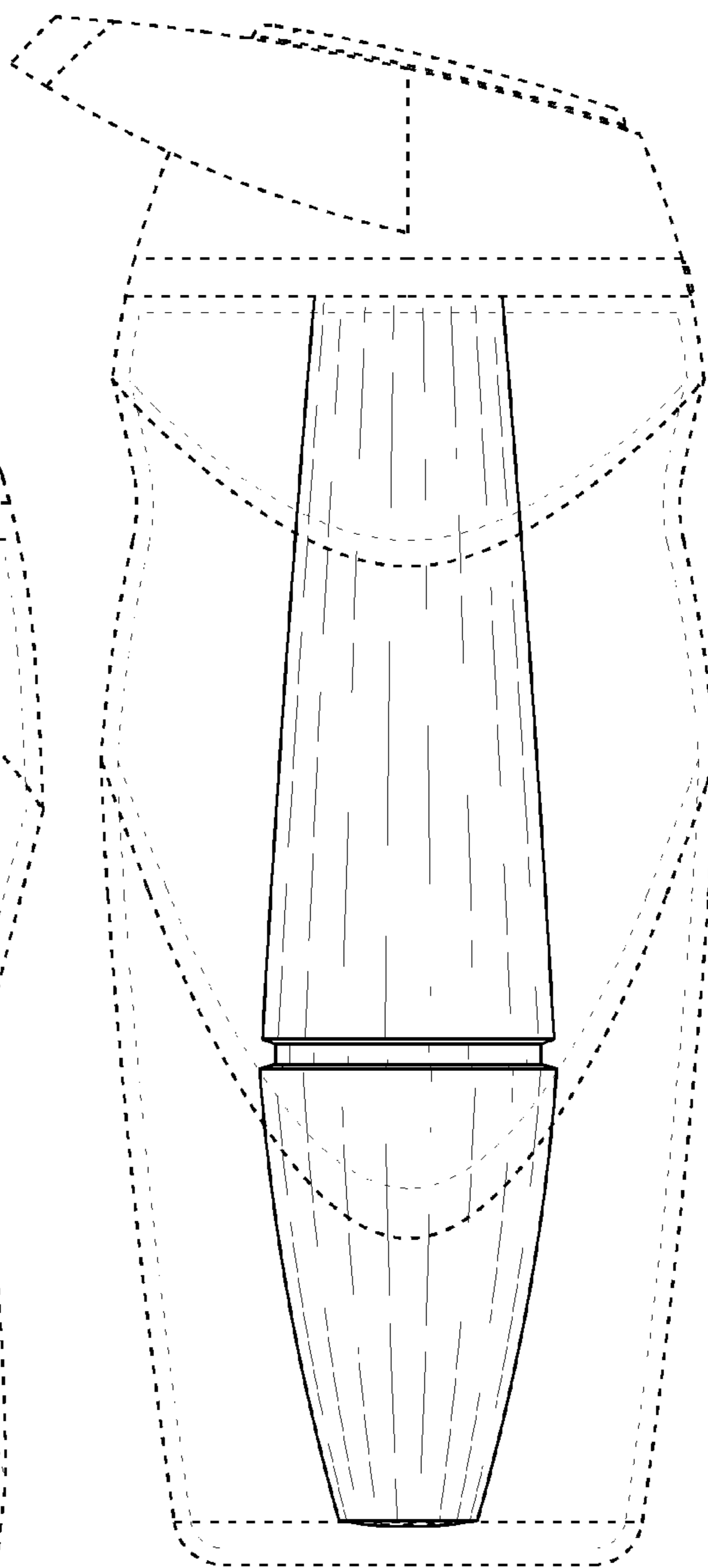

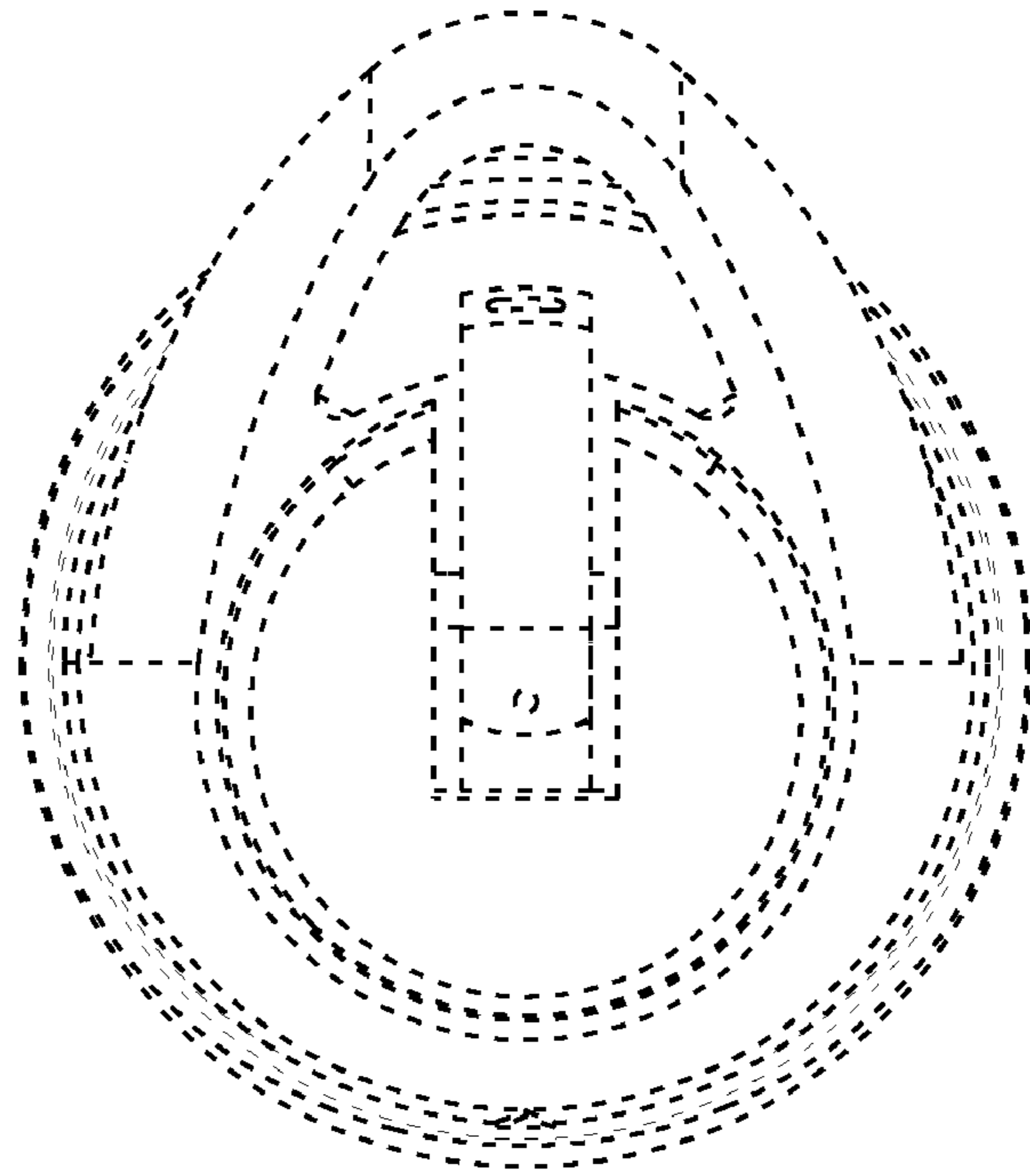

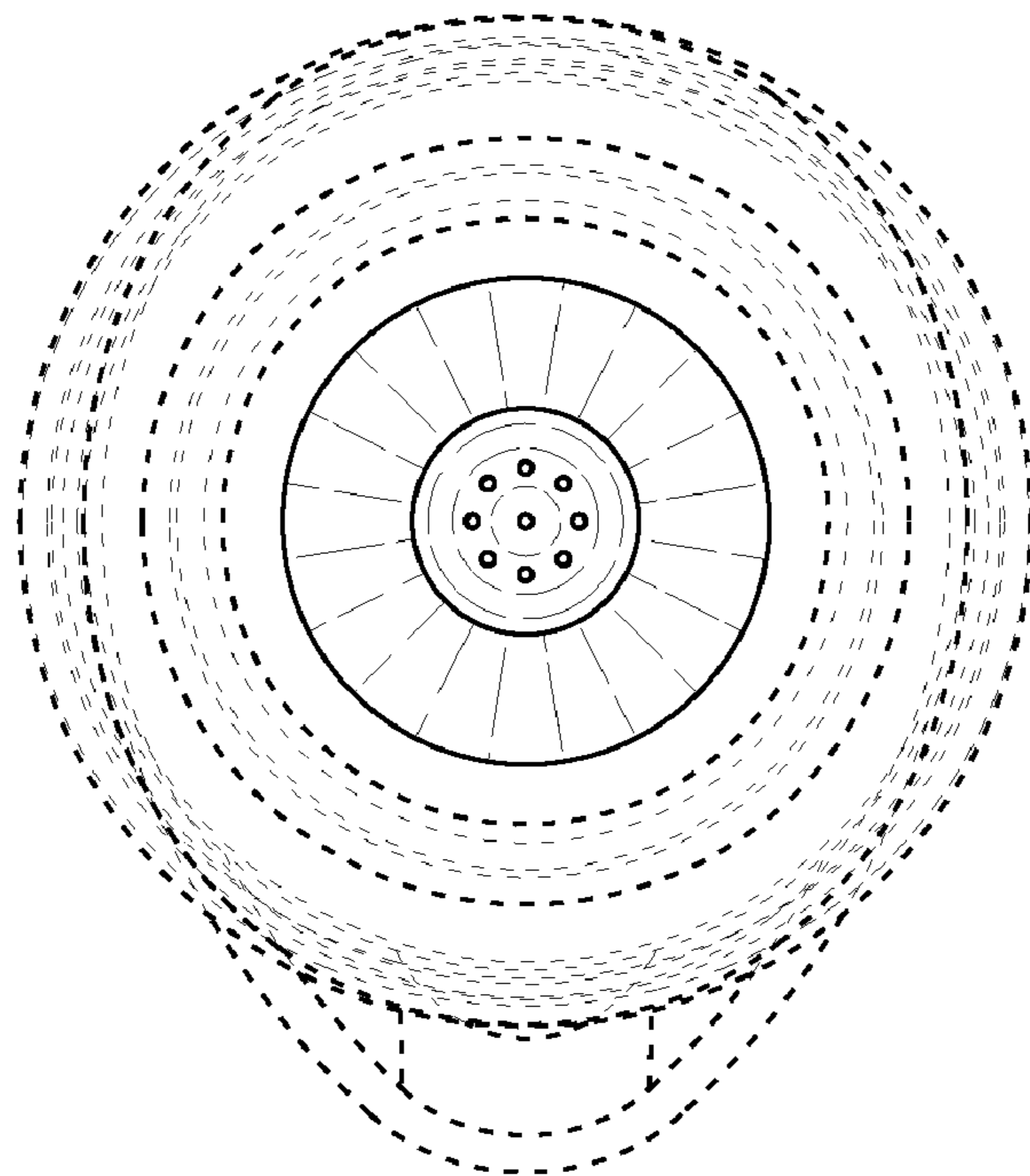
