We claim the ornamental design for a self spacing razor knife,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the self spacing razor knife;
FIG. 2 is a left view of the self spacing razor knife;
FIG. 3 is a top side view of the self spacing razor knife;
FIG. 4 is a right side view of the self spacing razor knife;
FIG. 5 is a bottom view of the self spacing razor knife;
FIG. 6 is a front view of the self spacing razor knife;
FIG. 7 is a back view of the self spacing razor knife; and,
FIG. 8 is an enlarged view of a front tip of the self spacing
razor knife.

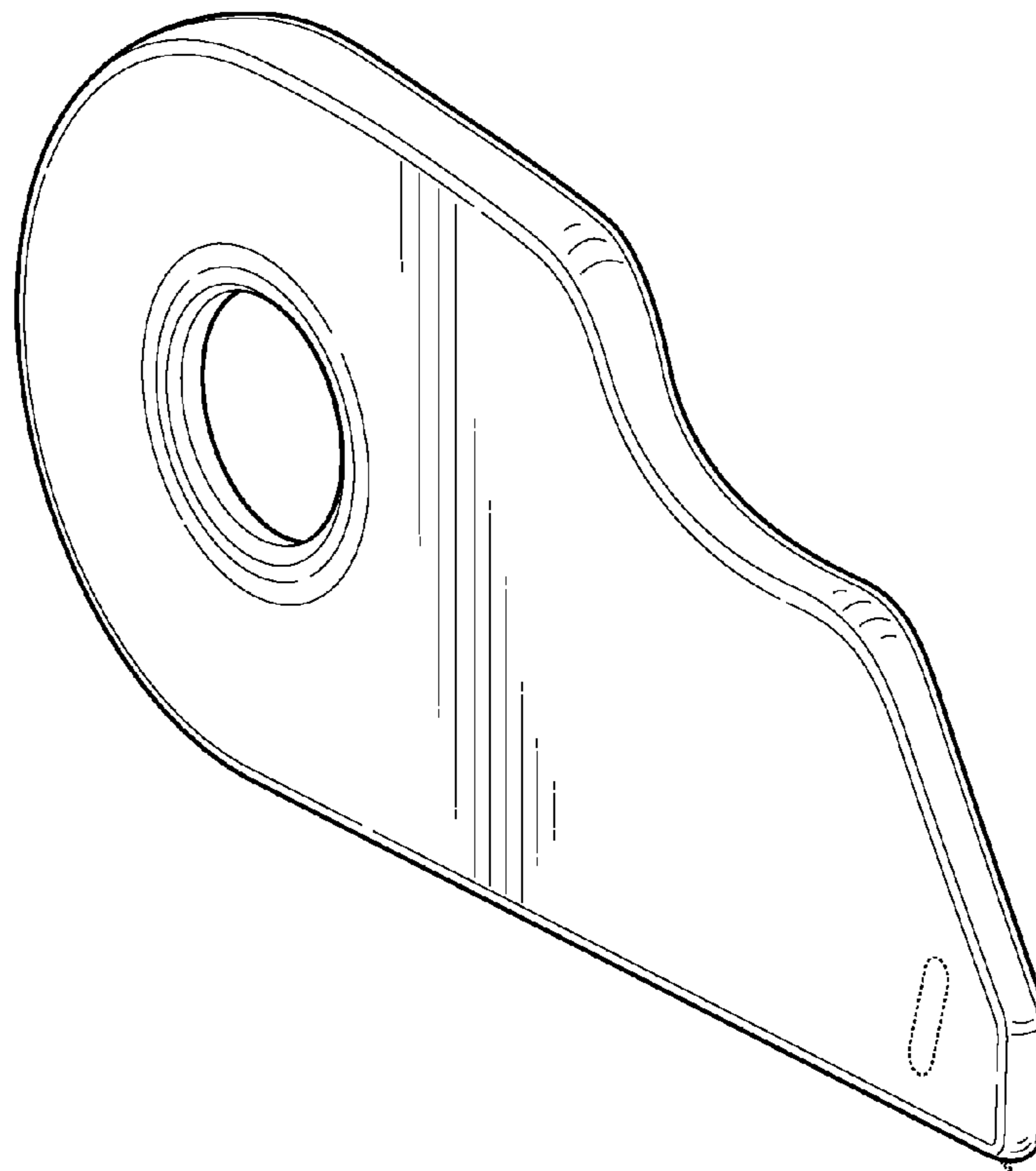

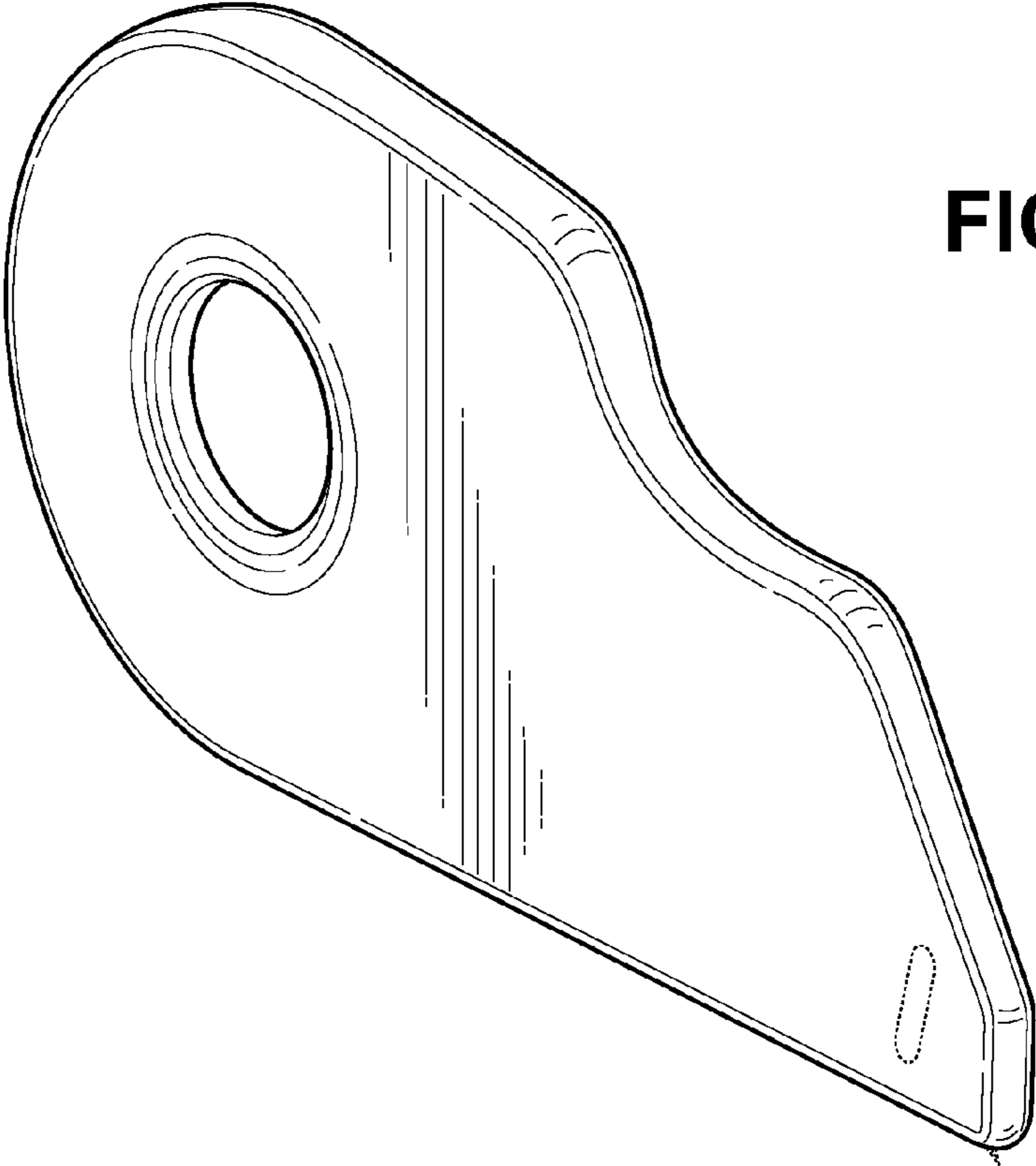

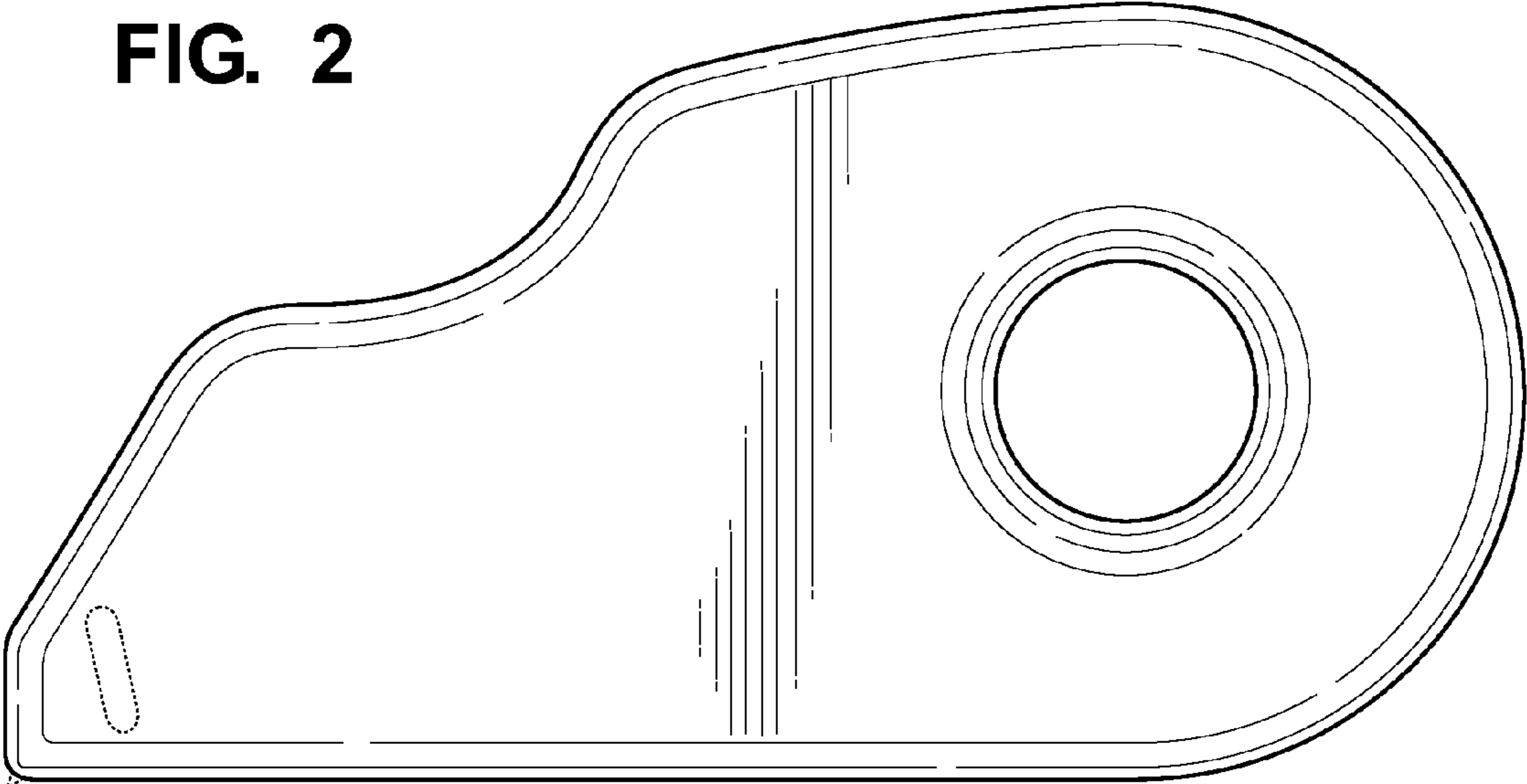

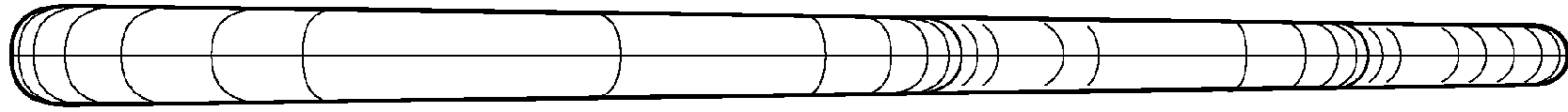

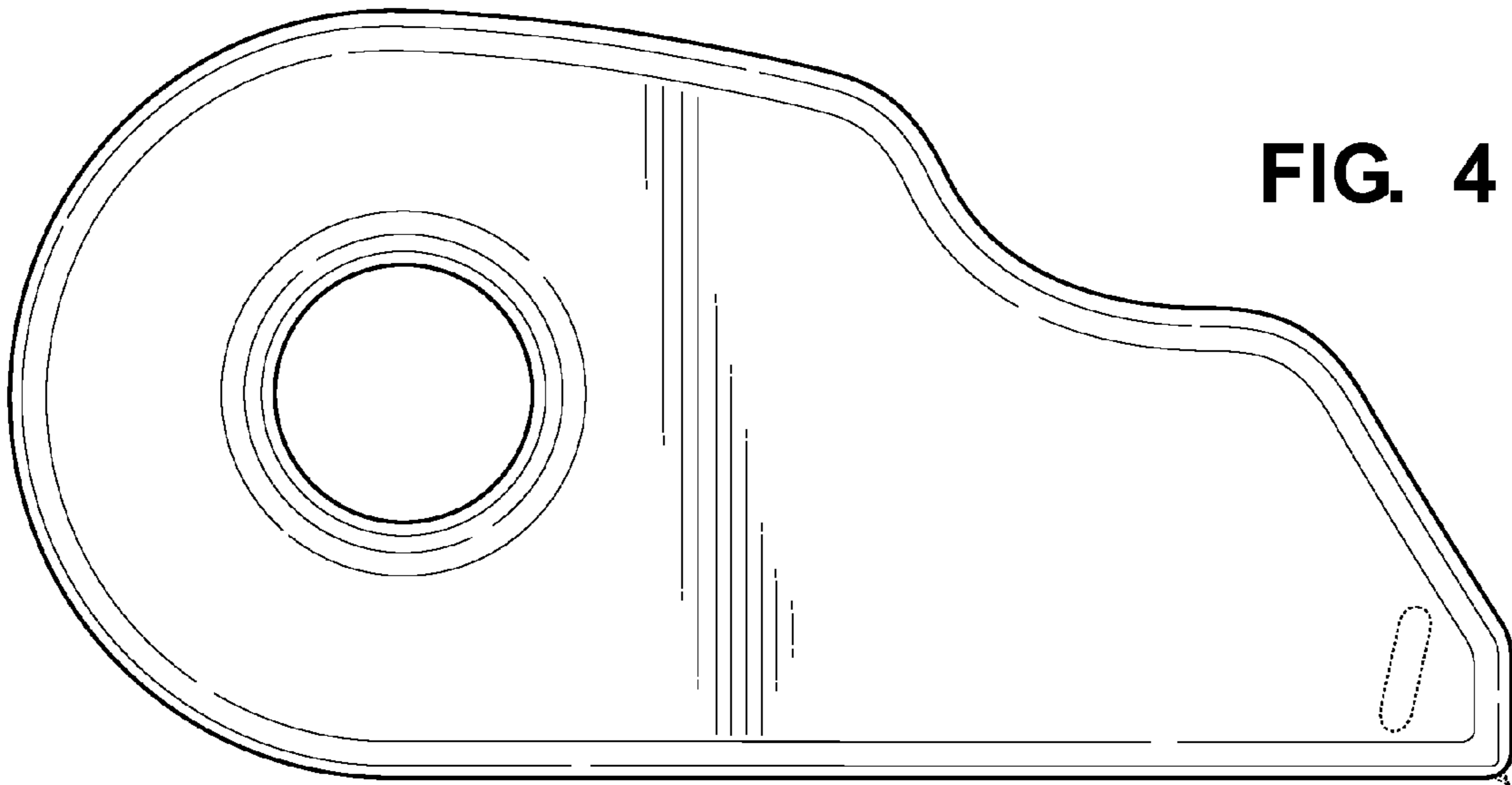

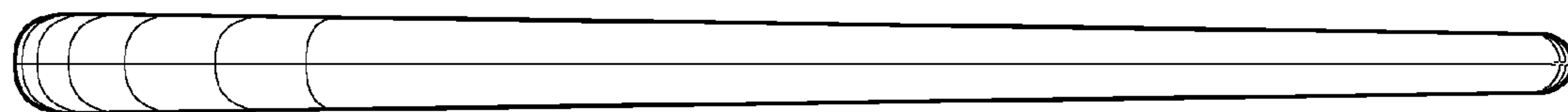

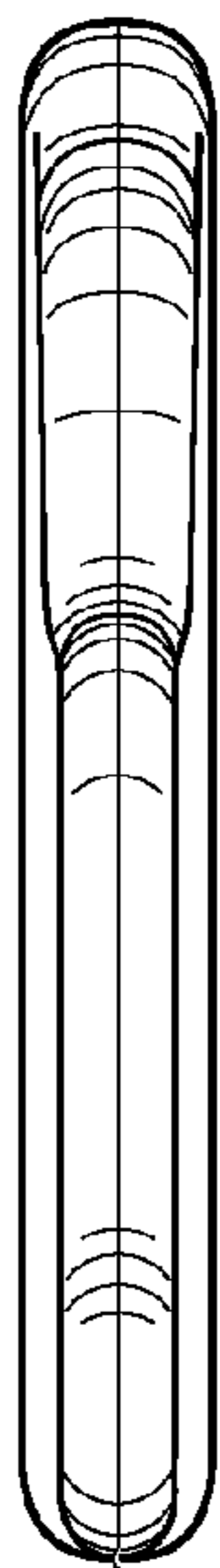

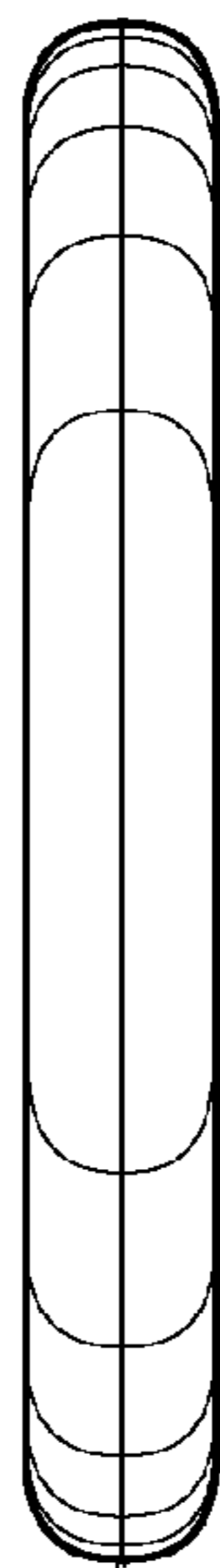
