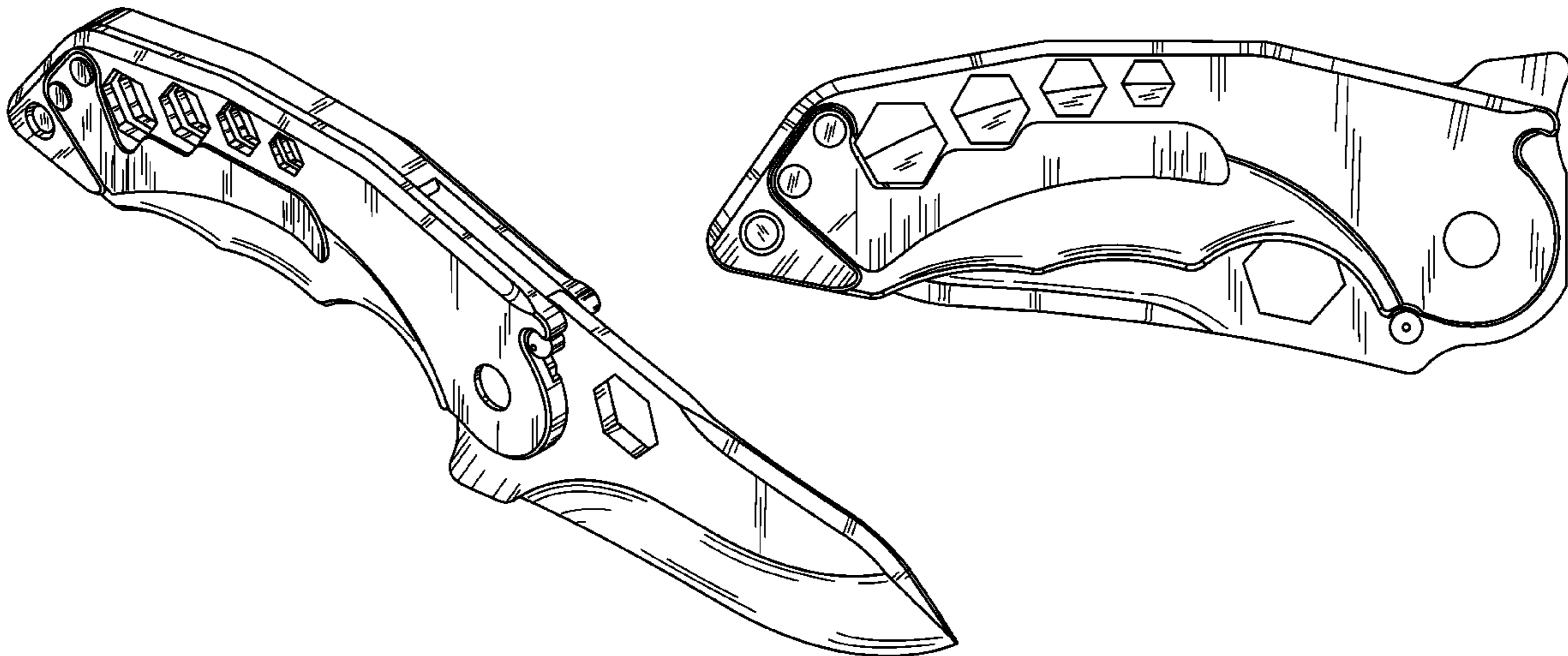
(57) **CLAIM**

The ornamental design for a folding knife, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a folding knife showing our new design, illustrated in an open position;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a front side elevational view thereof; and
FIG. 8 is a rear side elevational view thereof.
FIG. 9 is a front perspective view of the folding knife, illustrated in a closed position;
FIG. 10 is a rear perspective view thereof;

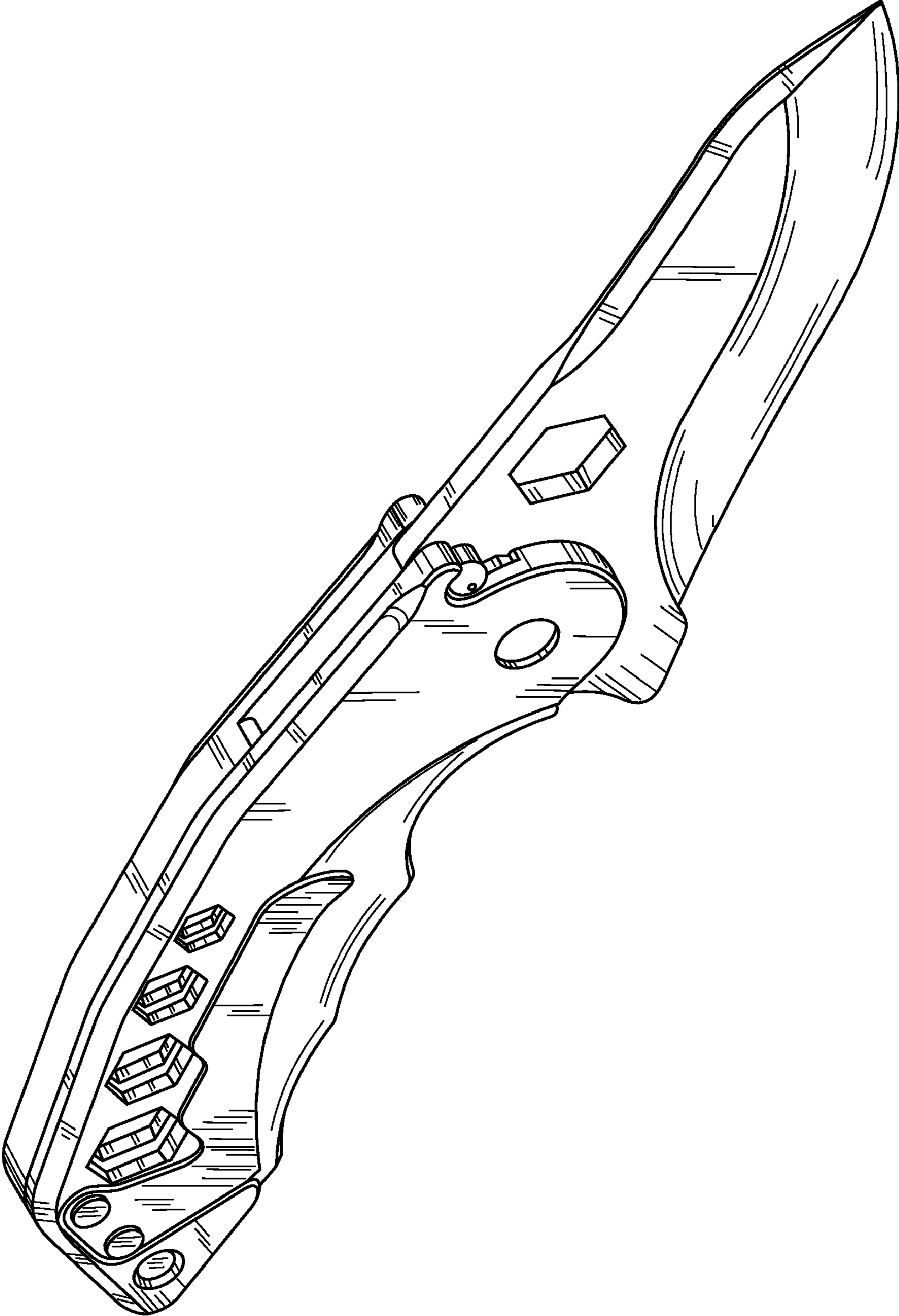

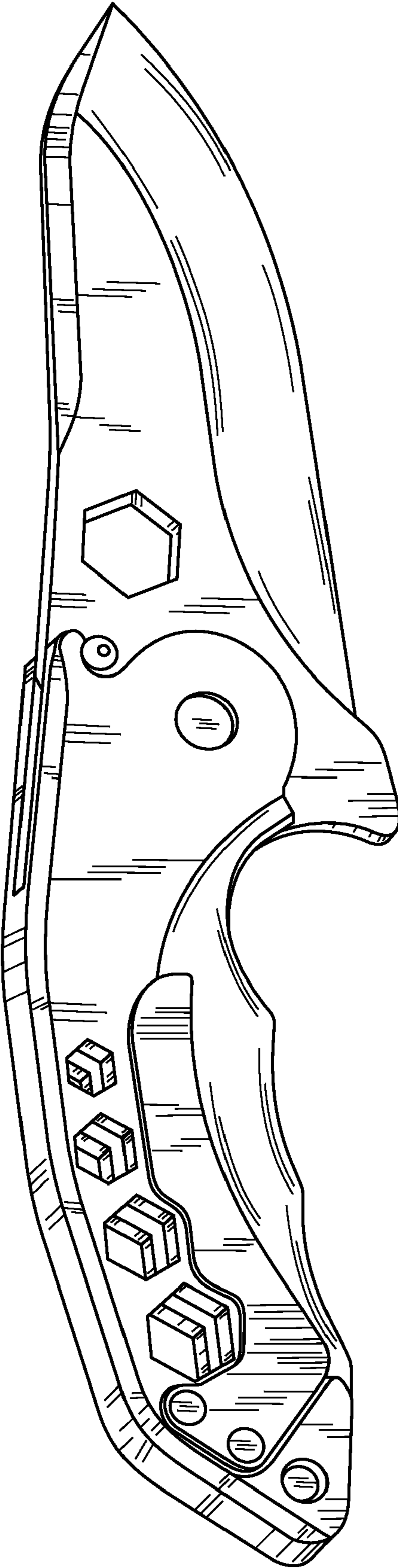

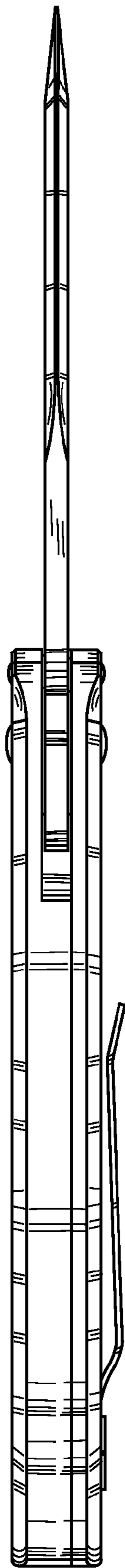

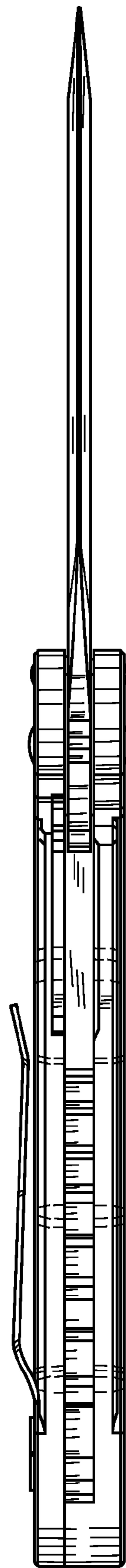

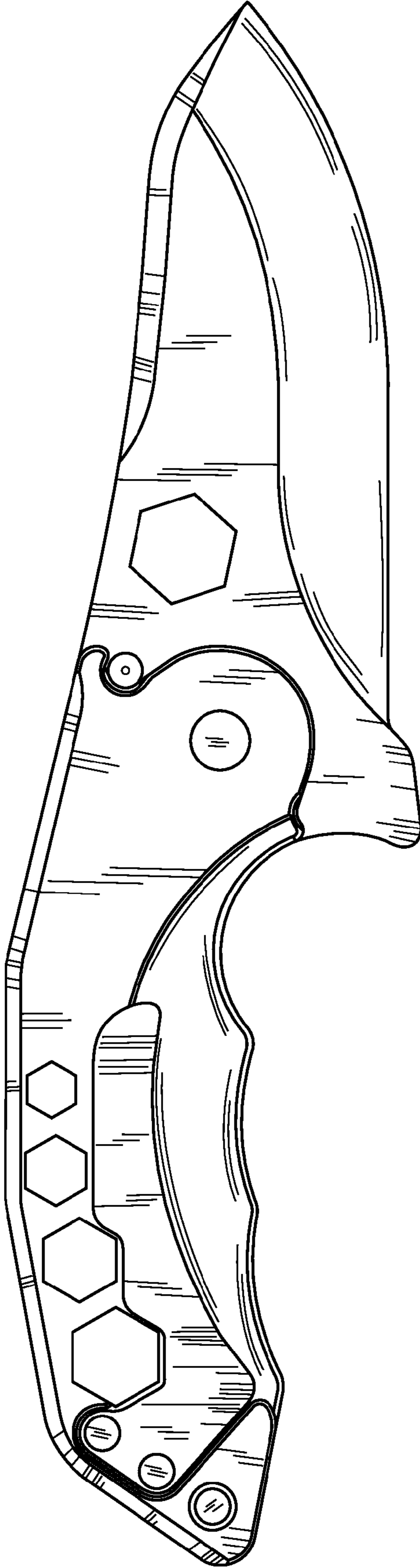

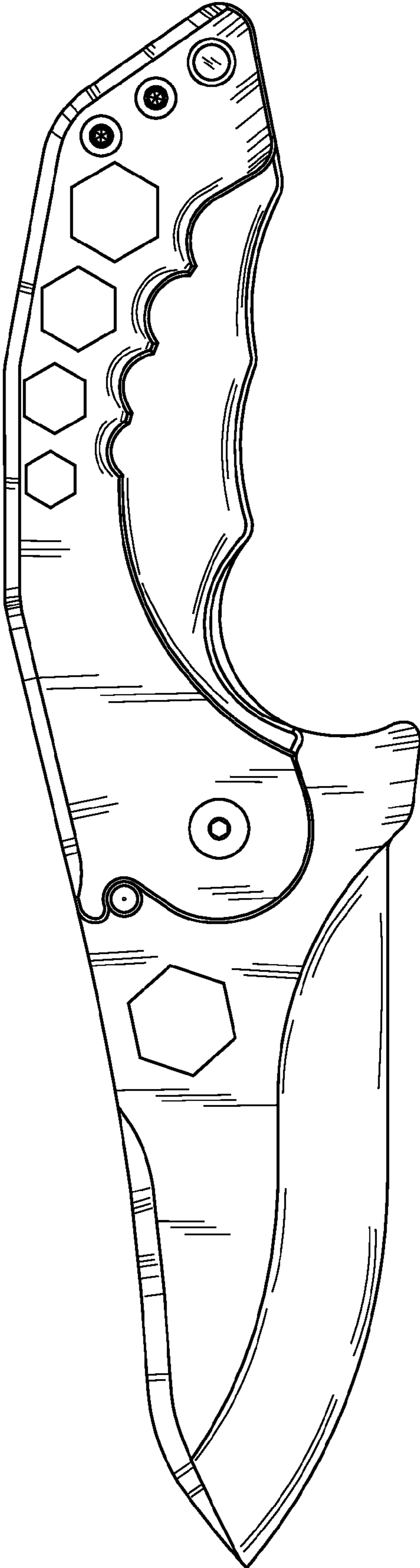

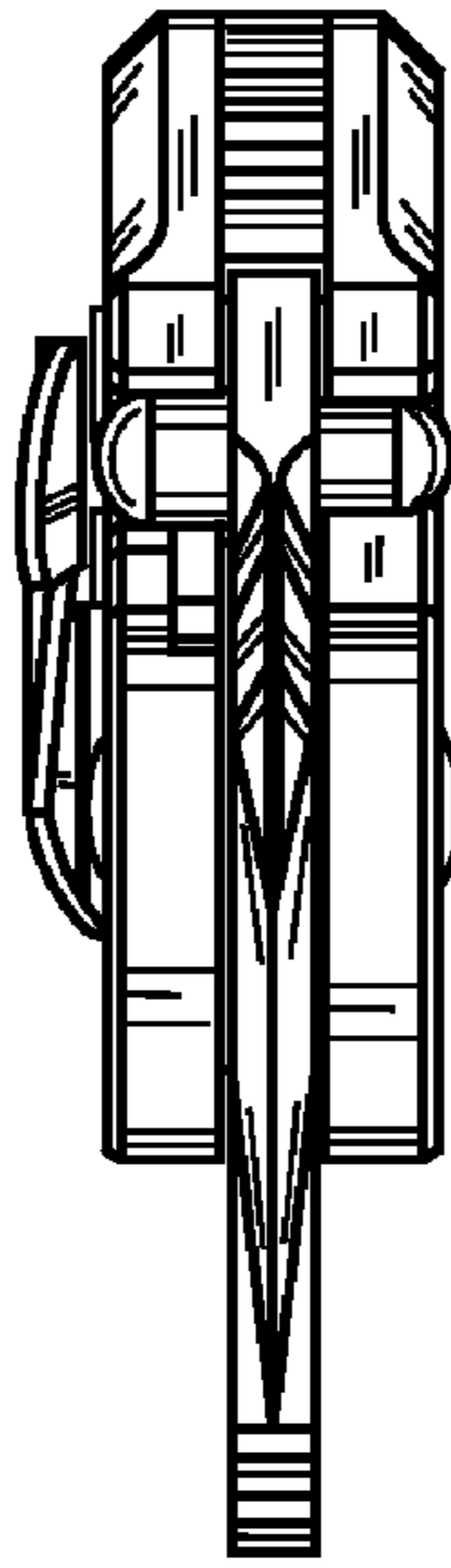

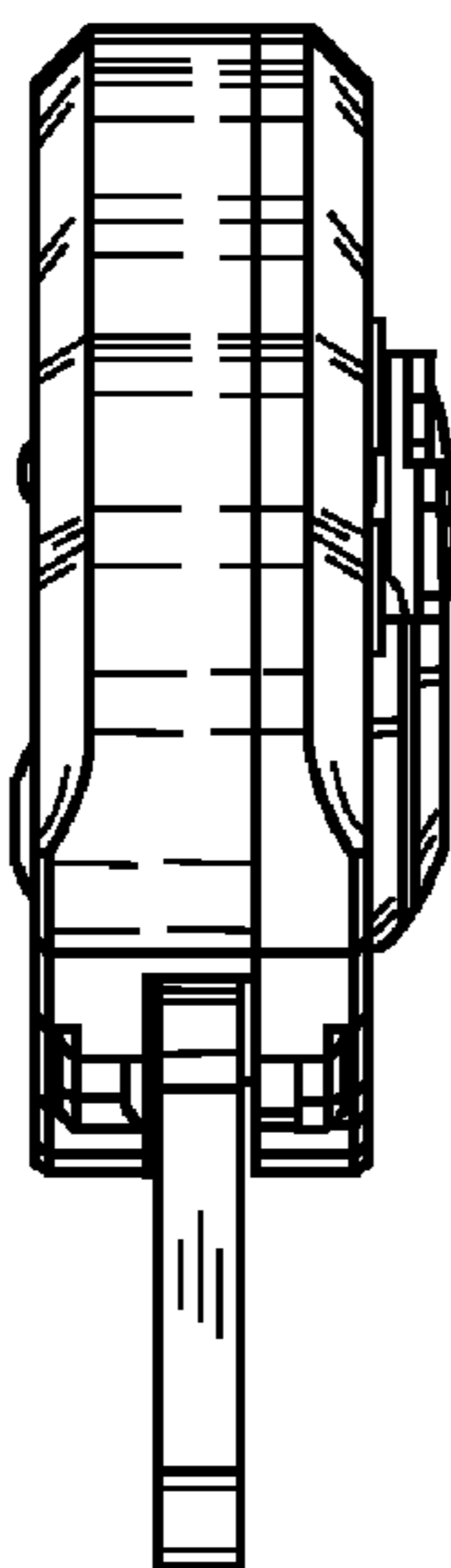

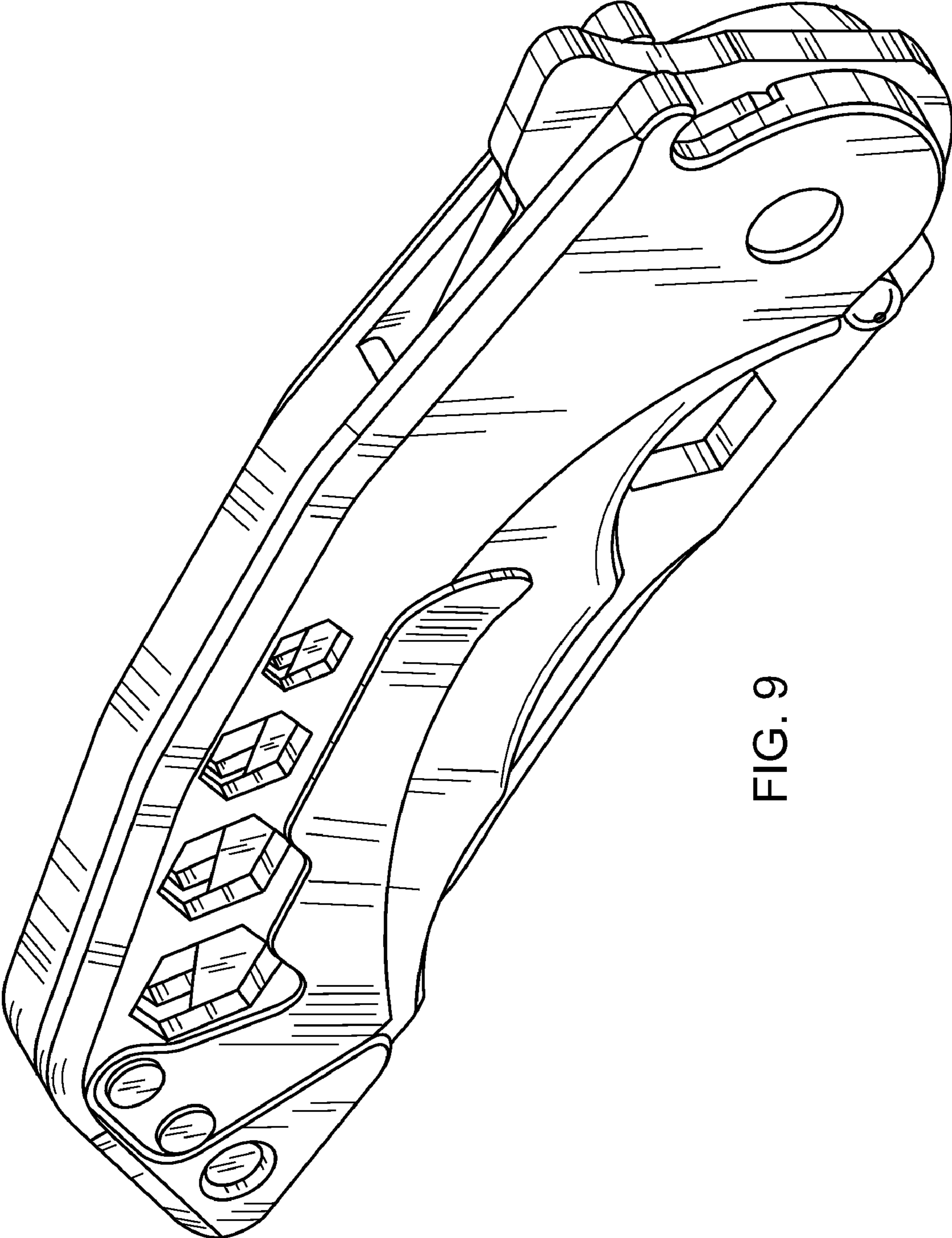

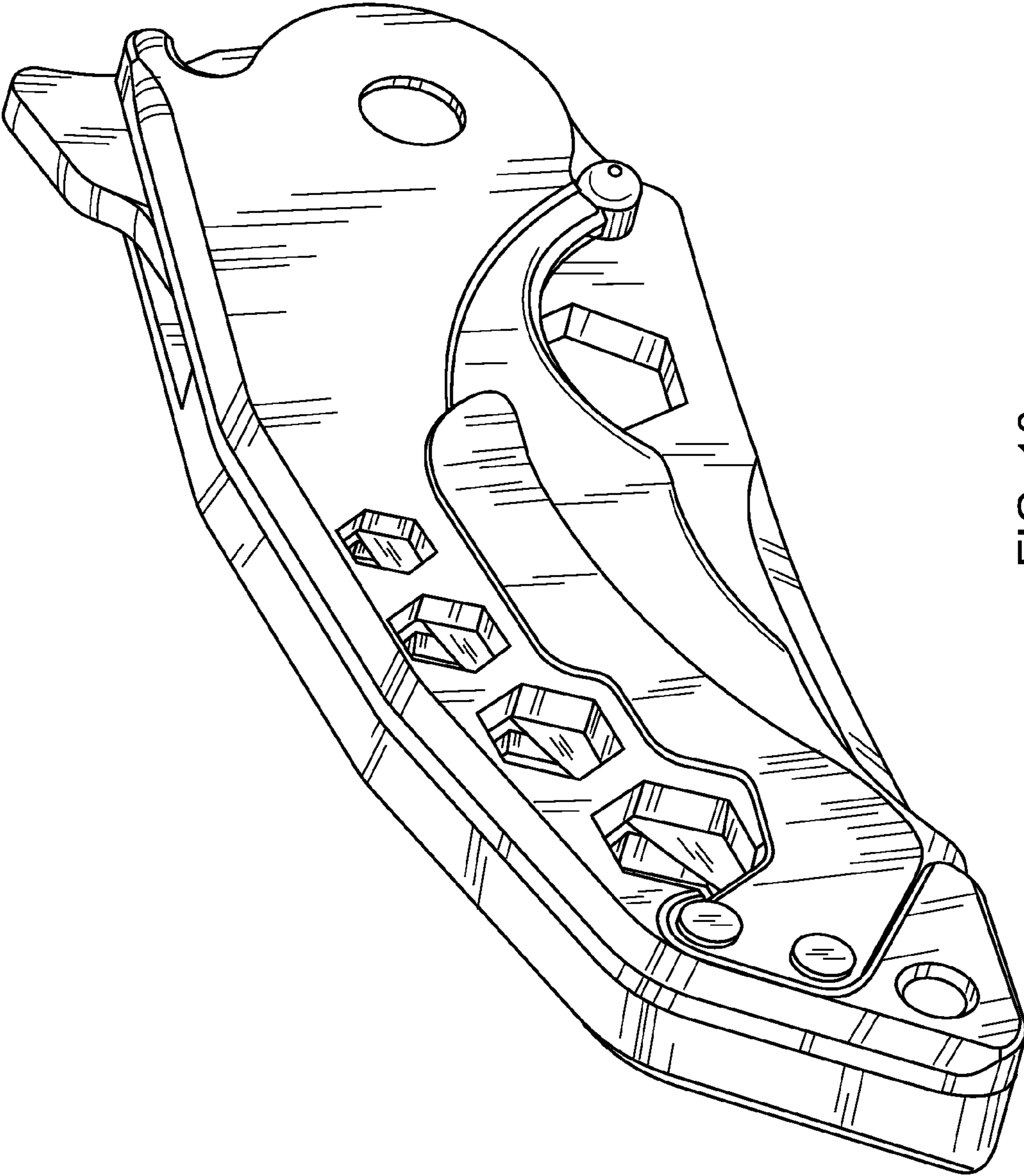

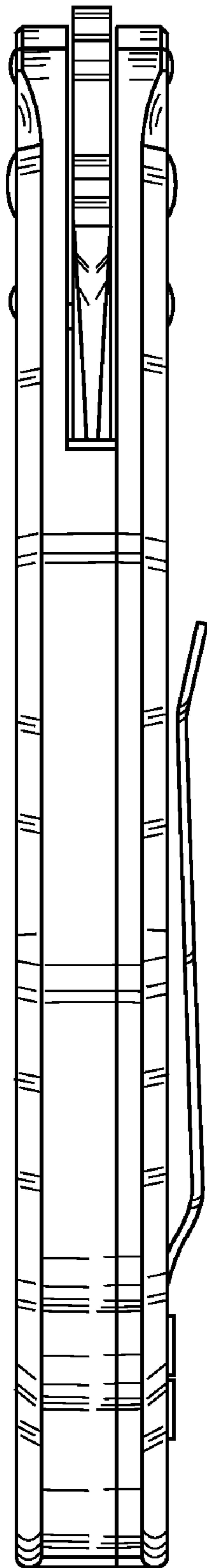

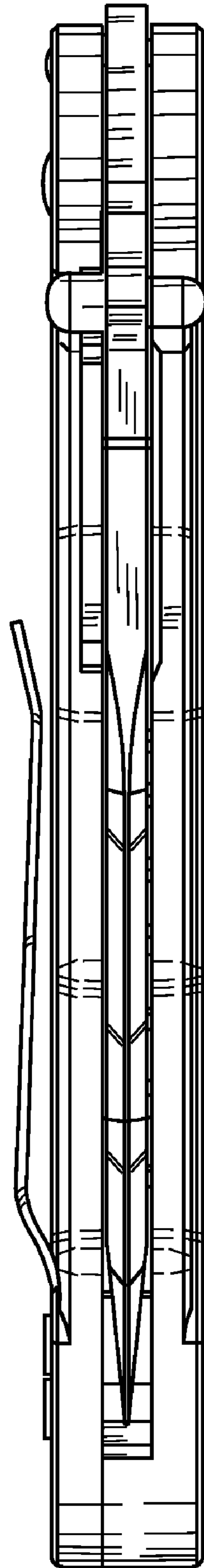

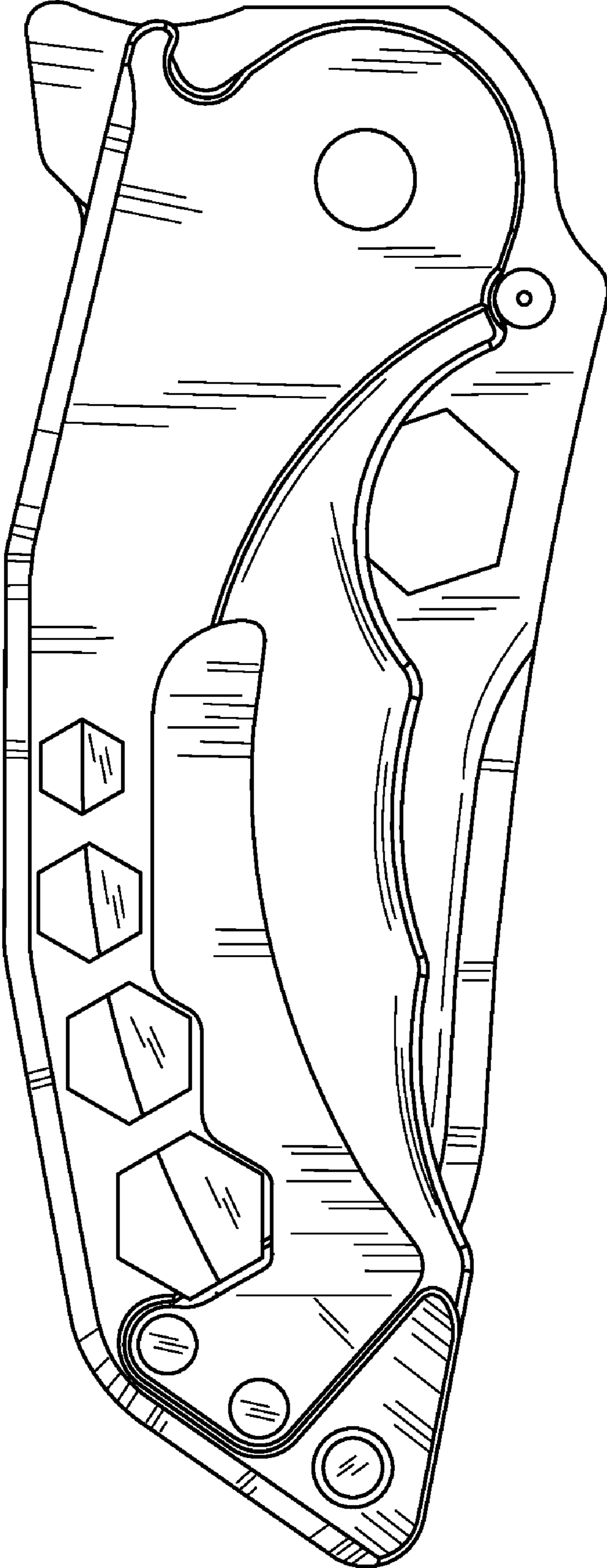

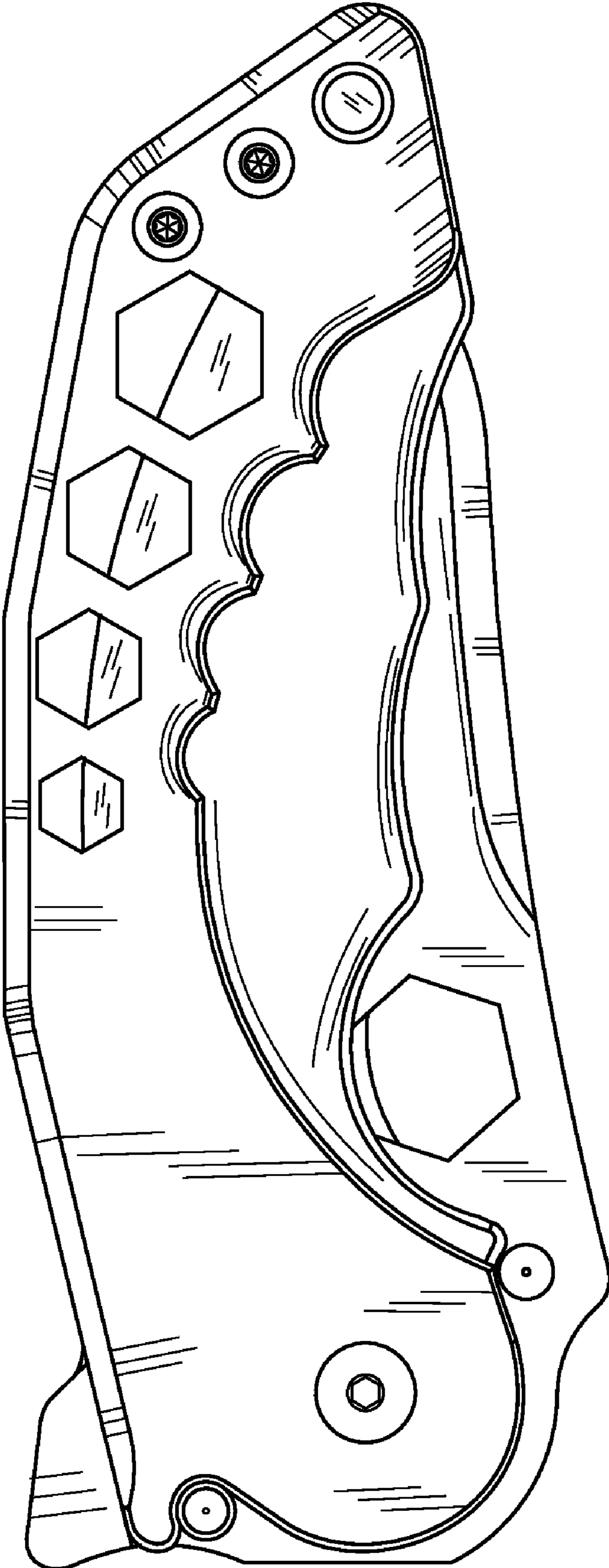

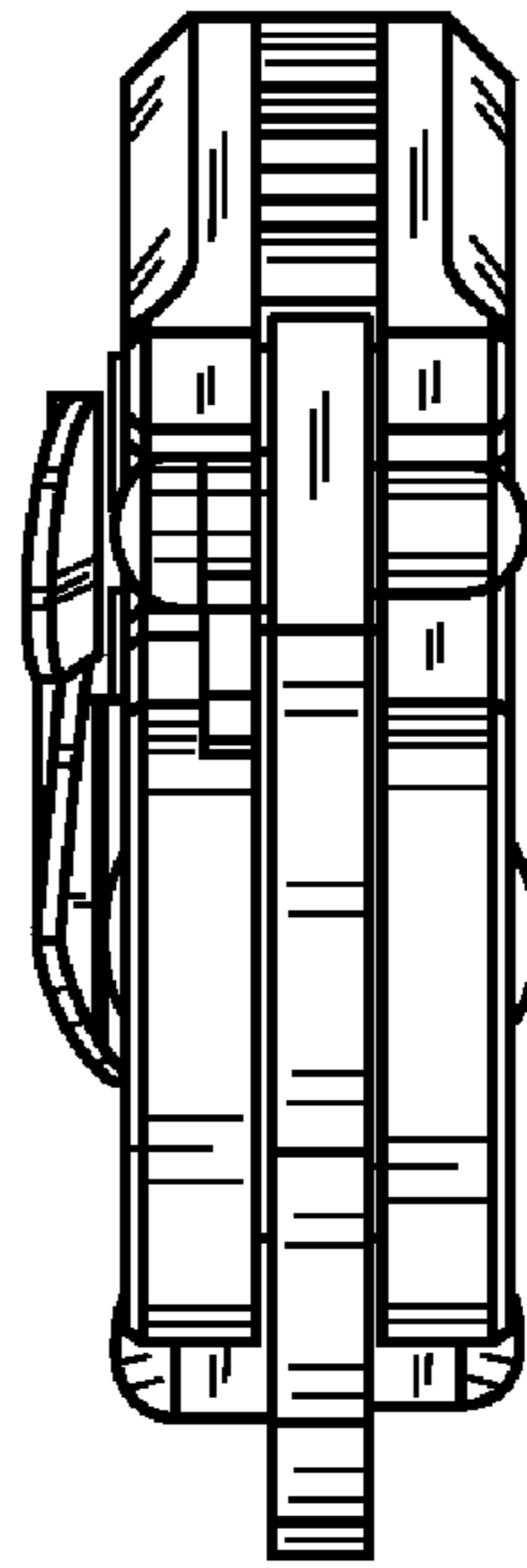

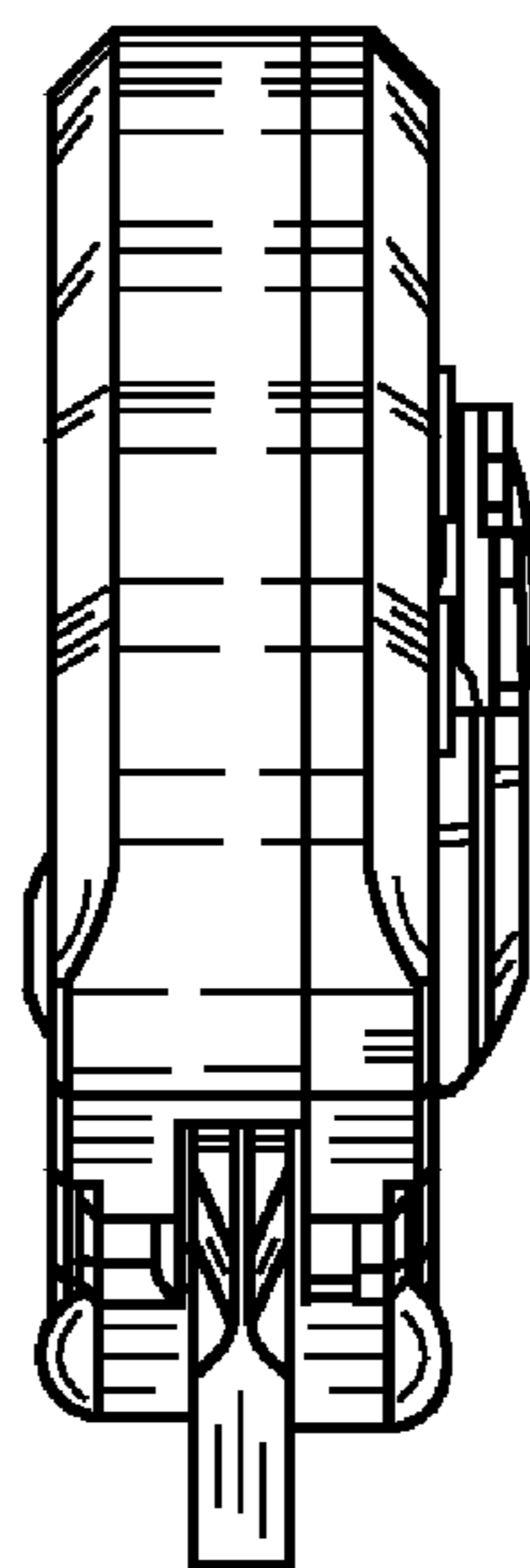
