(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a bottle showing our new design;

FIG. 2 is a right side elevation view thereof;

FIG. 3 is a left side elevation view thereof;

FIG. 4 is a rear elevation view thereof;

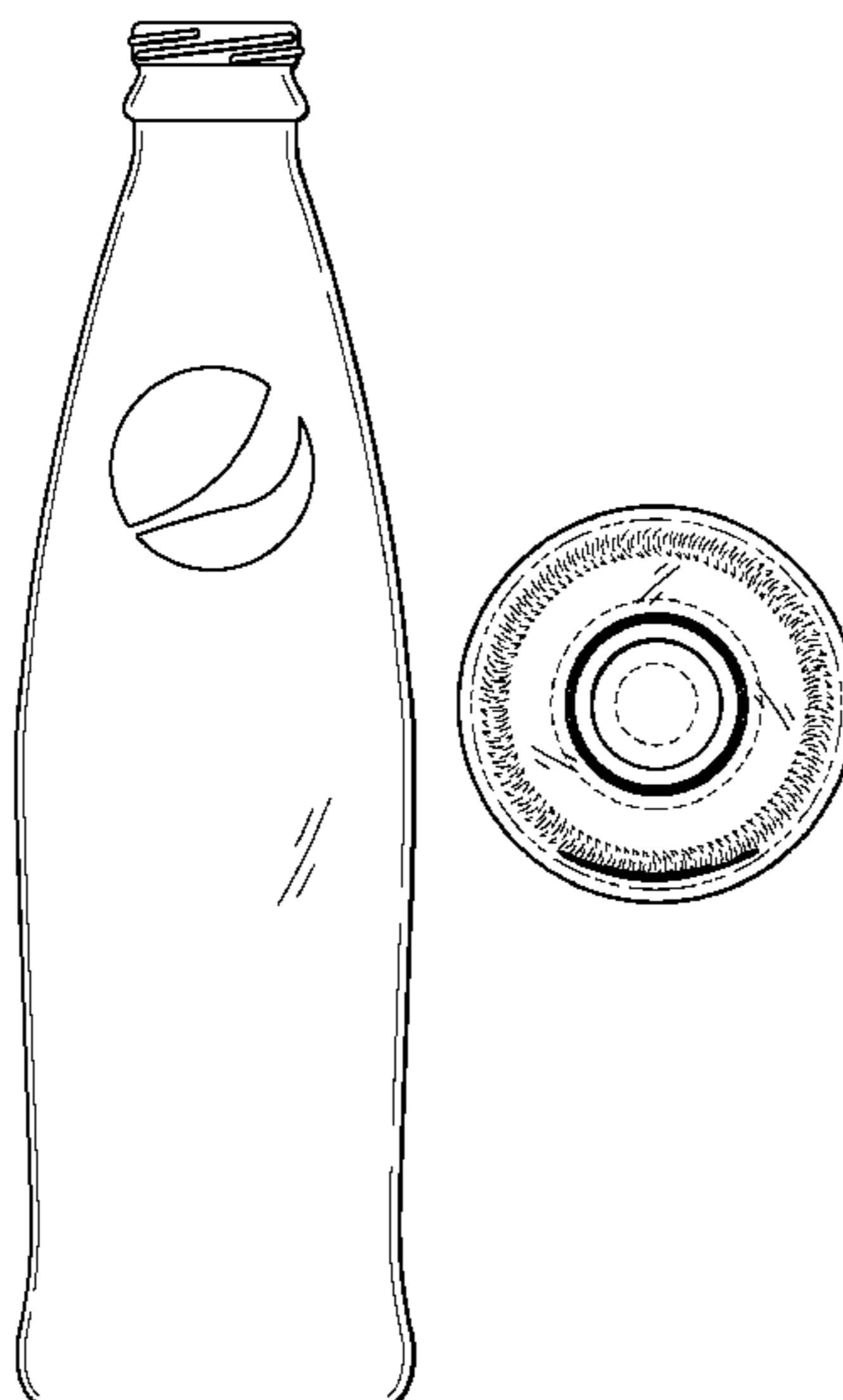
FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

The evenly dashed broken lines shown in FIG. 6 represents showing the bottom surface details of the bottle are for illustrative purposes only and form no part of the claimed design. The 'short dash-short dash-long dash' broken line shown in FIG. 6 represents the bounds of the claim and forms no part thereof.

The claimed surface ornamentation applied to the front surface of the bottle visible in FIGS. 1-5 is a registered trademark of PepsiCo, Inc.

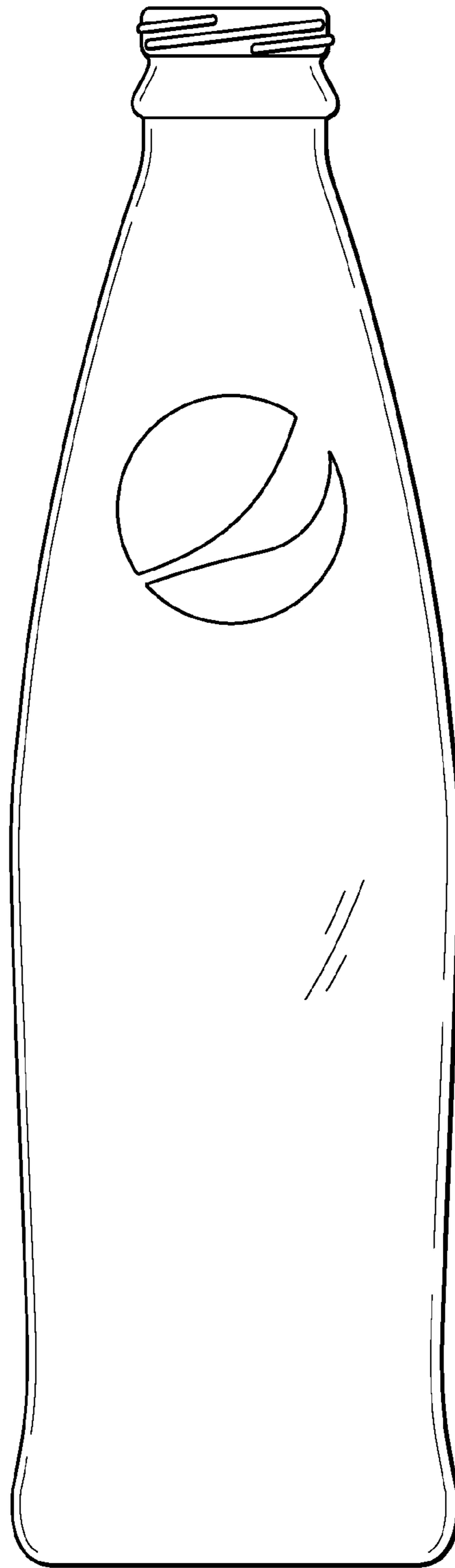

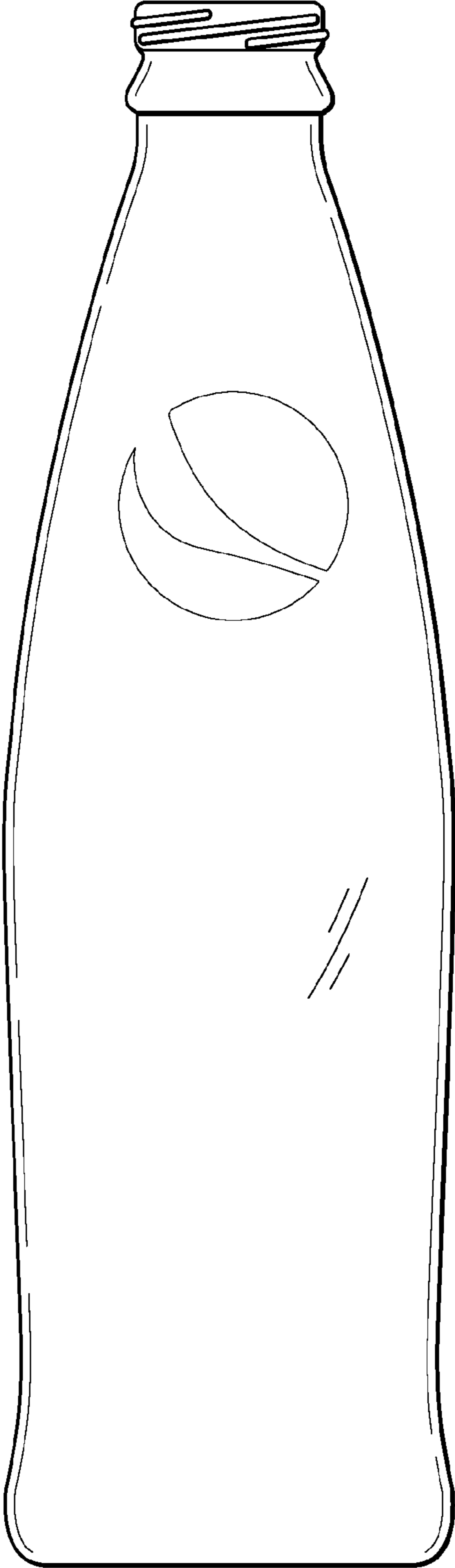

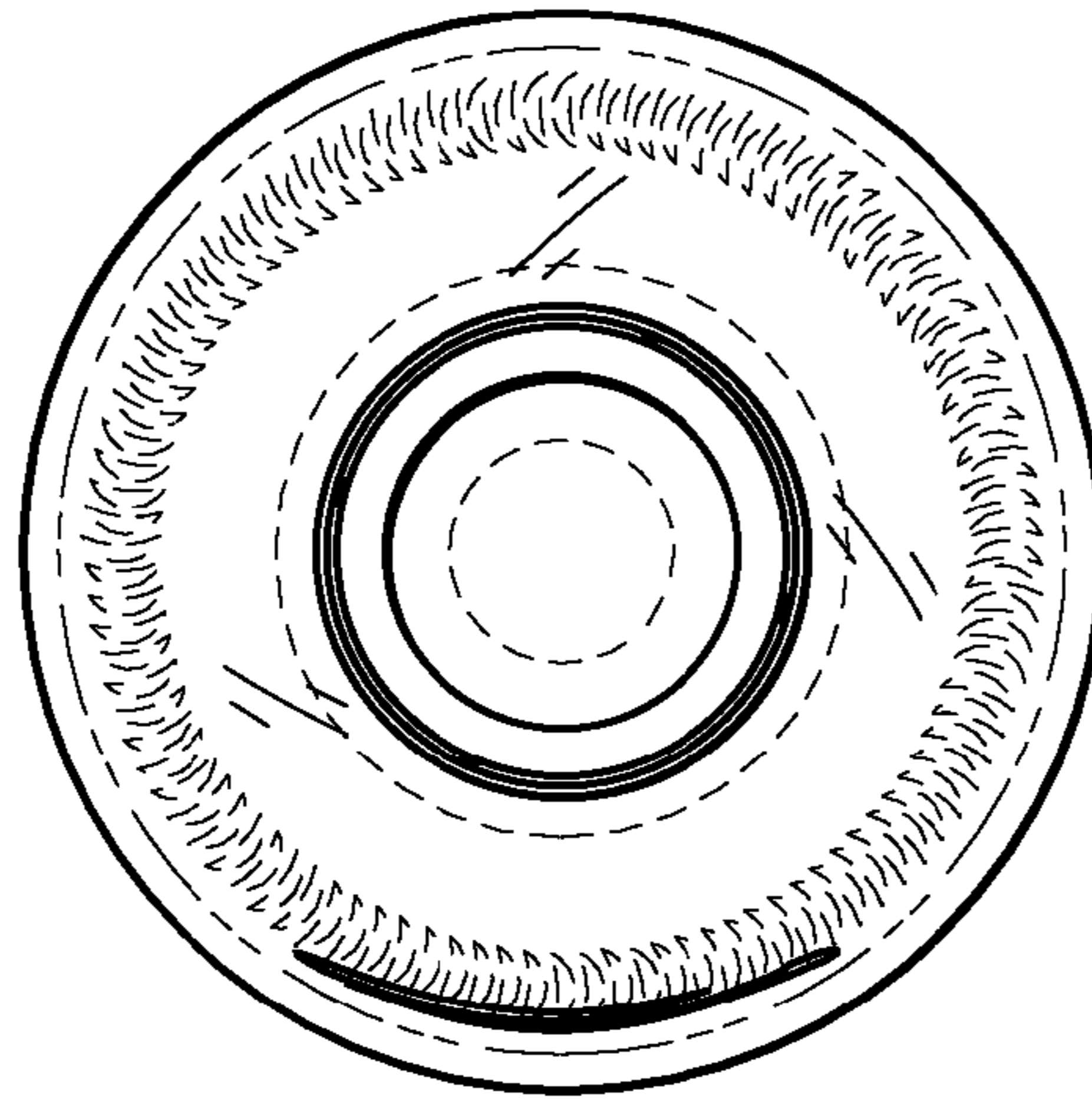
