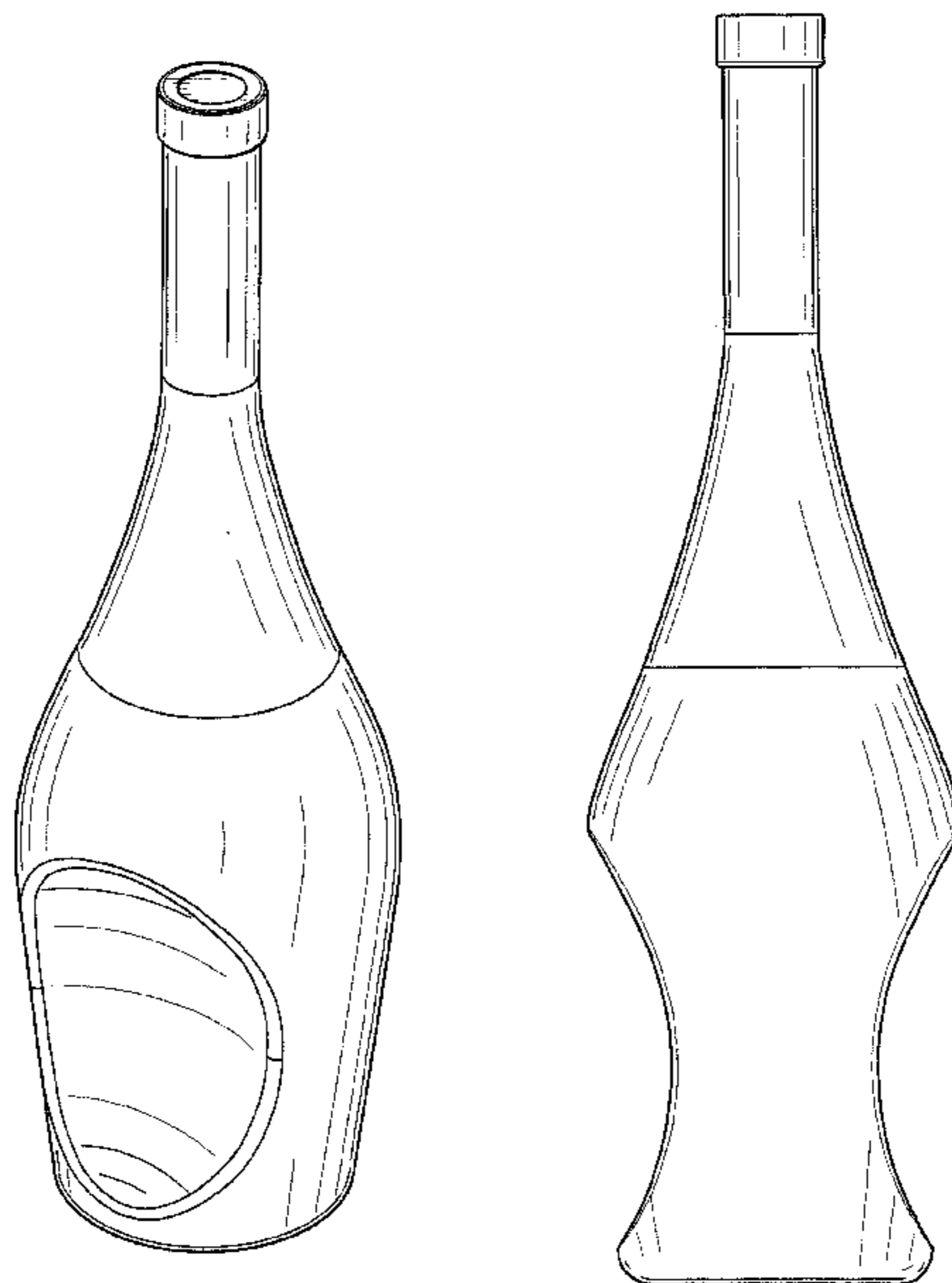
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a bottle showing my new design, the rear elevation being identical;

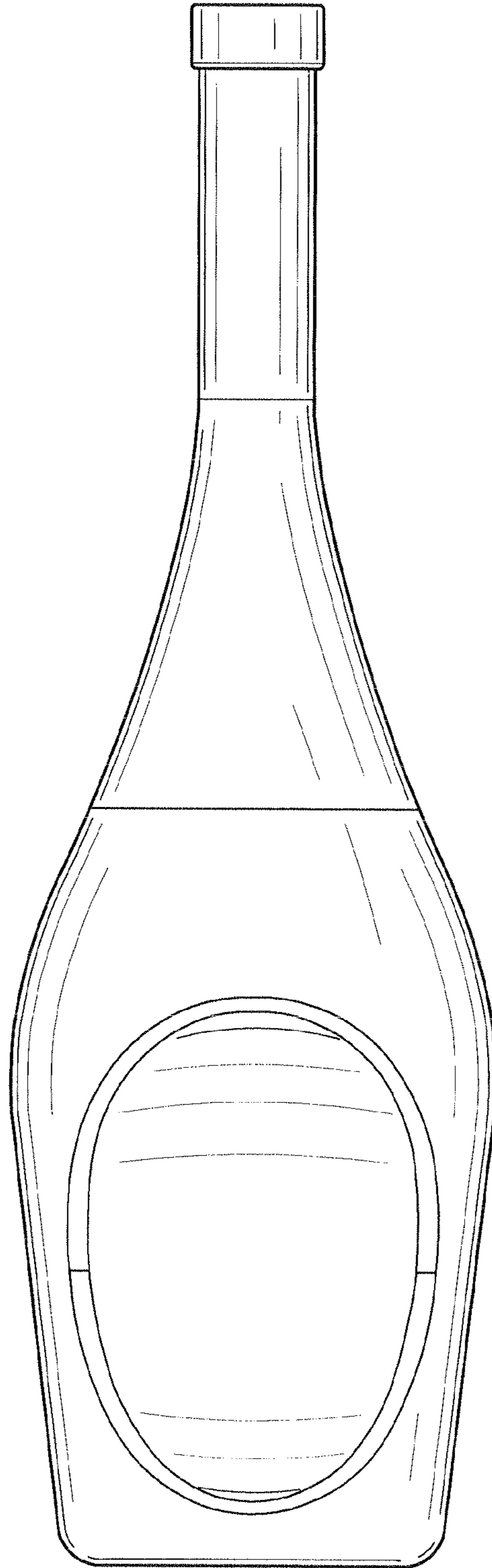

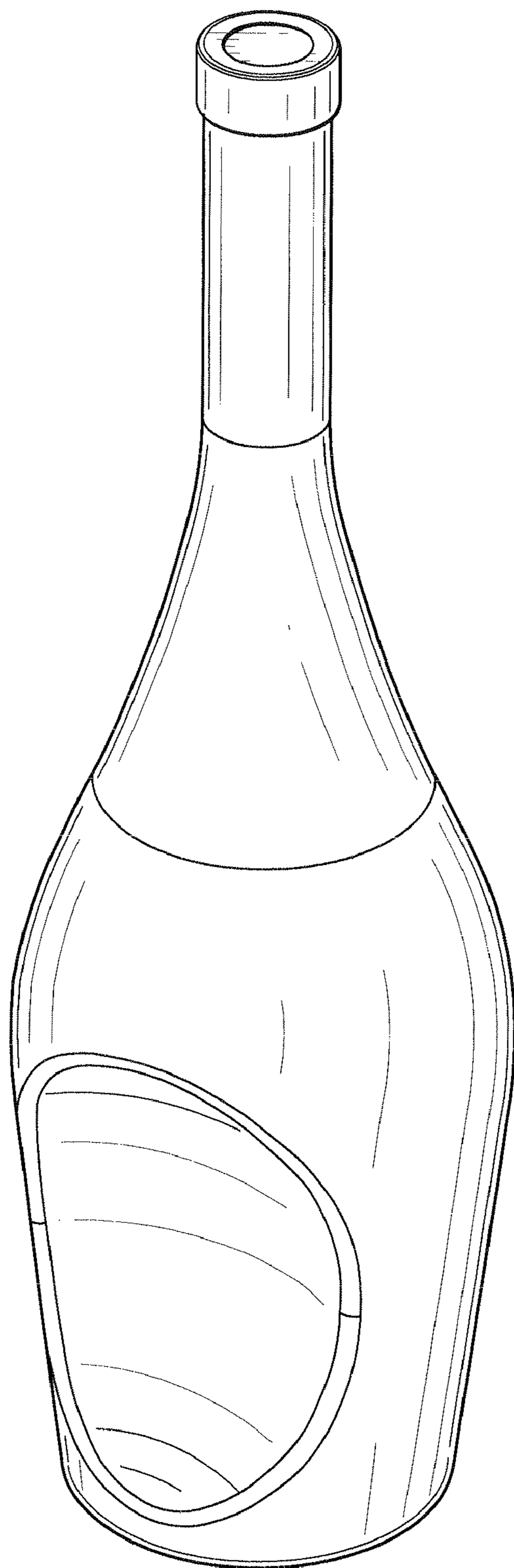

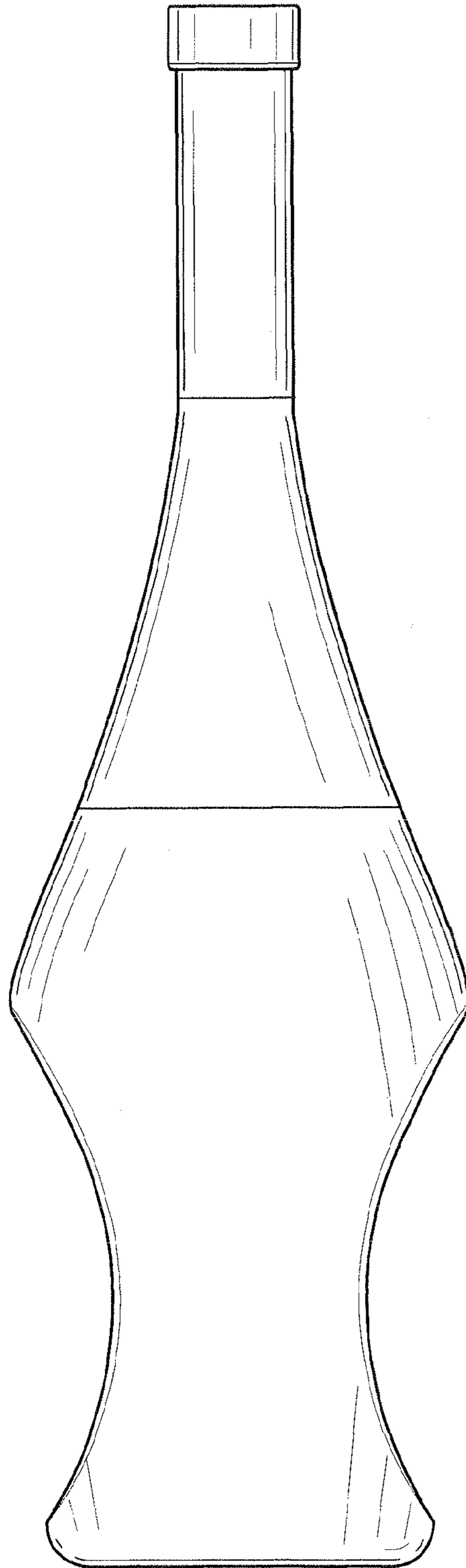

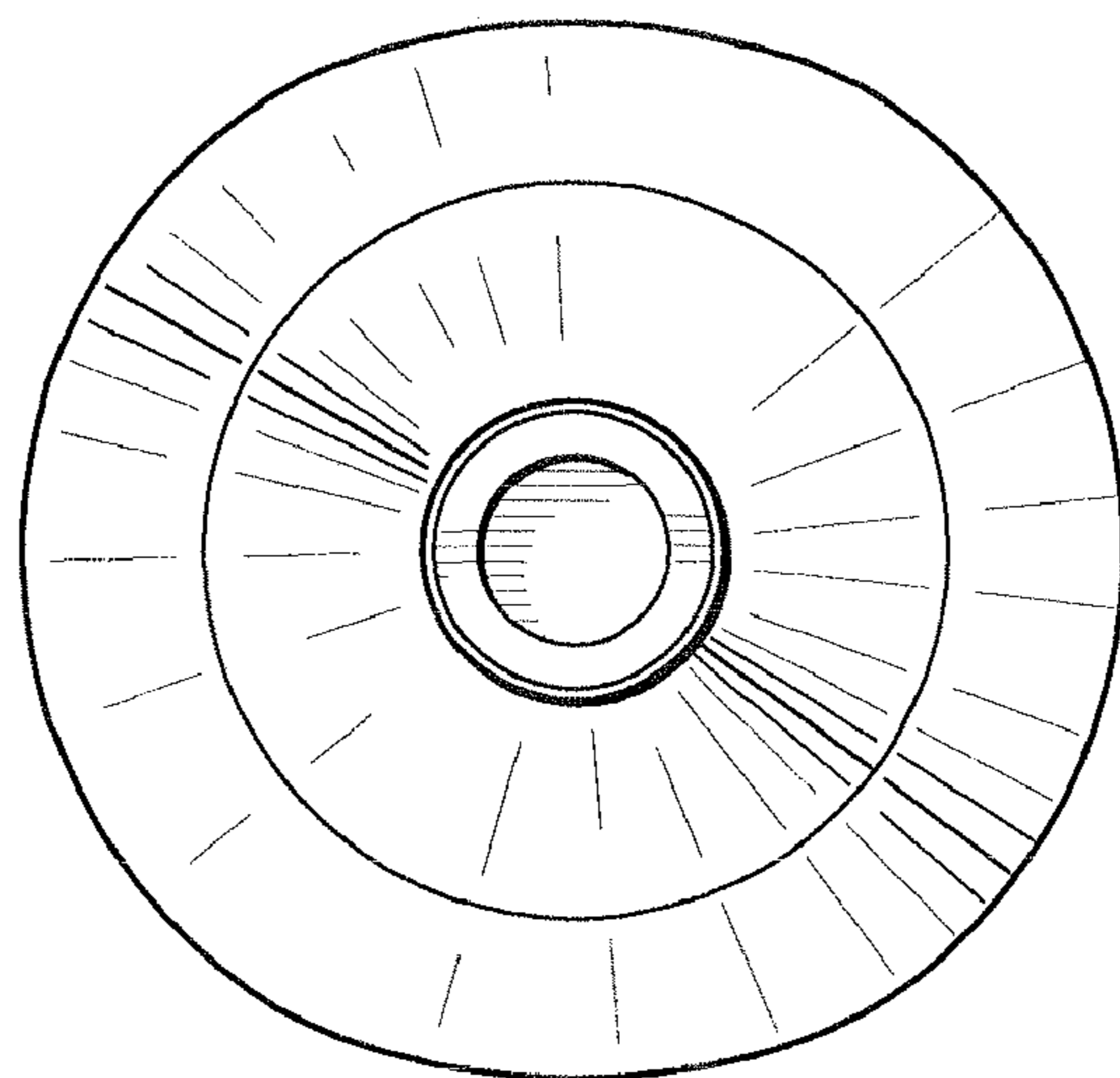

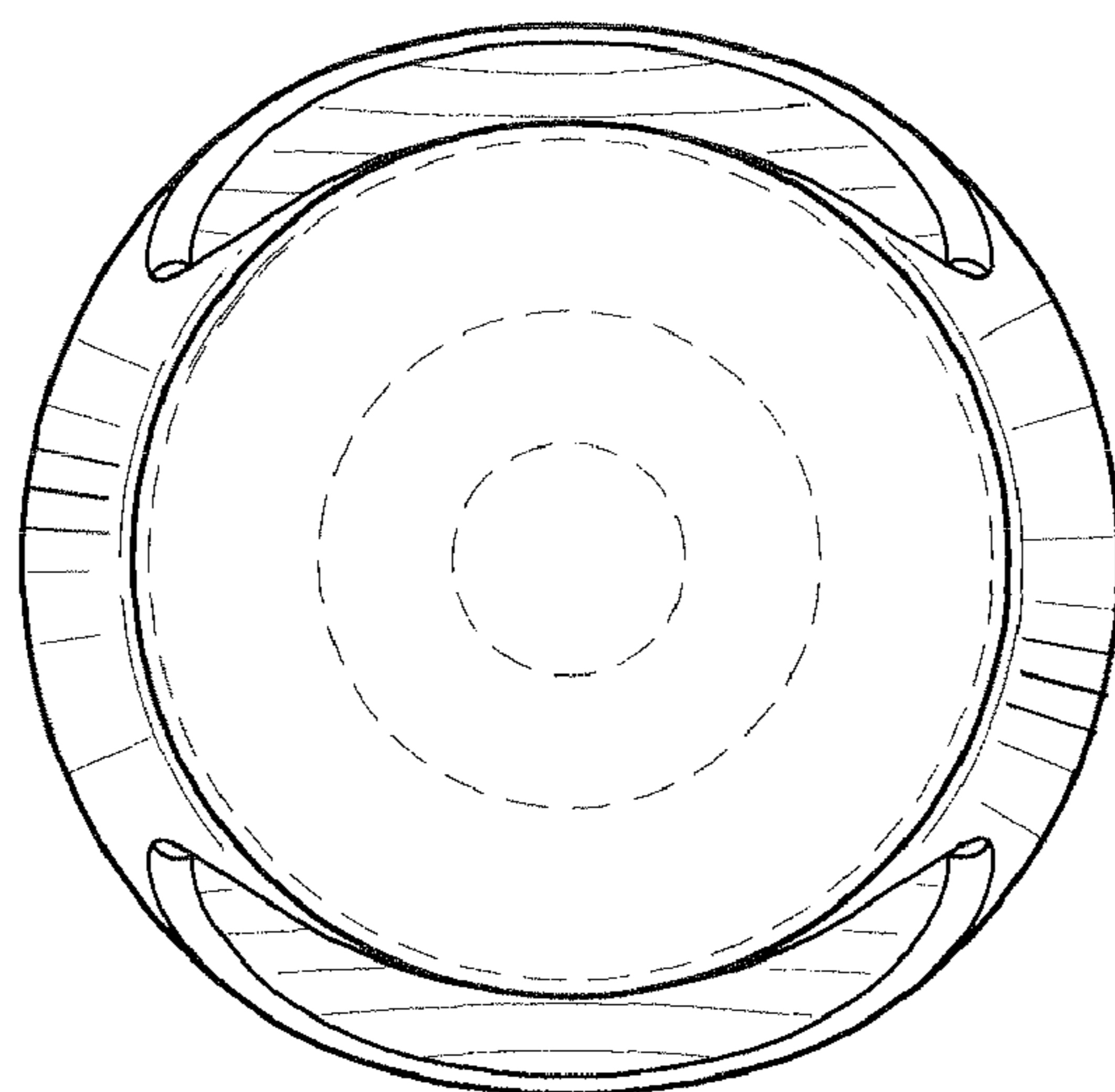
