(57) **CLAIM**

The ornamental design for a flexible laptop display slipcover having a transparent front panel and an advertising back panel, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a flexible laptop display slipcover having a transparent front panel and an advertising back panel, illustrating the new, original, and ornamental design;

FIG. 2 is a front planar view of the flexible laptop display slipcover having a transparent front panel and an advertising back panel, illustrating the new, original, and ornamental design of the transparent front panel on the front side;

FIG. 3 is a rear planar view of the flexible laptop display slipcover having a transparent front panel and an advertising back panel, illustrating the new, original, and ornamental design of the advertising panel on the rear side;

FIG. 4 is a top planar view of the flexible laptop display slipcover having a transparent front panel and an advertising back panel, illustrating the new, original, and ornamental design;

FIG. 5 is a bottom planar view of the flexible laptop display slipcover having a transparent front panel and an advertising back panel, illustrating the new, original, and ornamental design;

FIG. 6 is a left side planar view of the flexible laptop display slipcover having a transparent front panel and an advertising back panel, illustrating the new, original, and ornamental design;

FIG. 7 is a right side planar view of the flexible laptop display slipcover having a transparent front panel and an advertising back panel, illustrating the new, original, and ornamental design;

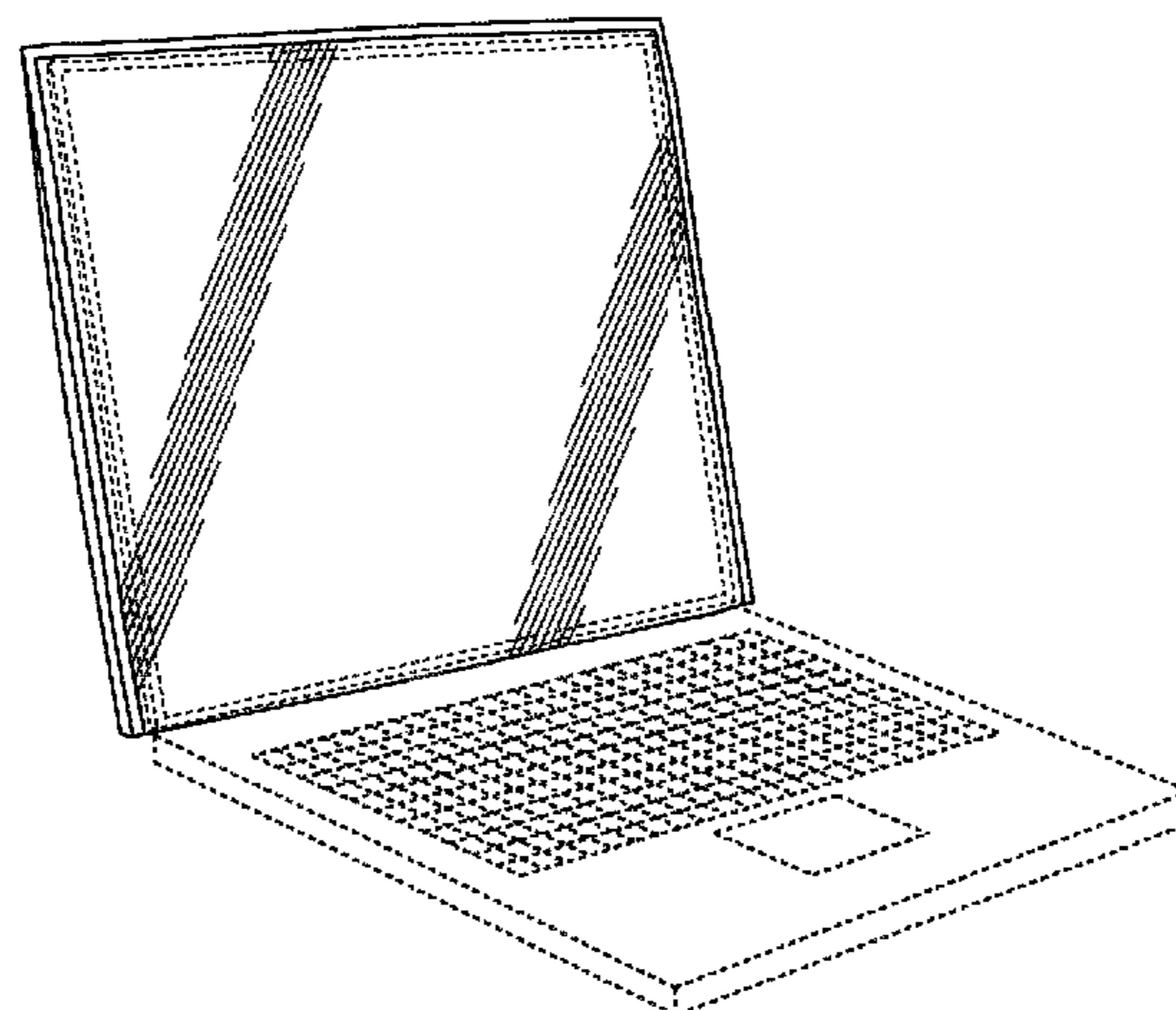
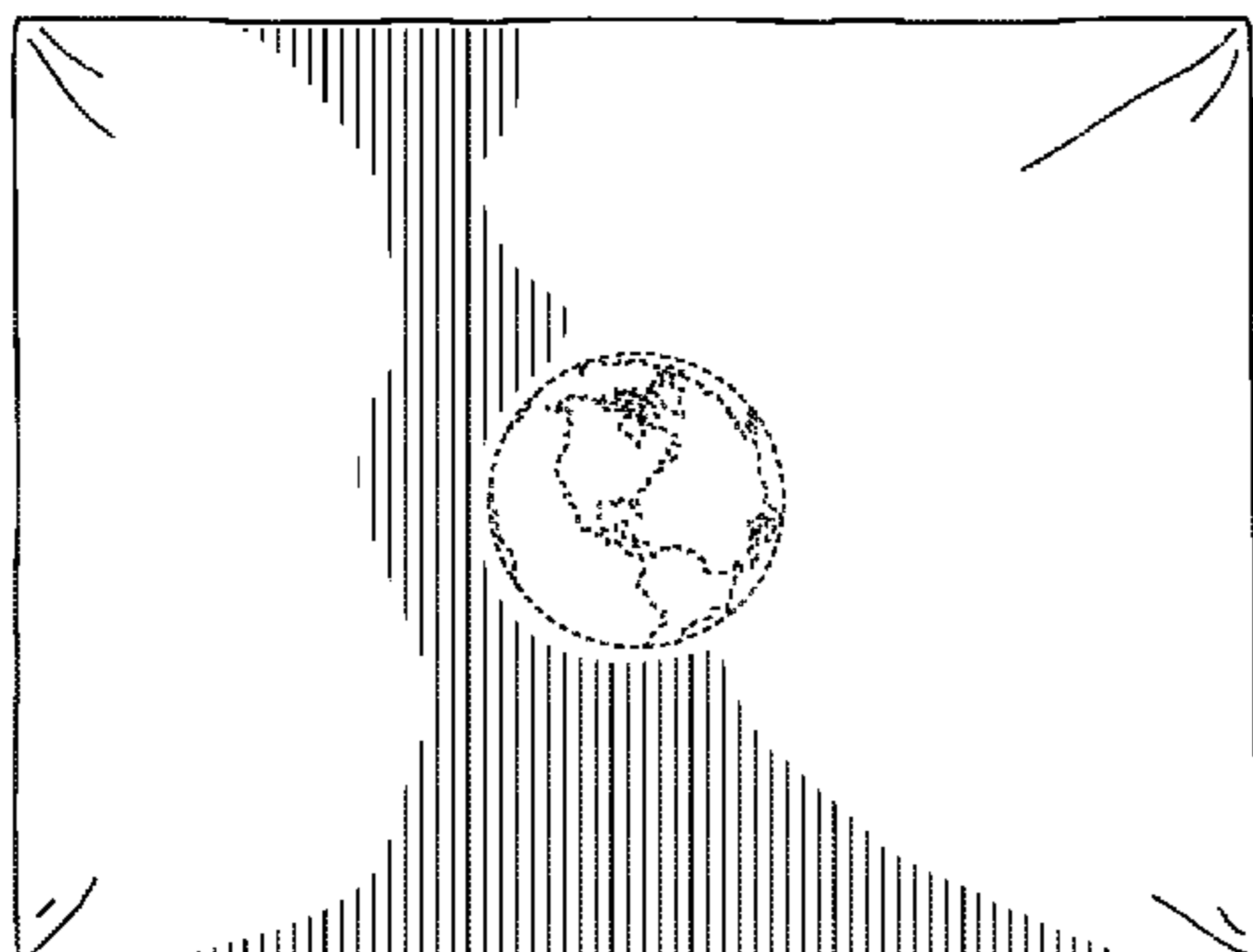

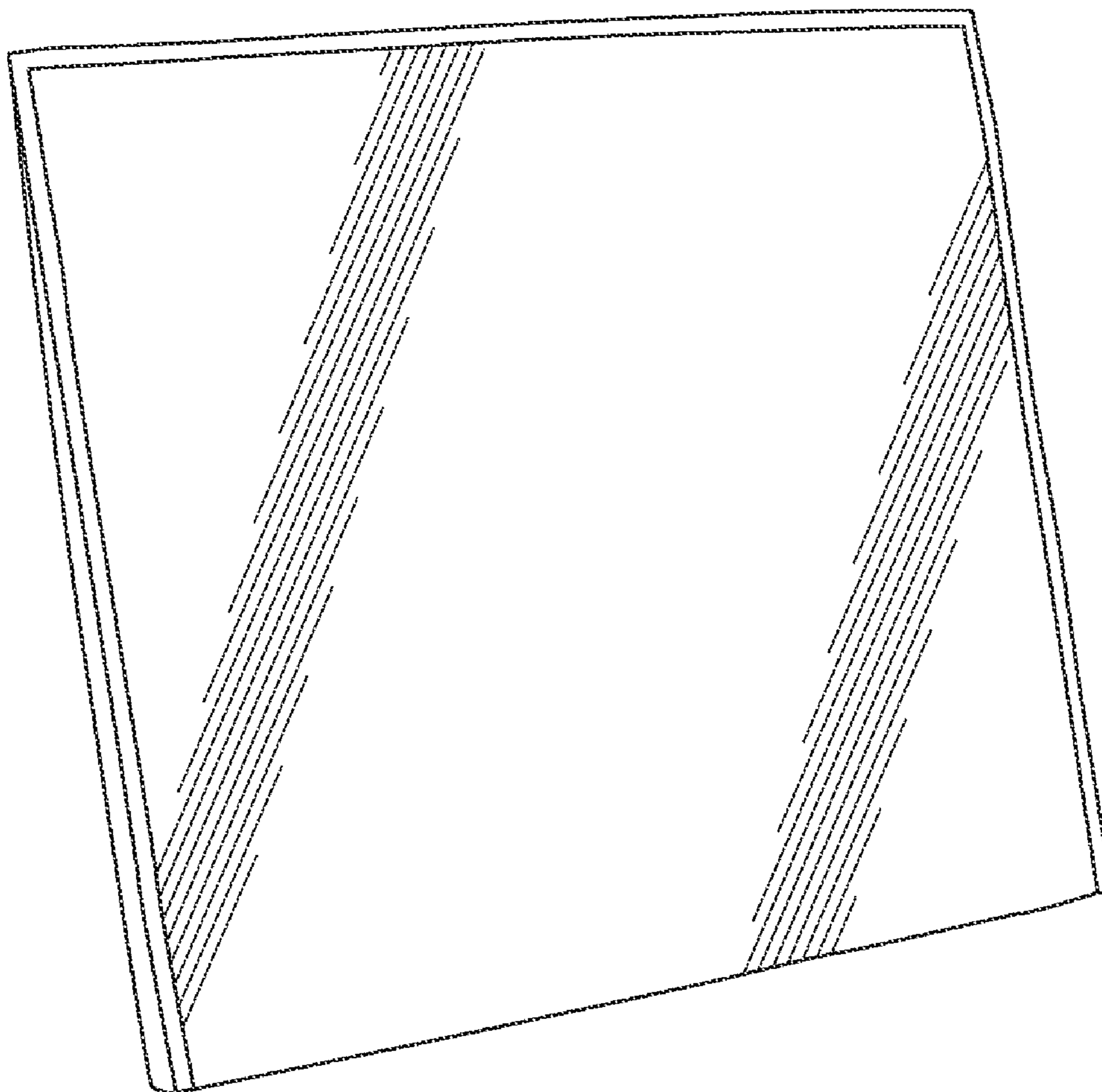

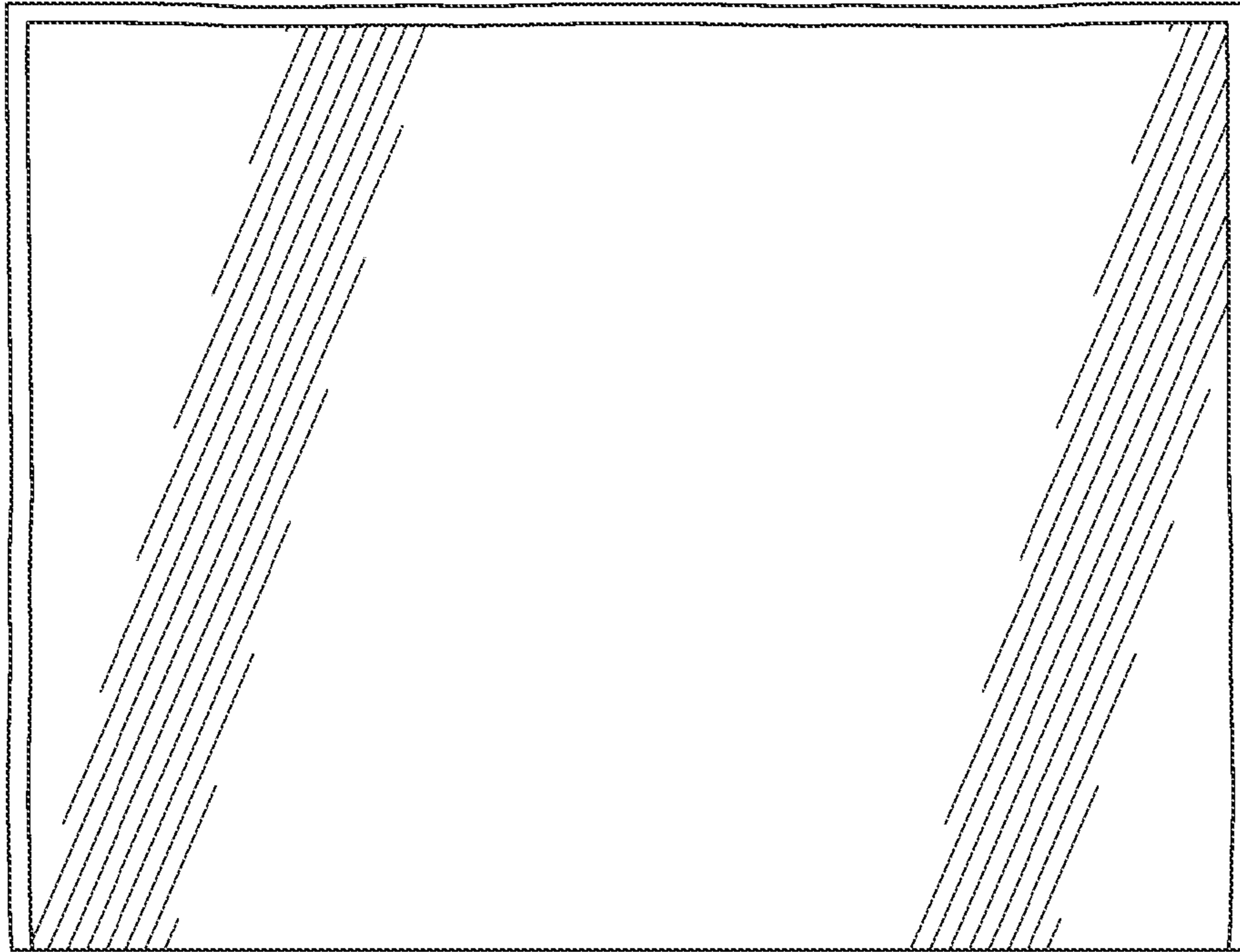

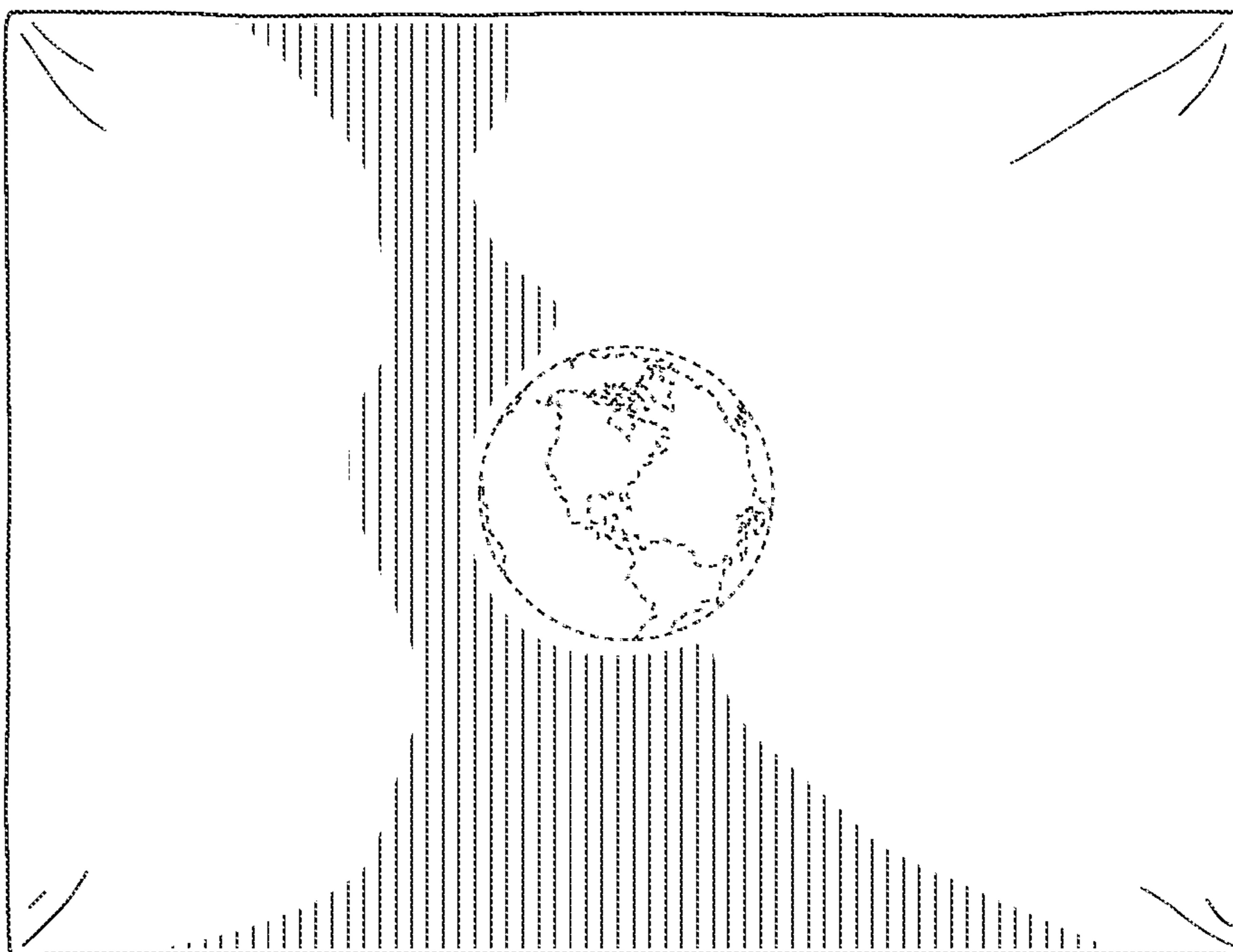
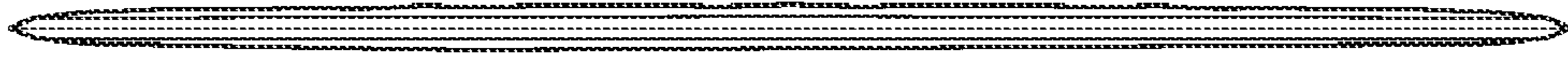

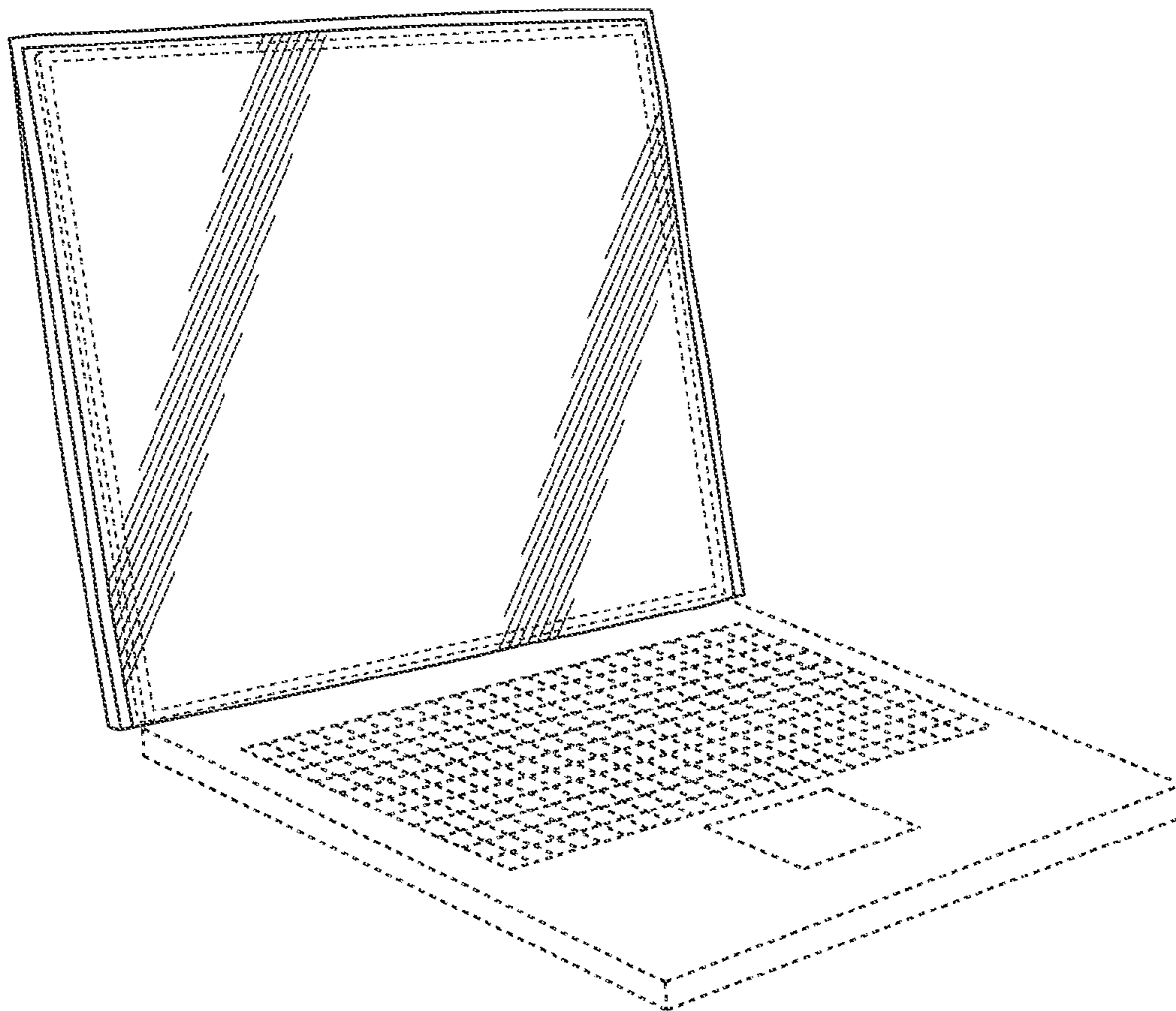
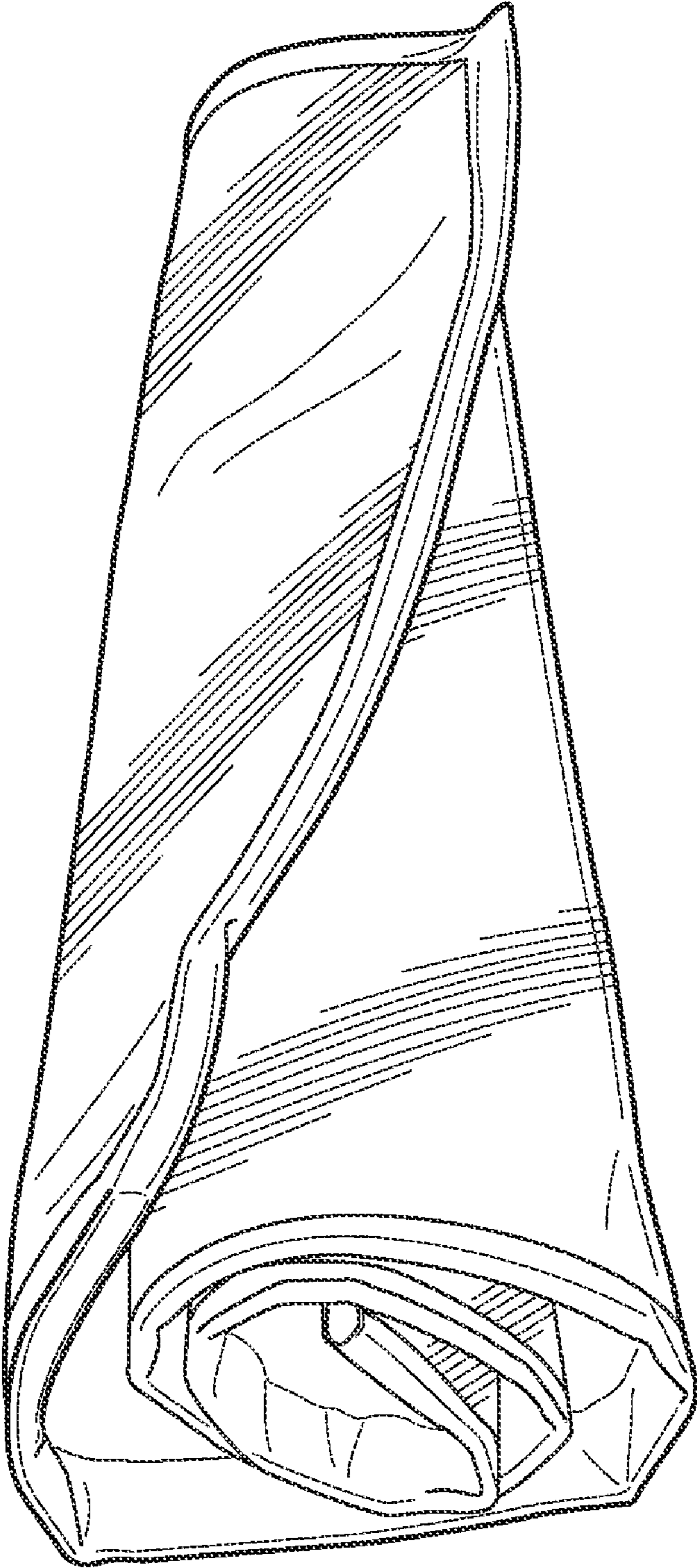
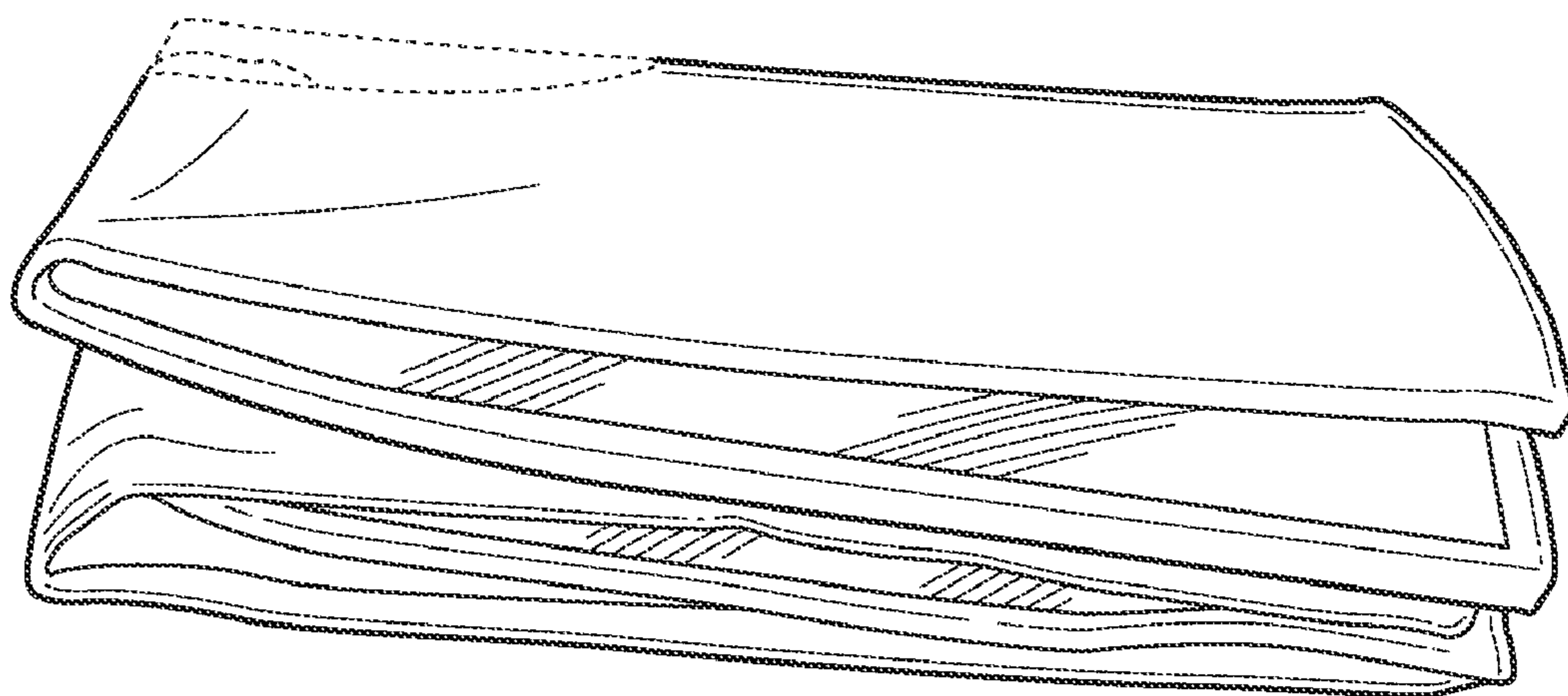
