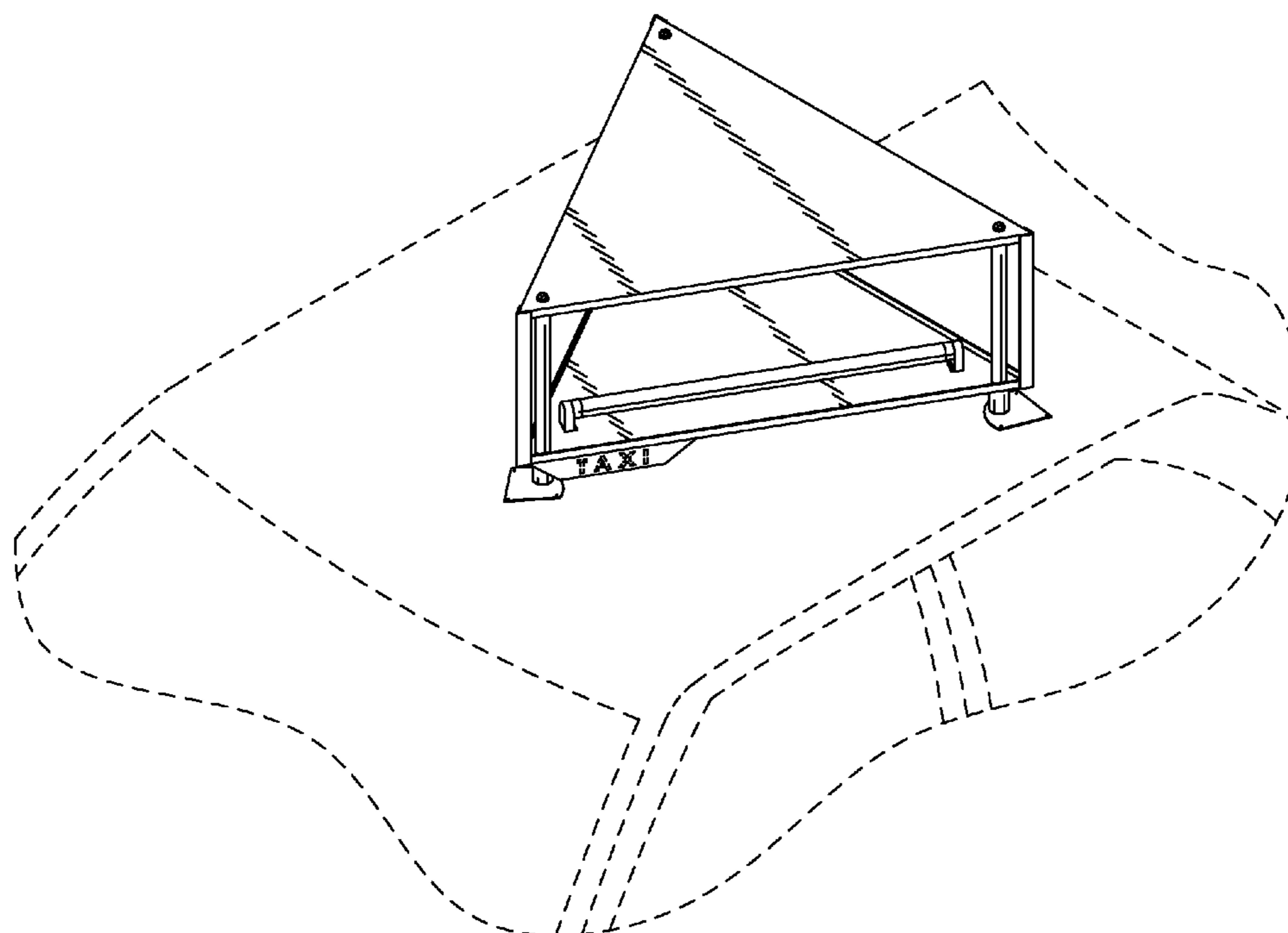
(57) **CLAIM**

What is claimed is the ornamental design for a advertising display sign, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a advertising display sign, showing the new design in use;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines showing a roof of a car in FIG. 1 and the word taxi are included for the purpose of illustrating the invention in use, and form no part of the claimed design.

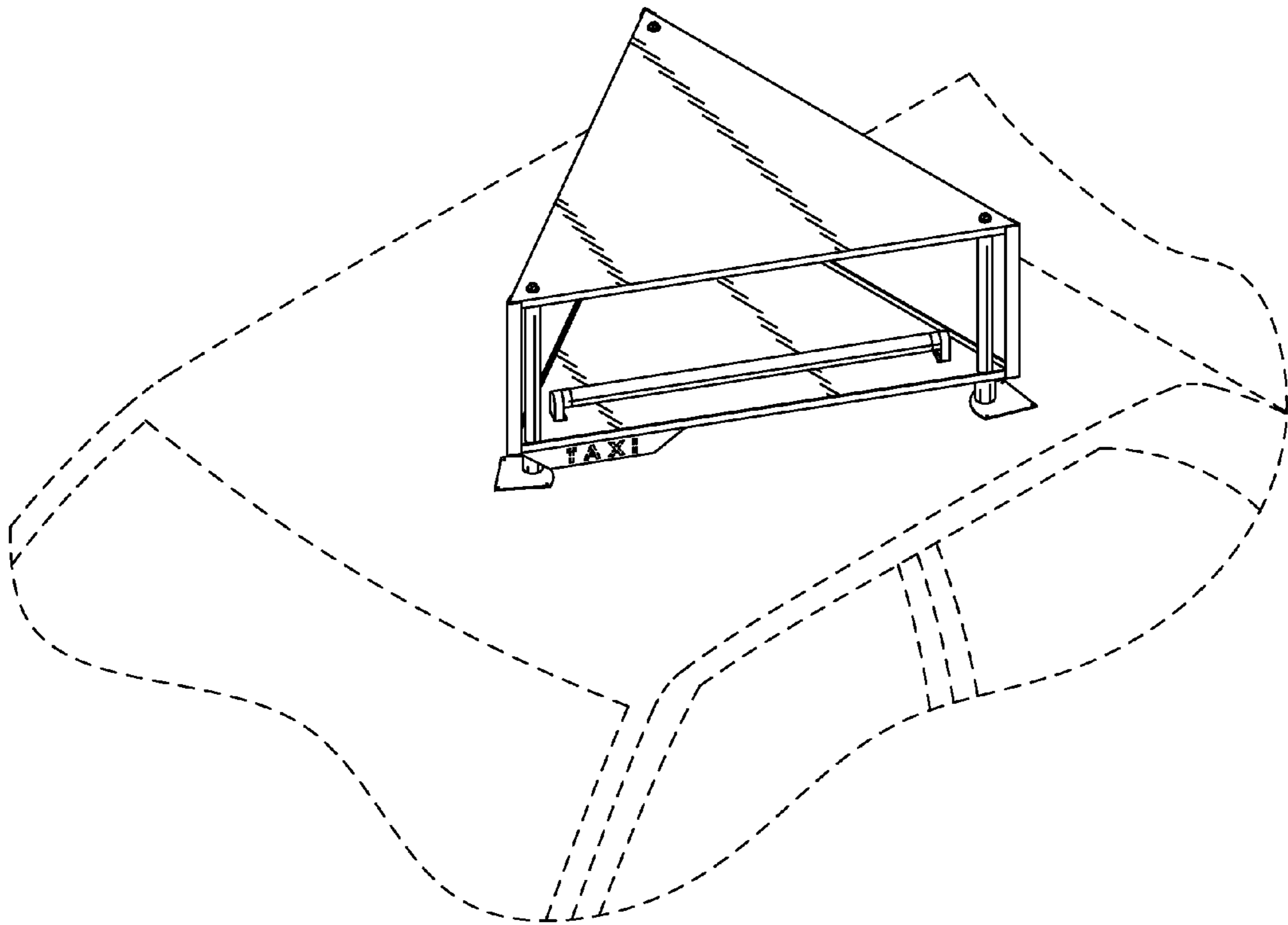

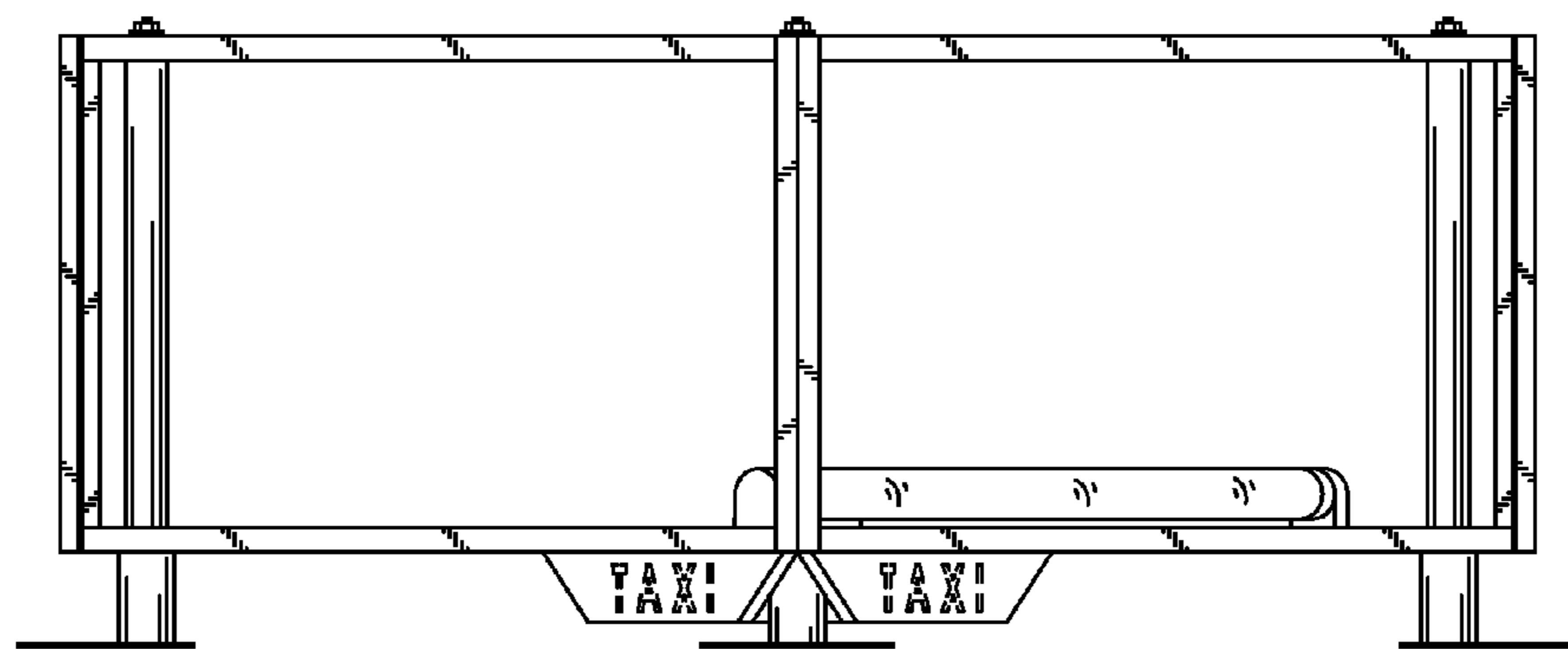

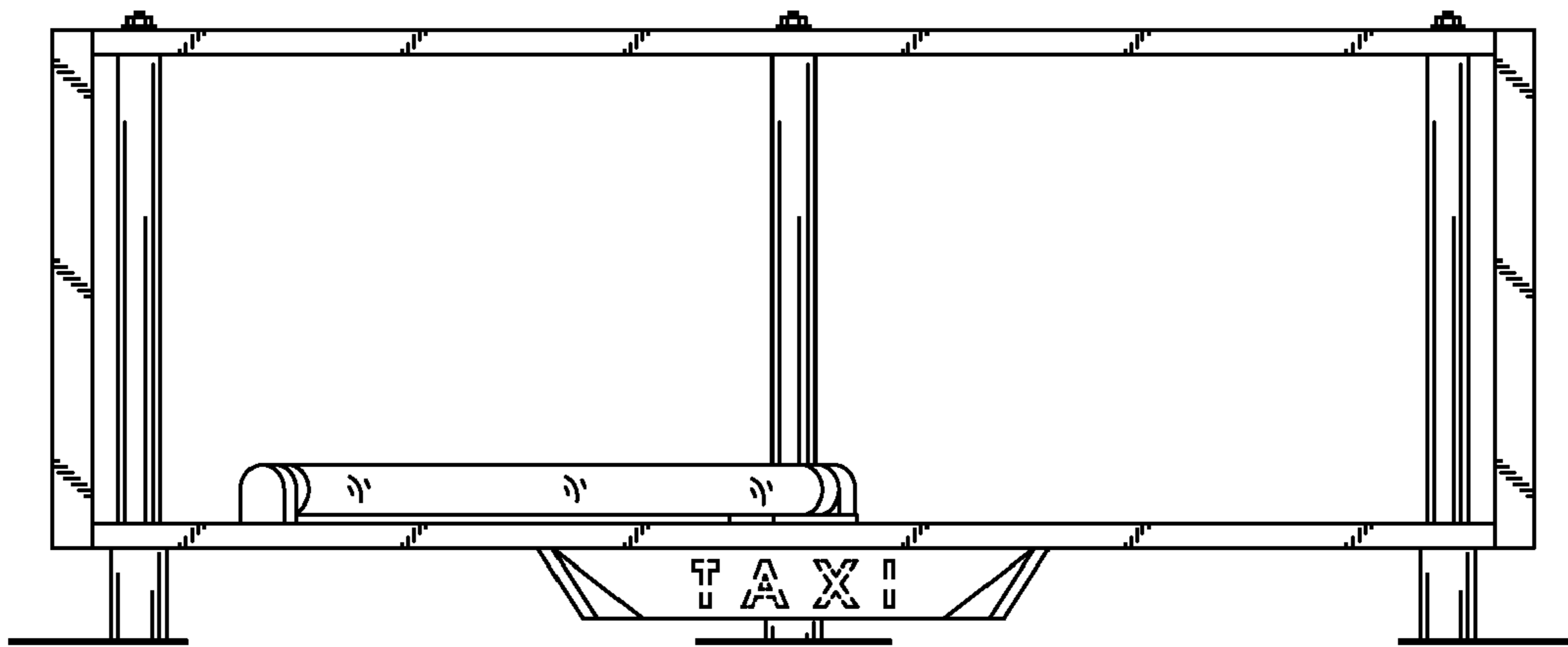

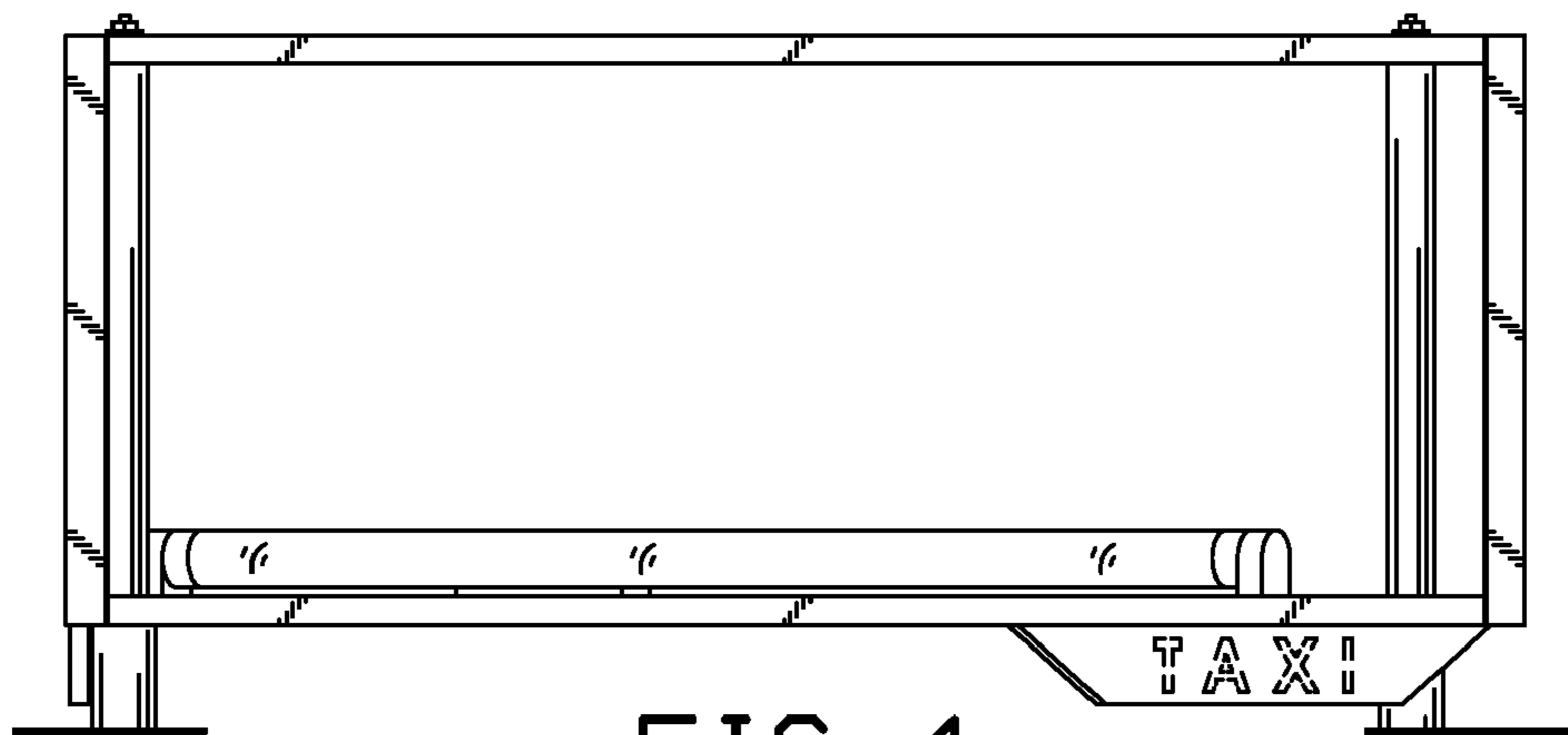

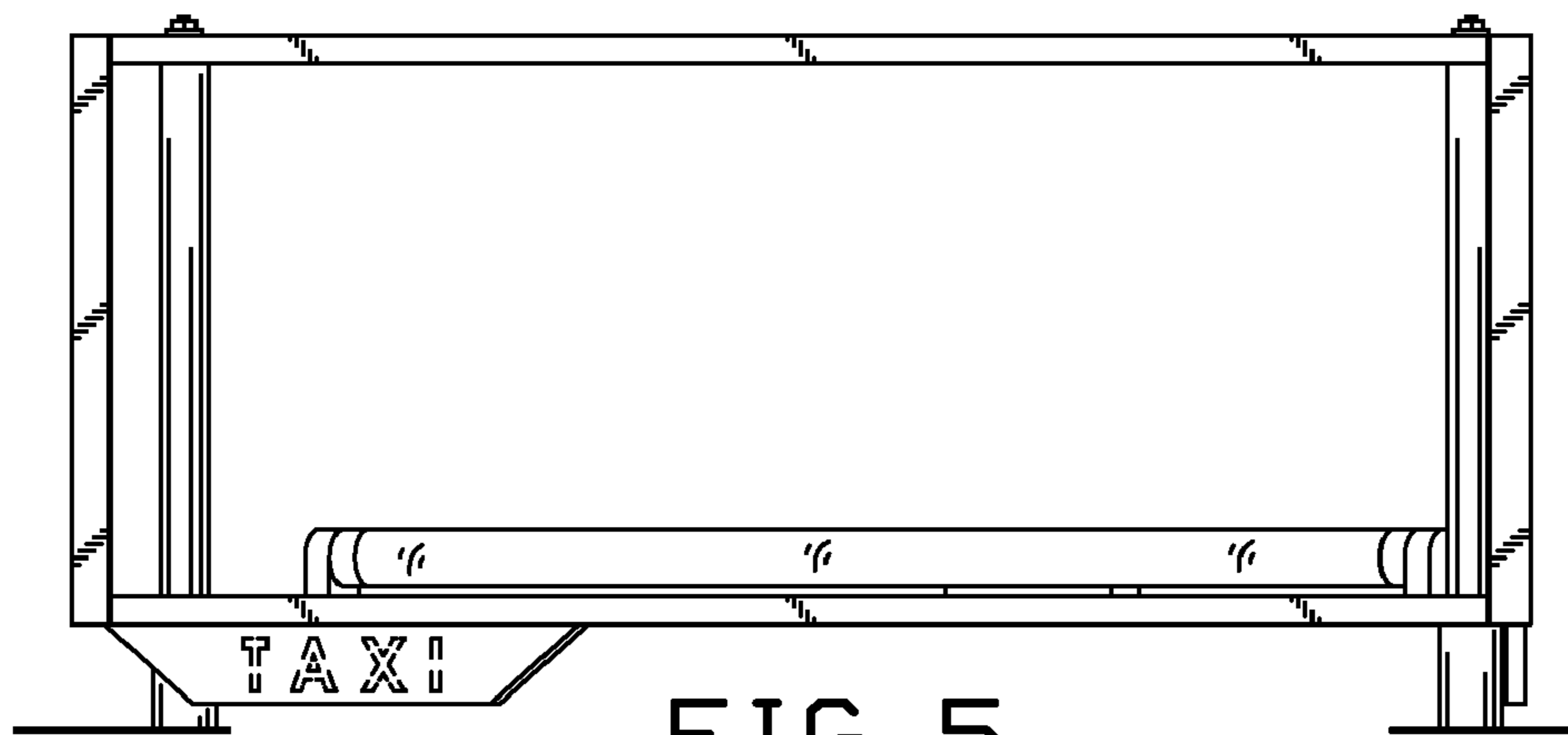
