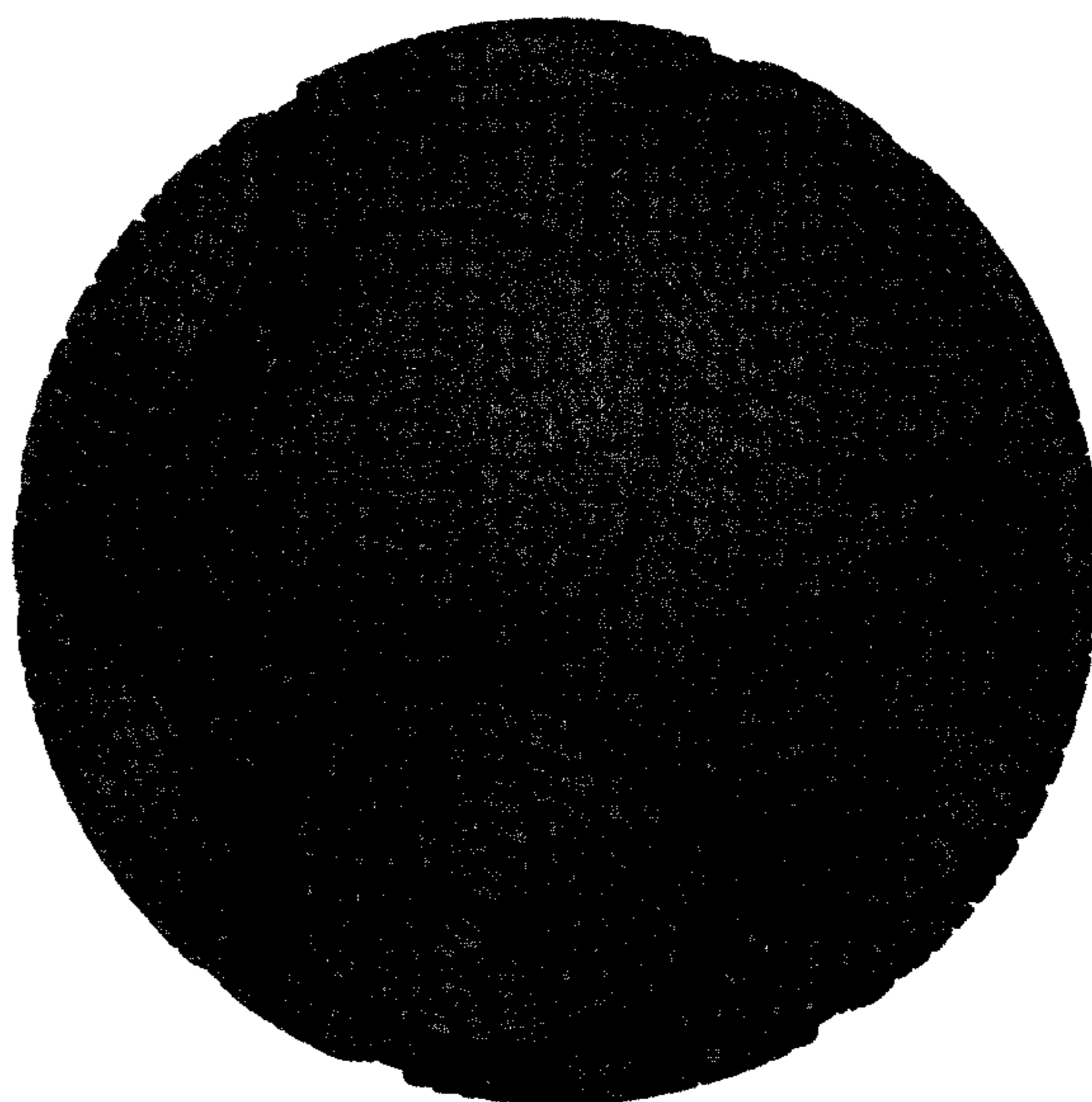
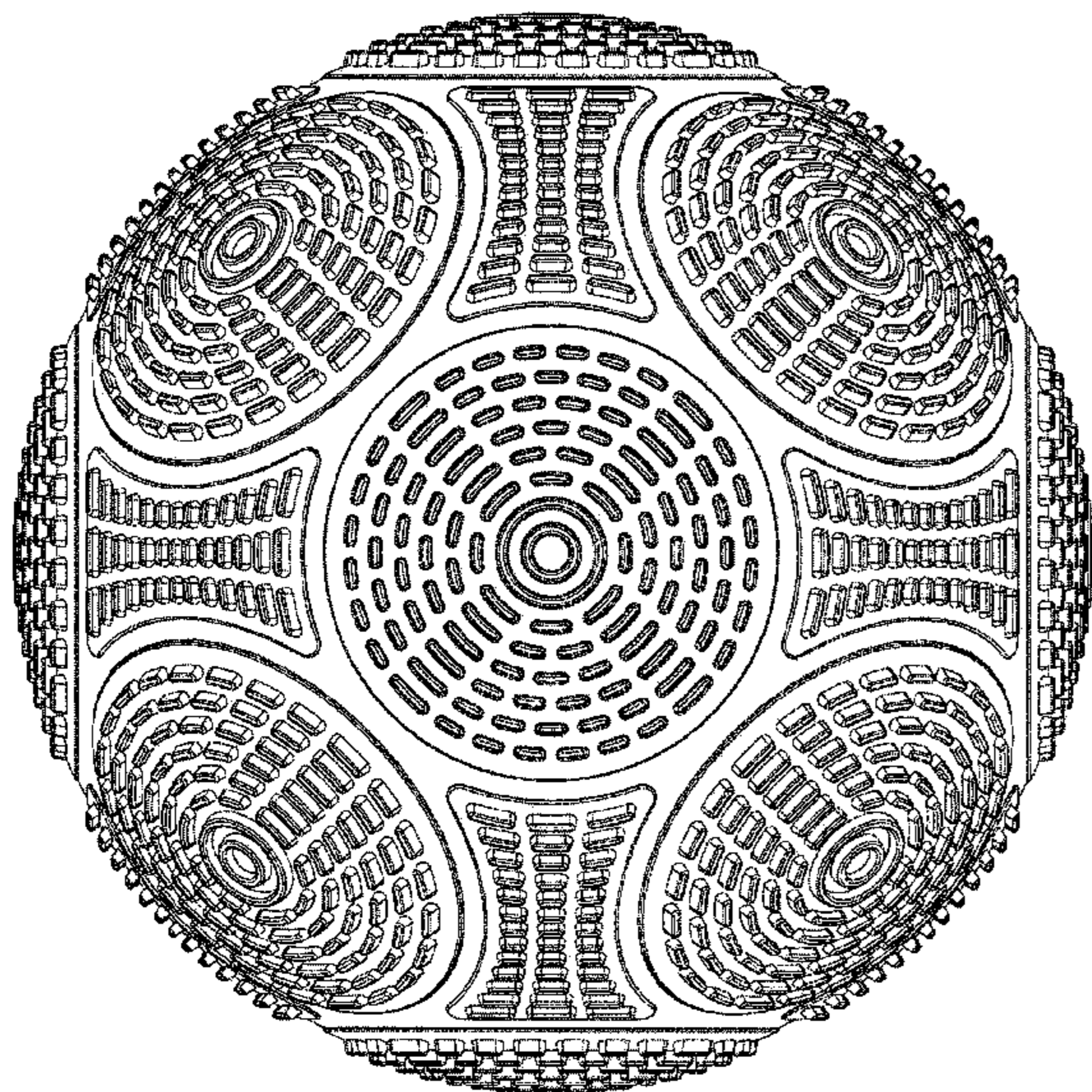
(57) **CLAIM**

FIG. 1 is a side view of the football shown with grey scale shading omitted for a clear disclosure of the surface contour; and,

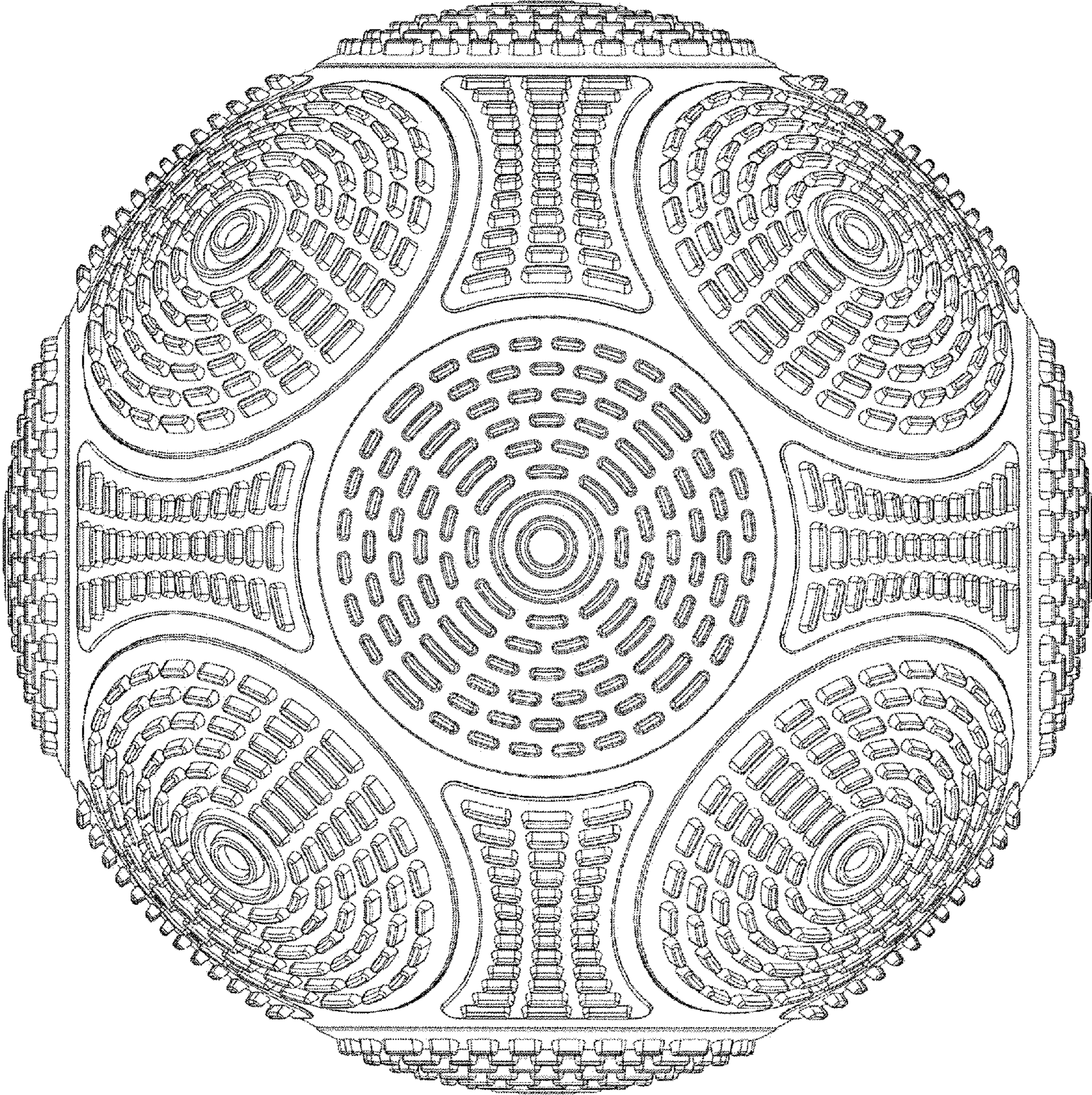
