(57) **CLAIM**

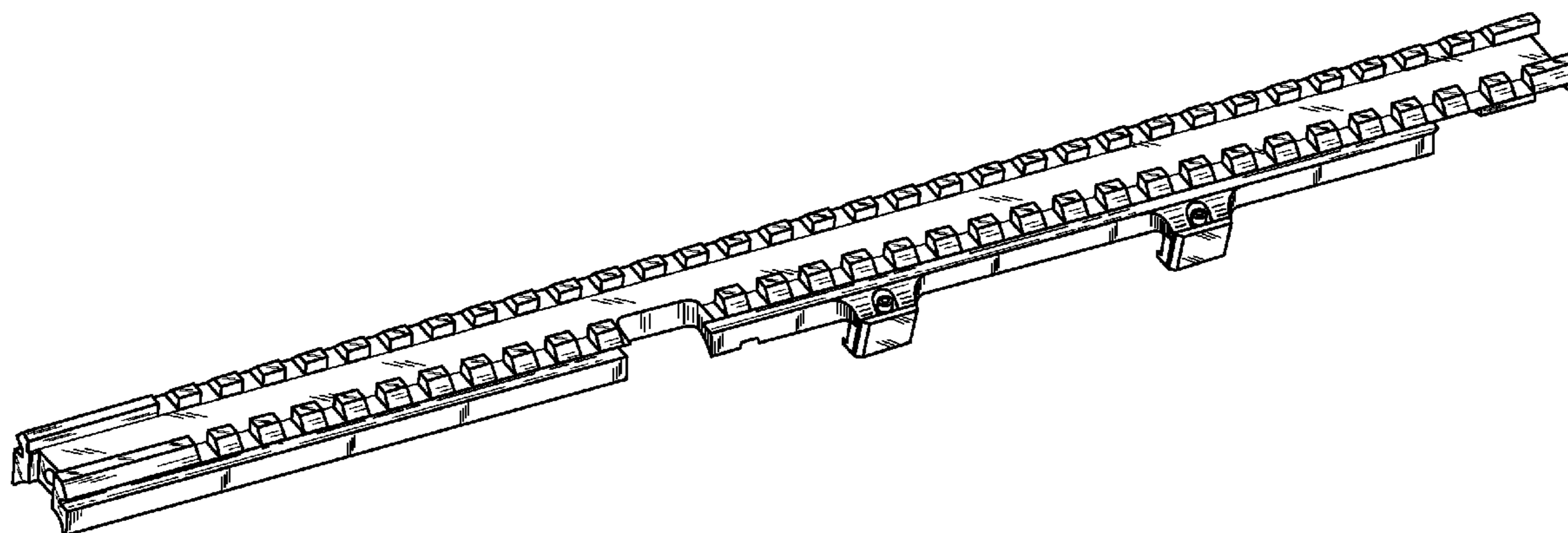
What is claimed is the ornamental design for a mount for GSG5 or MP5 firearms, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mount for GSG5 or MP5 firearms, showing the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

The broken lines in FIGS. 3 and 7 depict environmental matter, and form no part of the claimed design.

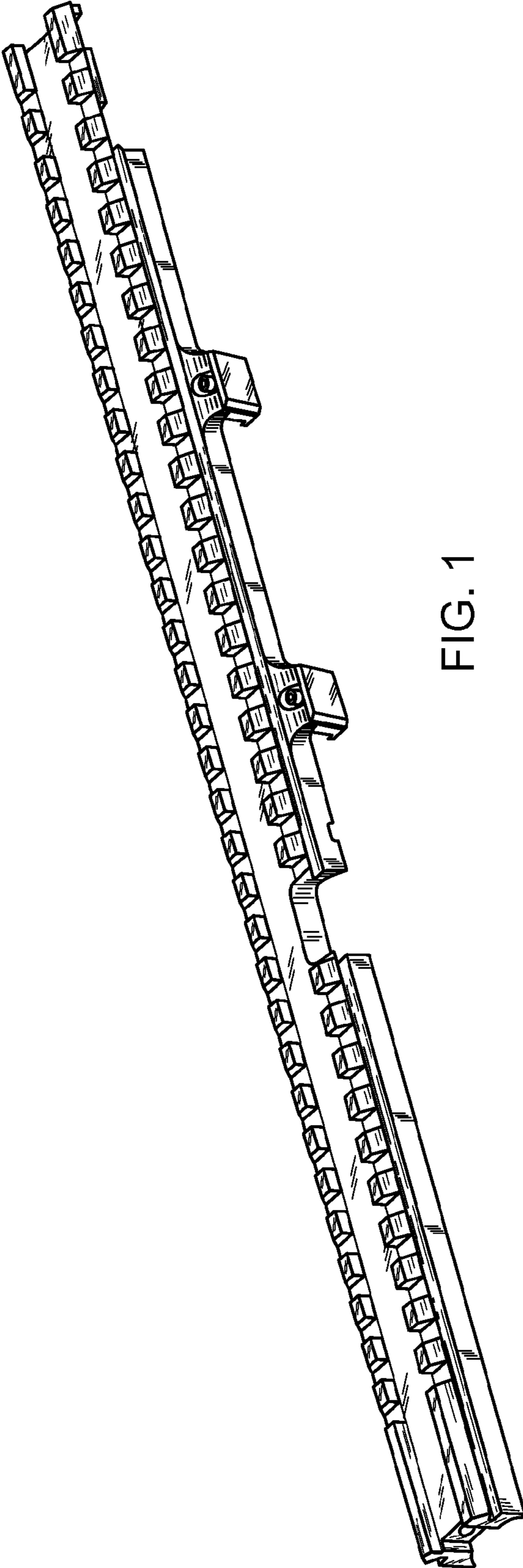

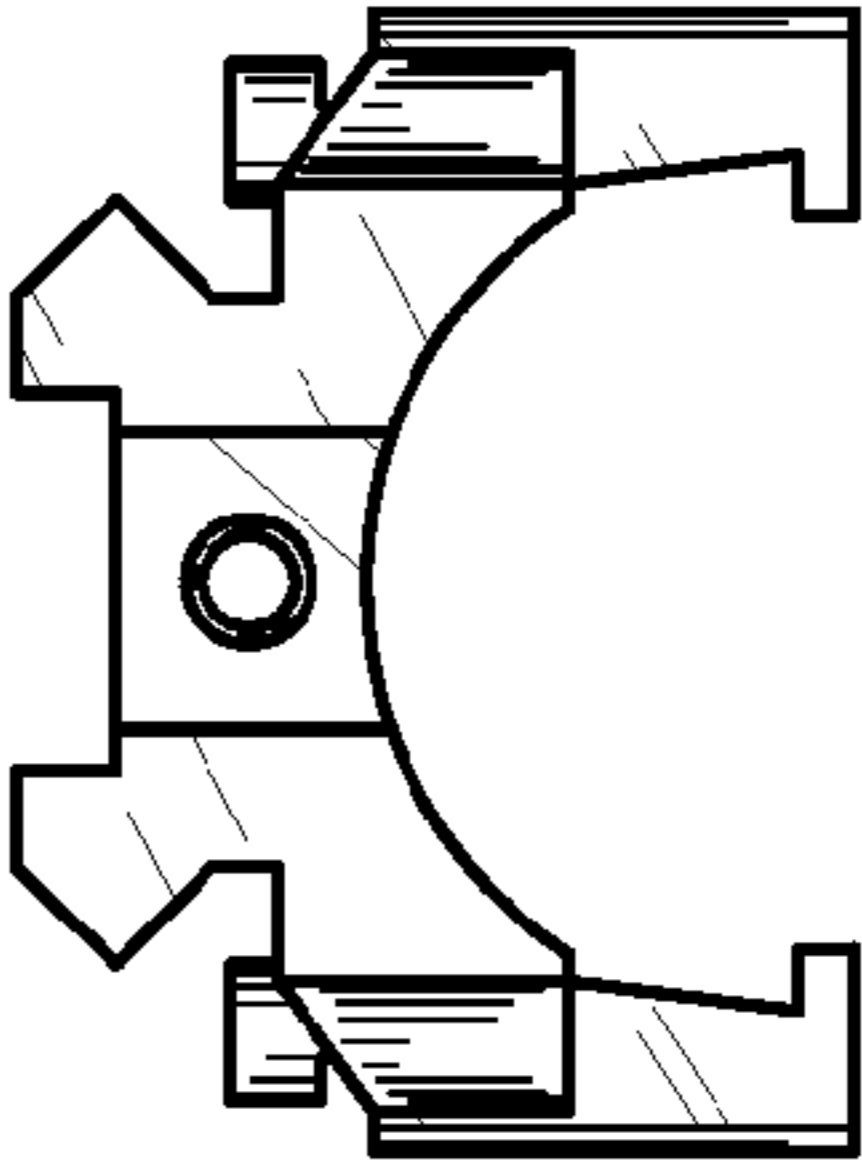

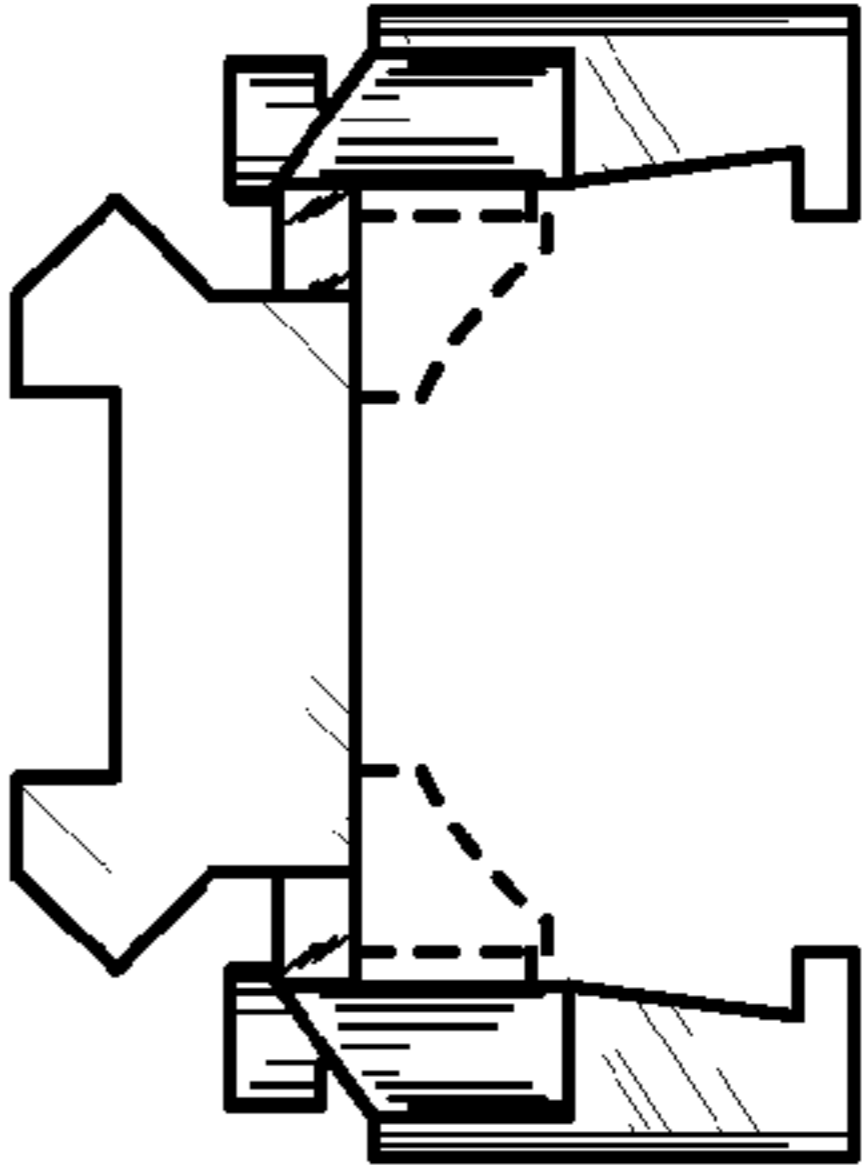

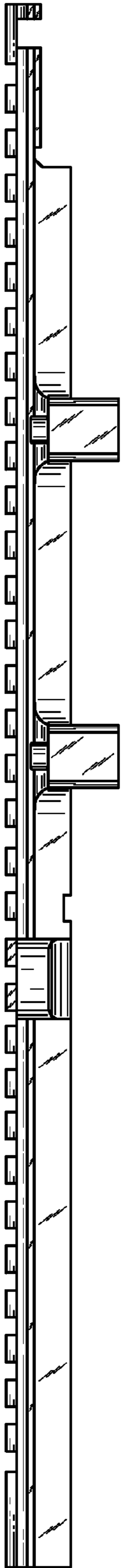

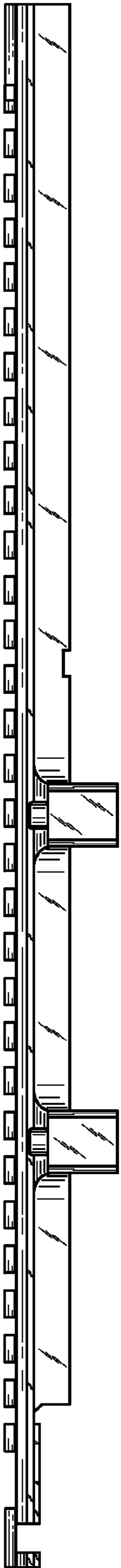

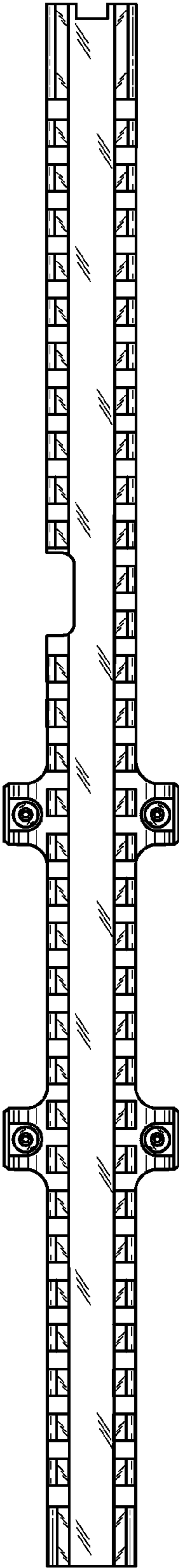

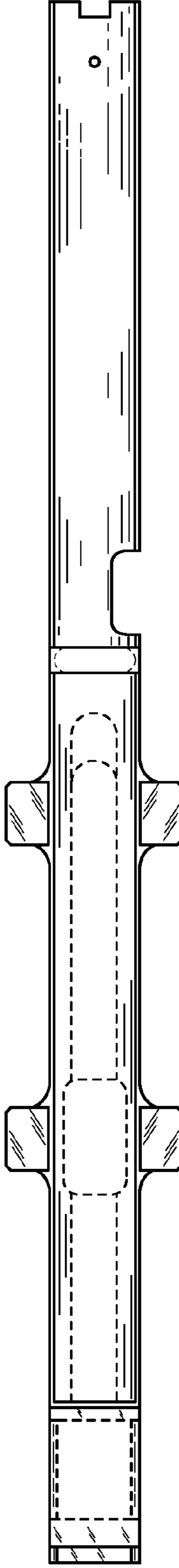
