DESCRIPTION

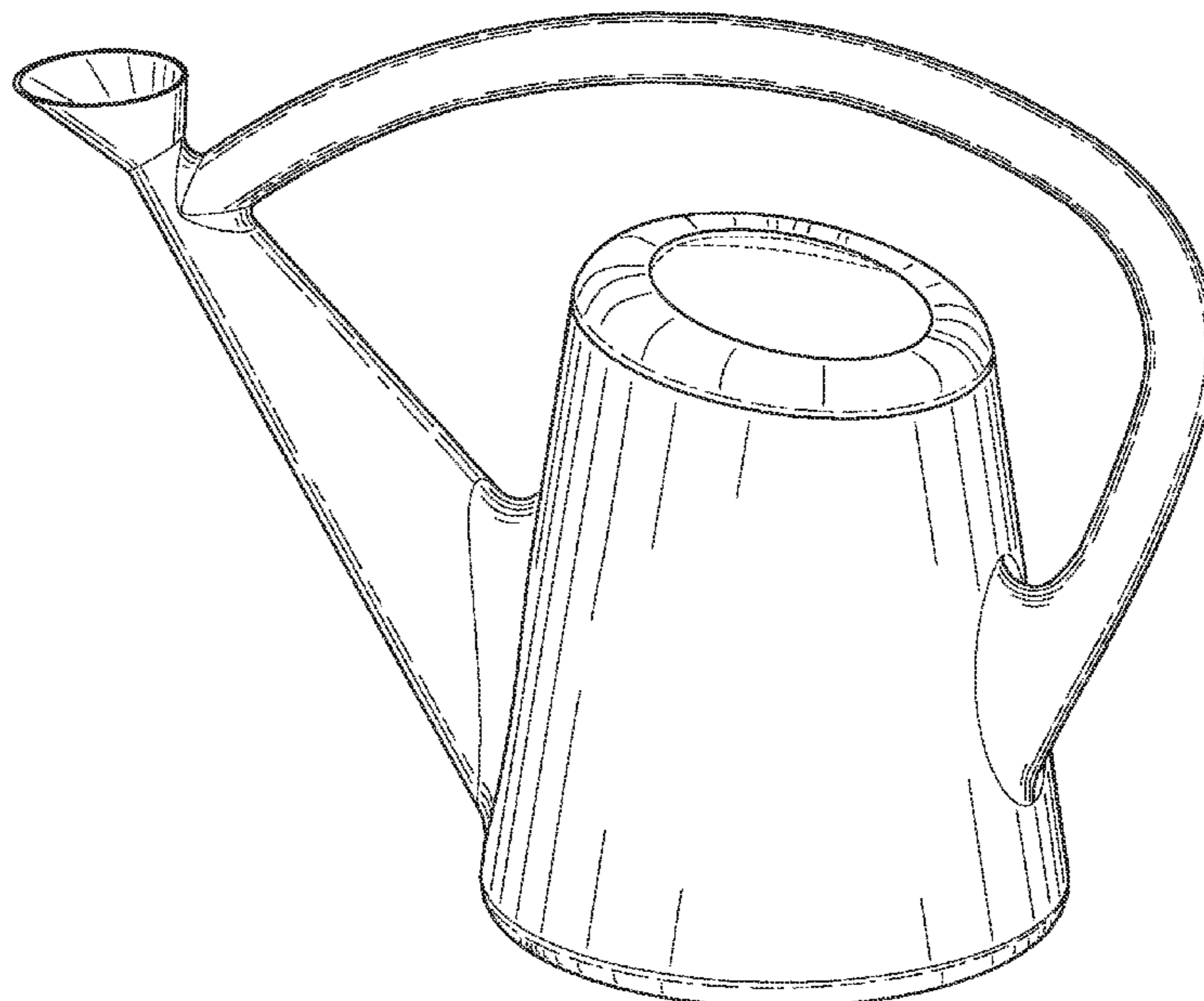
FIG. 1 is a front, top, perspective view of a watering can showing our new design;

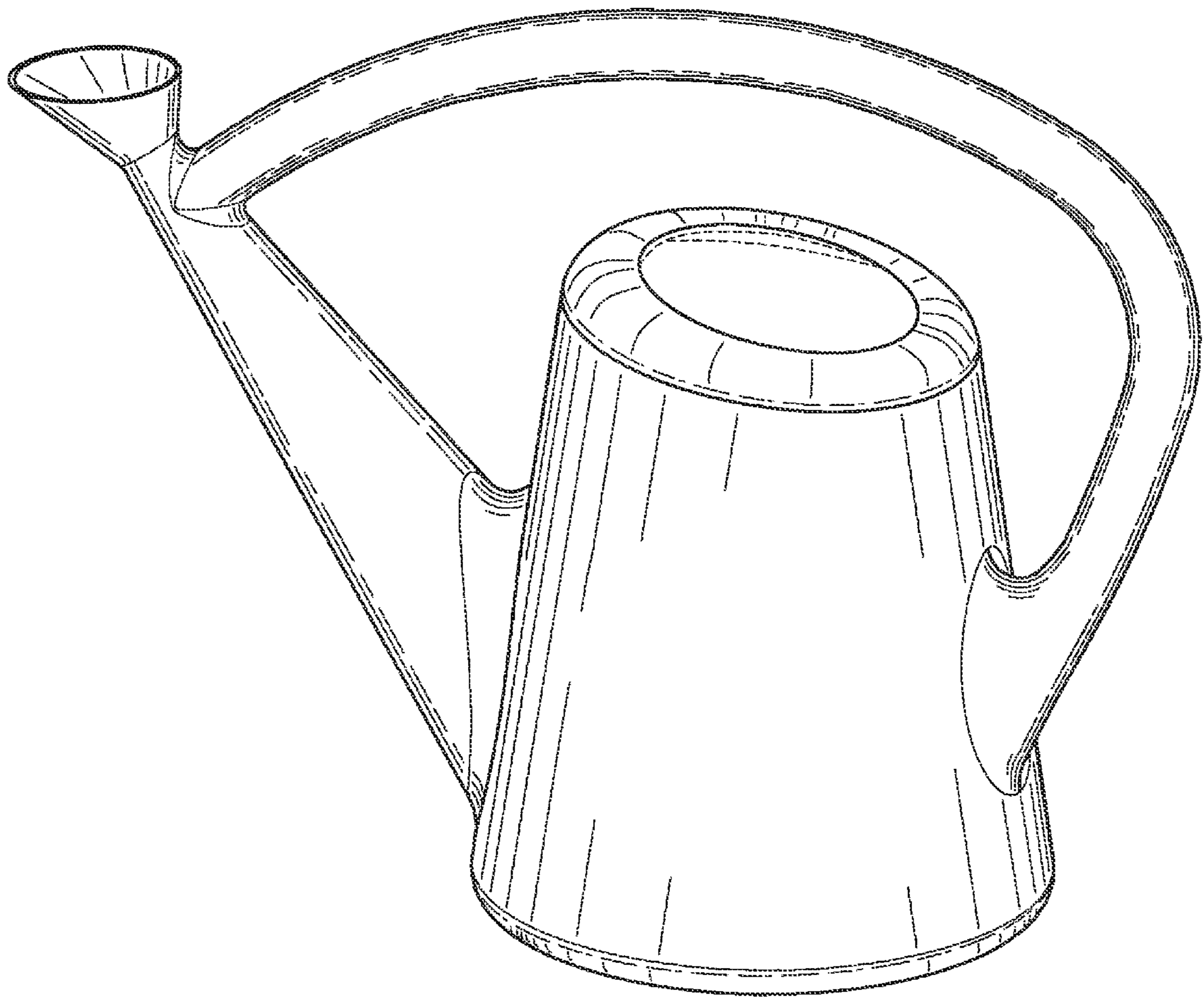

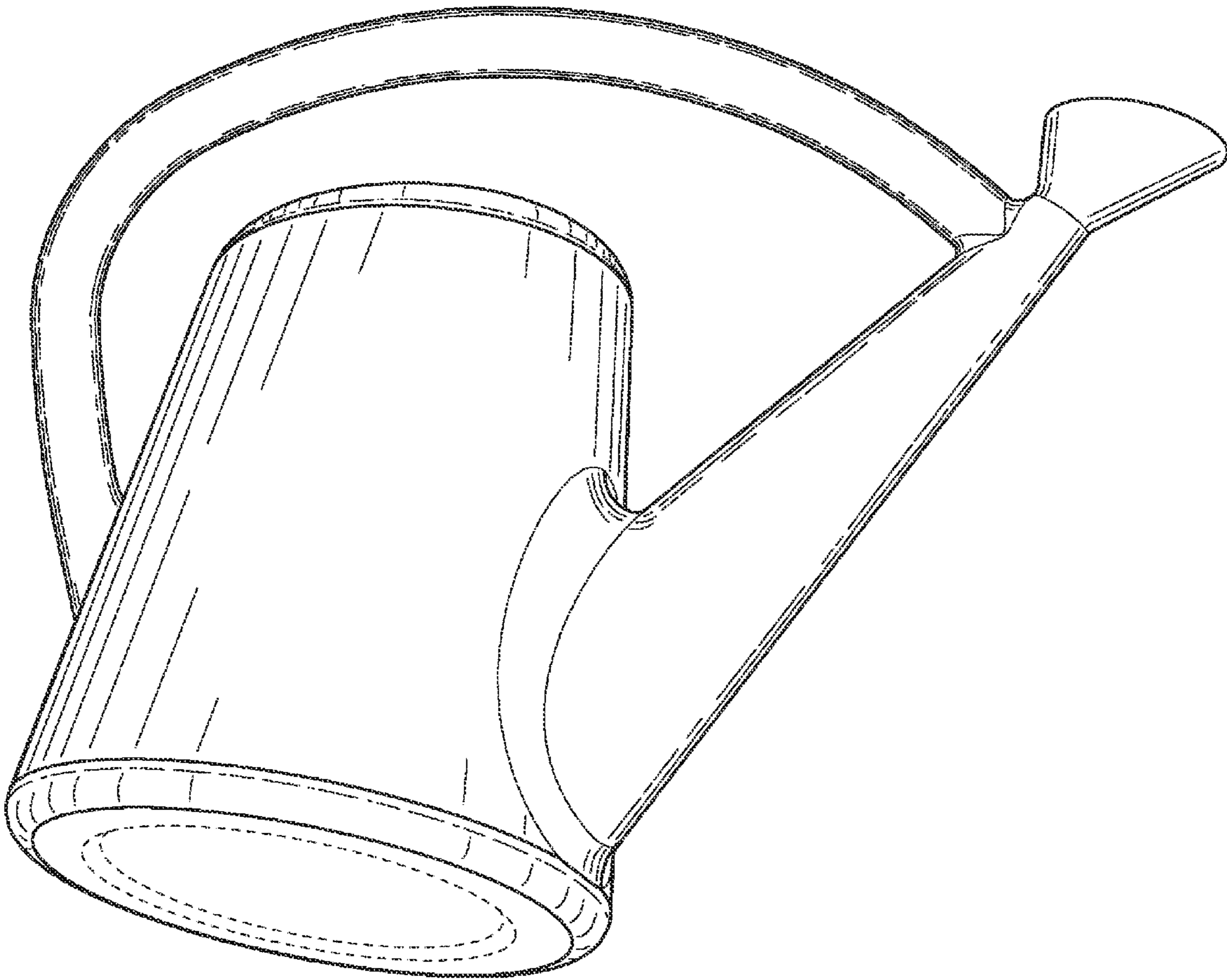

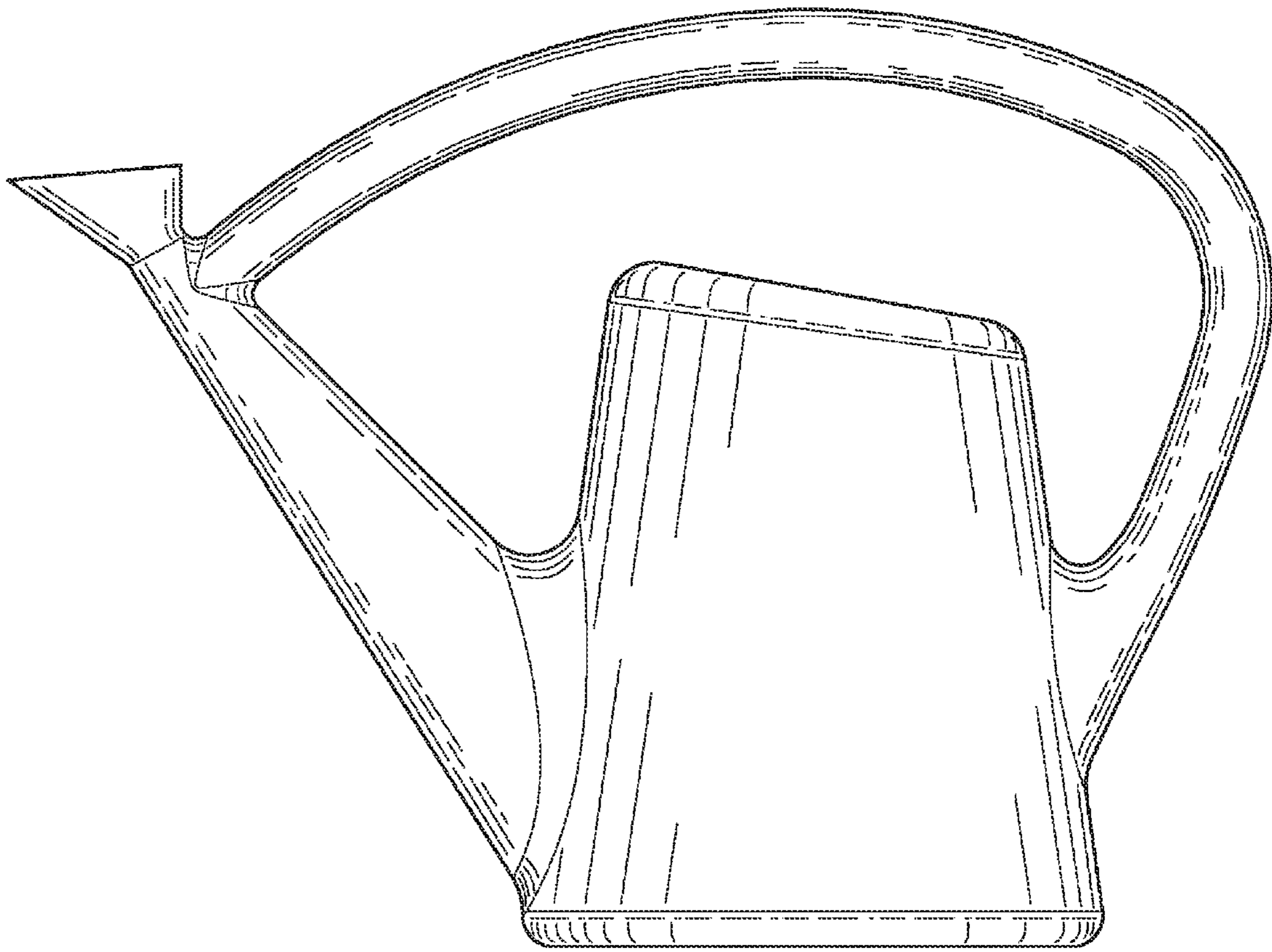

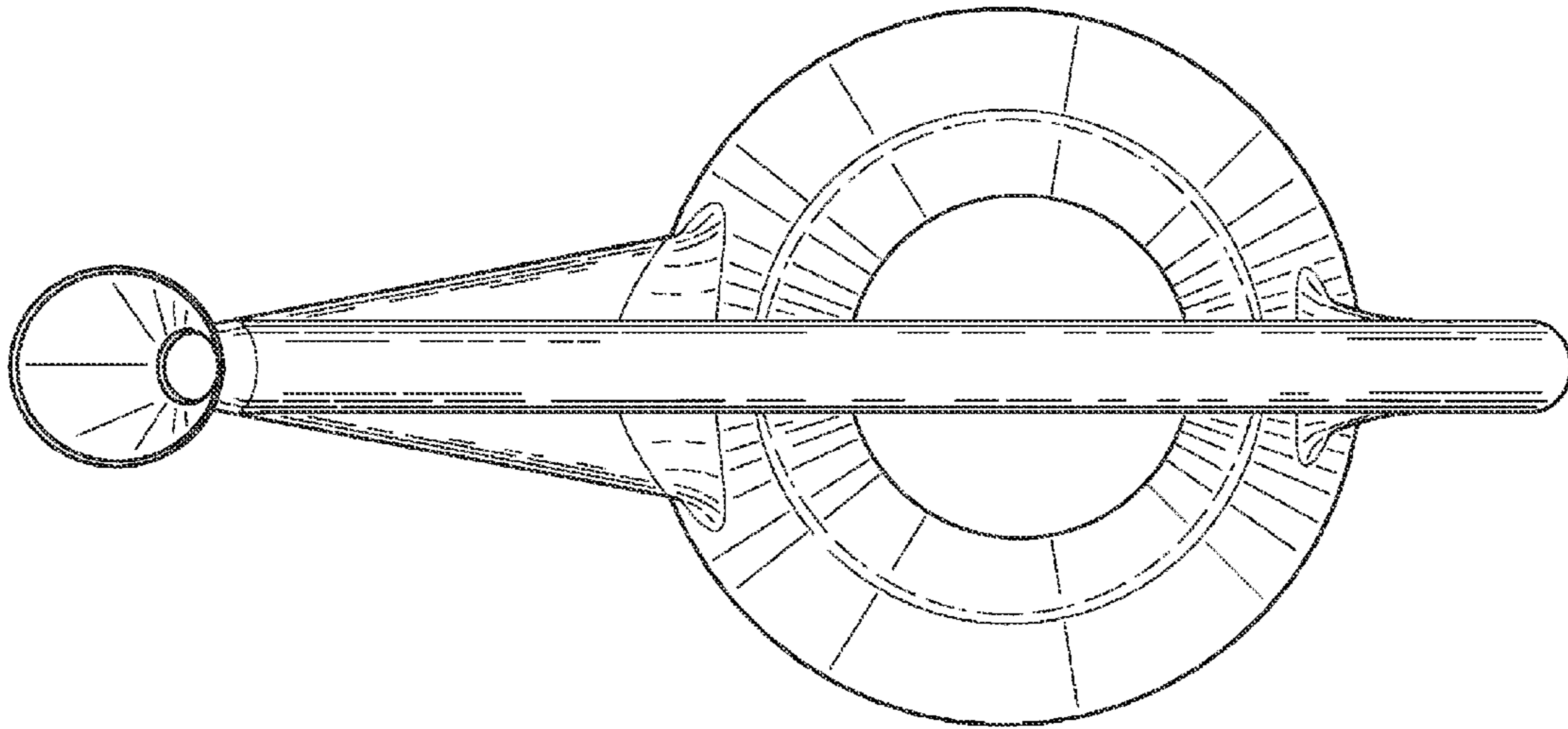

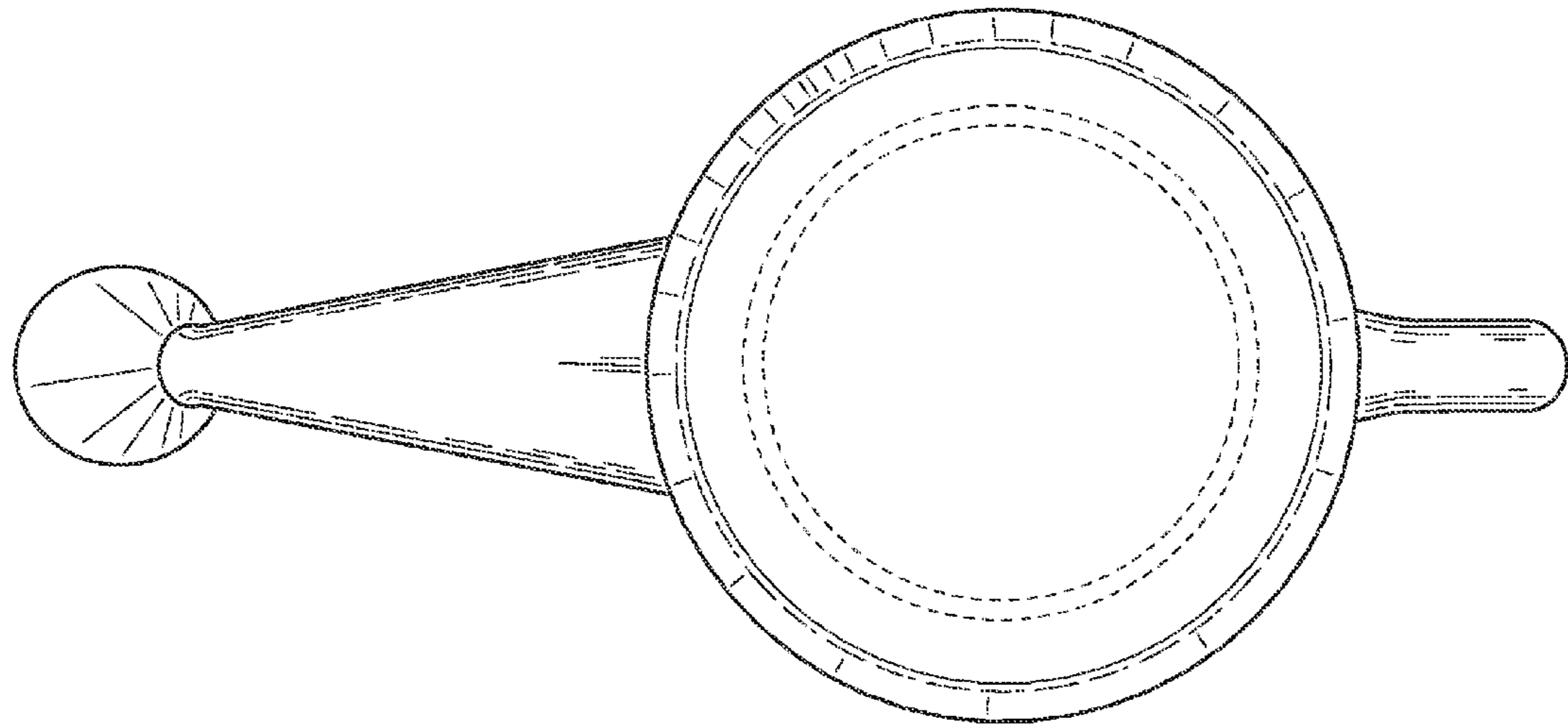

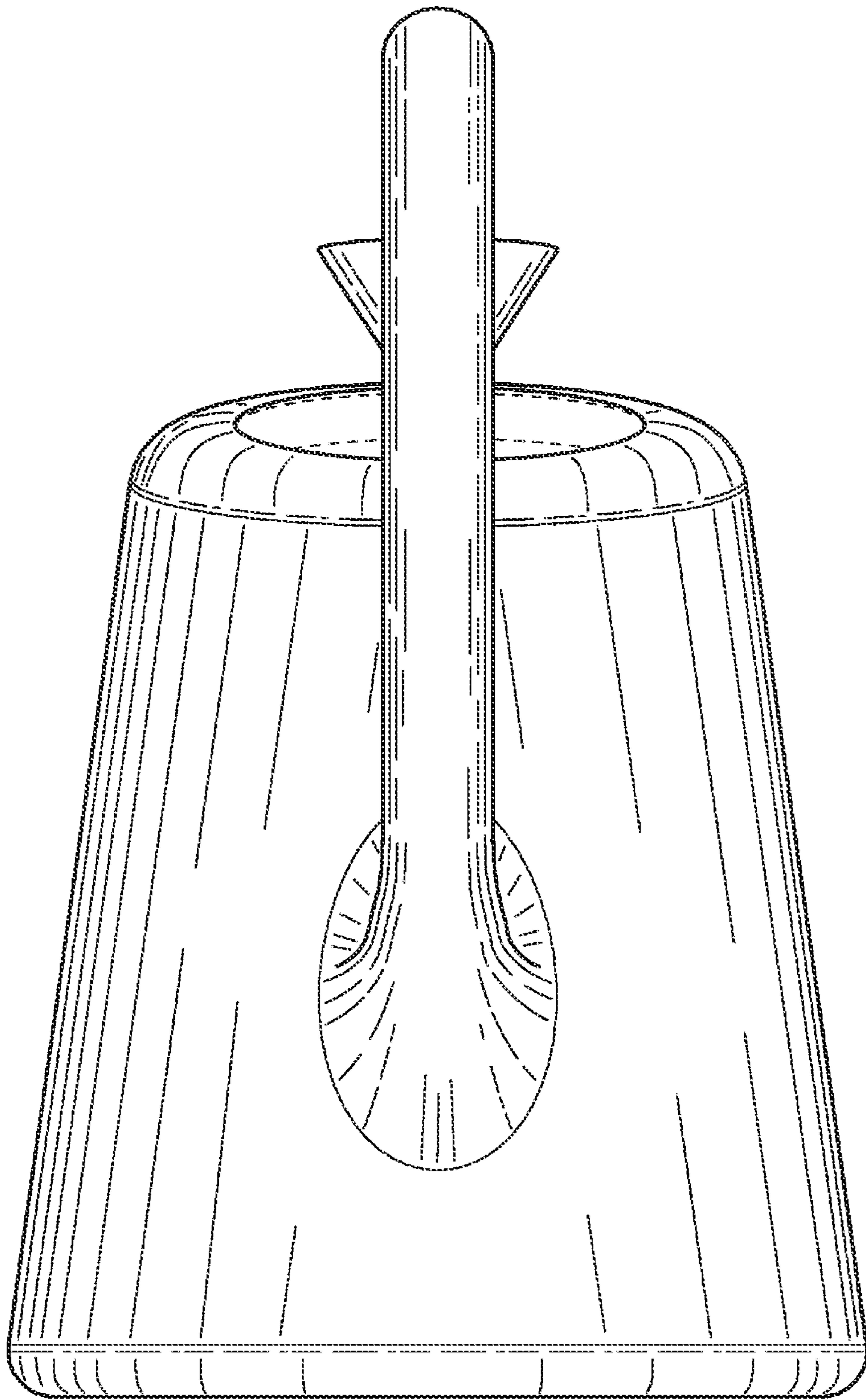

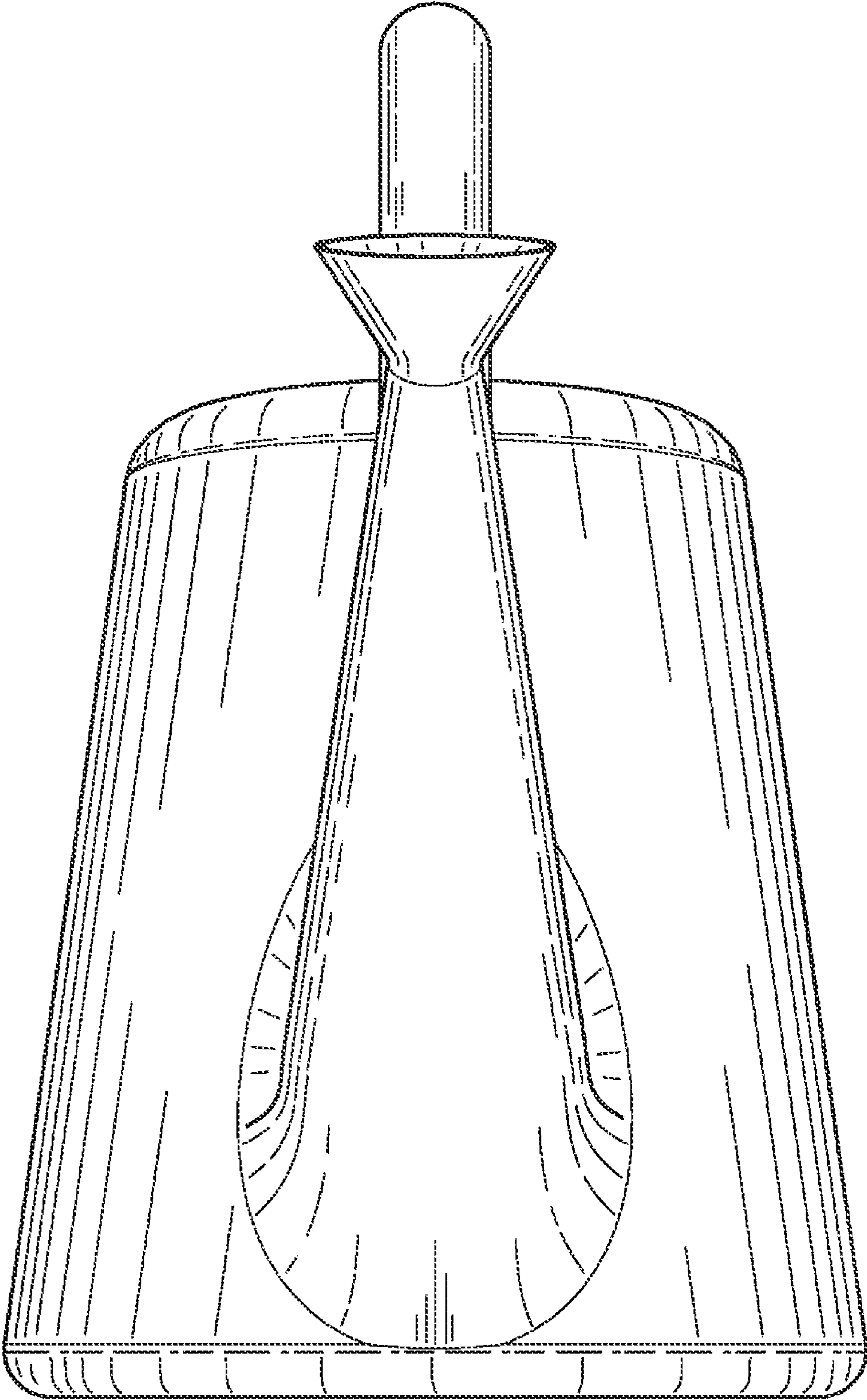
