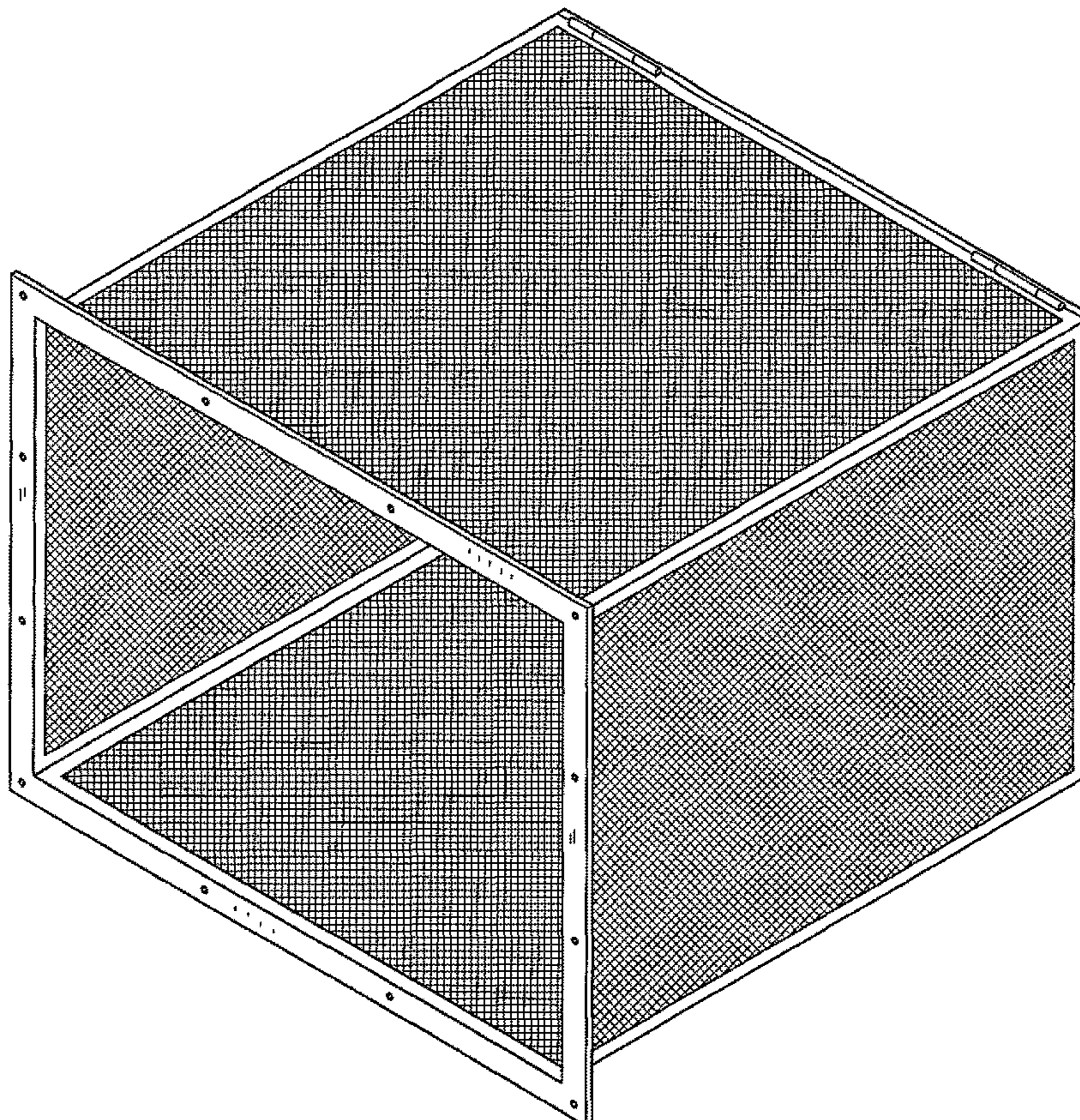
(57) **CLAIM**

The ornamental design for an air conditioner unit screening device, as shown and described.

DESCRIPTION

FIG. 1 is a rear elevational view of an air conditioner unit screening device showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof, with the broken-line disclosure being for illustrative purposes only and forming no part of the claimed design; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a top, front, and right side perspective thereof.

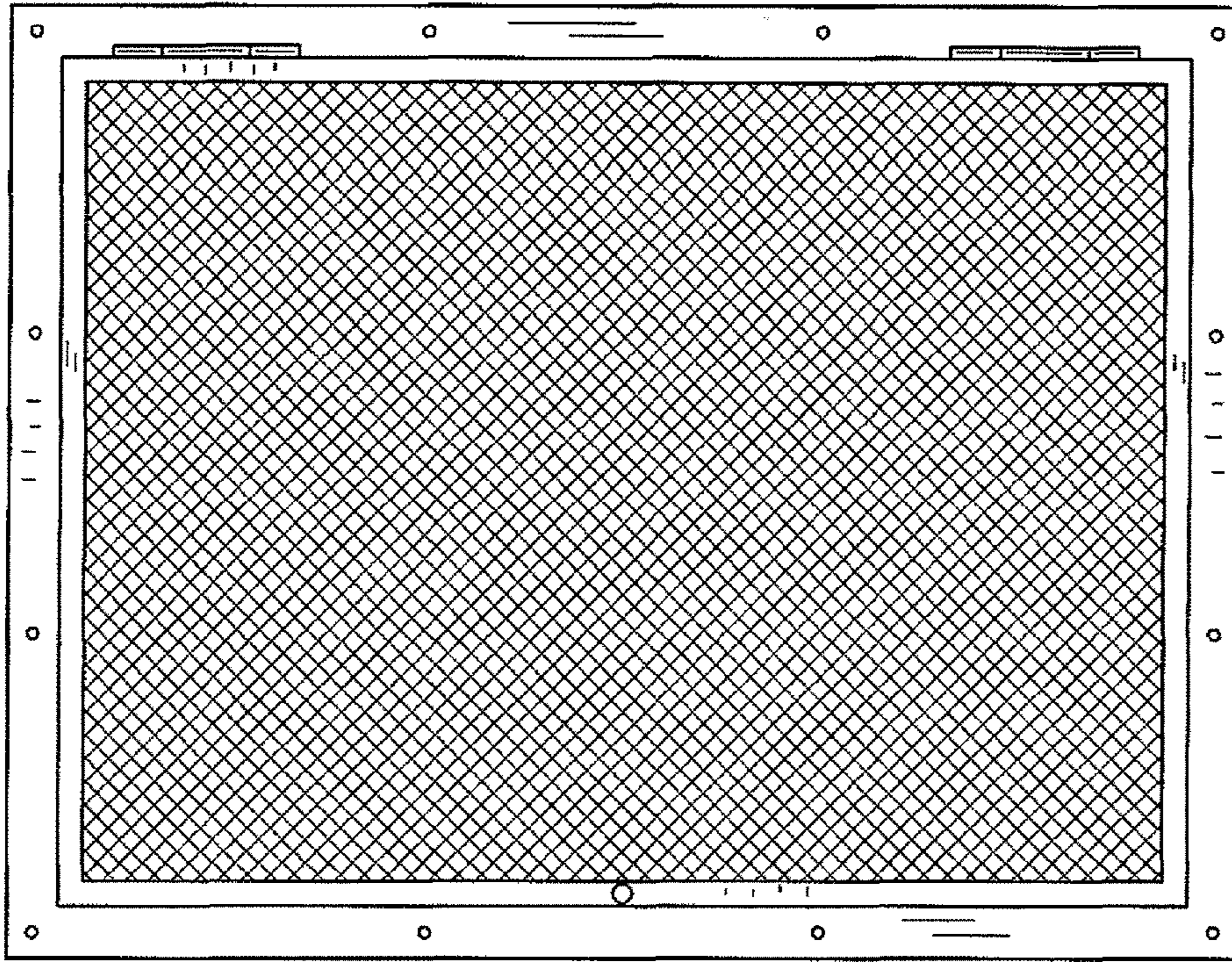

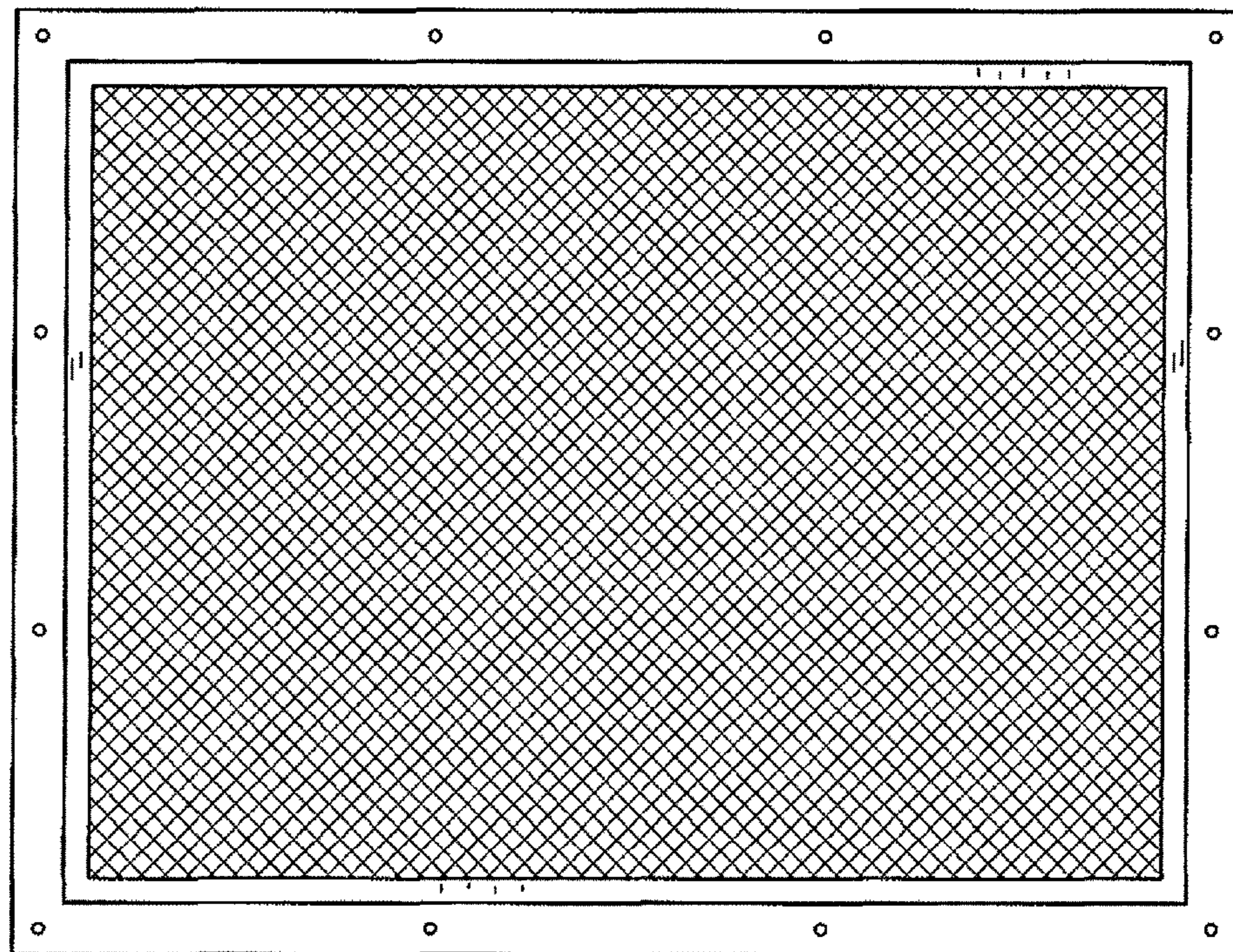

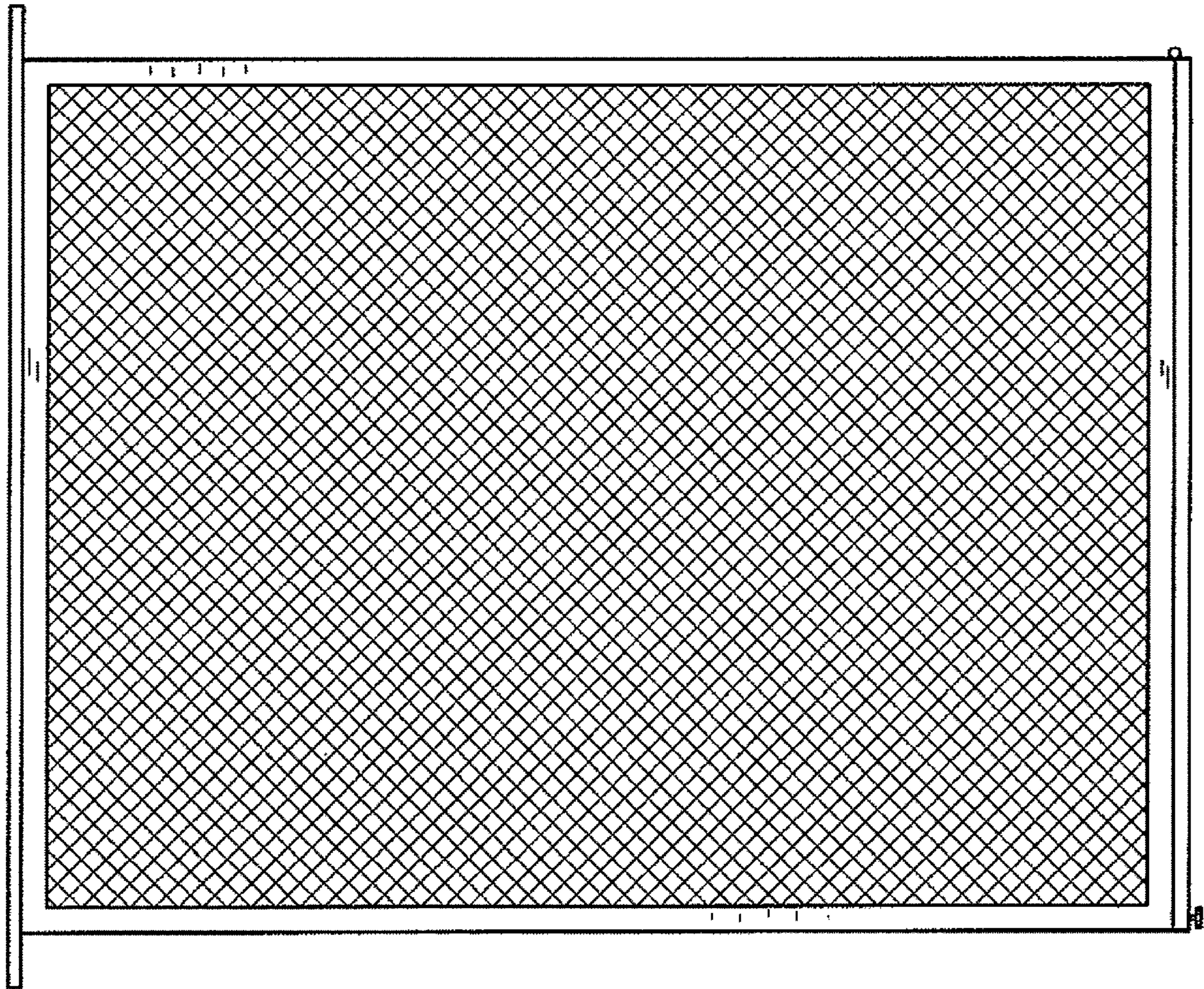

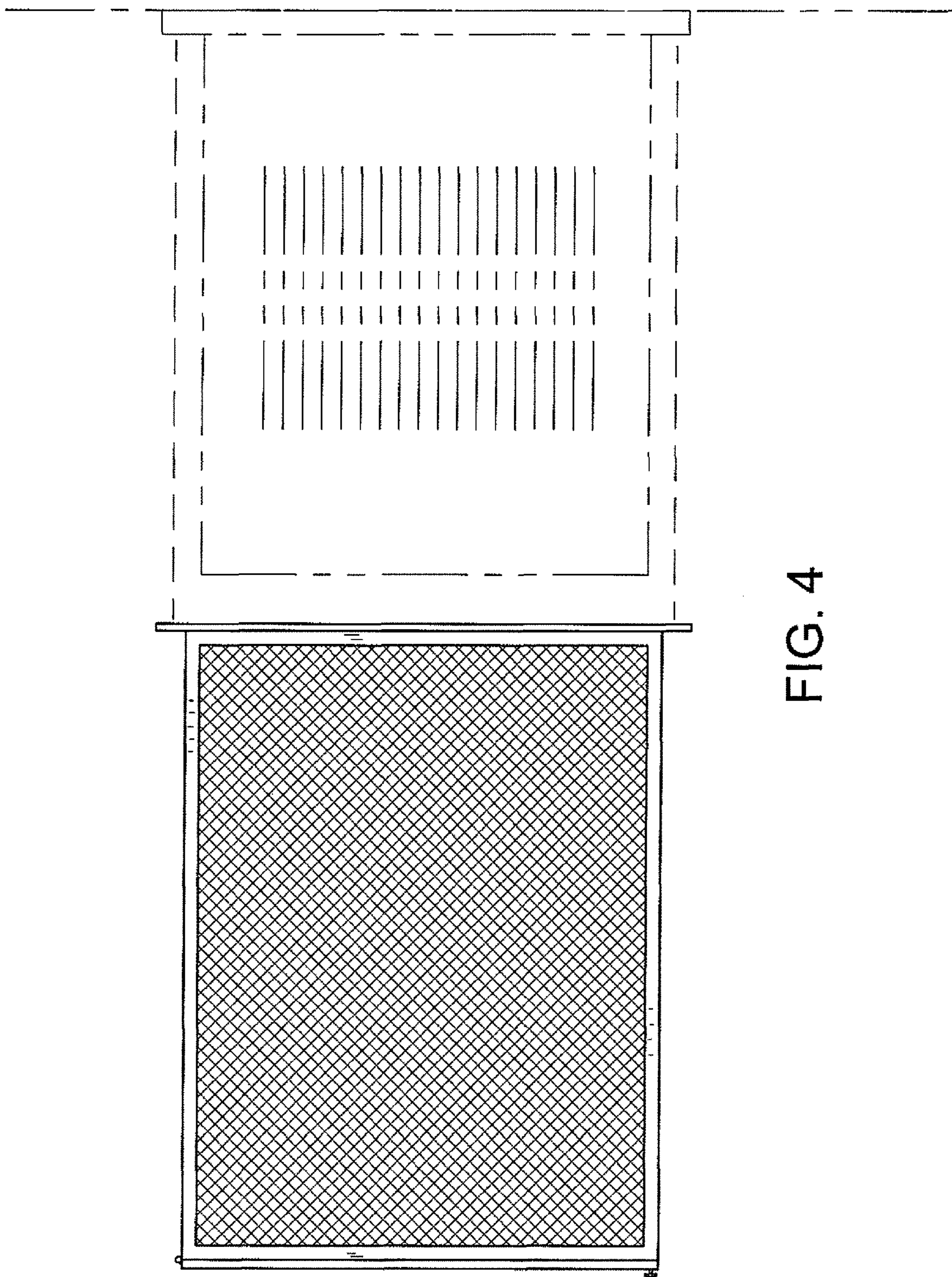

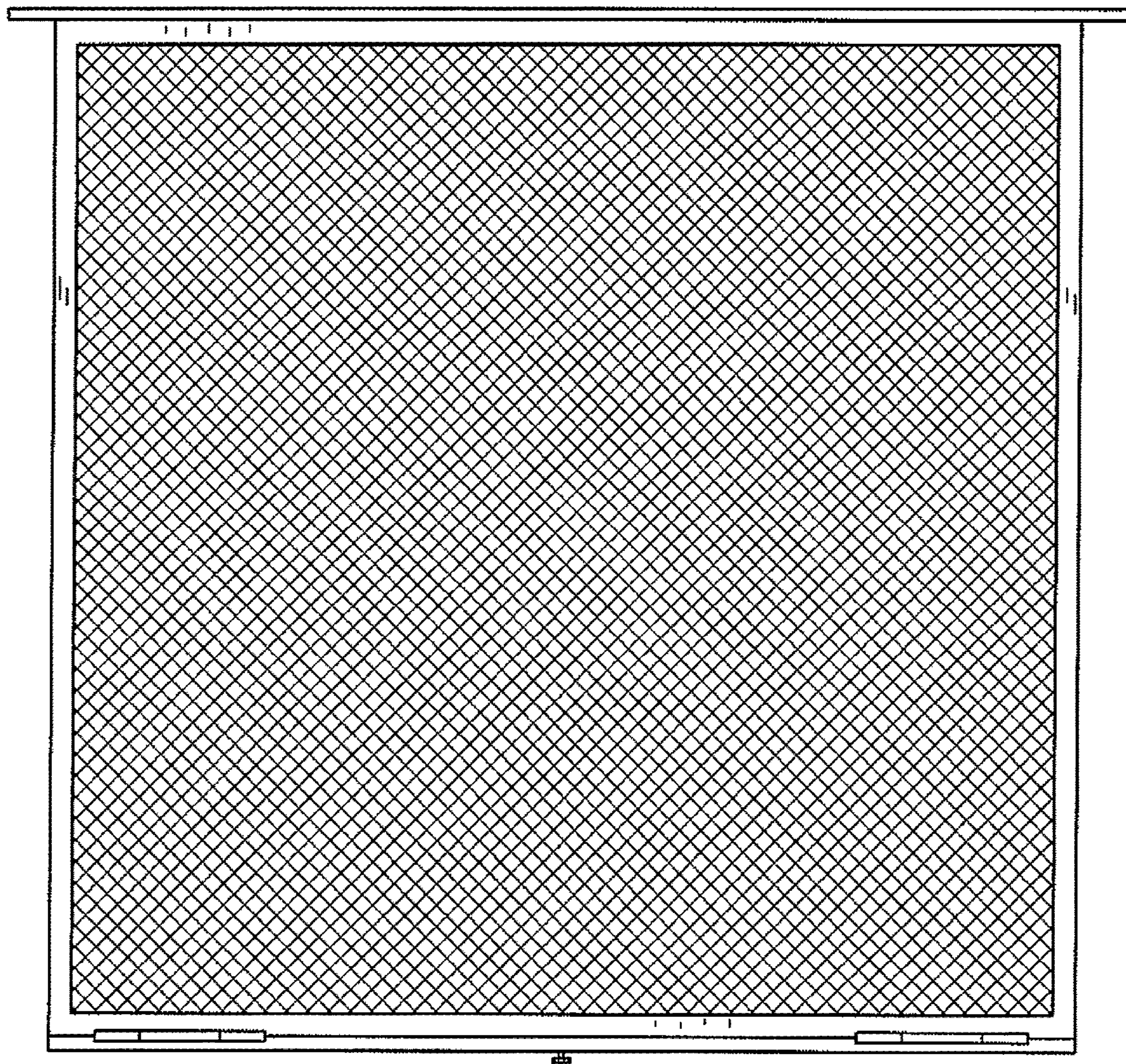

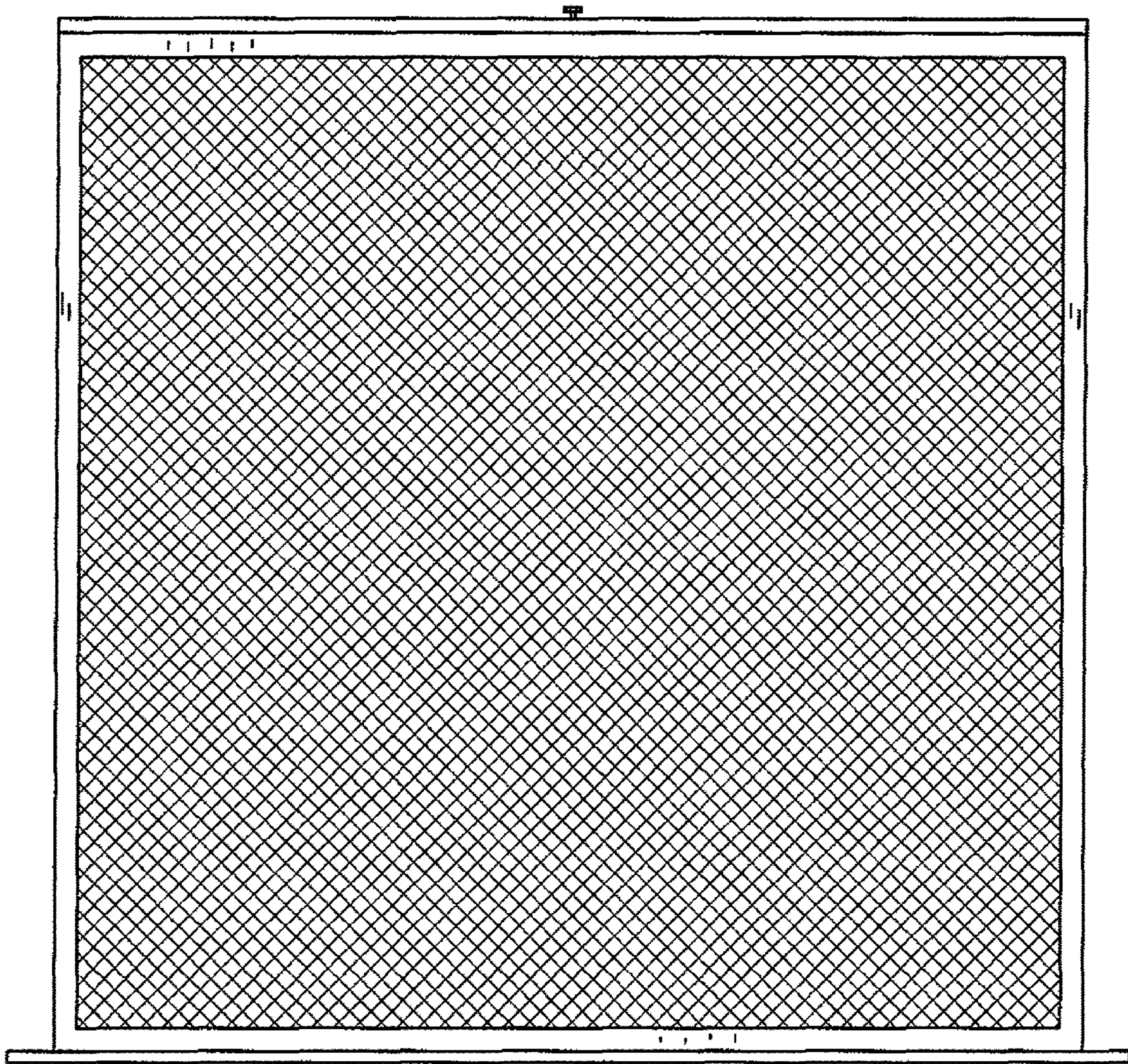

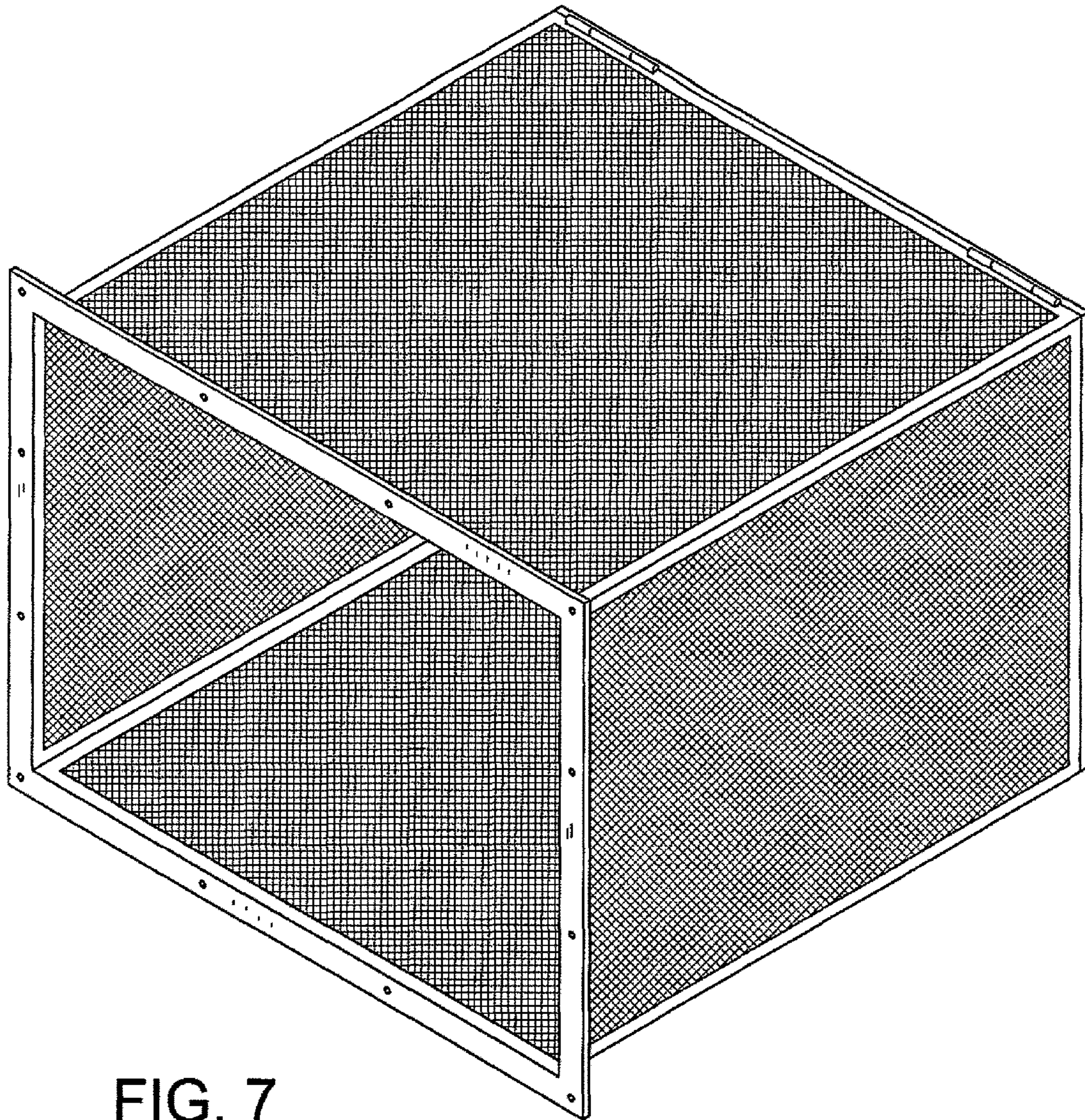
