DESCRIPTION

FIG. 1 is a front perspective view of an orthopedic walker showing my design.

FIG. 2 is a front elevational view of the orthopedic walker of FIG. 1.

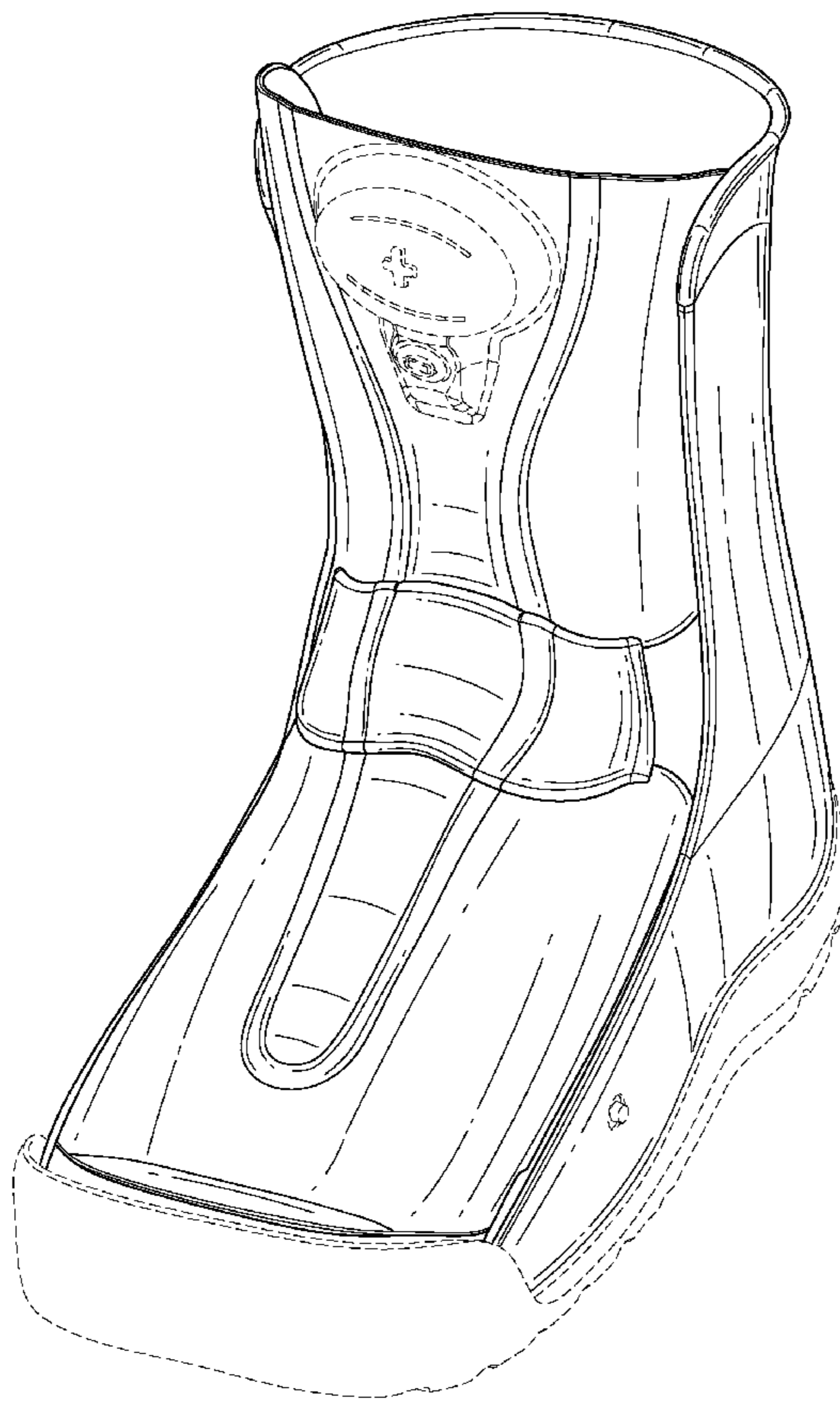
FIG. 3 is a first side elevational view of the orthopedic walker of FIG. 1.

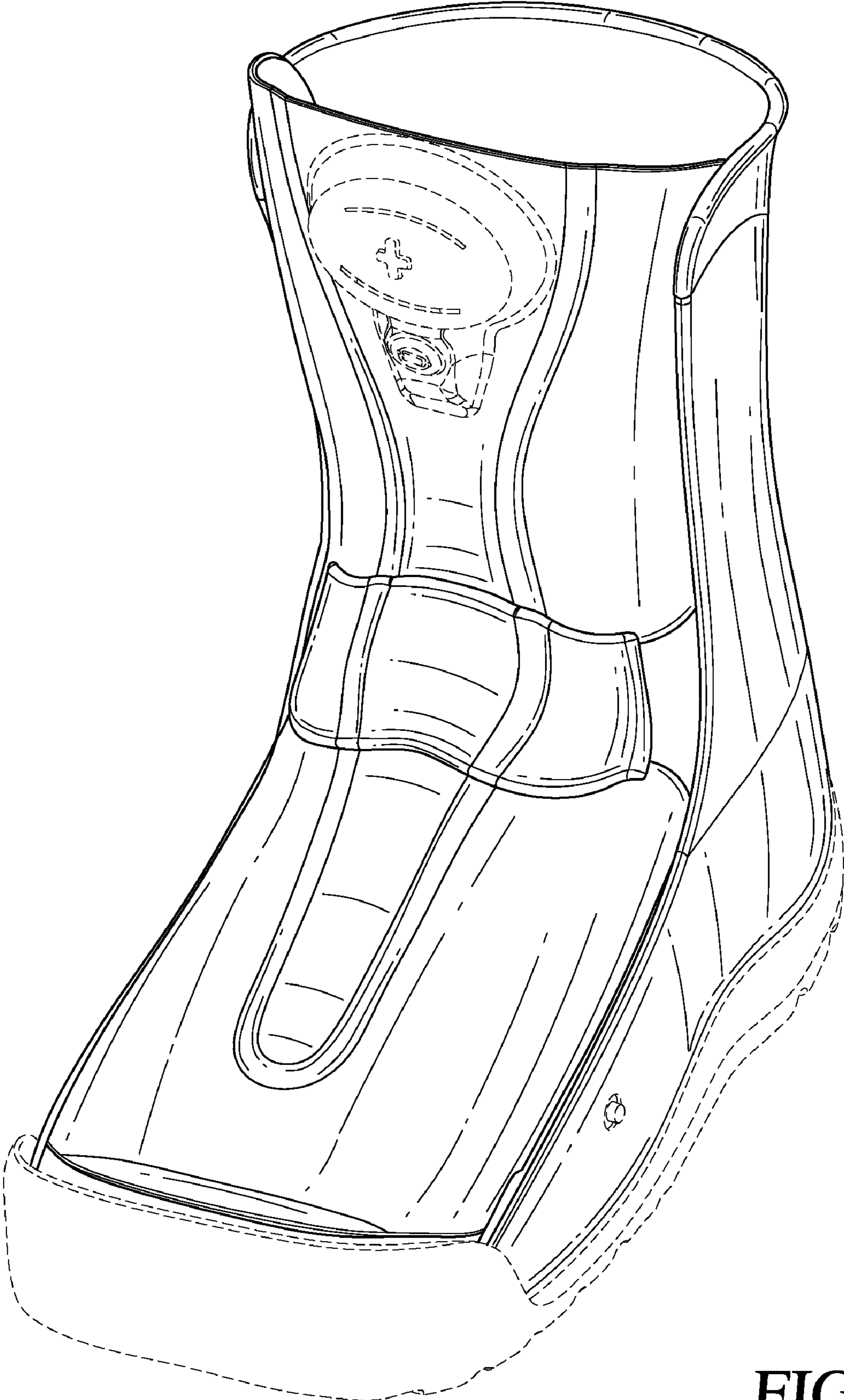

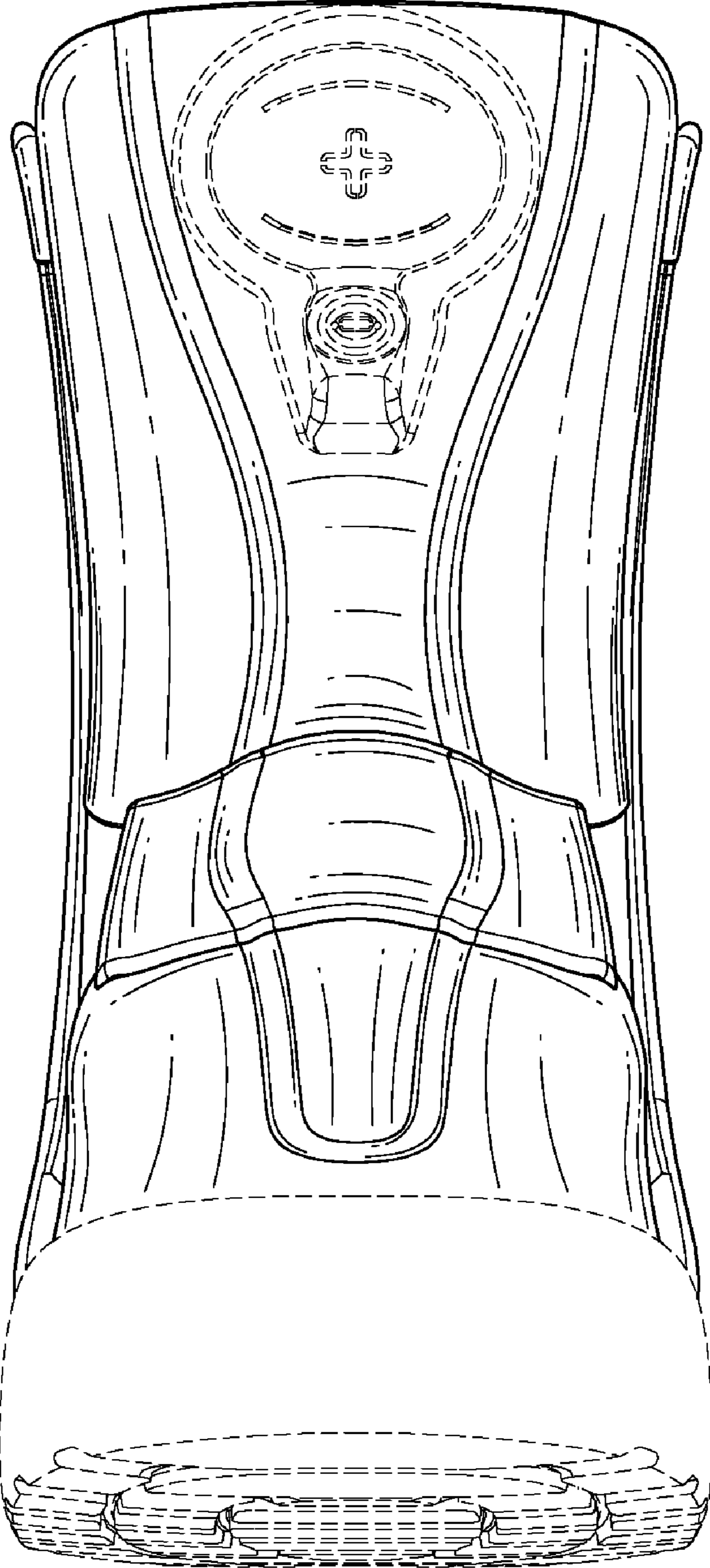

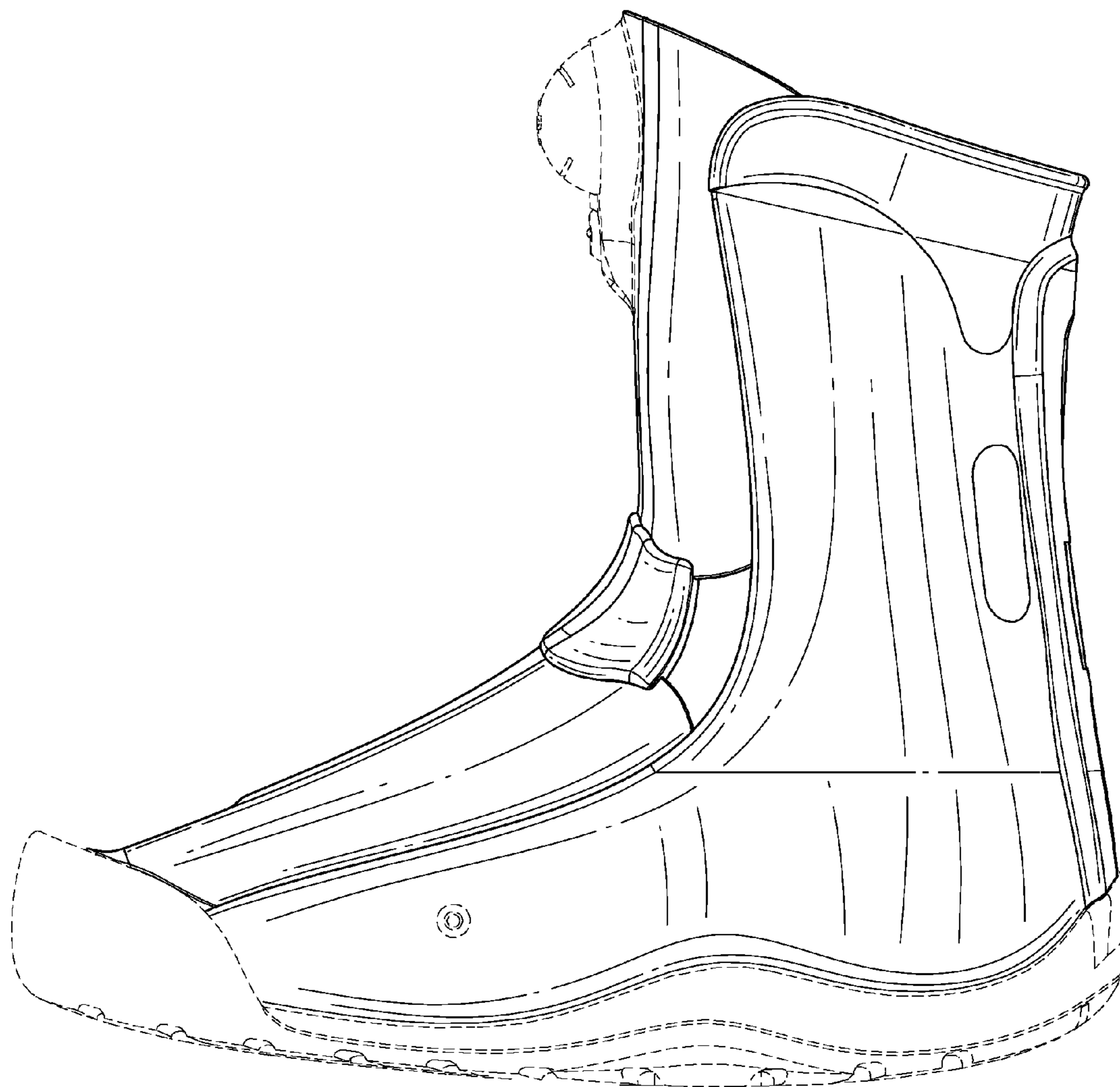

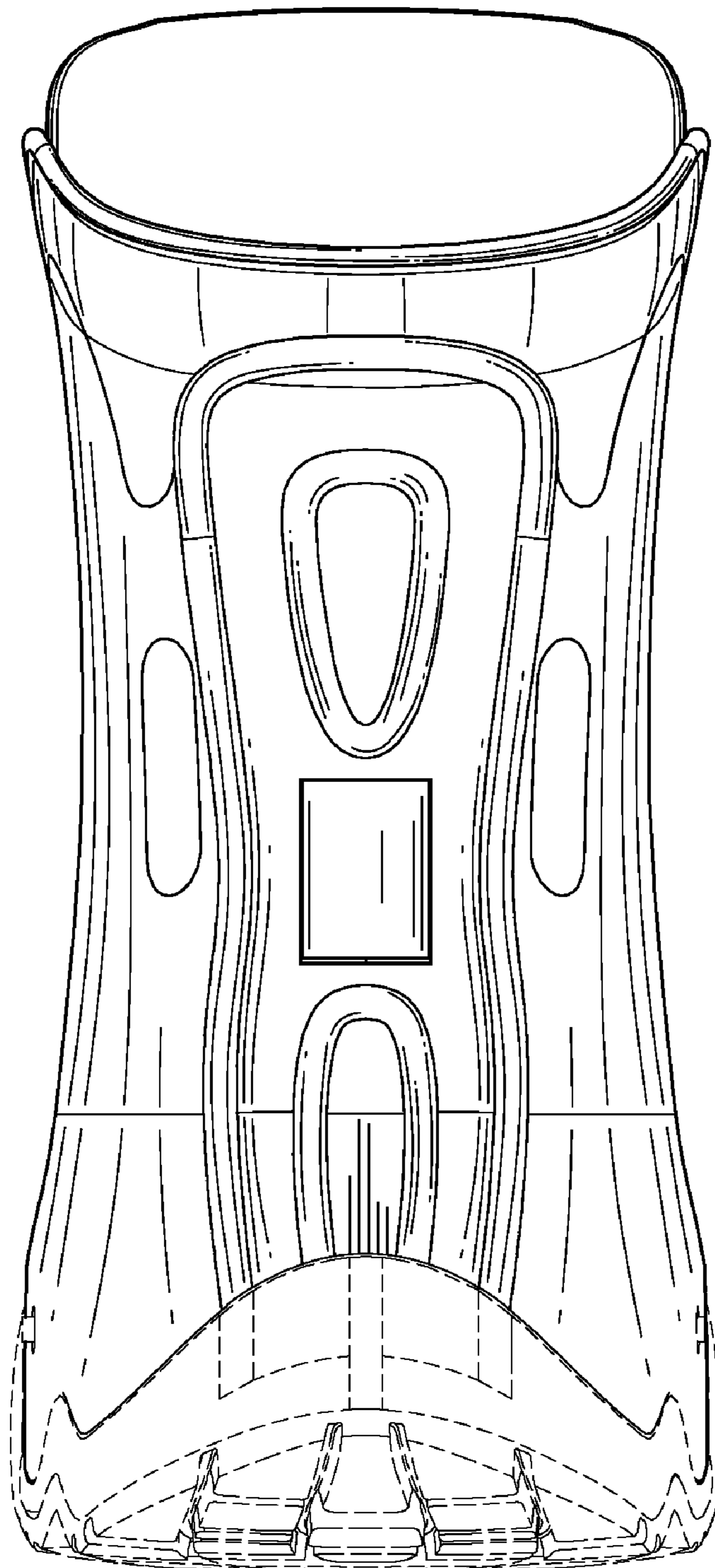

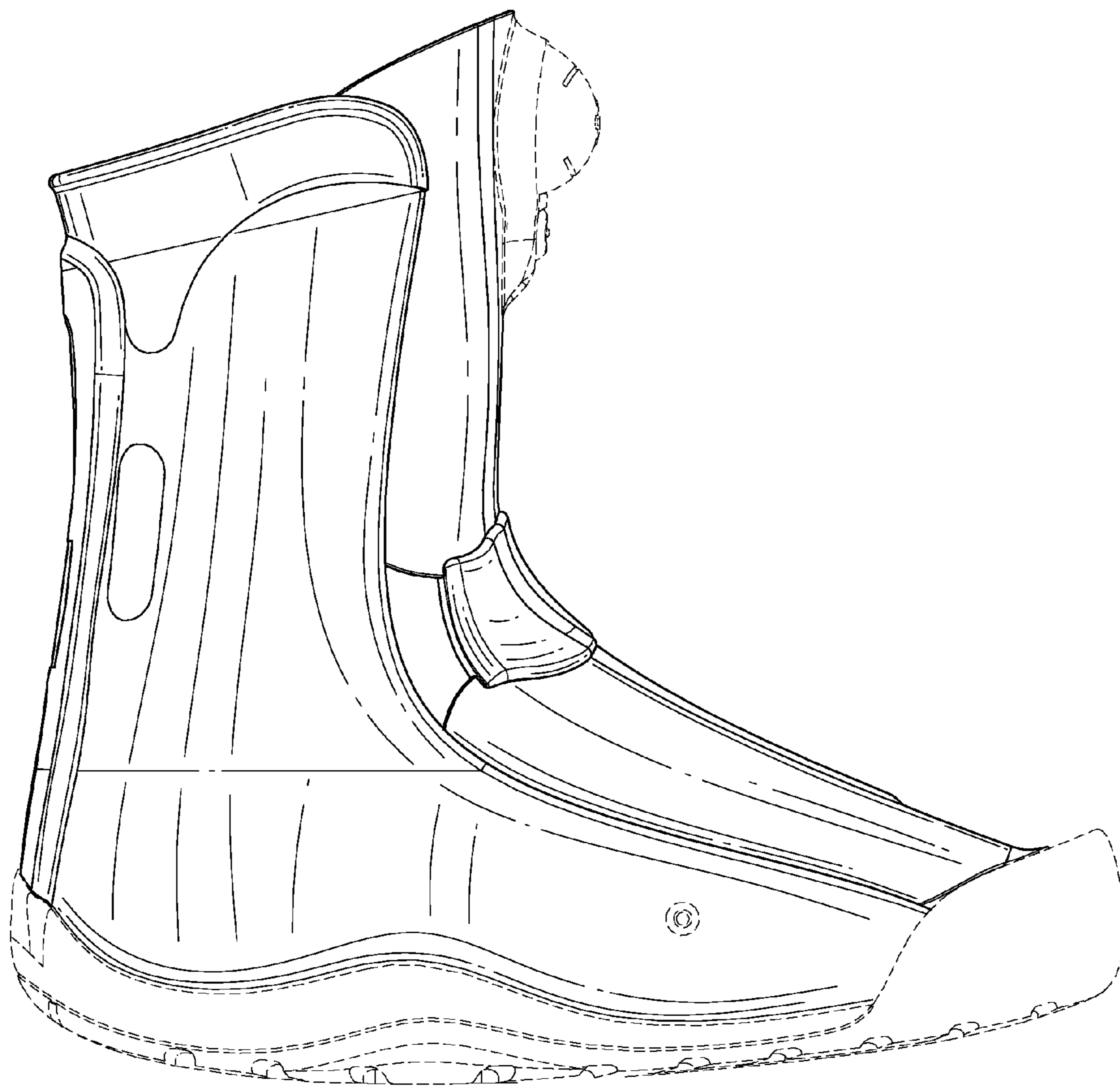

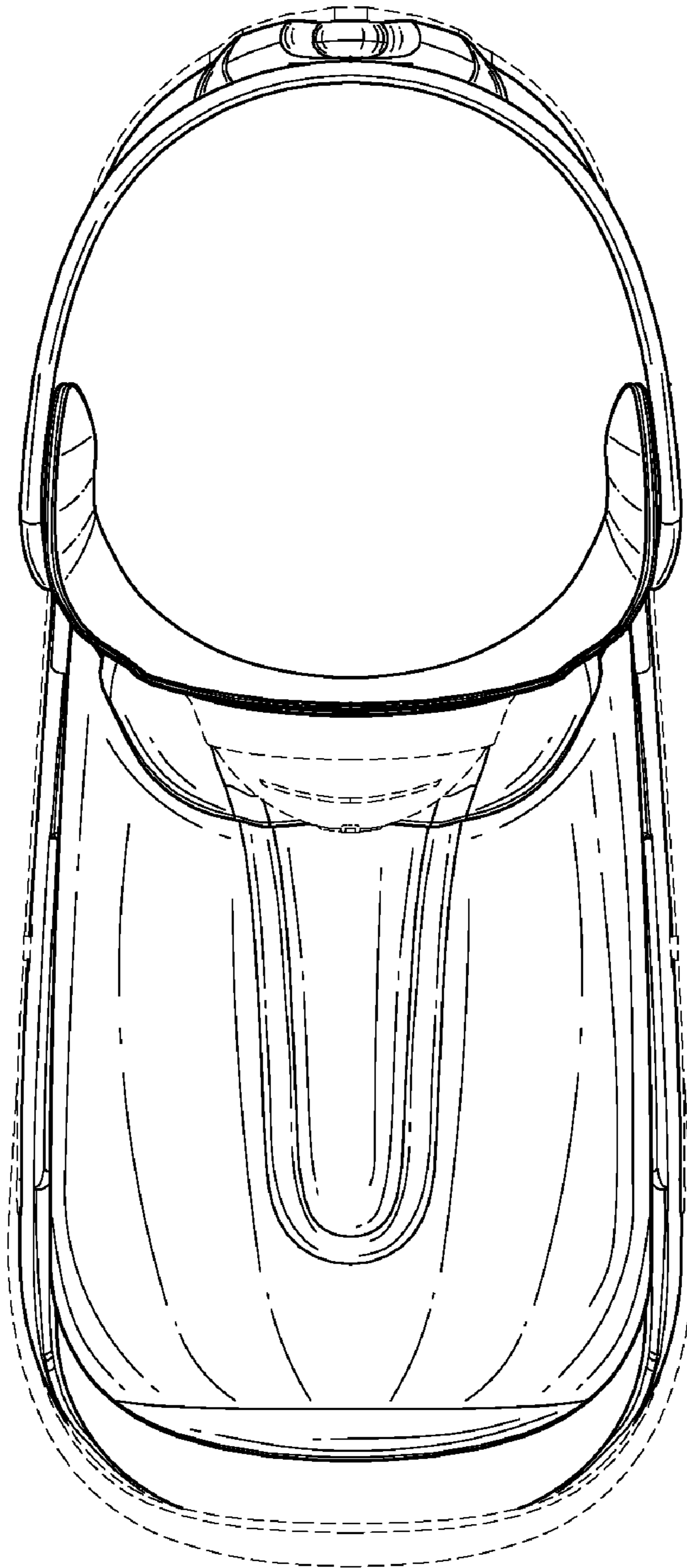
