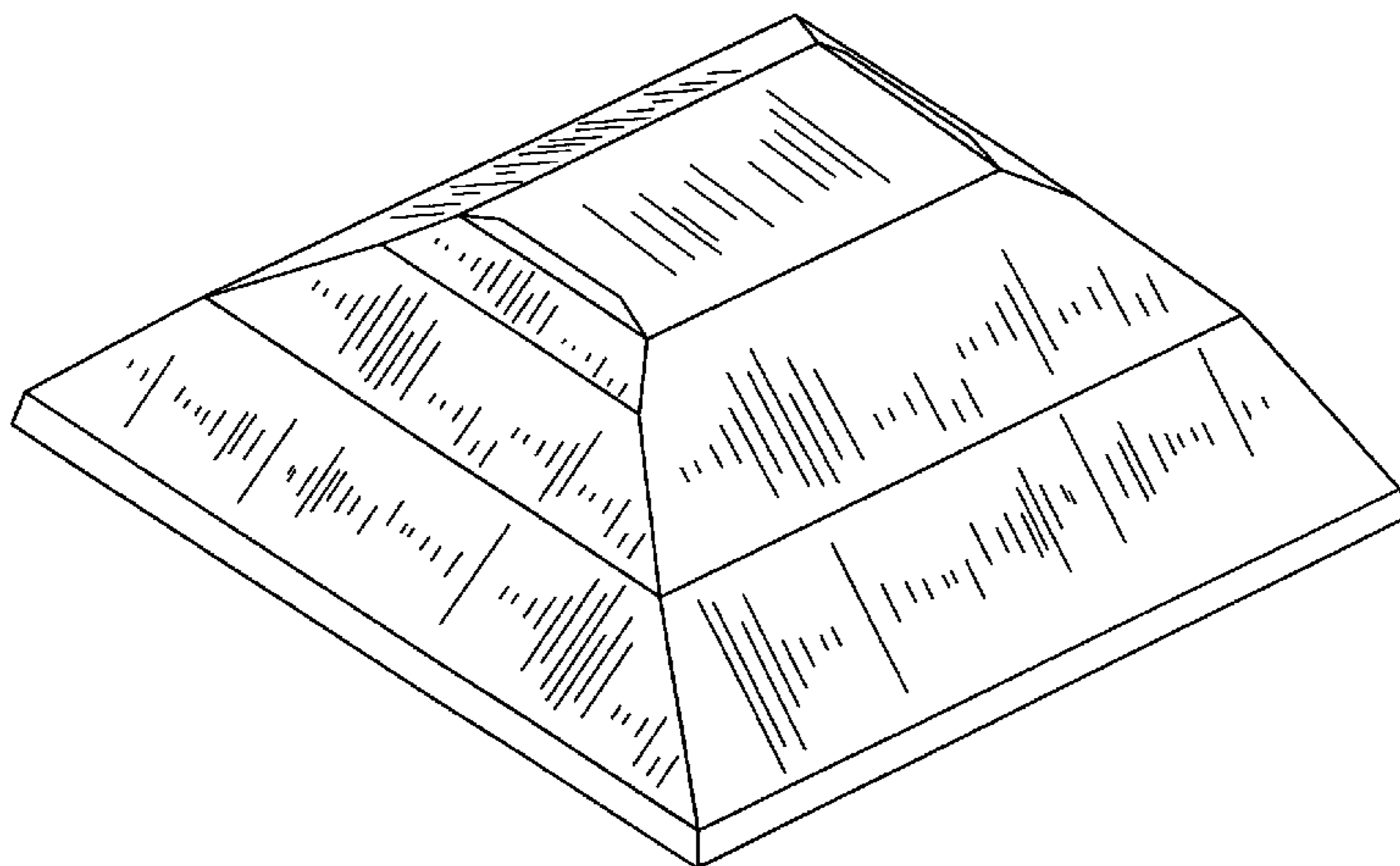
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left perspective side view;

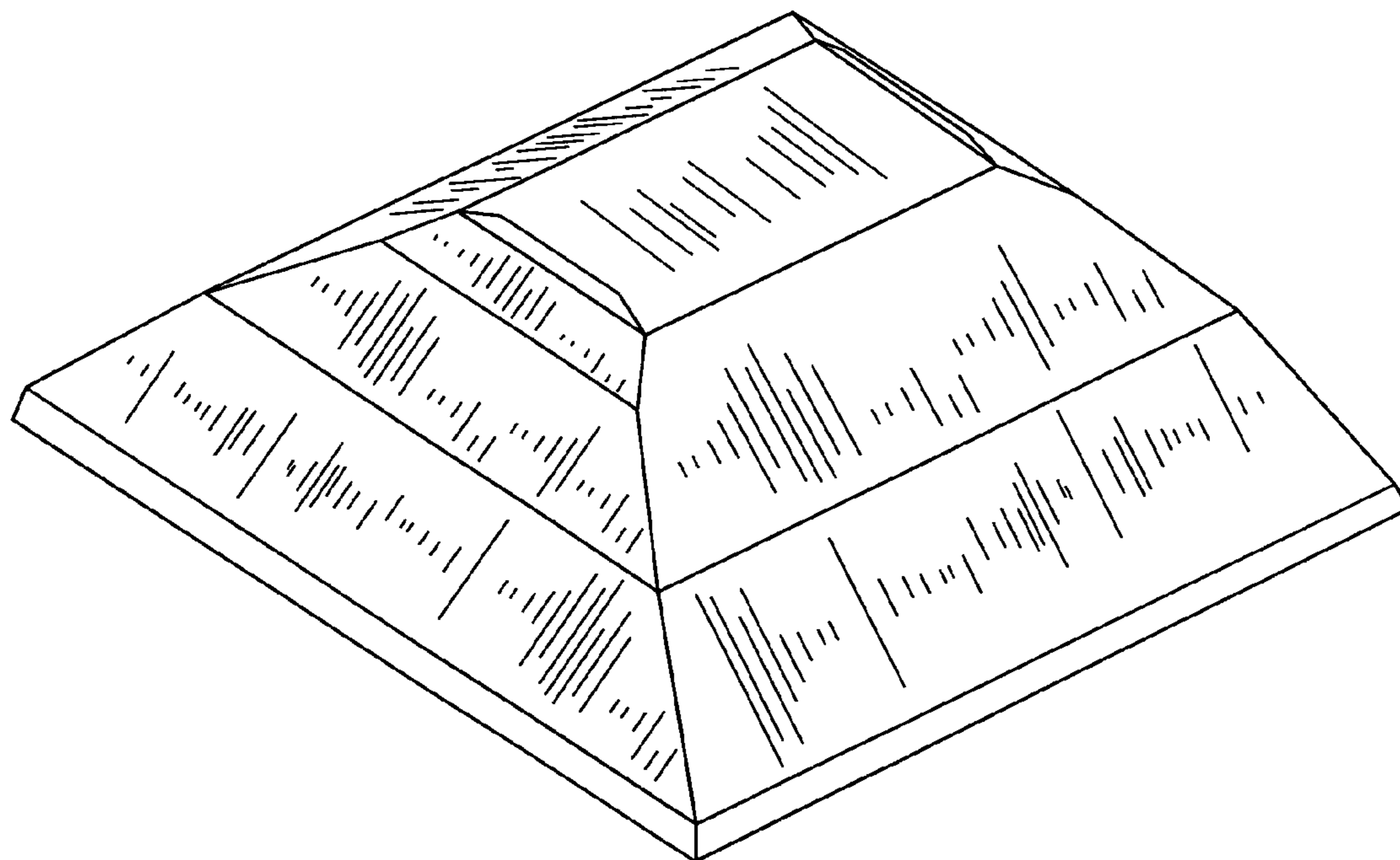

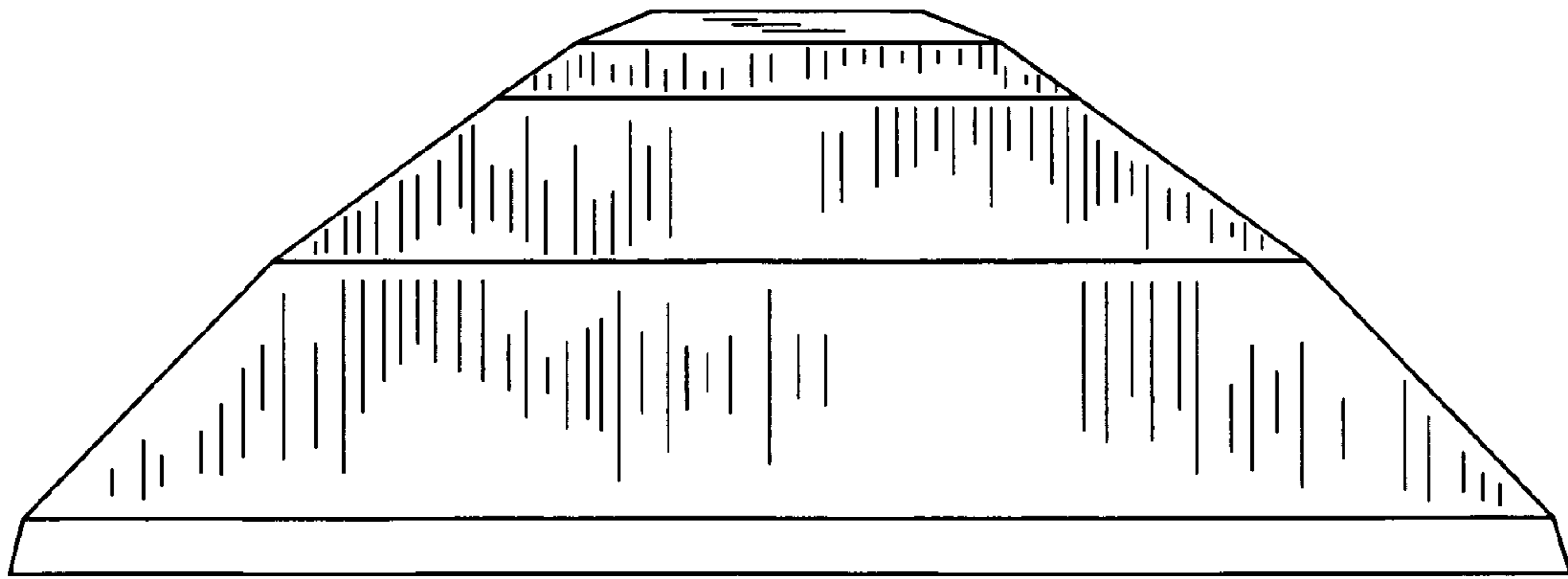

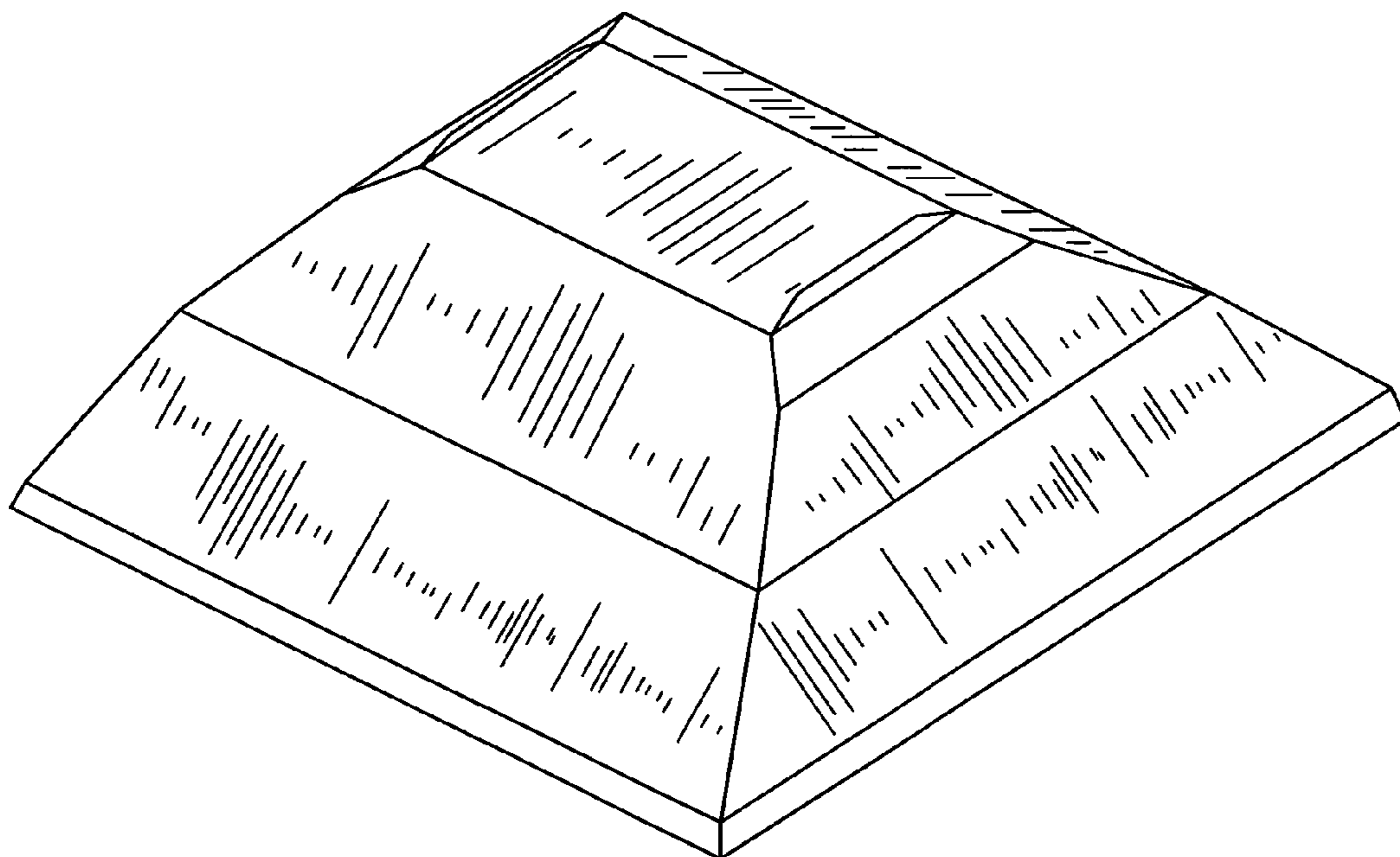

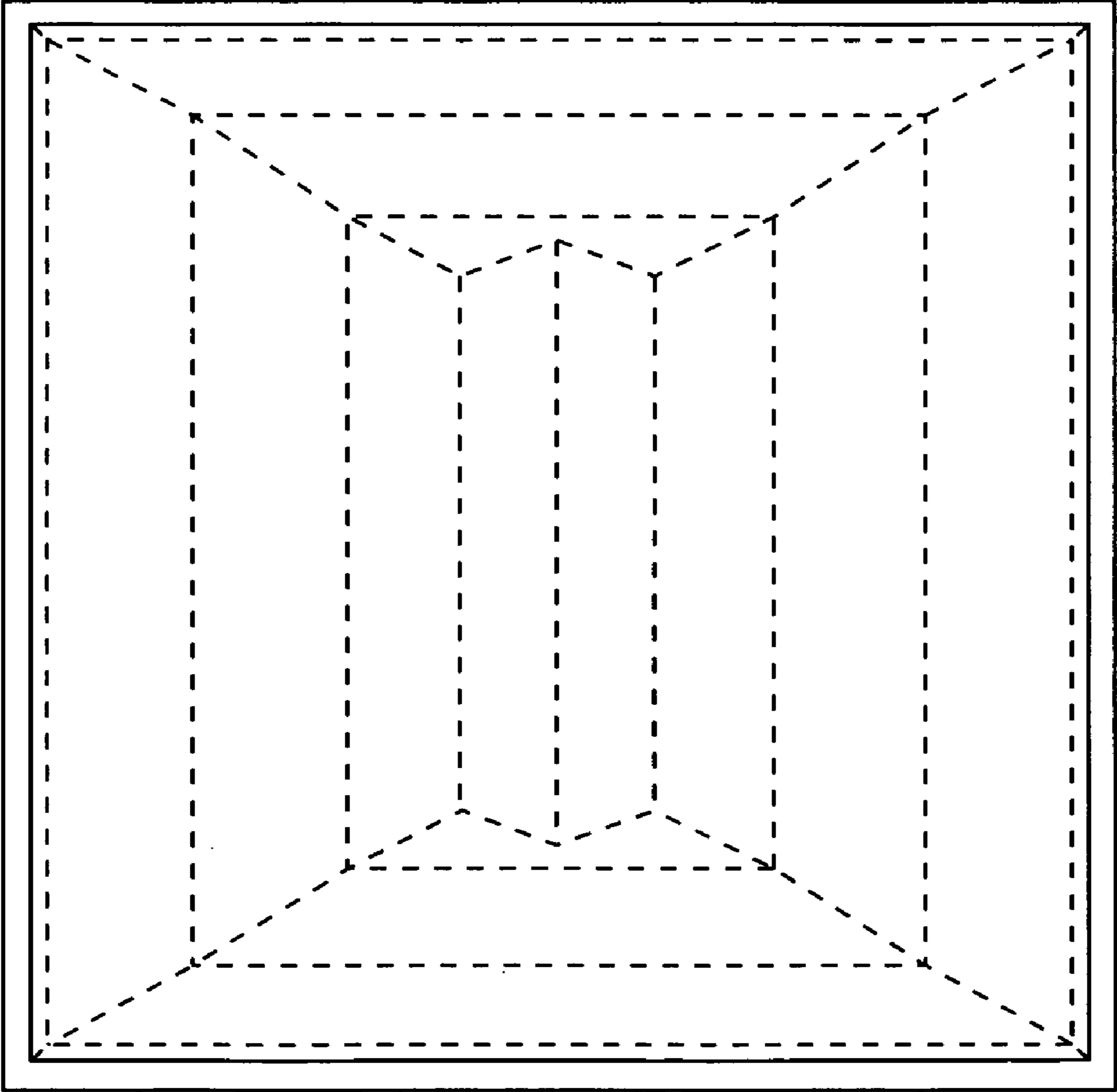

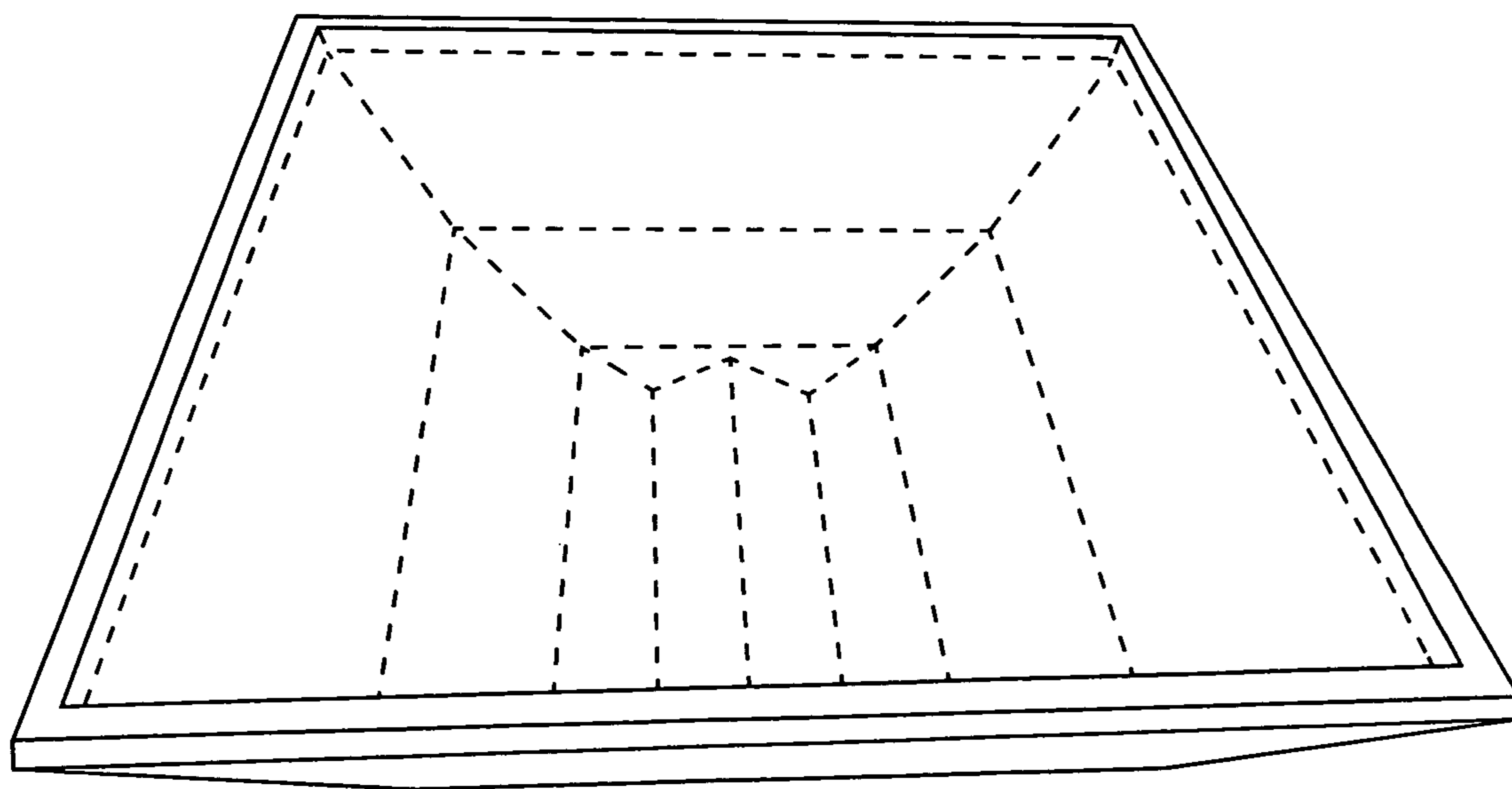

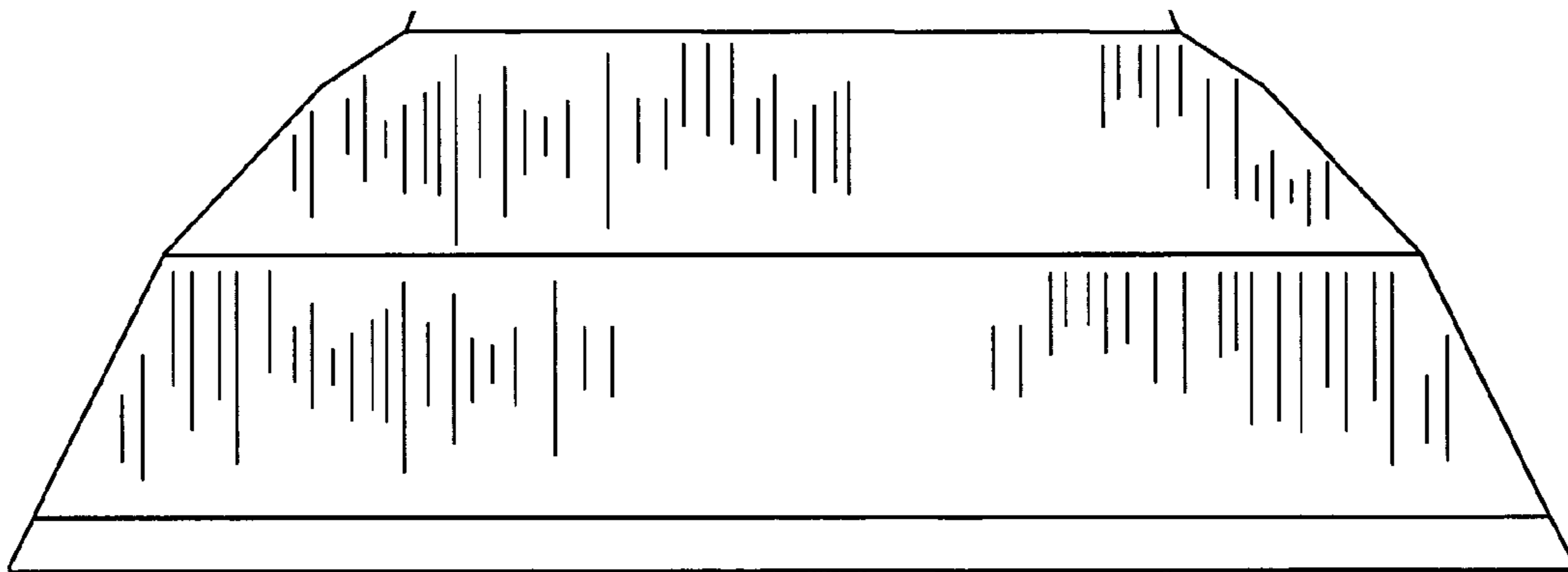

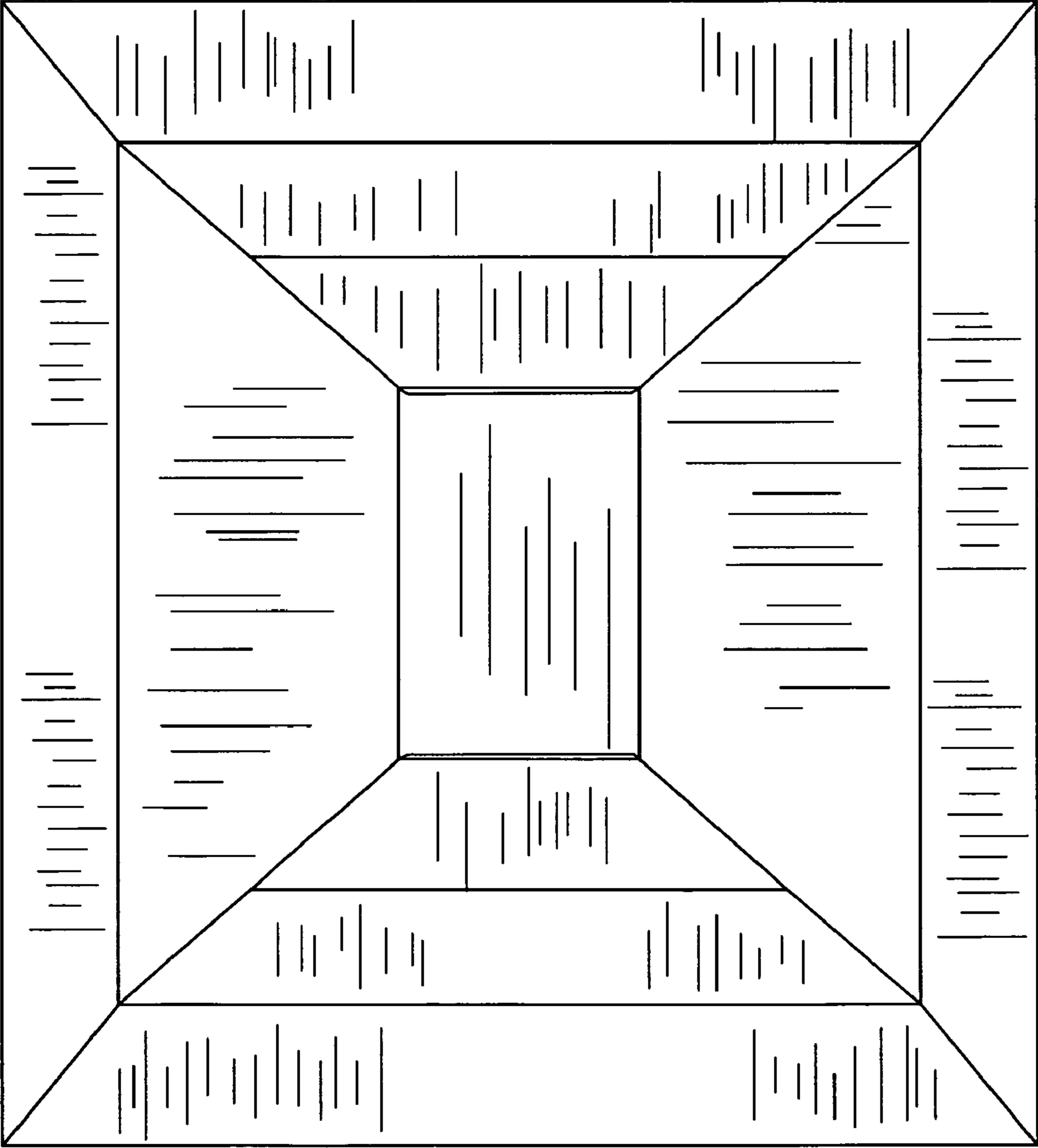
