(57) **CLAIM**

The ornamental design for a glove, as shown and described.

**DESCRIPTION**

FIG. 1 is an orthographic view of a first embodiment of a glove. The hand shown in broken lines illustrates the claimed design when being worn. The broken-line subject matter forms no part of the claimed design.

FIG. 2 is a second orthographic view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is an orthographic view of a second embodiment of the glove of FIG. 1;

FIG. 8 is a bottom plan view thereof;

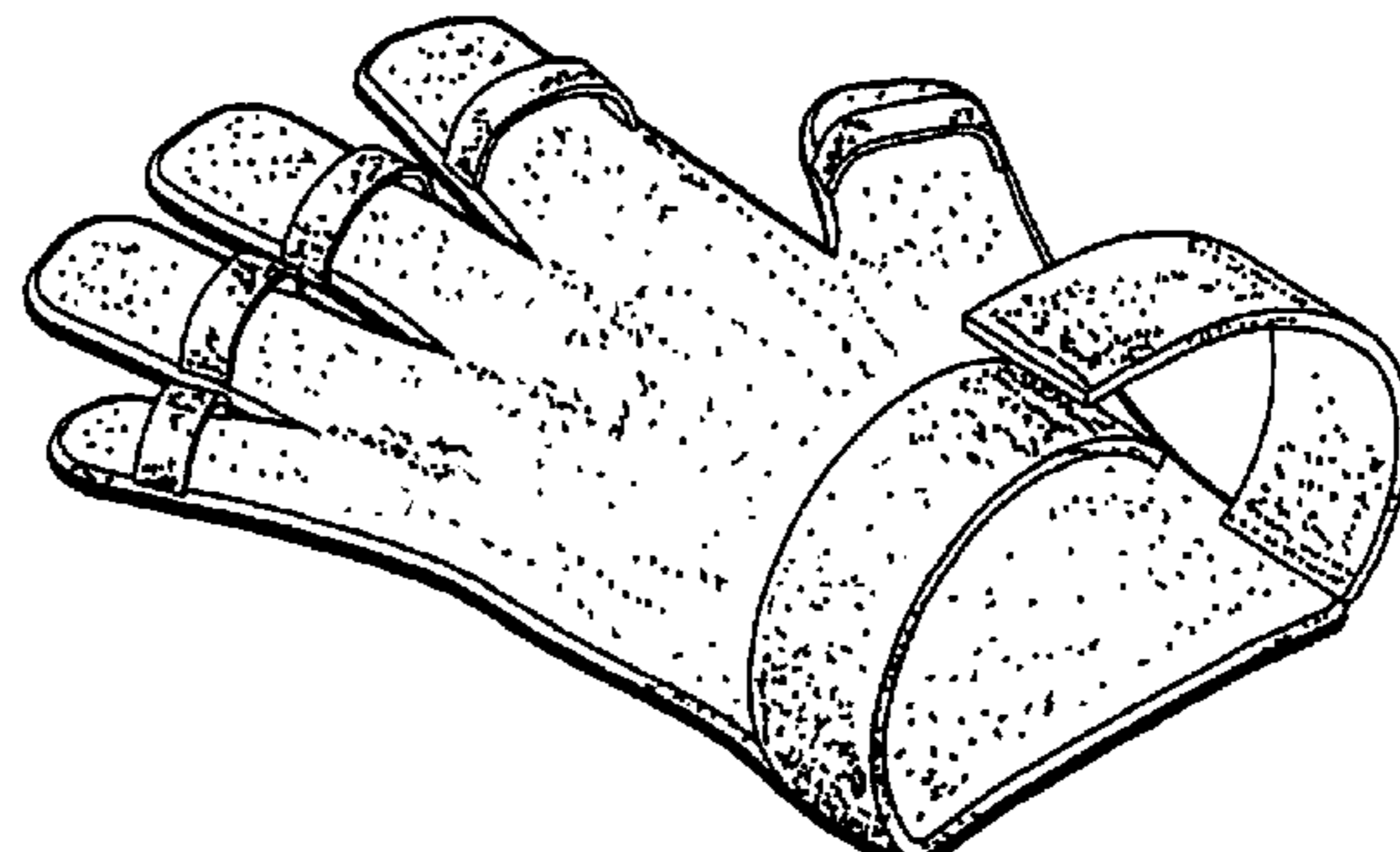
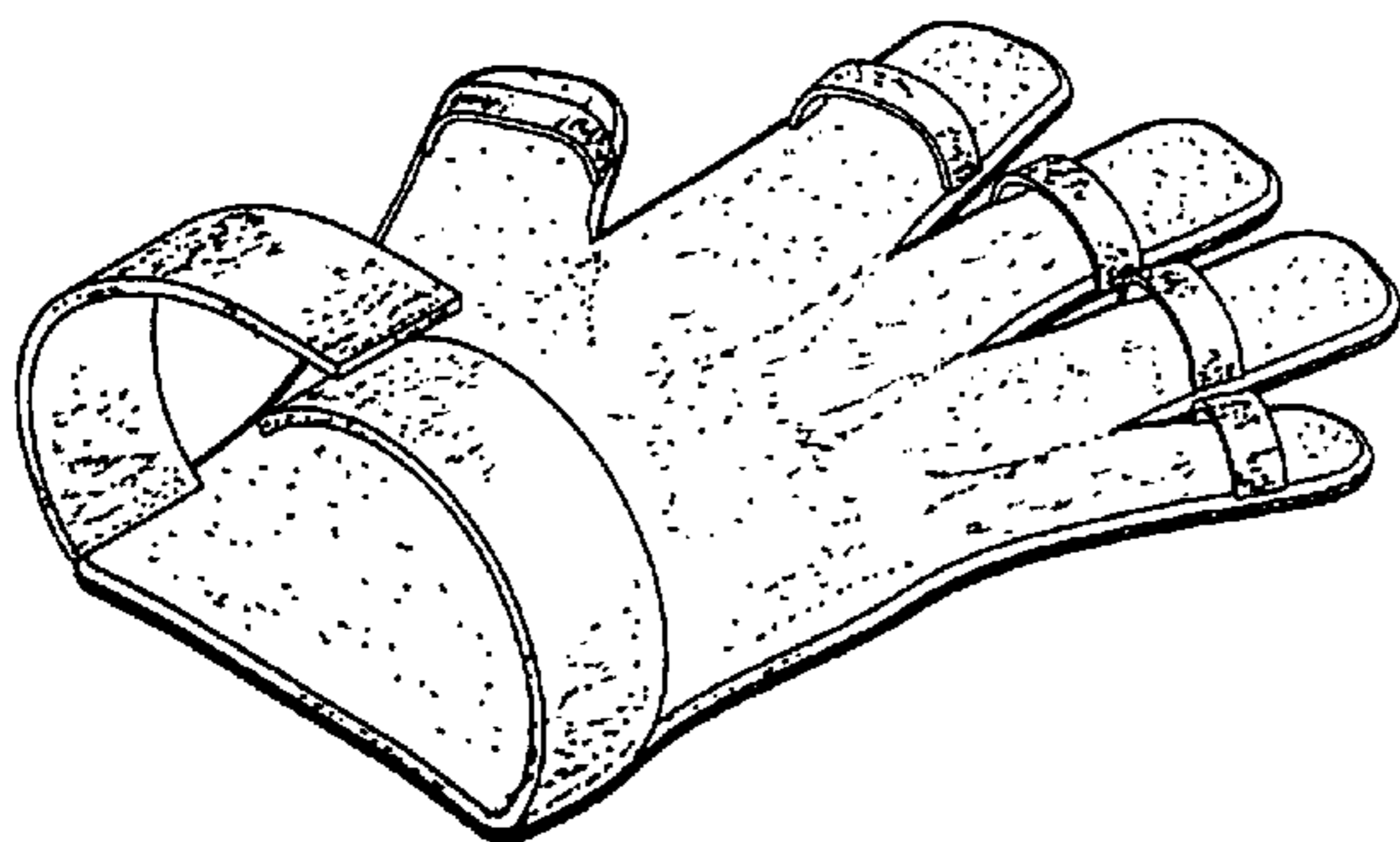
FIG. 9 is a top plan view thereof;

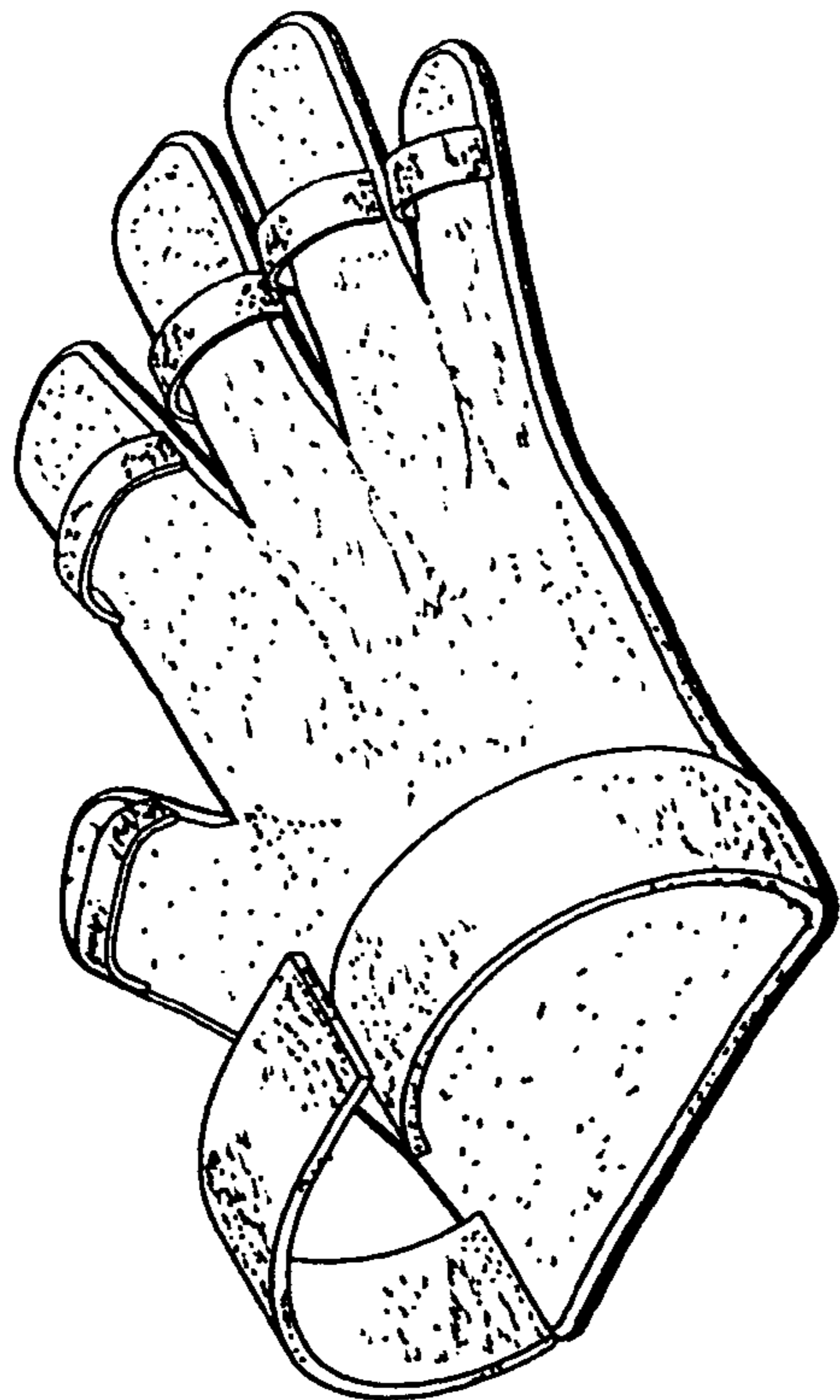

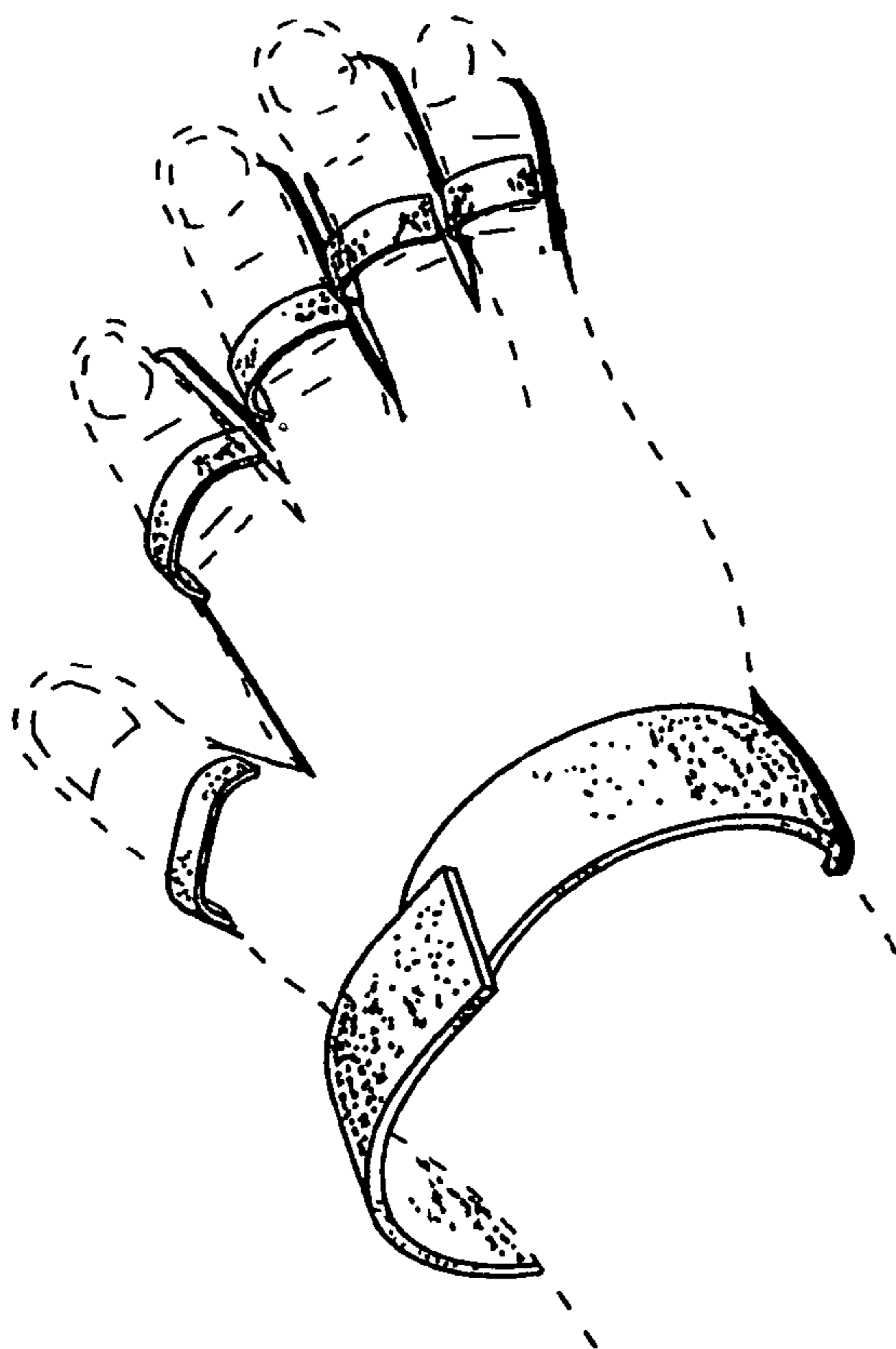

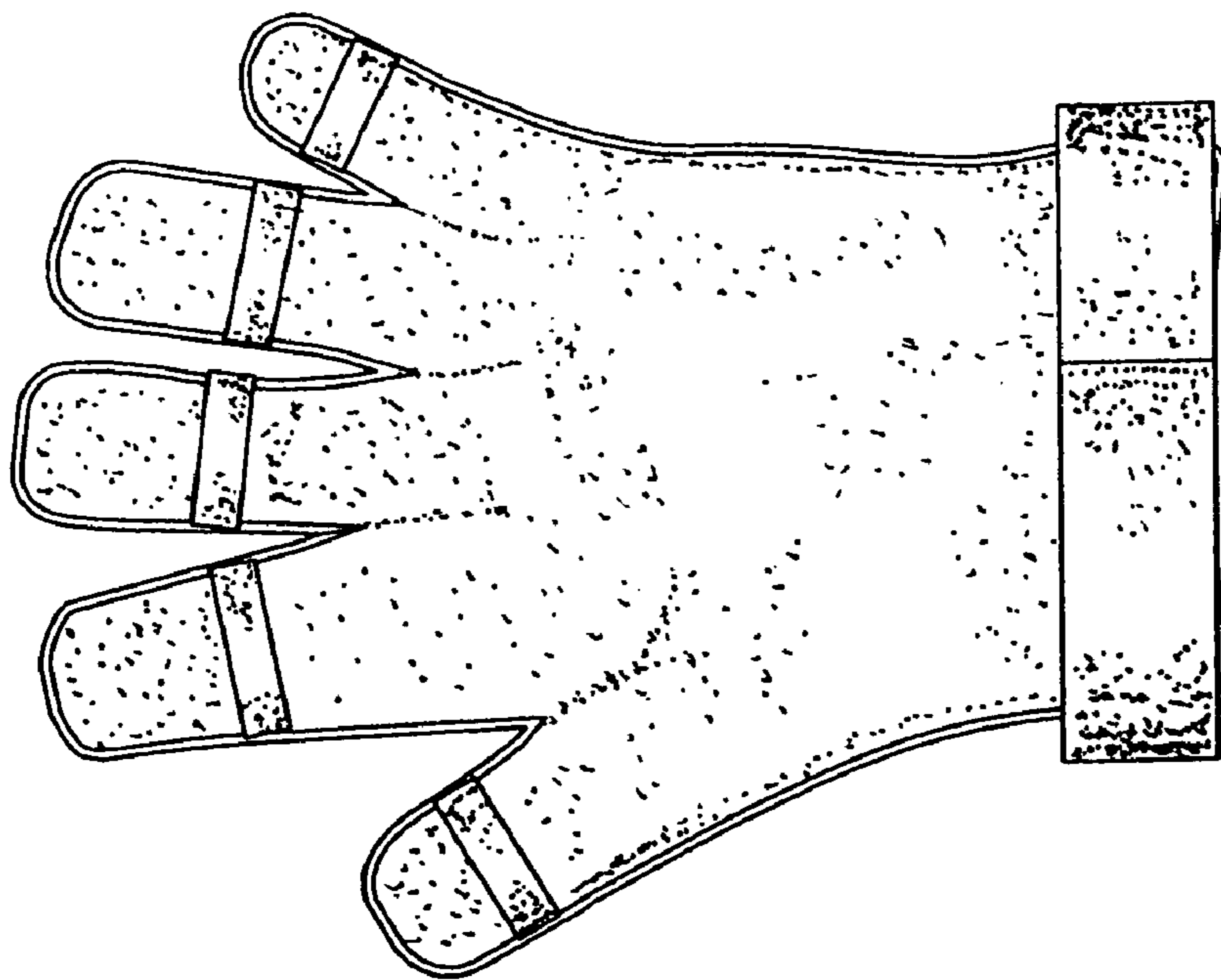

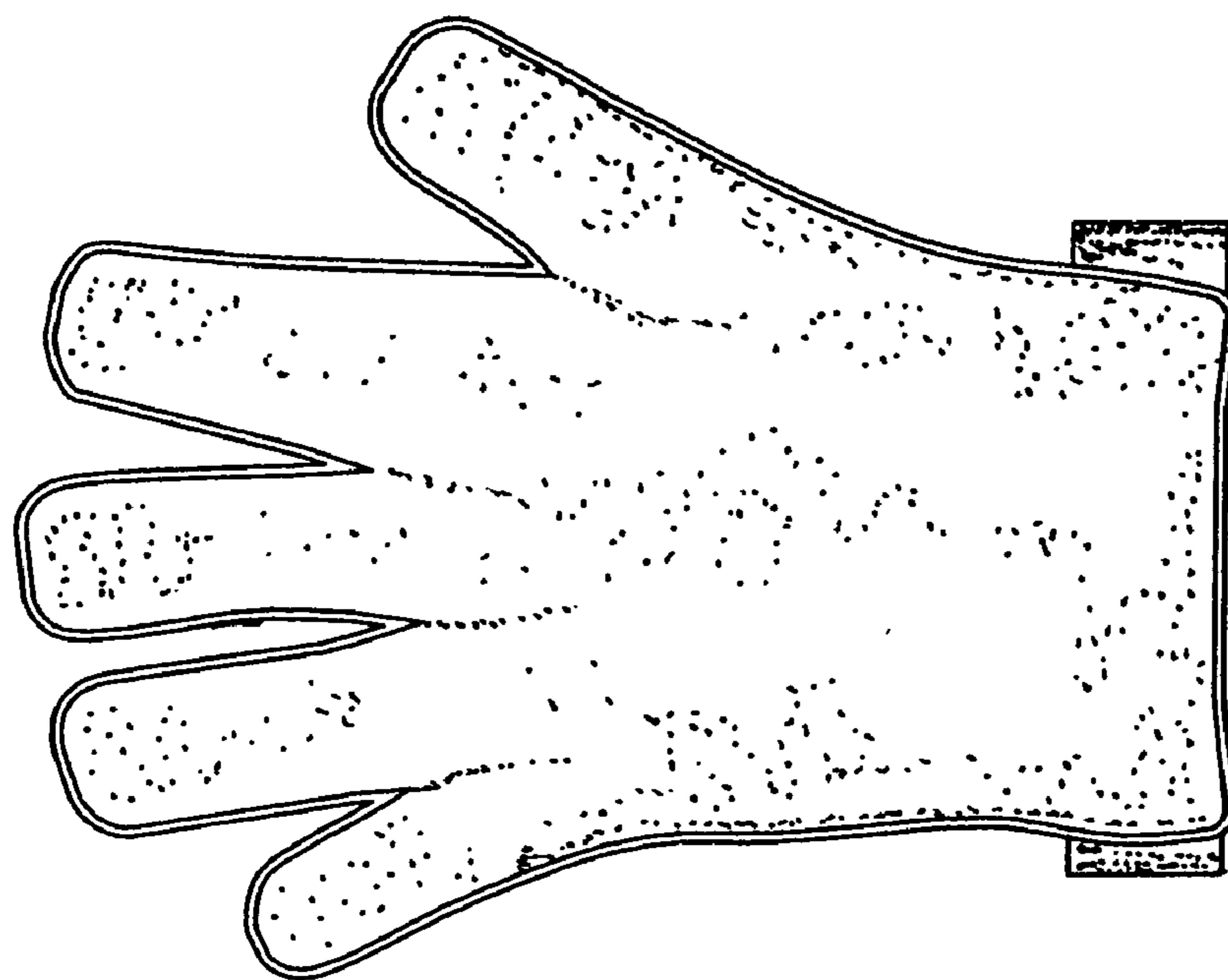

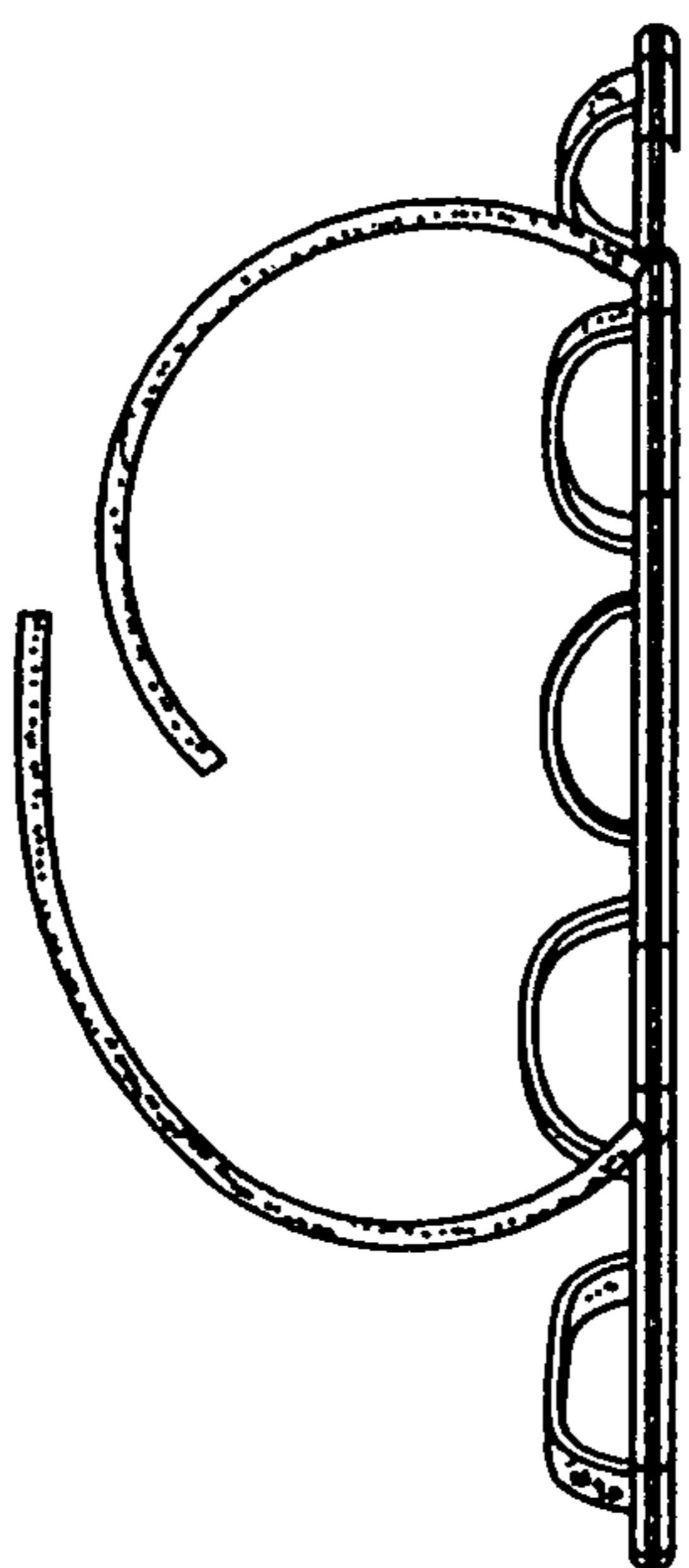

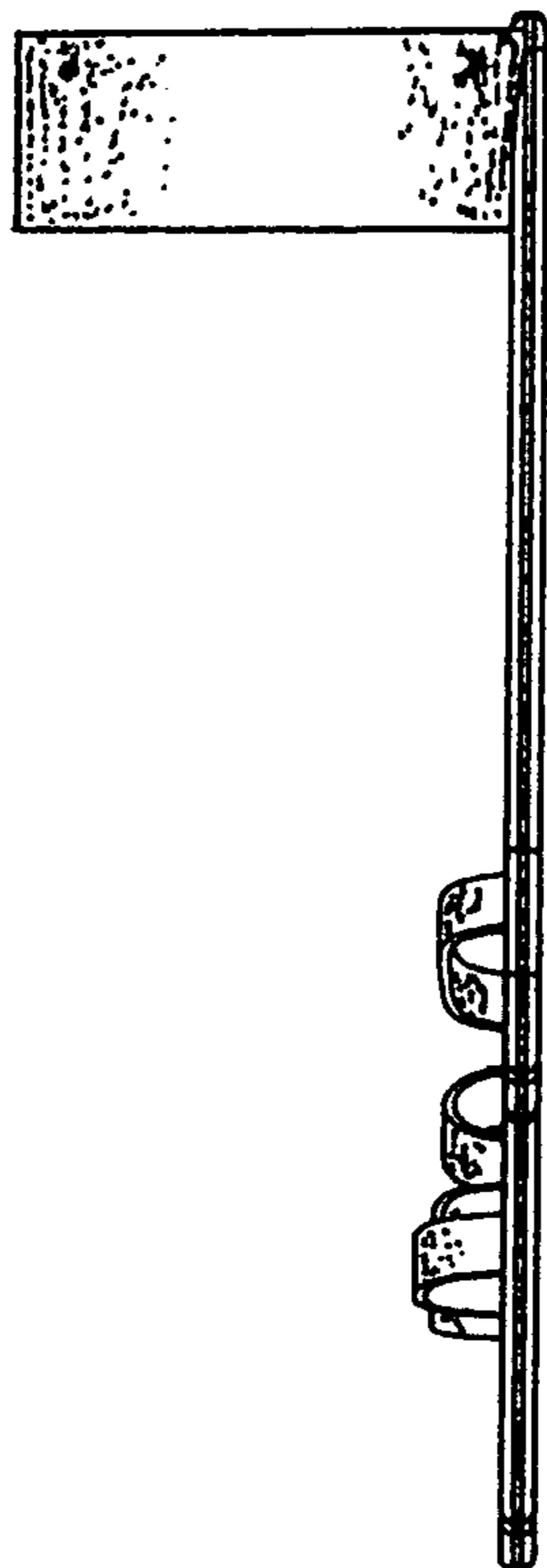

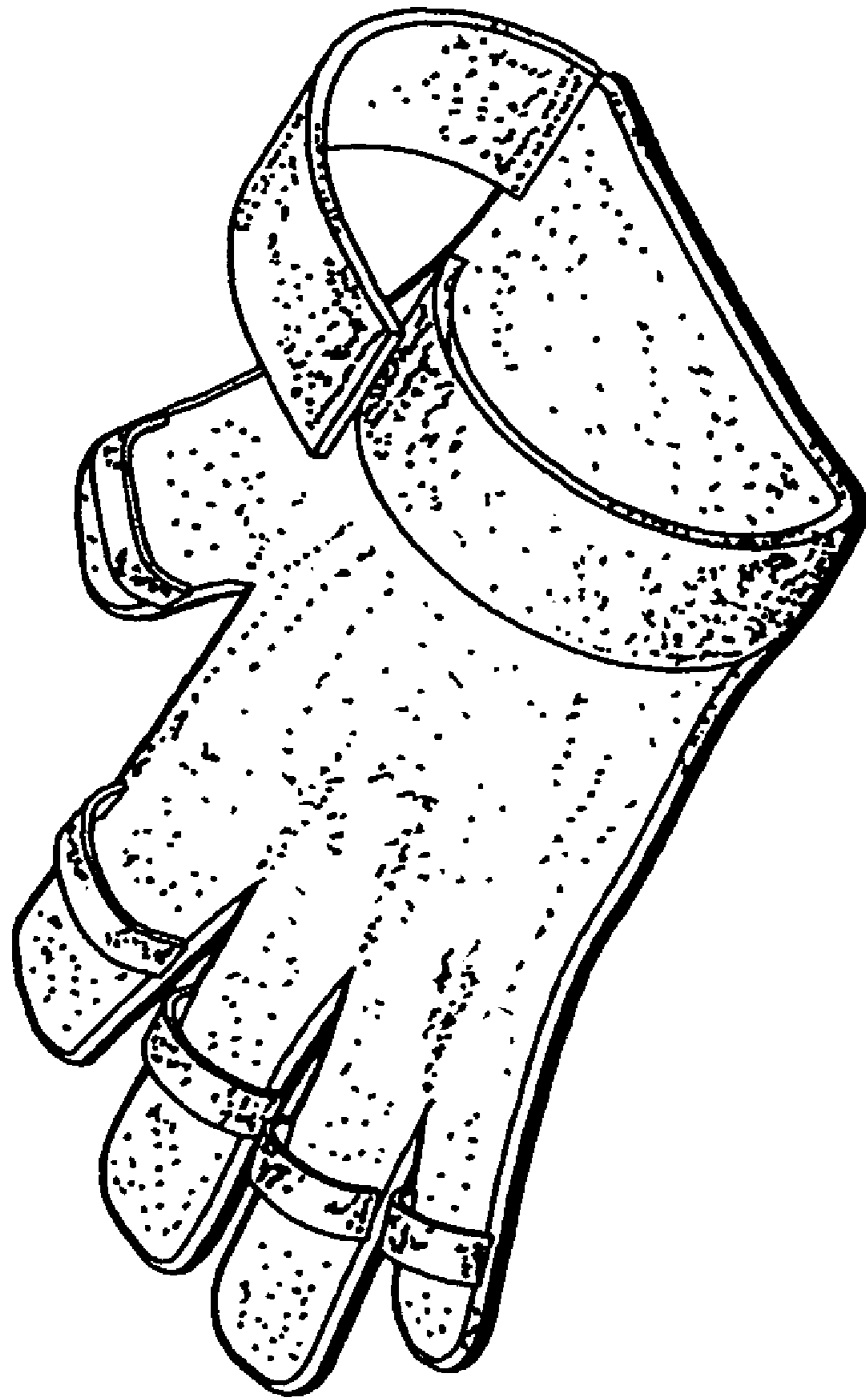

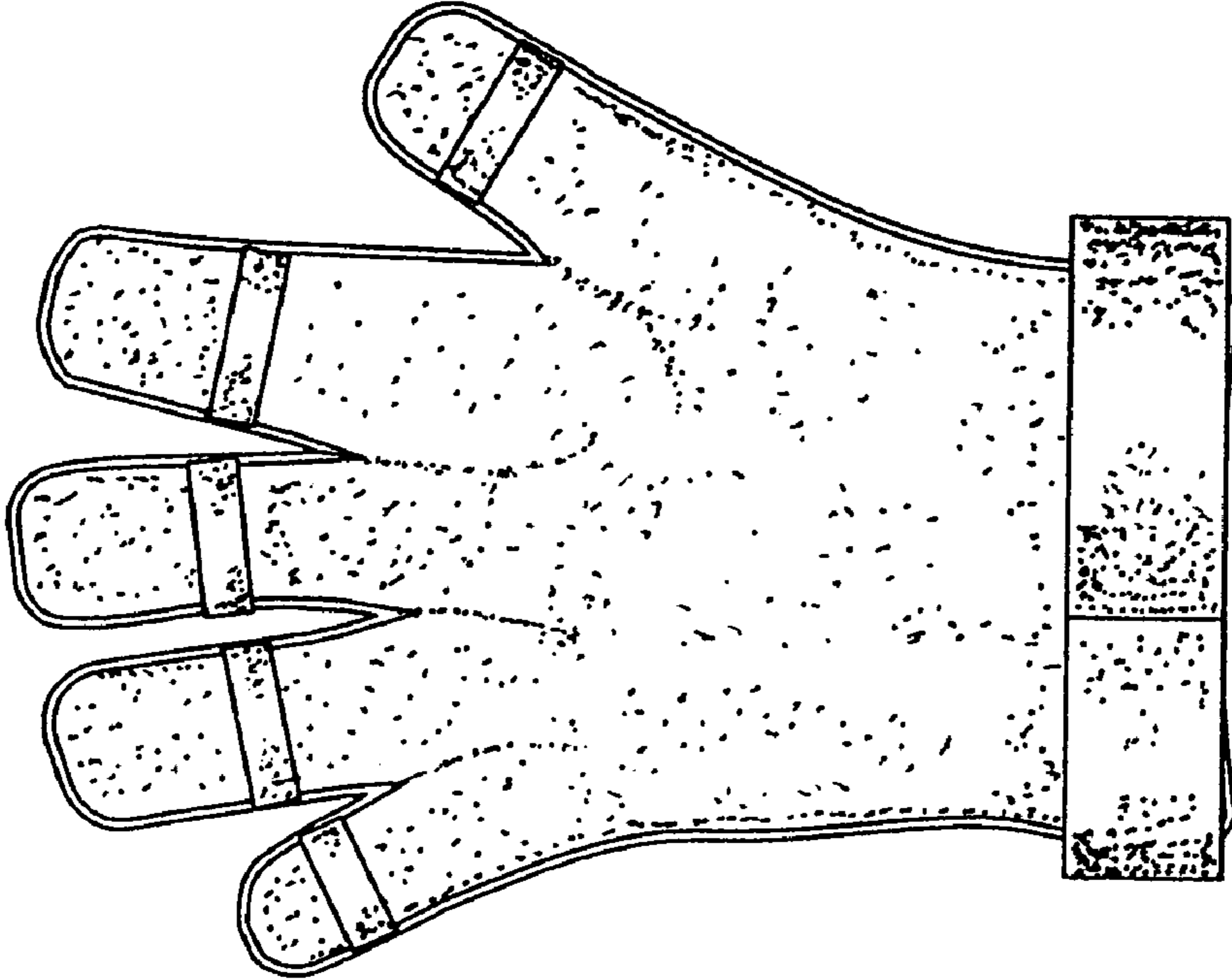

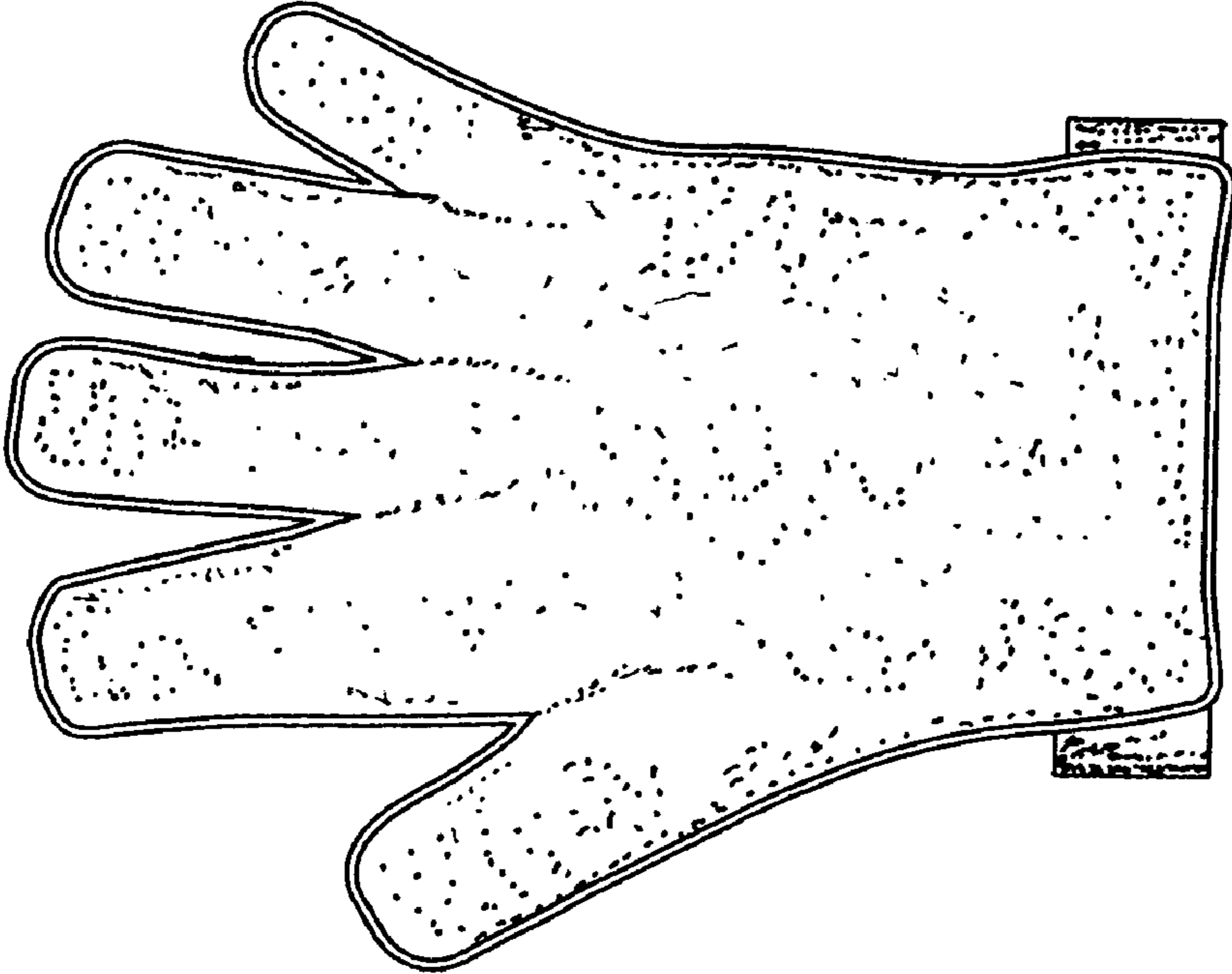

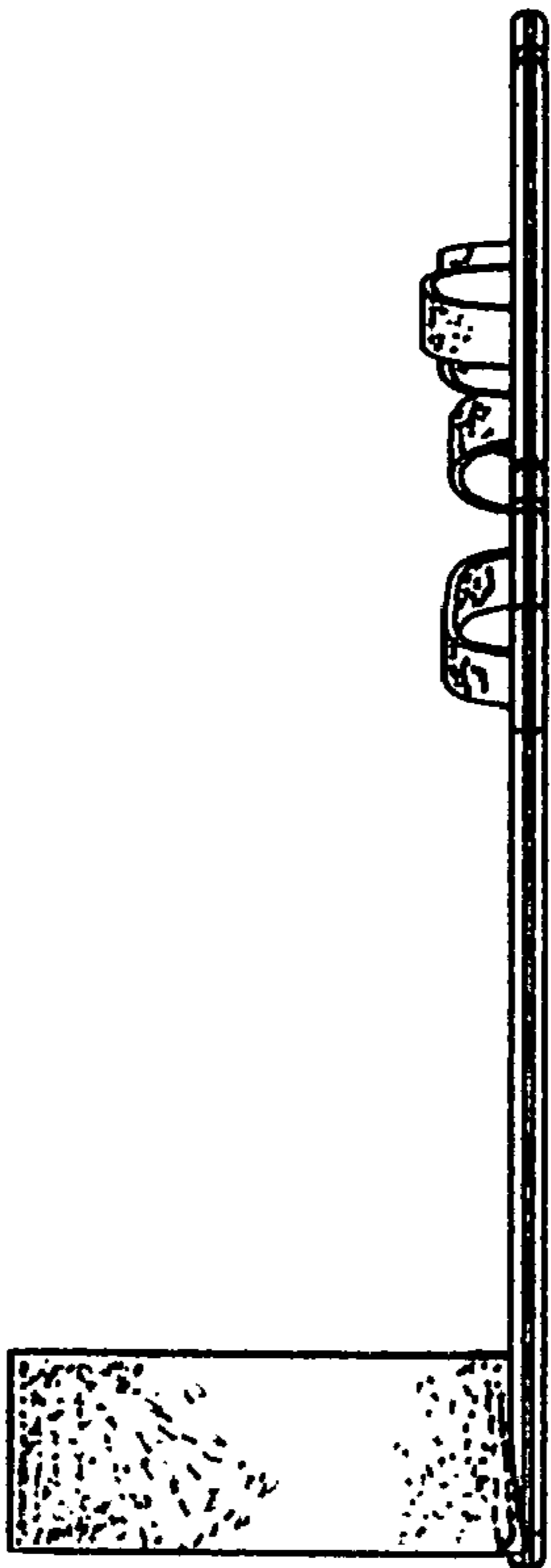

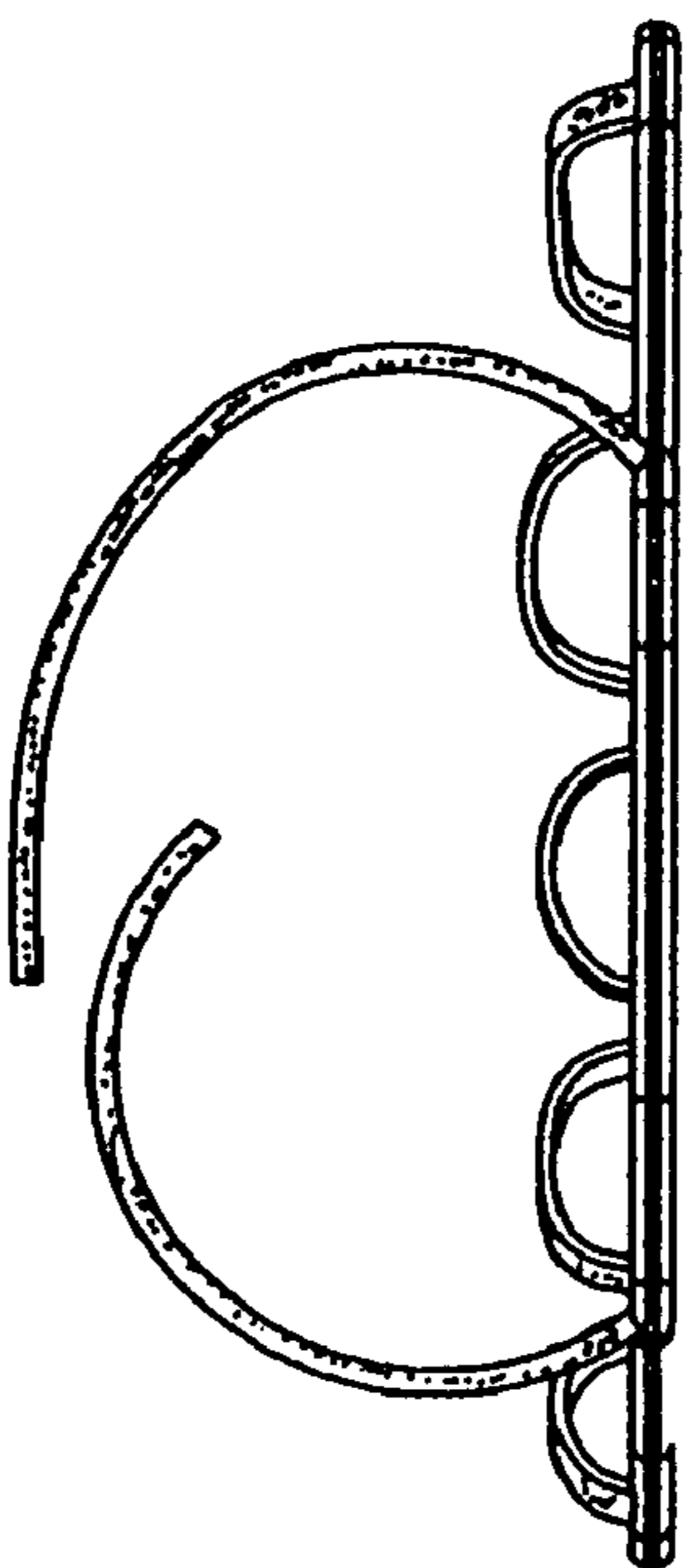
