(57) **CLAIM**

We claim the design for a pet waste collection tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the front, top, and right sides of a pet waste collection tool;

FIG. 2 is a front view of the pet waste collection tool depicted in FIG. 1;

FIG. 3 is a back view of the pet waste collection tool depicted in FIG. 1;

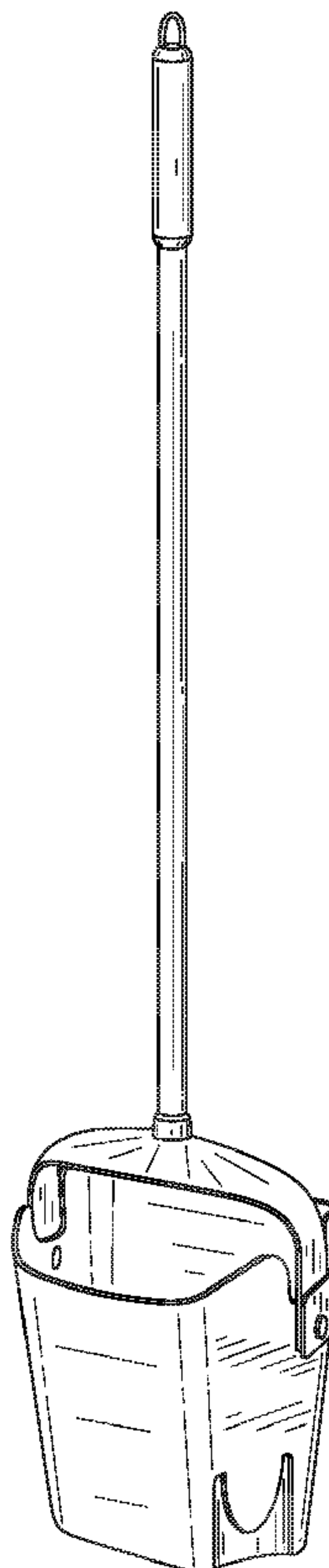
FIG. 4 is a right side view of the pet waste collection tool depicted in FIG. 1;

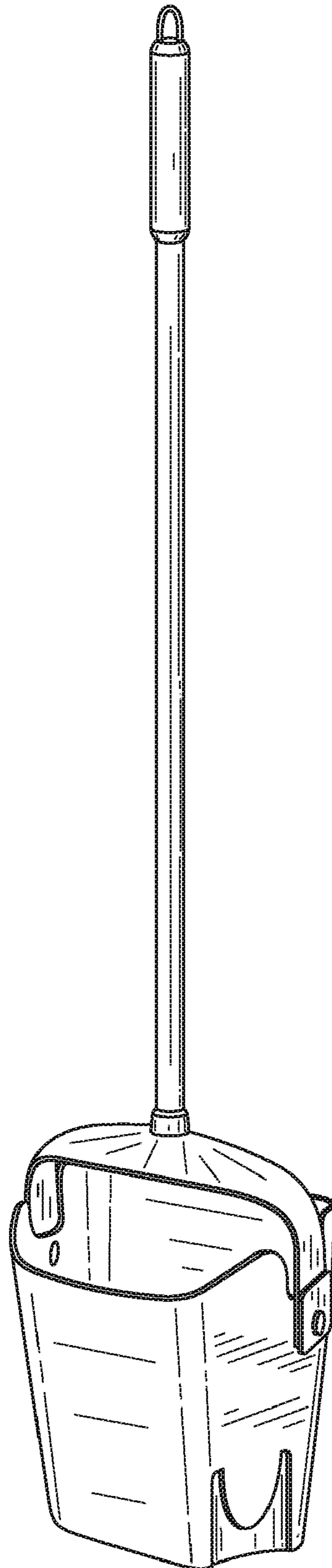

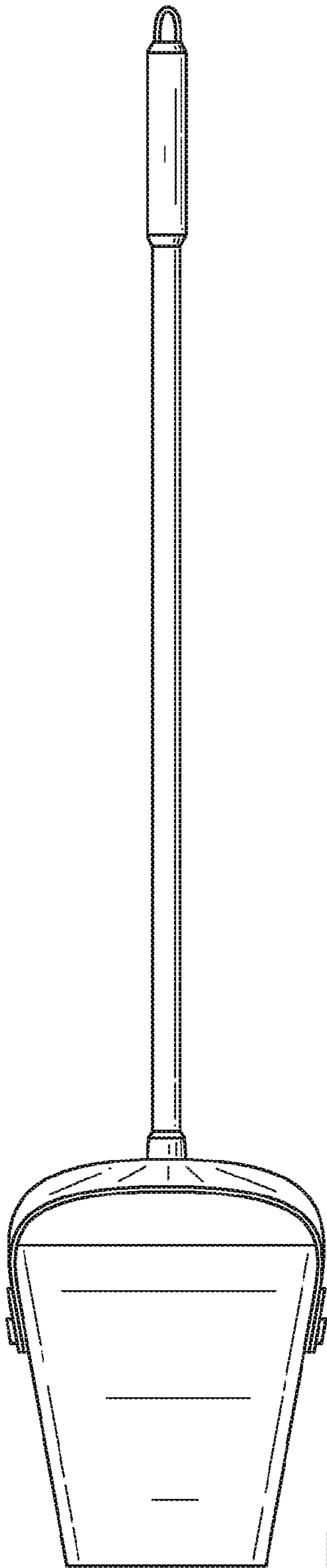

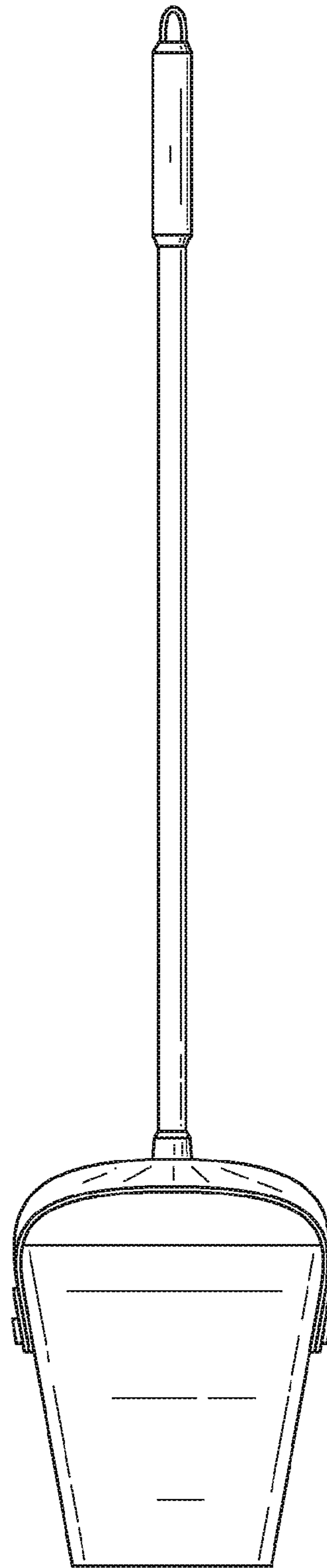

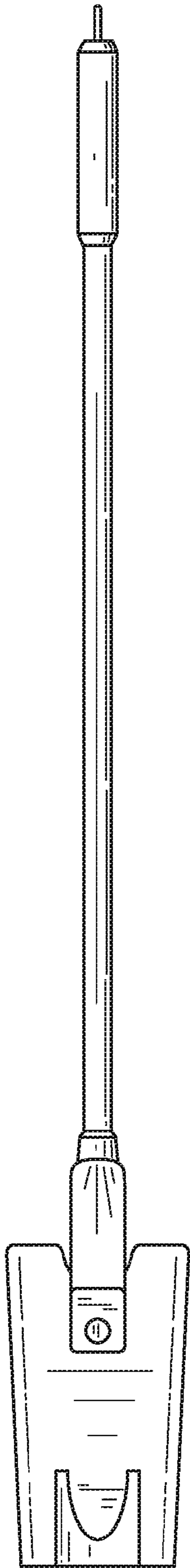

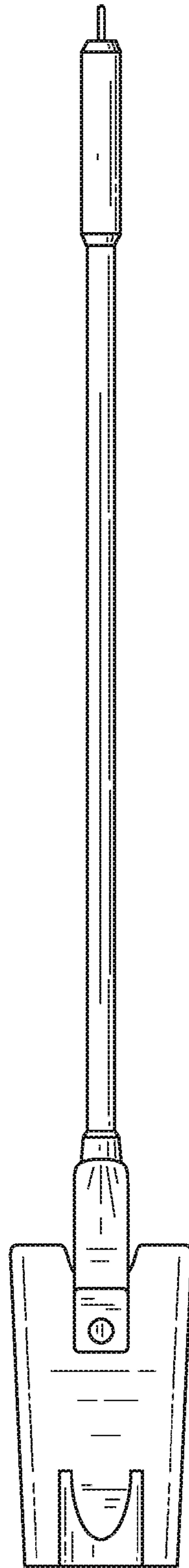

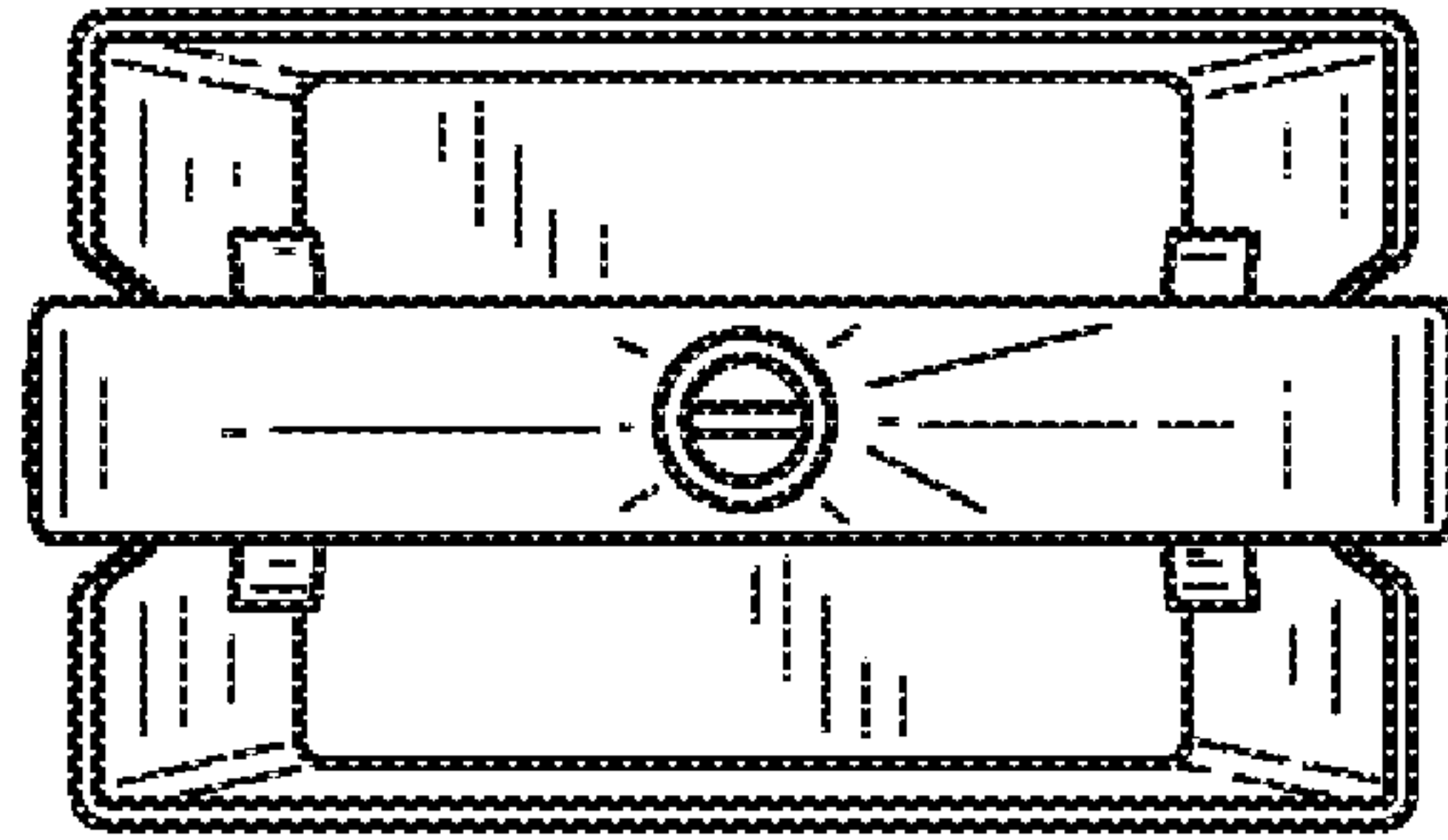

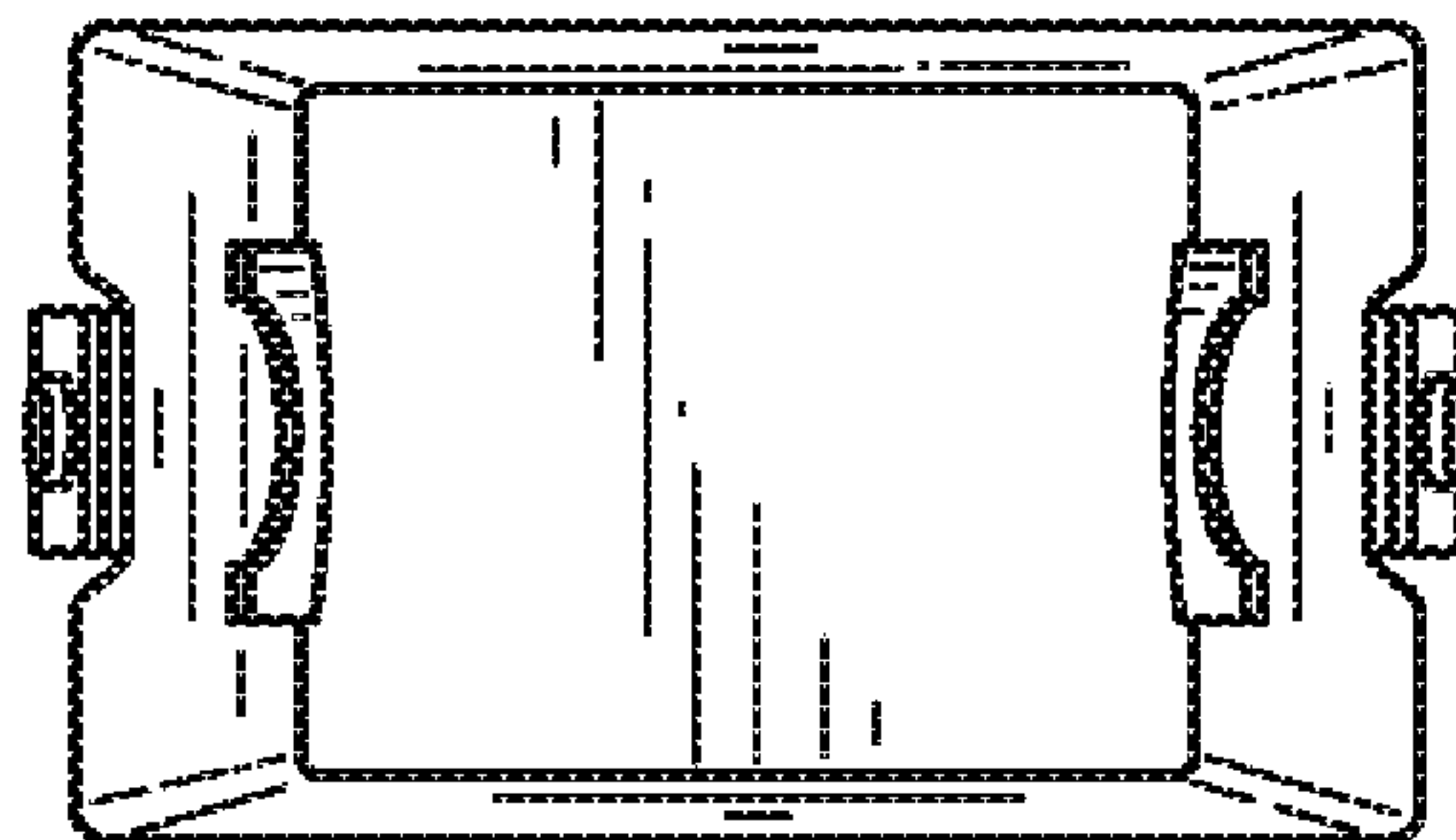
