**DESCRIPTION**

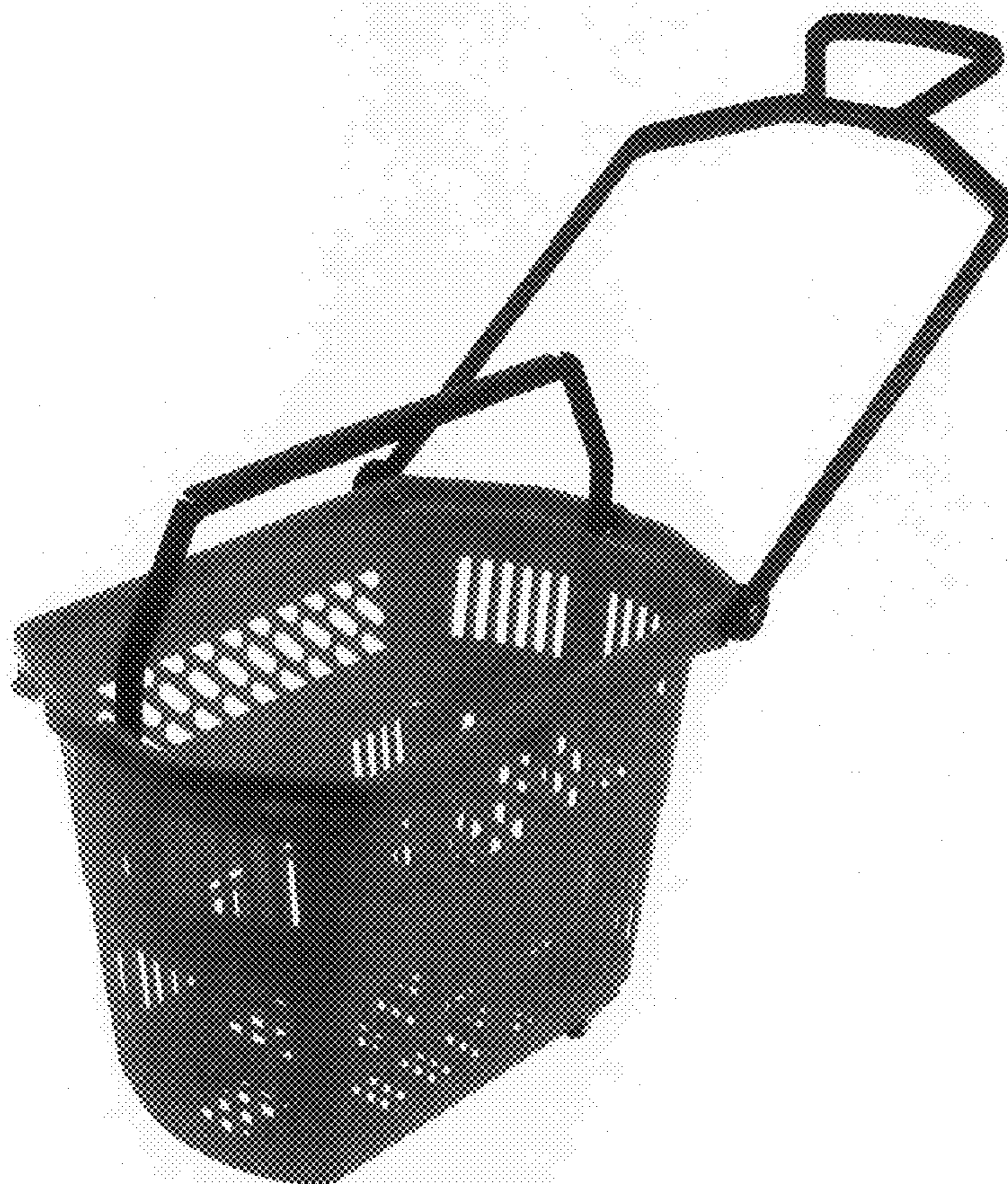

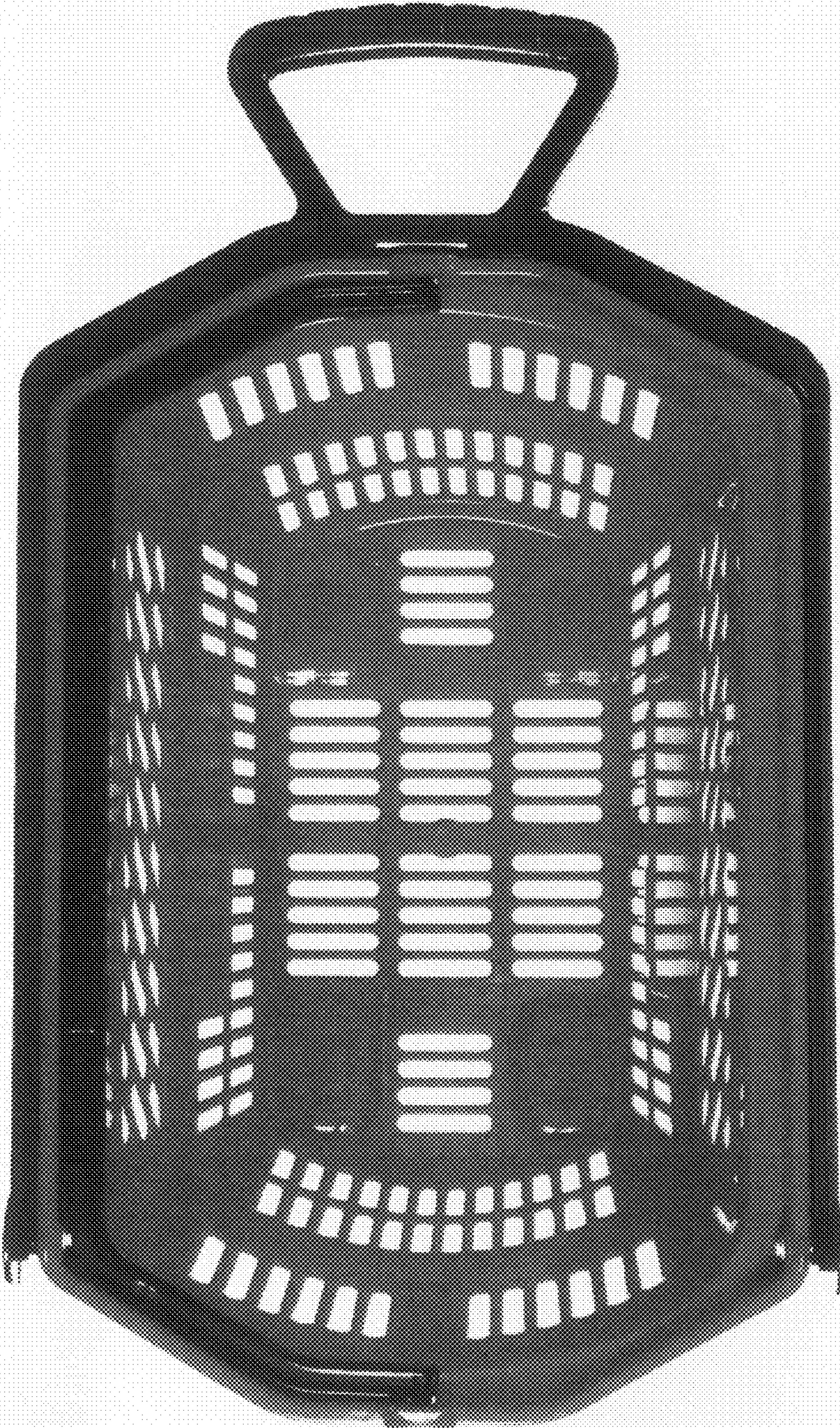

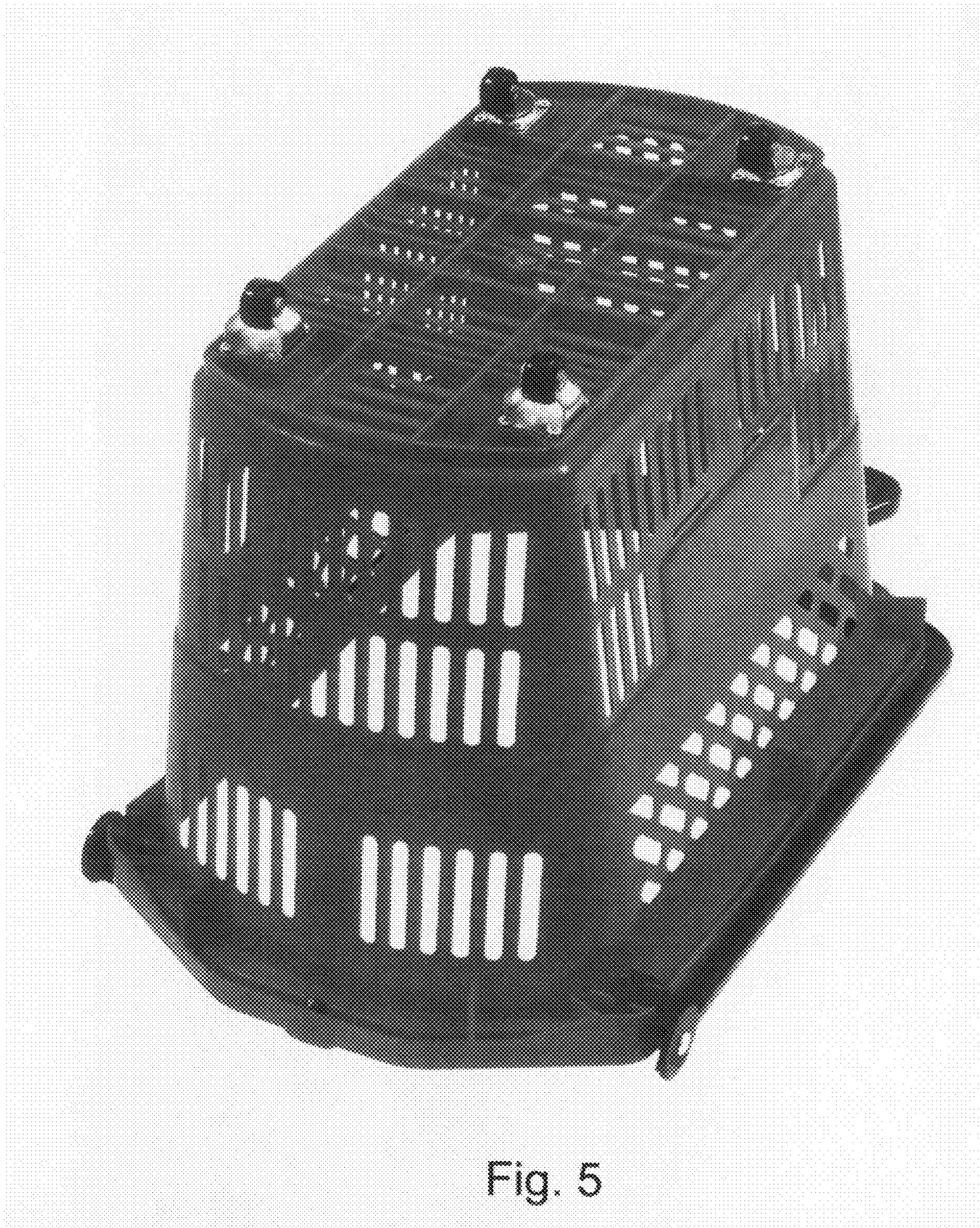

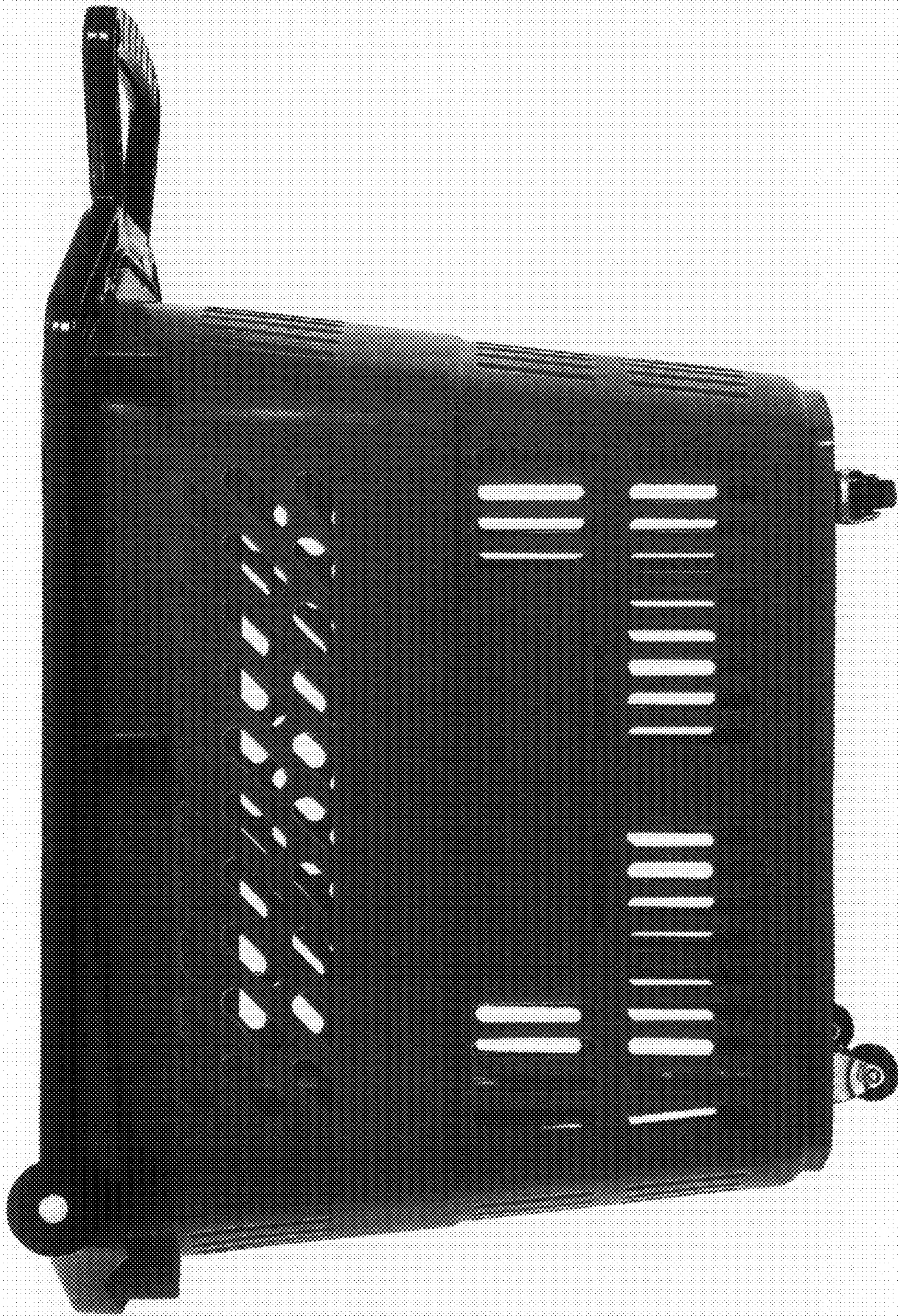
