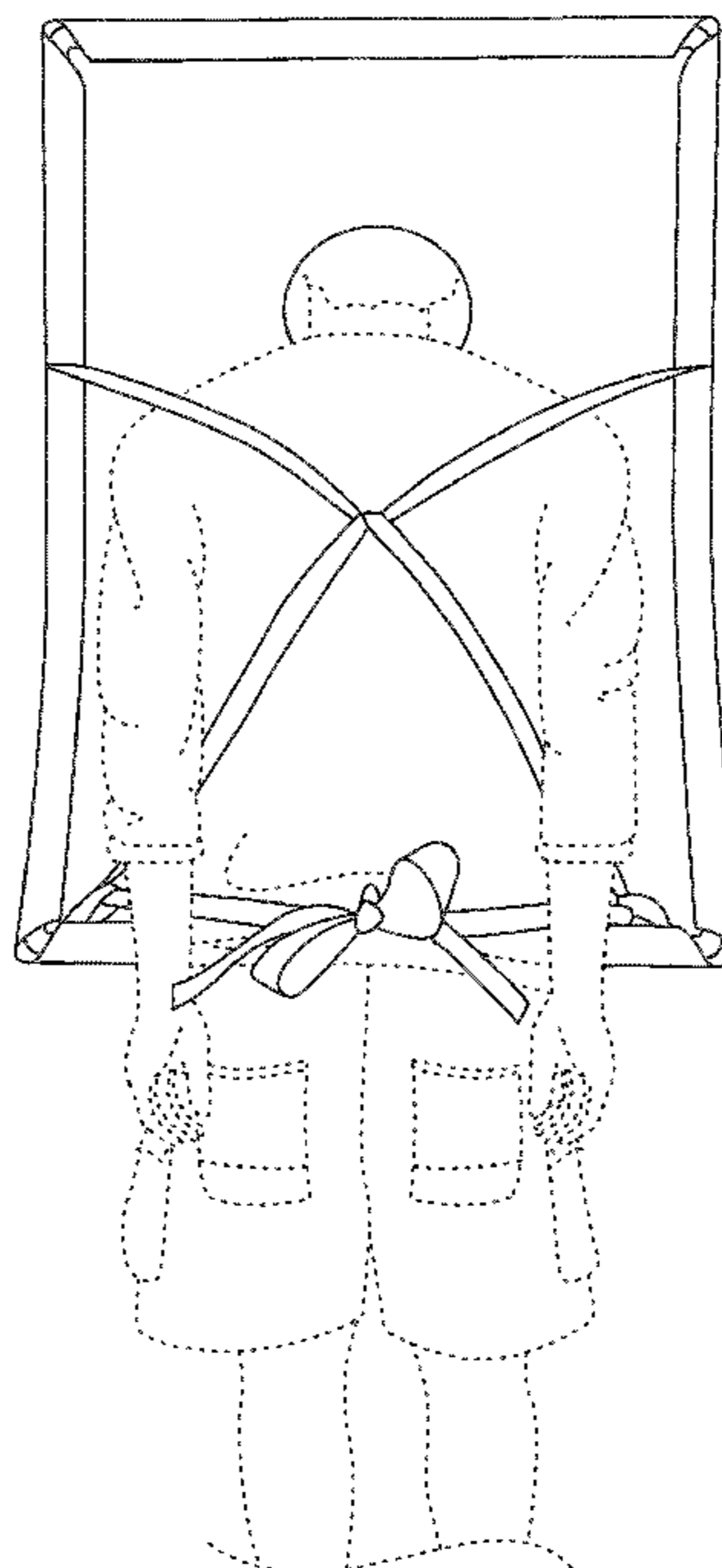
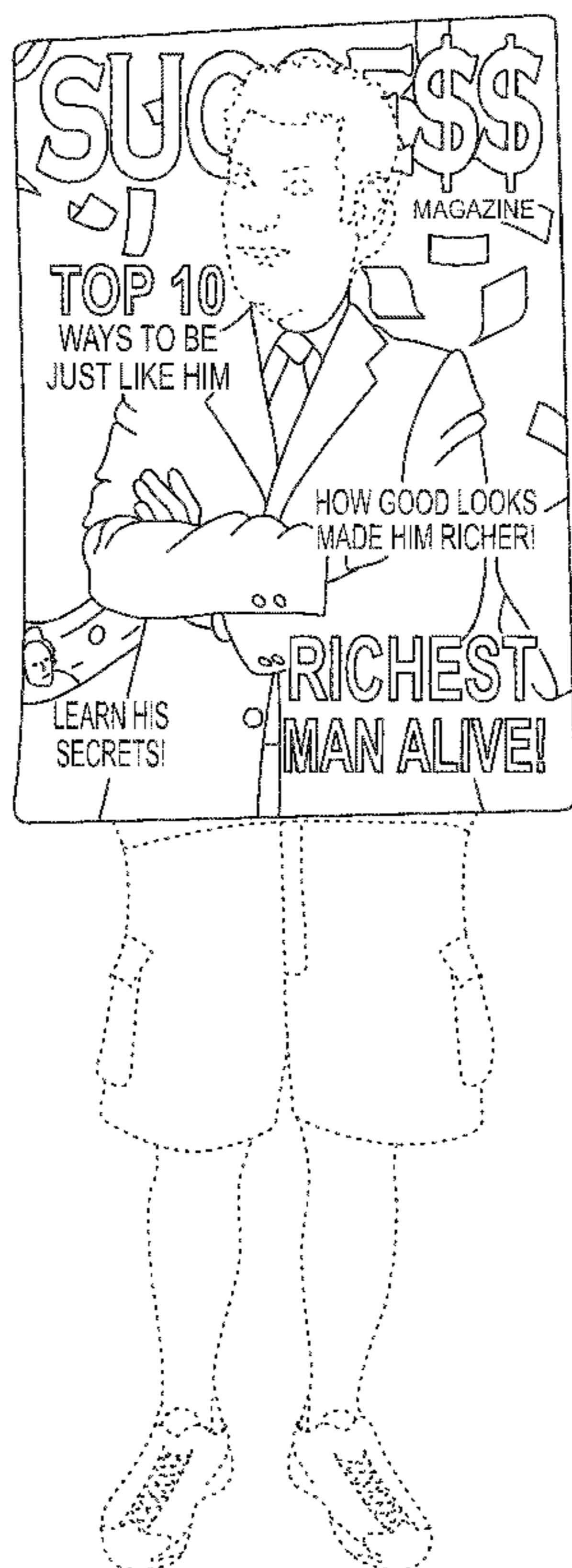
(57) **CLAIM**

The ornamental design for a magazine cover costume, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a magazine cover costume showing my new design;

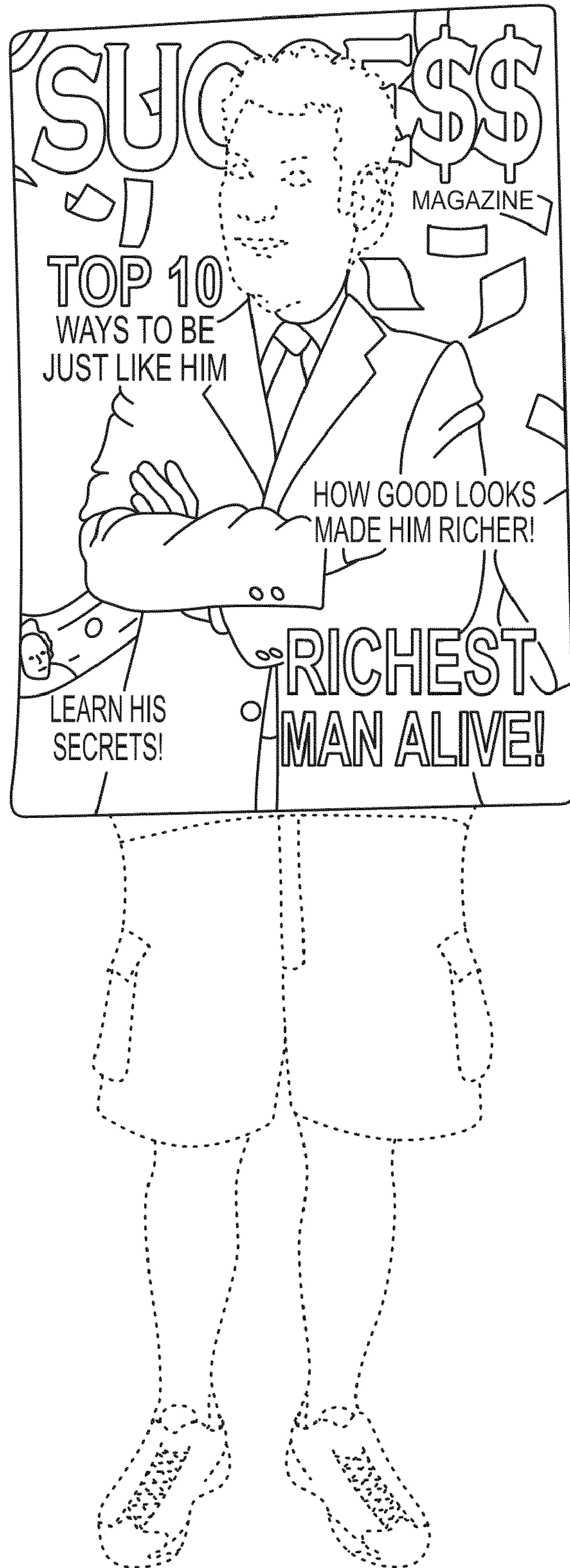

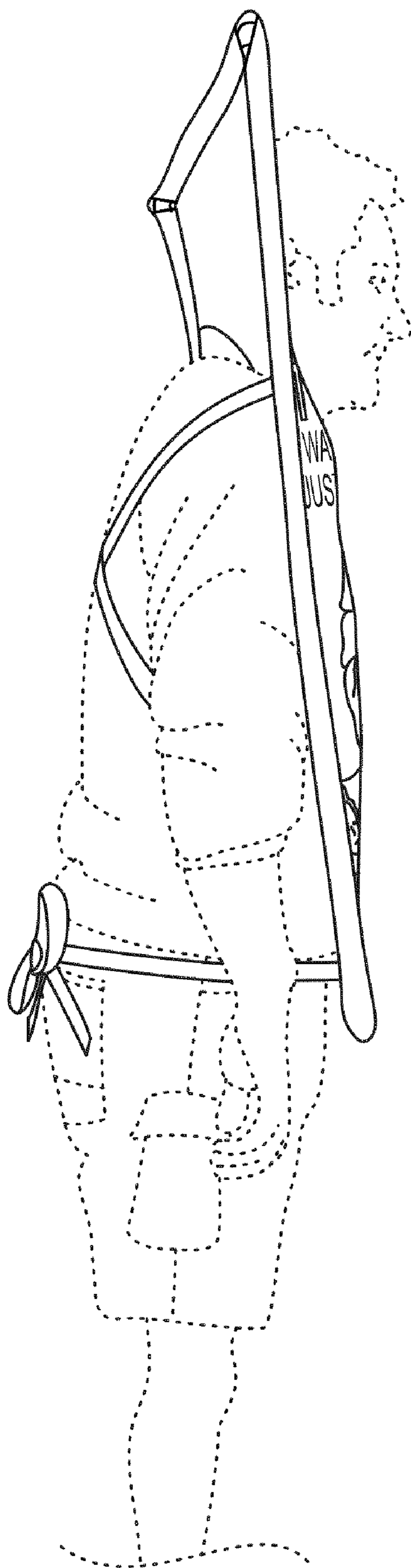

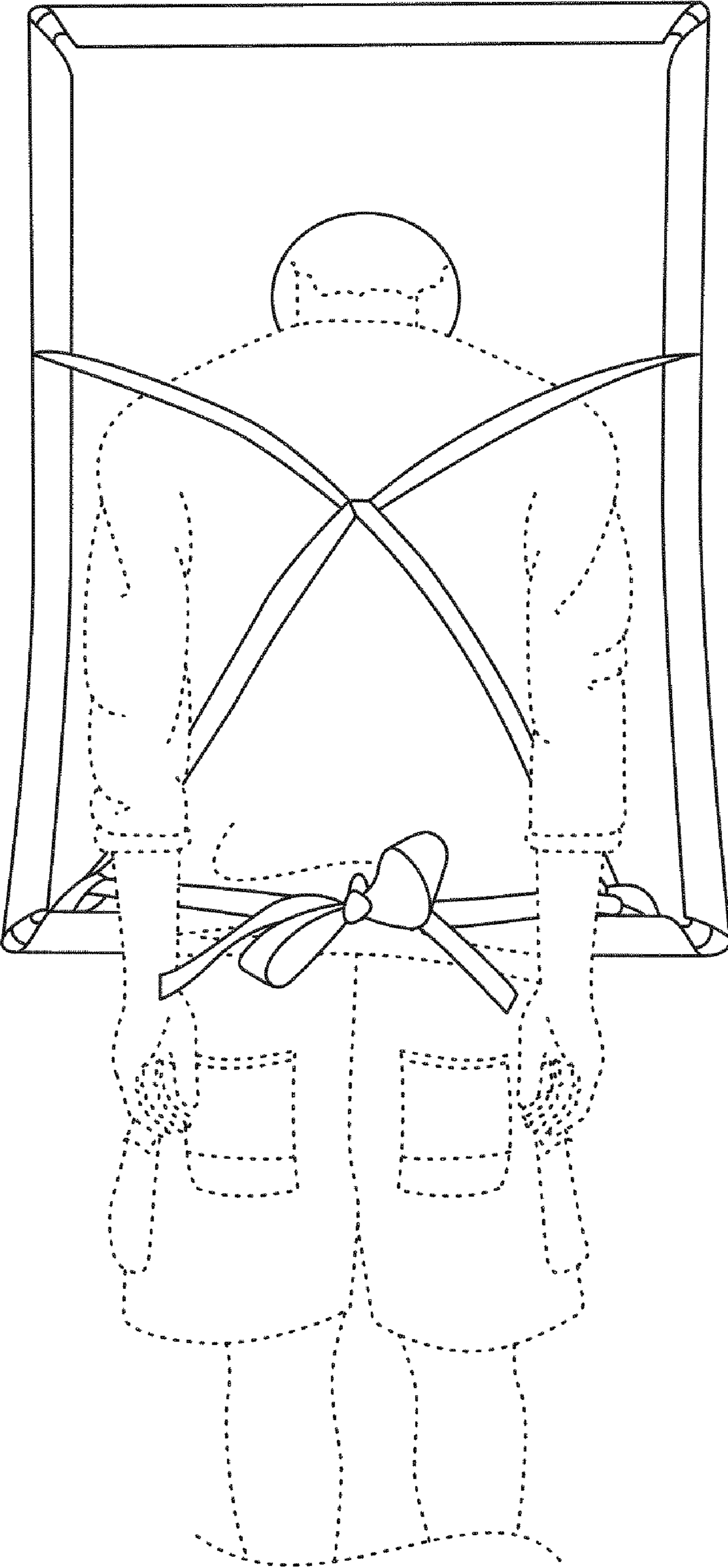
