DESCRIPTION

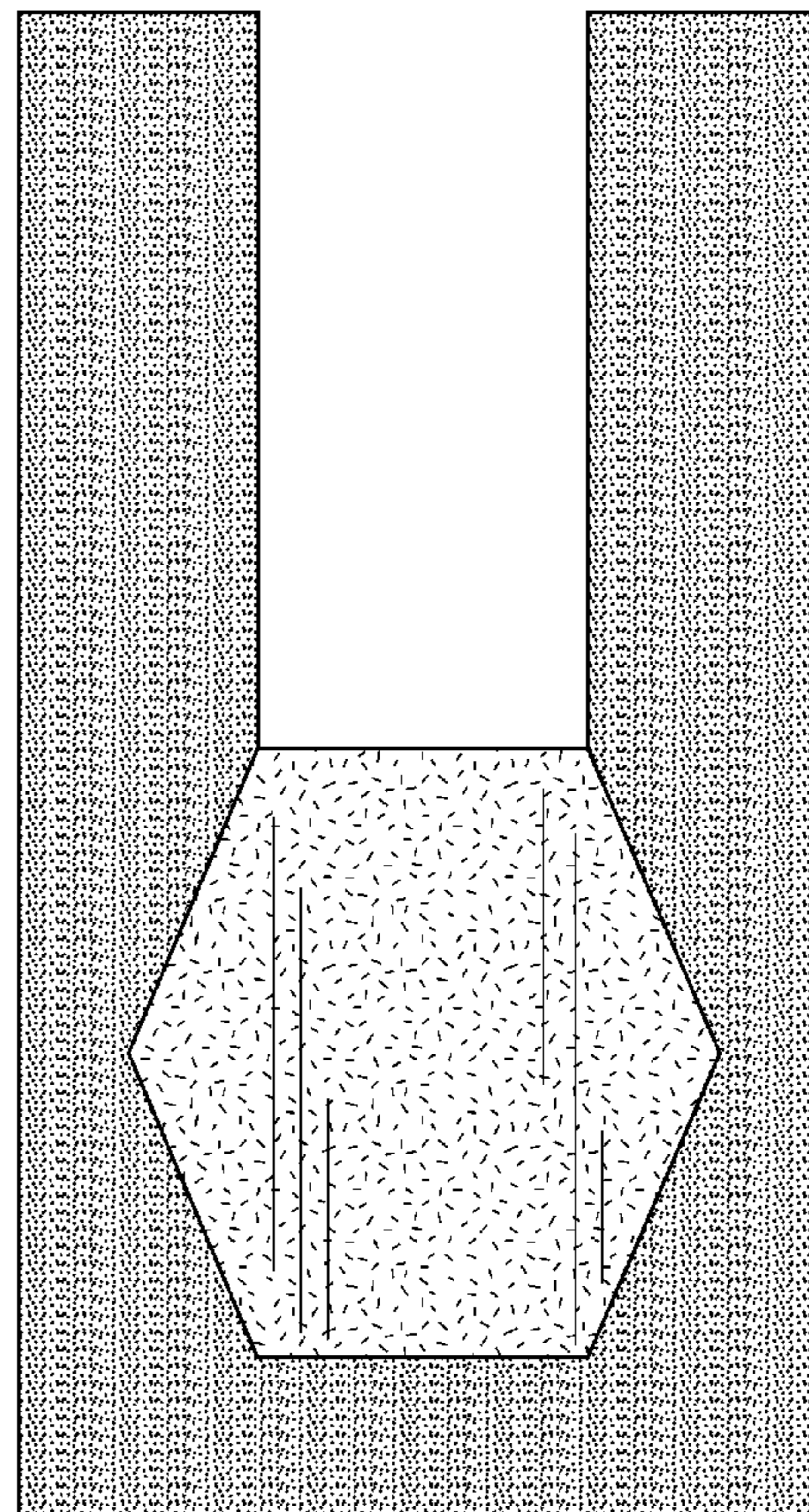
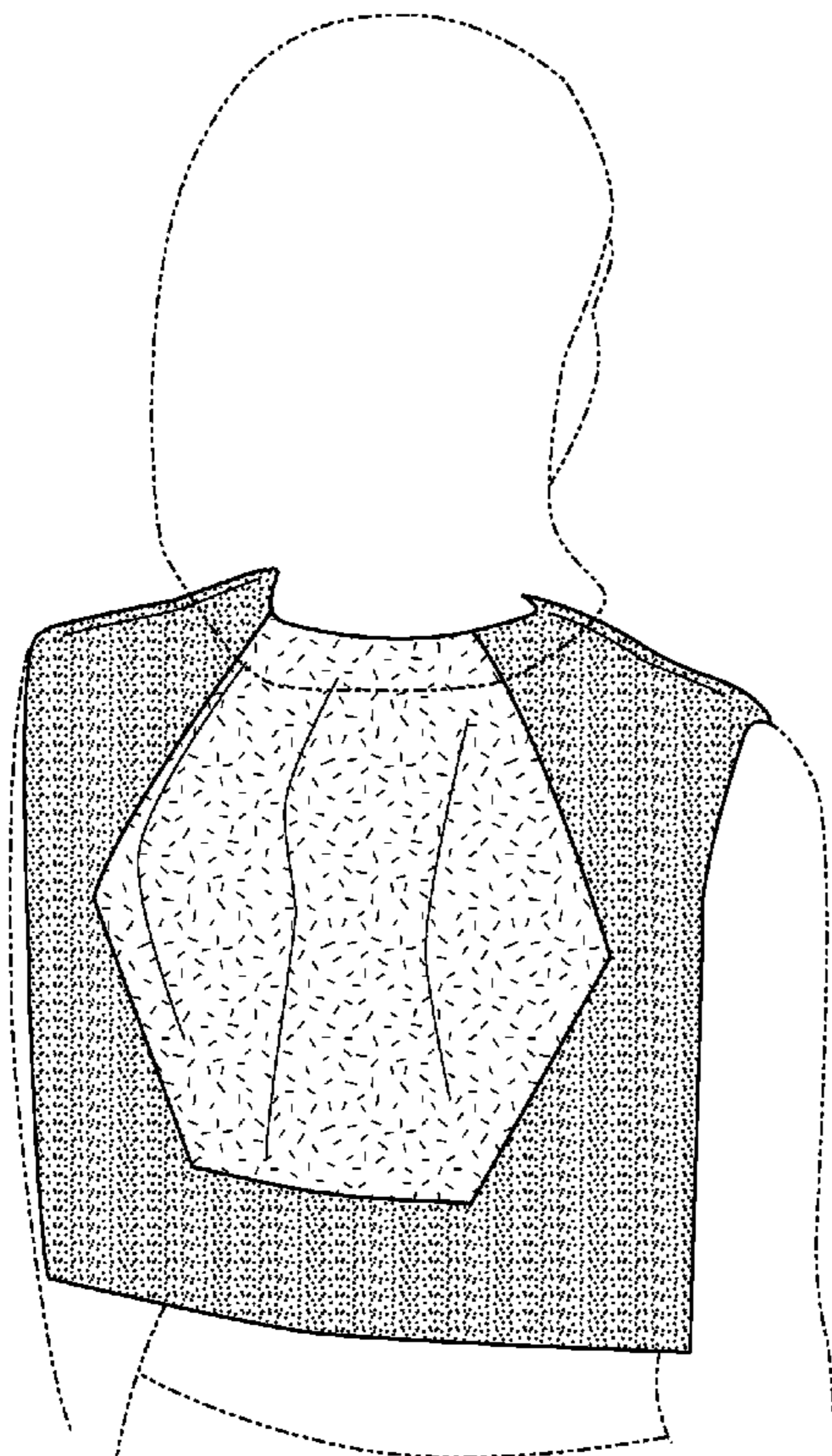
FIG. 1 is a perspective of a neck towel for hairstyling showing my new design in use;

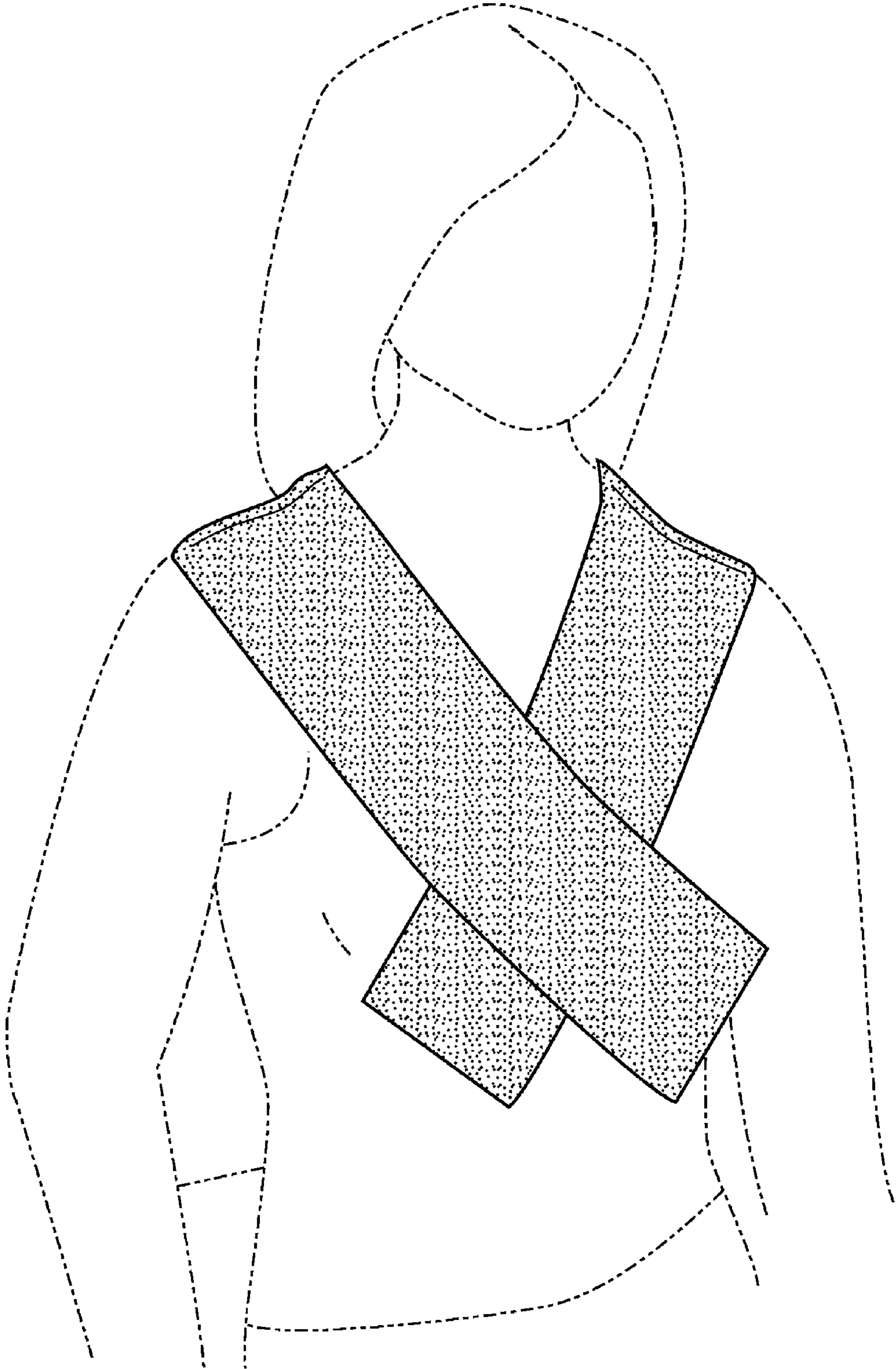

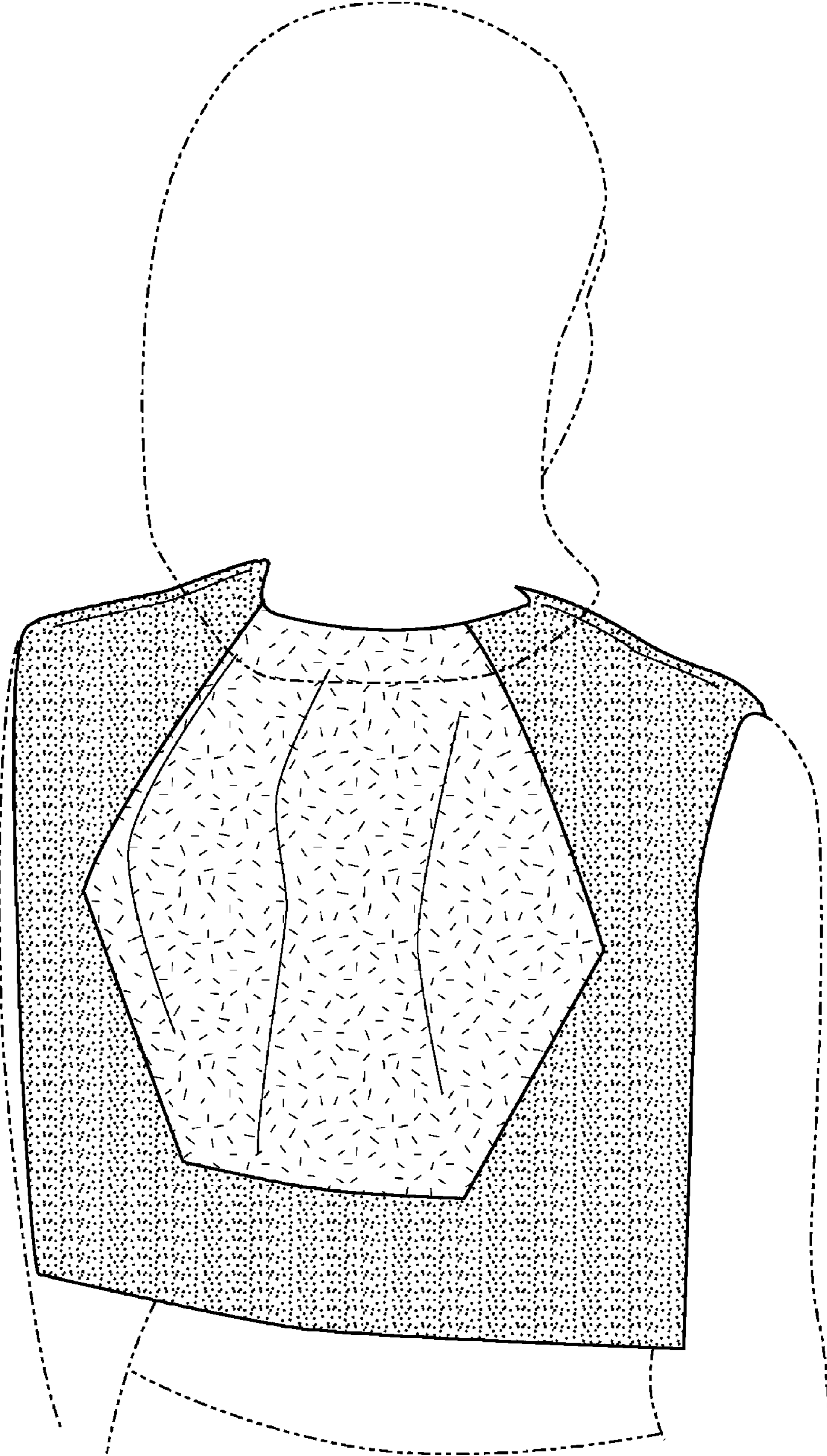

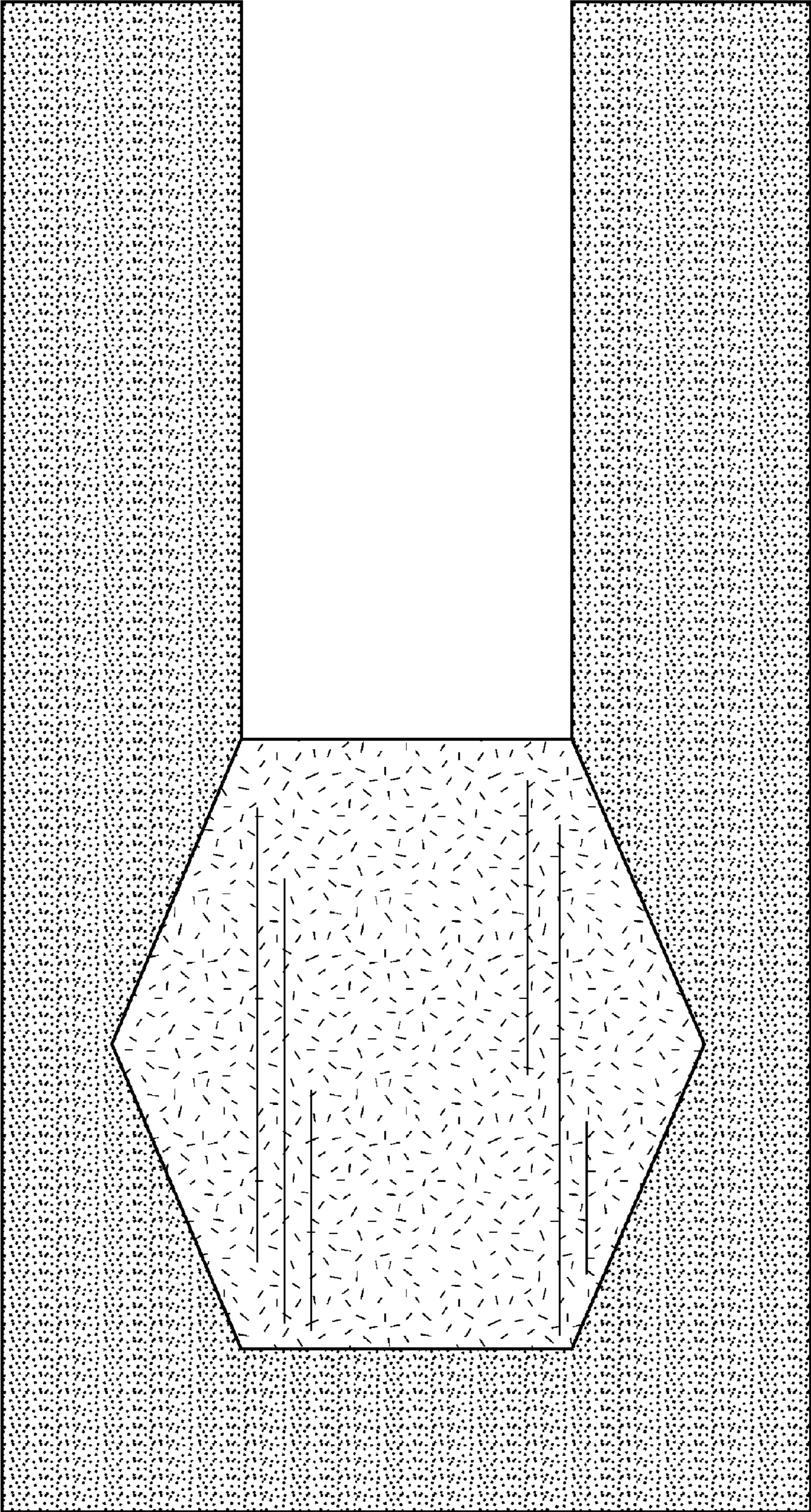
