DESCRIPTION

FIG. 1 is a perspective view of a boot upper, showing my new design;

FIG. 2 is a side elevational view thereof;

FIG. 3 is an opposite side elevational view thereof;

FIG. 4 is a front elevational view thereof;

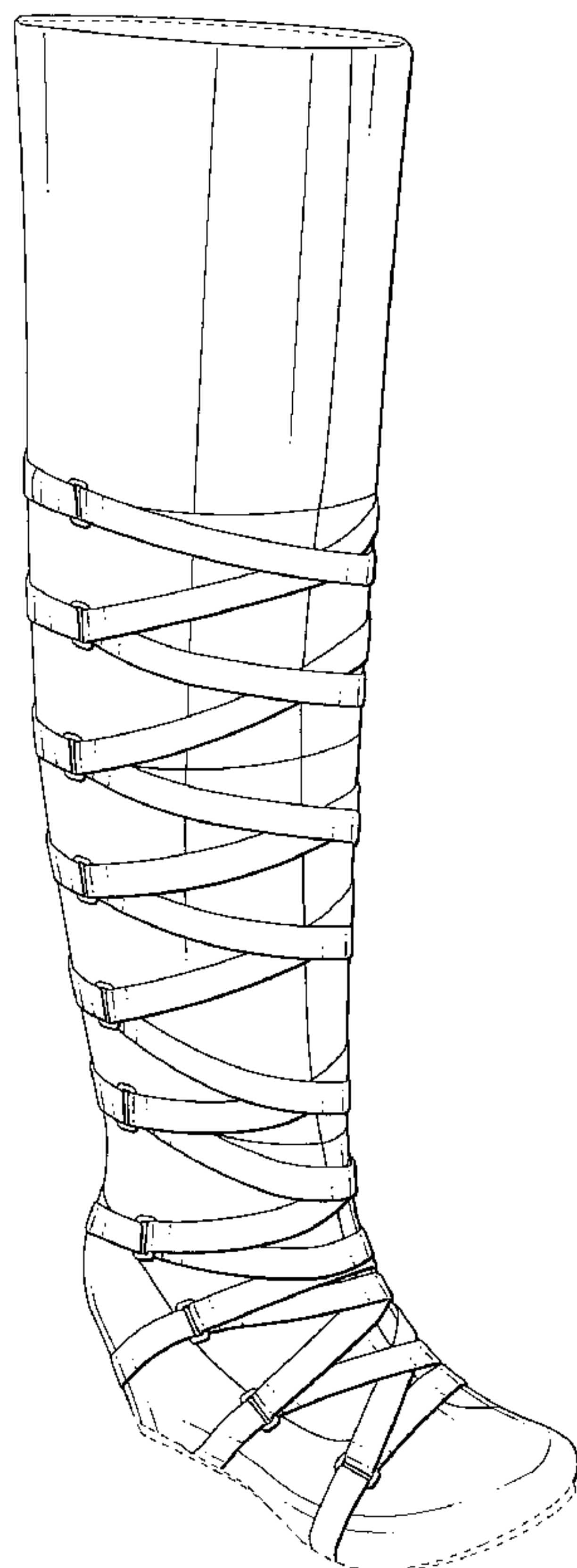
FIG. 5 is a rear elevational view thereof.

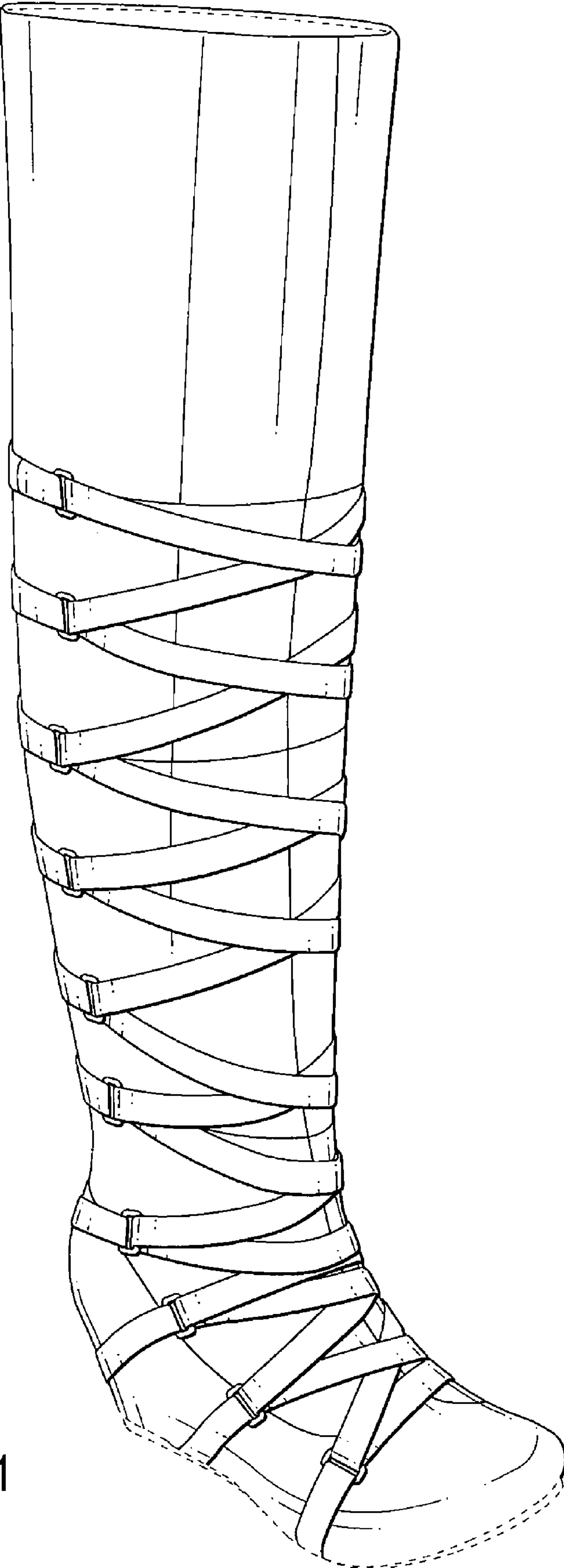

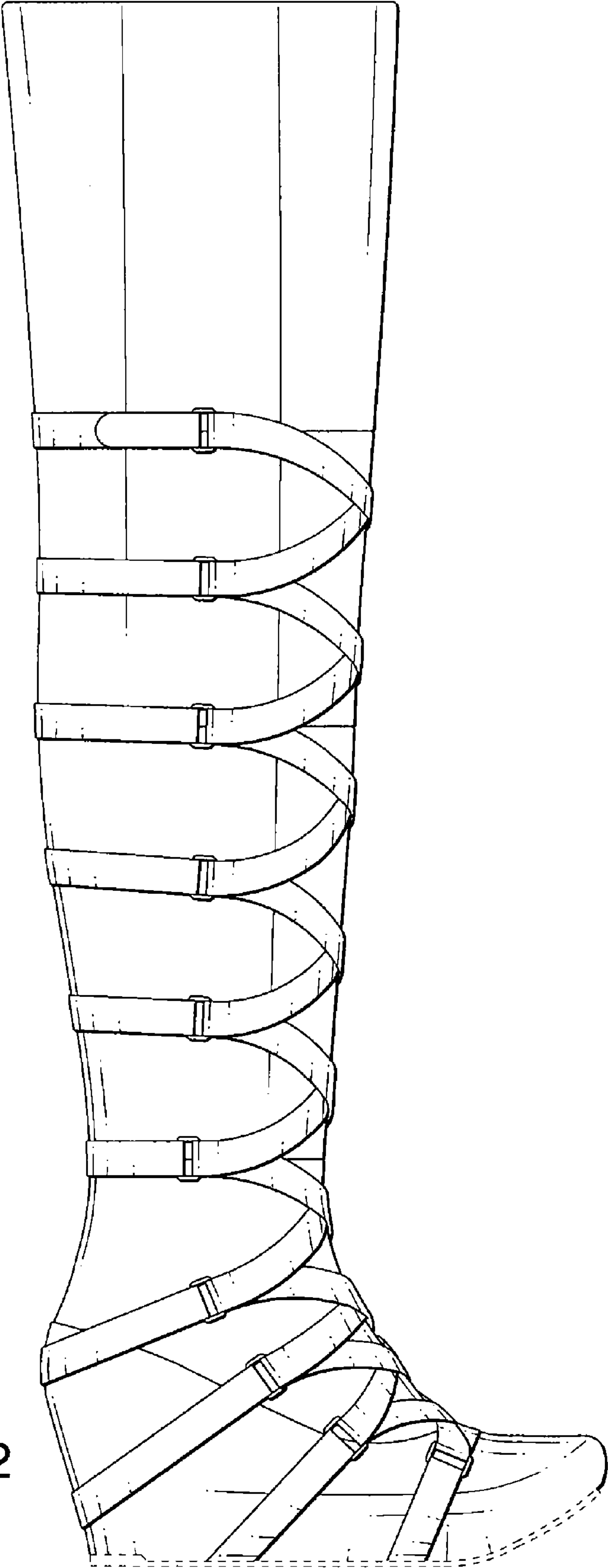

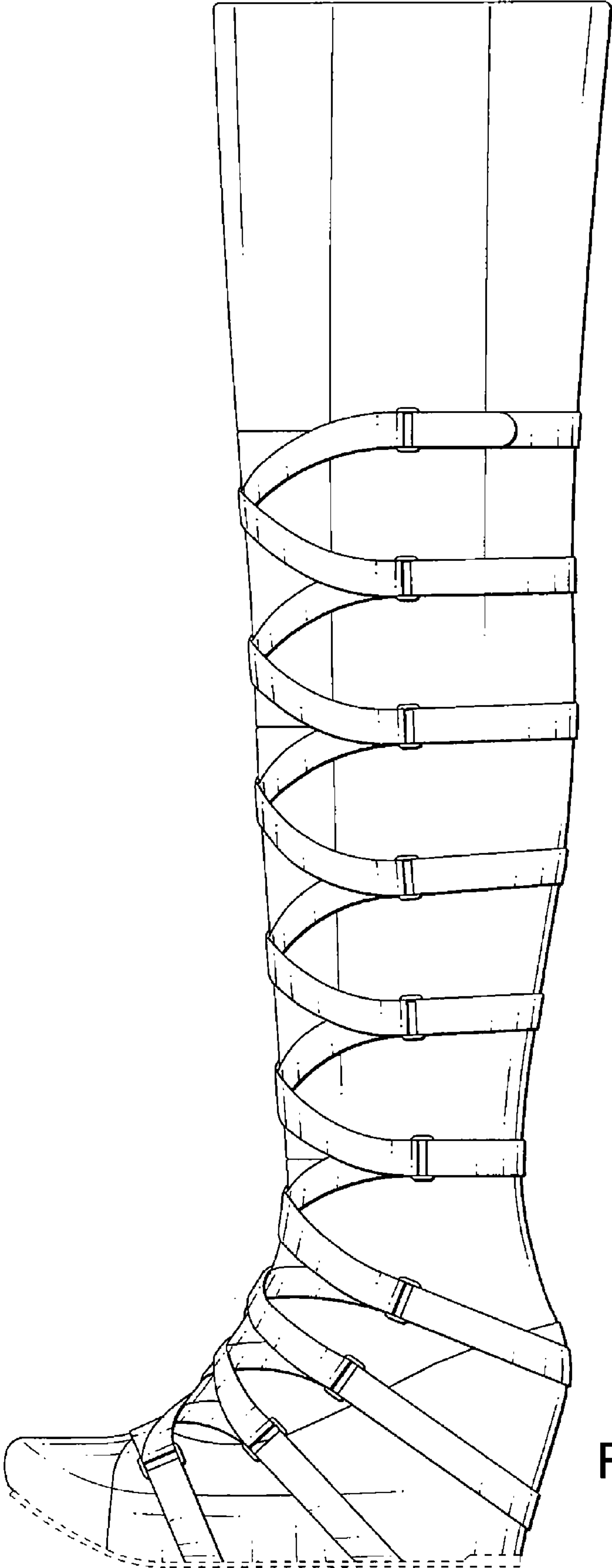

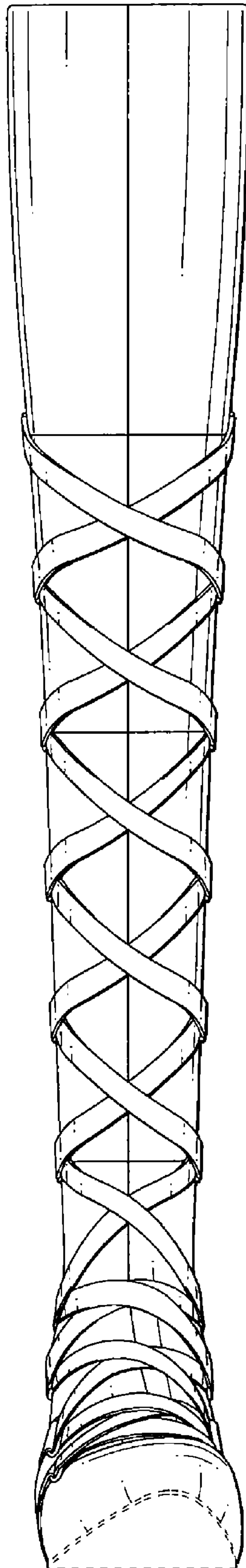

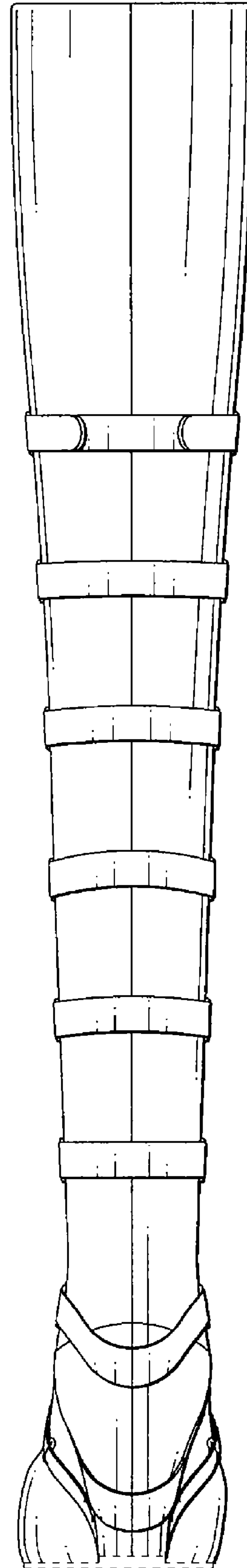

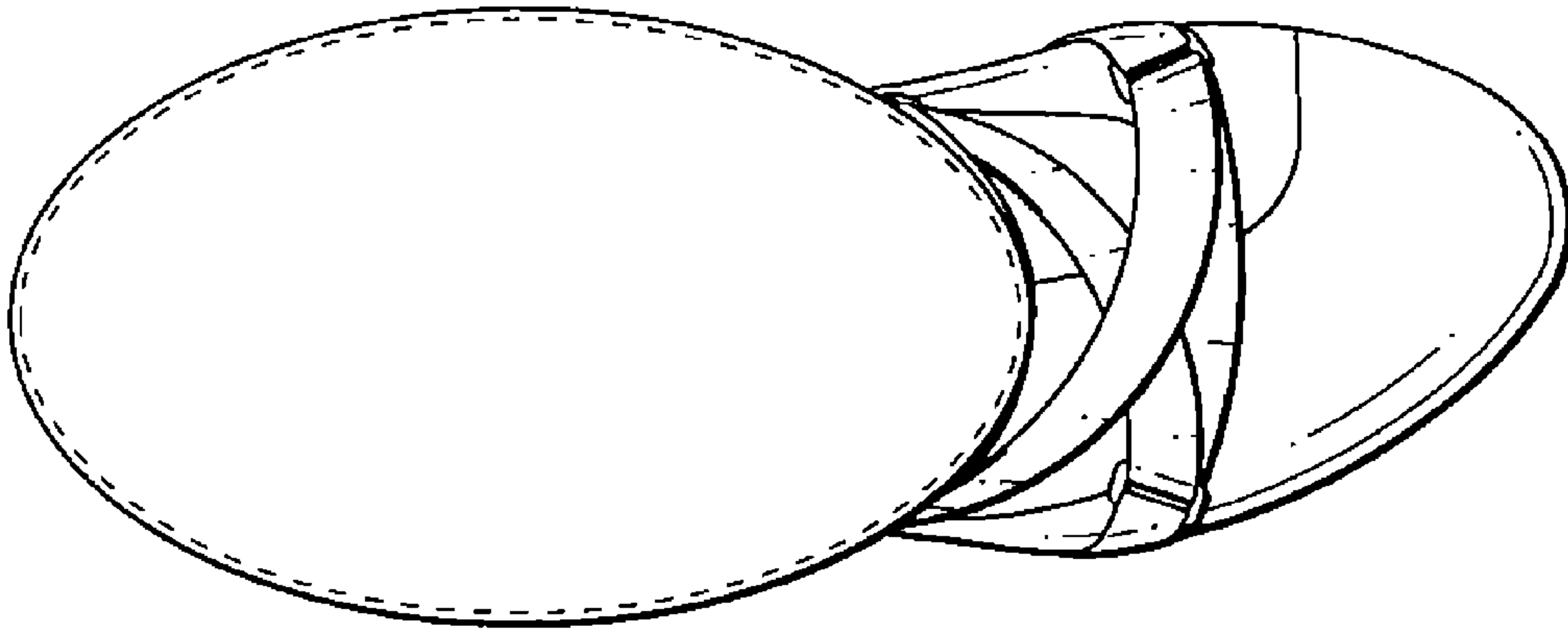

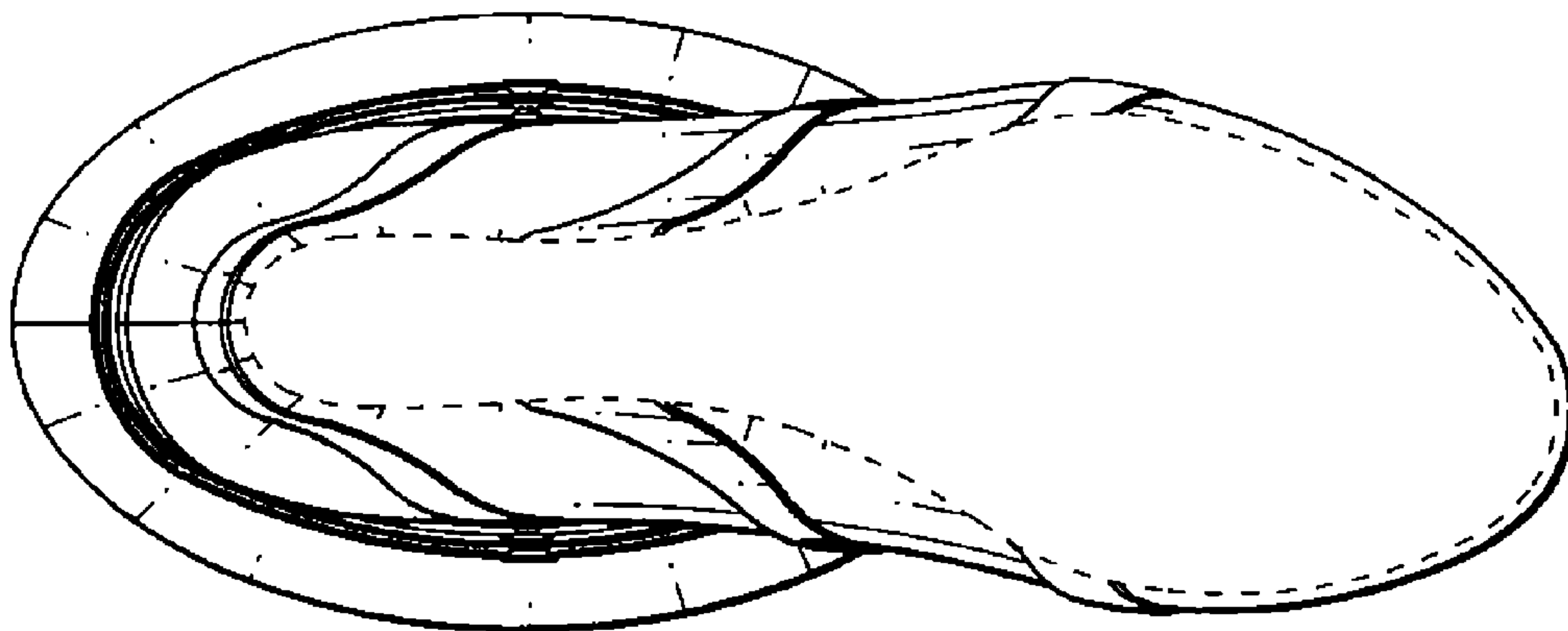
