(57) **CLAIM**

The ornamental design for a decorative strap for shoes, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a top plan view of a decorative strap for shoes in accordance with the present invention;

FIG. 2 is a right side perspective view of a shoe (shown in phantom) with the decorative strap of FIG. 1 coupled thereto in accordance with the present invention;

FIG. 3 is a left side perspective view of the shoe with the decorative strap of FIG. 1 coupled thereto in accordance with the present invention;

FIG. 4 is a front view of the shoe with the decorative strap of FIG. 1 coupled thereto in accordance with the present invention;

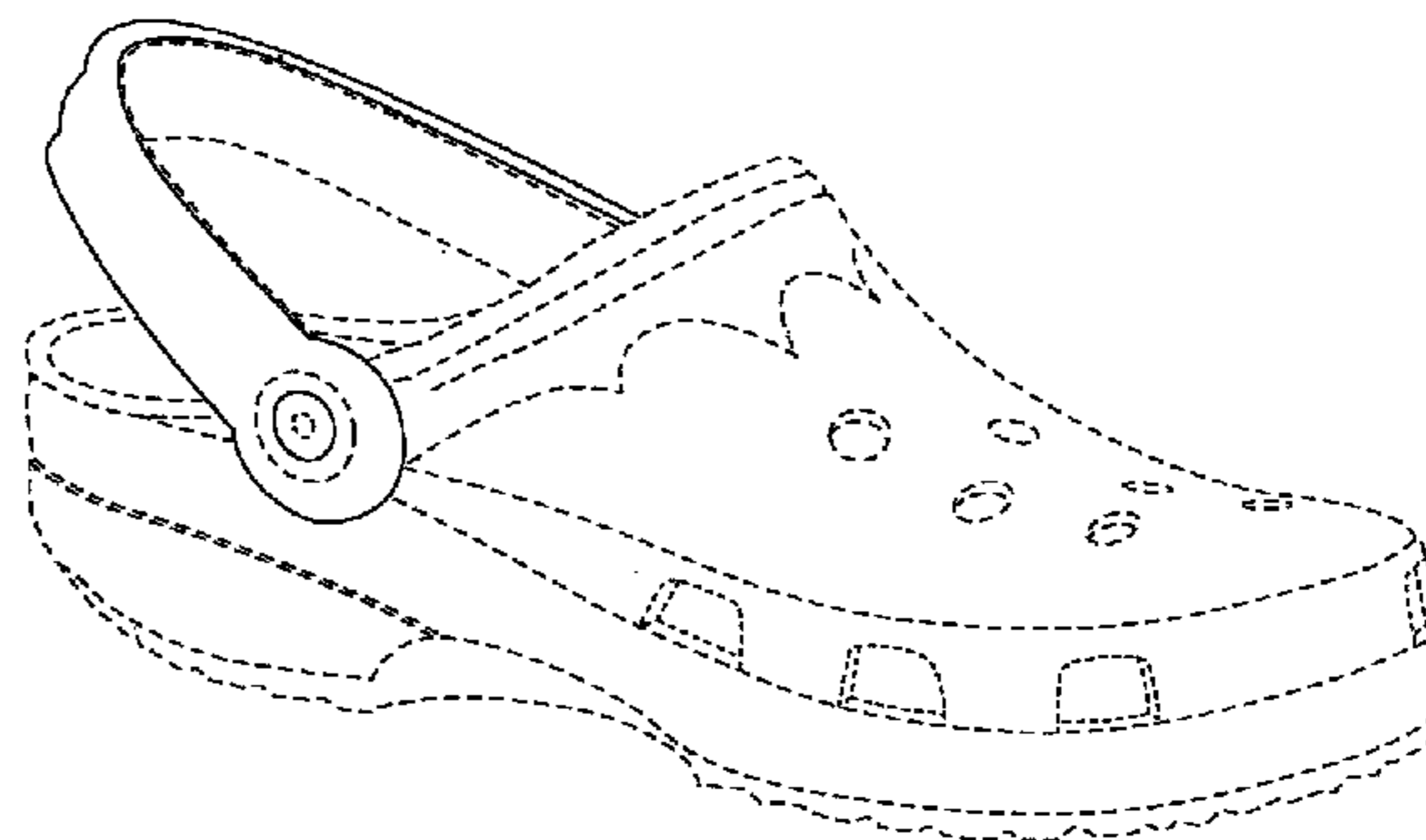
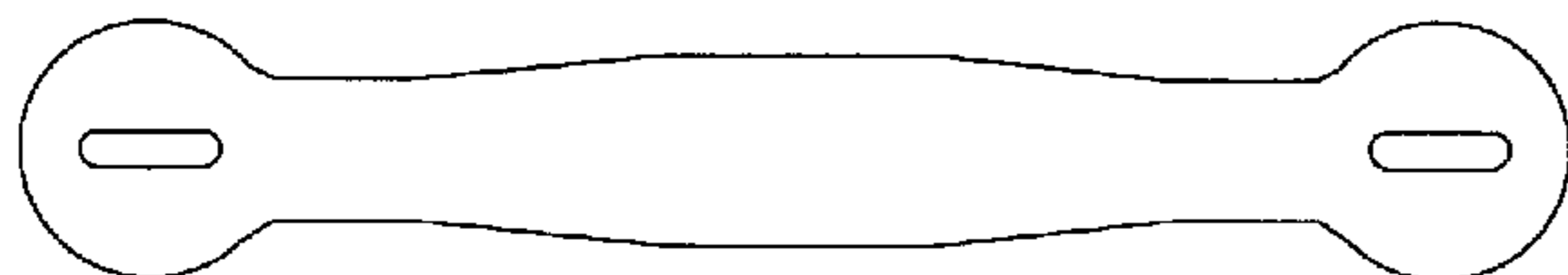
FIG. 5 is a top view of the shoe with the decorative strap of FIG. 1 coupled thereto in accordance with the present invention;

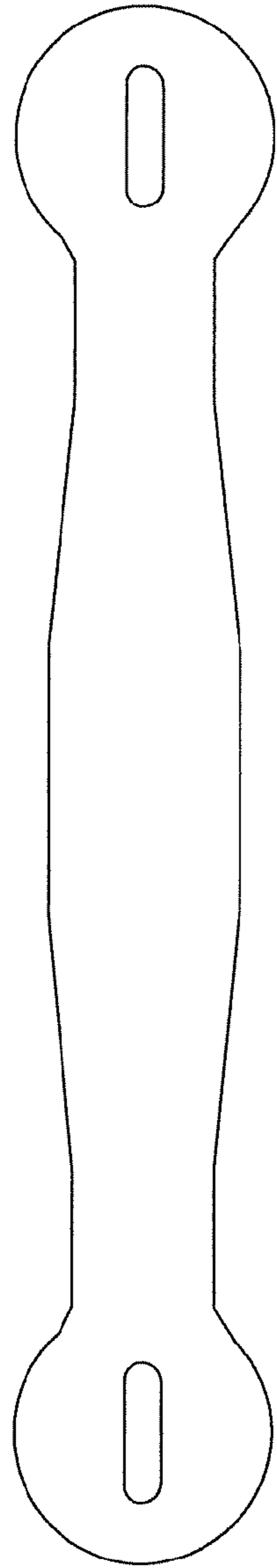

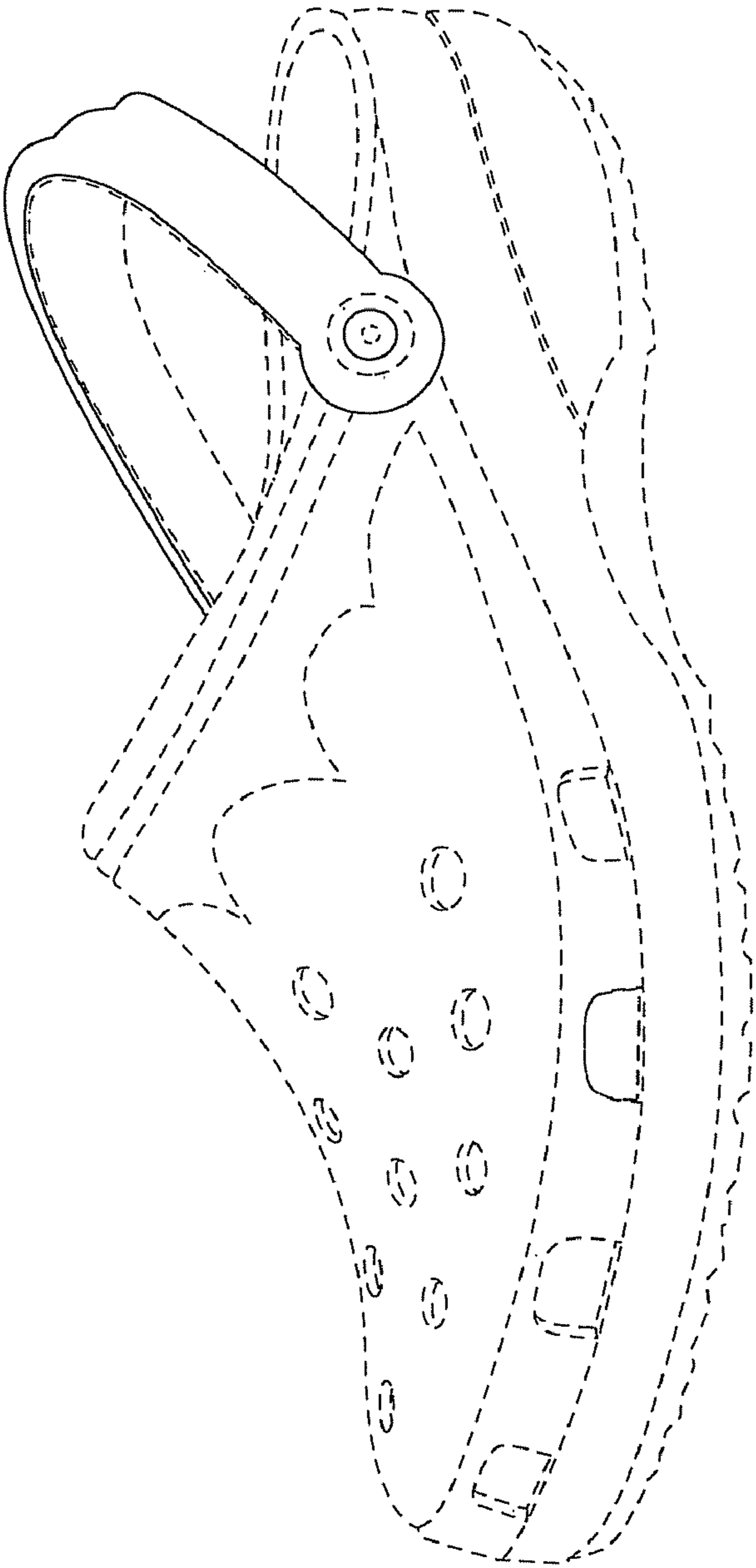

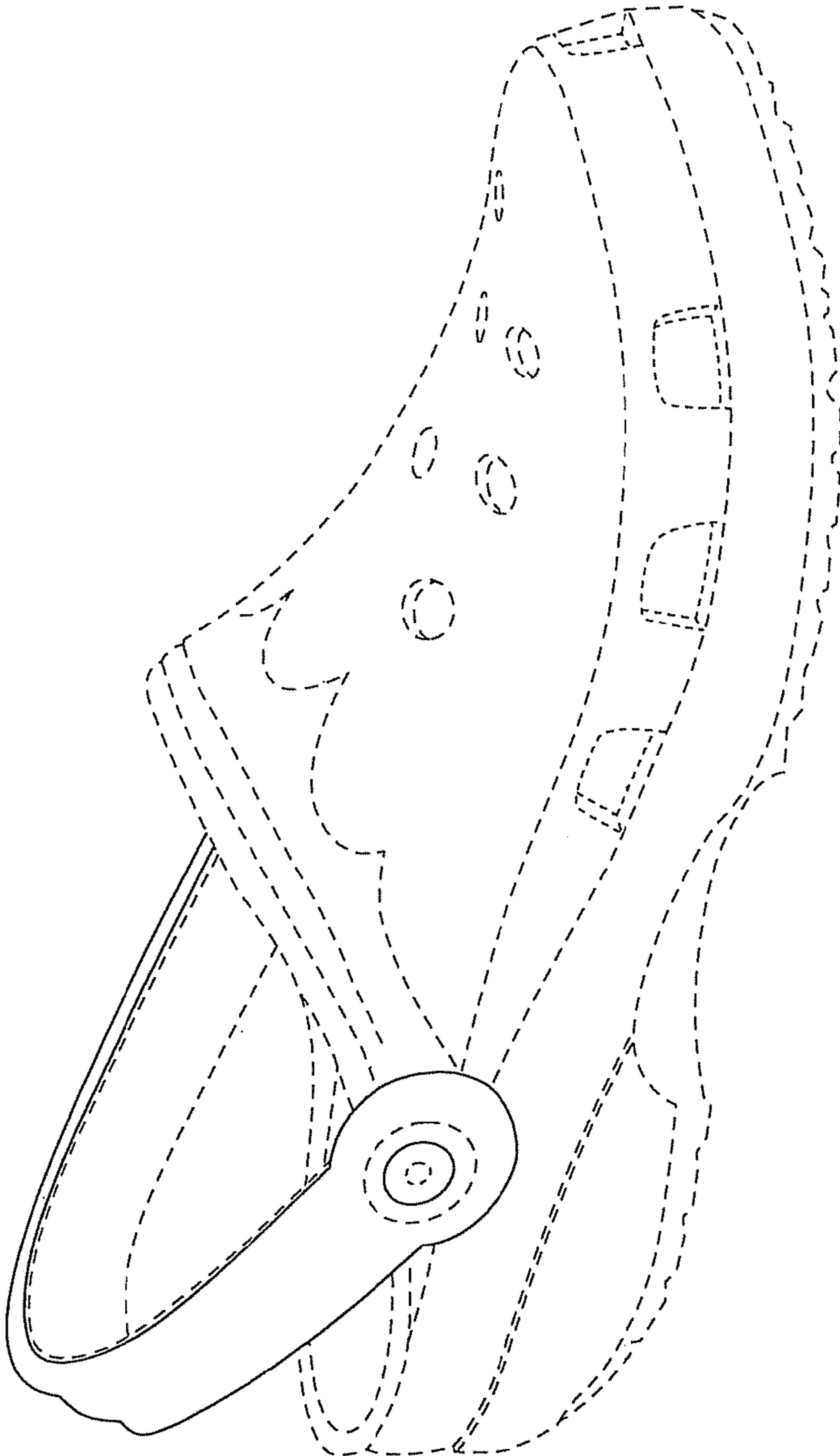
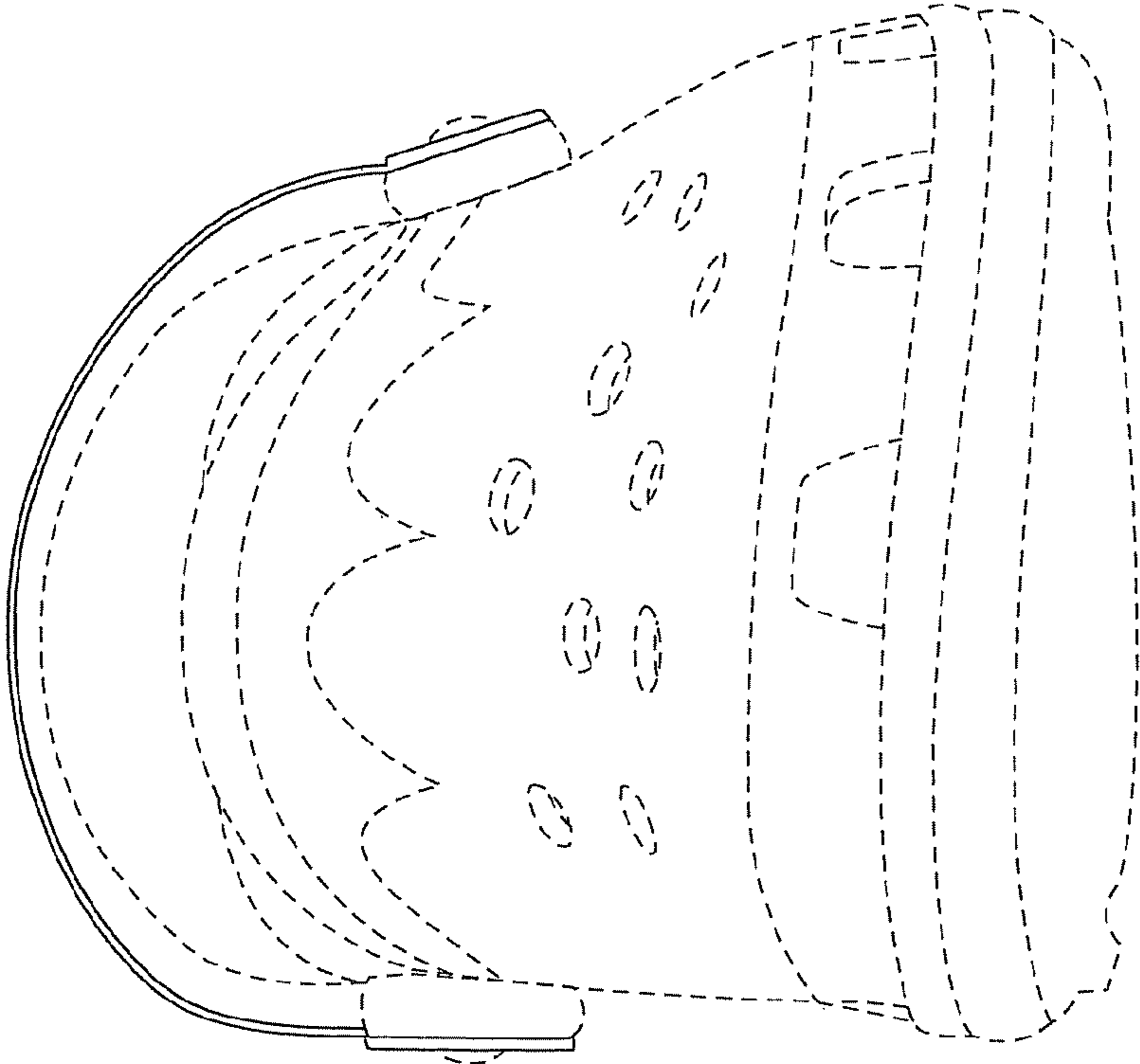
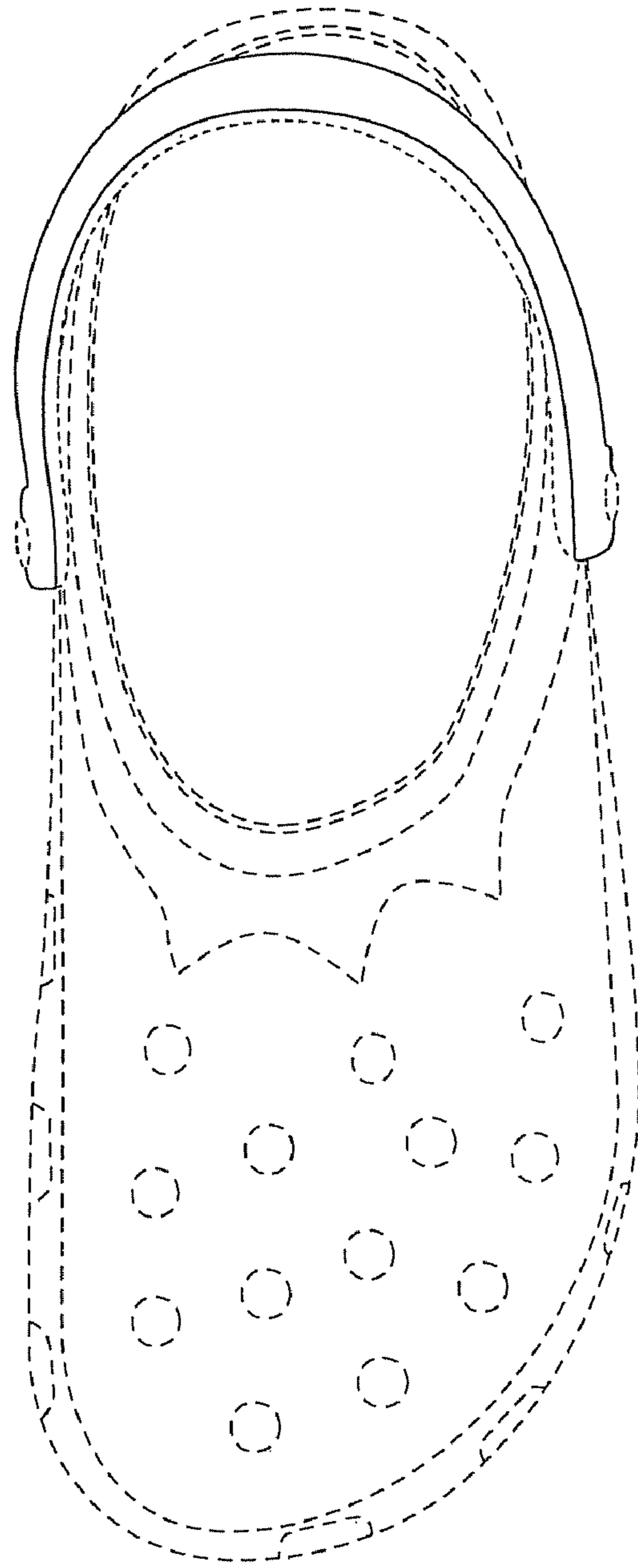


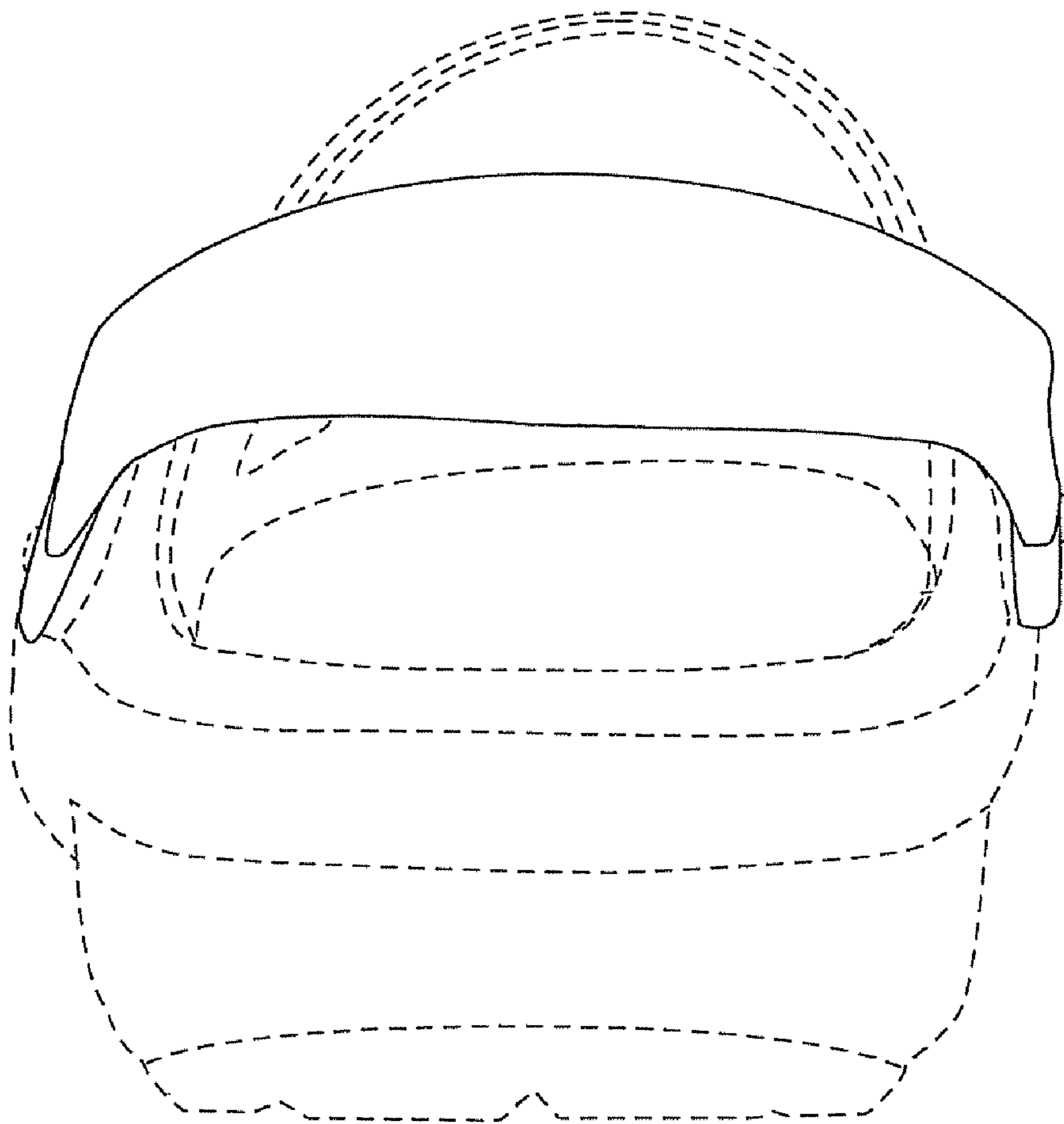

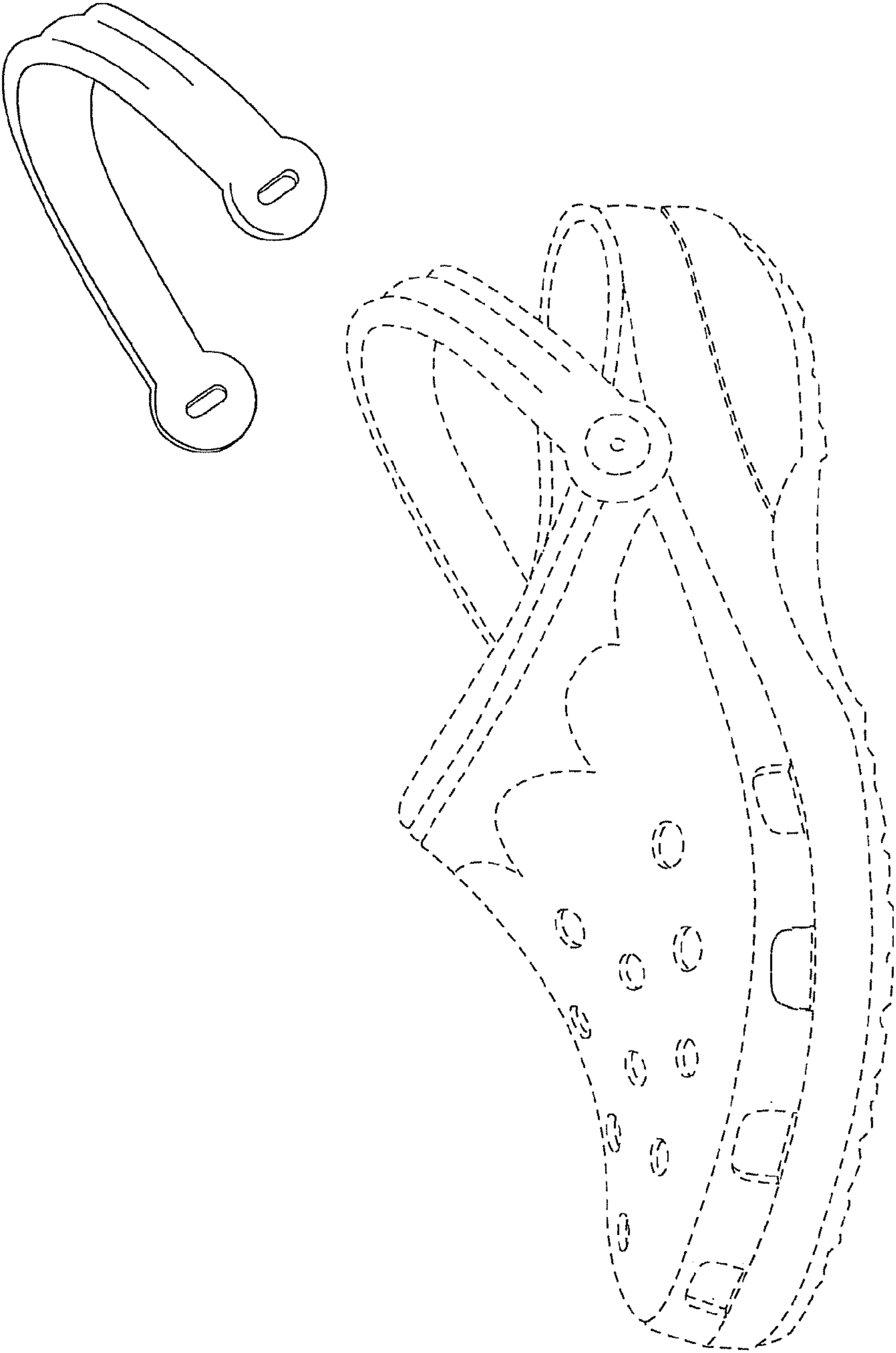
