FIG. 4 is a bottom plan view thereof.

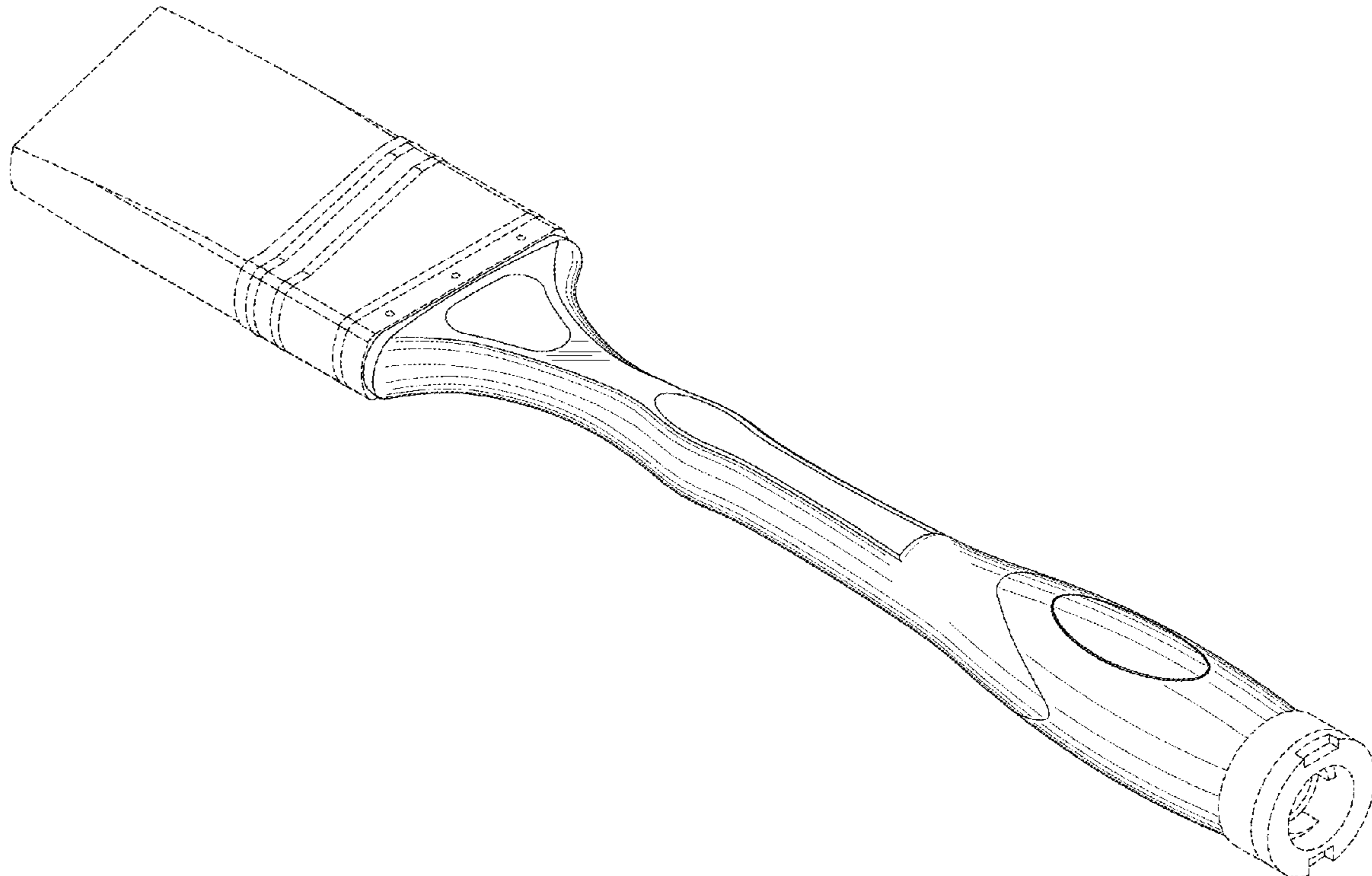
FIG. 5 is a left side elevational view thereof;

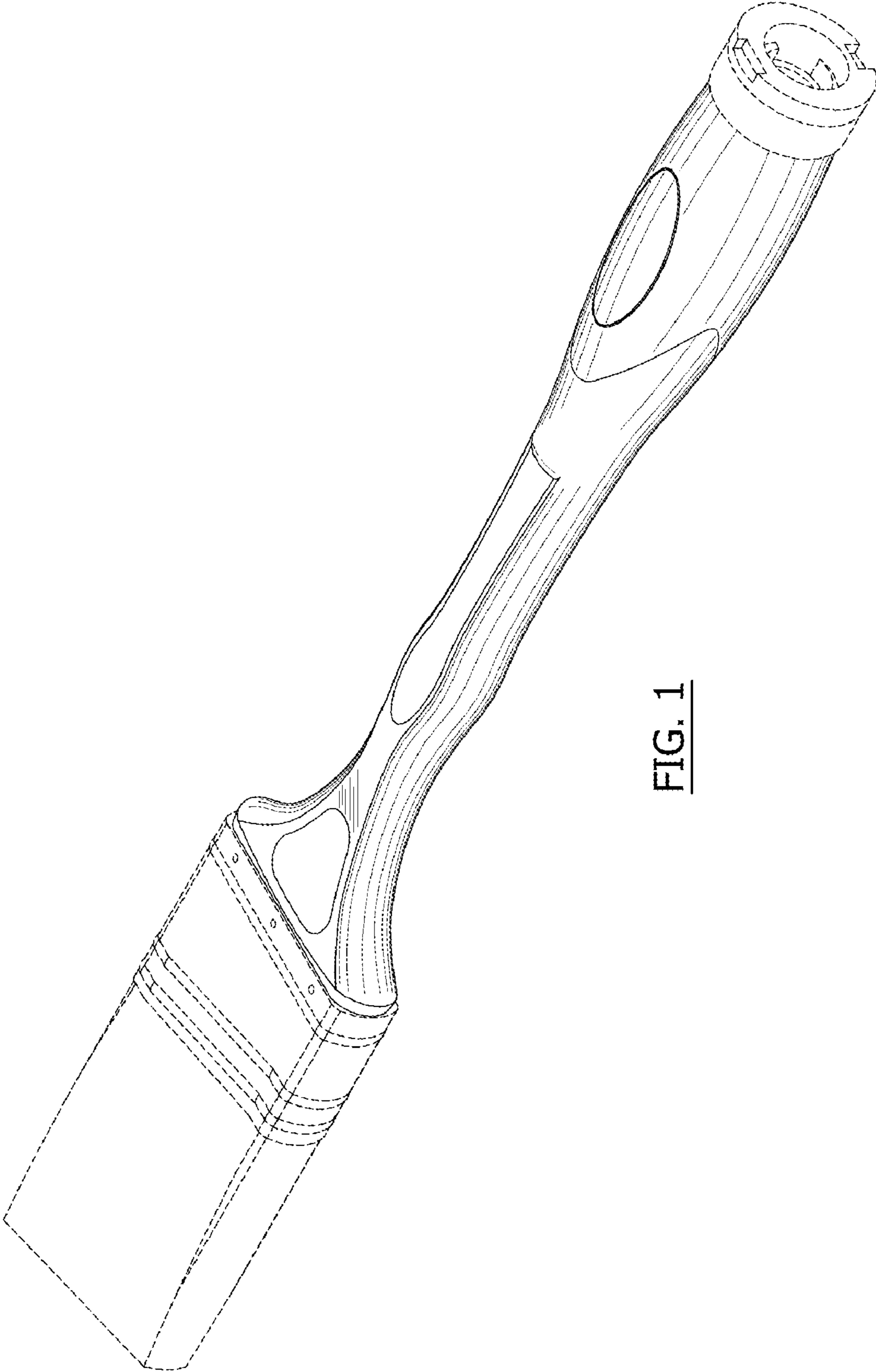

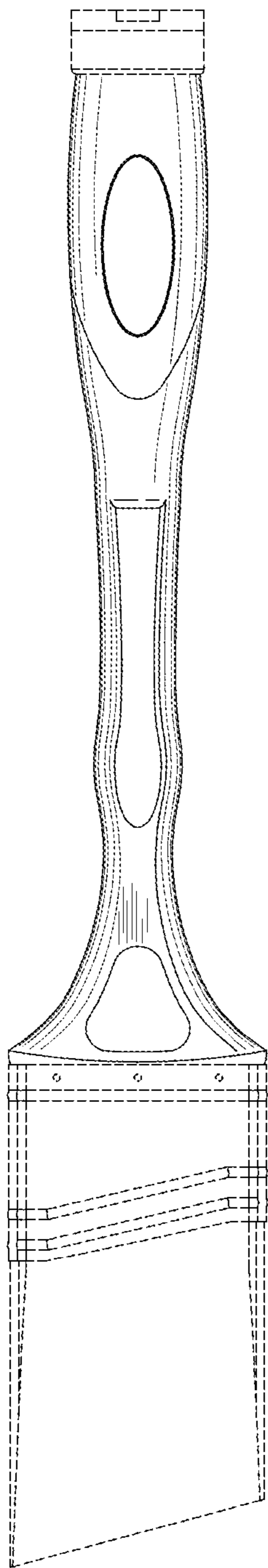

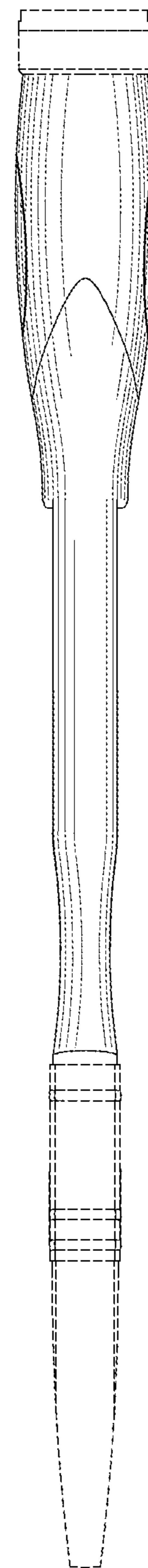

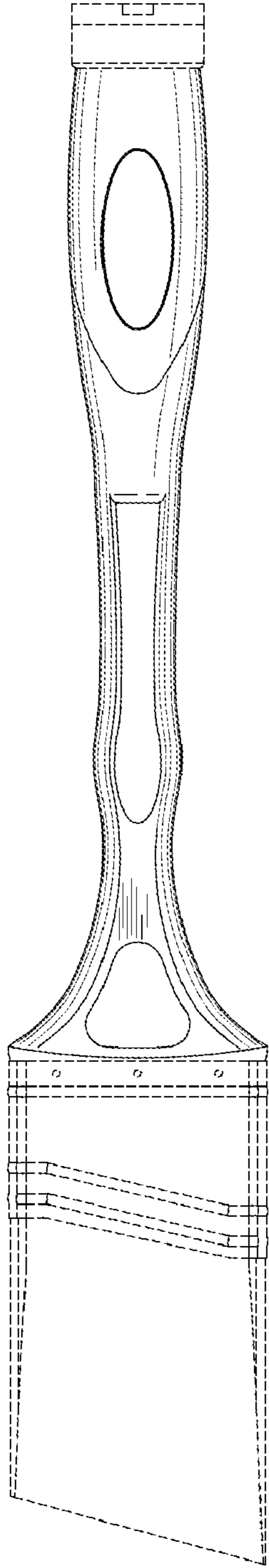

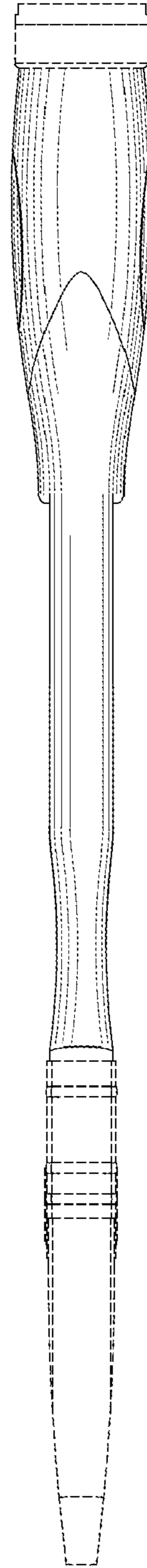

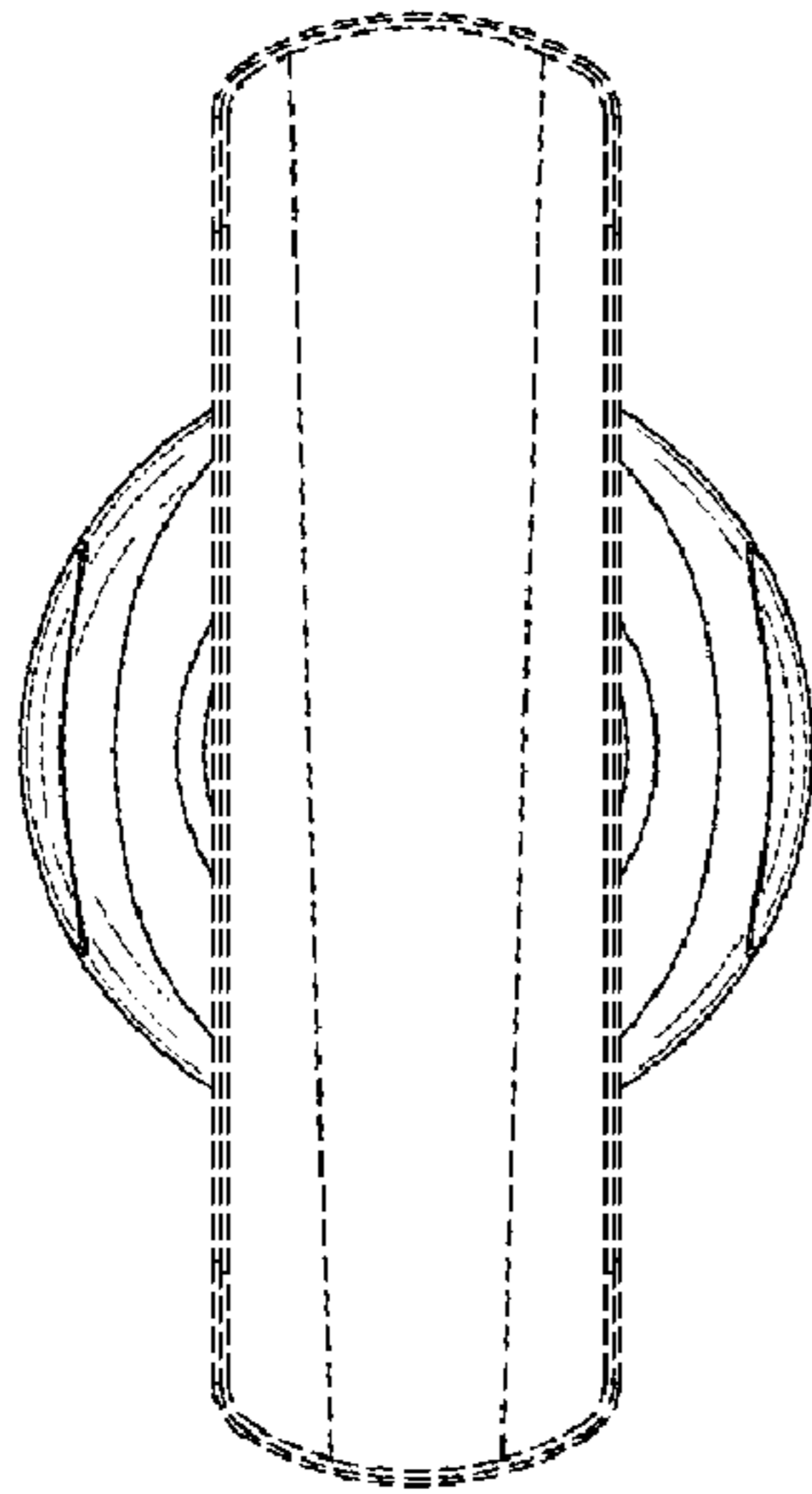

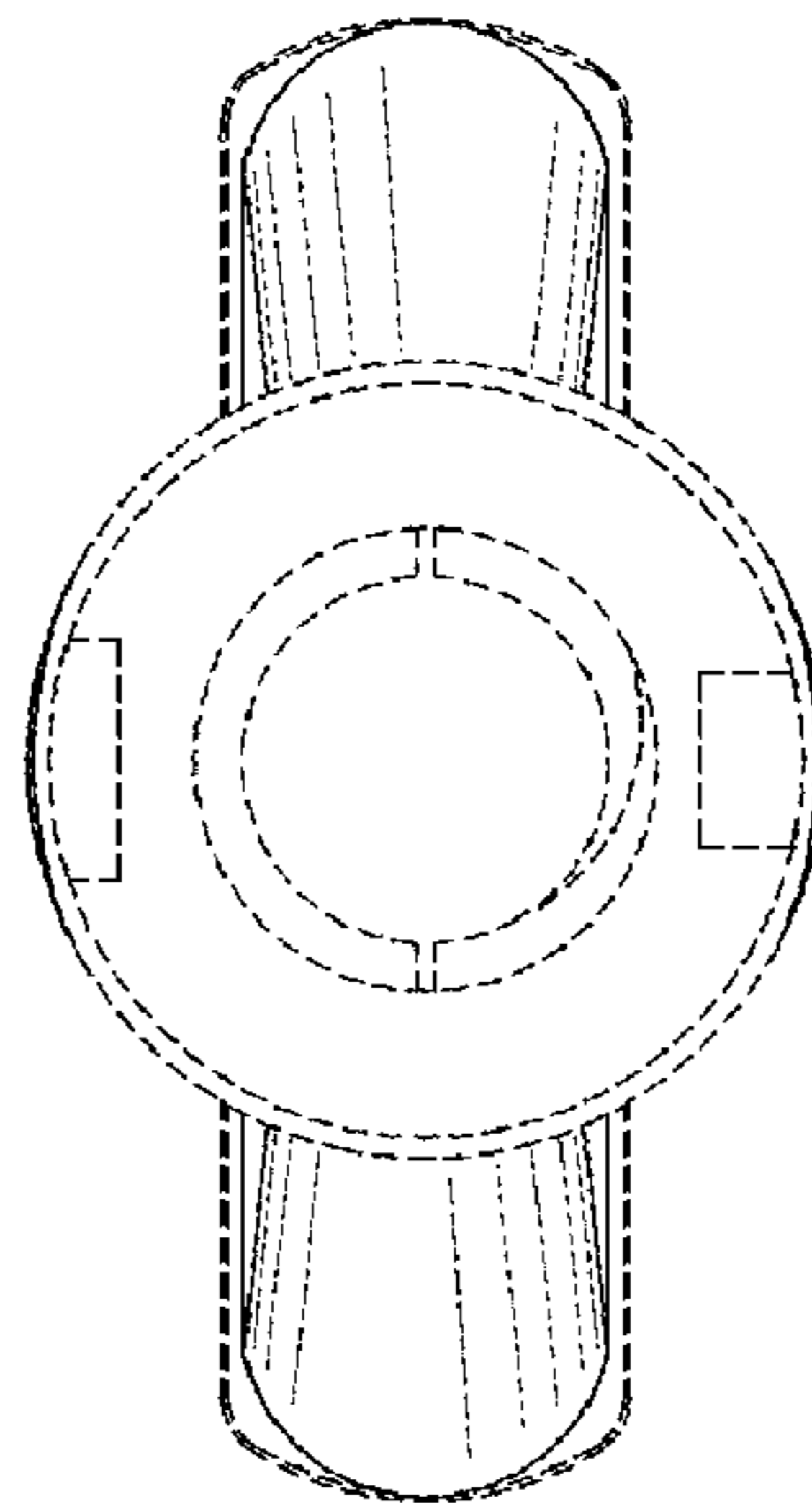

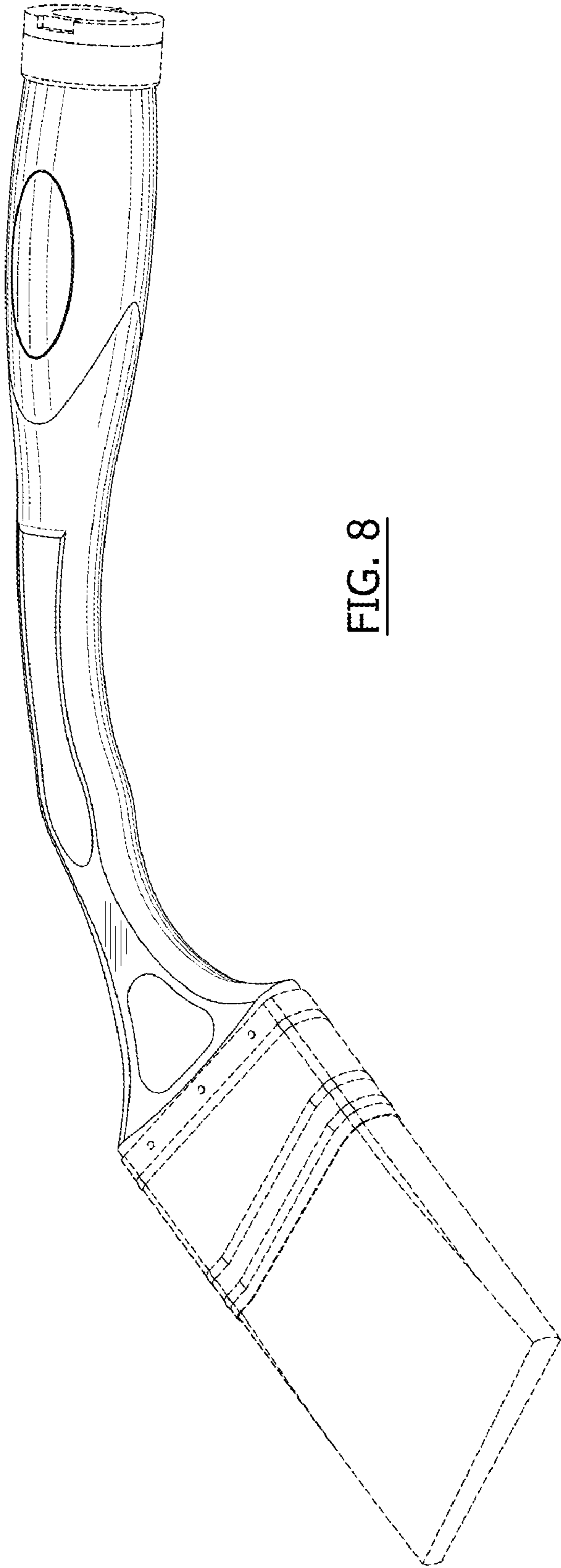
