The ornamental design for an applique applied to a fabric treatment article, as shown and described.

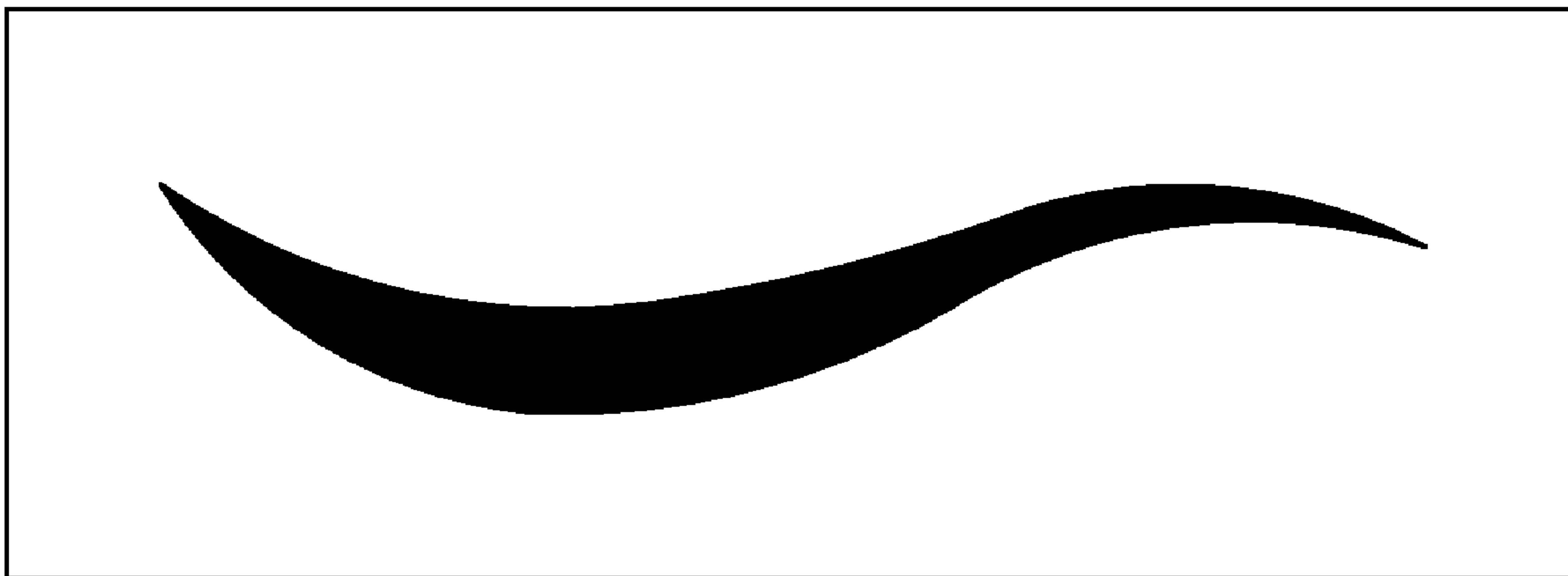
DESCRIPTION

FIG. 1 is a front plan view of a first embodiment of an appliqué applied to a fabric treatment article, showing our new ornamental design; and,

FIG. 2 is a front plan view of a second embodiment of an appliqué applied to a fabric treatment article.

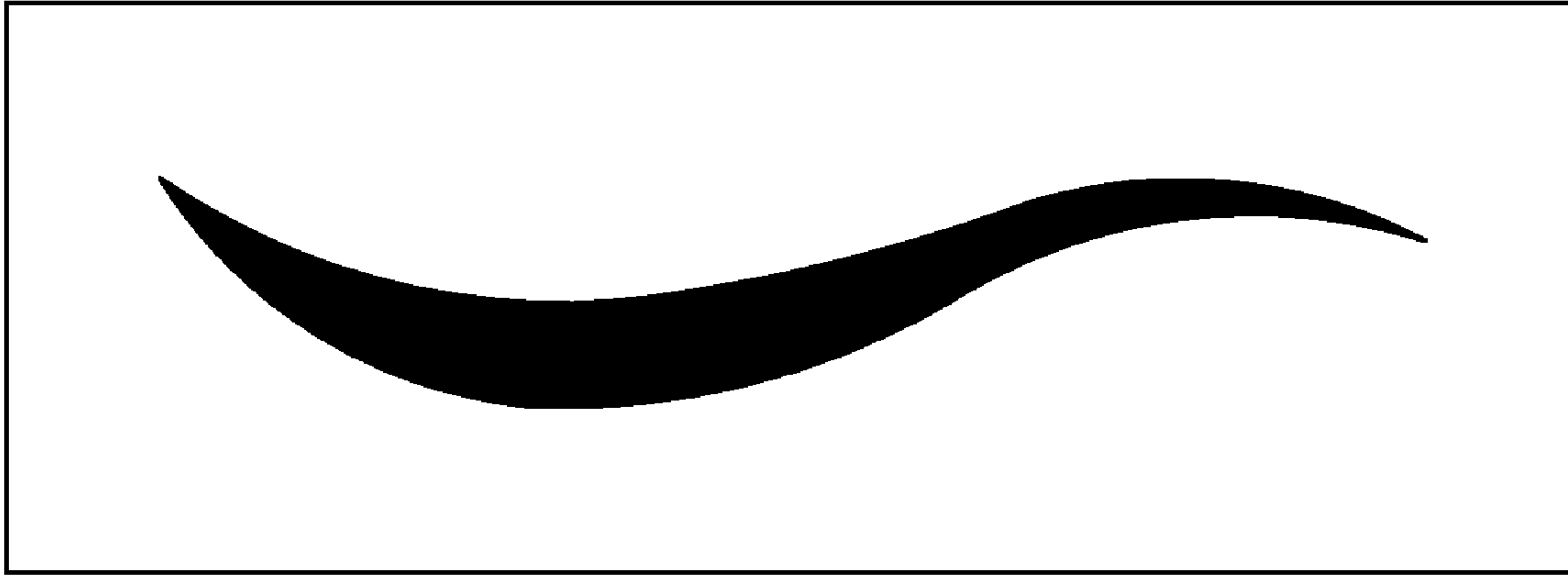

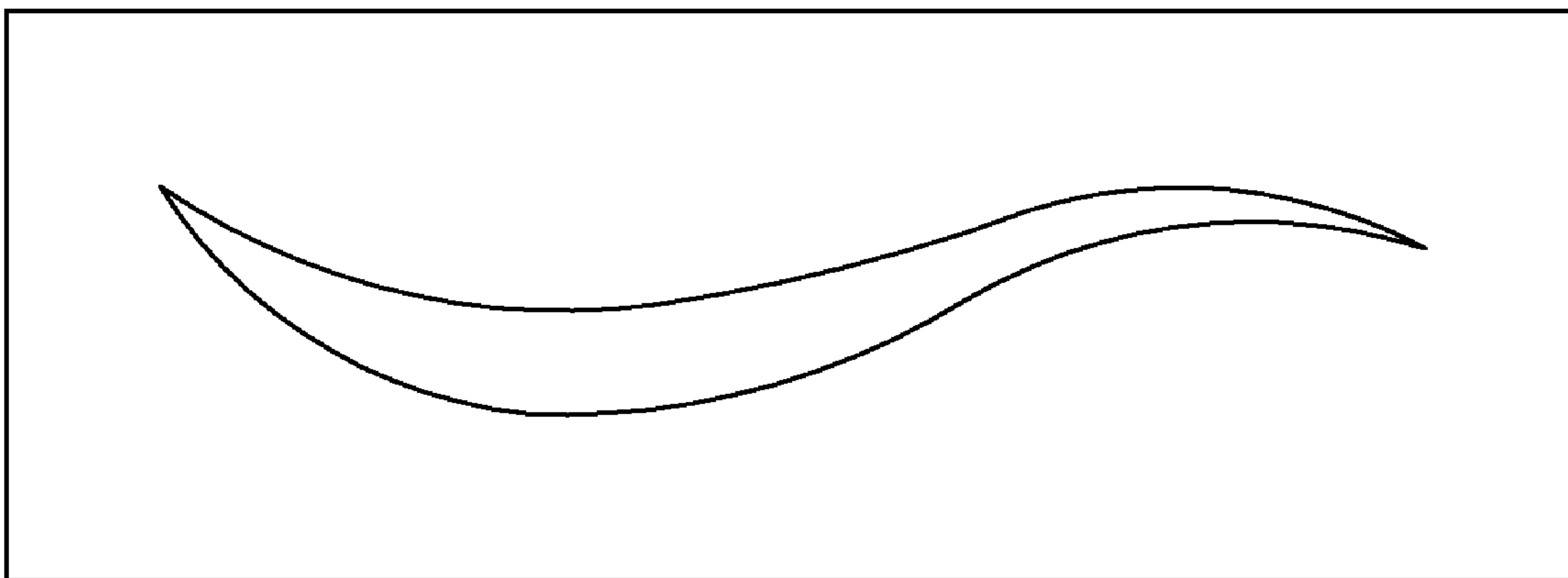
