(57) **CLAIM**

The ornamental design for a fixed caster, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a fixed
caster of the present invention;

FIG. 2 is a right side elevation view thereof, the left side being
a mirror image thereof;

FIG. 3 is a front elevation view thereof, the rear being a minor
image thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a perspective view of a second embodiment of a
fixed caster of the present invention;

FIG. 6 is a right side elevation view thereof, the left side being
a mirror image thereof;

FIG. 7 is a front elevation view thereof, the rear being a mirror
image thereof; and,

FIG. 8 is a bottom plan view thereof.

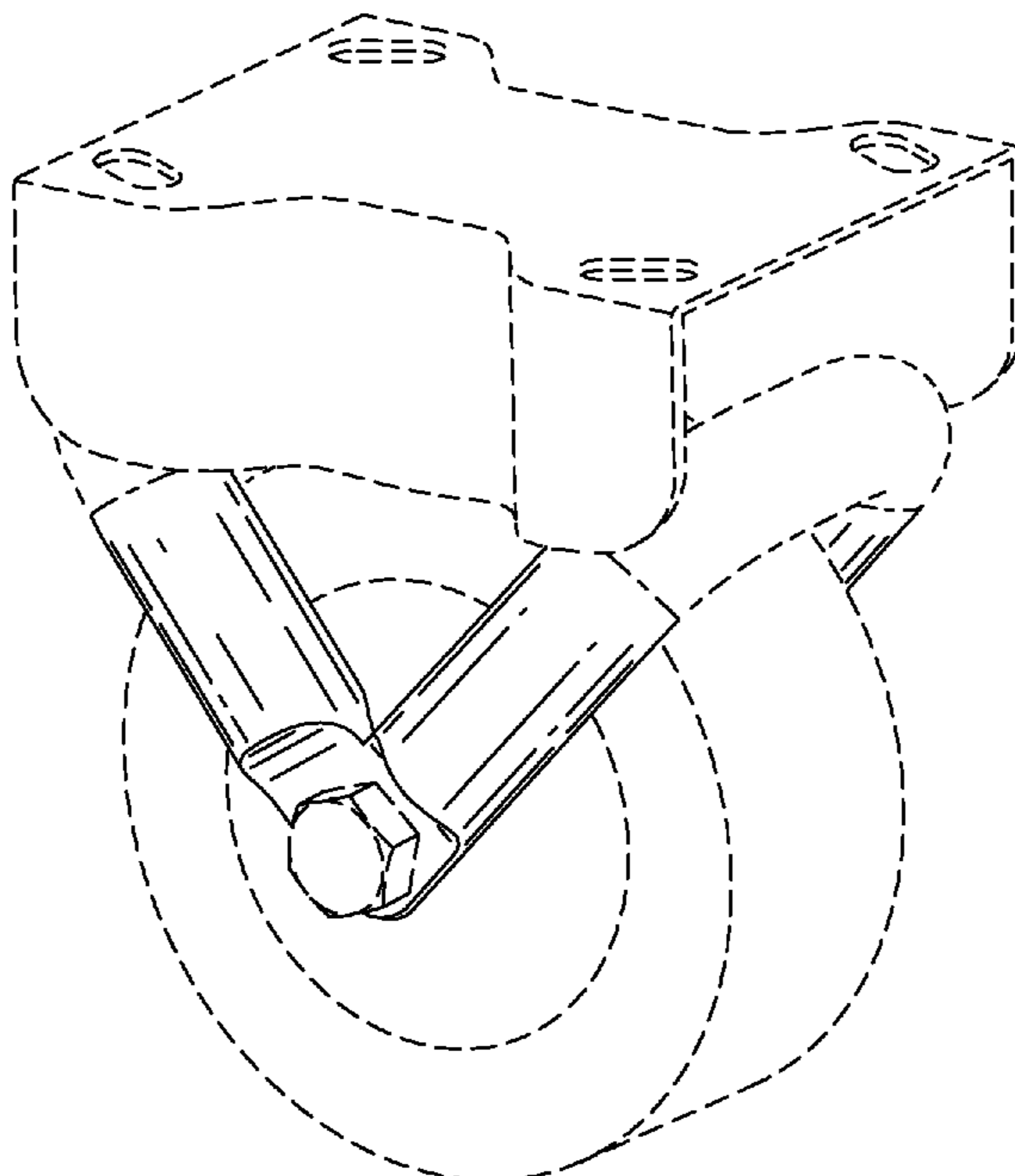
Top plan views have been omitted as they do not form a

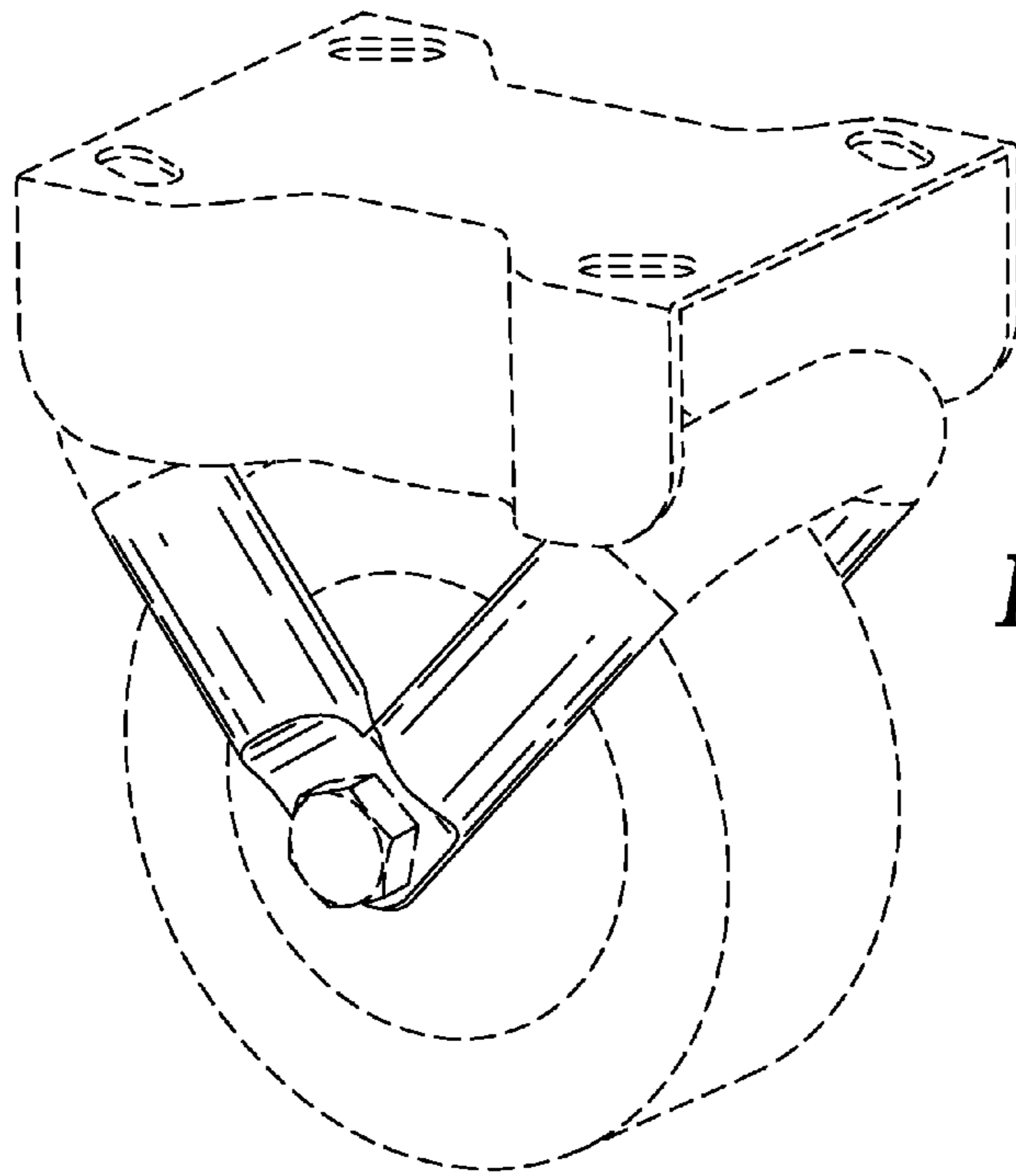

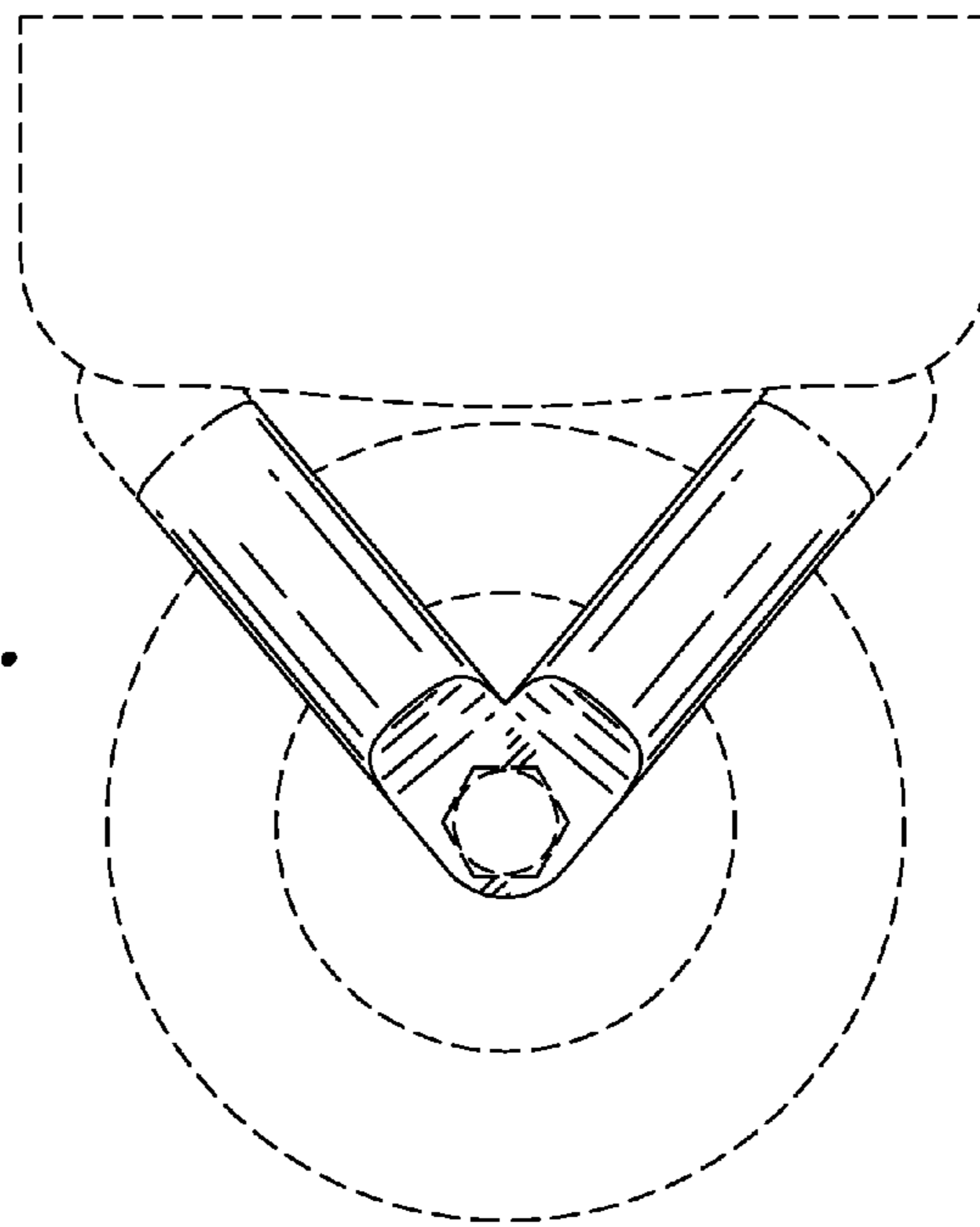

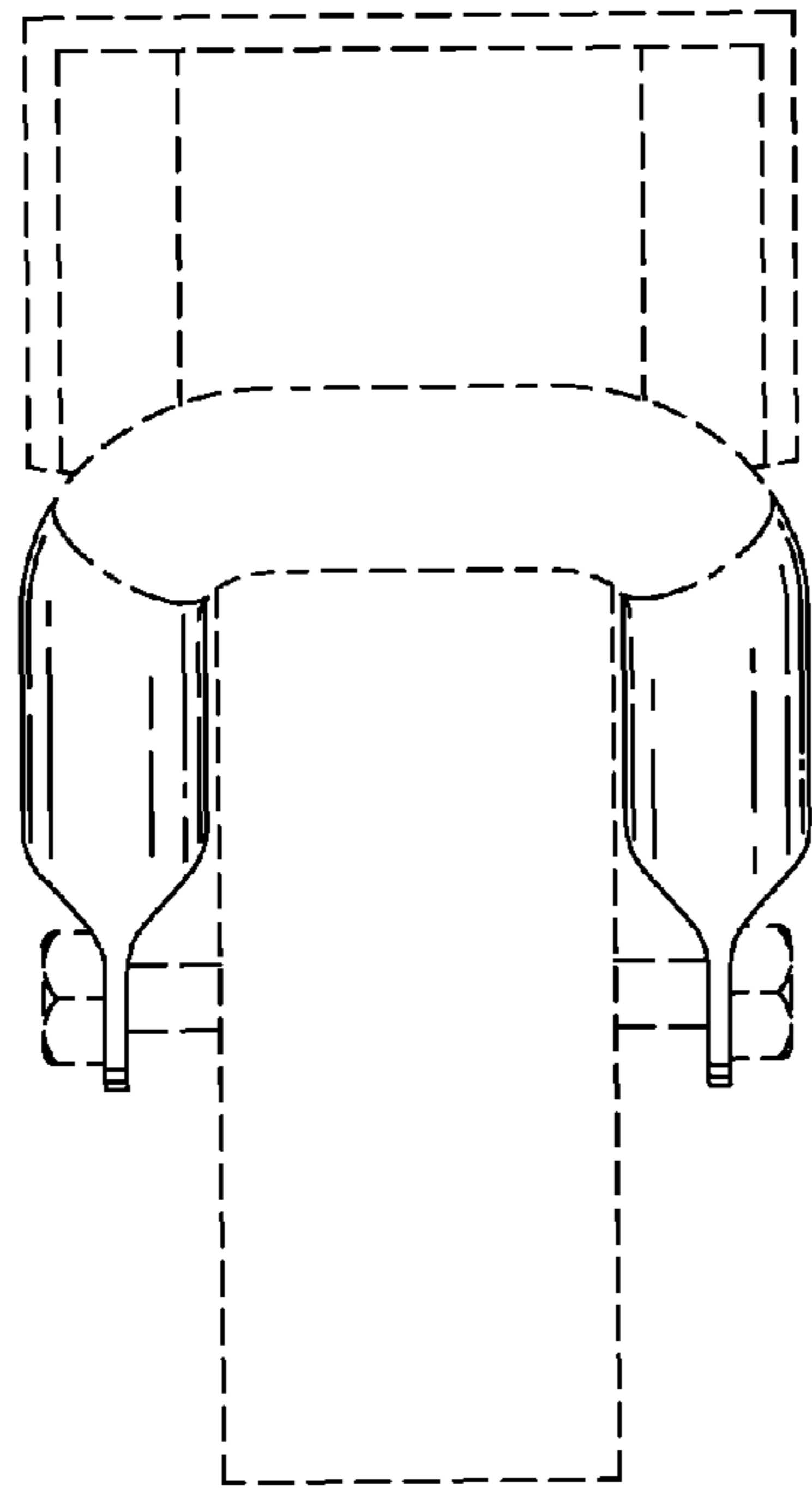

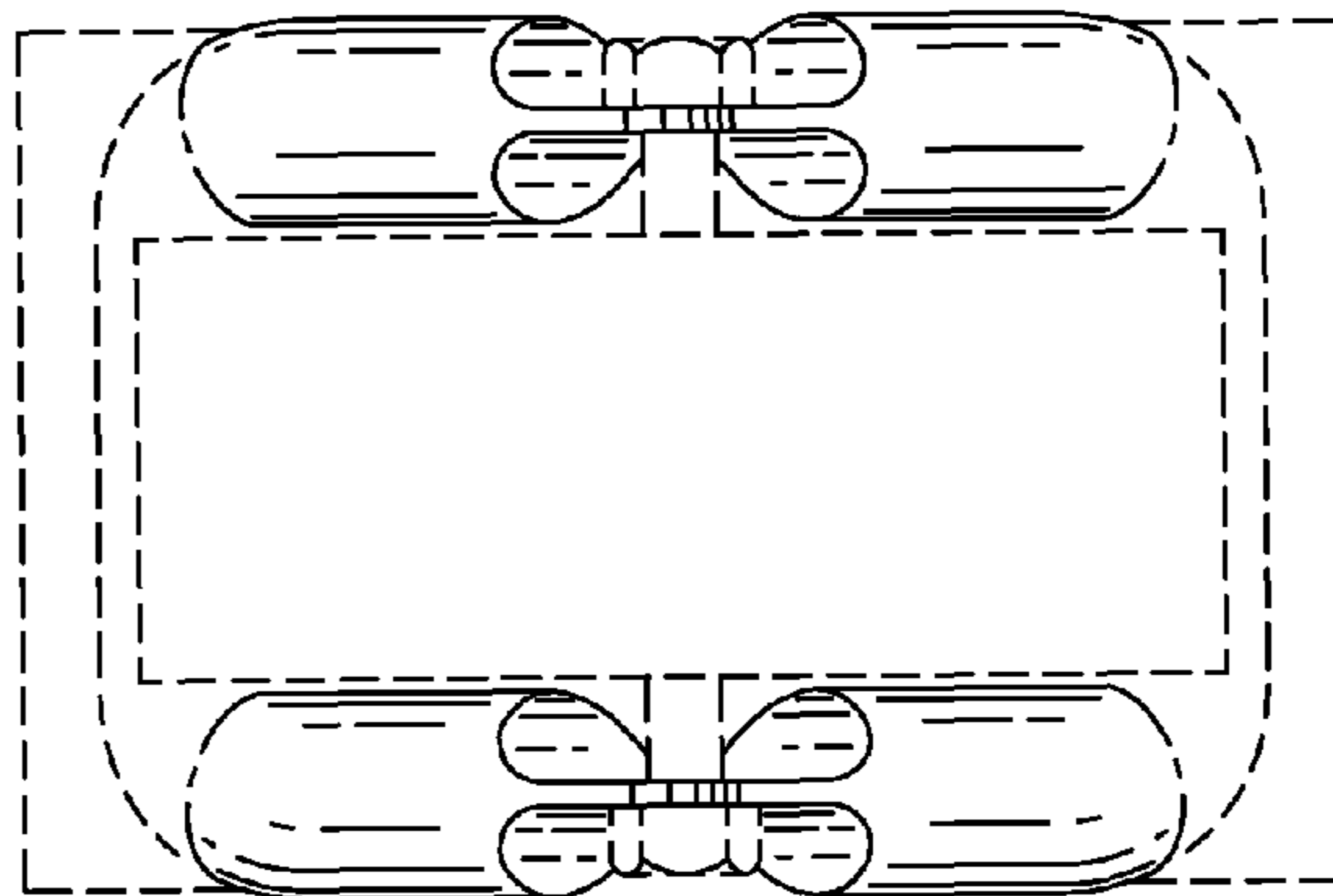

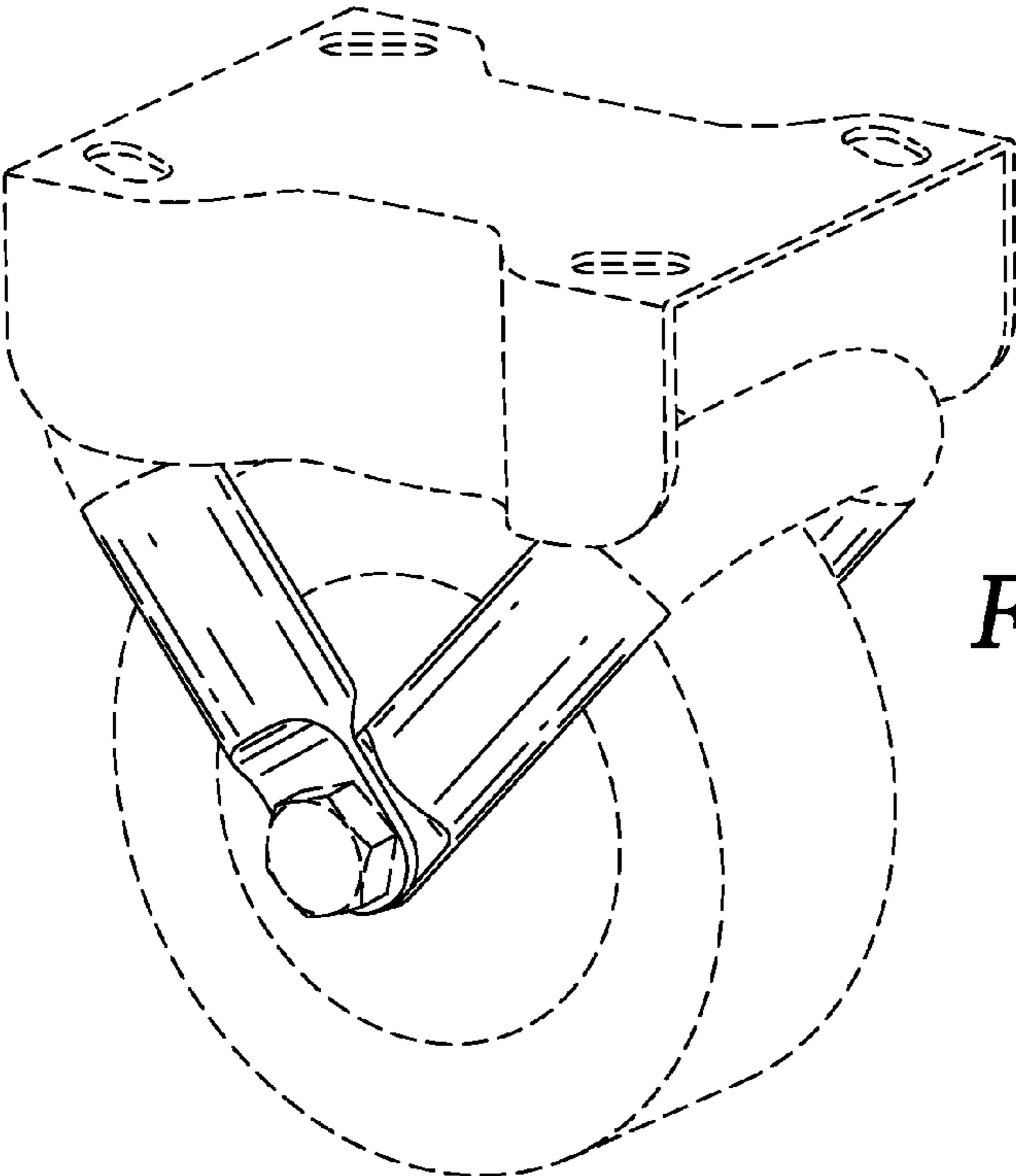

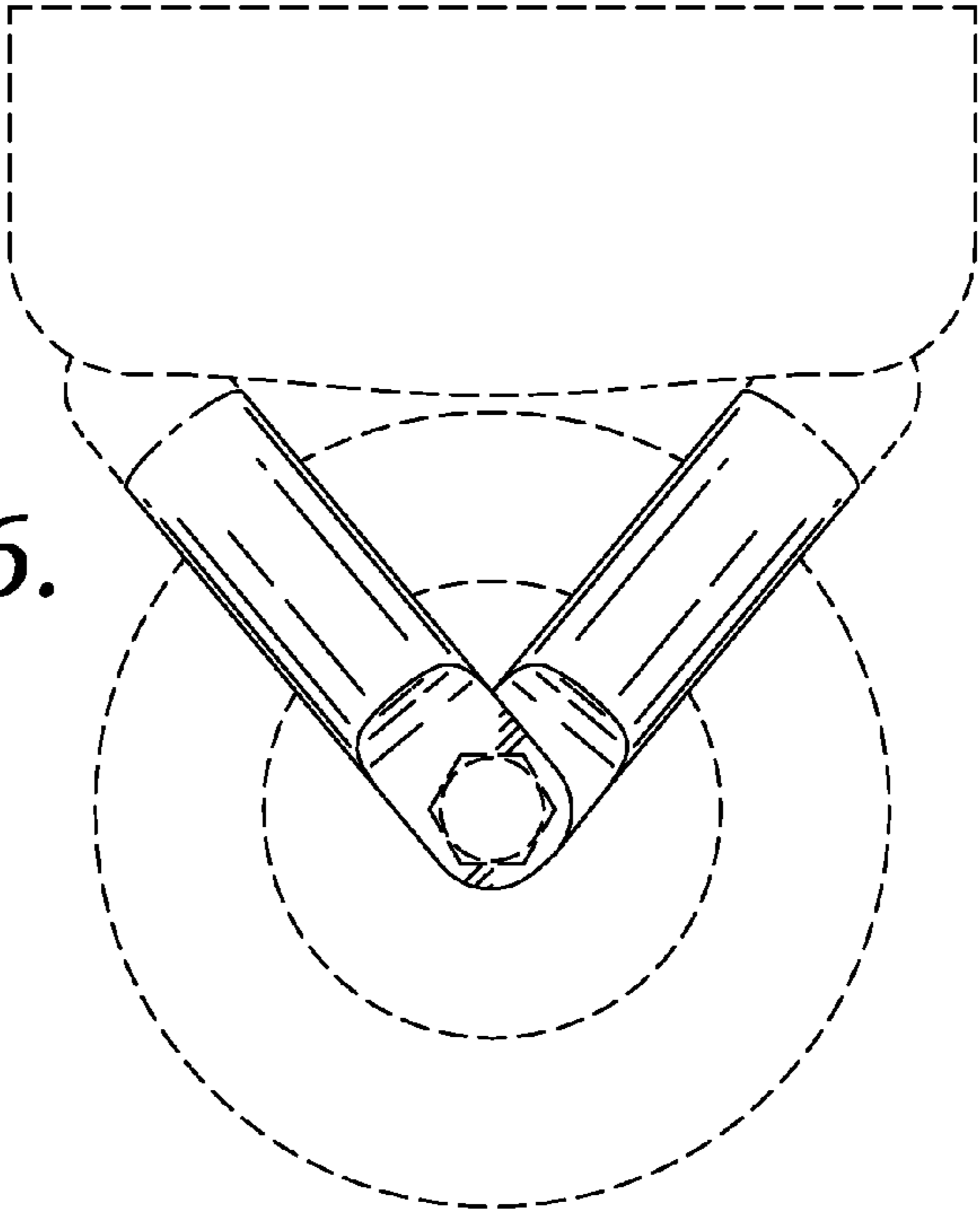

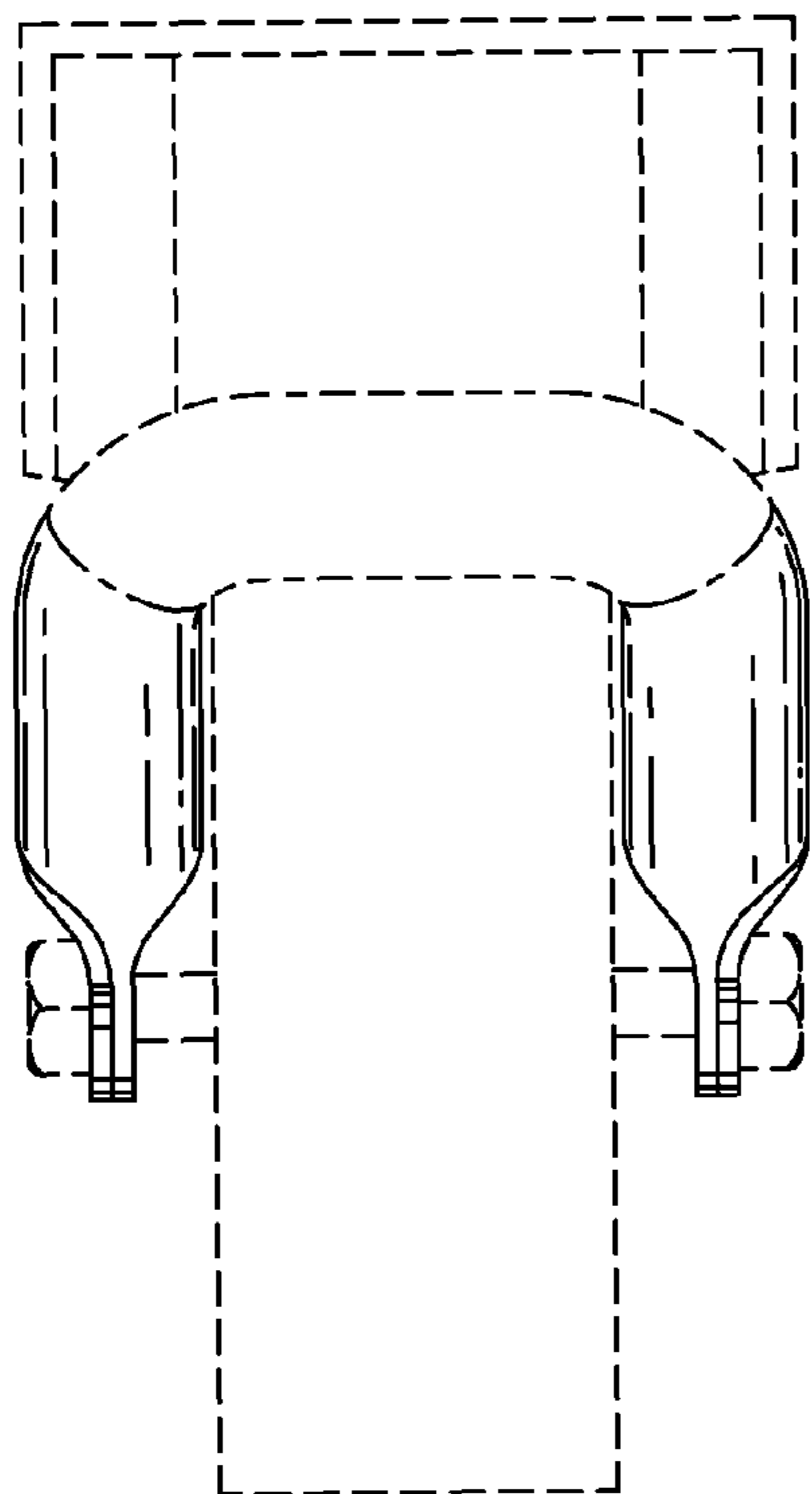

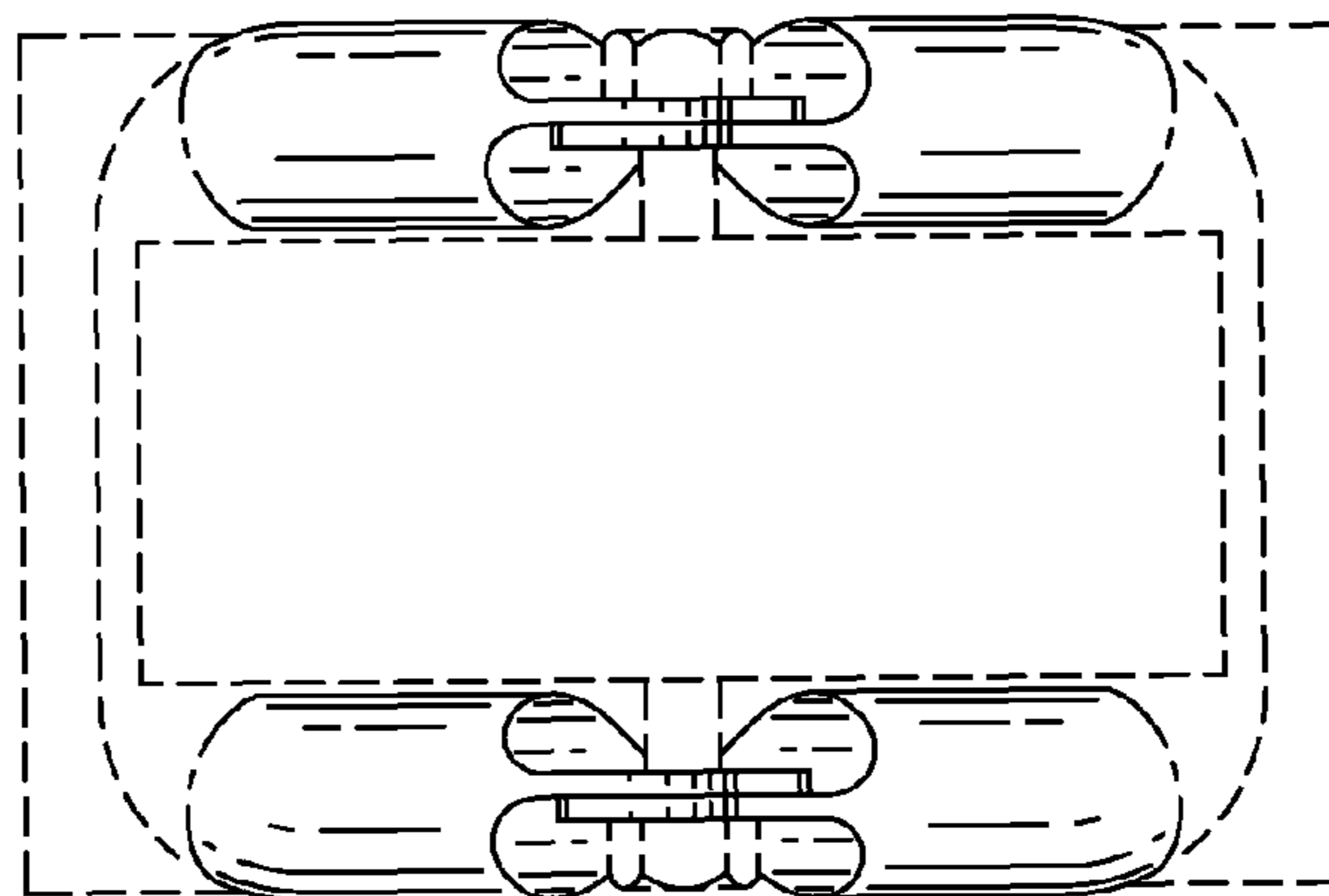
