(57) **CLAIM**

I claim the ornamental design for food container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a food container showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is right side elevation view thereof;

FIG. 5 is a left side elevation view thereof; and,

FIG. 6 is a front end elevation view thereof; the rear elevation view being the same.

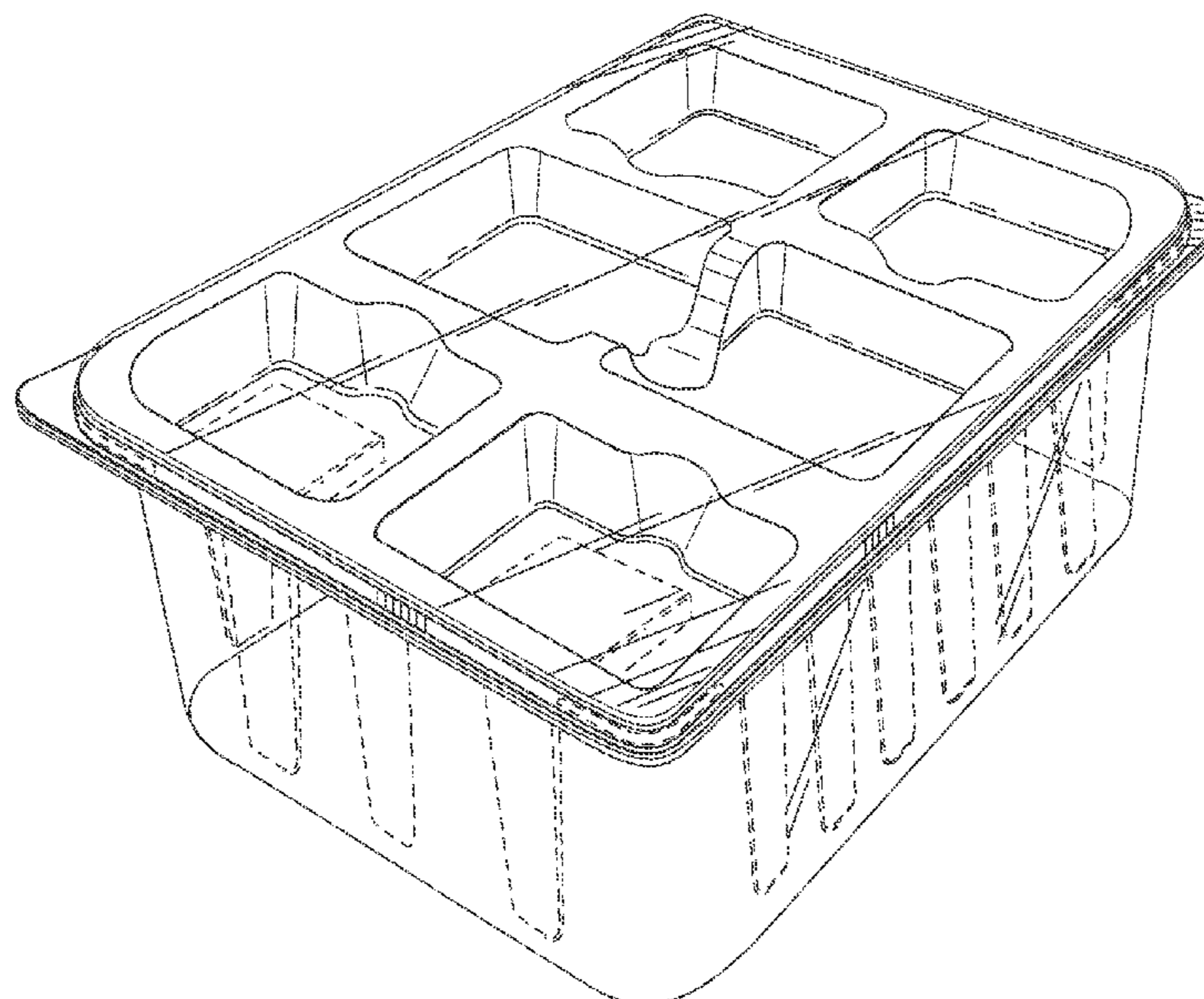

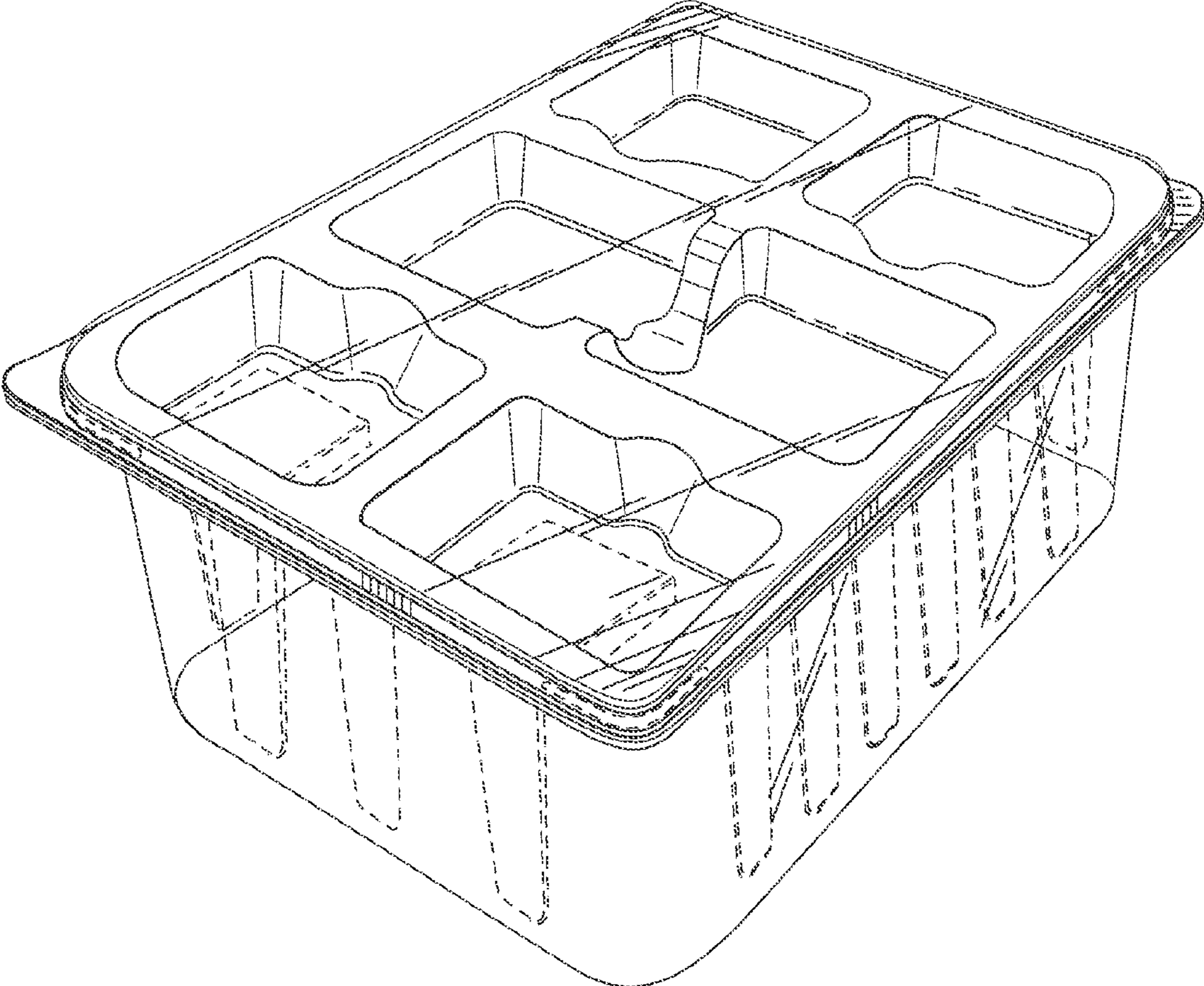

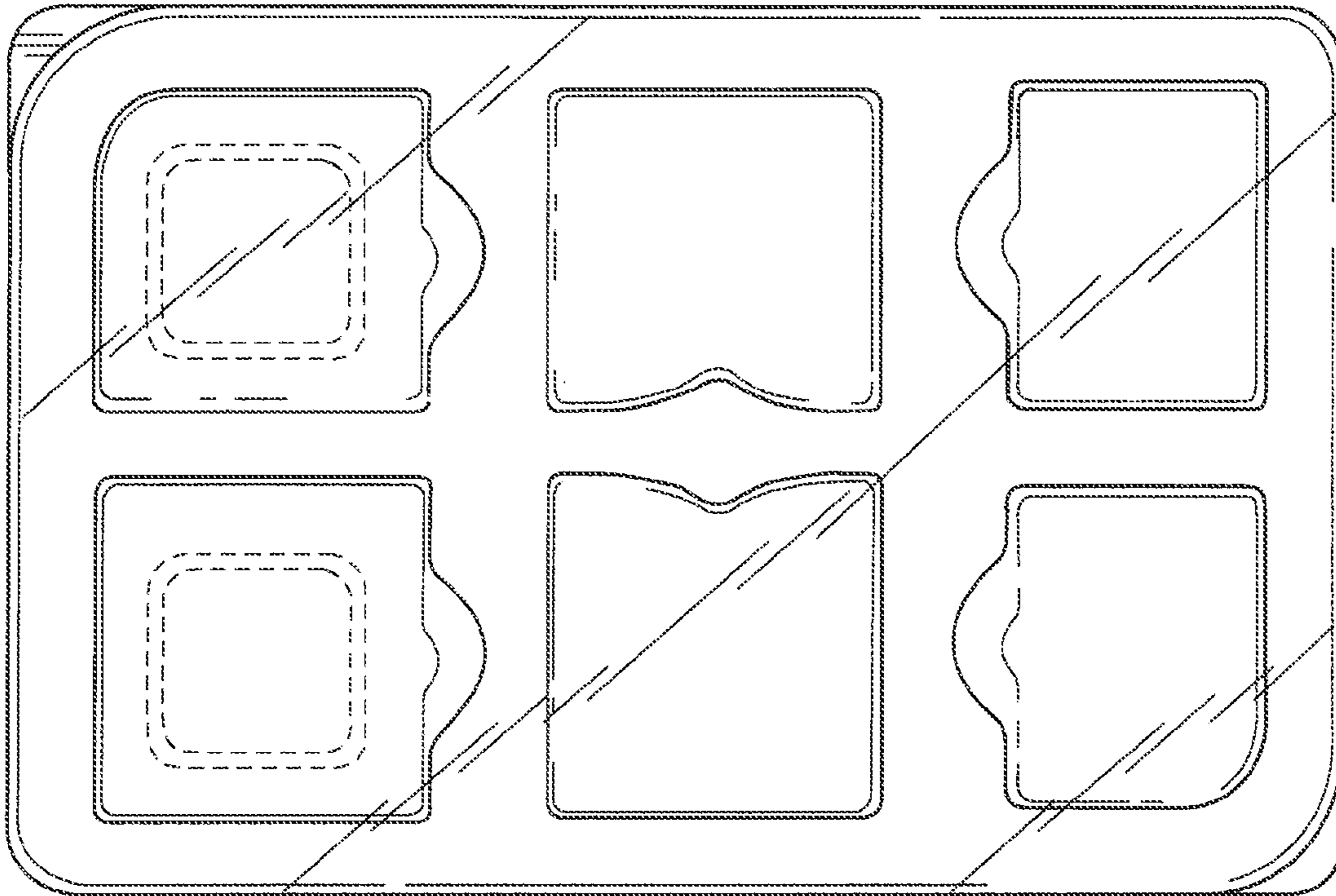

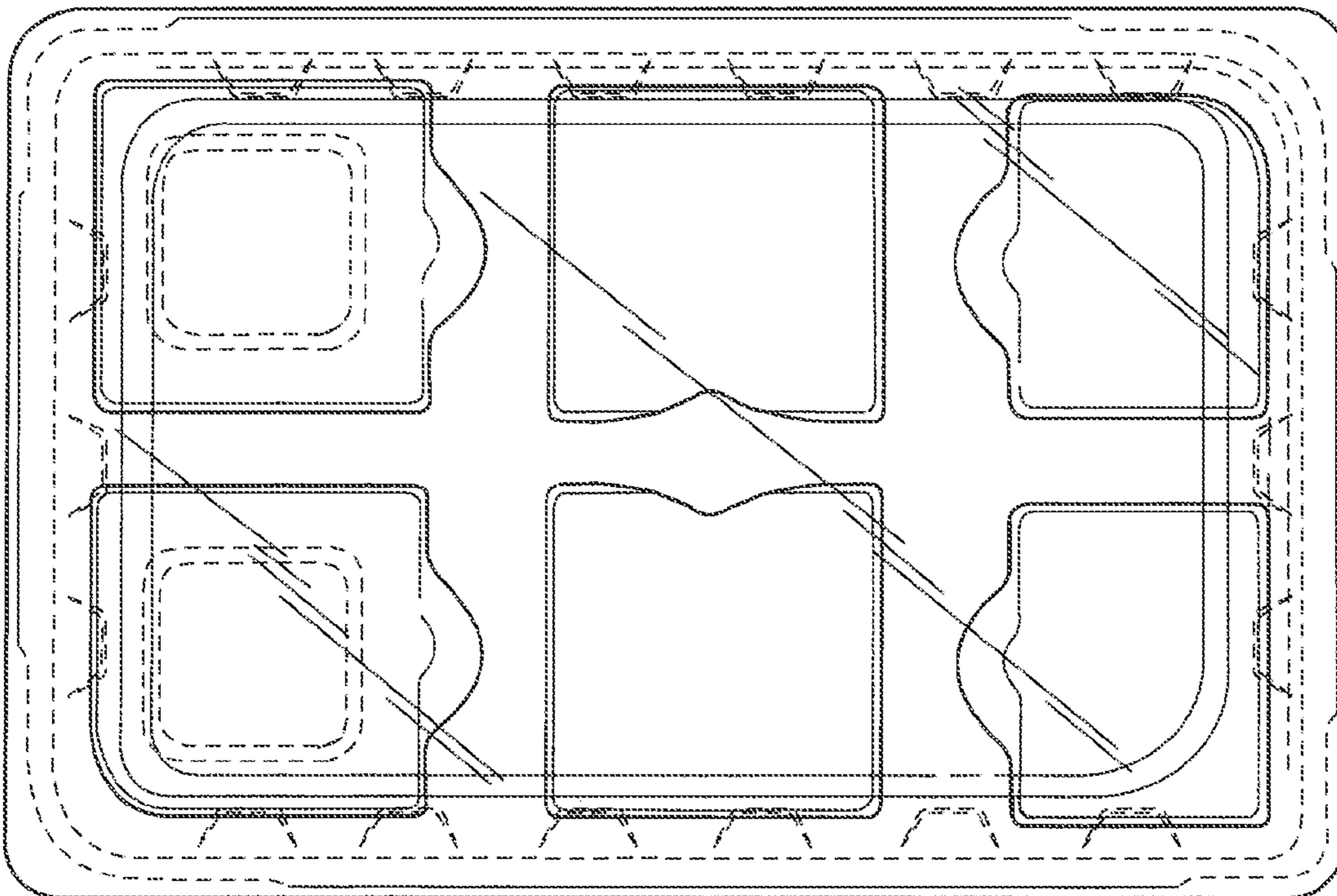

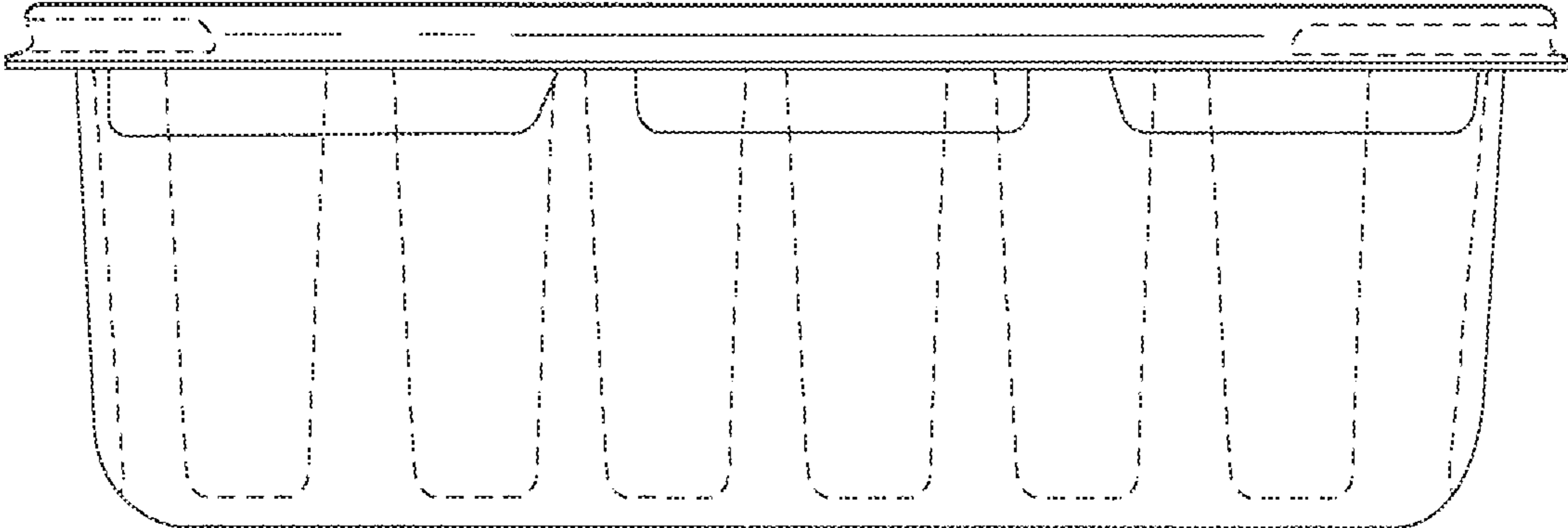

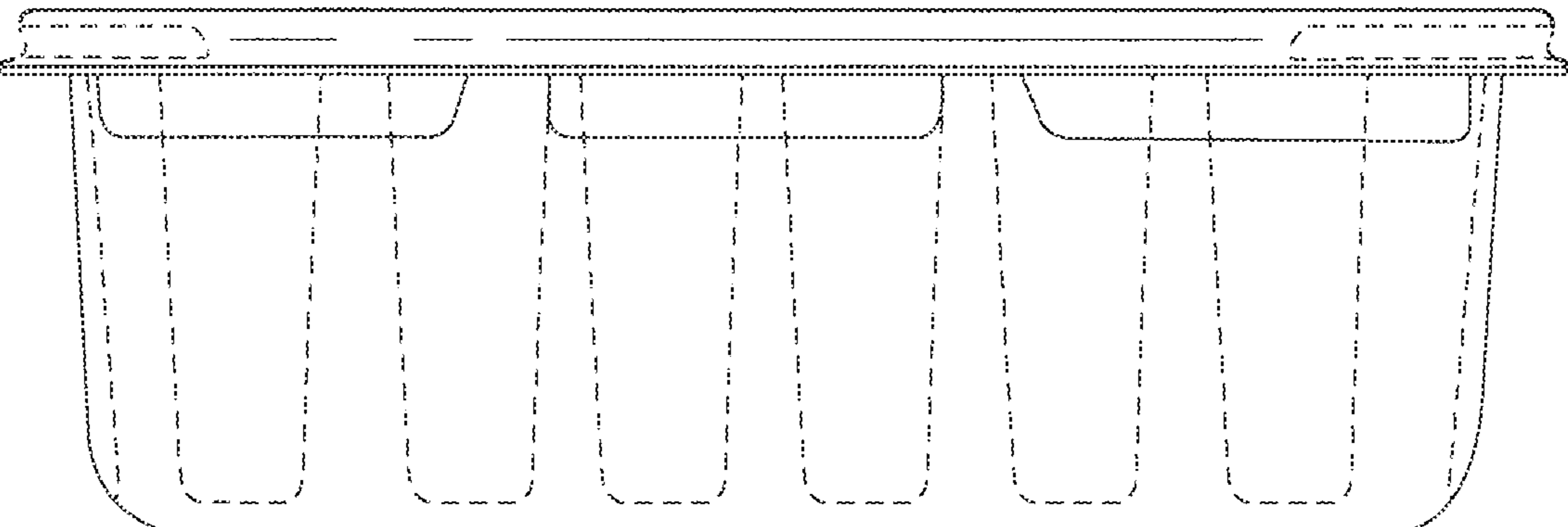
