FIG. 4 is a front elevational view of the embodiment shown in FIG. 1.

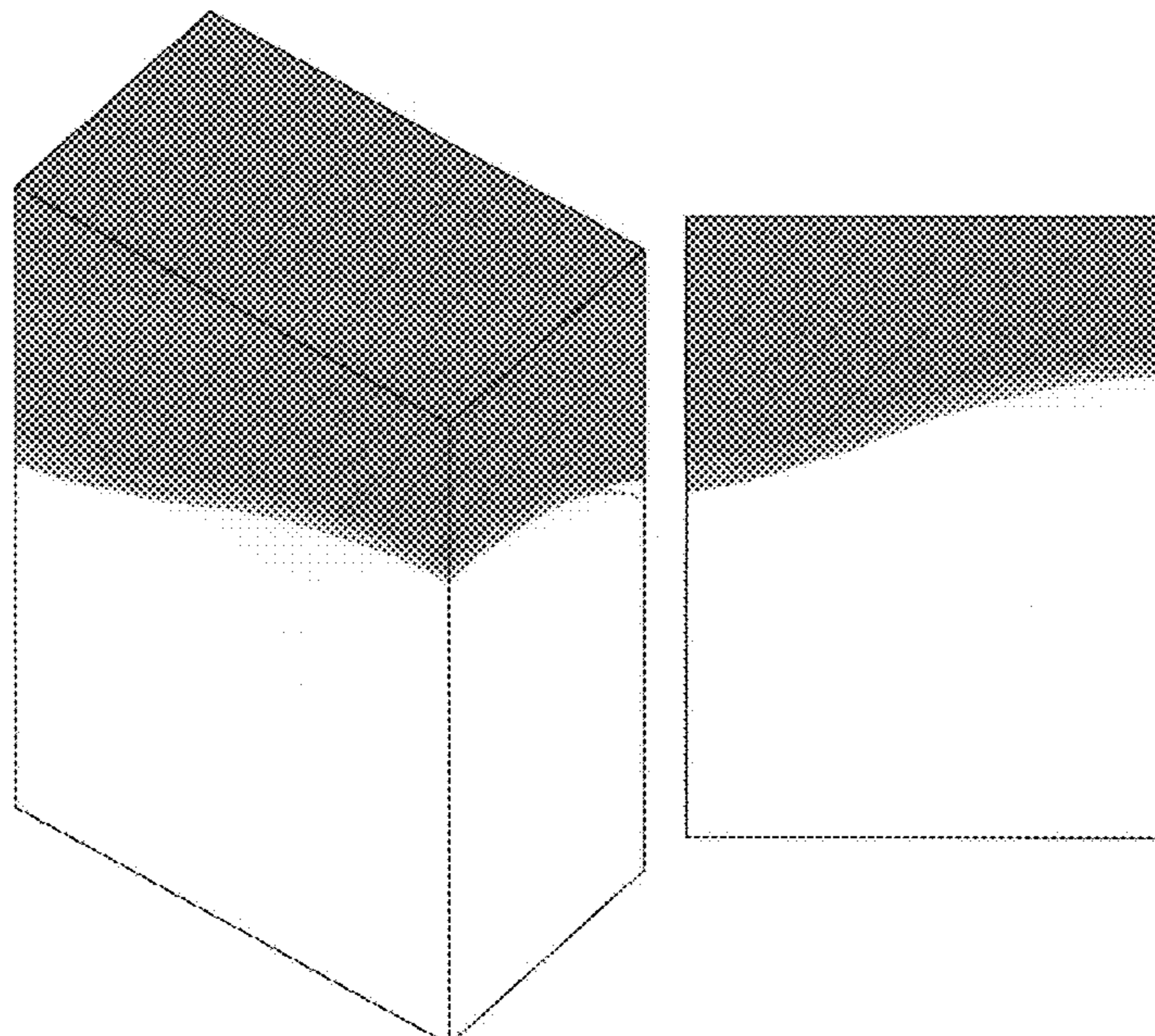
FIG. 5 is a side elevational view of the embodiment shown in FIG. 1.

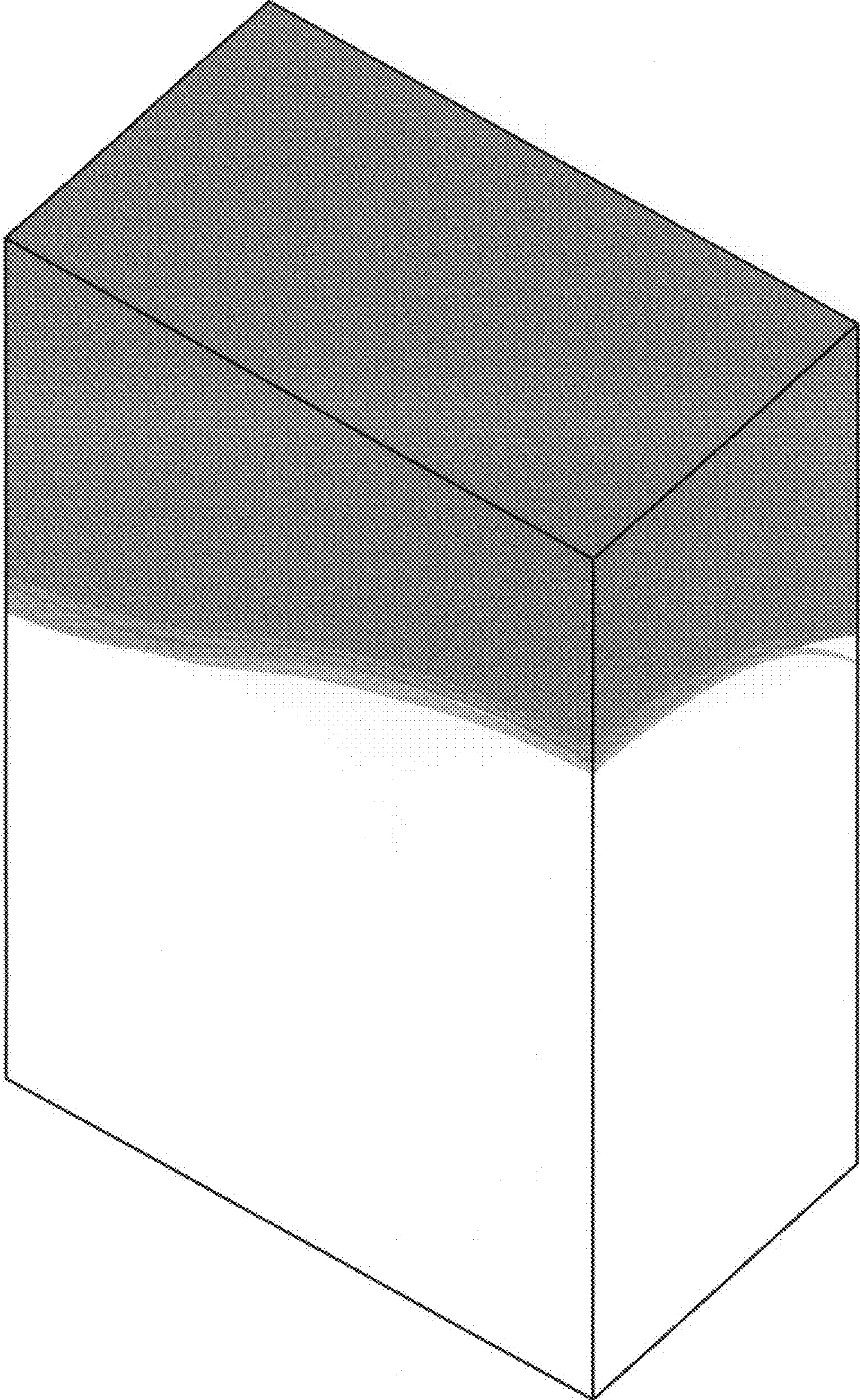

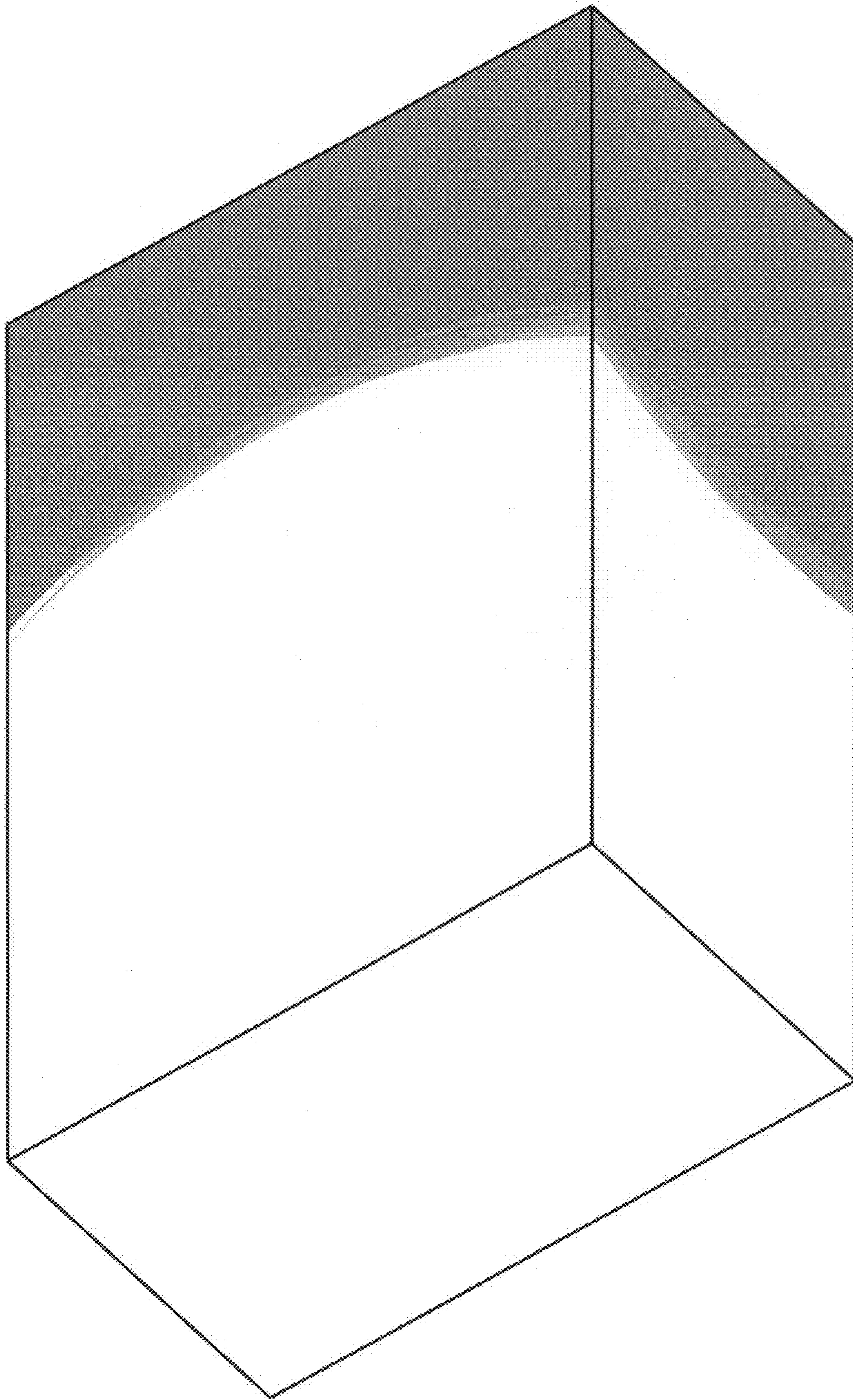

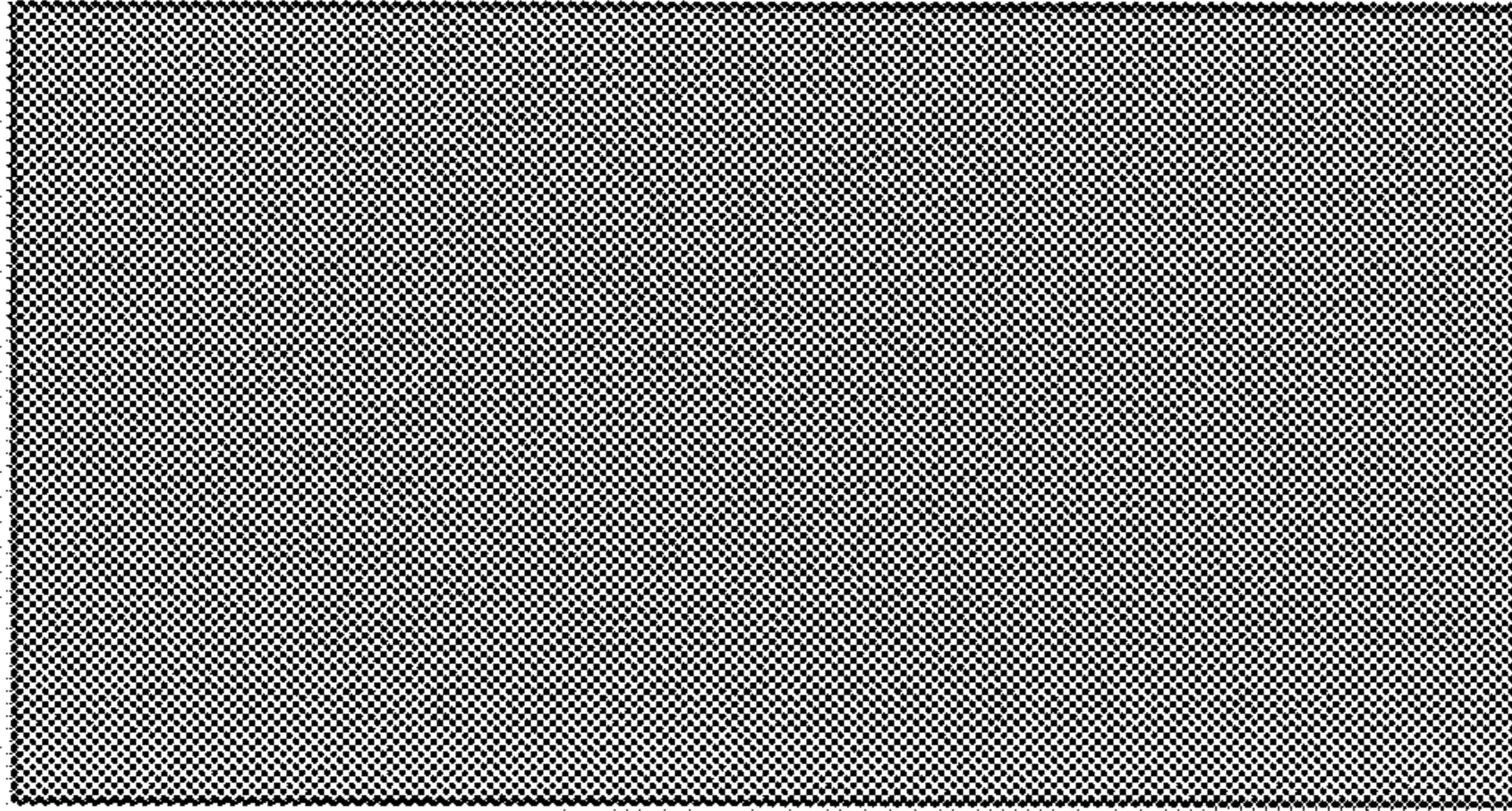

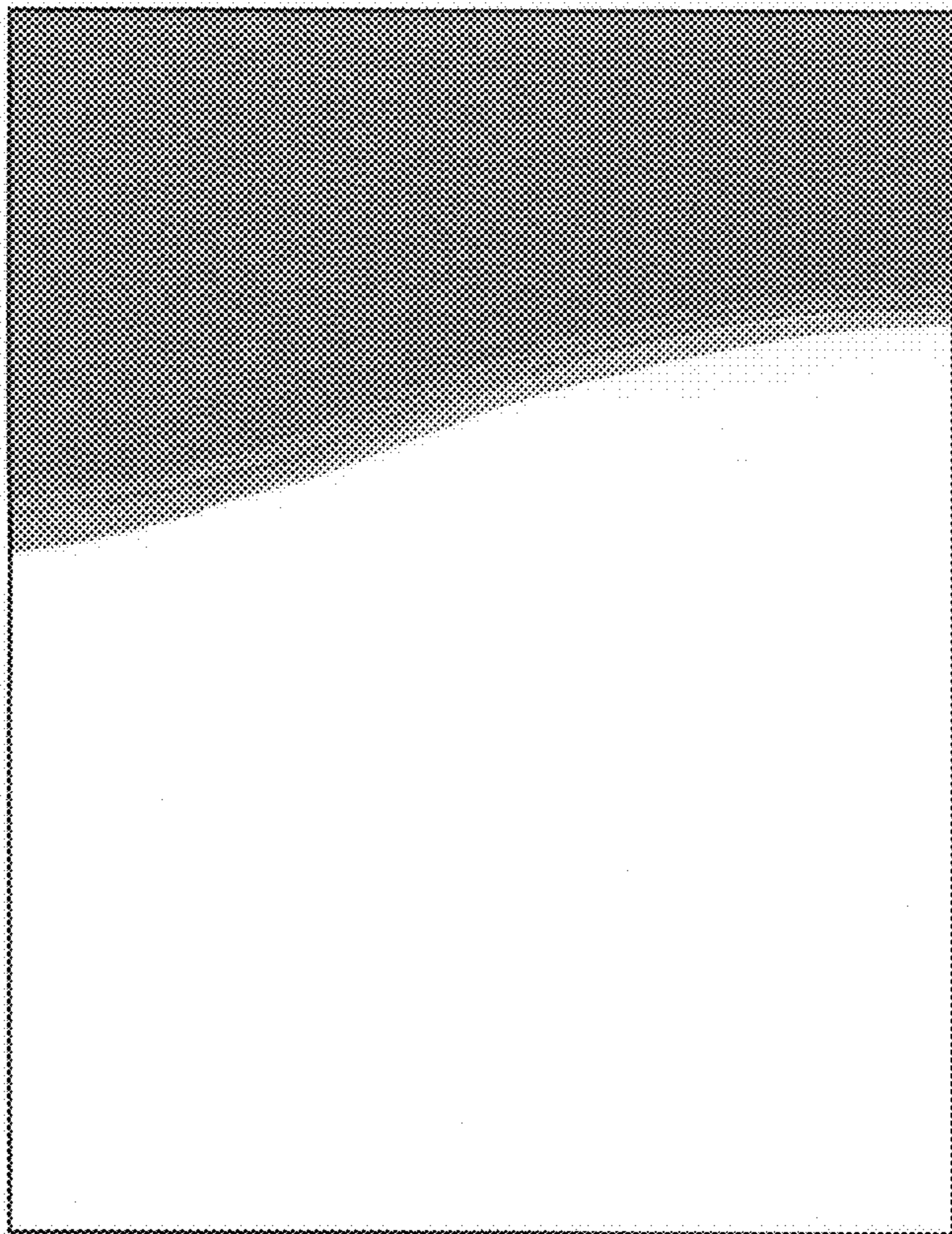

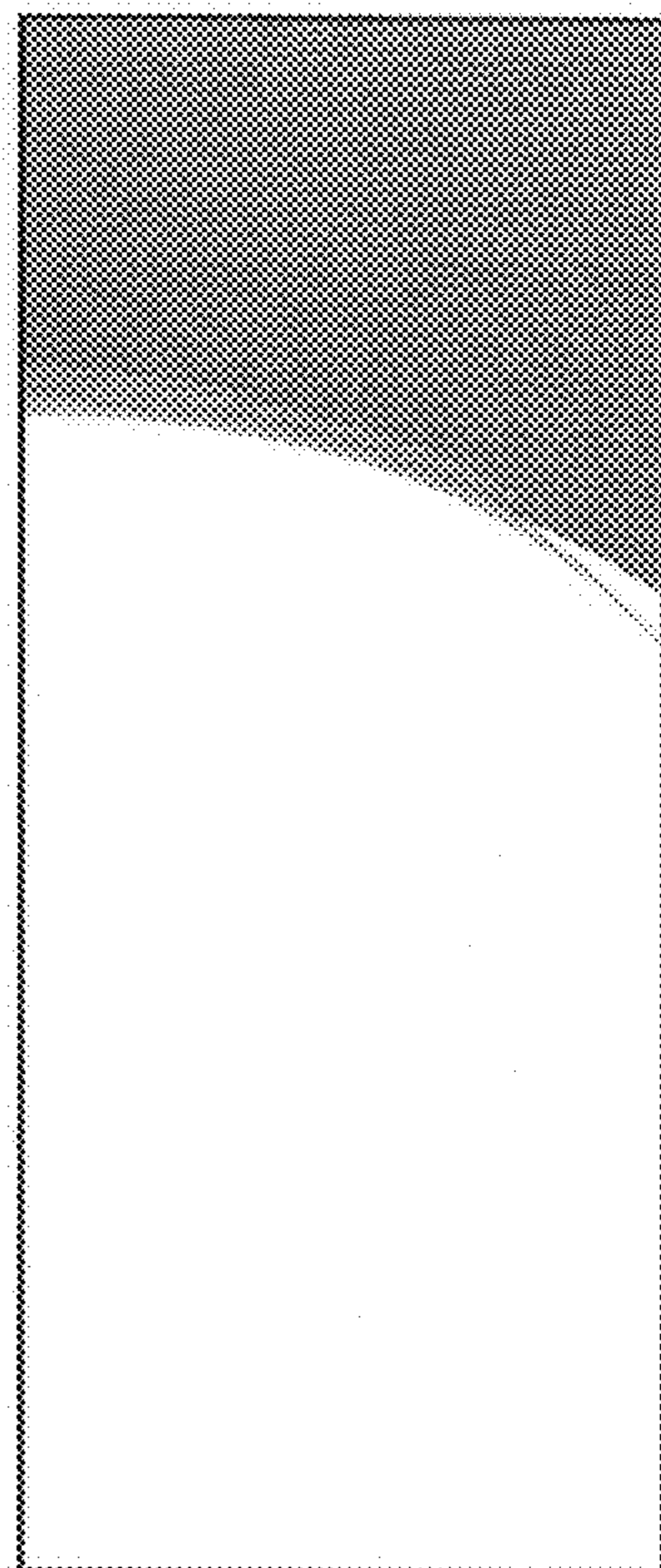

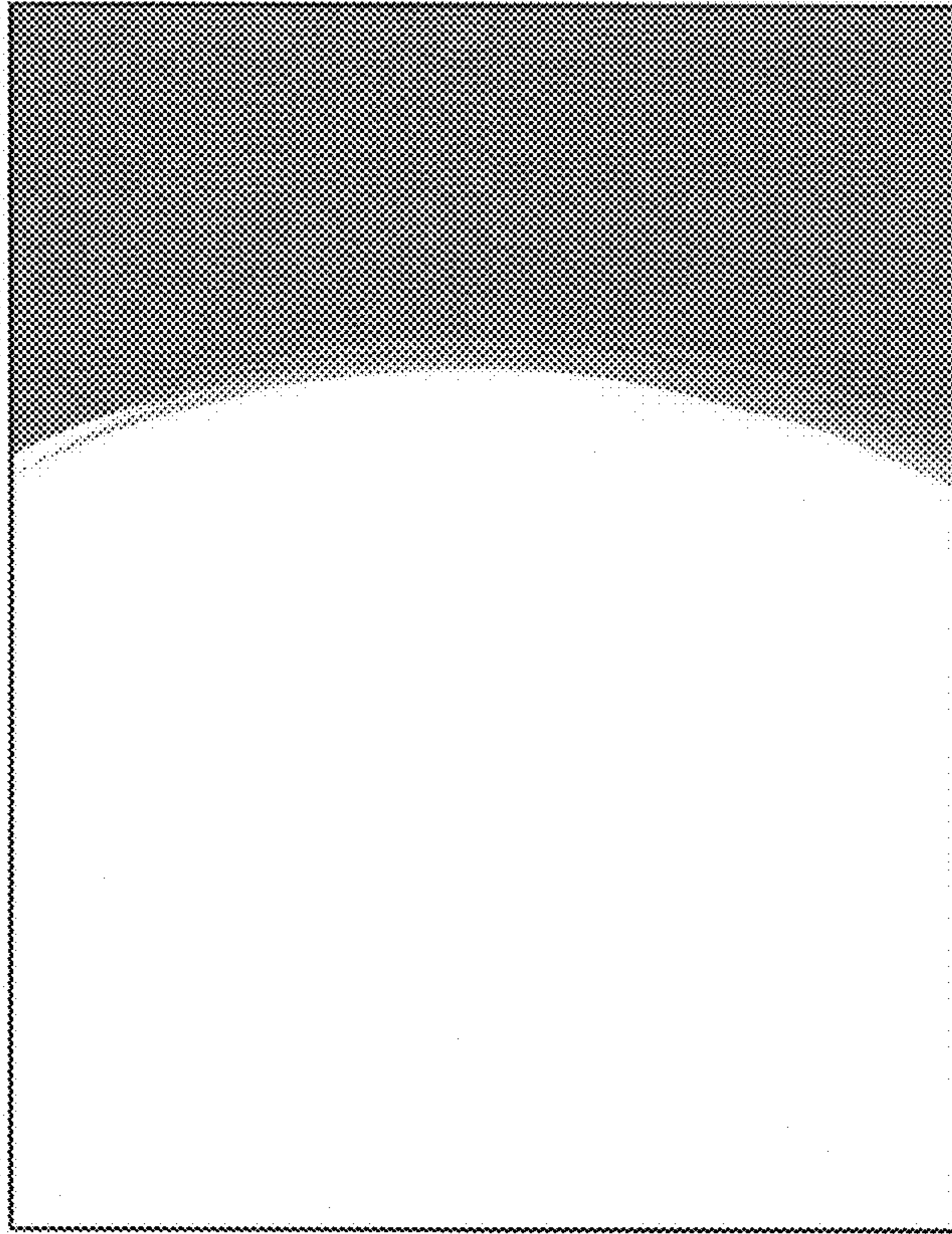

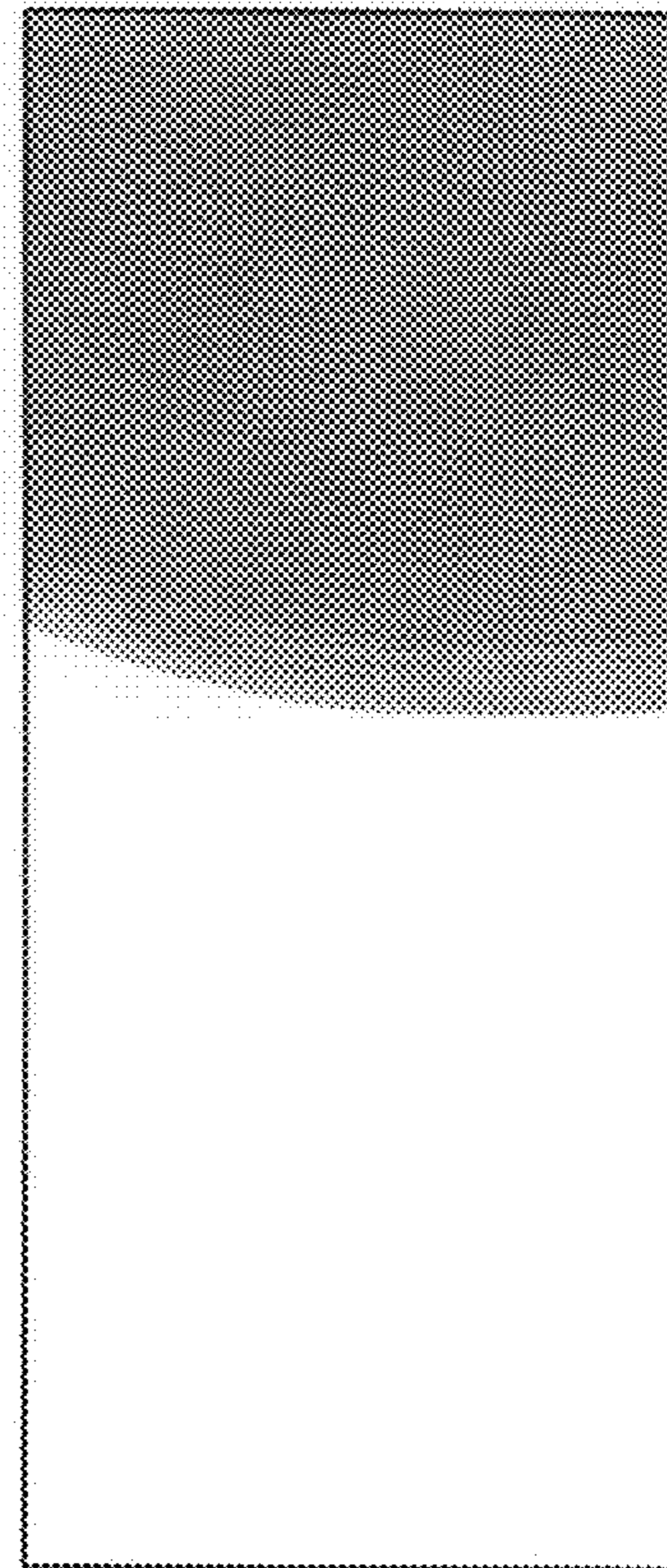

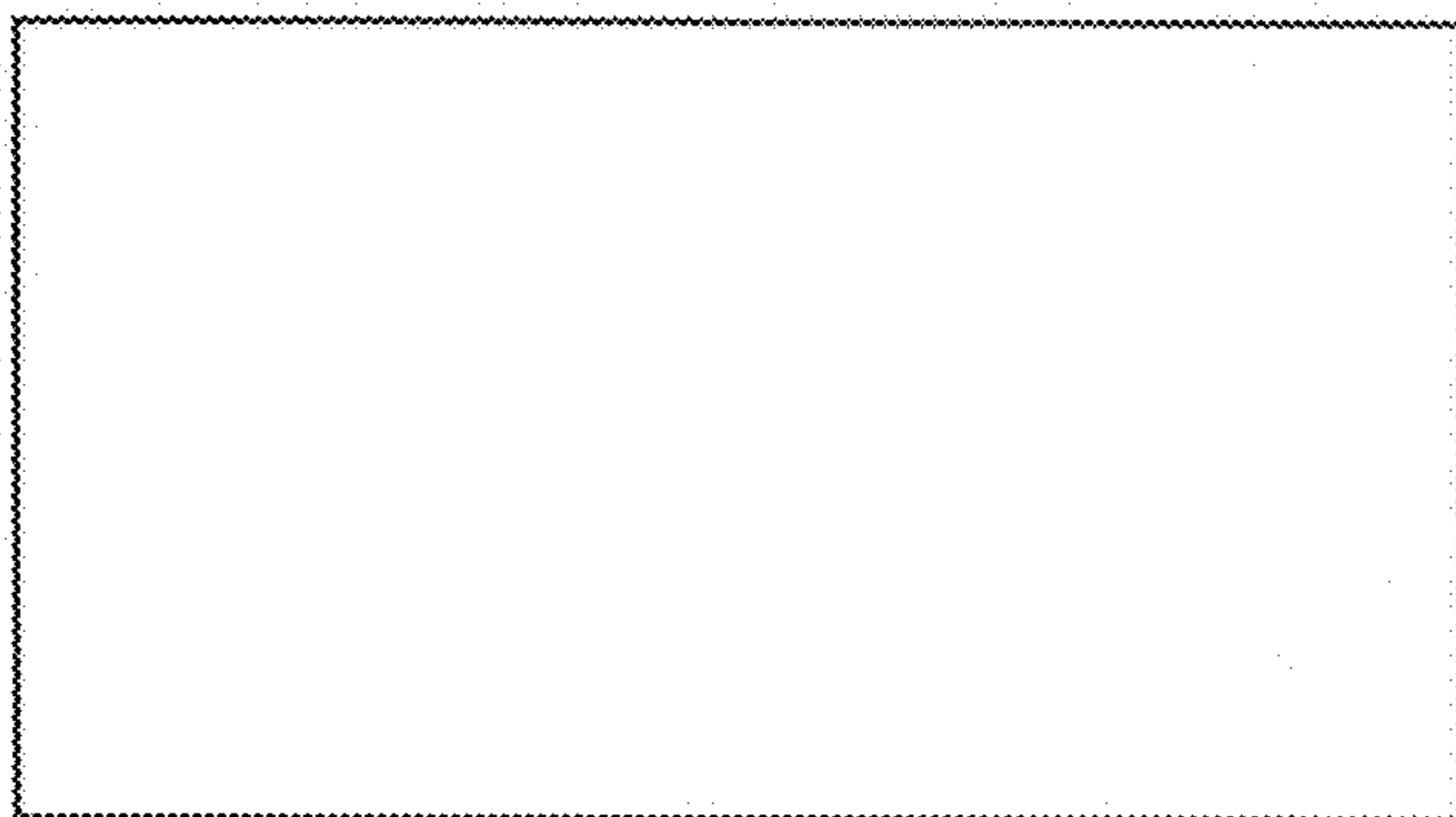
